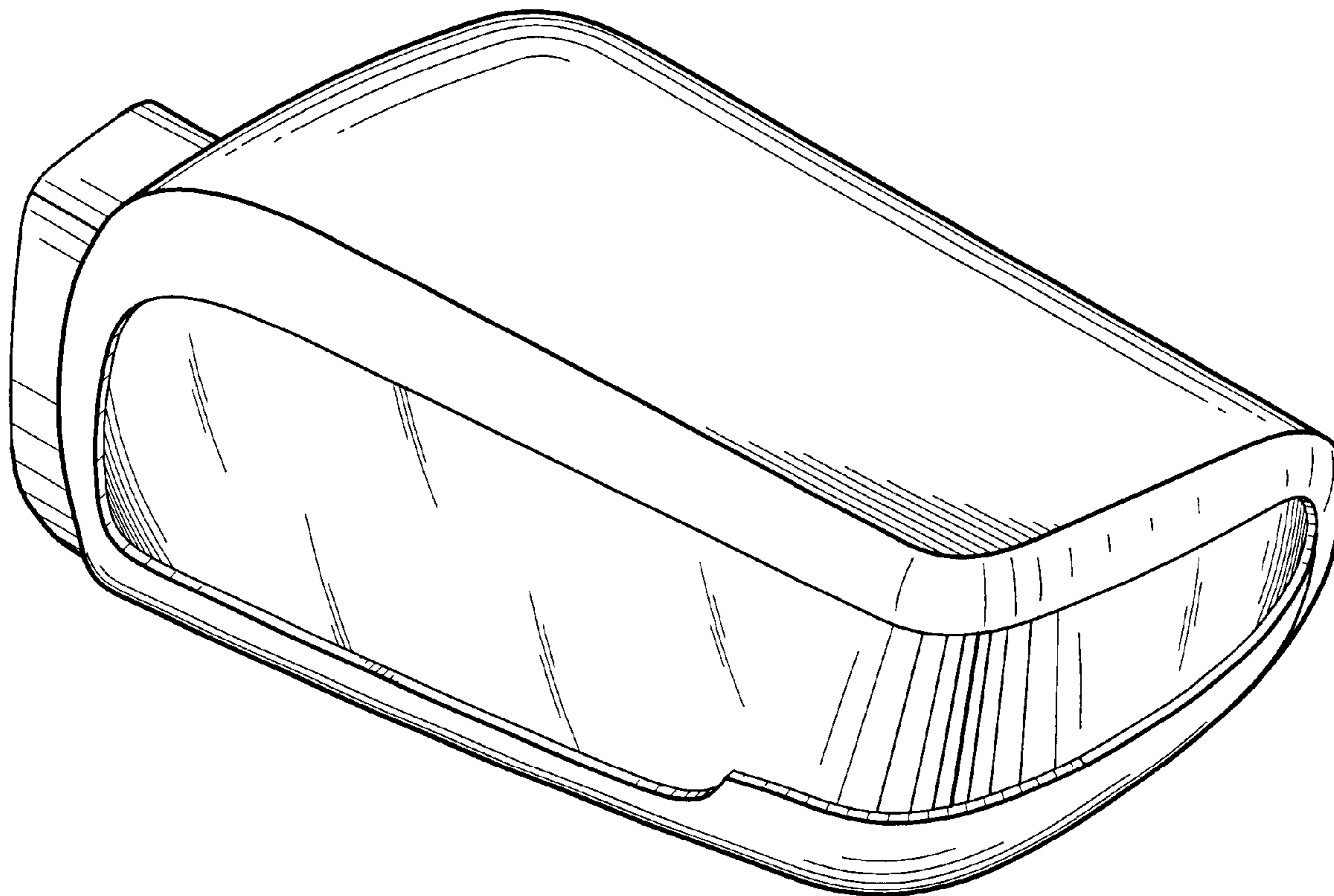
FIG. 1 is a top front perspective view of a pod vehicle

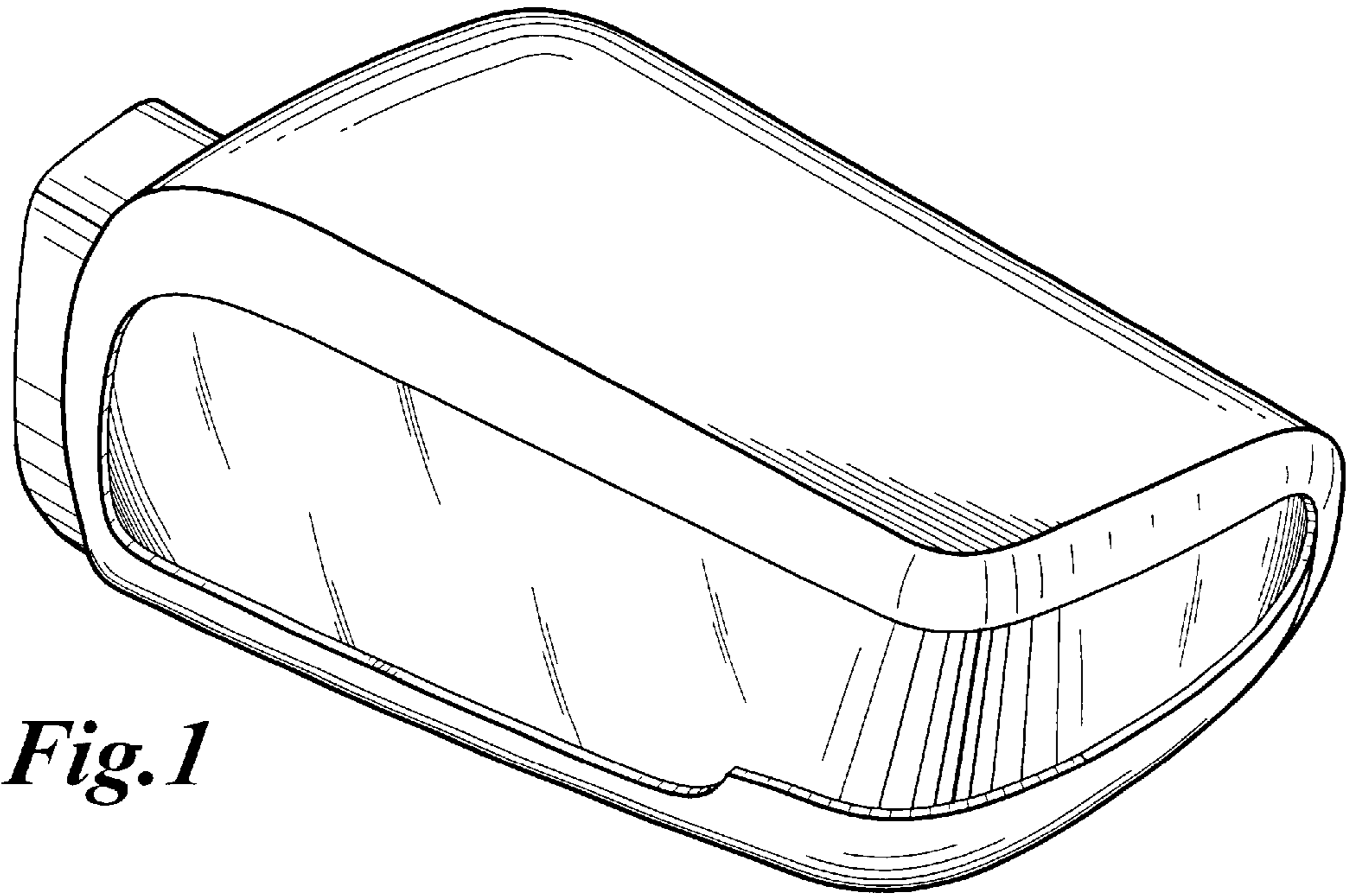

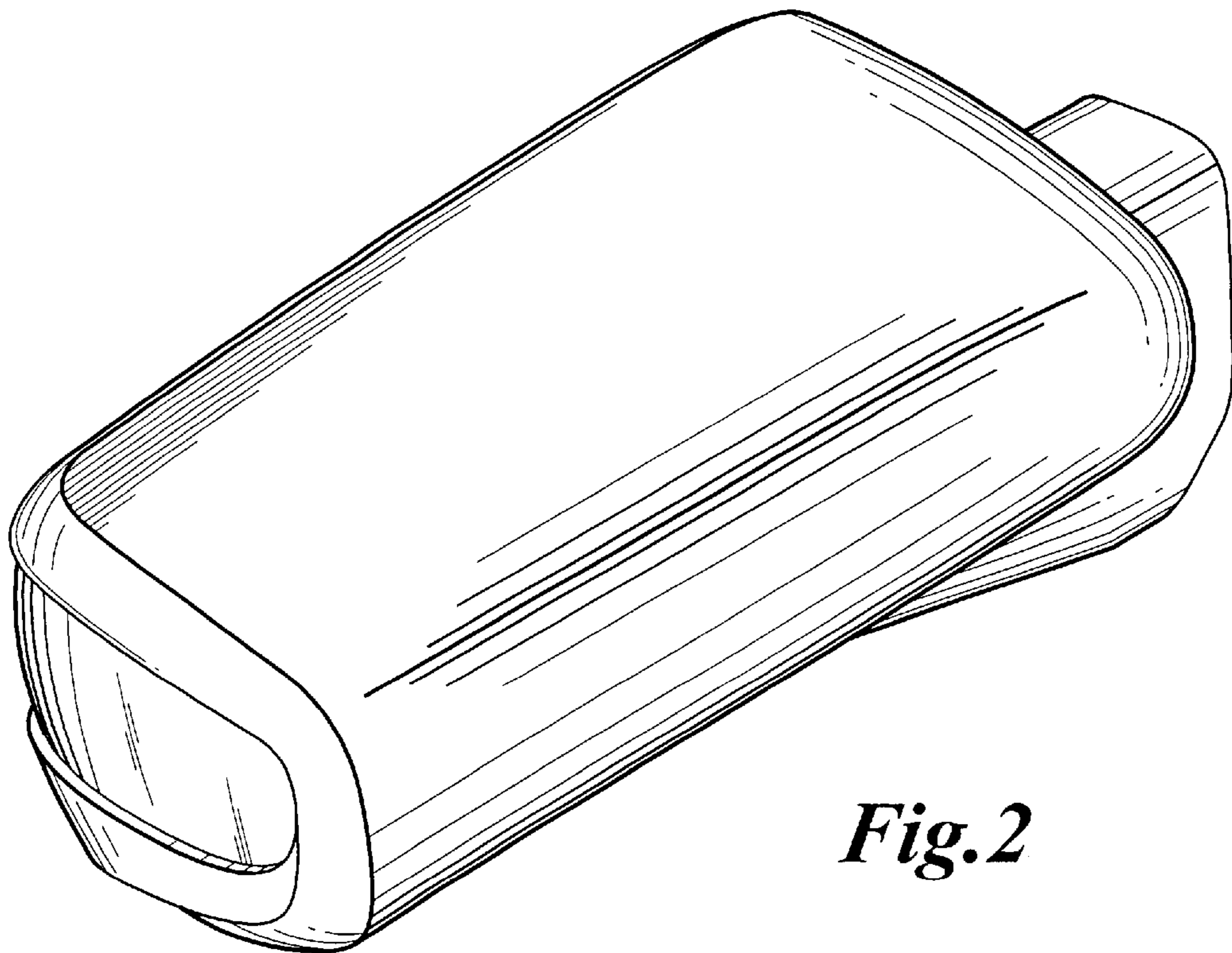

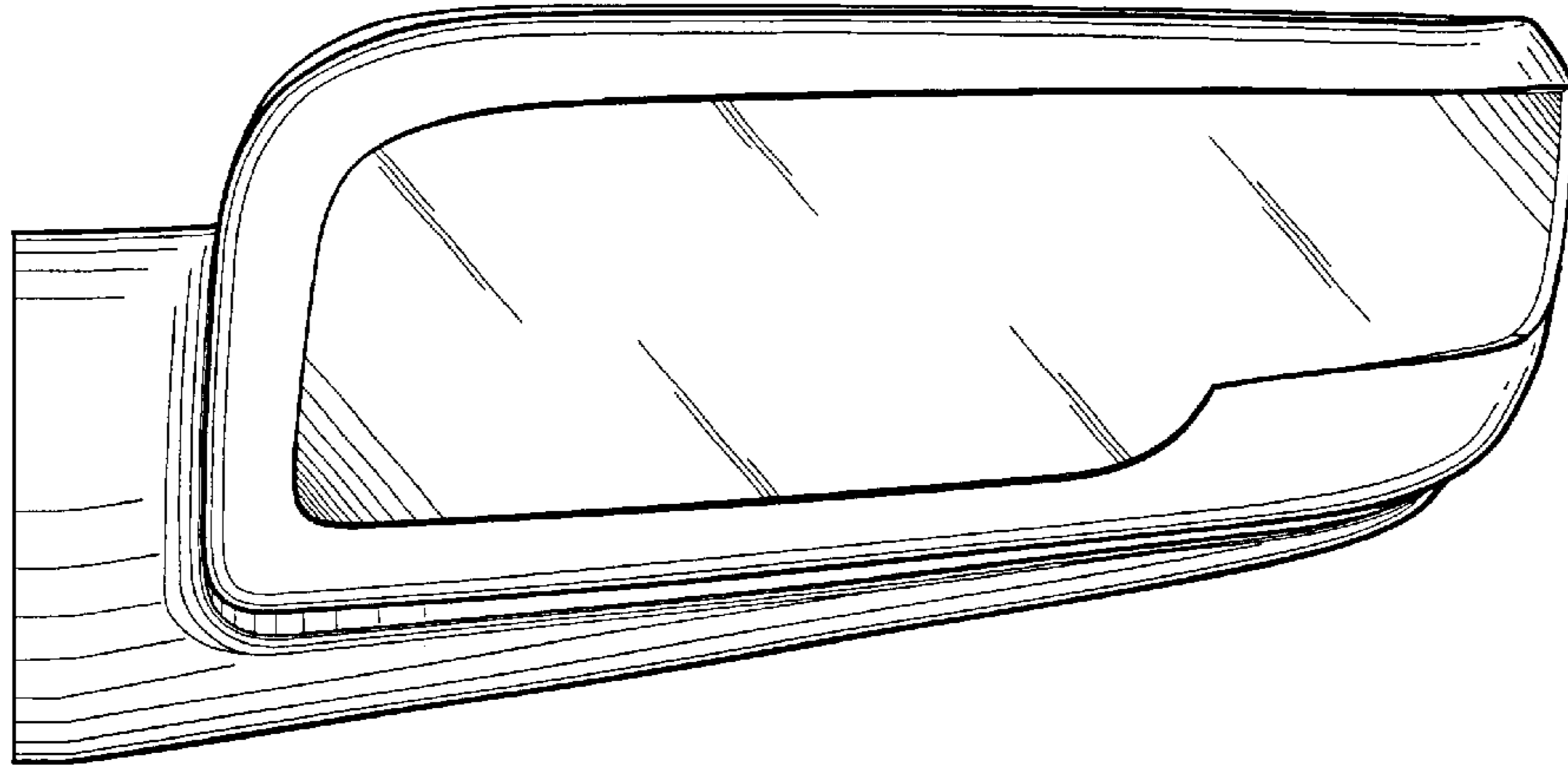

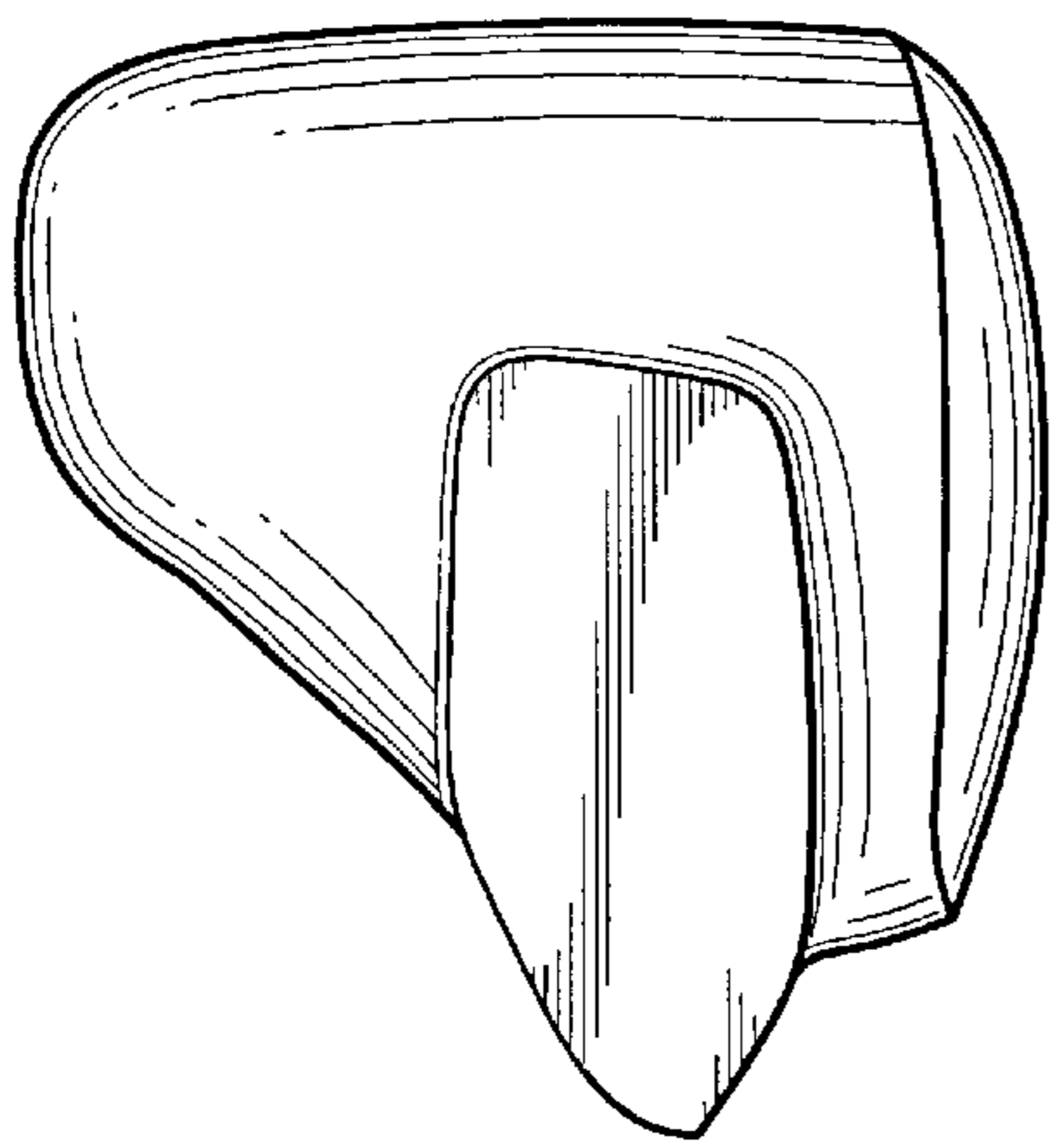

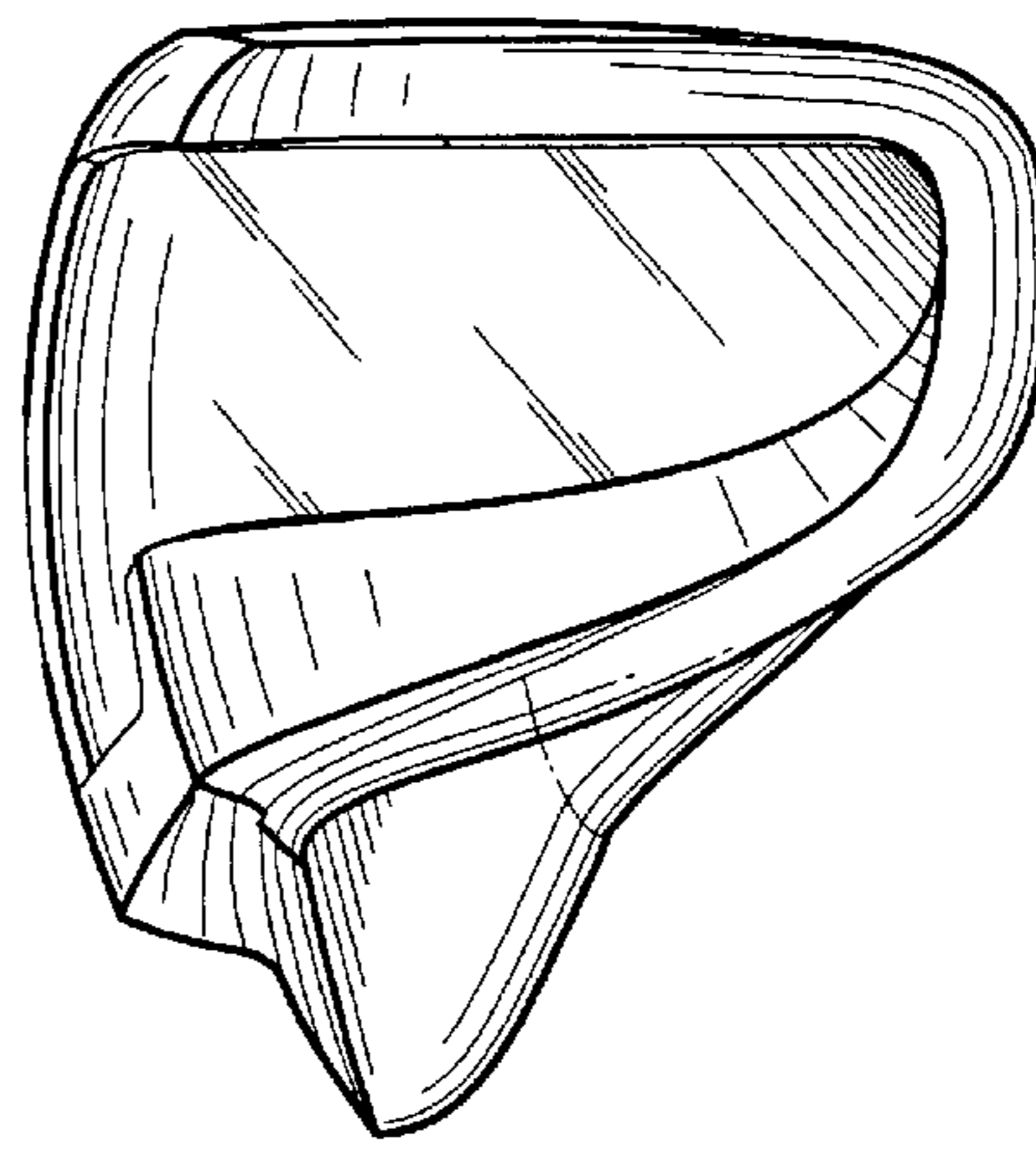

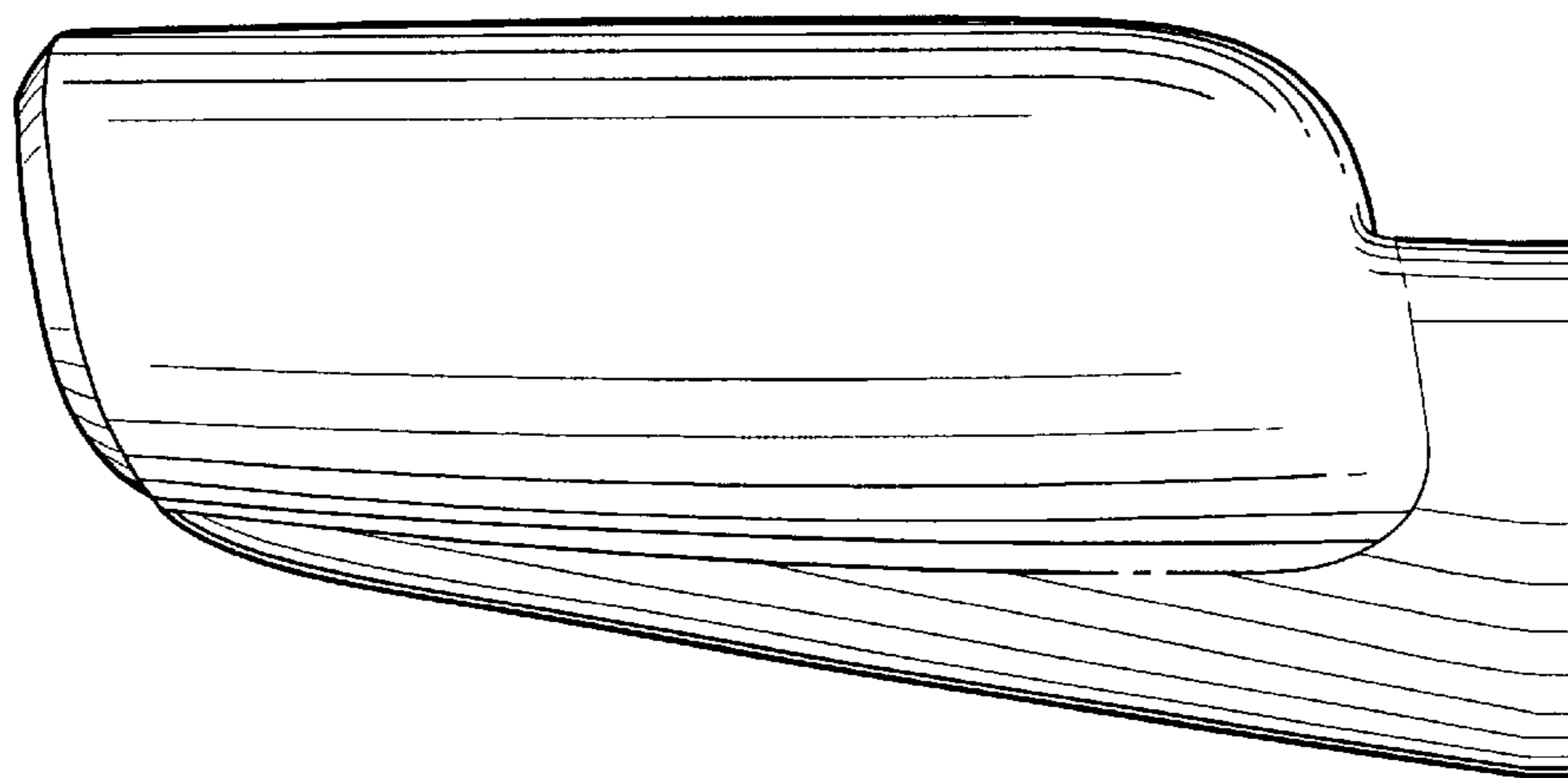

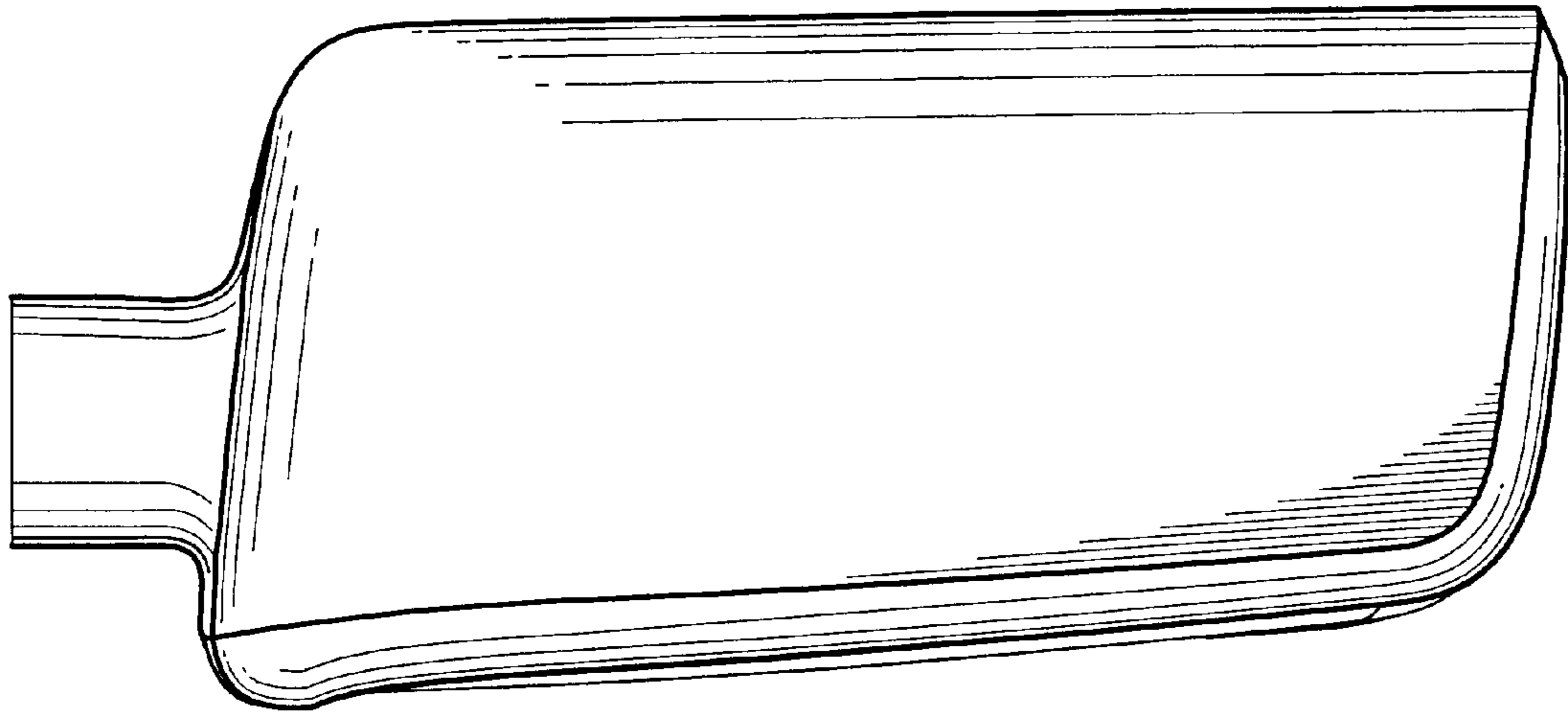

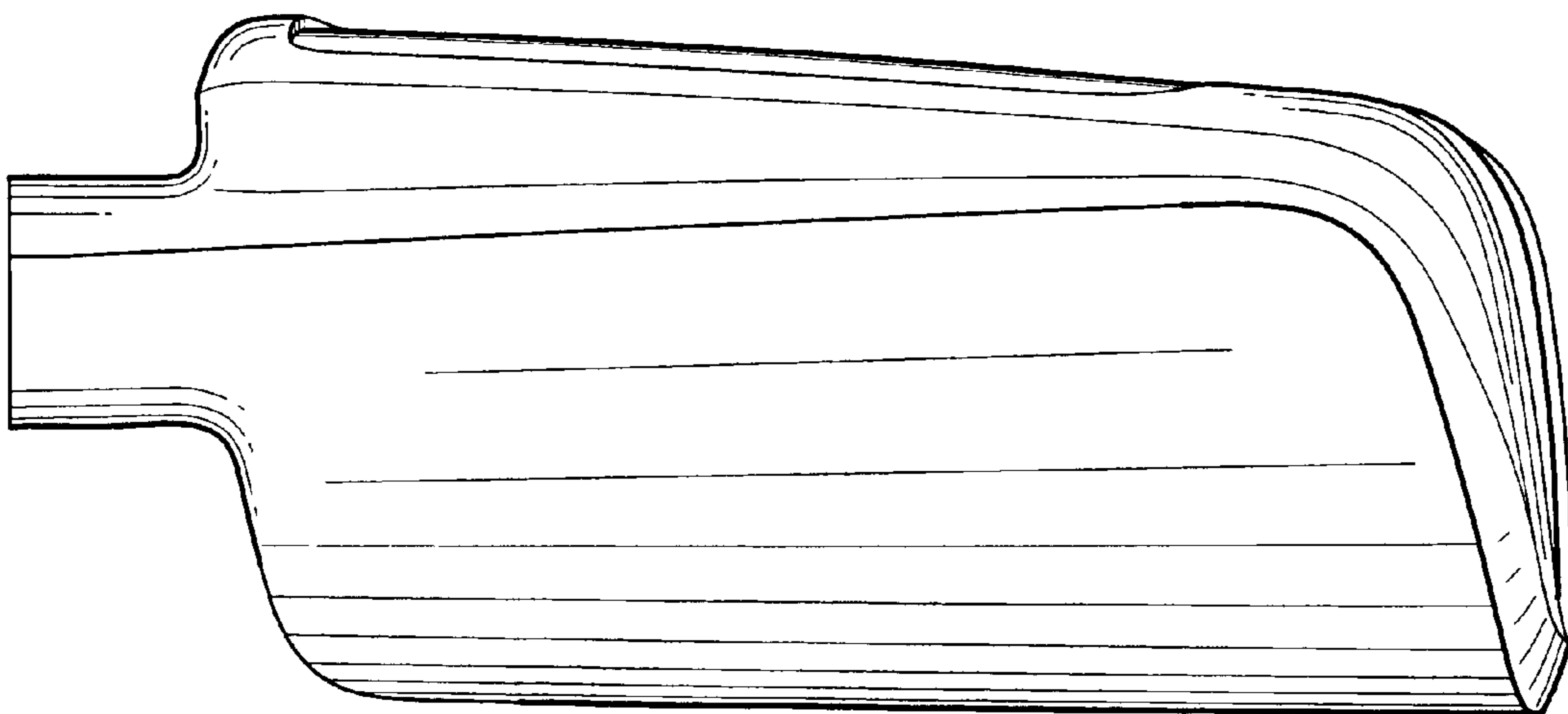
