(57) **CLAIM**

The ornamental design for a transport and display case for a golf set, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the transport and display case for a golf set.

FIG. 2 is a front elevational view of the transport and display case for a golf set.

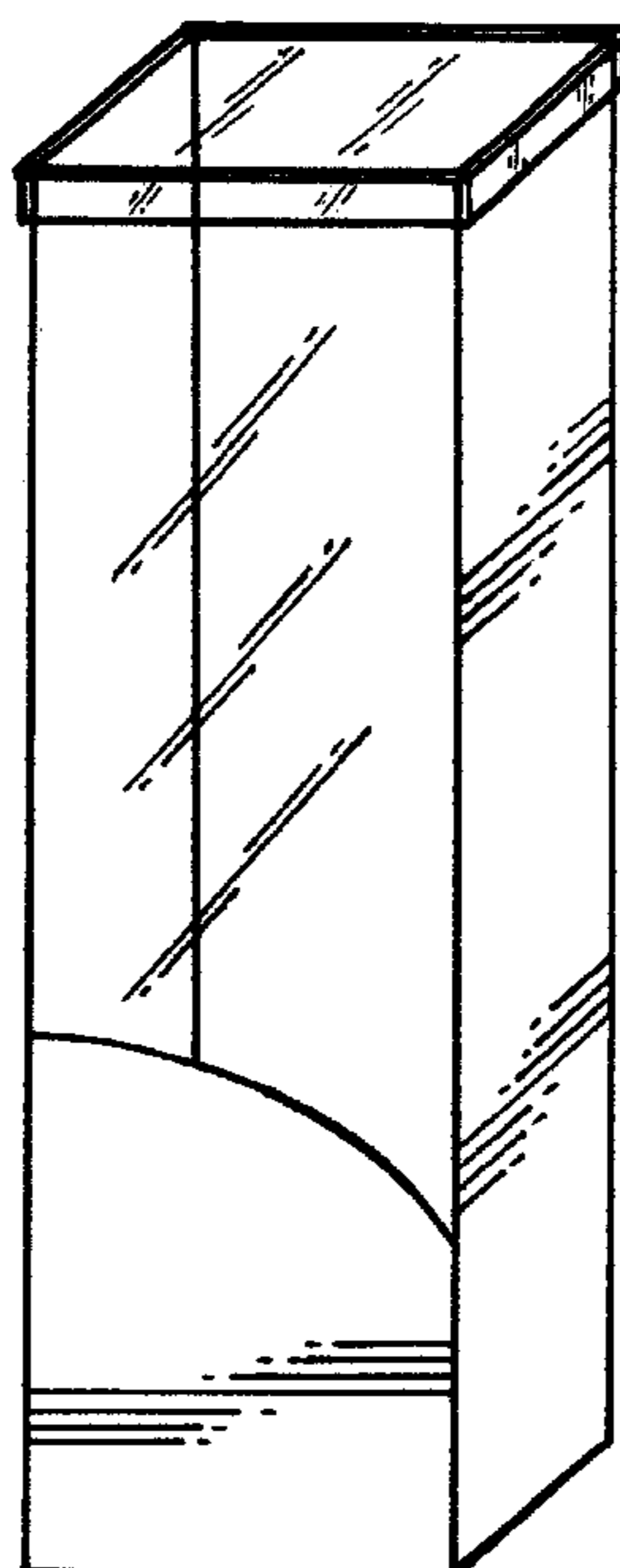
FIG. 3 is a right elevational view of the transport and display case for a golf set. The left side view is a mirror image of the right side view.

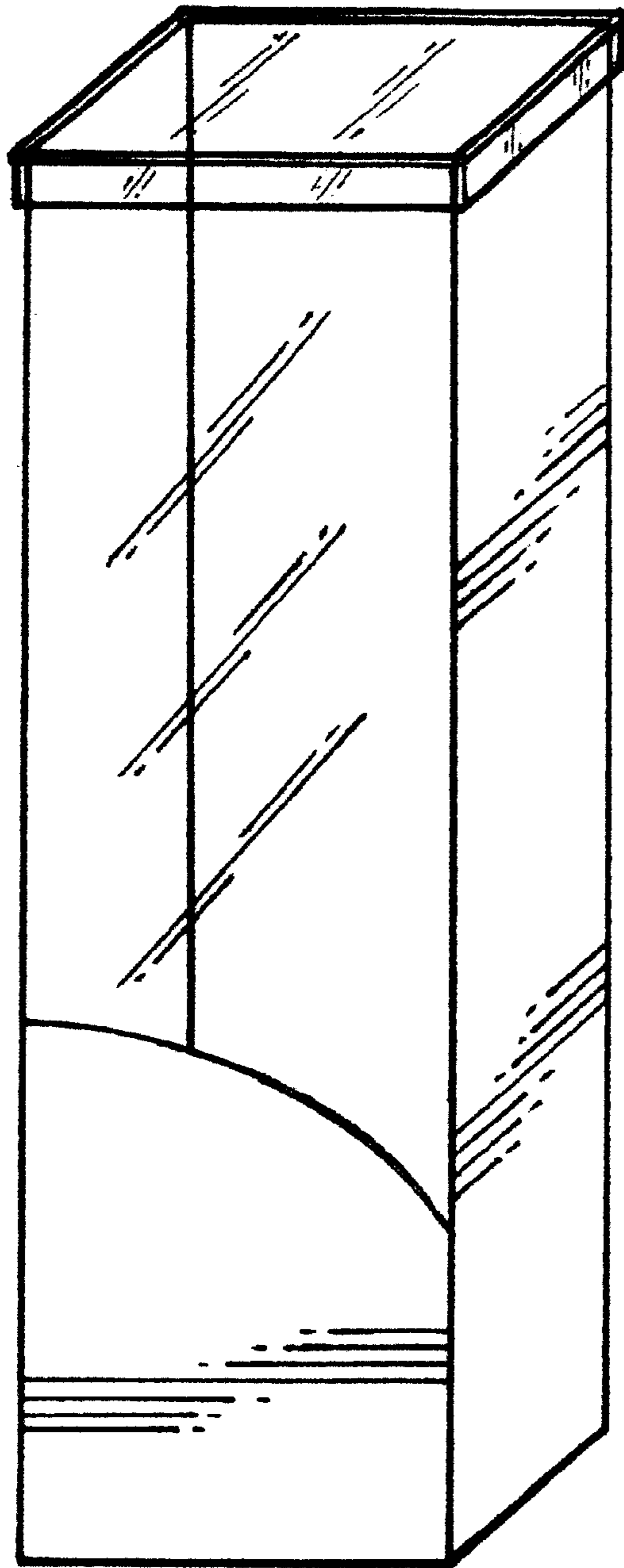

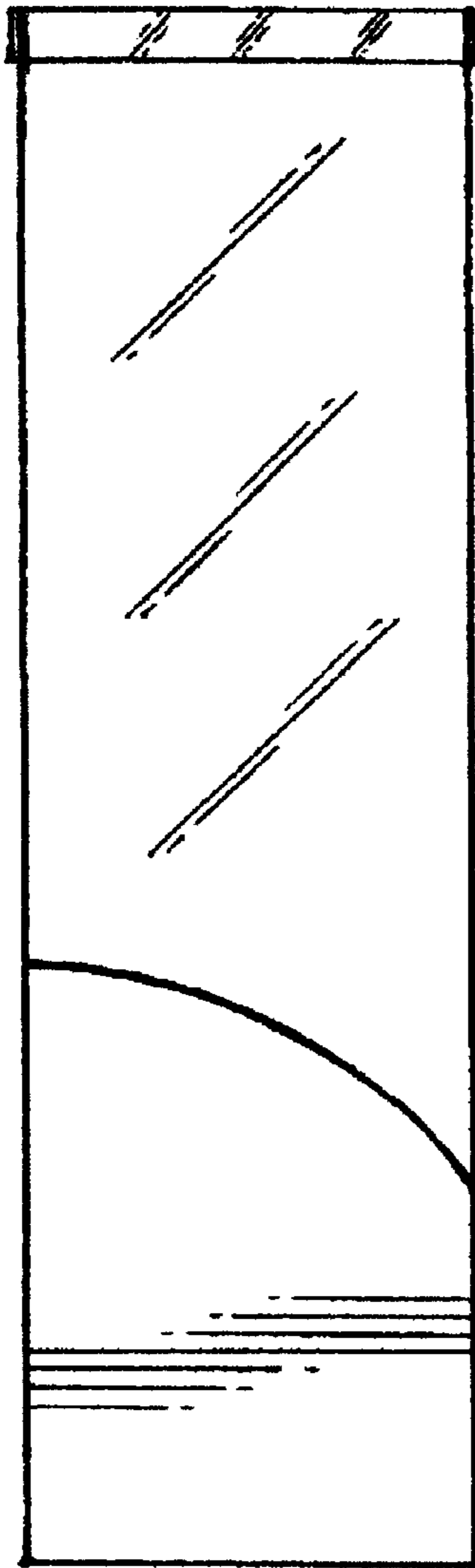

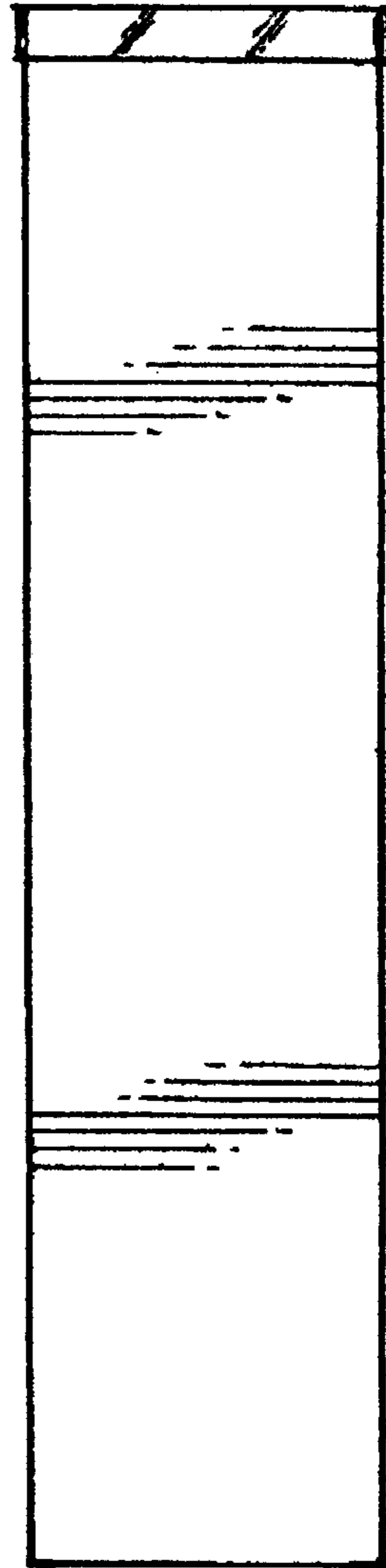

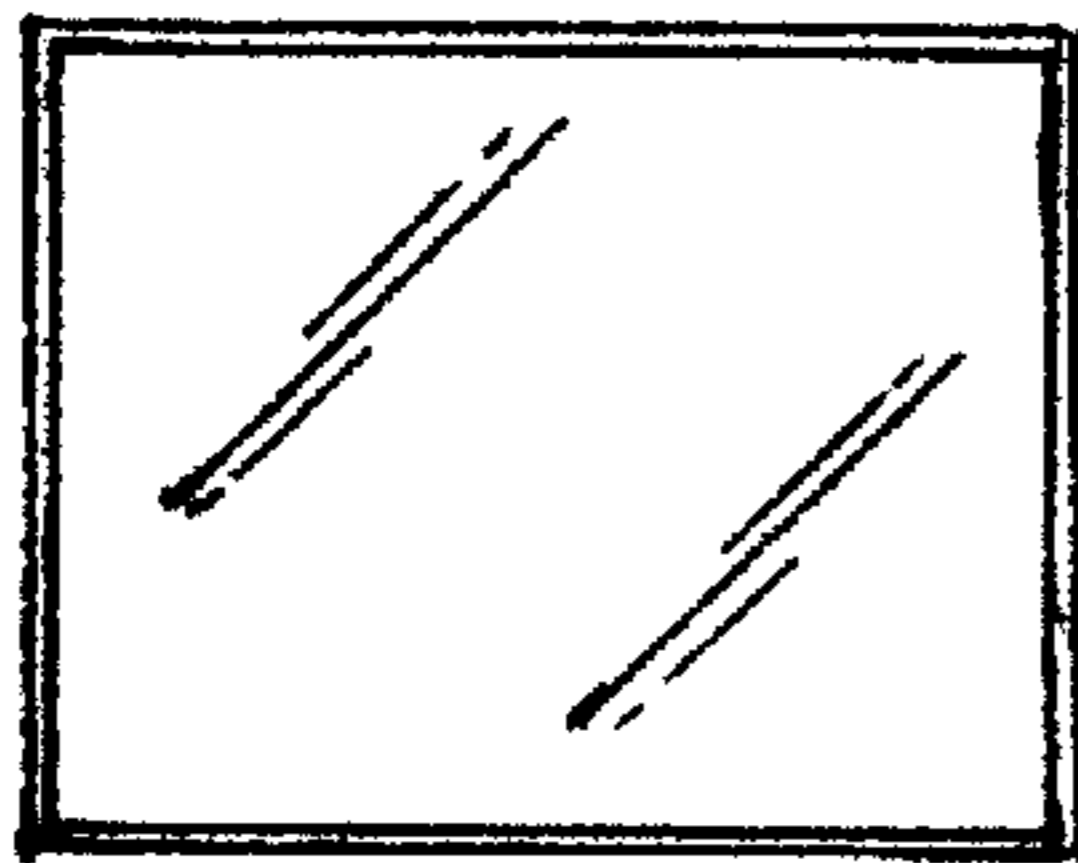

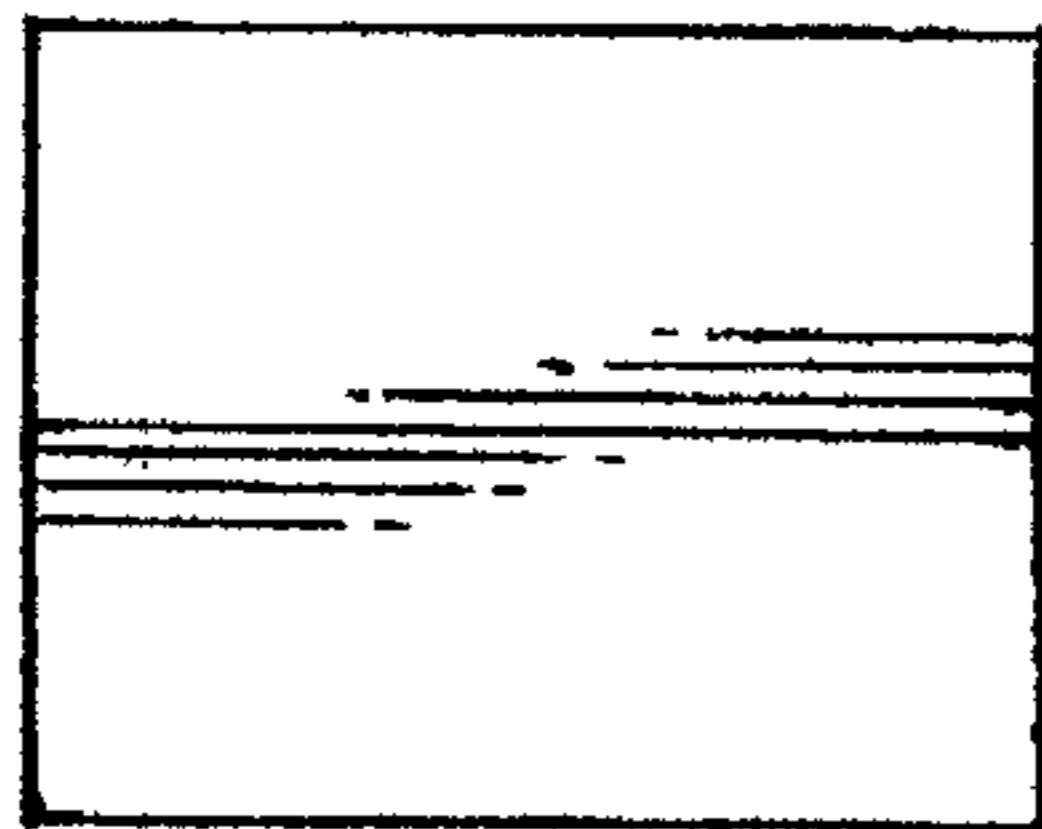

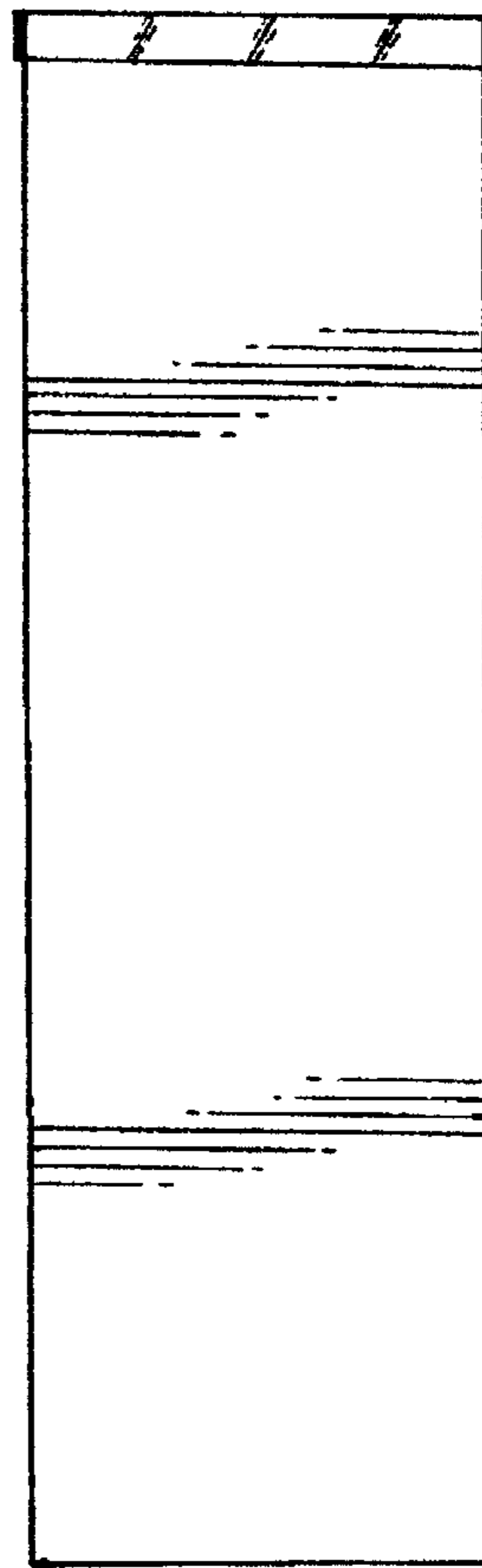
