FIG. 6 is a left side view of my new and novel design;

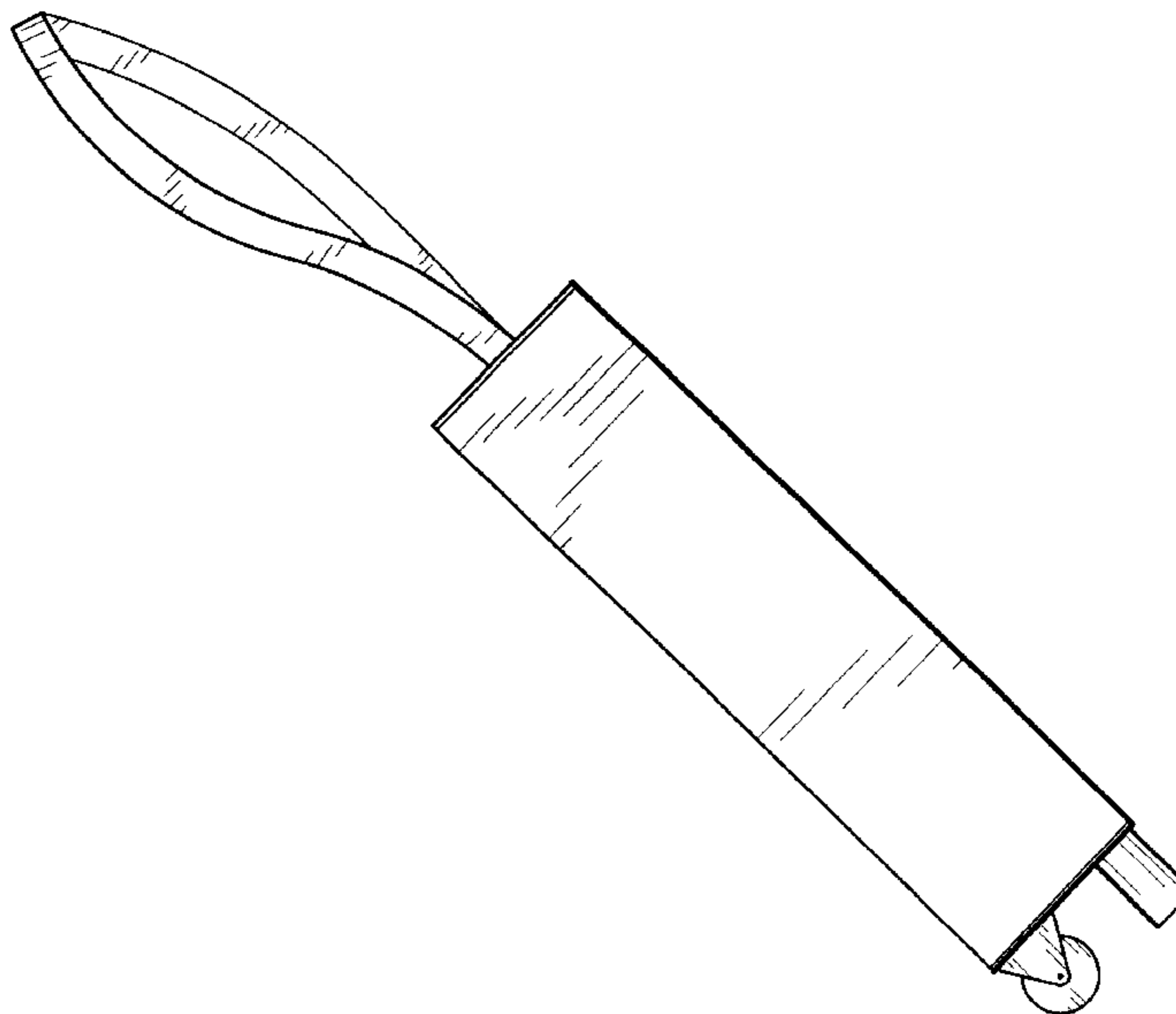
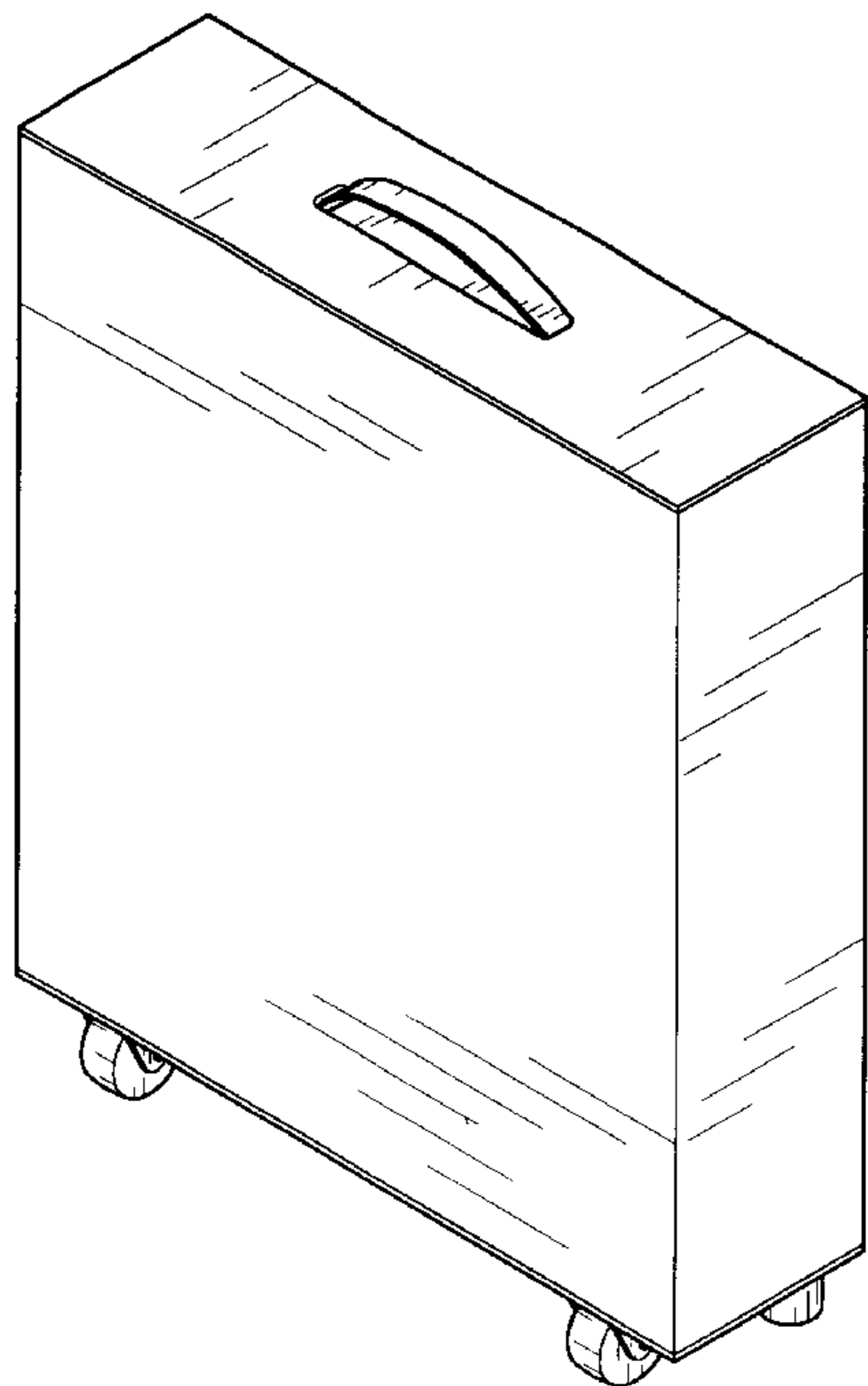
FIG. 7 is a top view of my new and novel design;

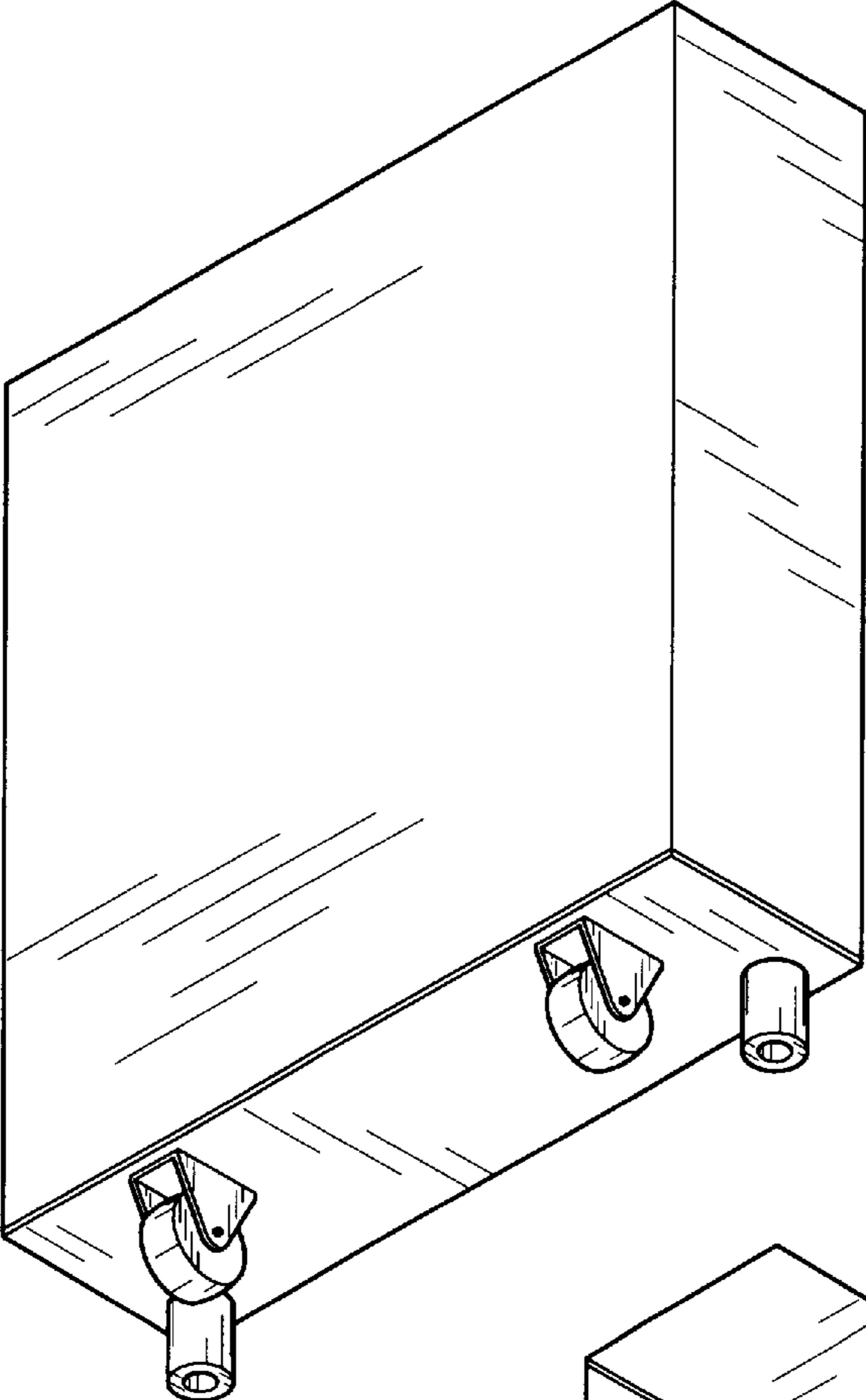
FIG. 8 is a bottom view of my new and novel design;

FIG. 9 is a front perspective view of my new and novel design with the handle strap extended; and,

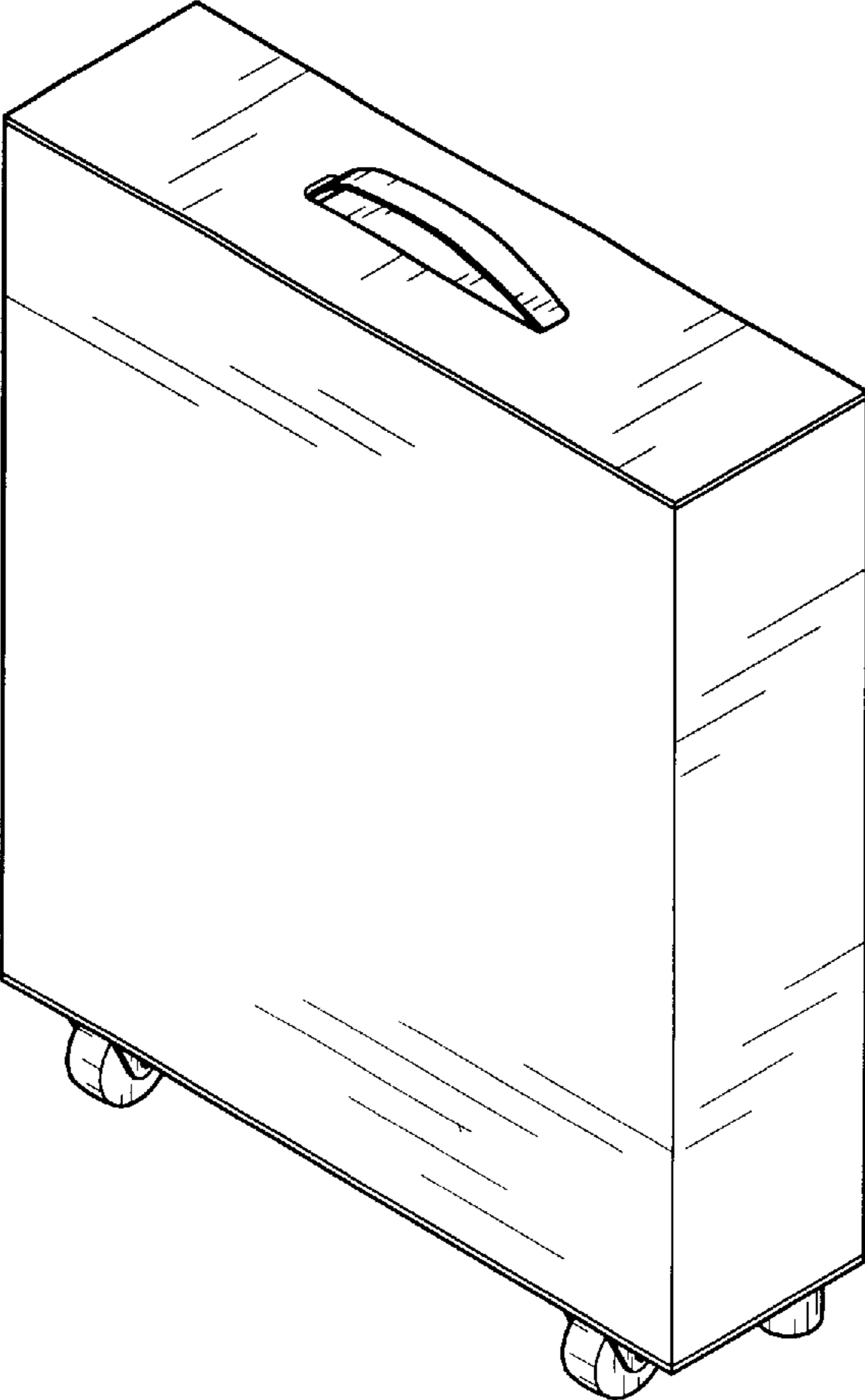
FIG. 10 is a right side view of my new and novel design in a tilted position with the handle strap extended.

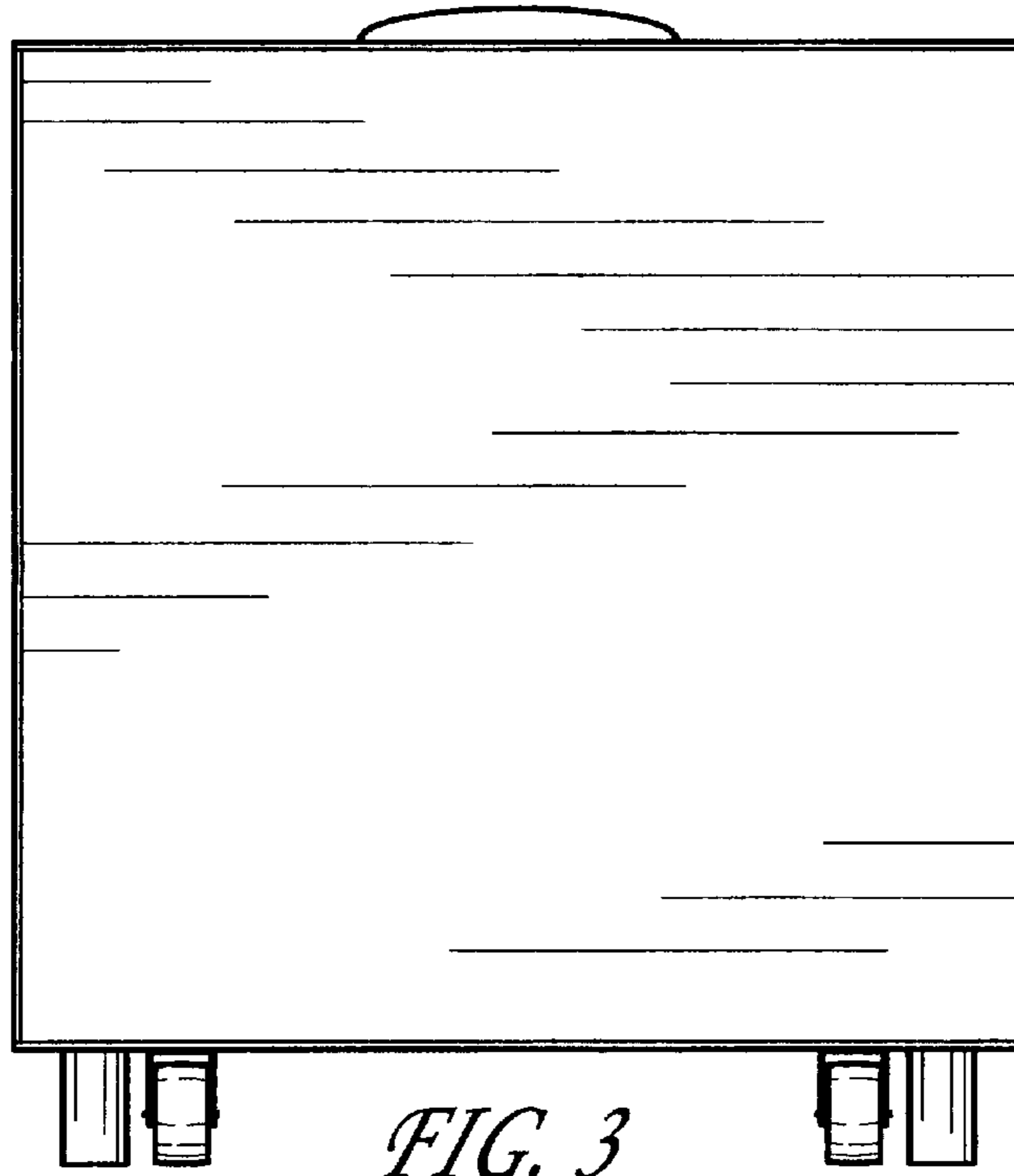




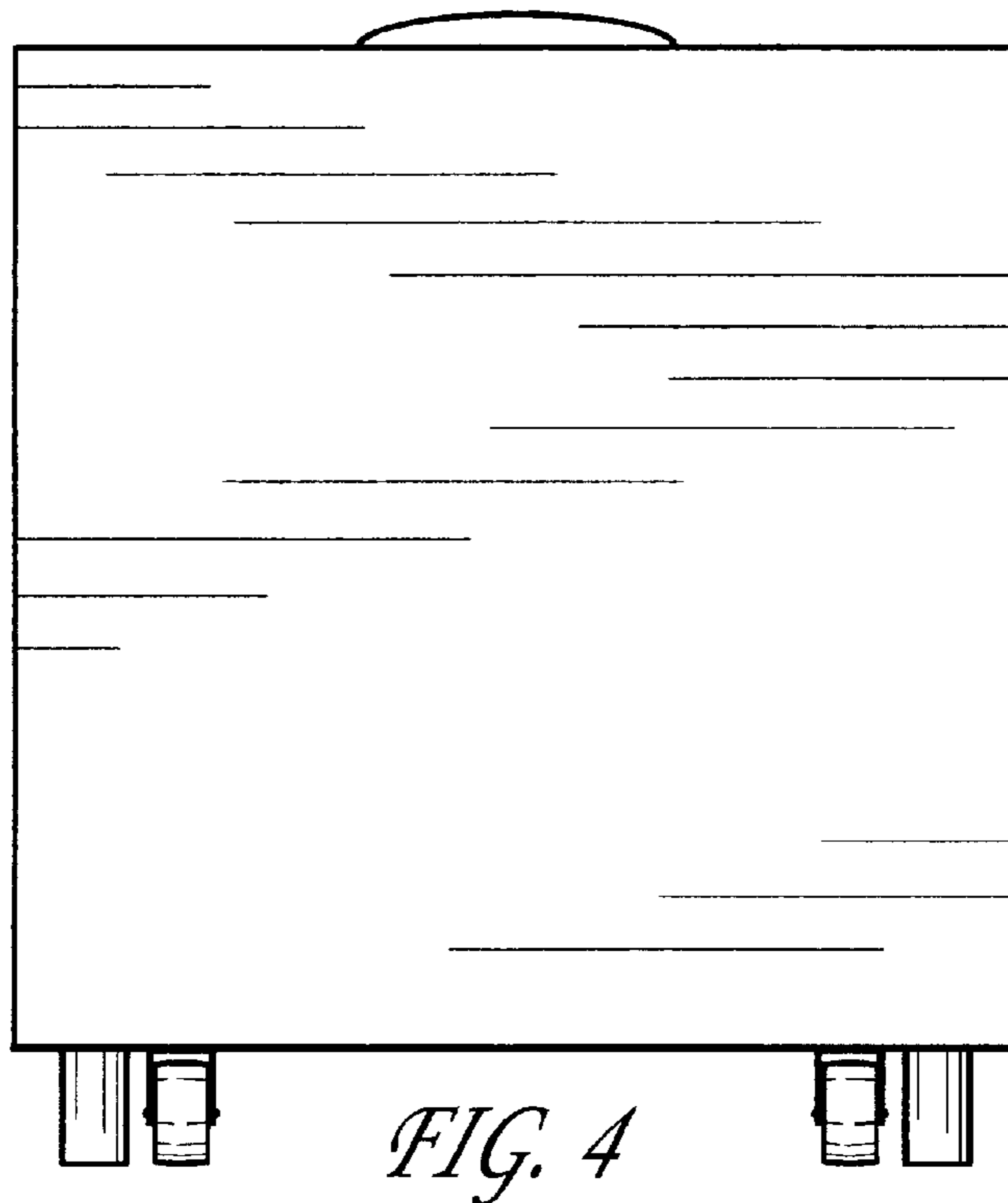

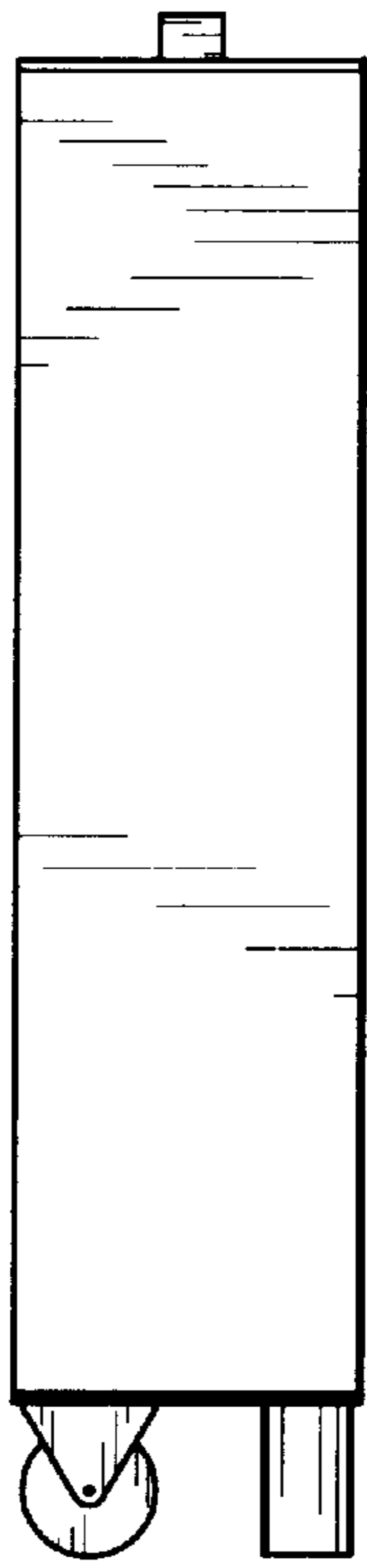

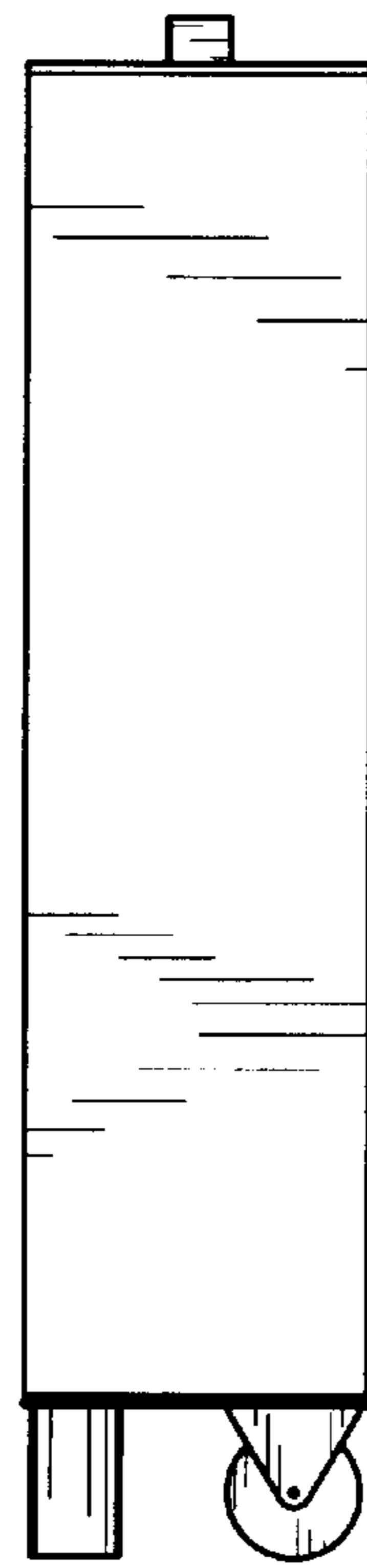

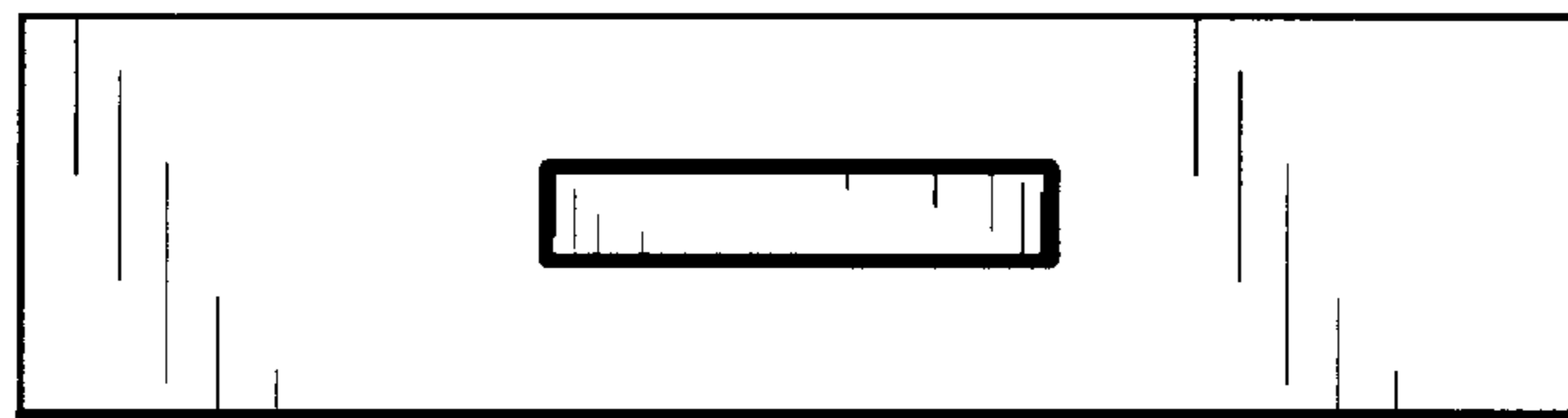

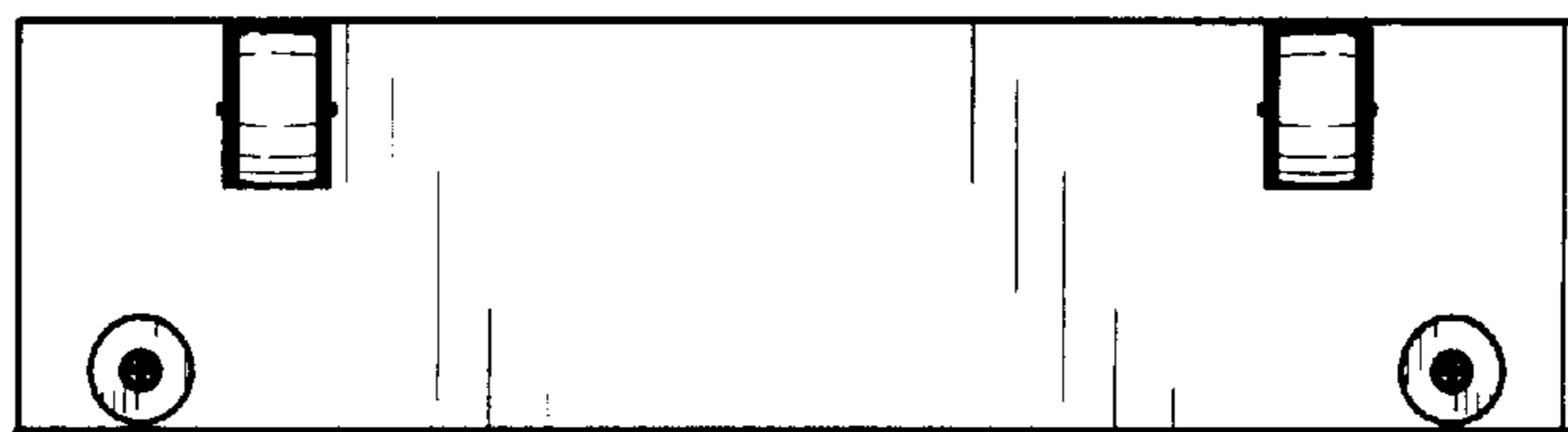

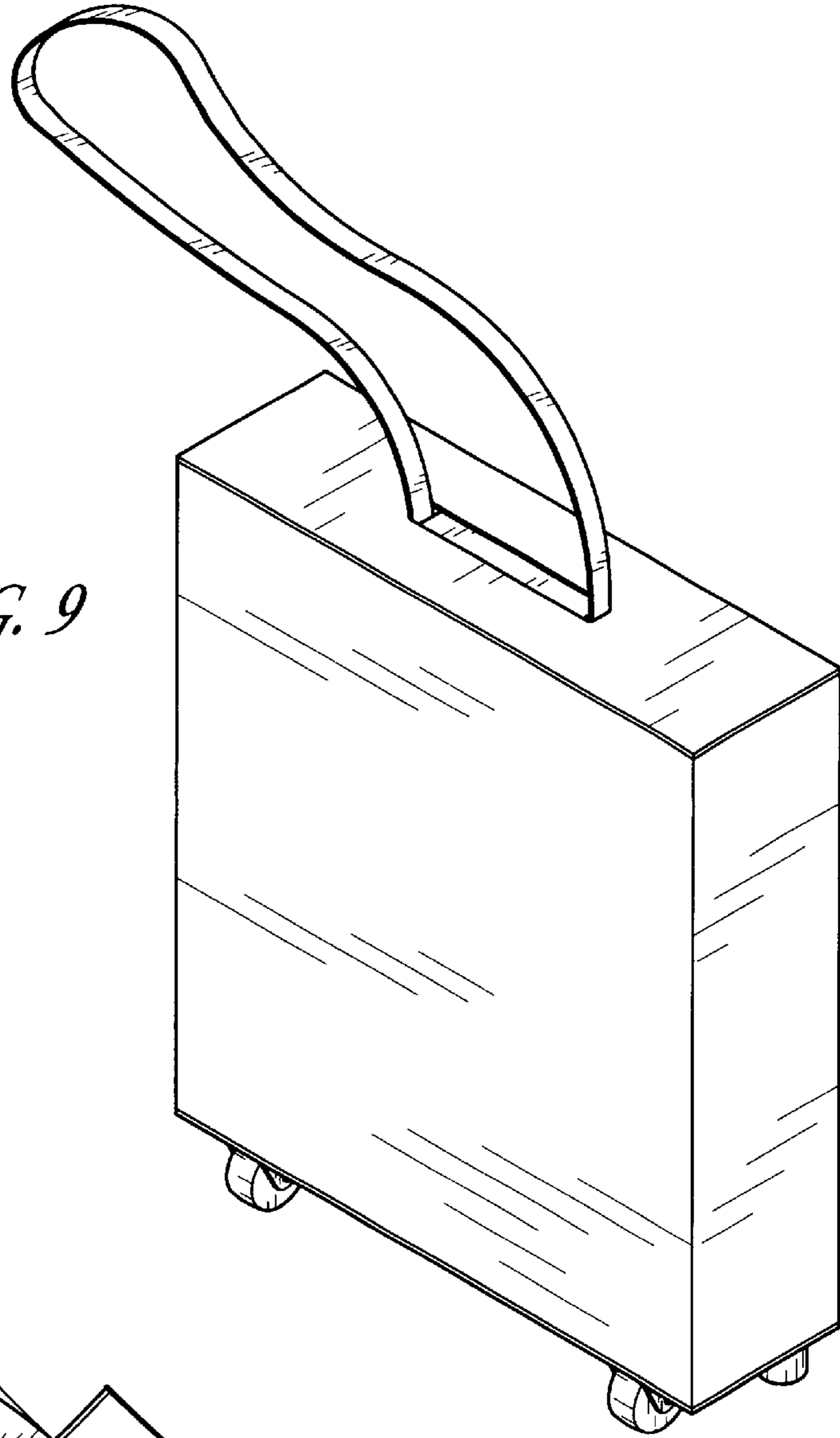
