FIG. 1 is a front elevational view of a dresser according to an embodiment of the invention.

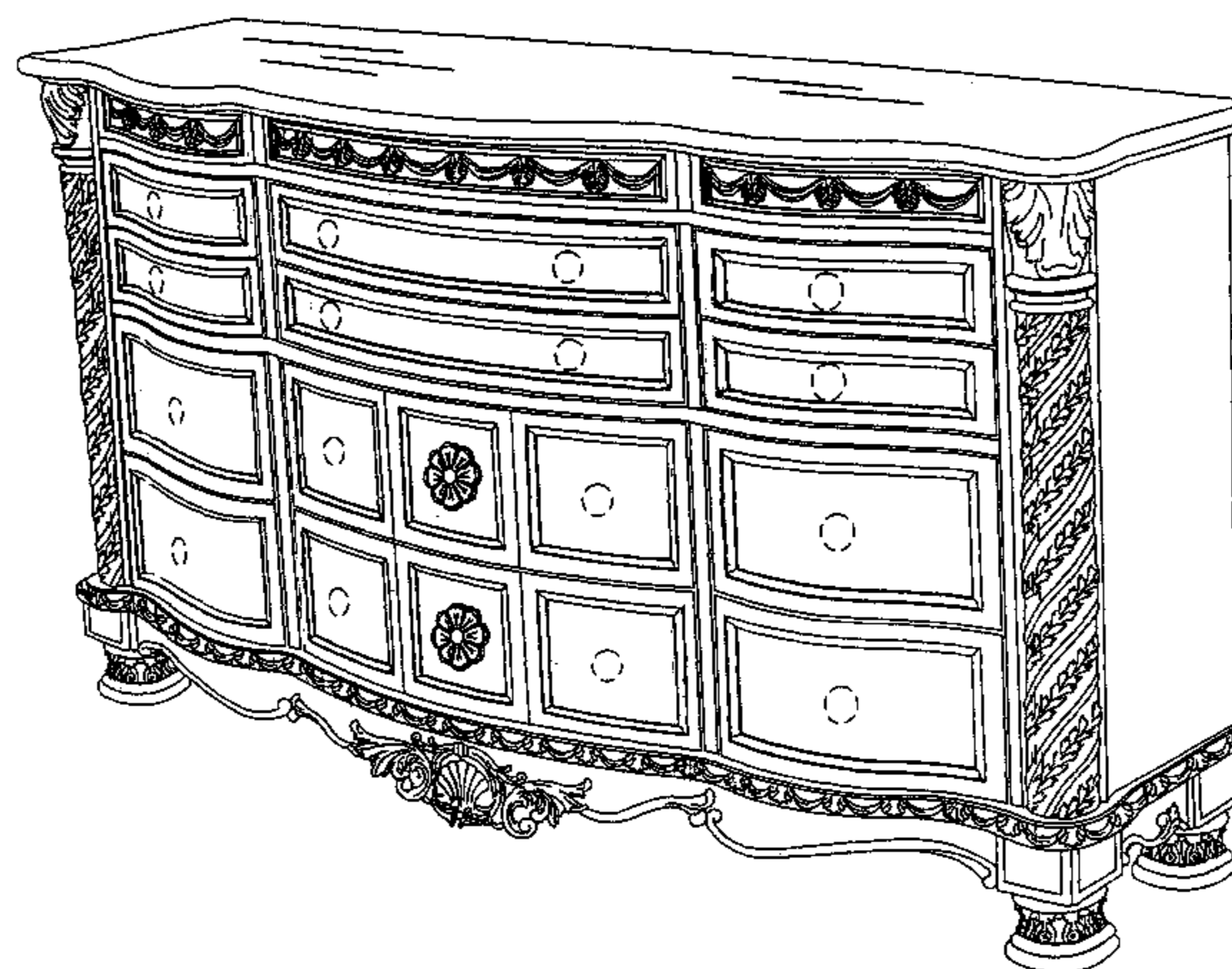
FIG. 2 is a right front perspective view of a dresser according to an embodiment of the invention.

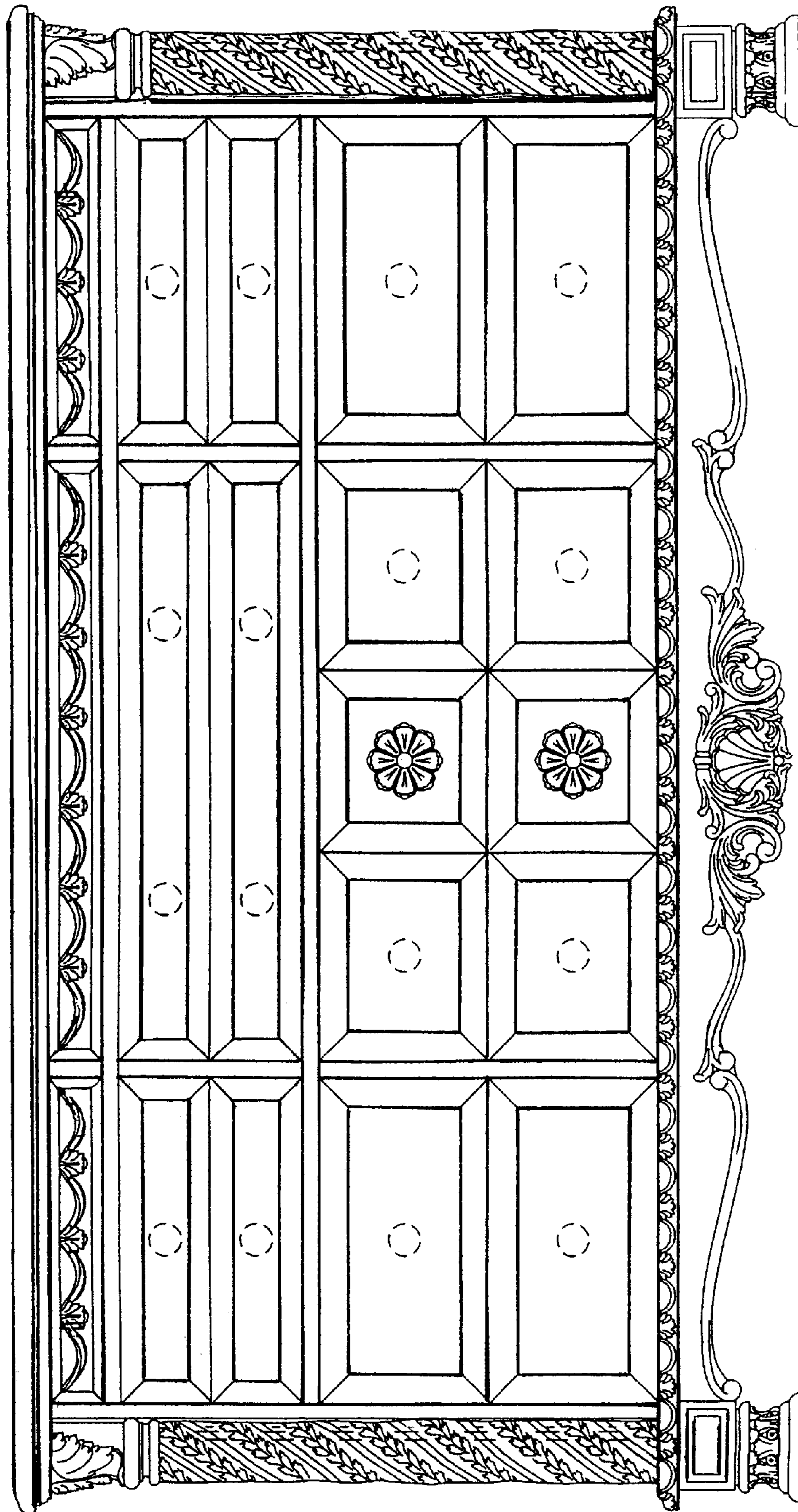

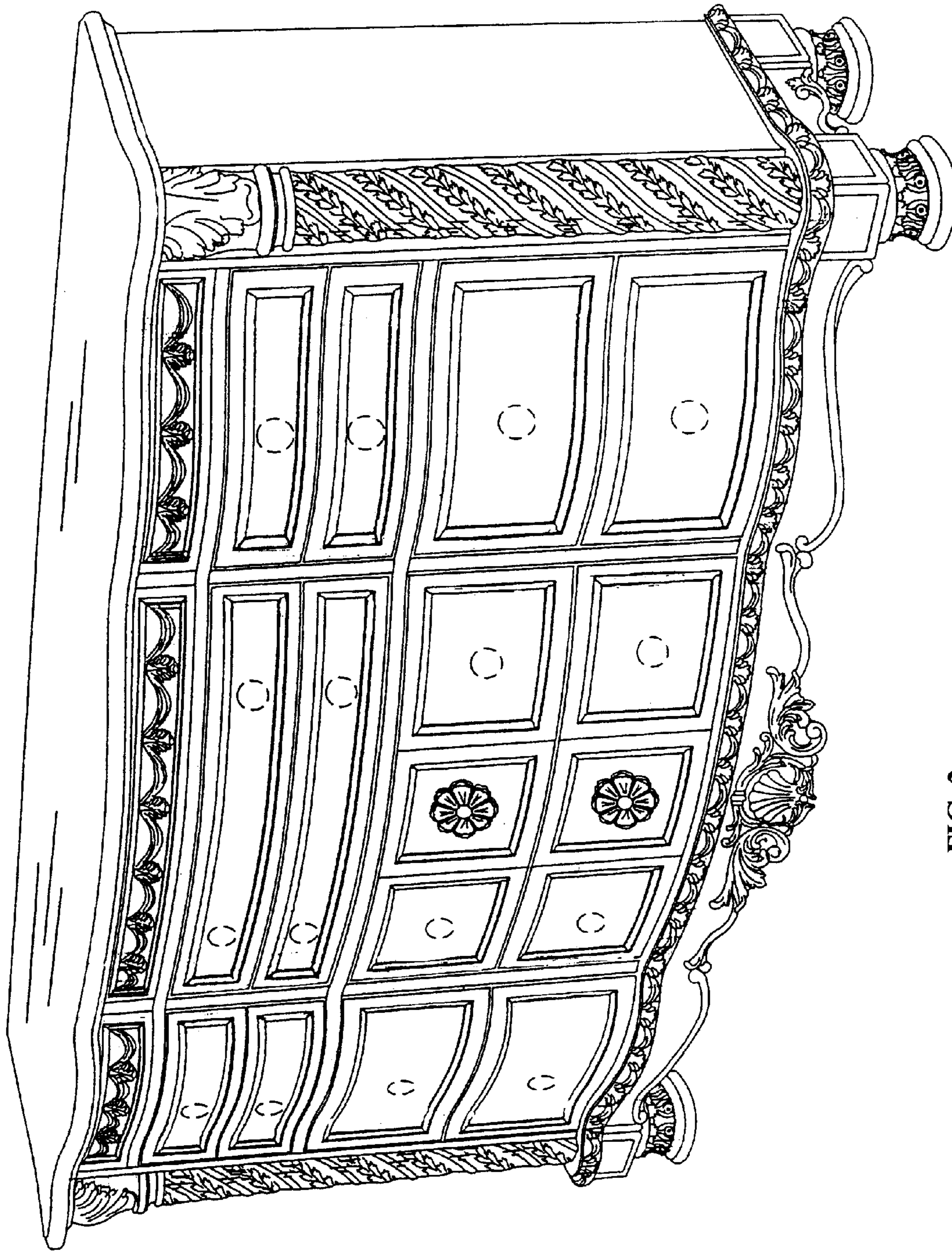

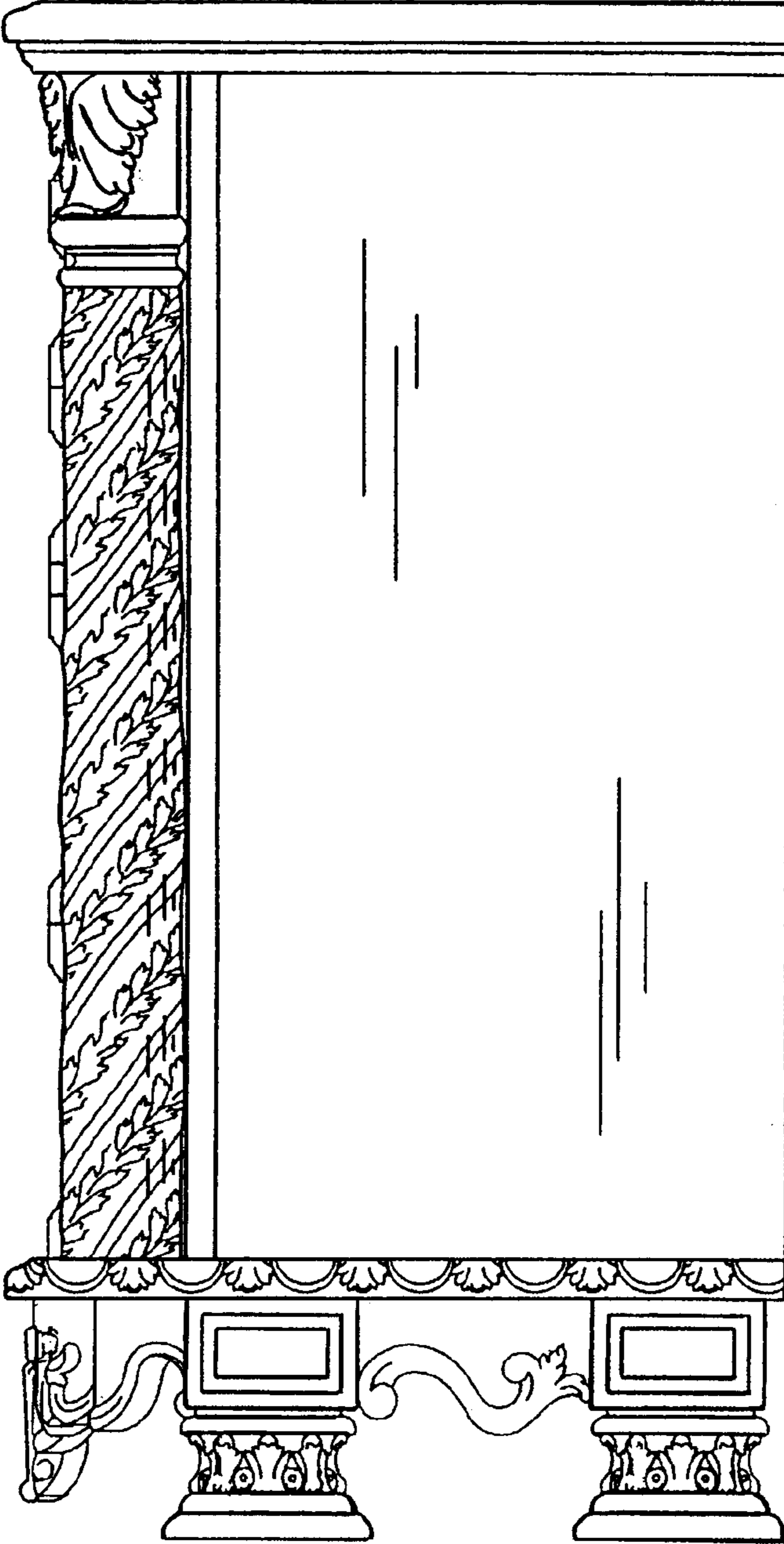

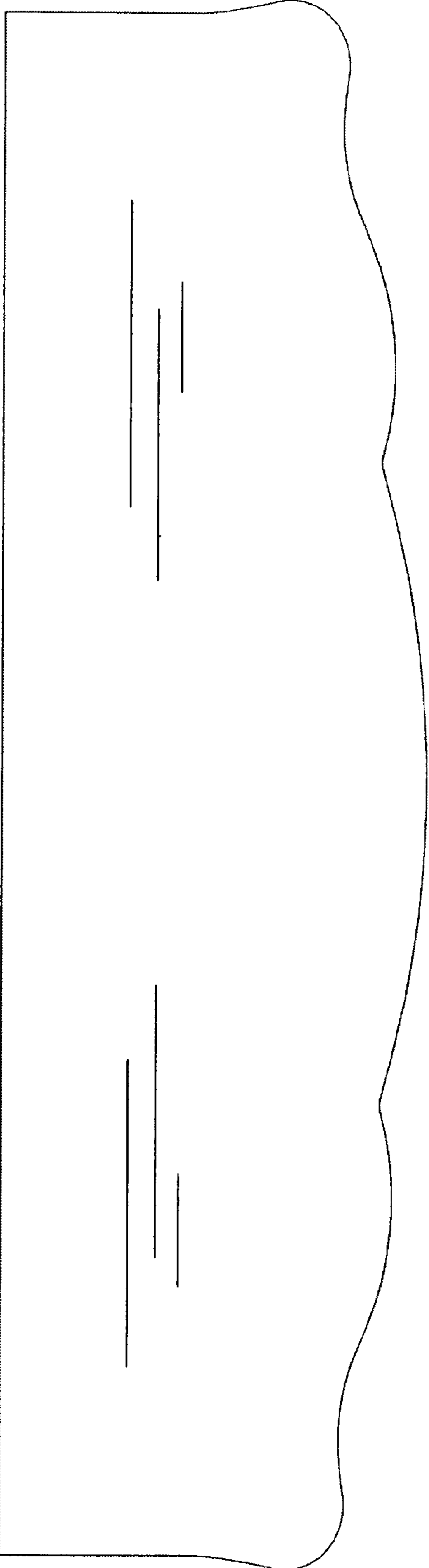
