(57) **CLAIM**

The ornamental design for the scissors, as shown and described in the accompanying figures.

**DESCRIPTION**

FIG. 1 is a perspective view of the scissors according to the present invention;

FIG. 2 is a front plan view of the scissors of FIG. 1;

FIG. 3 is a rear plan view of the scissors, rotated 180 degrees from the view of FIG. 2, of the scissors of FIG. 1;

FIG. 4 is a left side view of the scissors of FIG. 1, the right side view being a mirror image thereof;

FIG. 5 is a first end view of the scissors of FIG. 1; and

FIG. 6 is a second, opposite end view of the scissors of FIG. 1;

FIG. 7 is a perspective view of an alternative embodiment of the scissors of FIG. 1;

FIG. 8 is a front plan view of the scissors of FIG. 7;

FIG. 9 is a rear plan view of the scissors, rotated 180 degrees from the view of FIG. 8, of the scissors of FIG. 7;

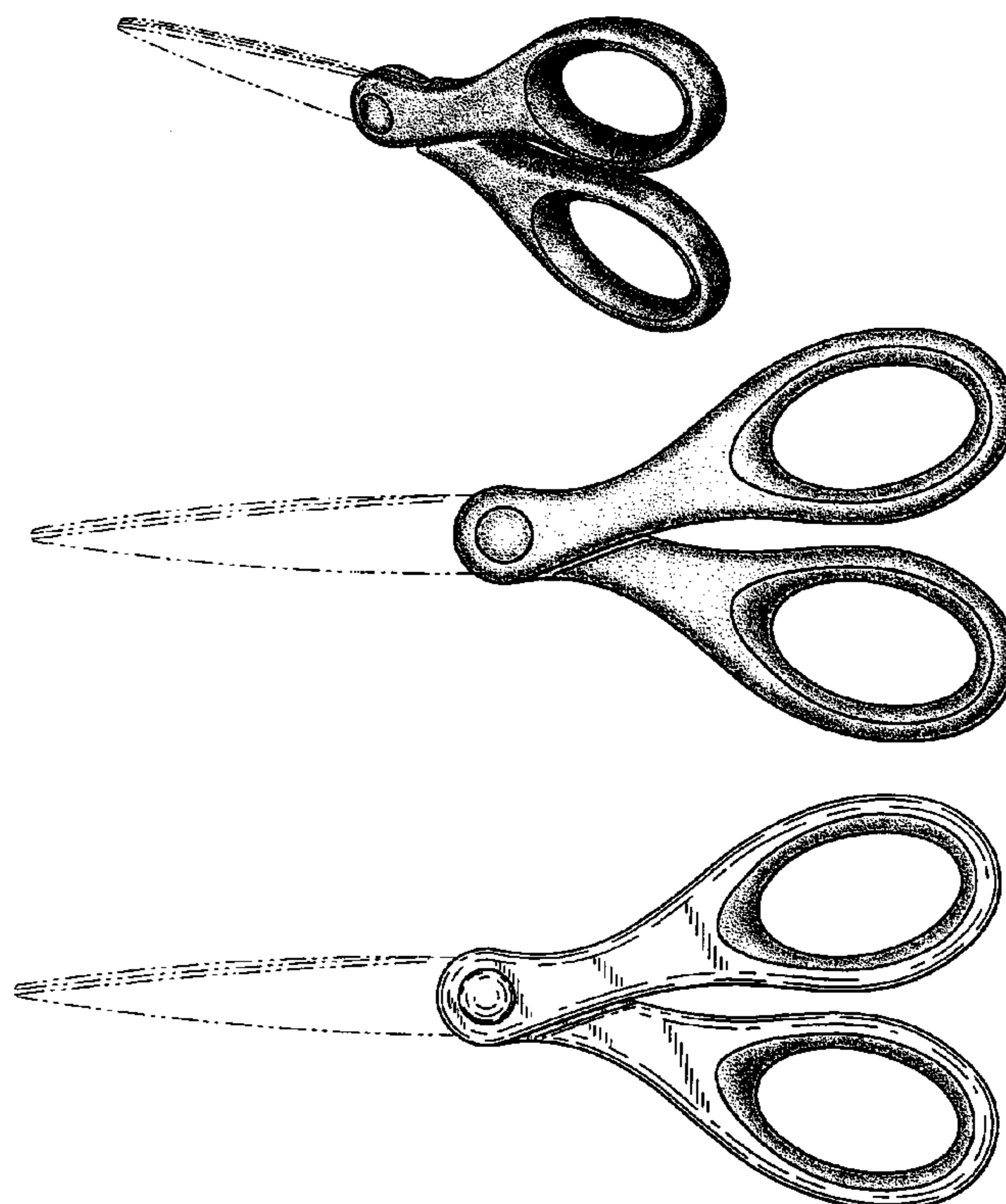
FIG. 10 is a left side view of the scissors of FIG. 7, the right side view being a mirror image thereof;

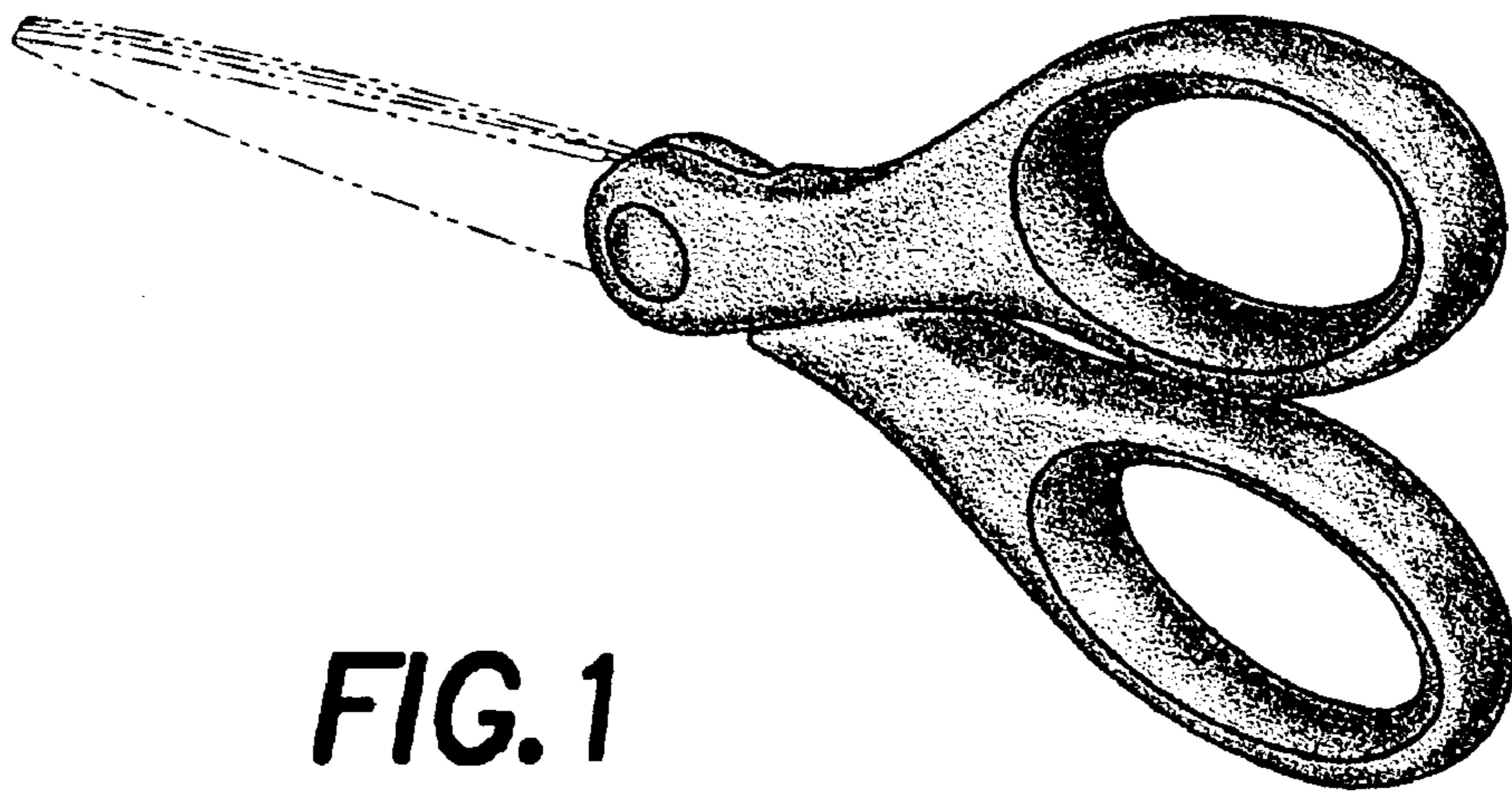
FIG. 11 is a first end view of the scissors of FIG. 7; and,

FIG. 12 is a second, opposite end view of the scissors of FIG. 7.

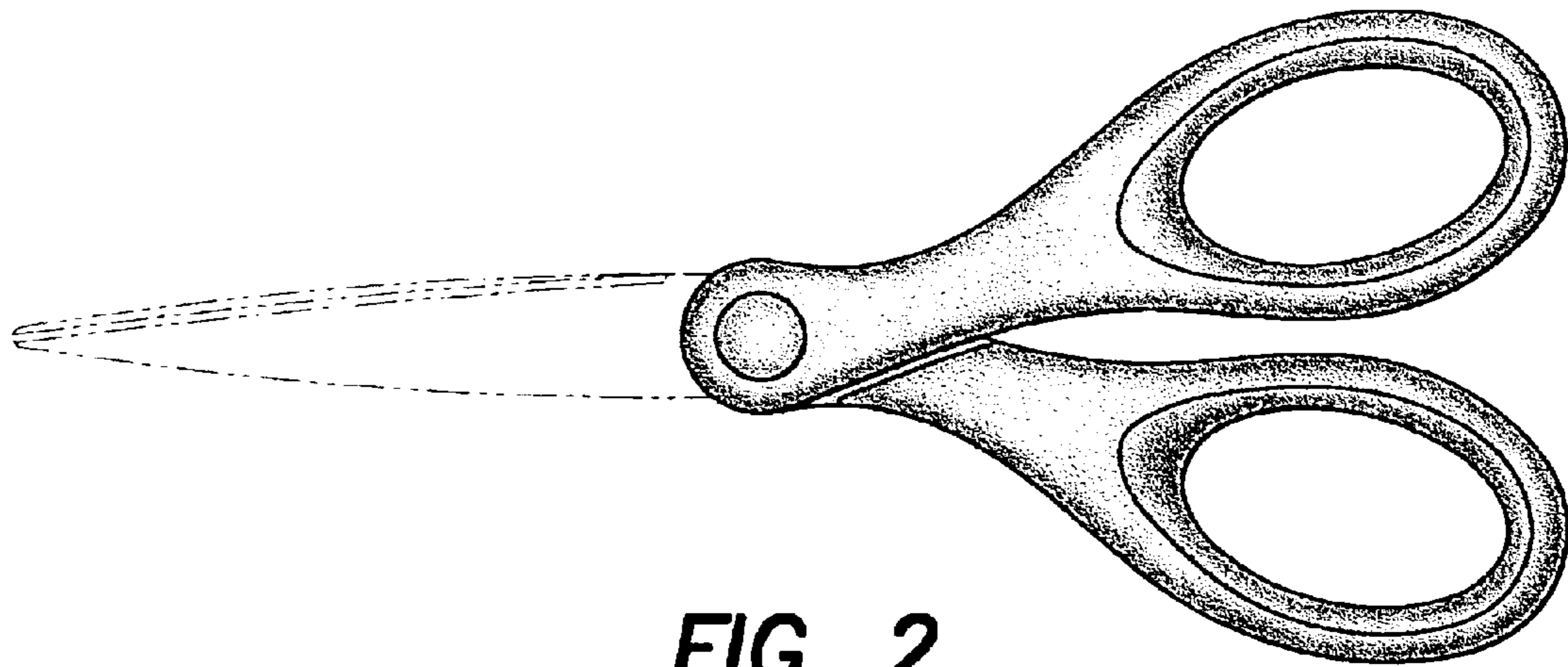

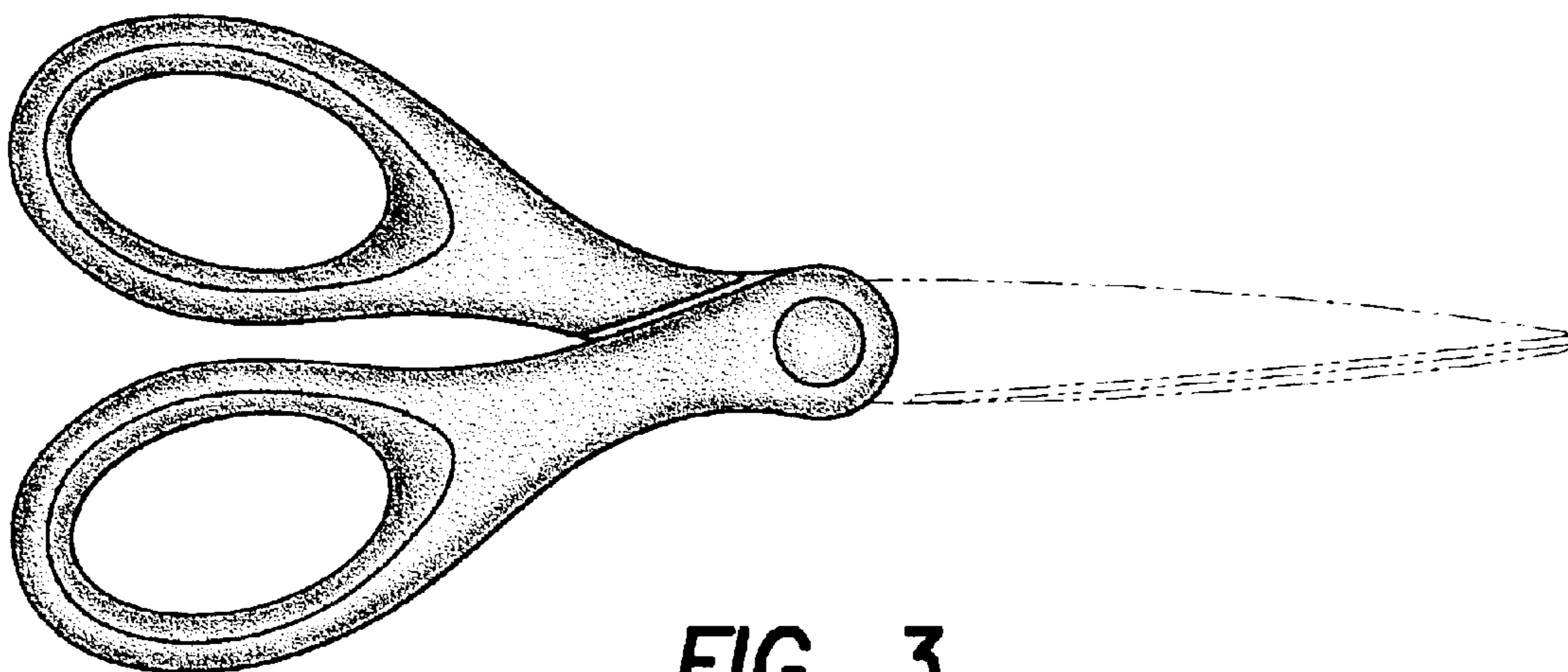




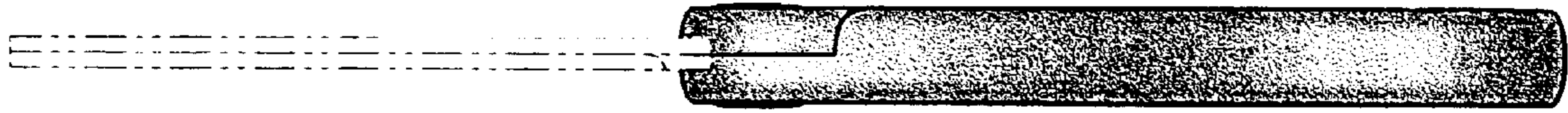

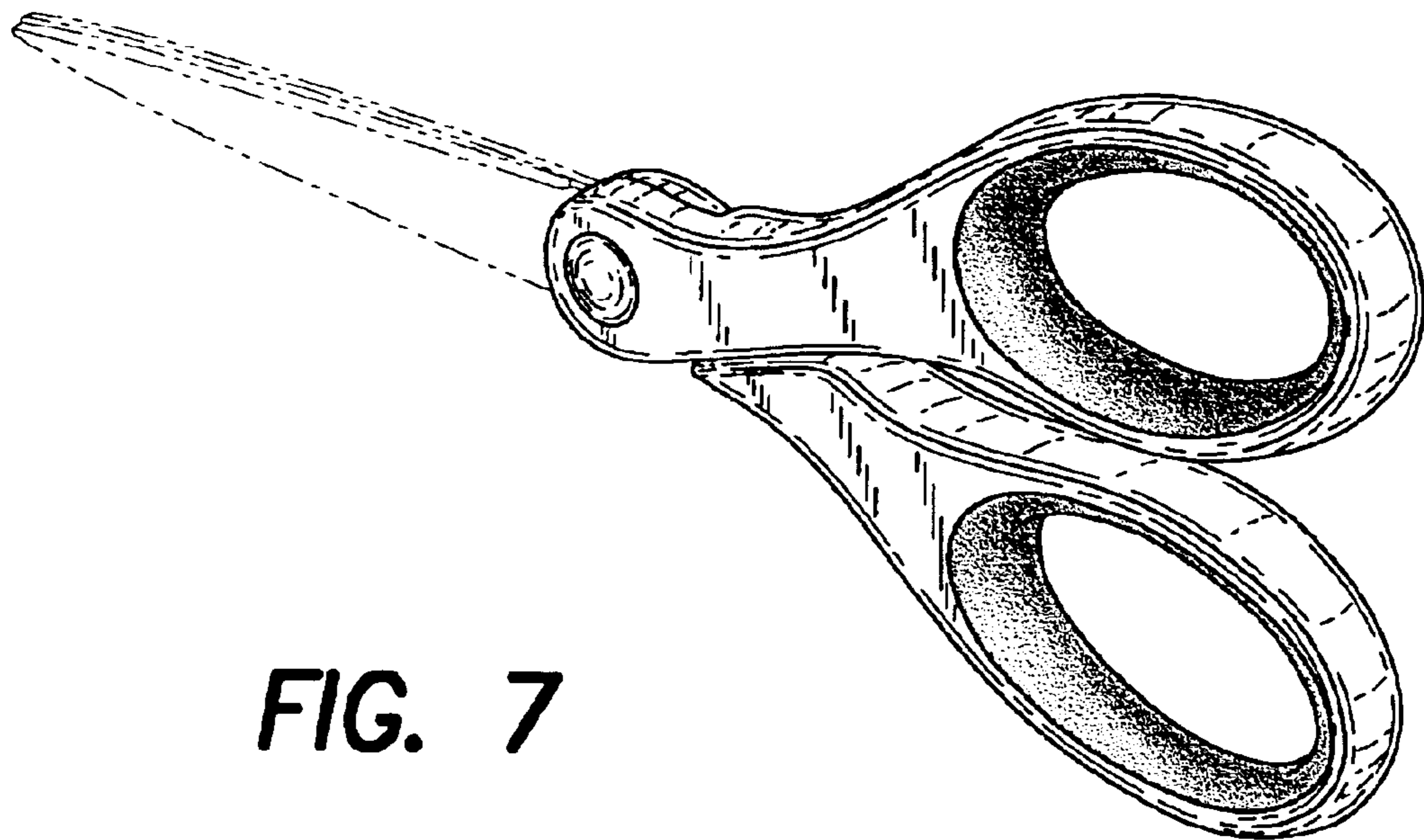

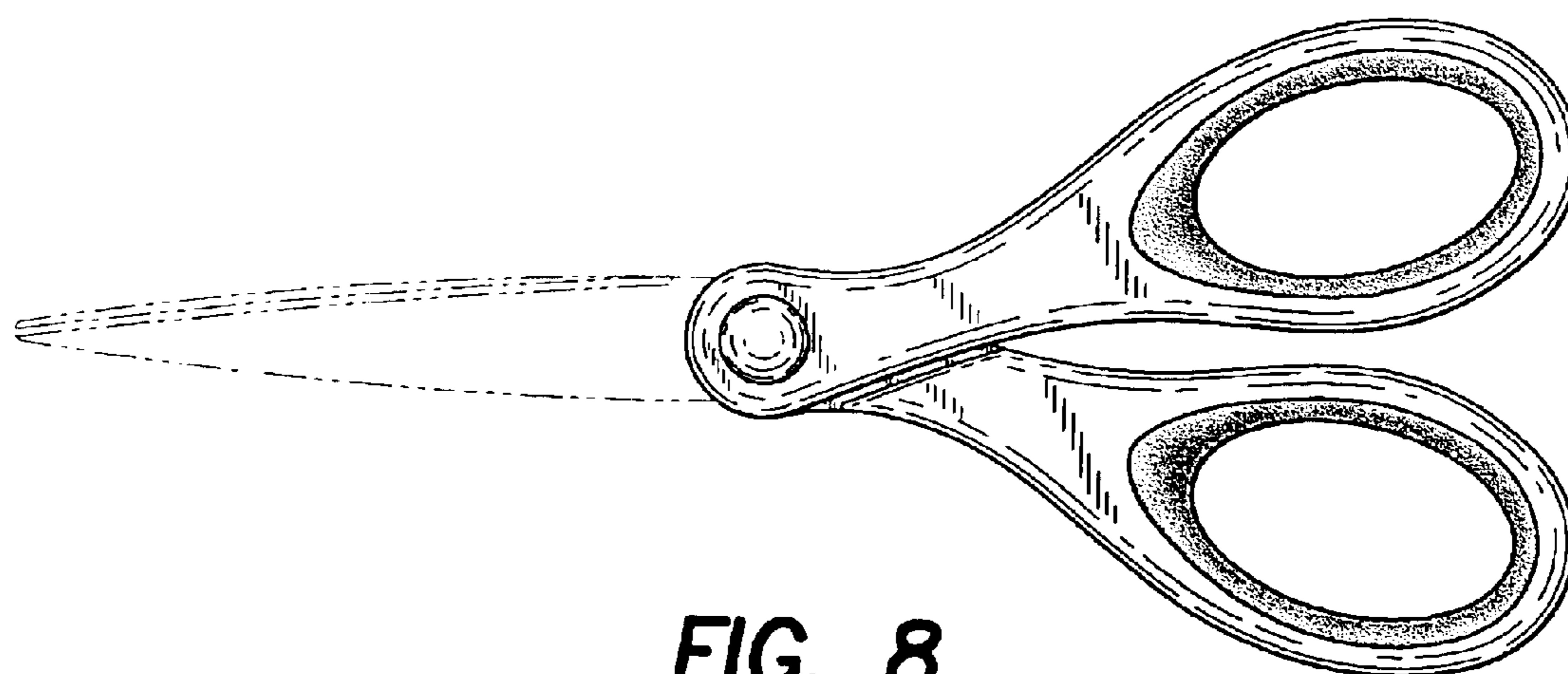

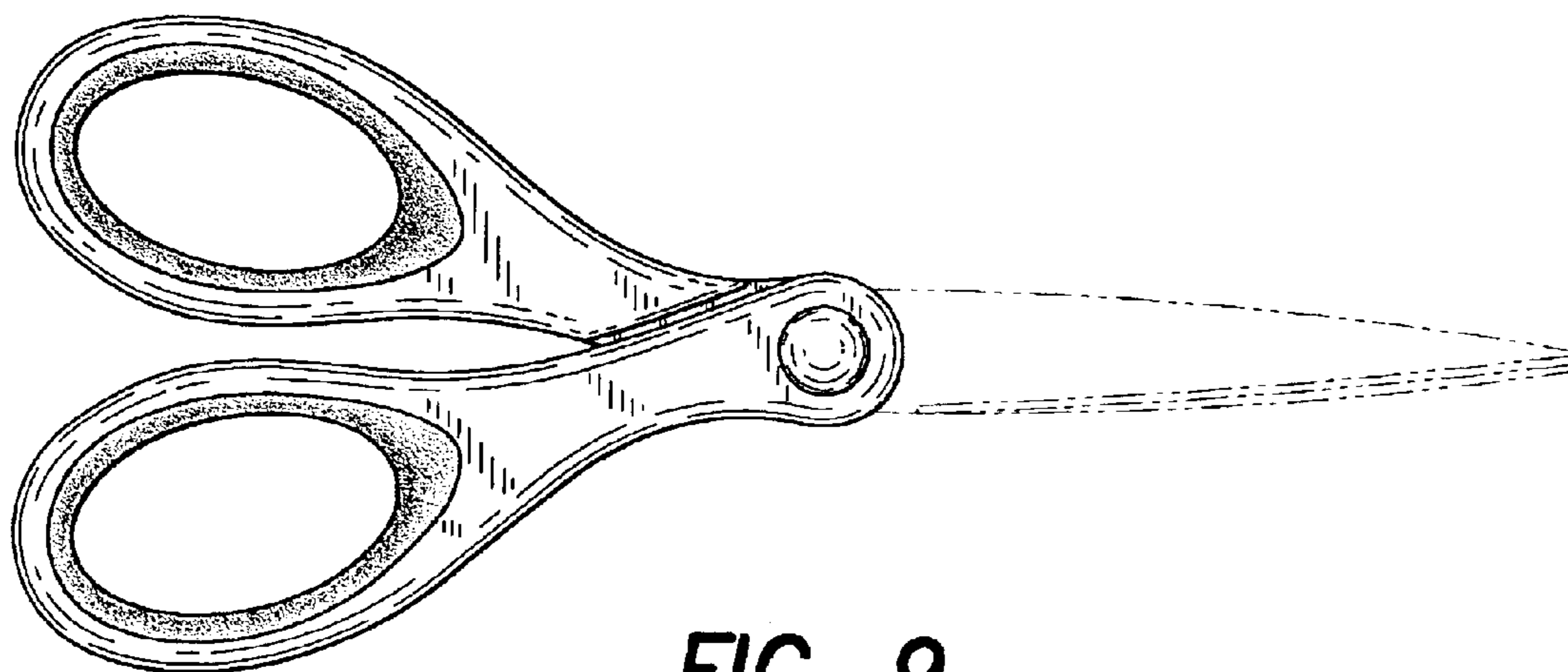

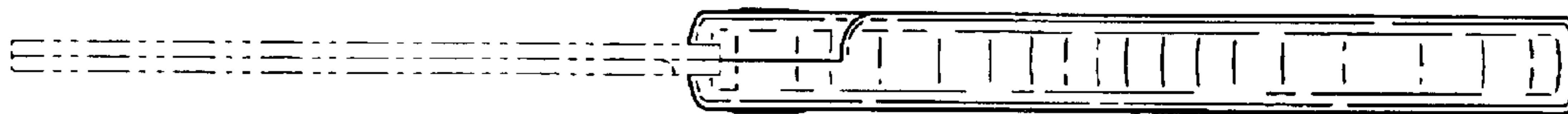
