end, and side of the housing shown in FIG. 1.

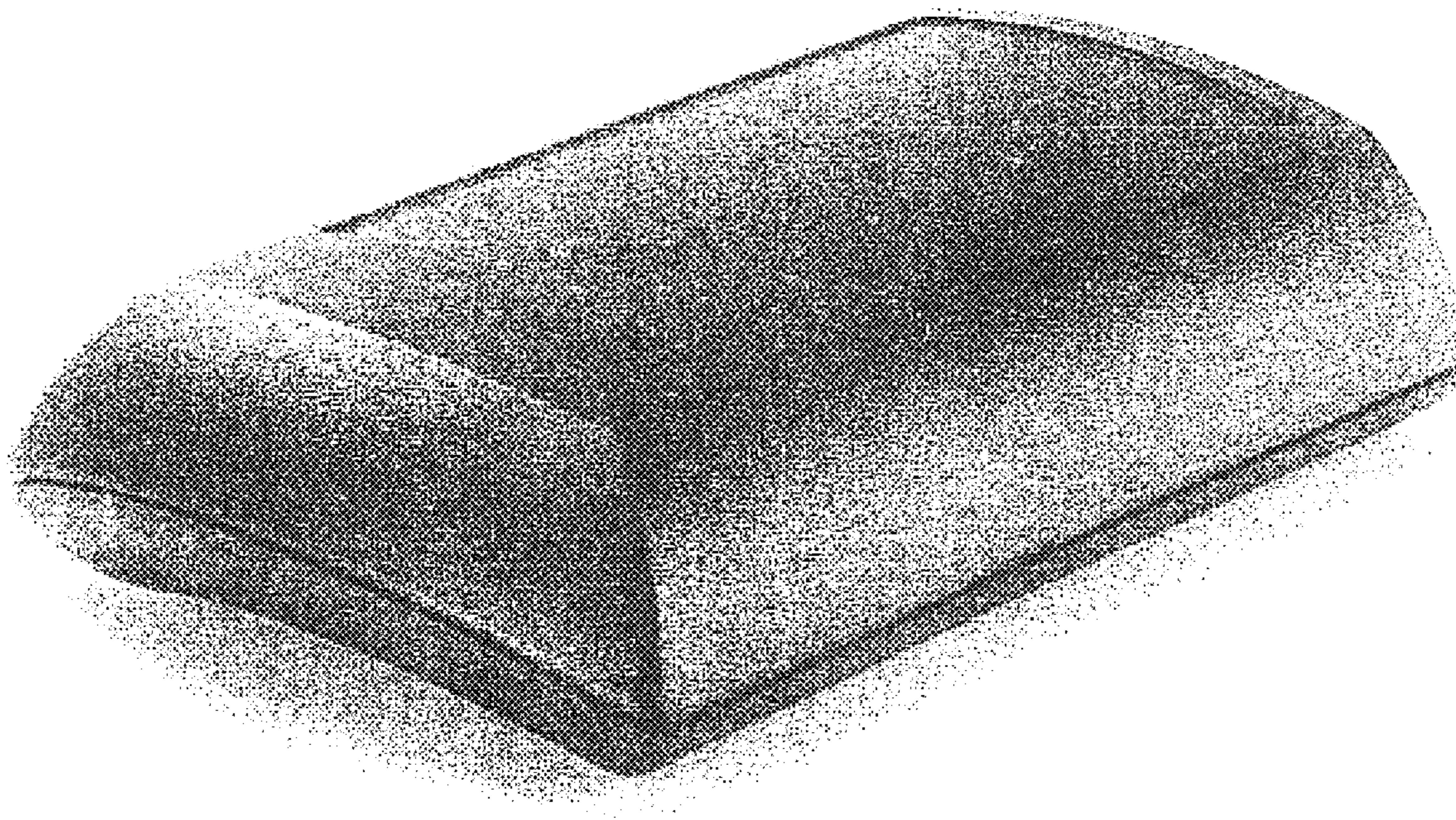
FIG. 3 is a photograph from a perspective showing the  
bottom, end, and side of the housing shown in FIG. 1.

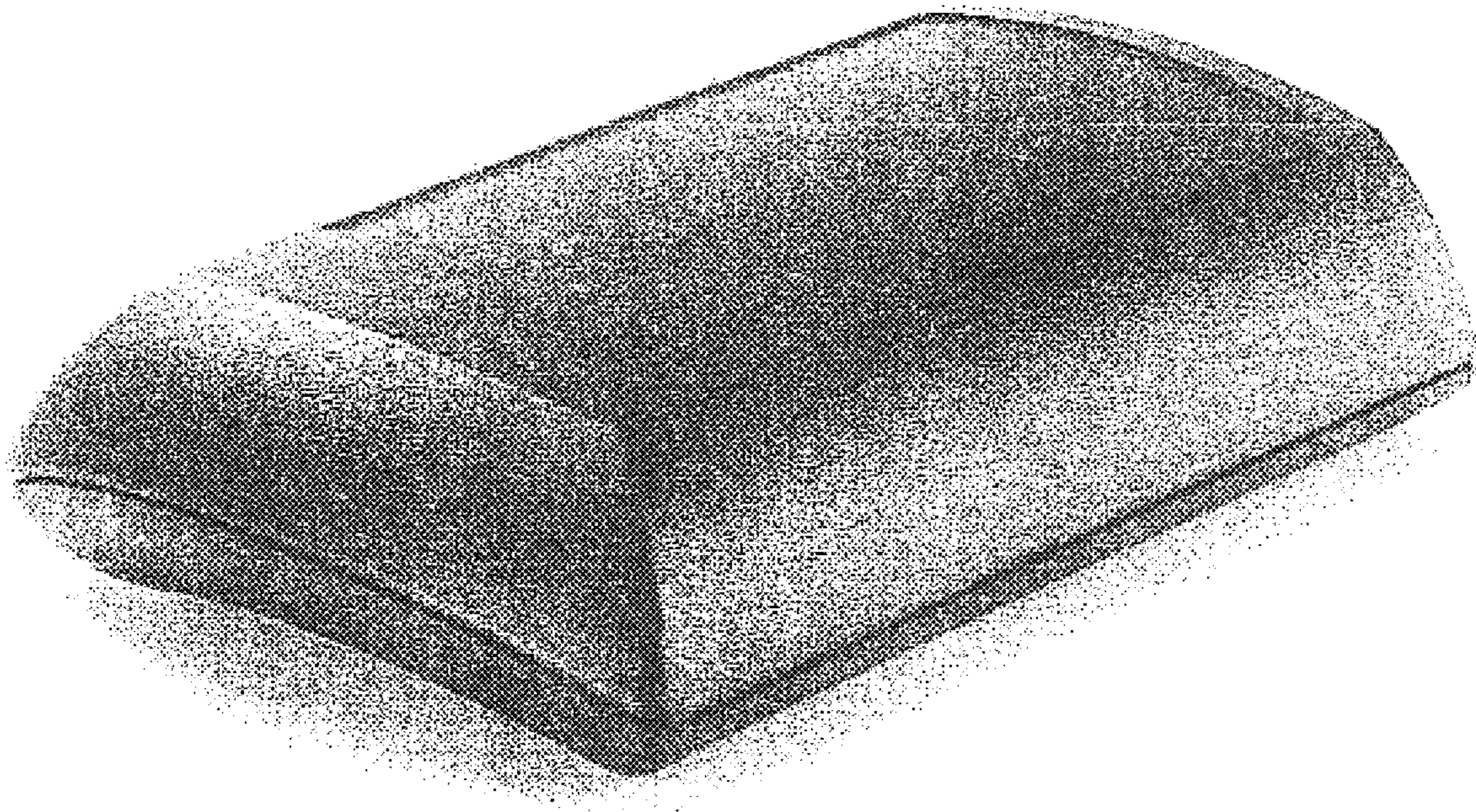
FIG. 4 is a photograph from a perspective showing the top,

end, and side of the housing shown in FIG. 4; and,

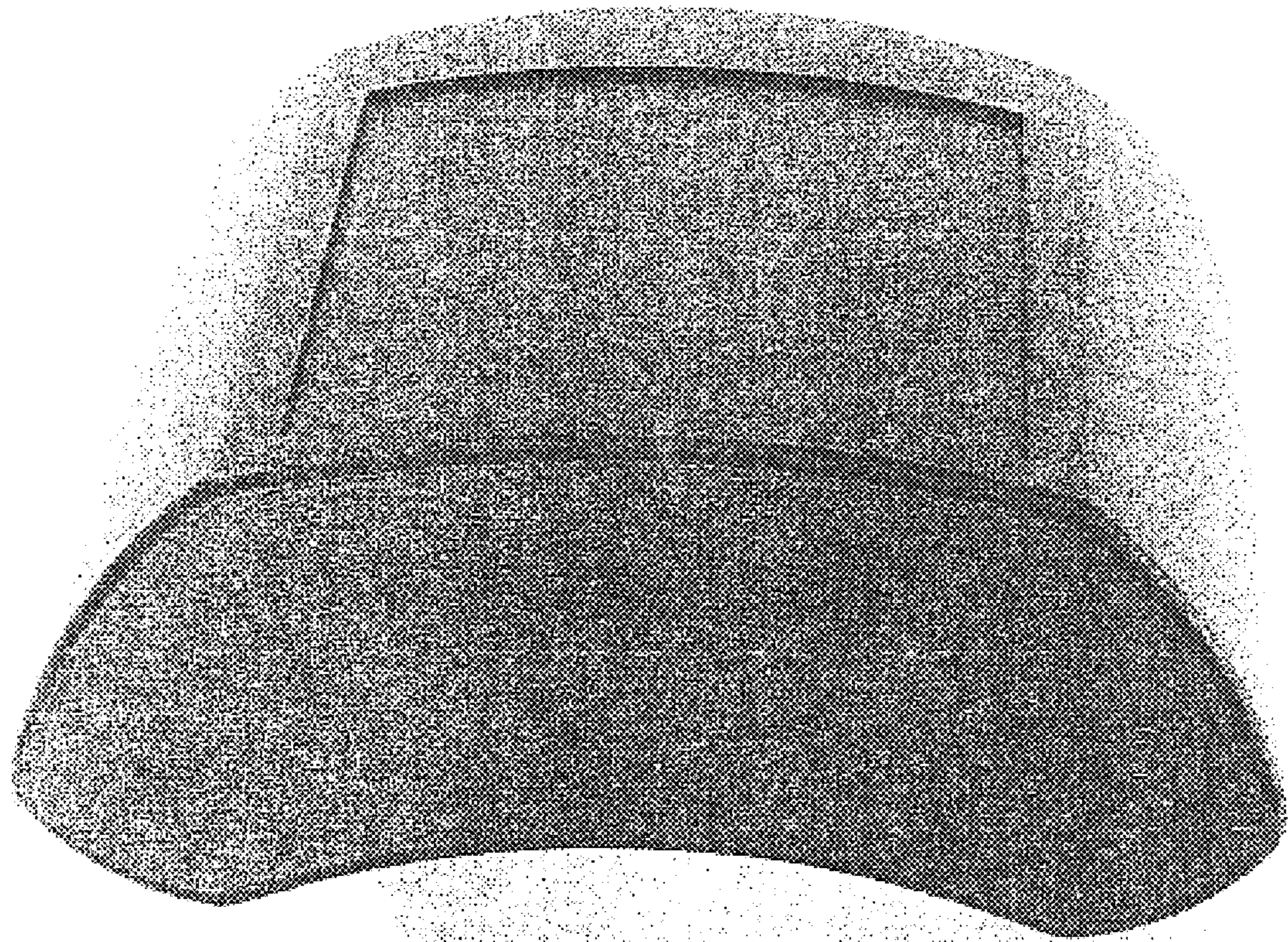
FIG. 6 is a photograph from a perspective showing the

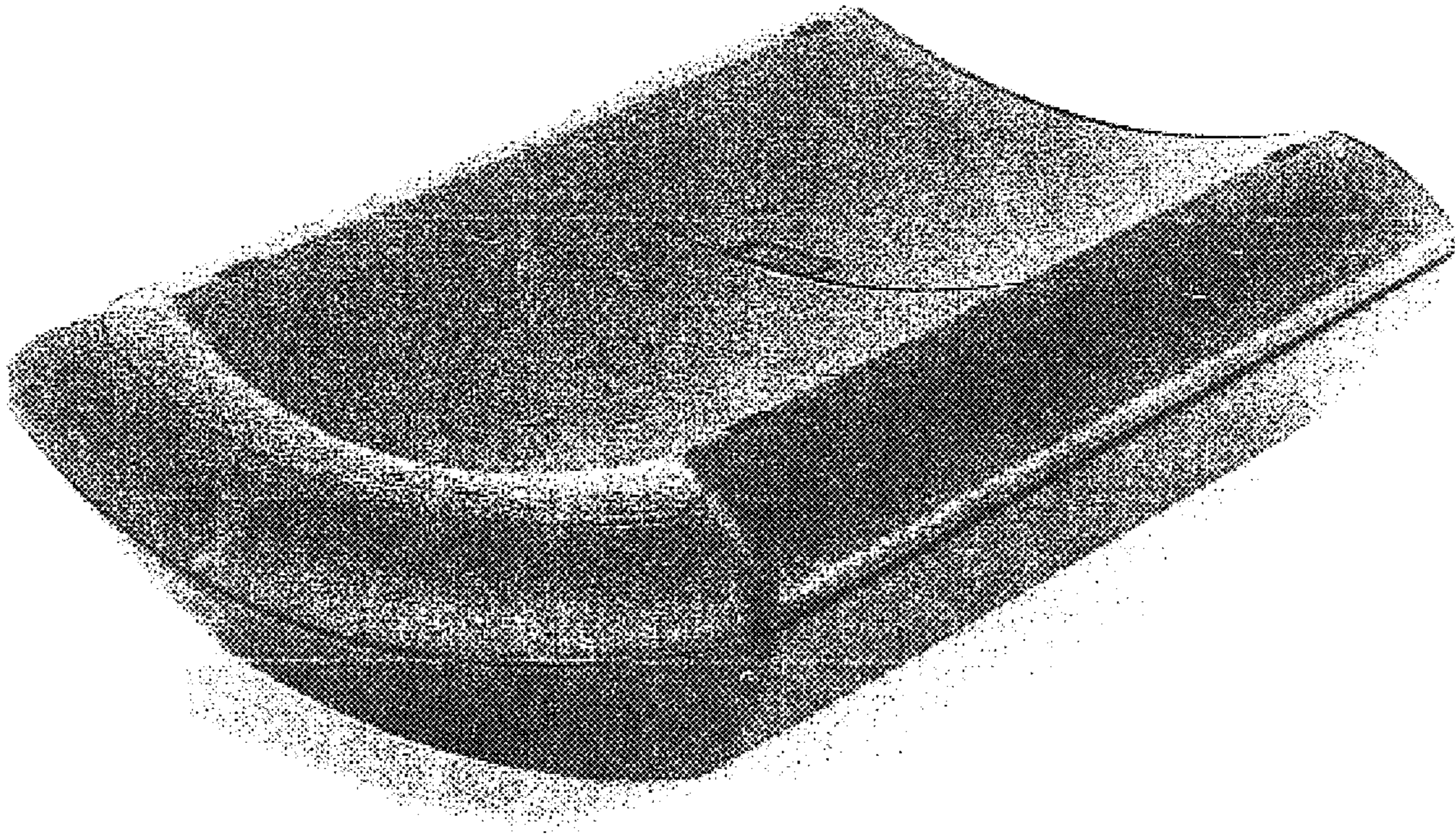


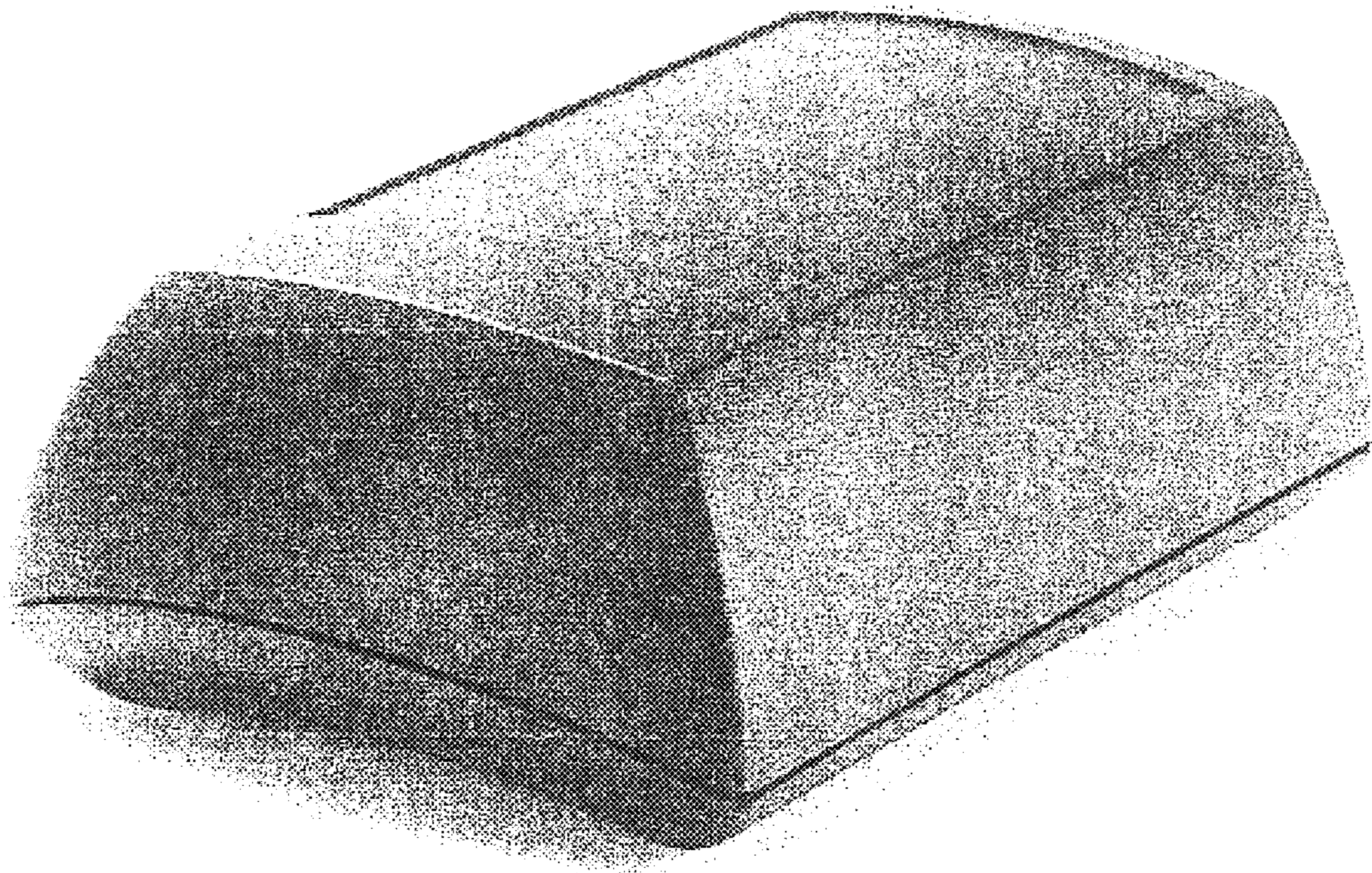

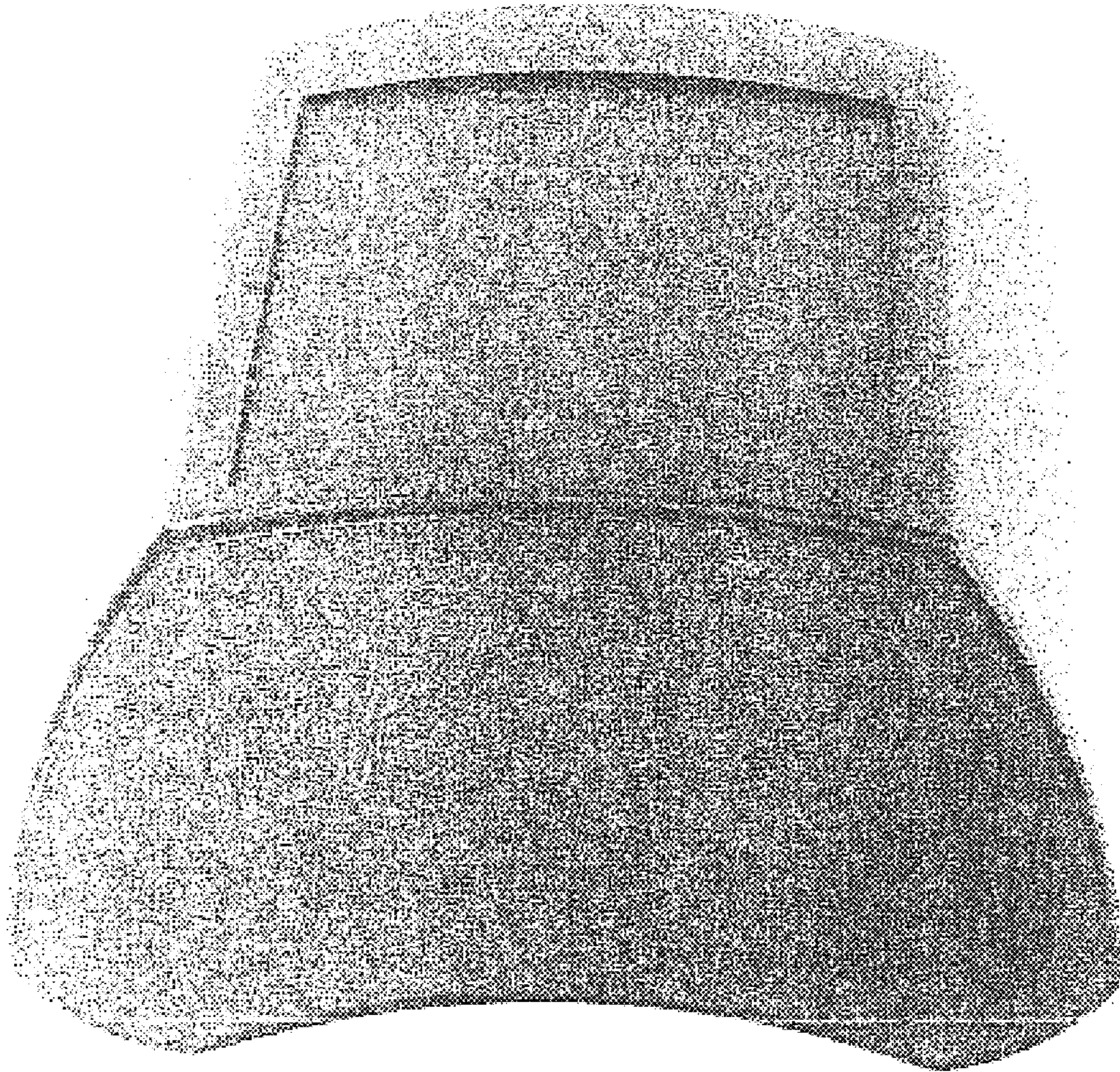

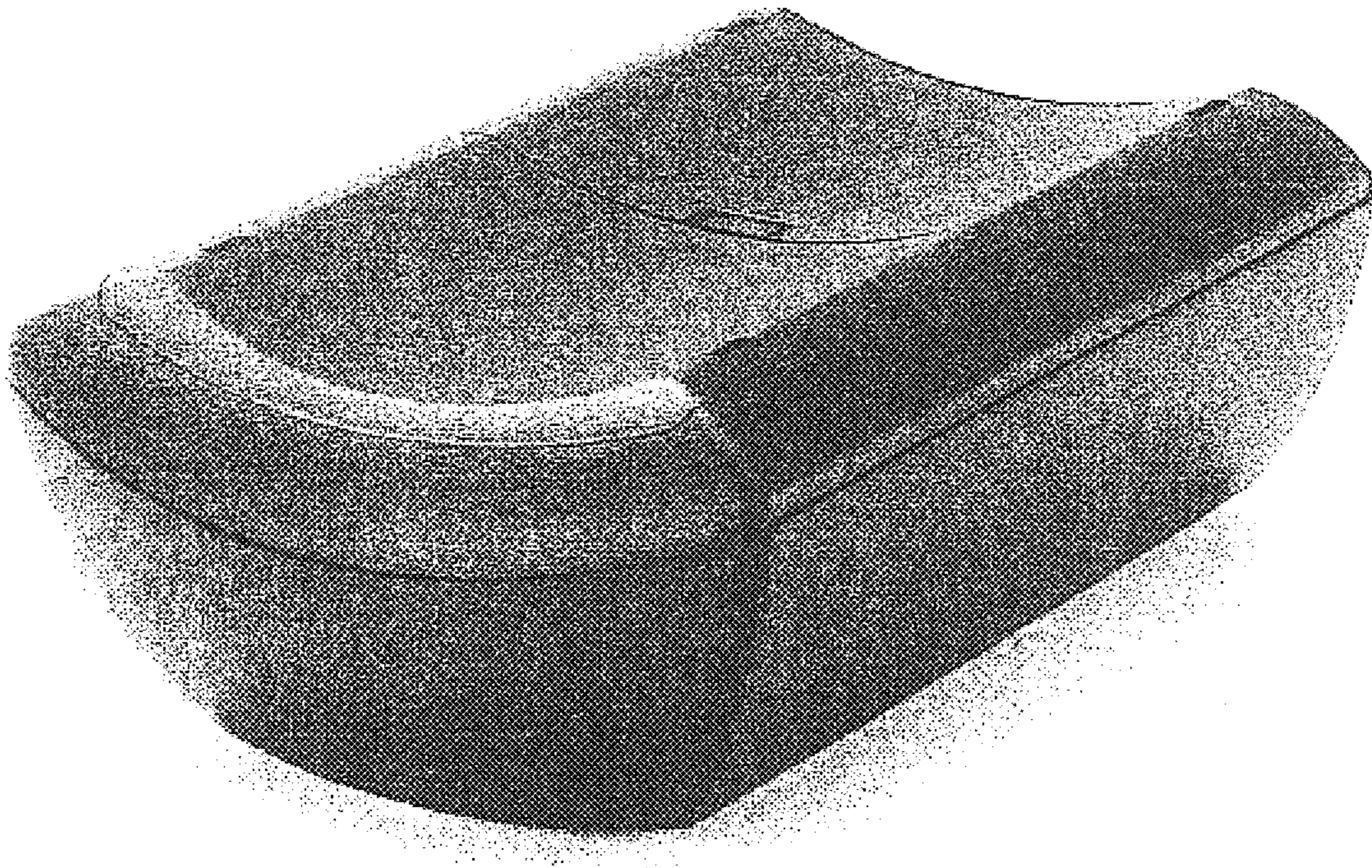
