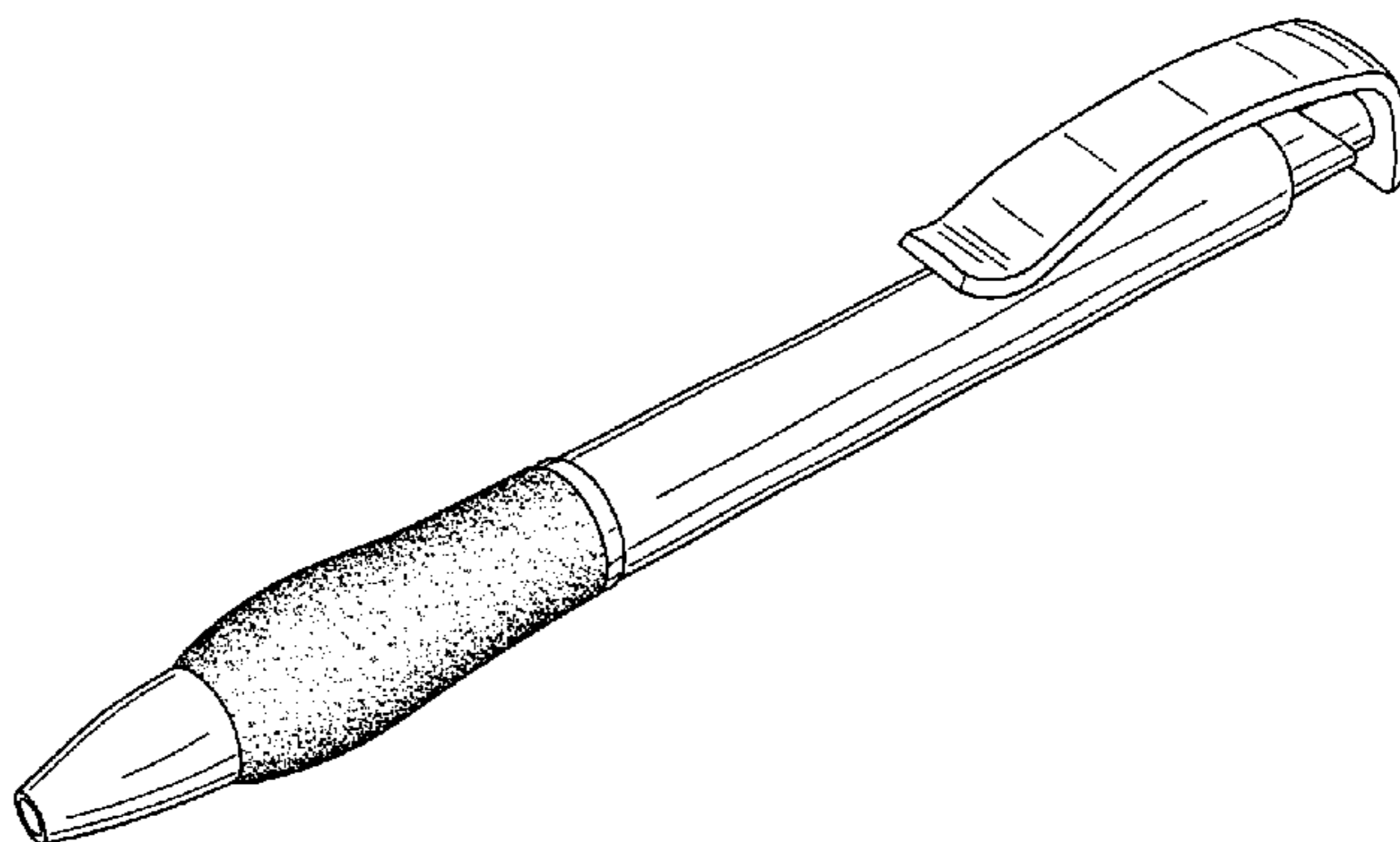
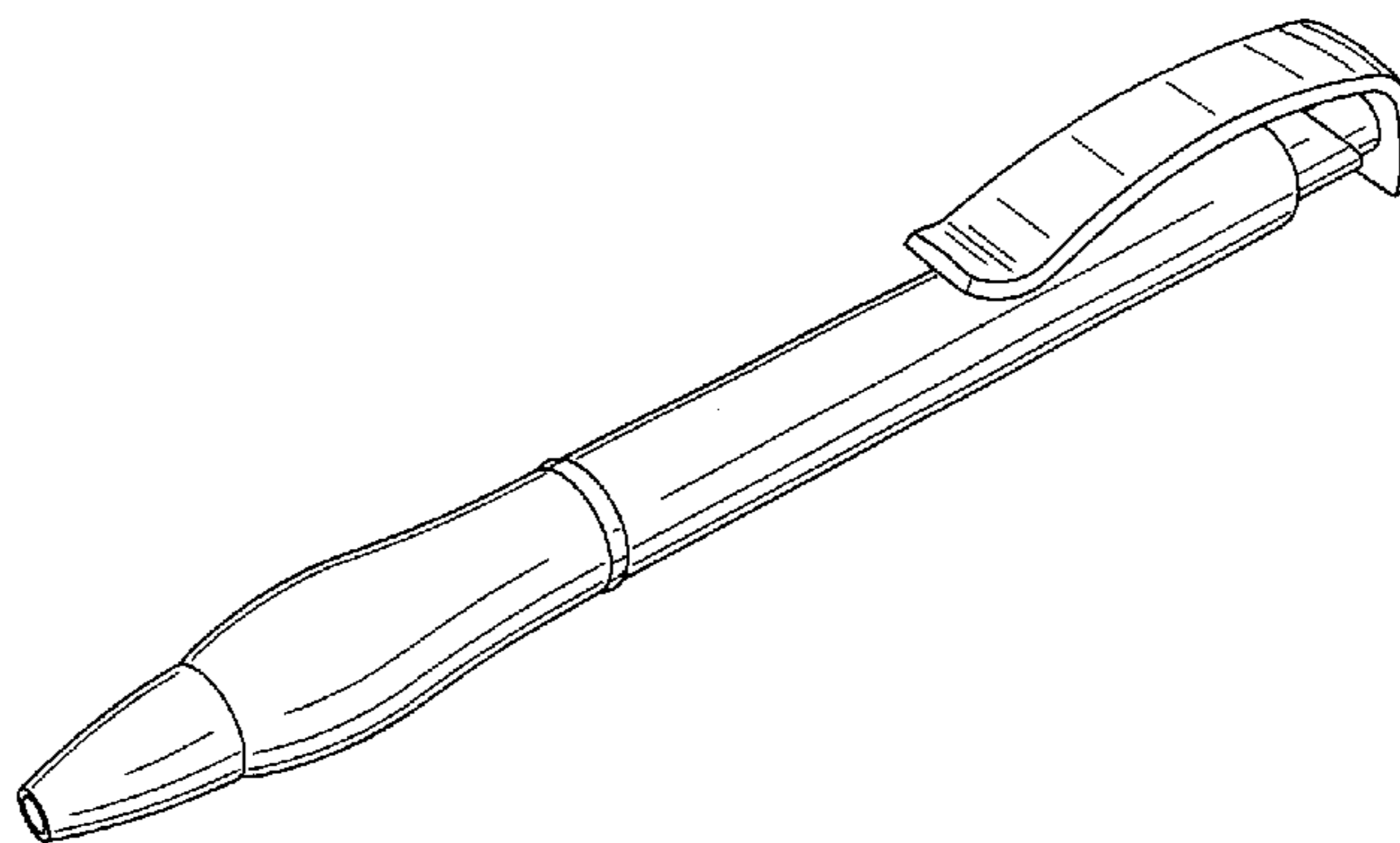
FIG. 1 is a perspective view of pen showing my new design;

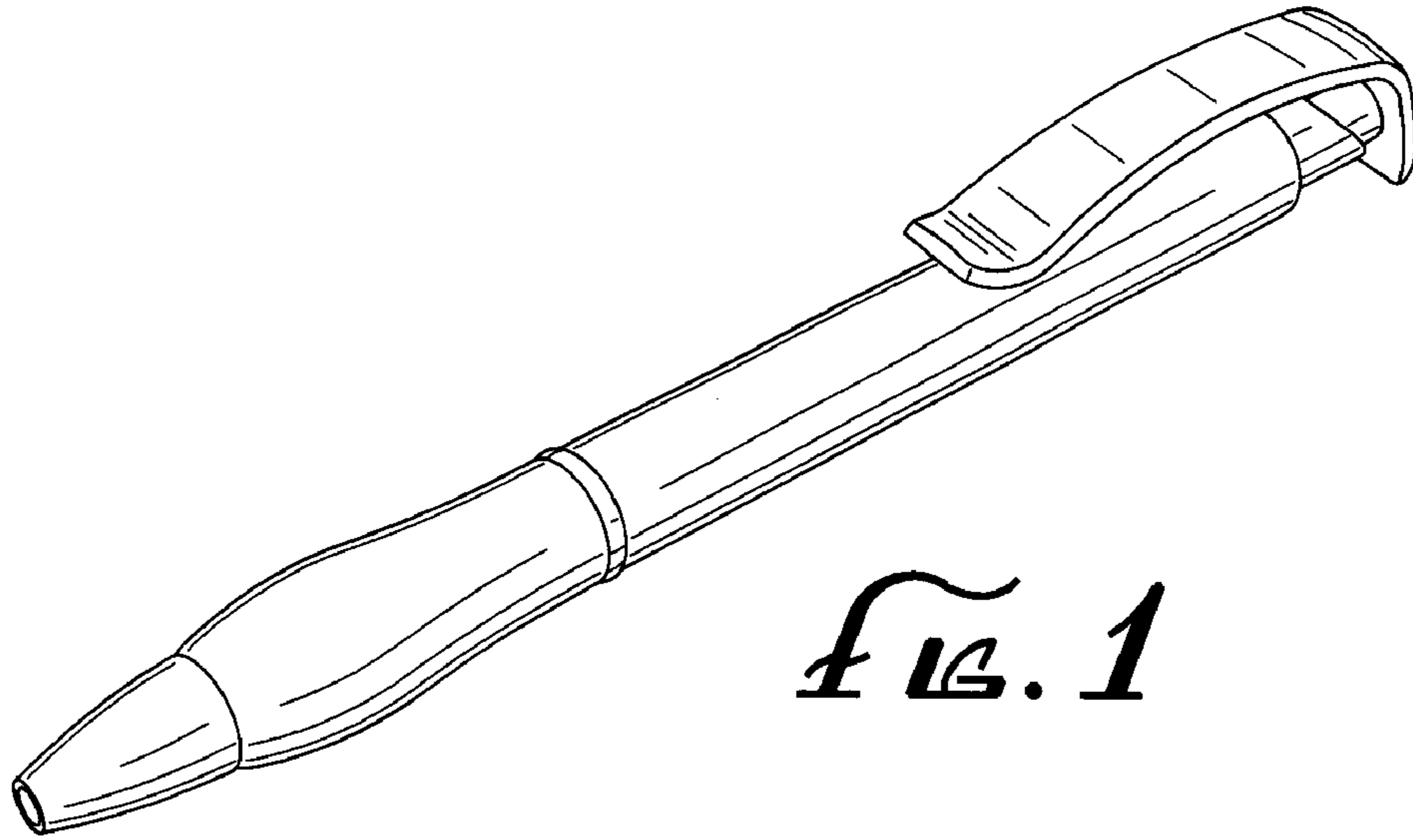

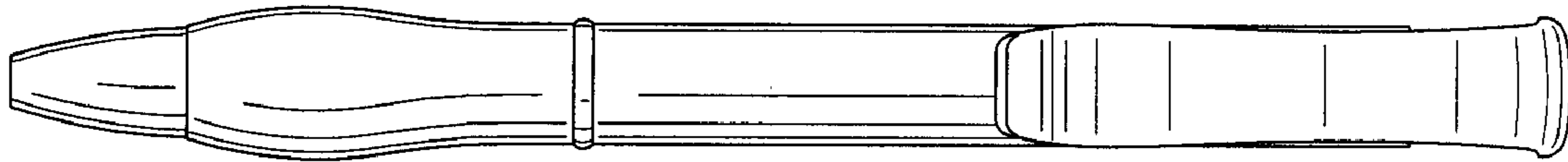

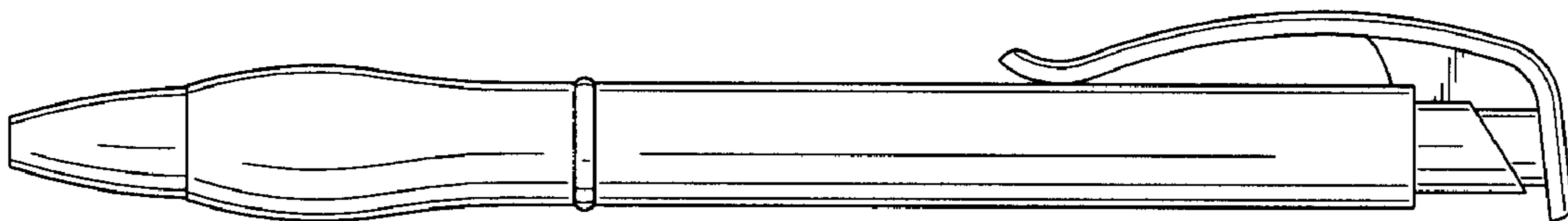

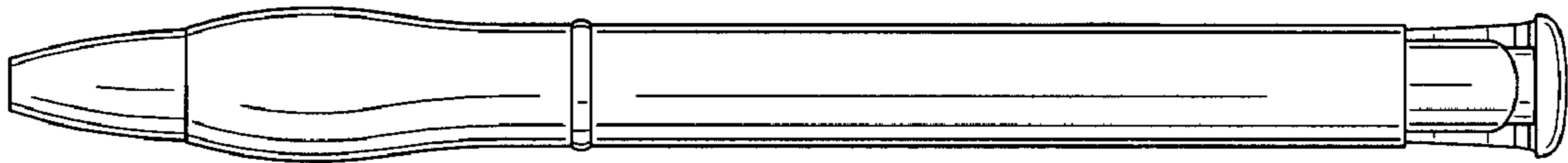

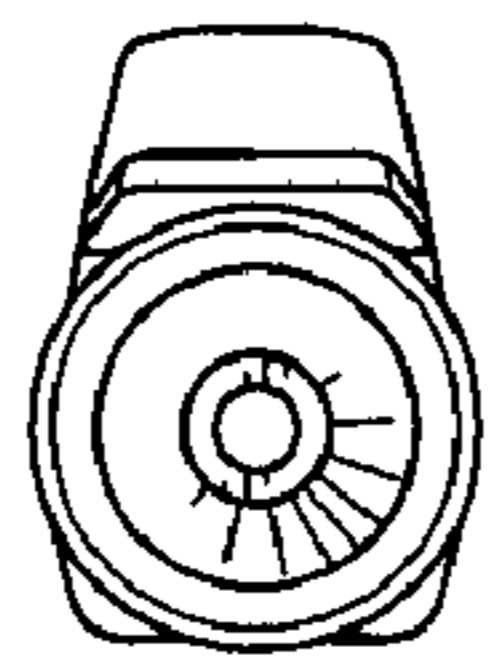

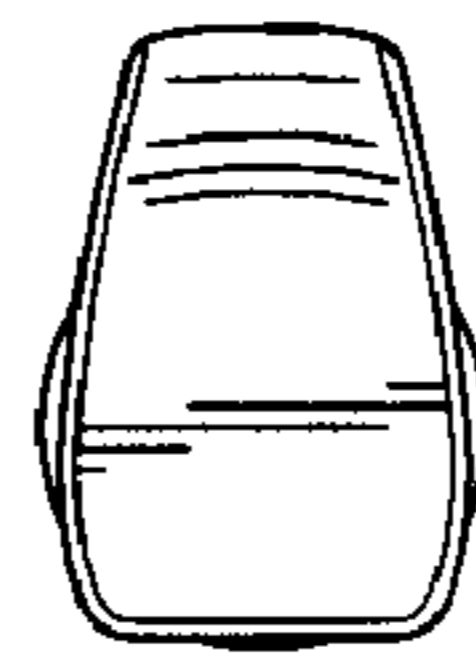

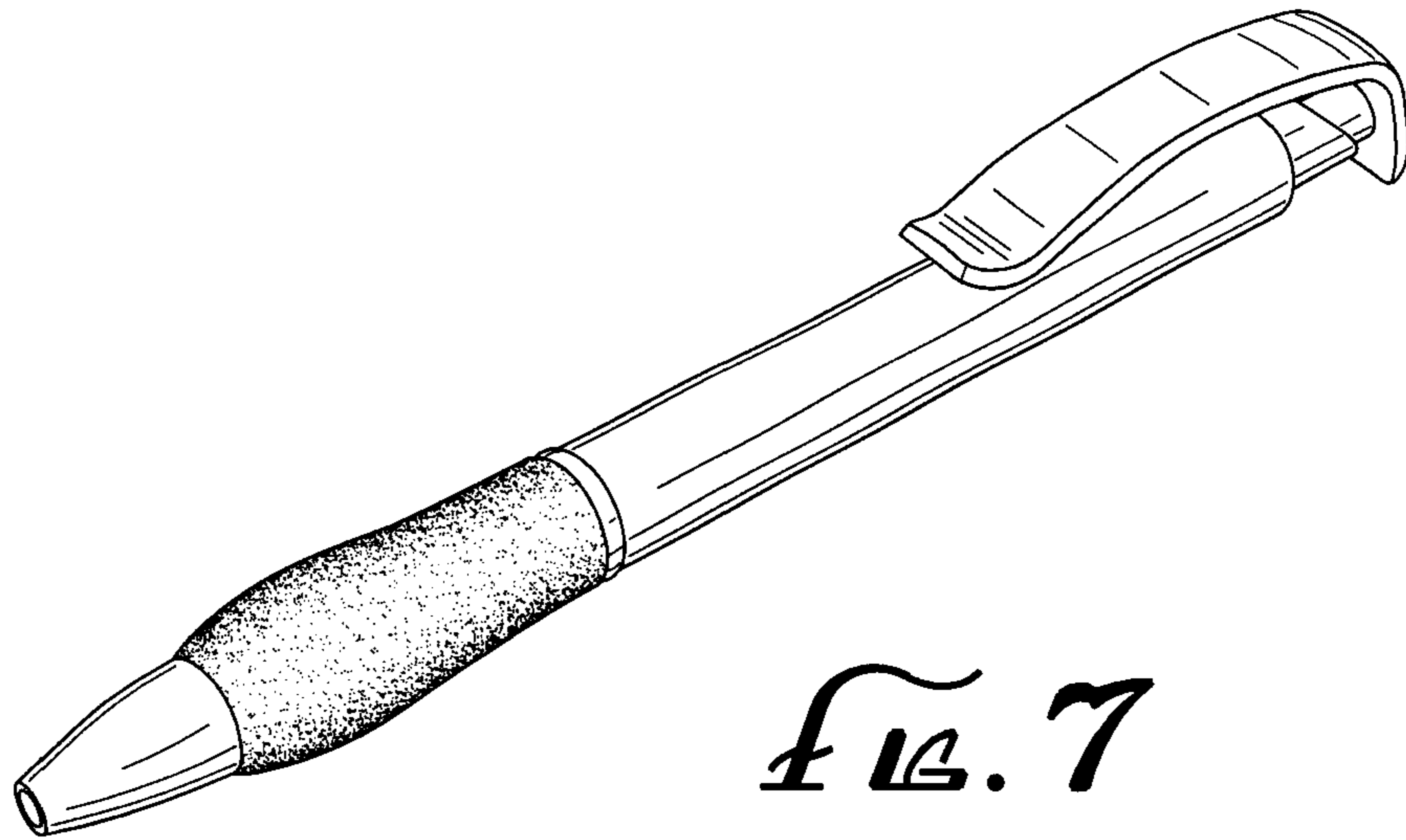

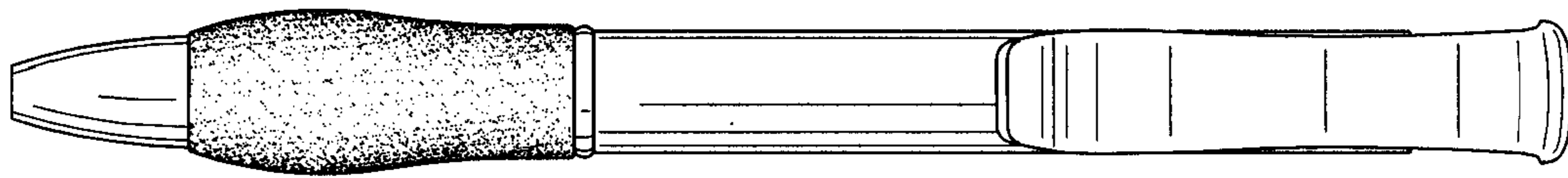

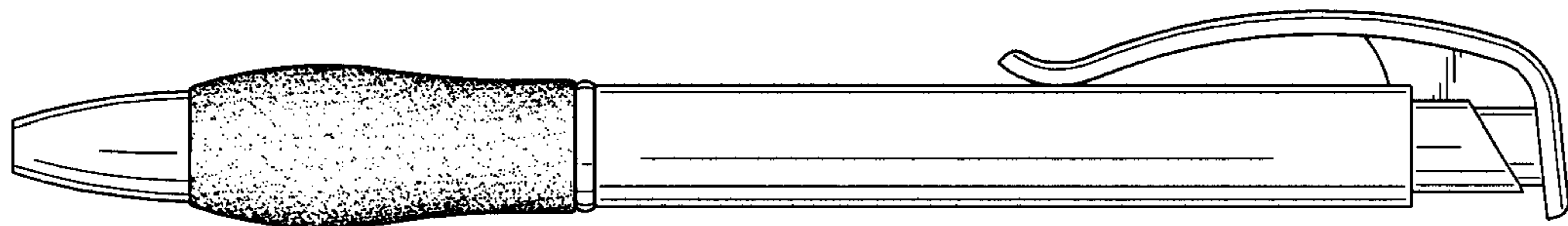

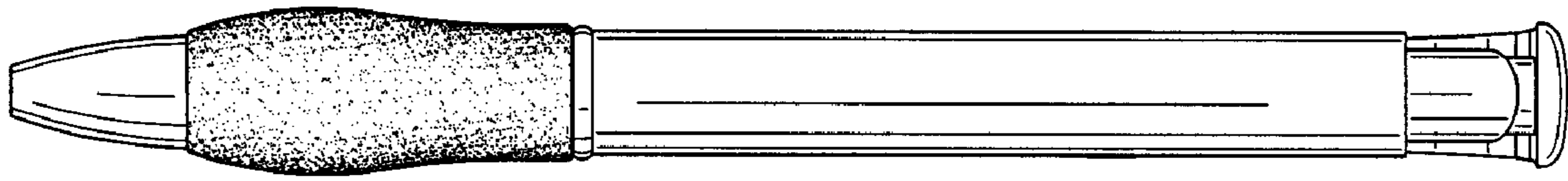

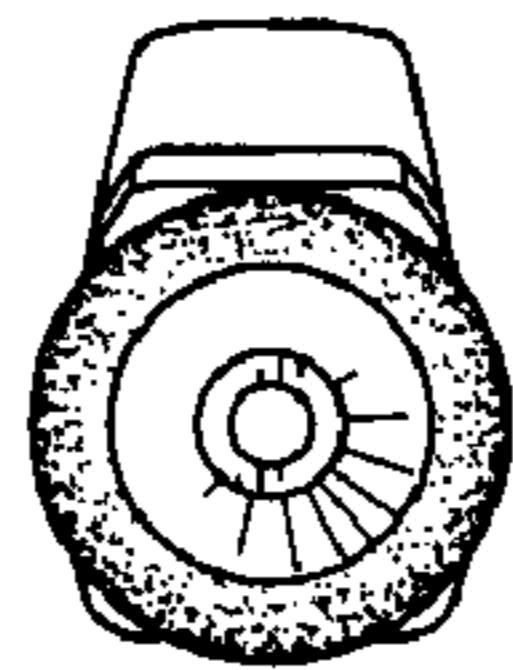

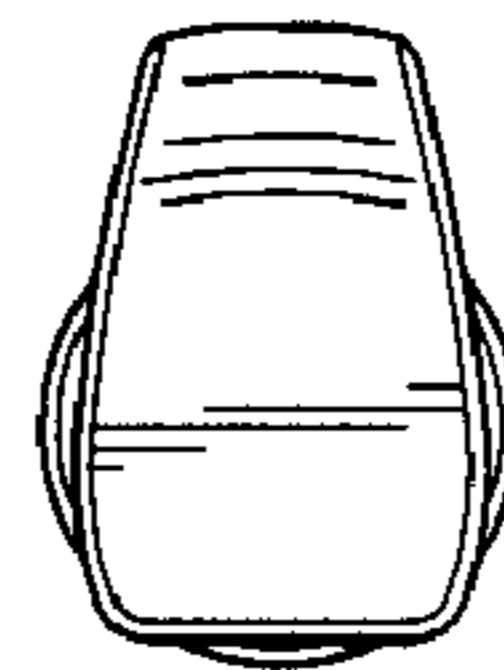
