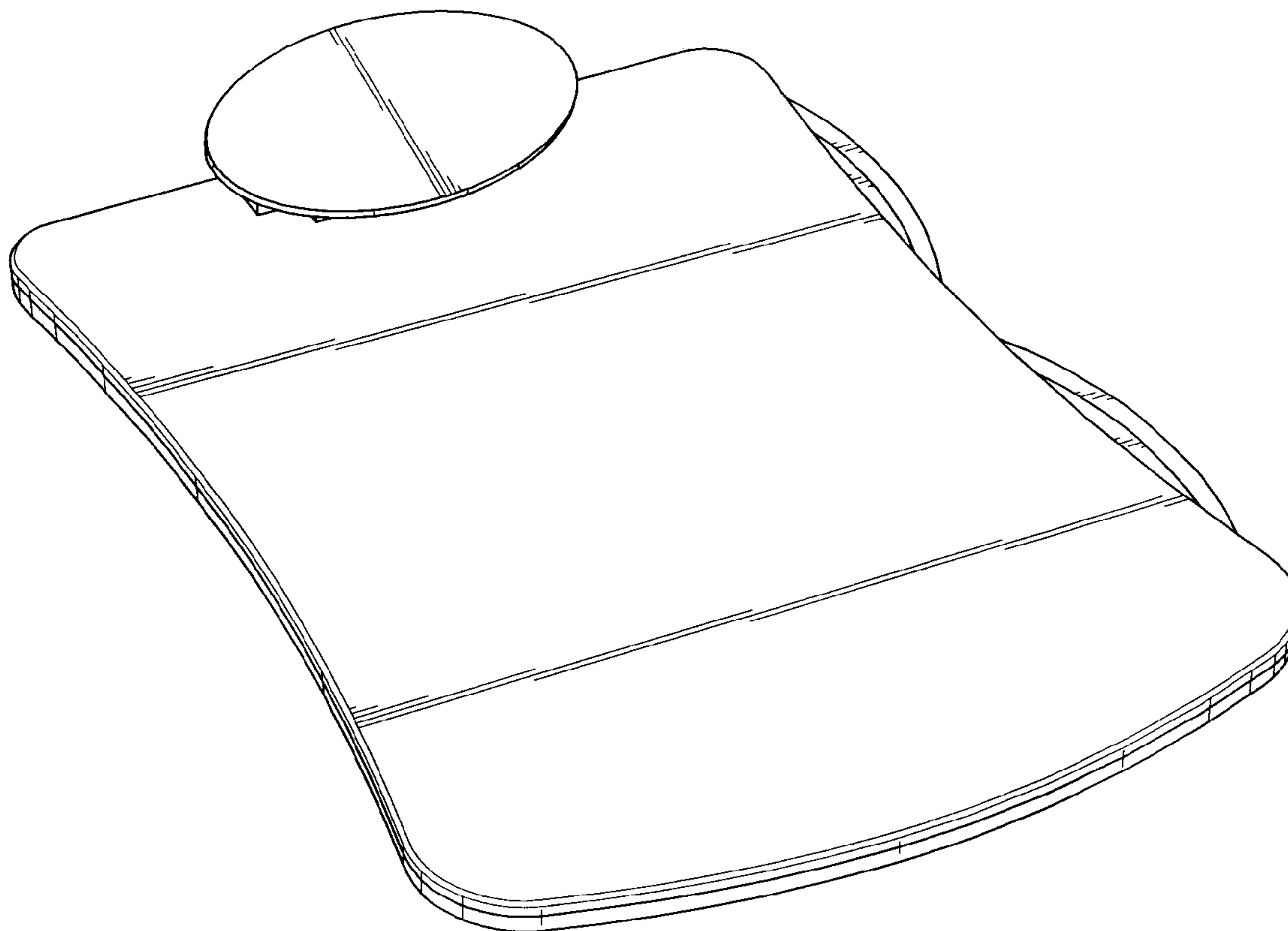

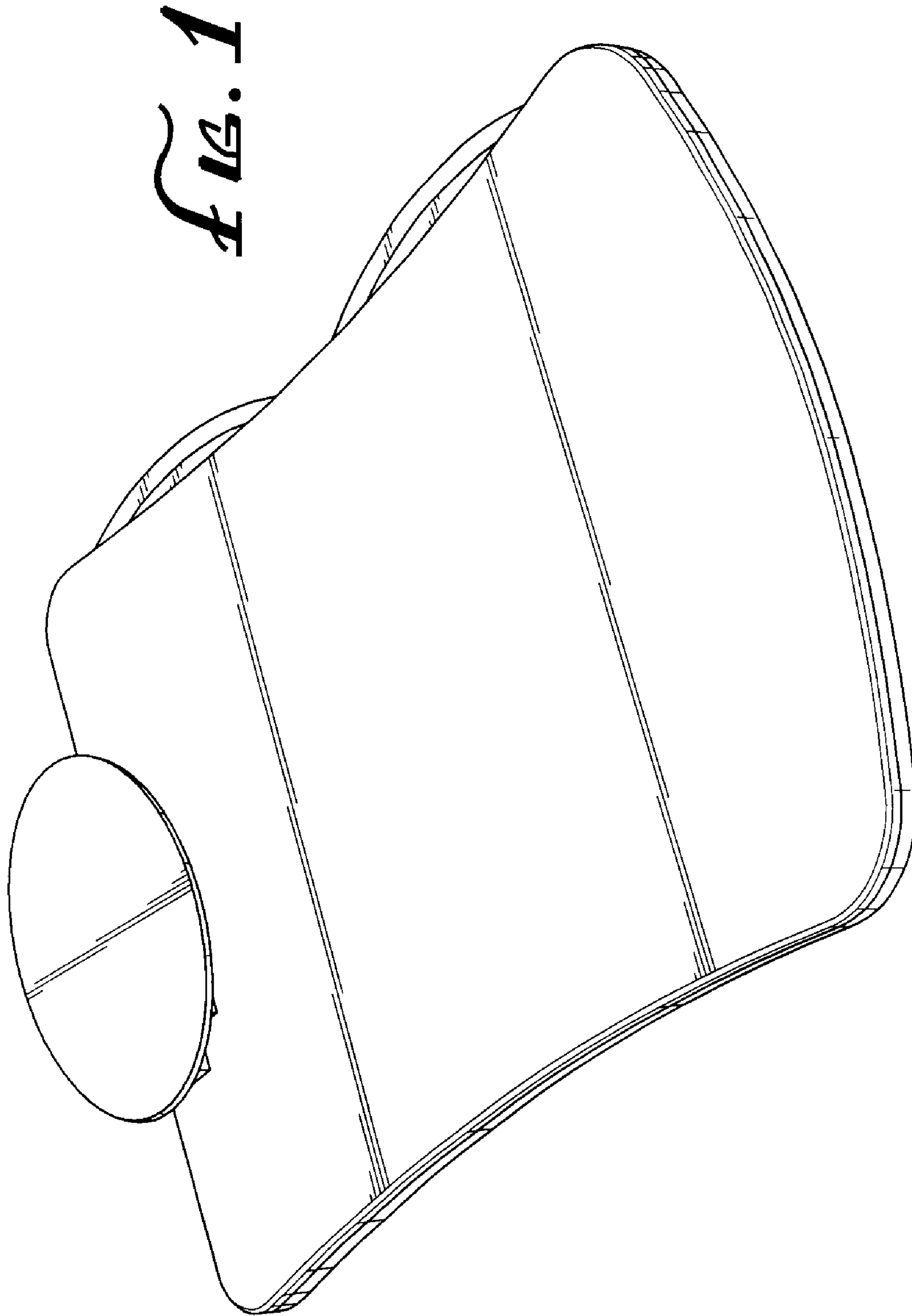
The ornamental design for a clipboard, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a clipboard;

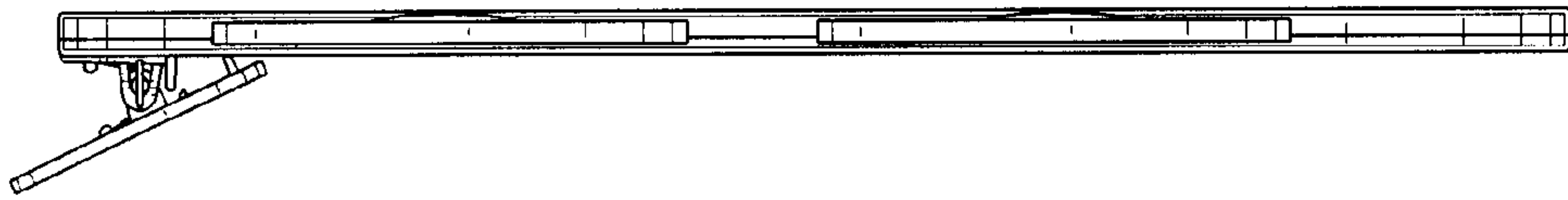

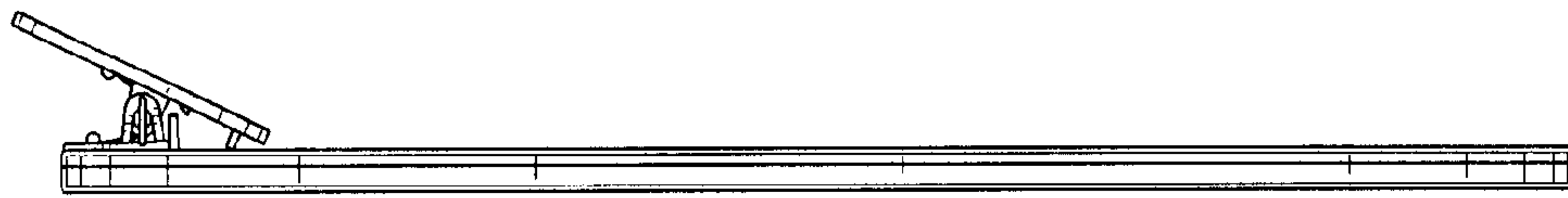

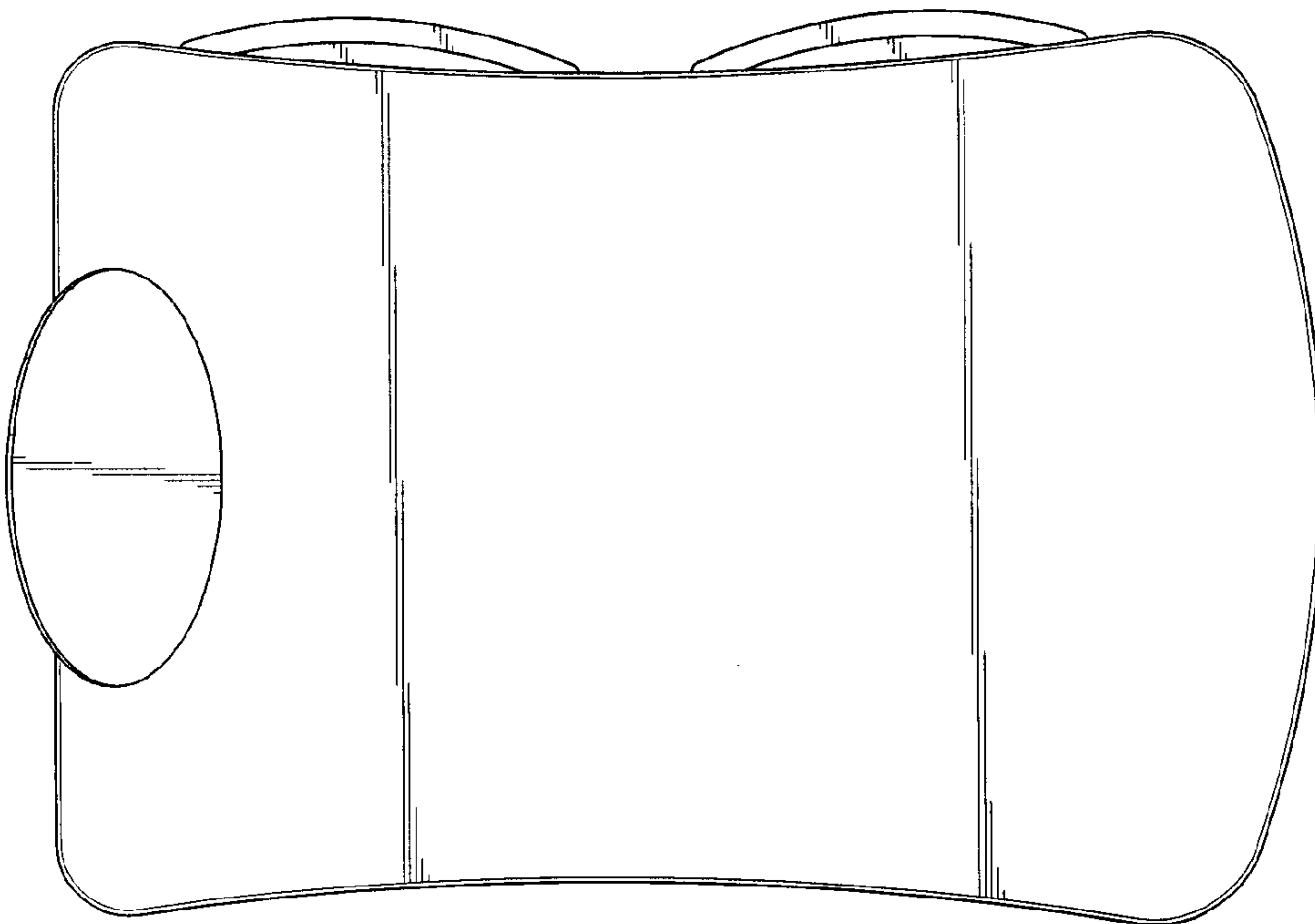

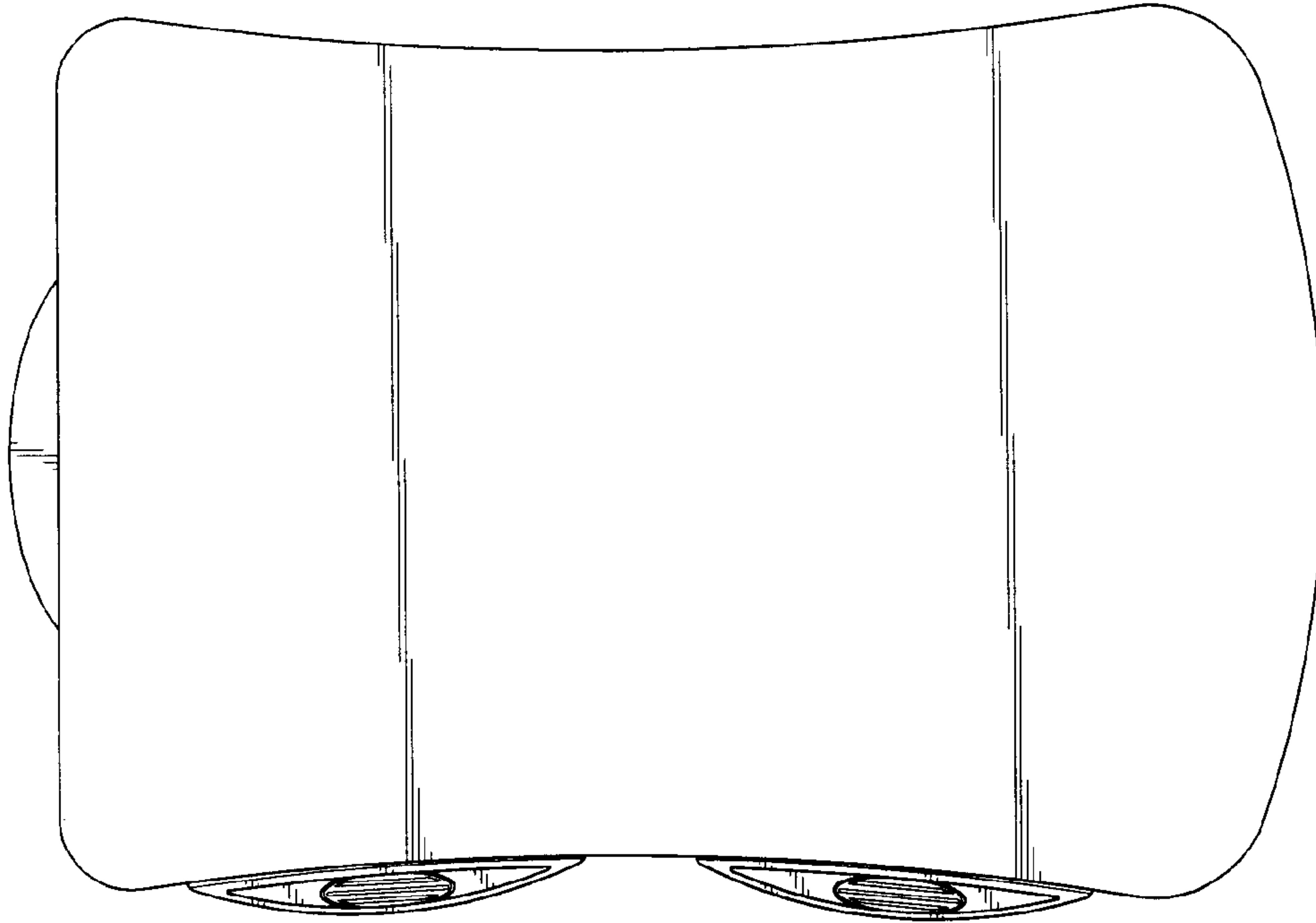

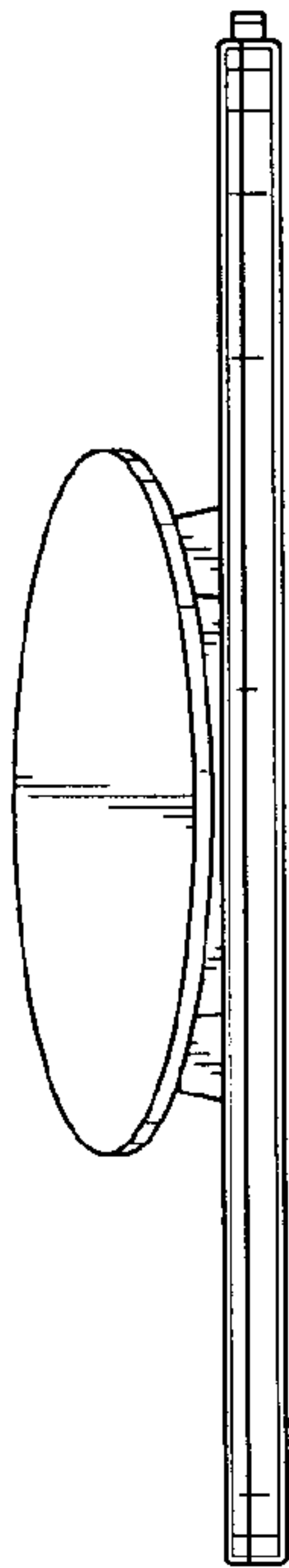

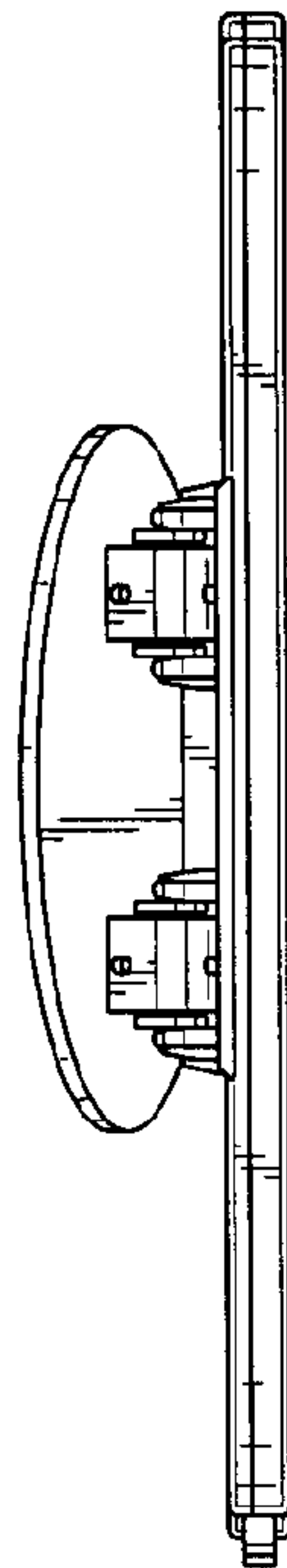

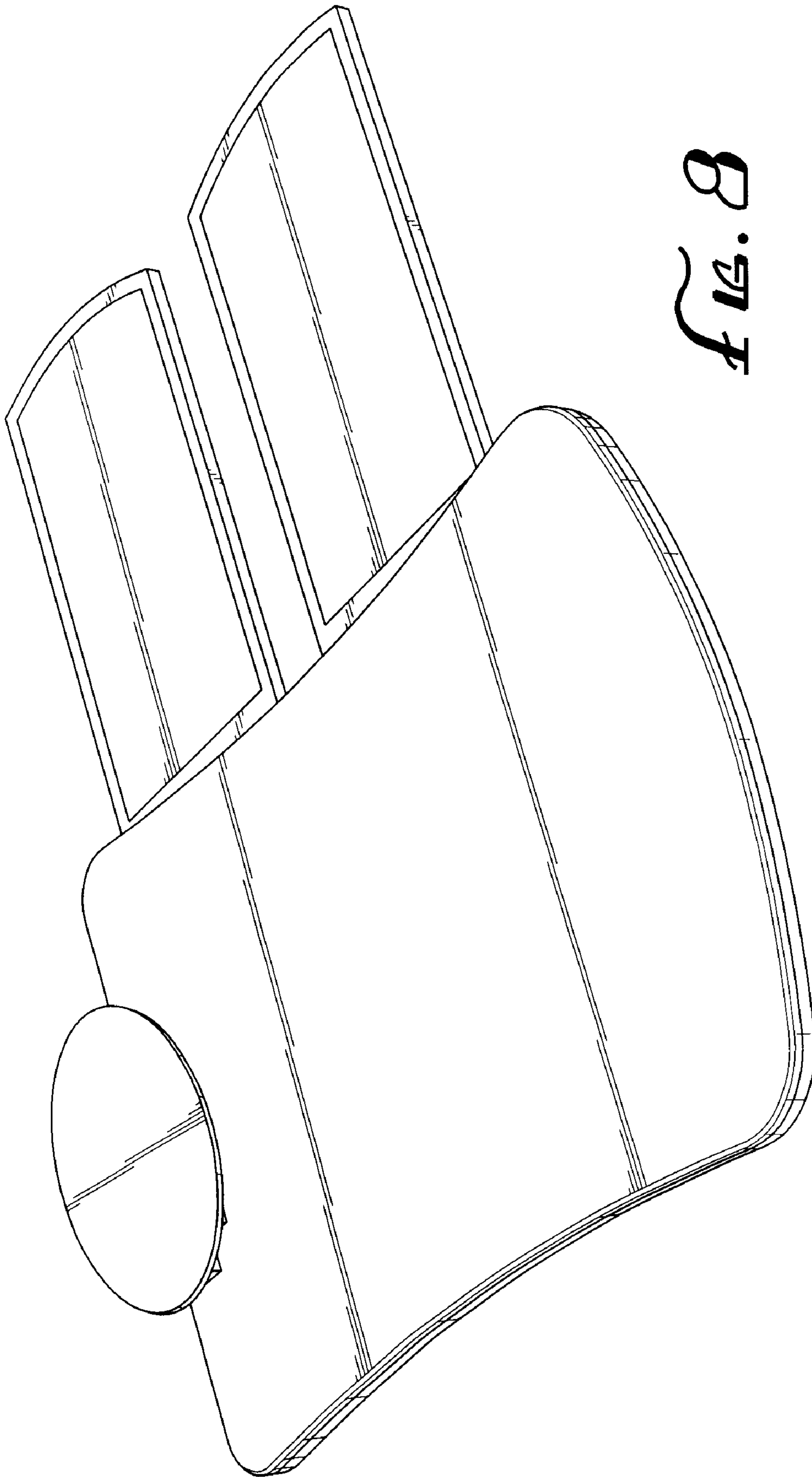
