(57) **CLAIM**

The ornamental design for an oral-care appliance (electric toothpick), as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an oral-care appliance (electric toothpick) showing the new design;

FIG. 2 is a left side view of the oral-care appliance (electric toothpick) of FIG. 1;

FIG. 3 is a front view of the oral-care appliance (electric toothpick) of FIG. 1;

FIG. 4 is a right side view of the oral-care appliance (electric toothpick) of FIG. 1;

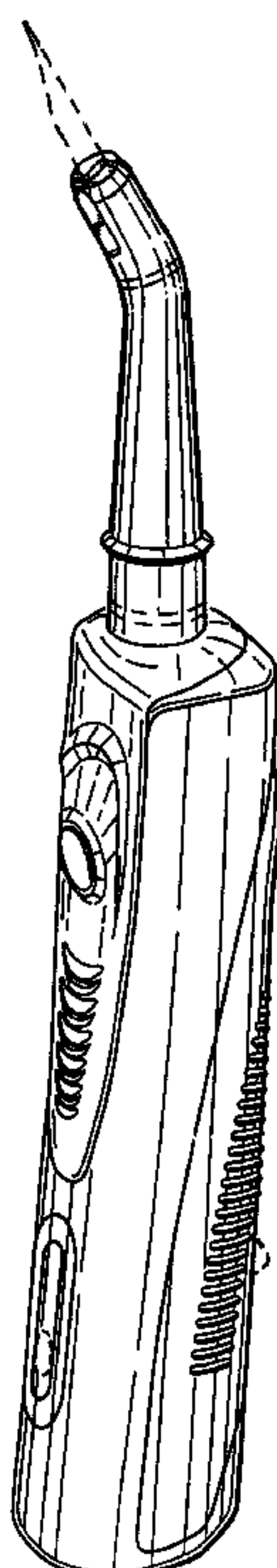
FIG. 5 is a back side view of the oral-care appliance (electric toothpick) of FIG. 1;

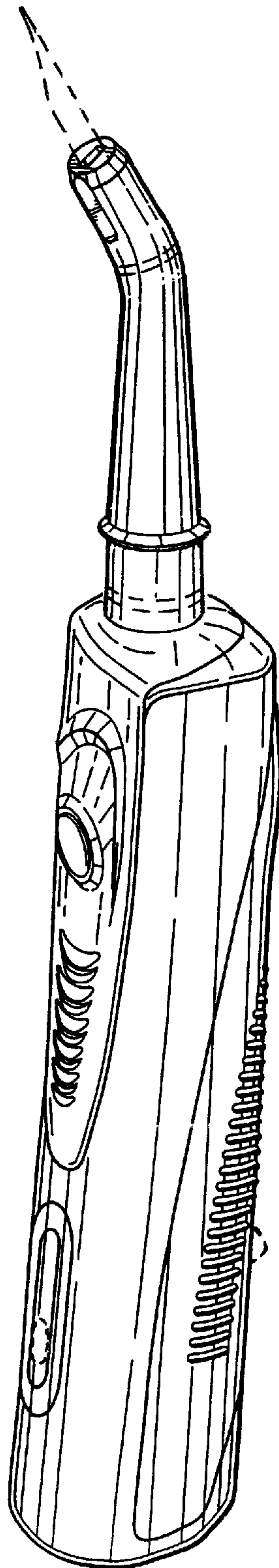

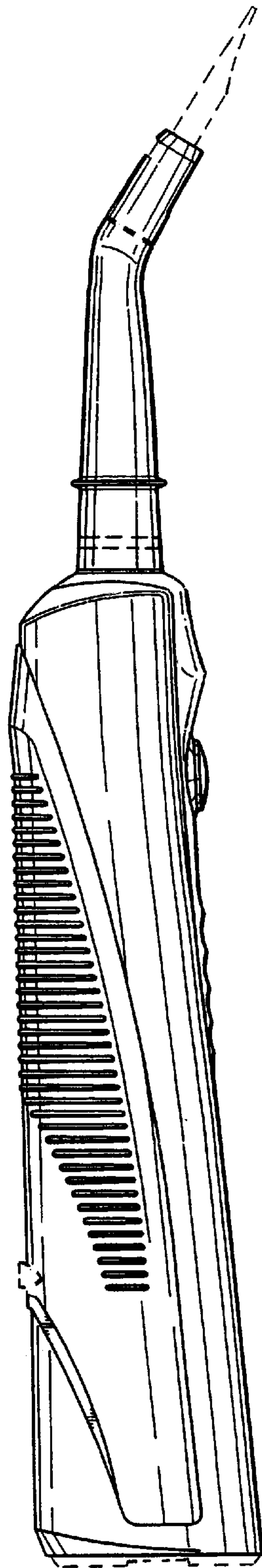

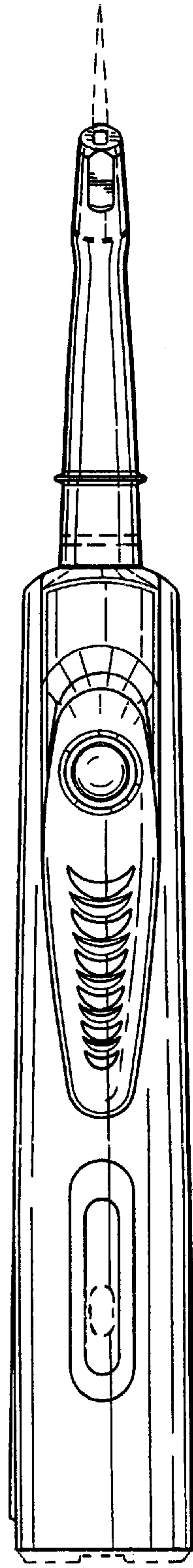

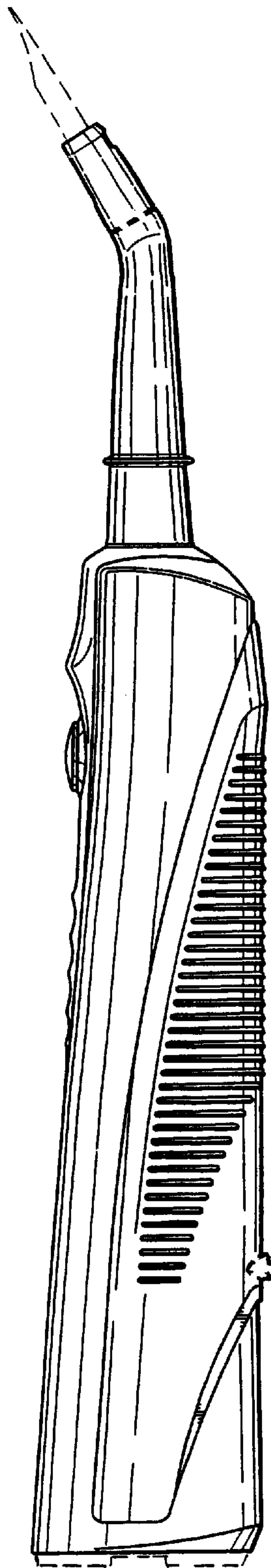

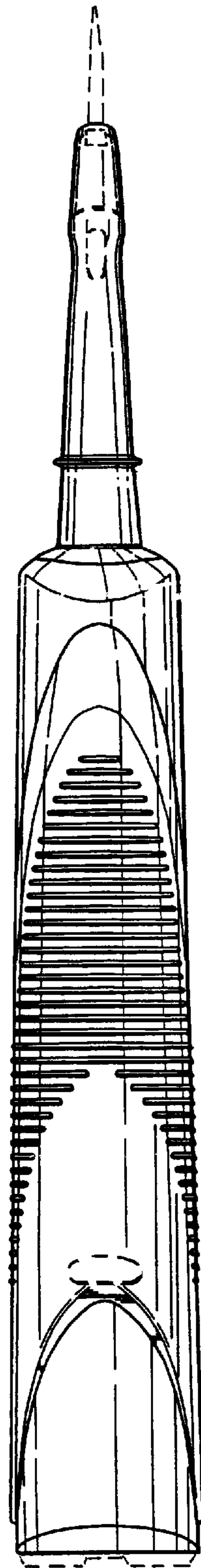

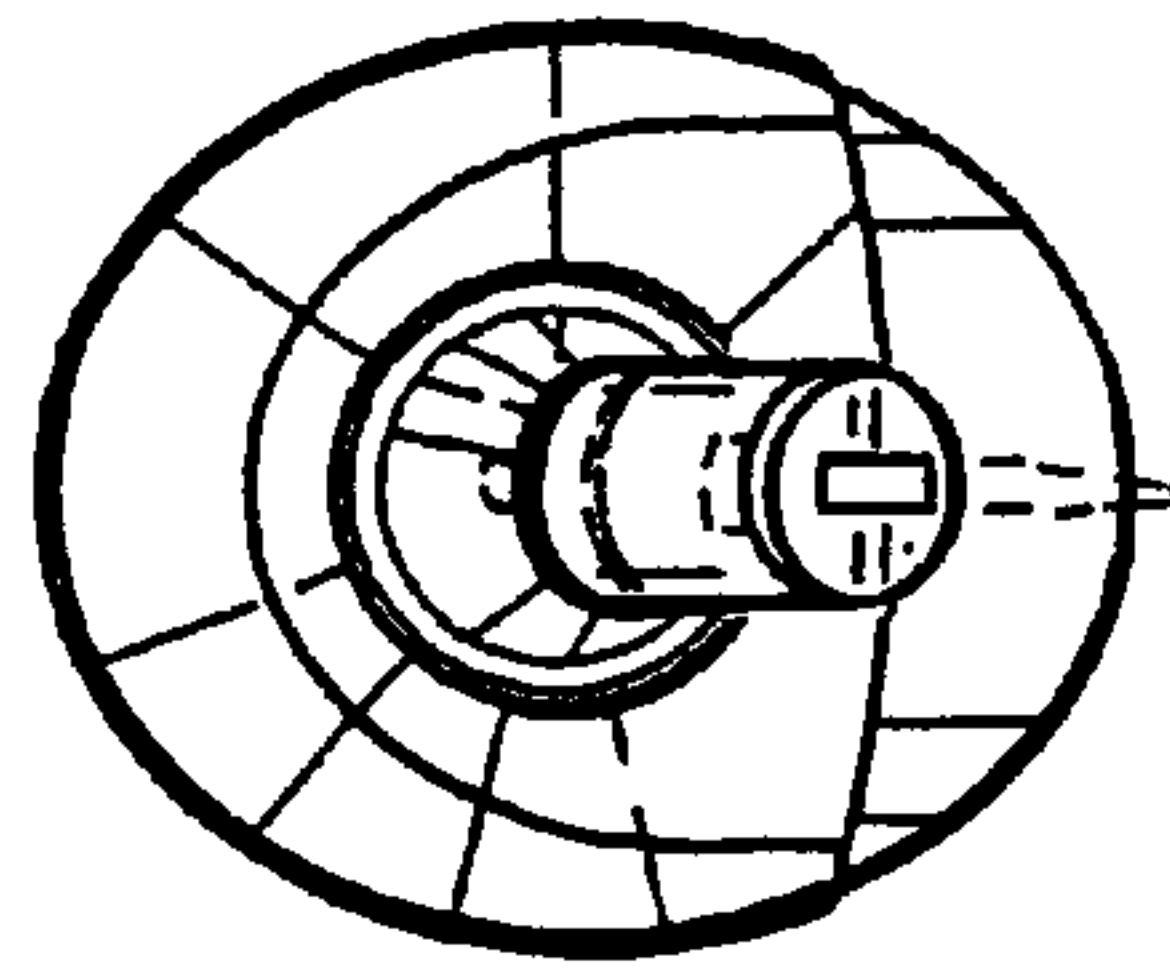

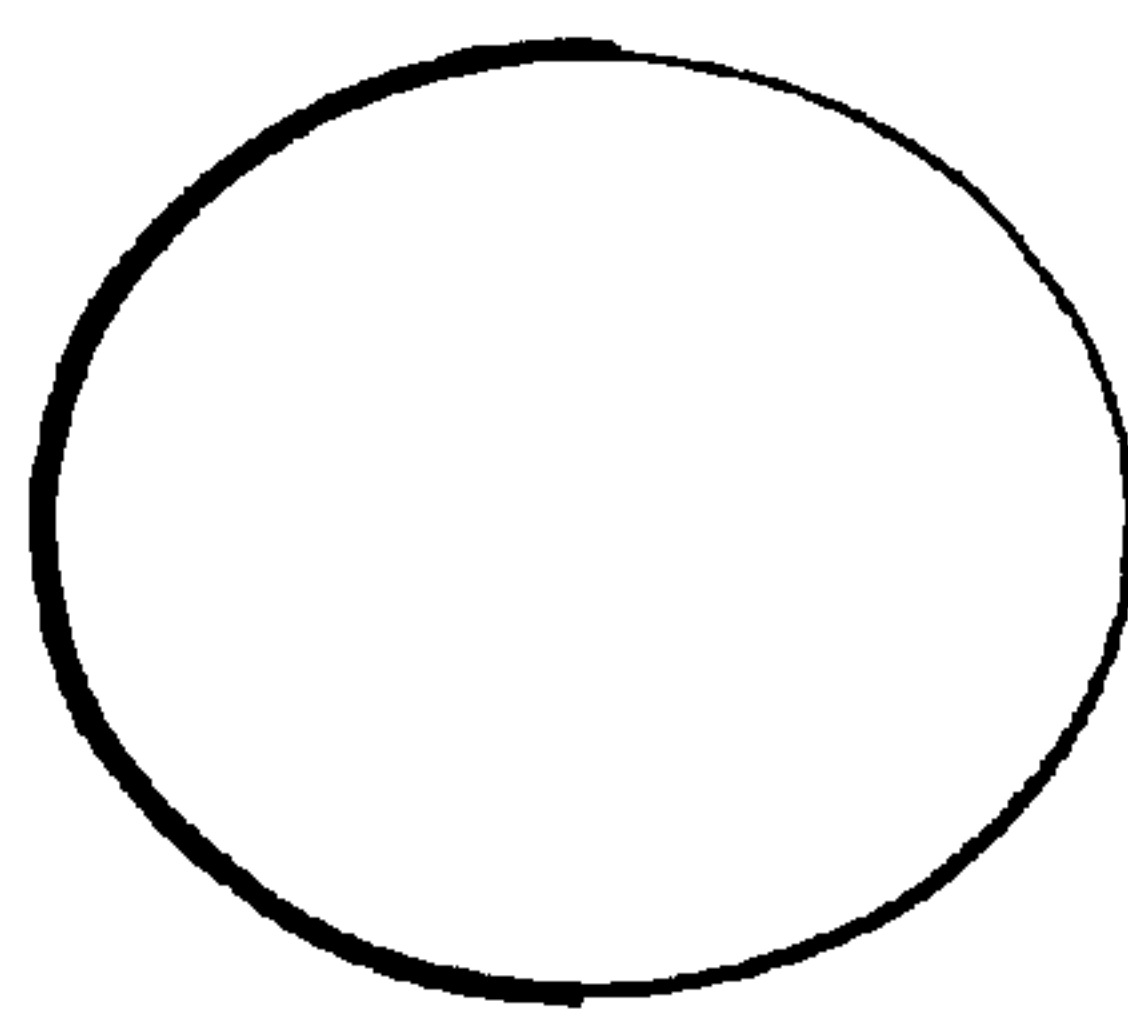
