The ornamental design for a wig, as shown and described.

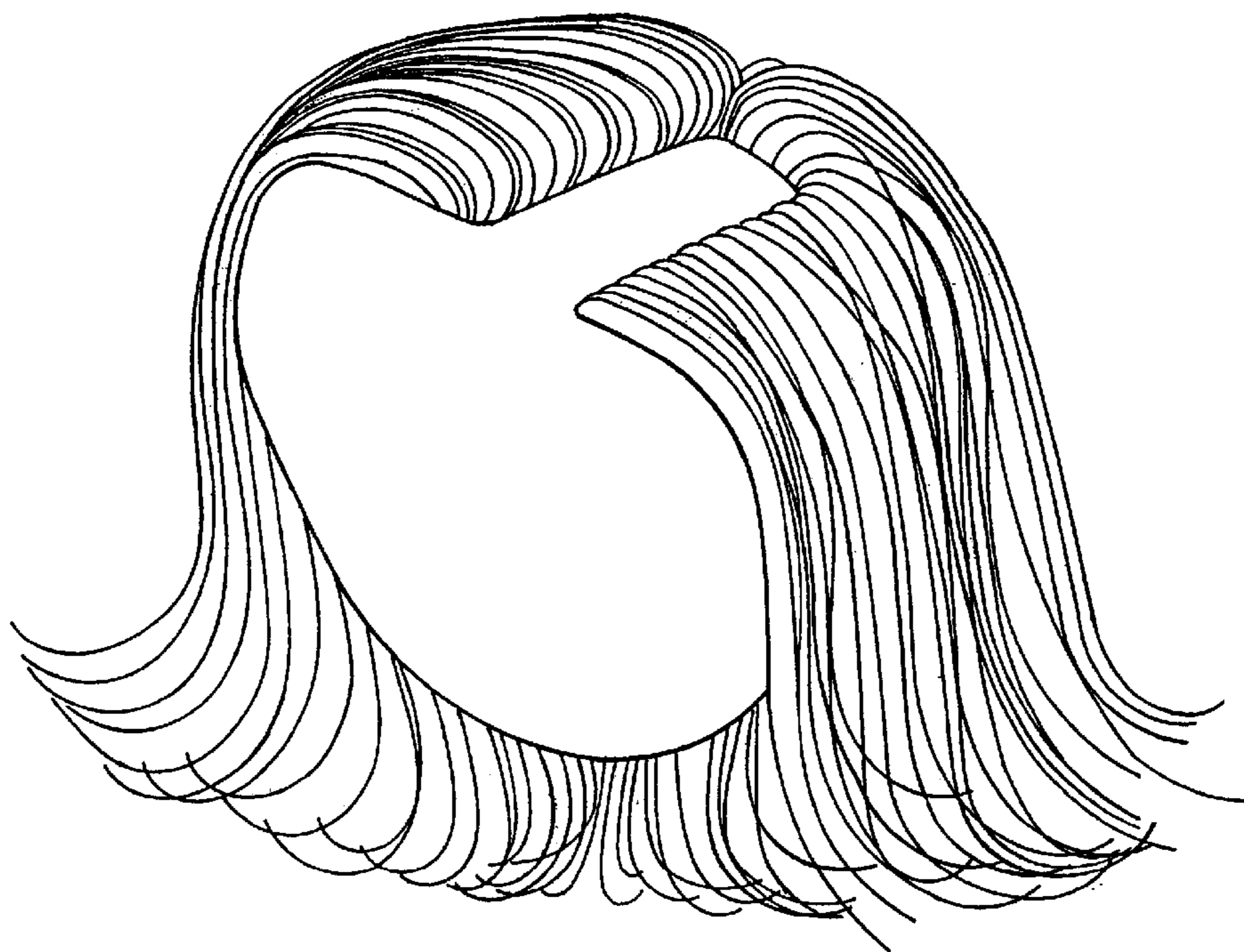
DESCRIPTION

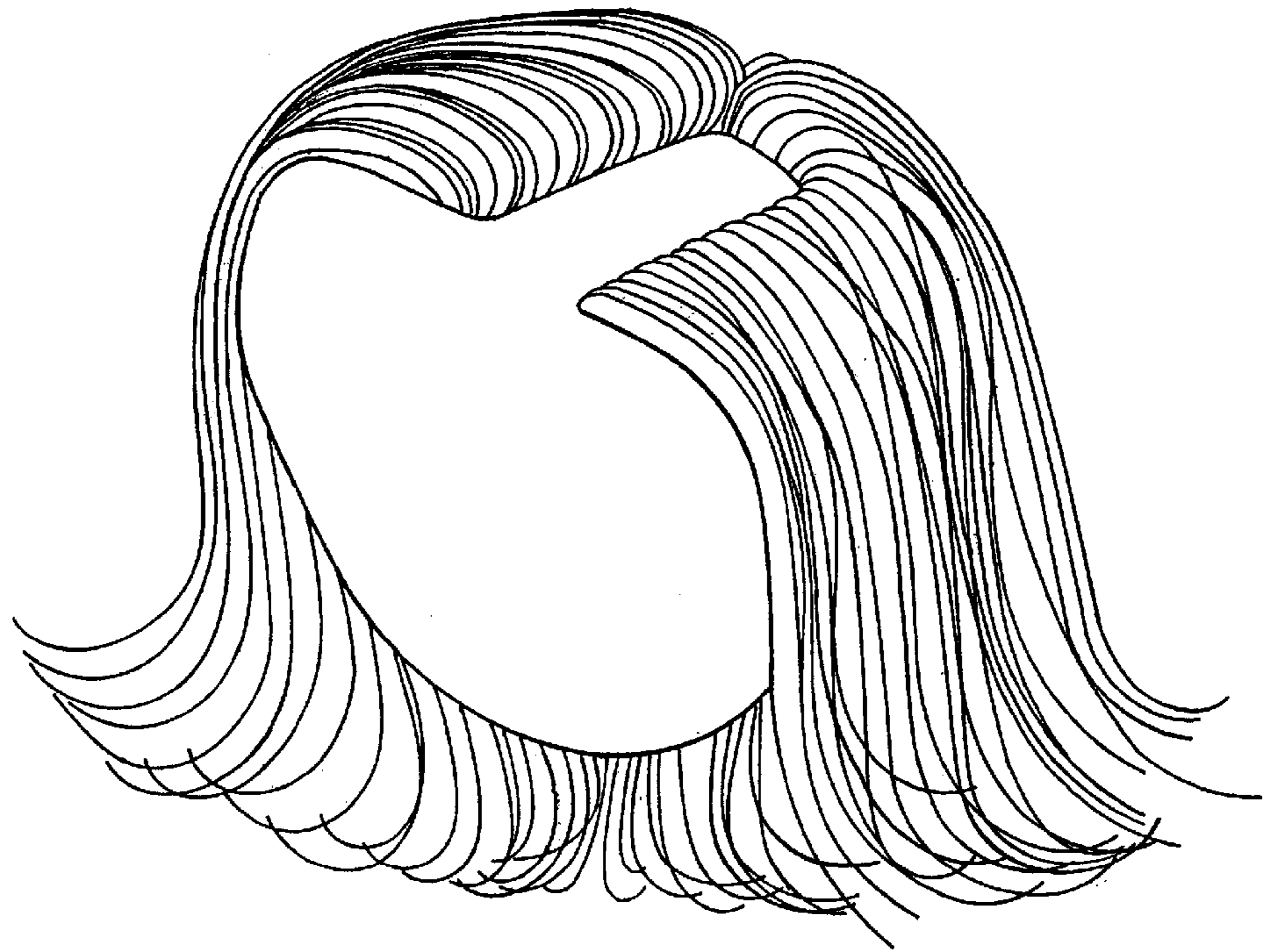

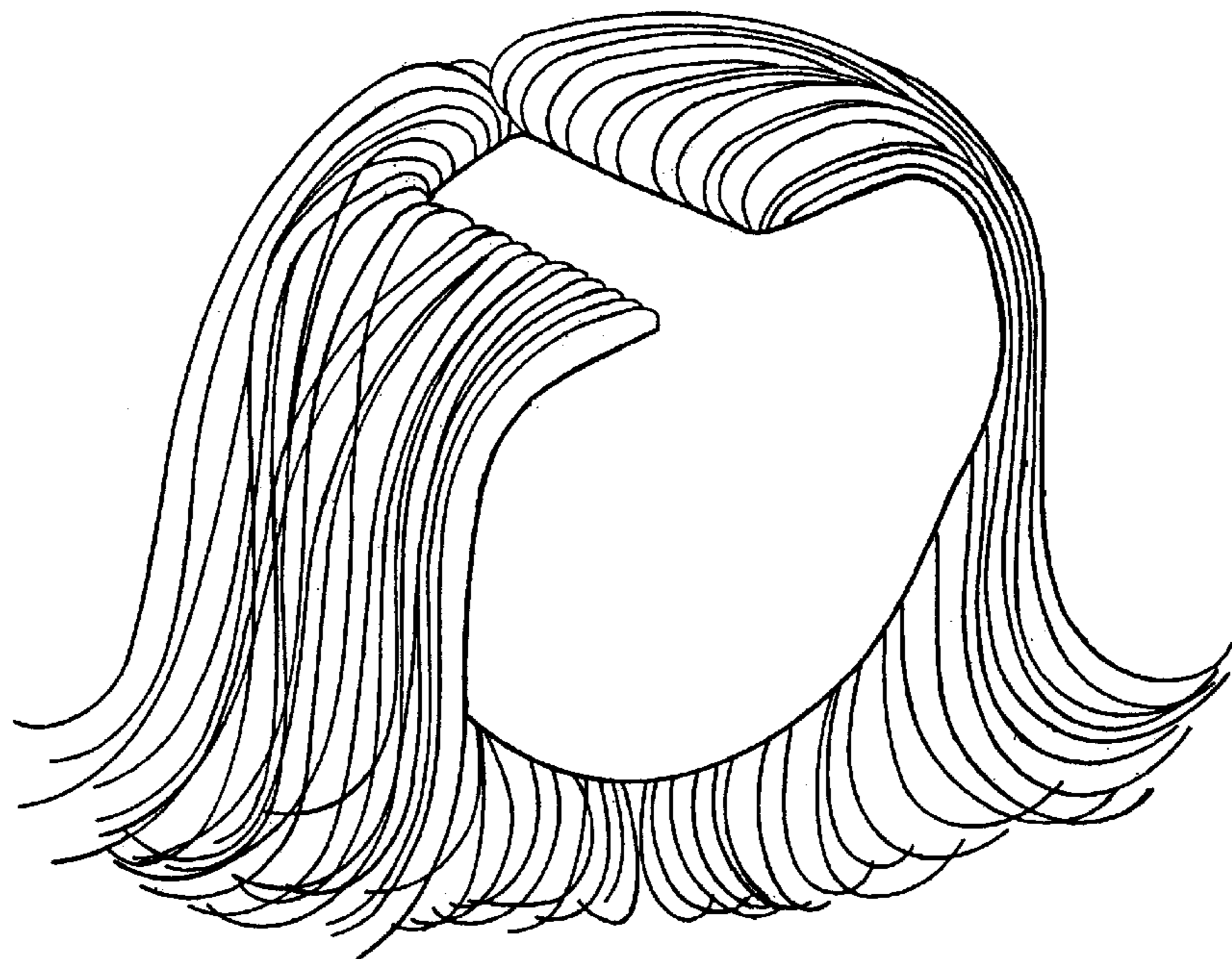
