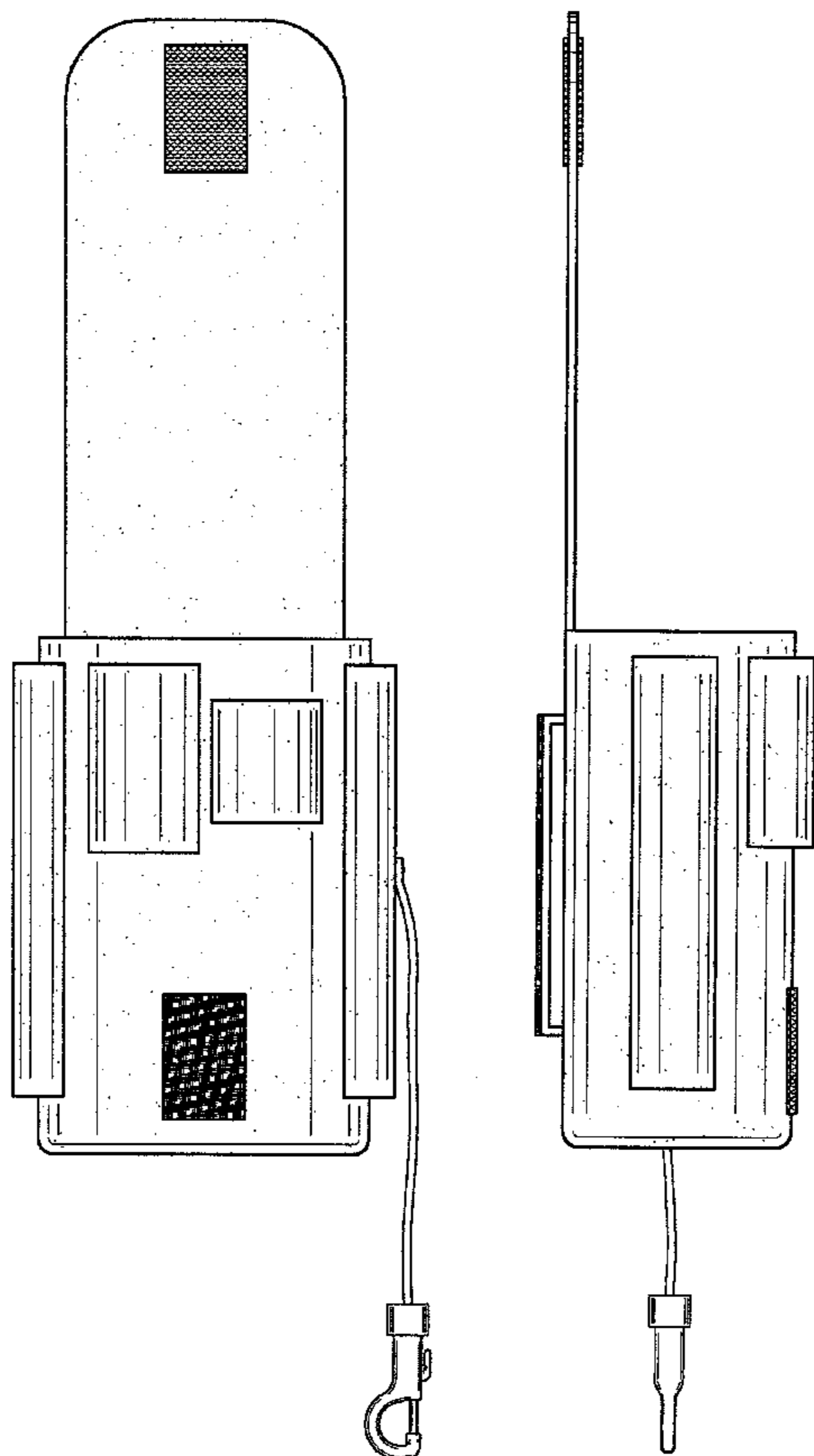

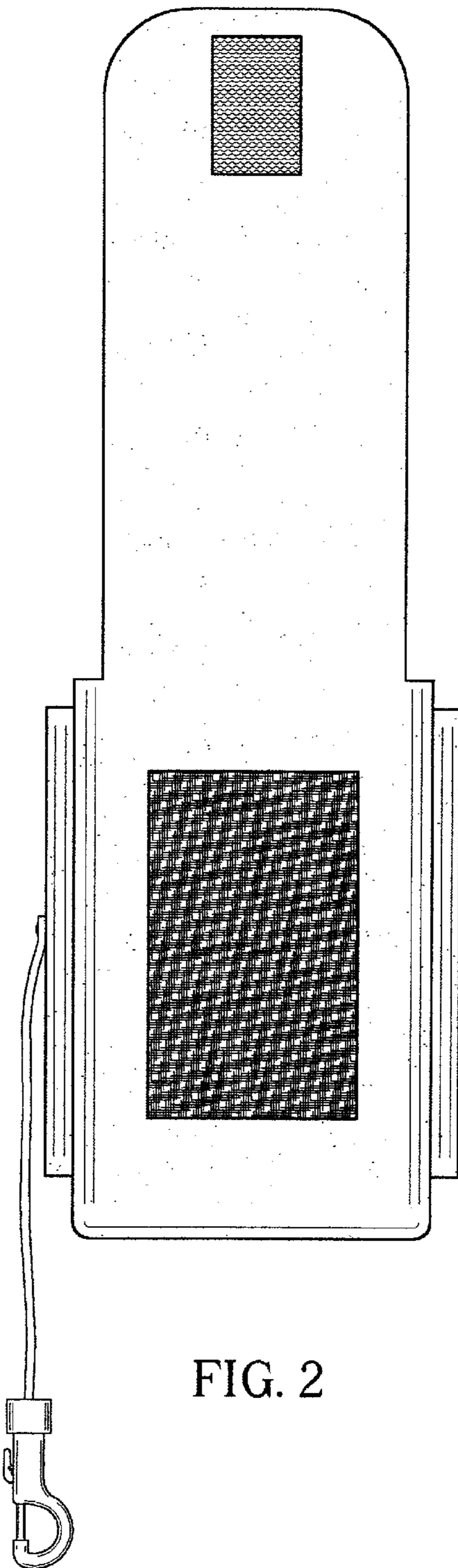
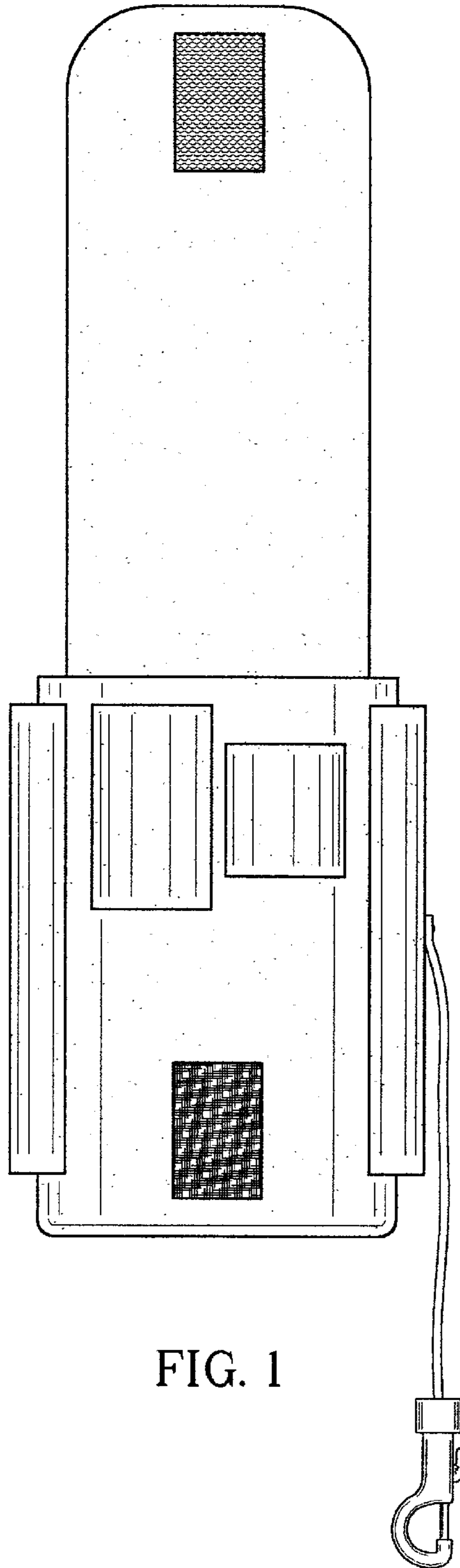
The ornamental design for a case for spectacles and accessories, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a case for spectacles and accessories showing our new design;  
FIG. 2 is a rear elevational view thereof;

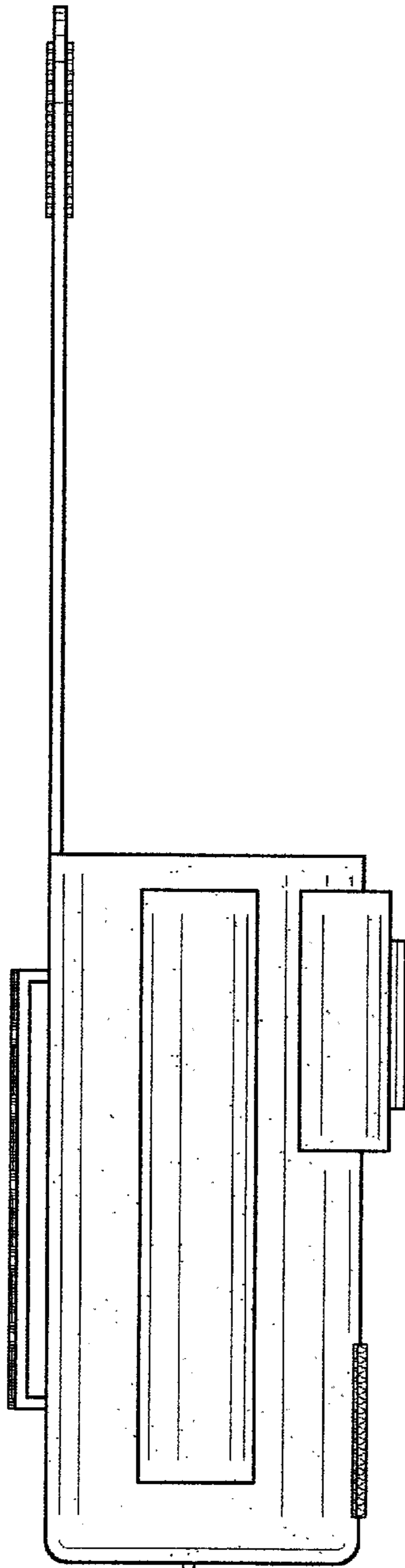

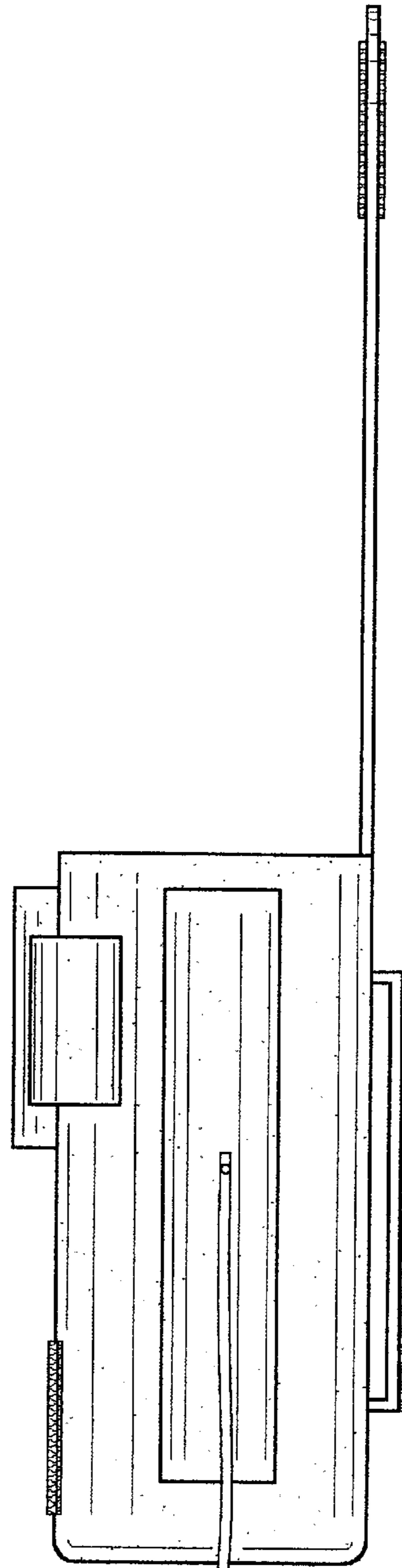

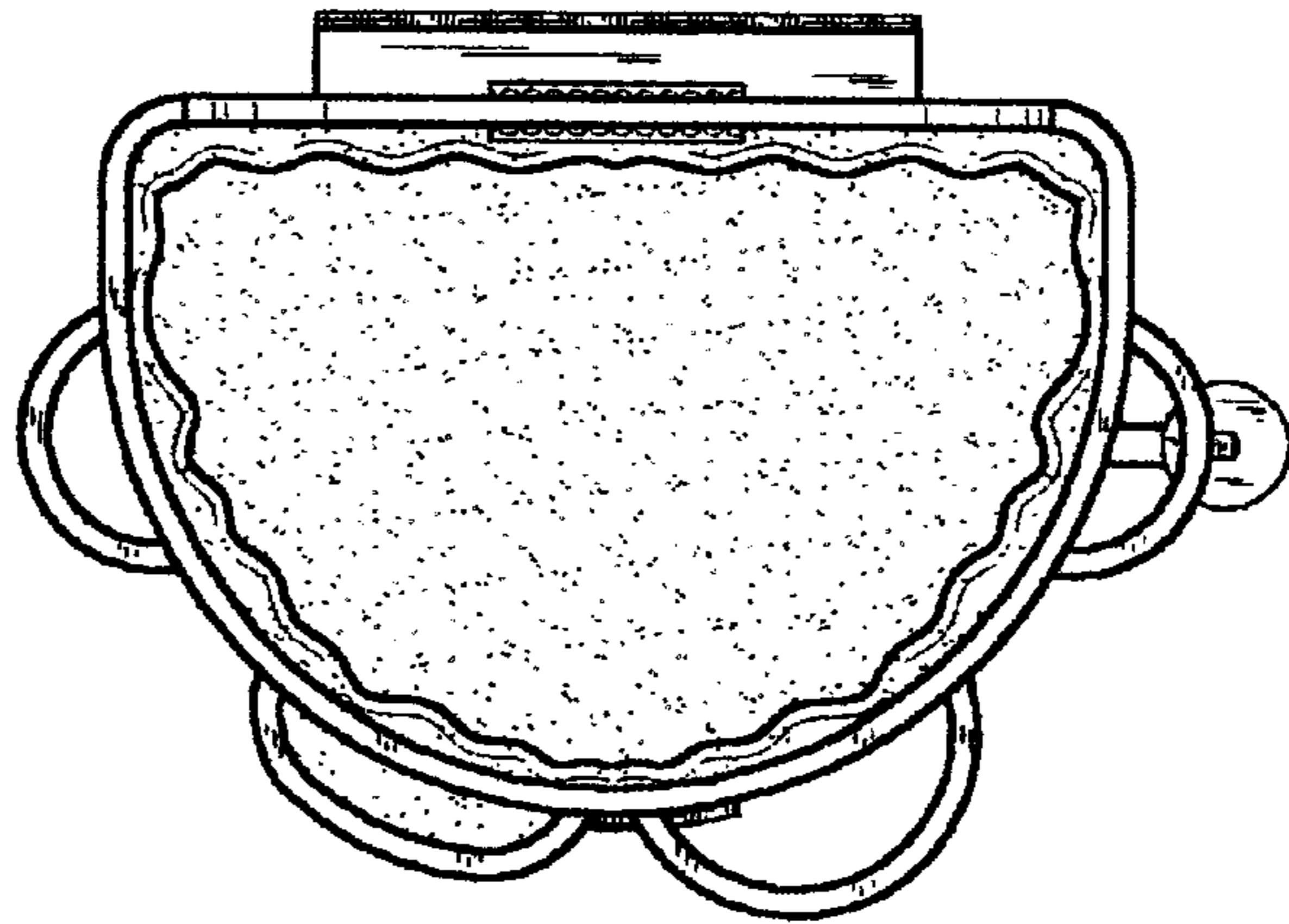
