The areas of texture shown in FIGS. 1, 4 and 5 are understood to extend across the entire surface.

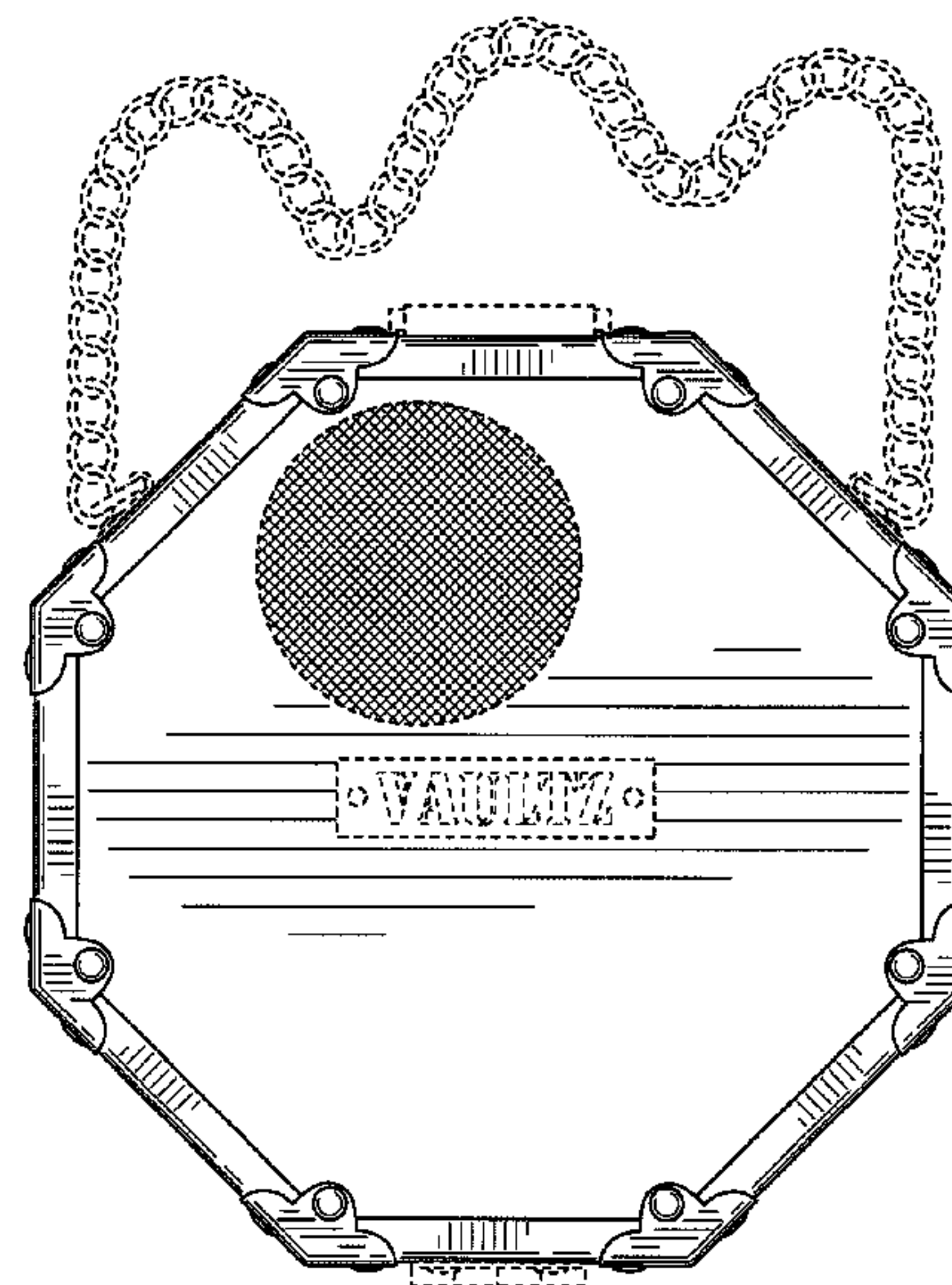
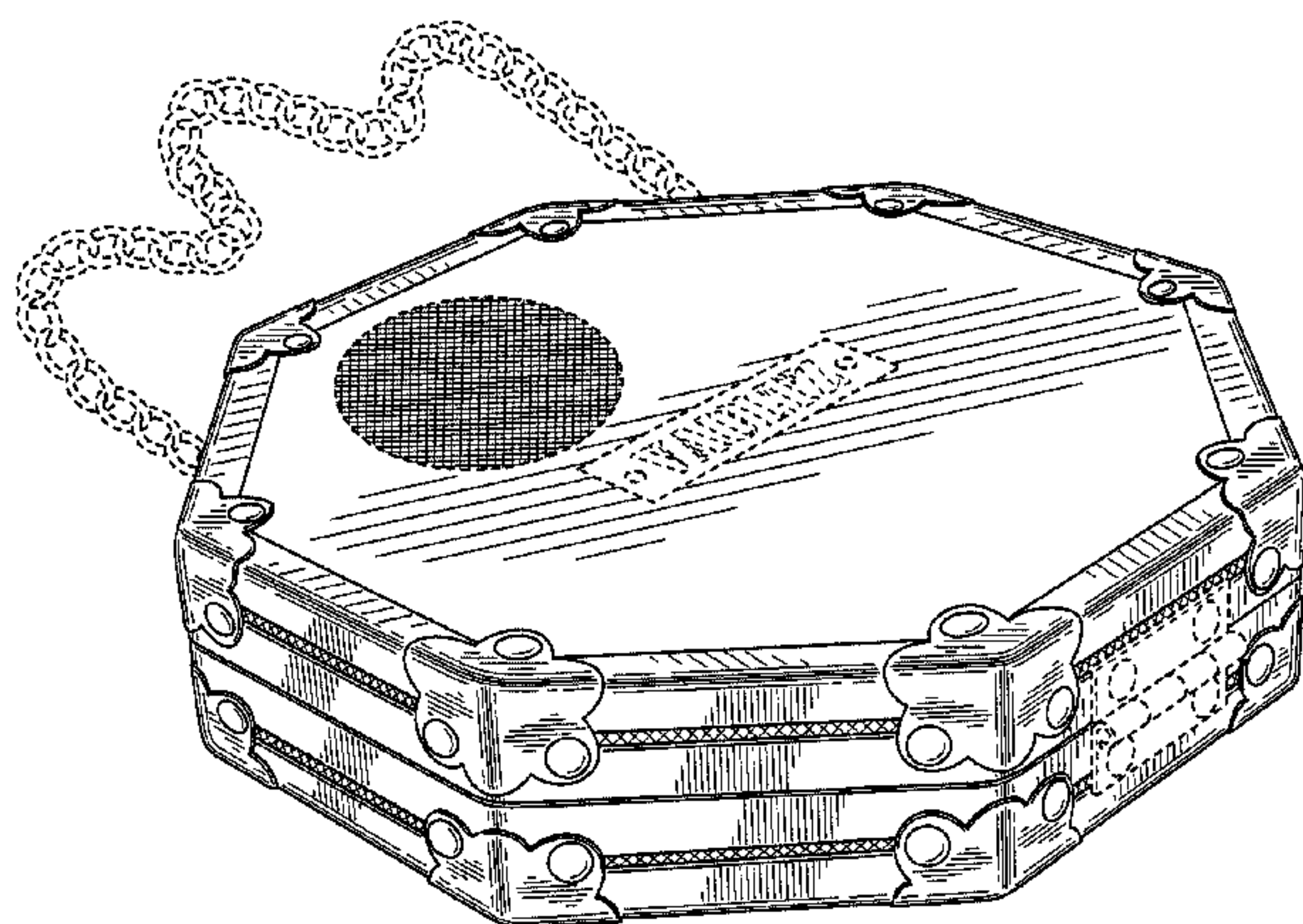

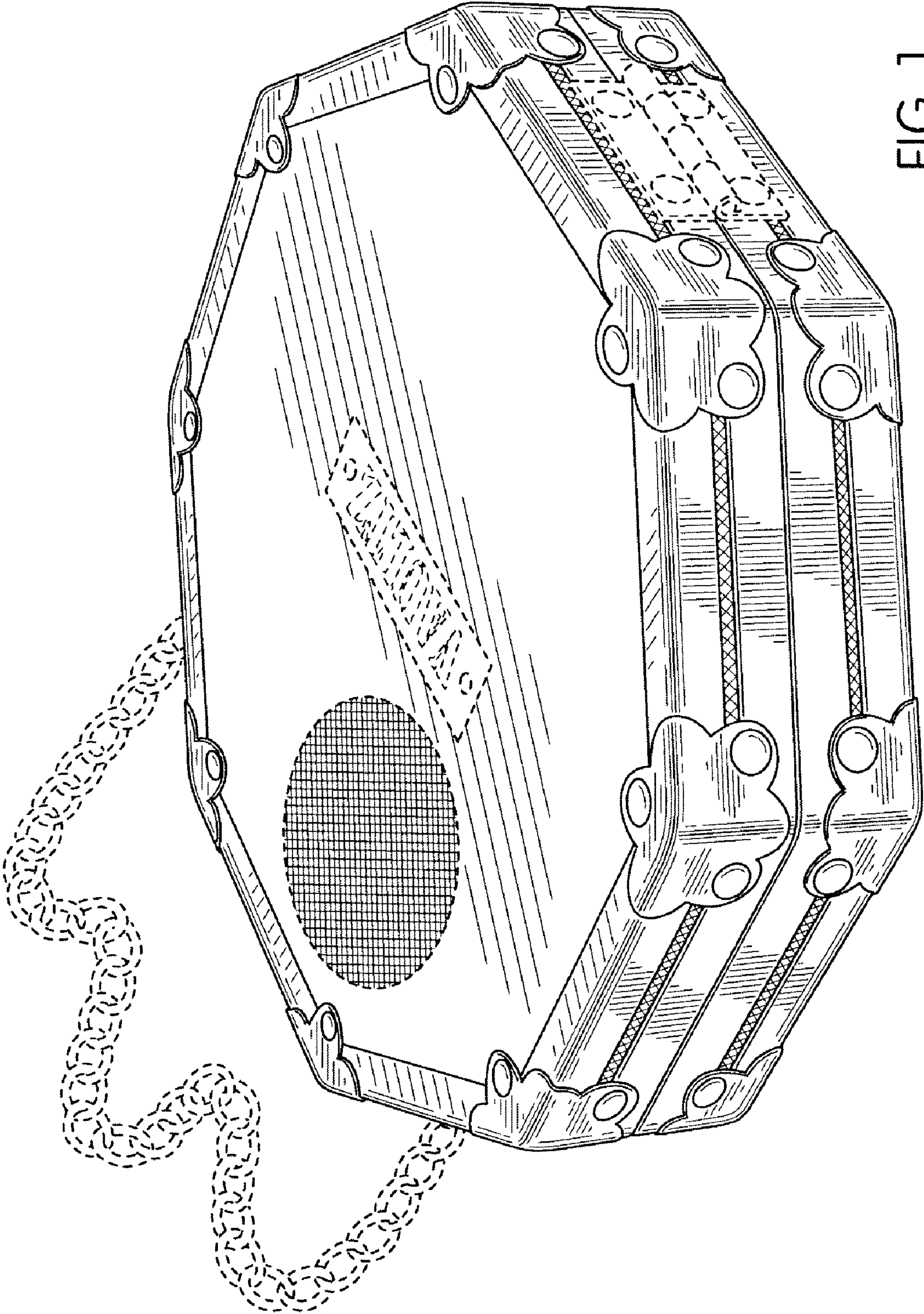

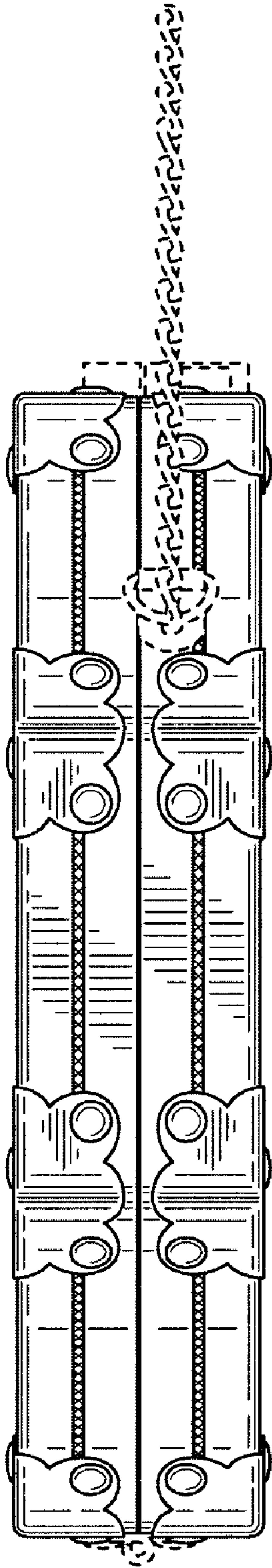

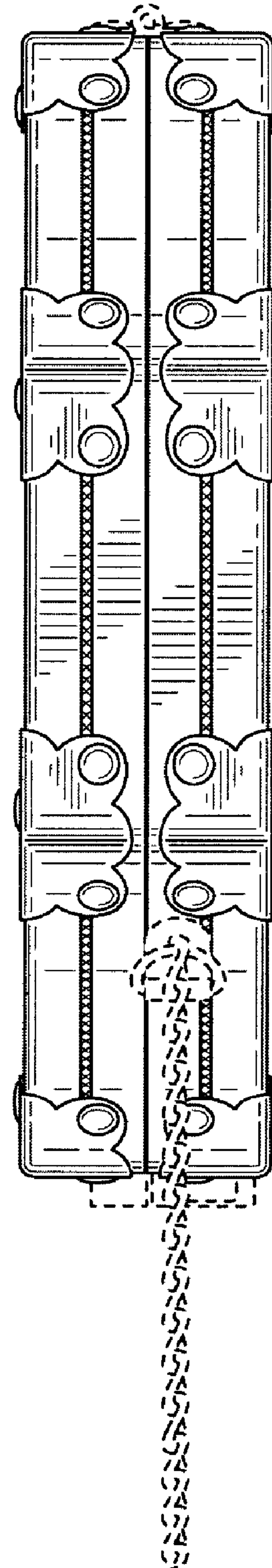

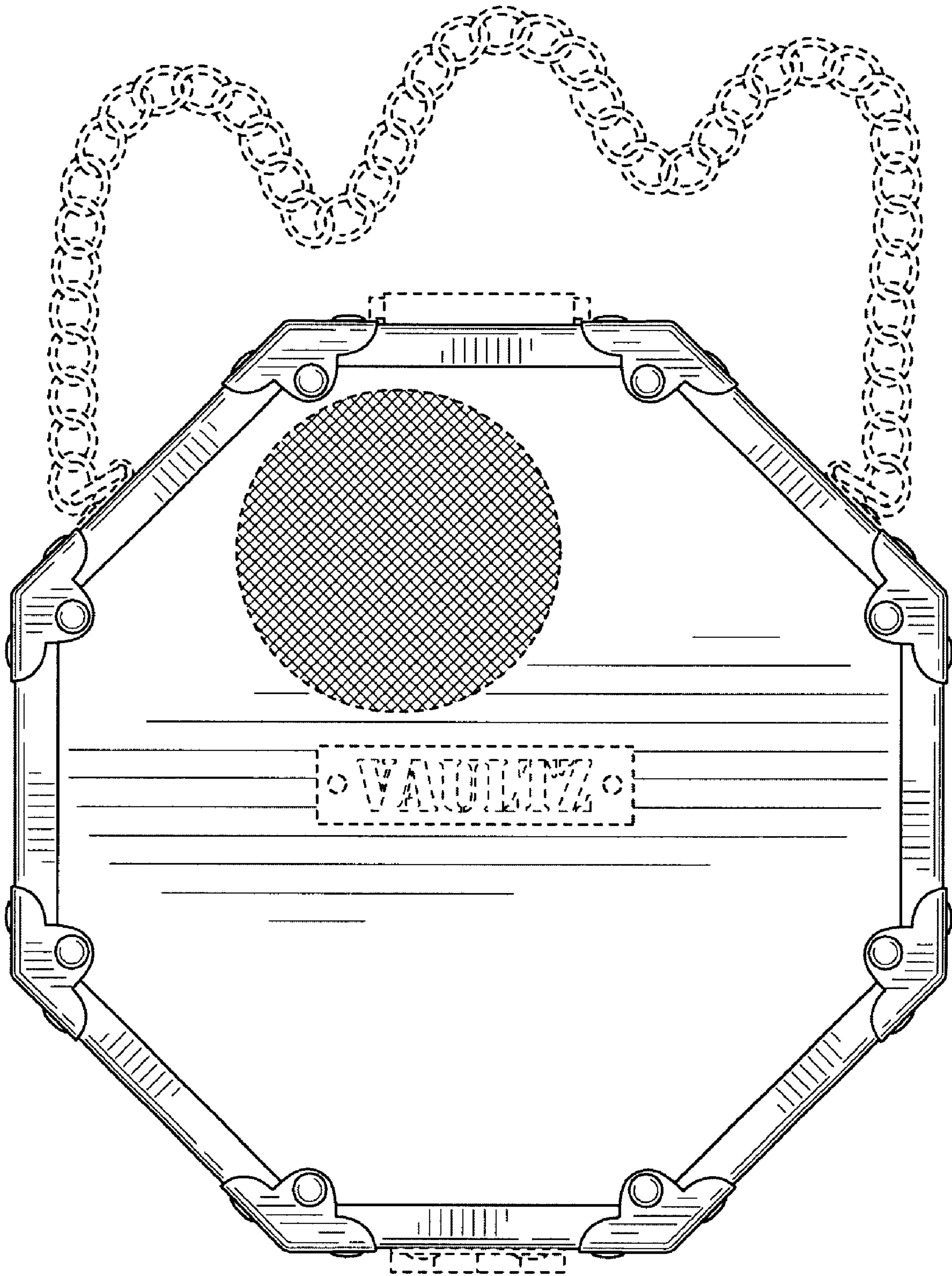

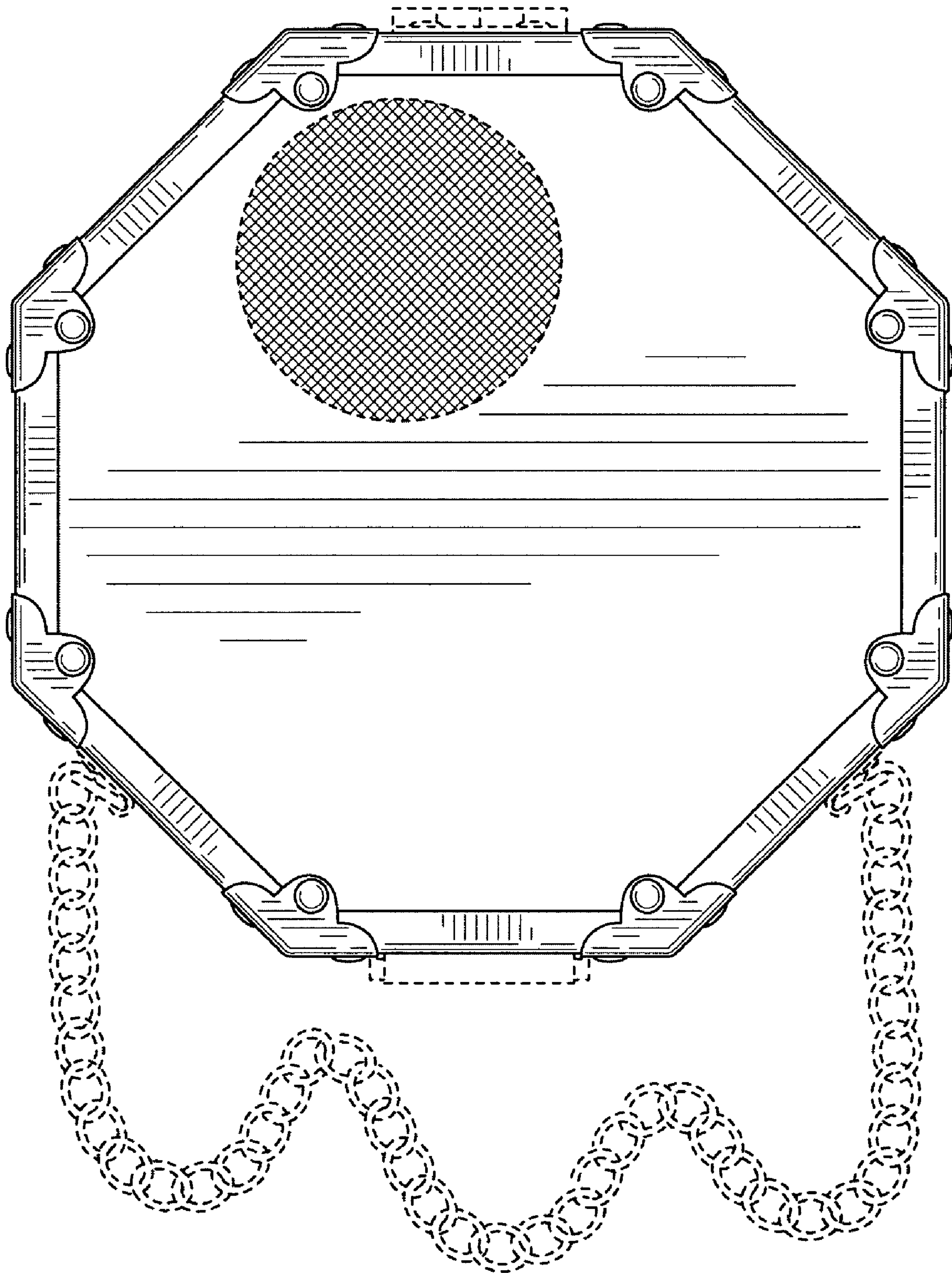

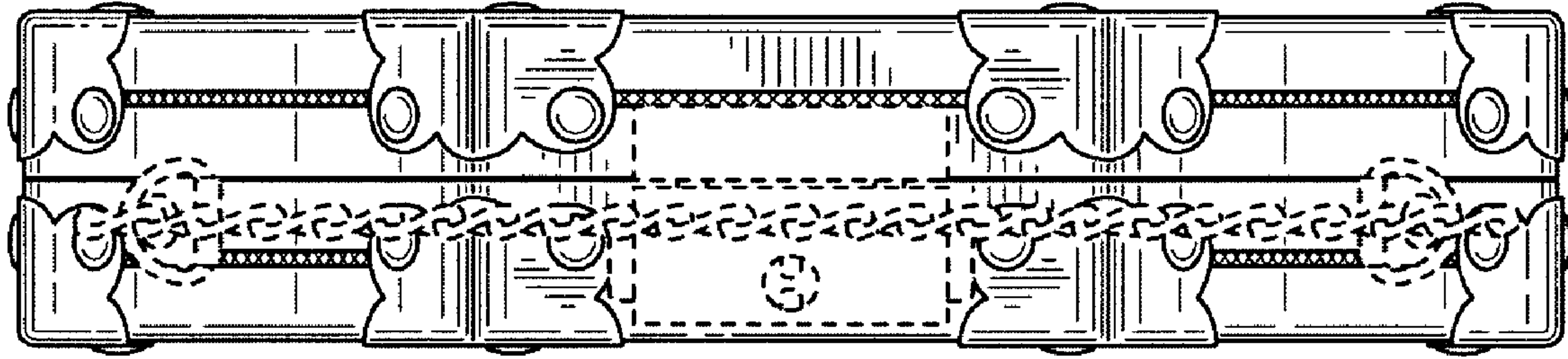

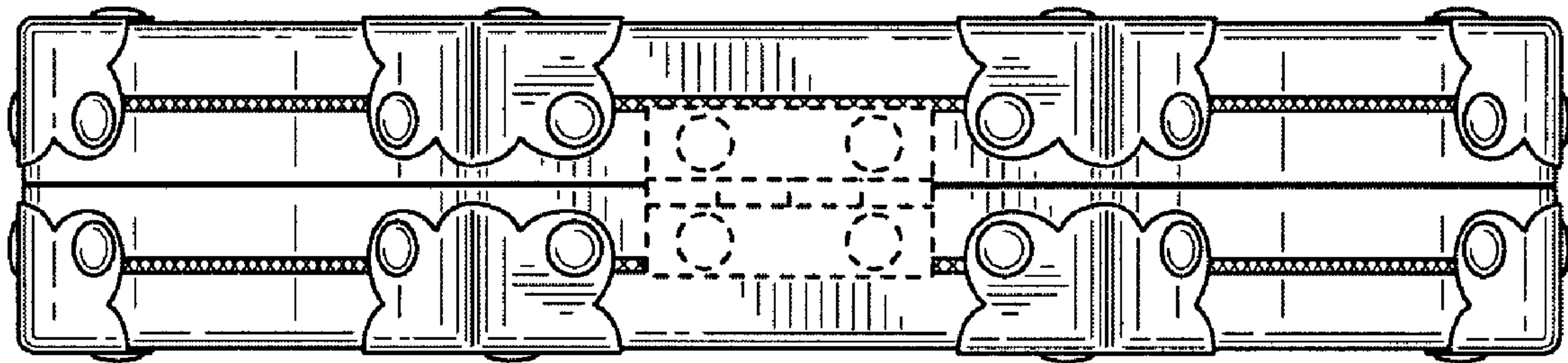
