DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of my invention;

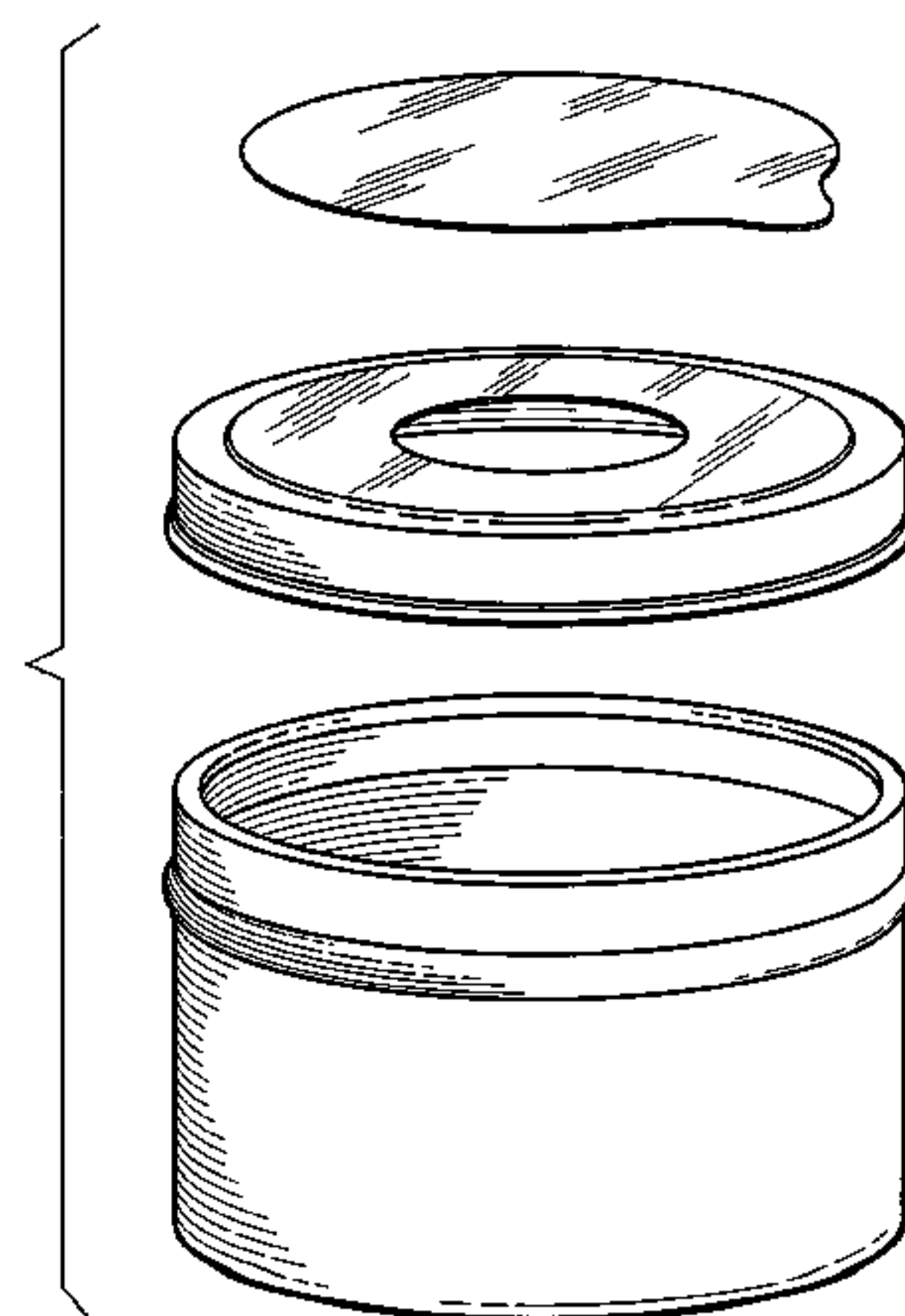

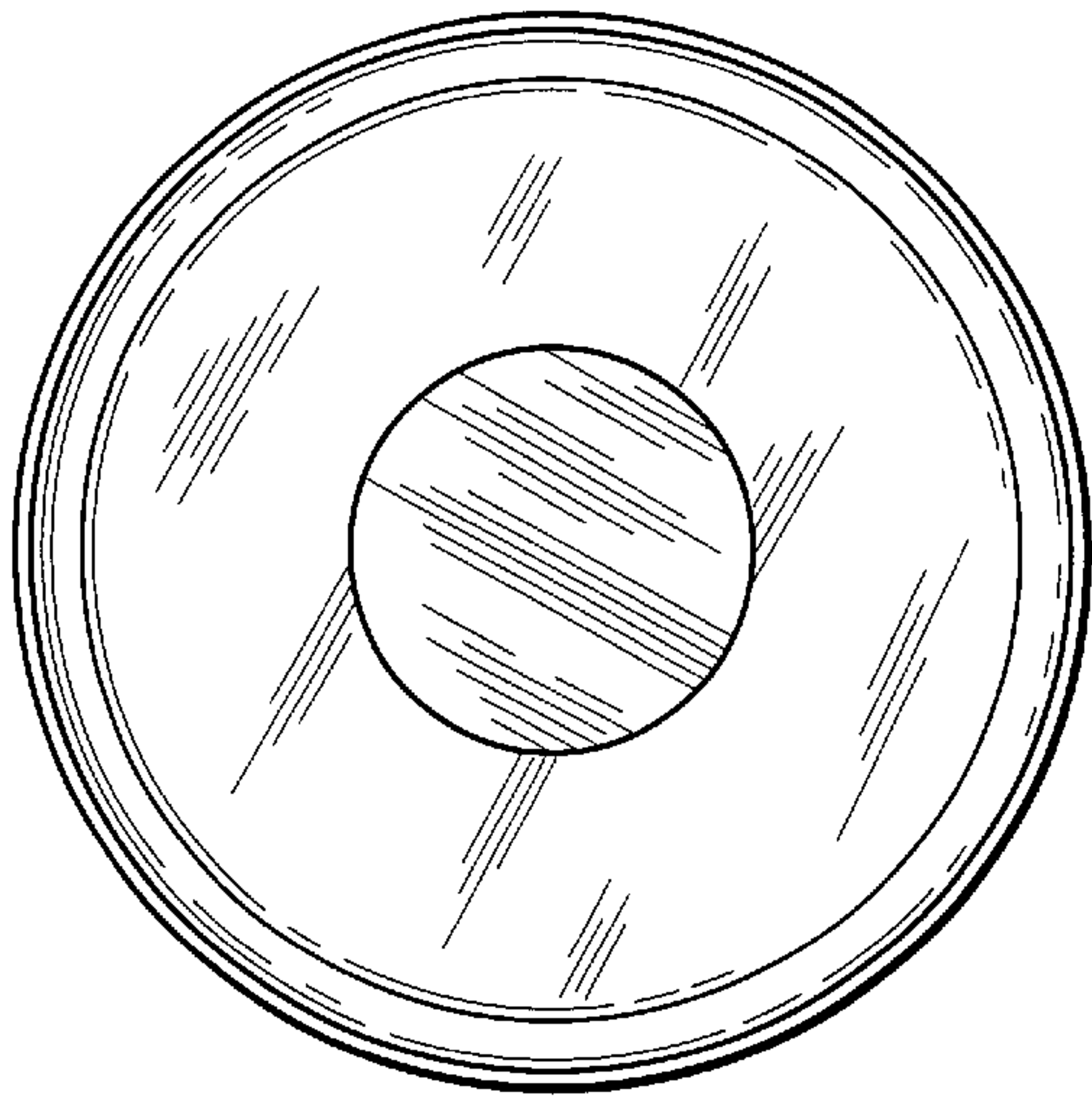

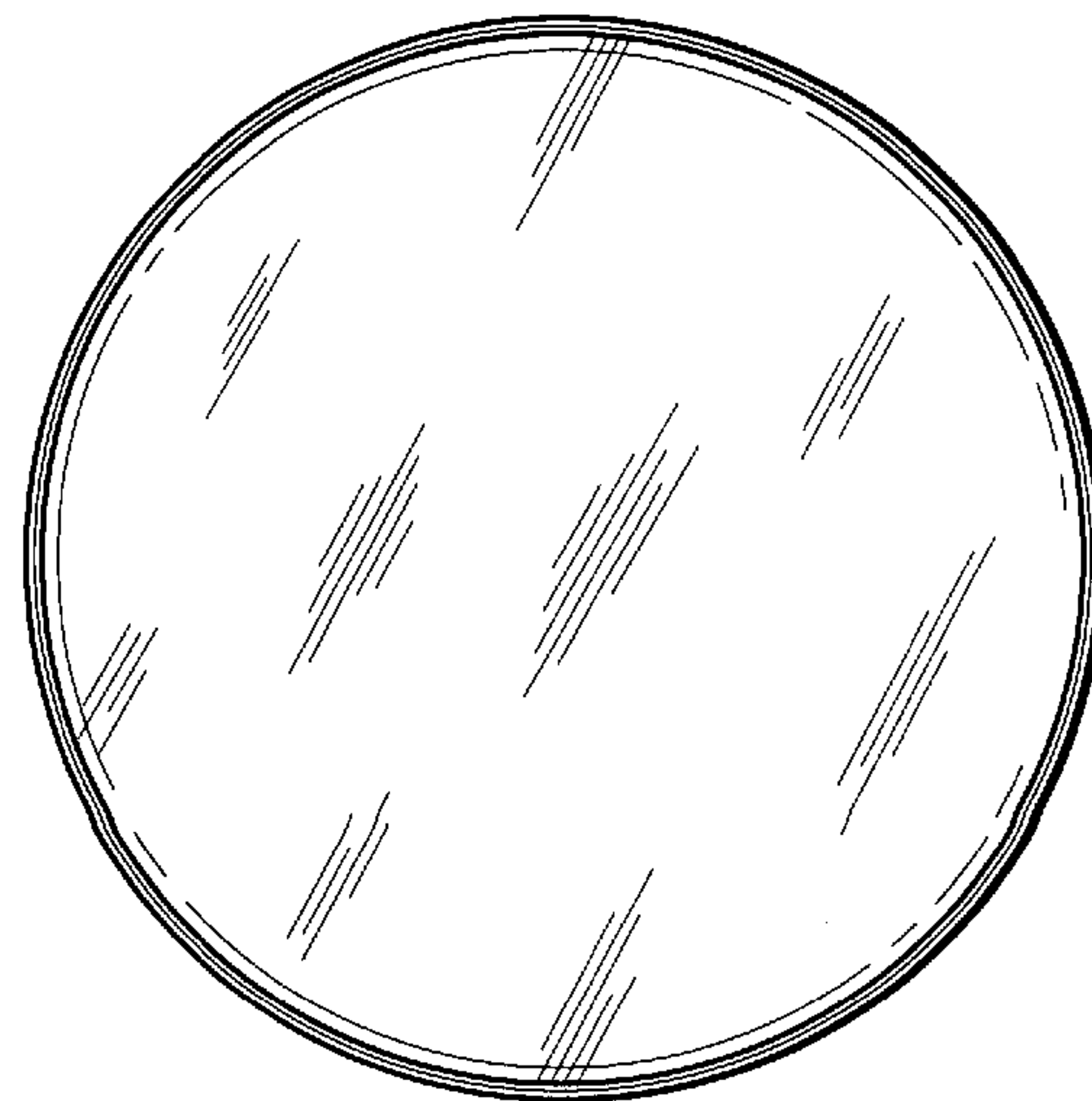

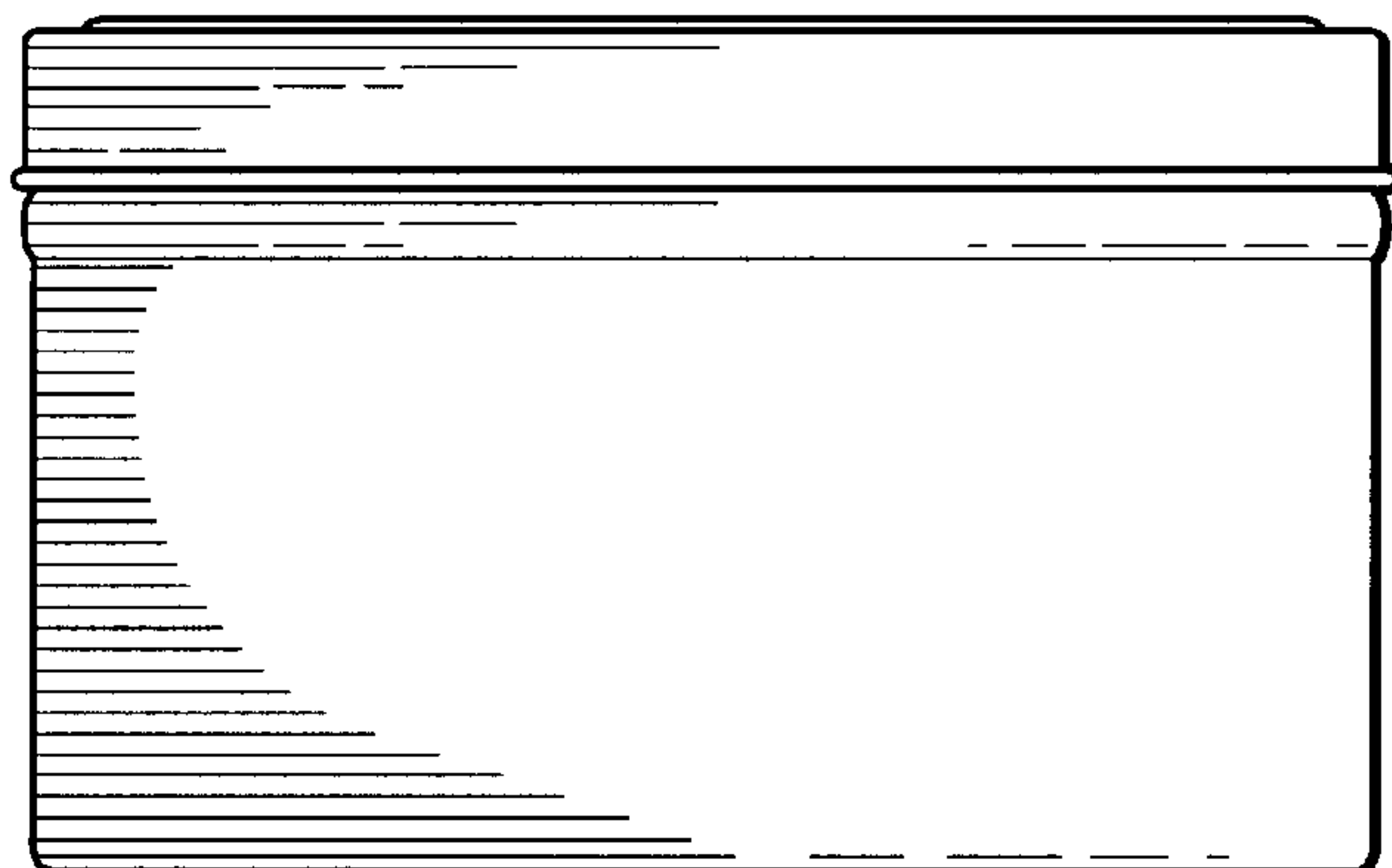

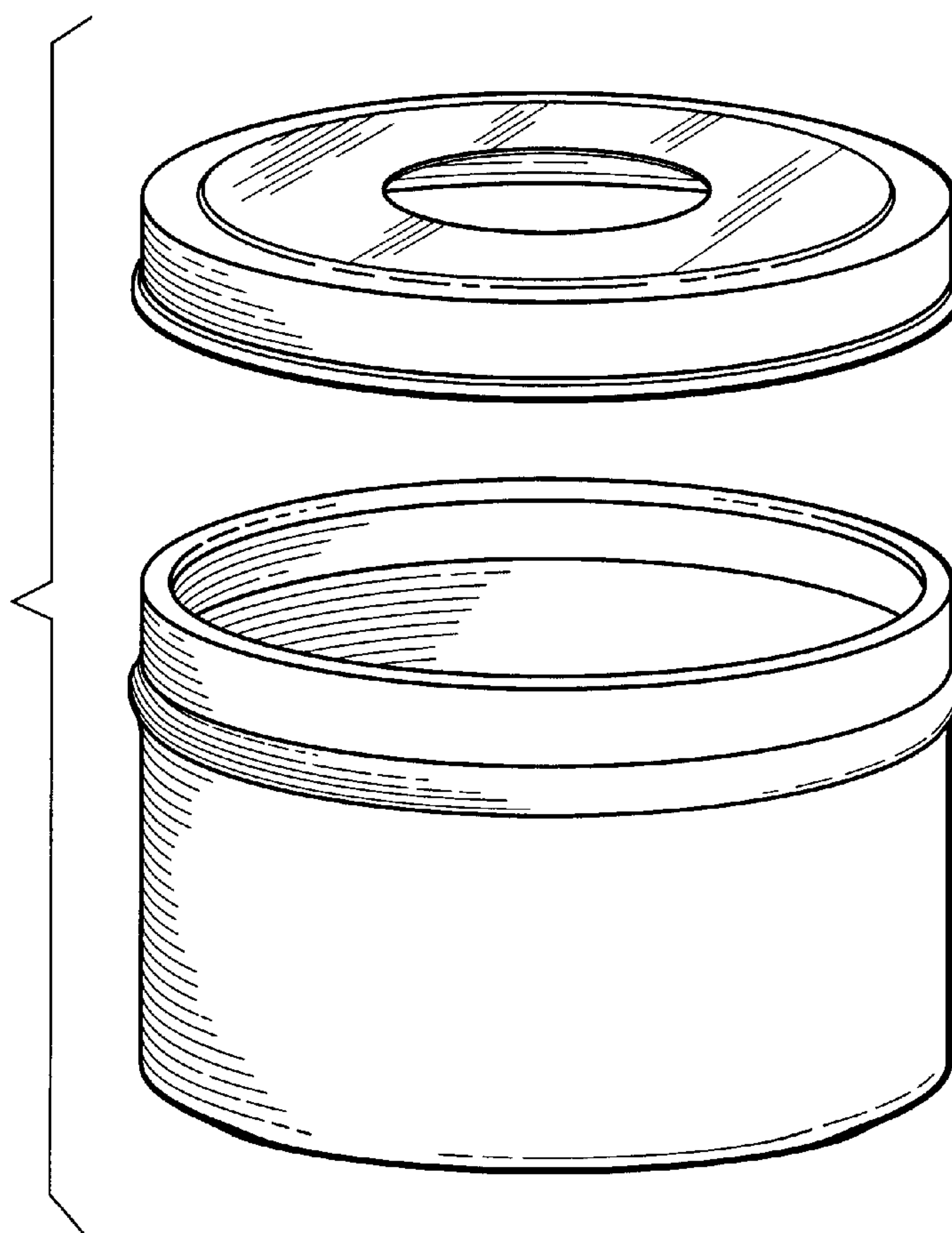

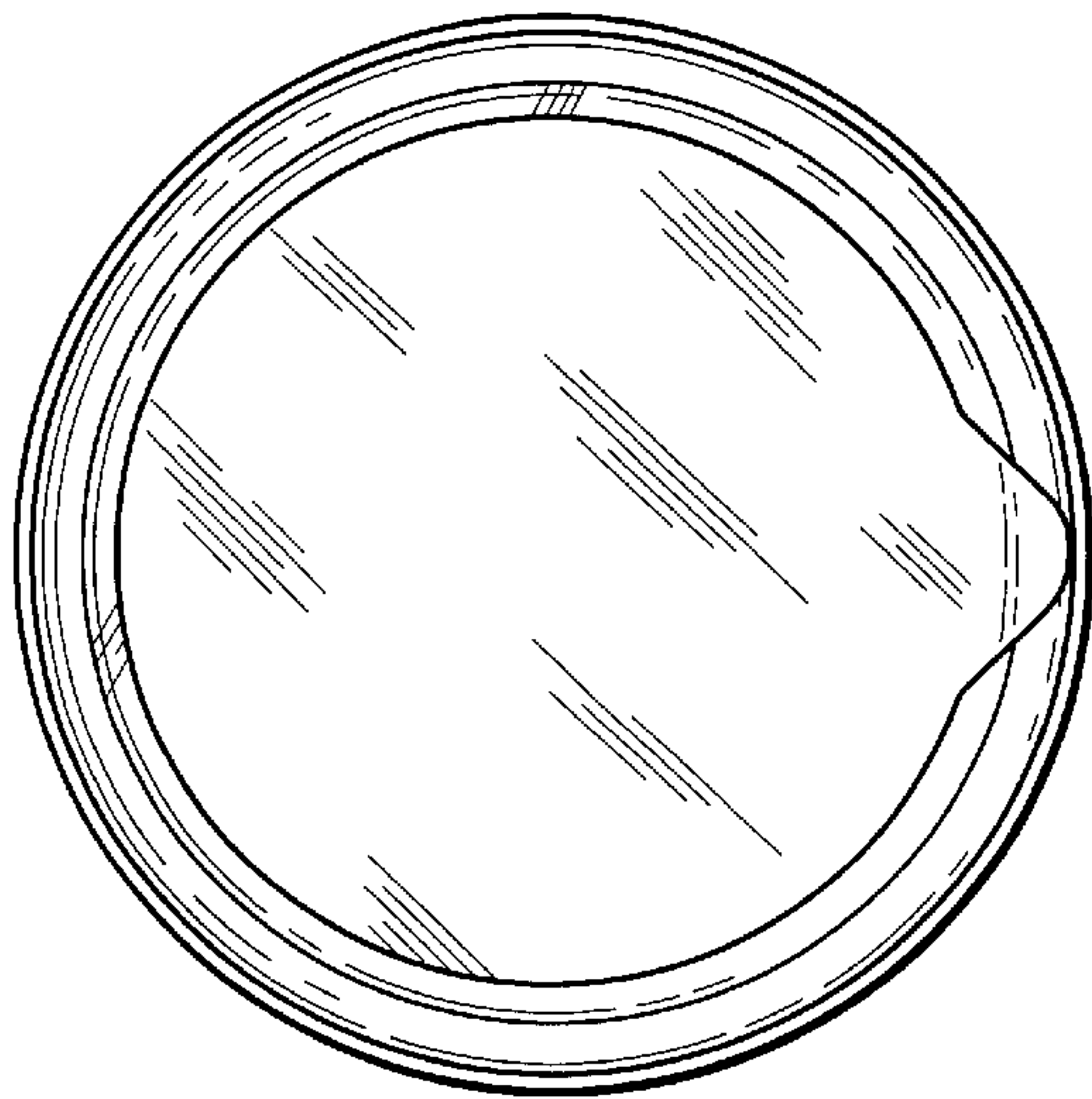

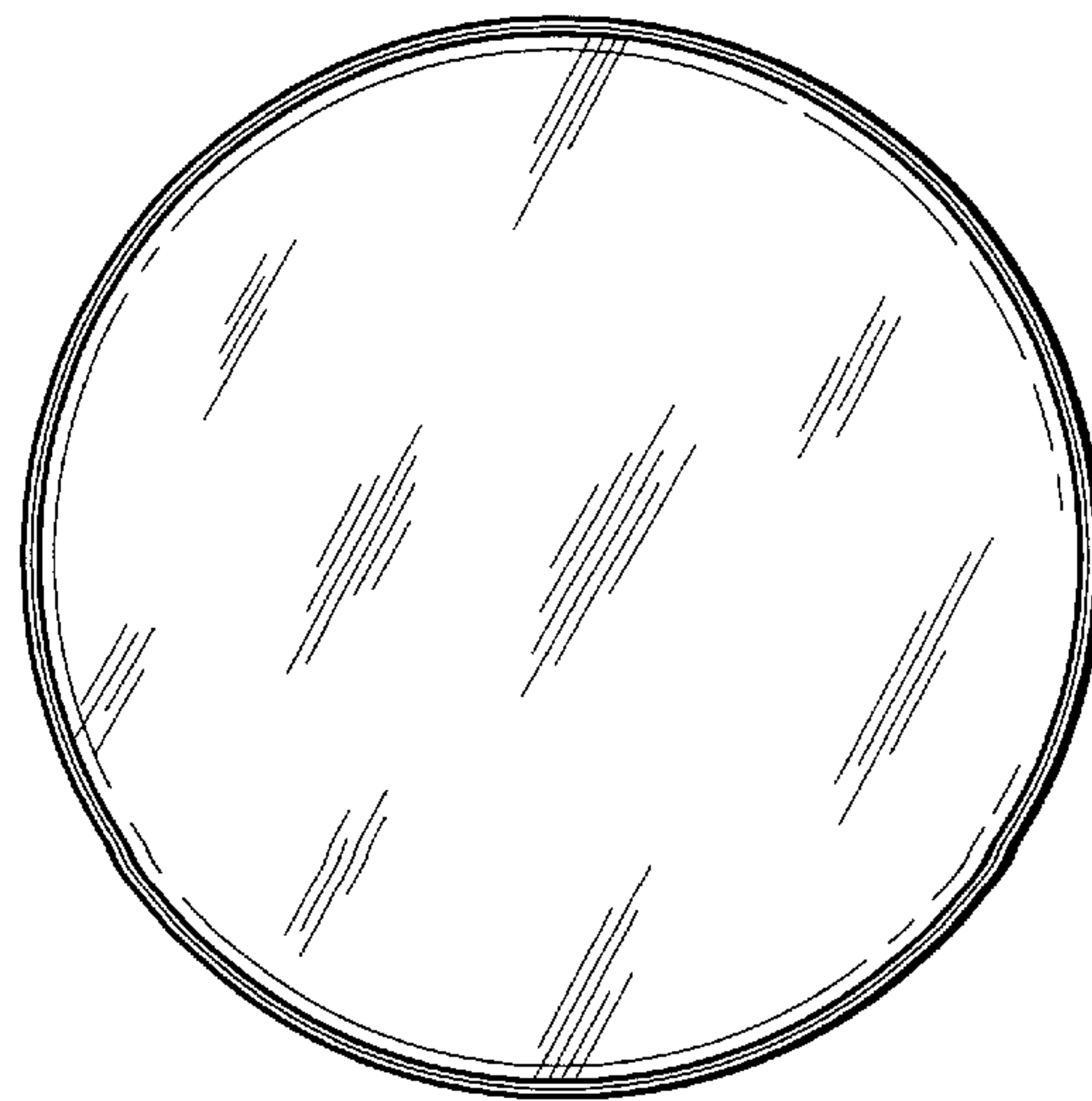

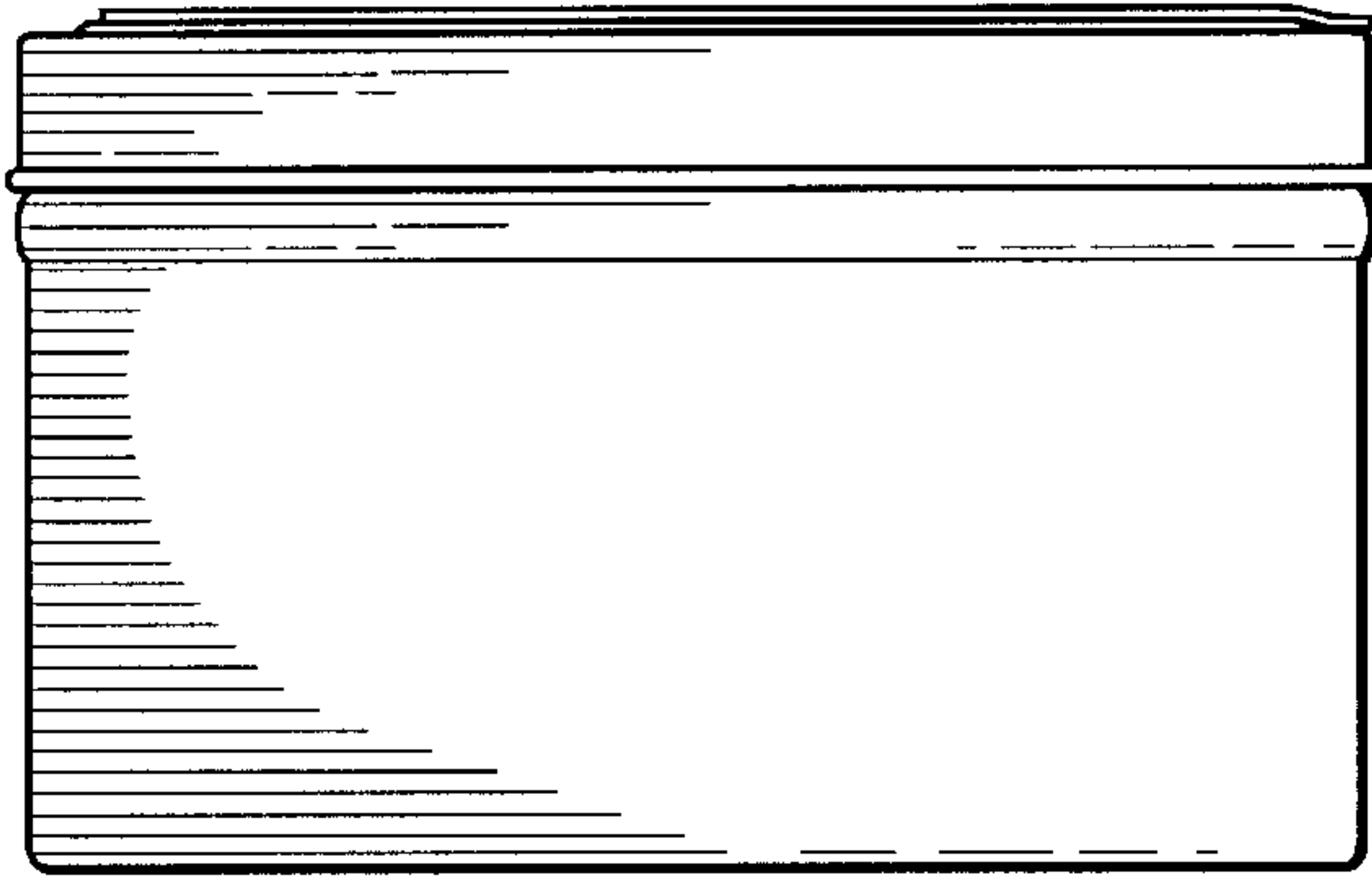

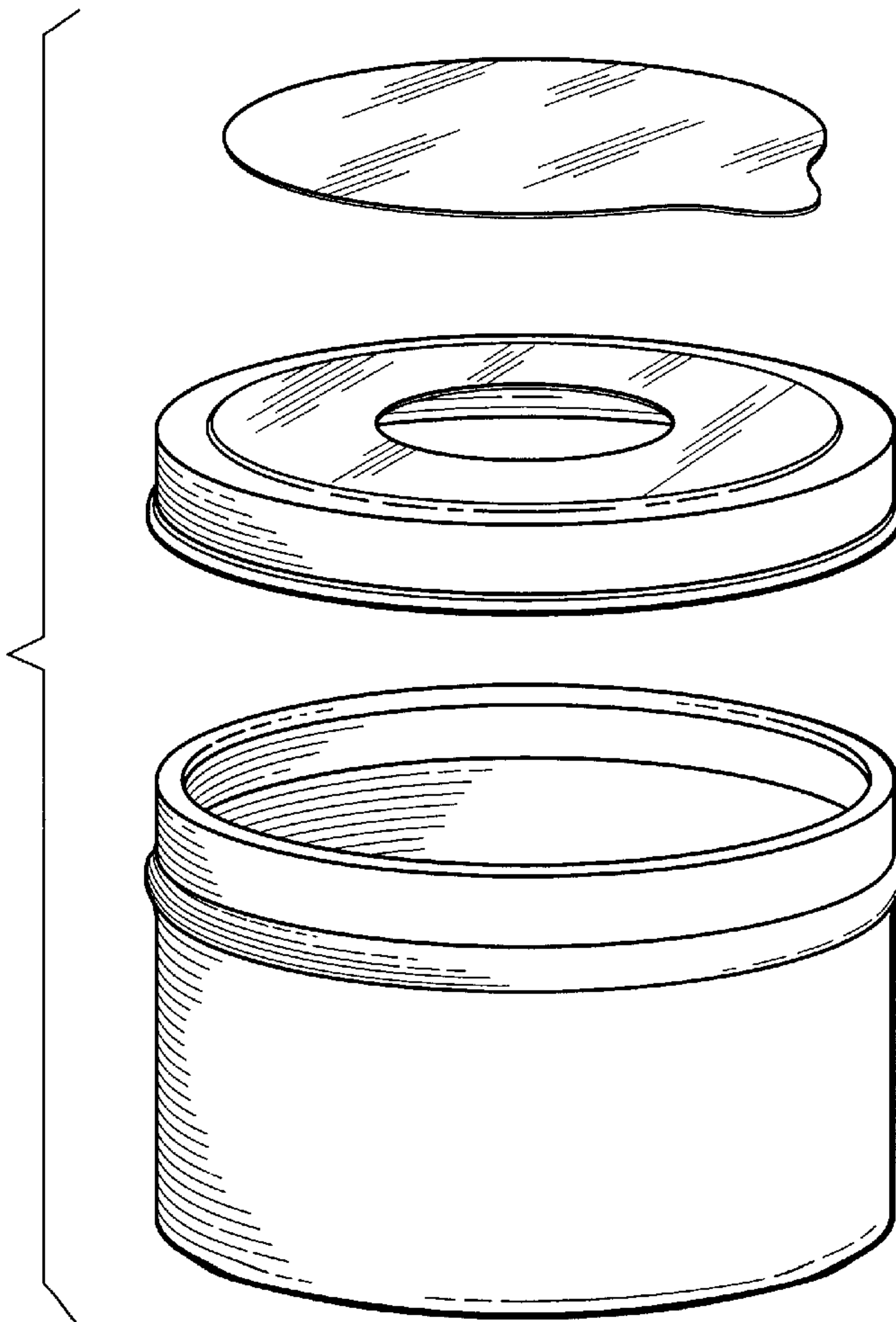
