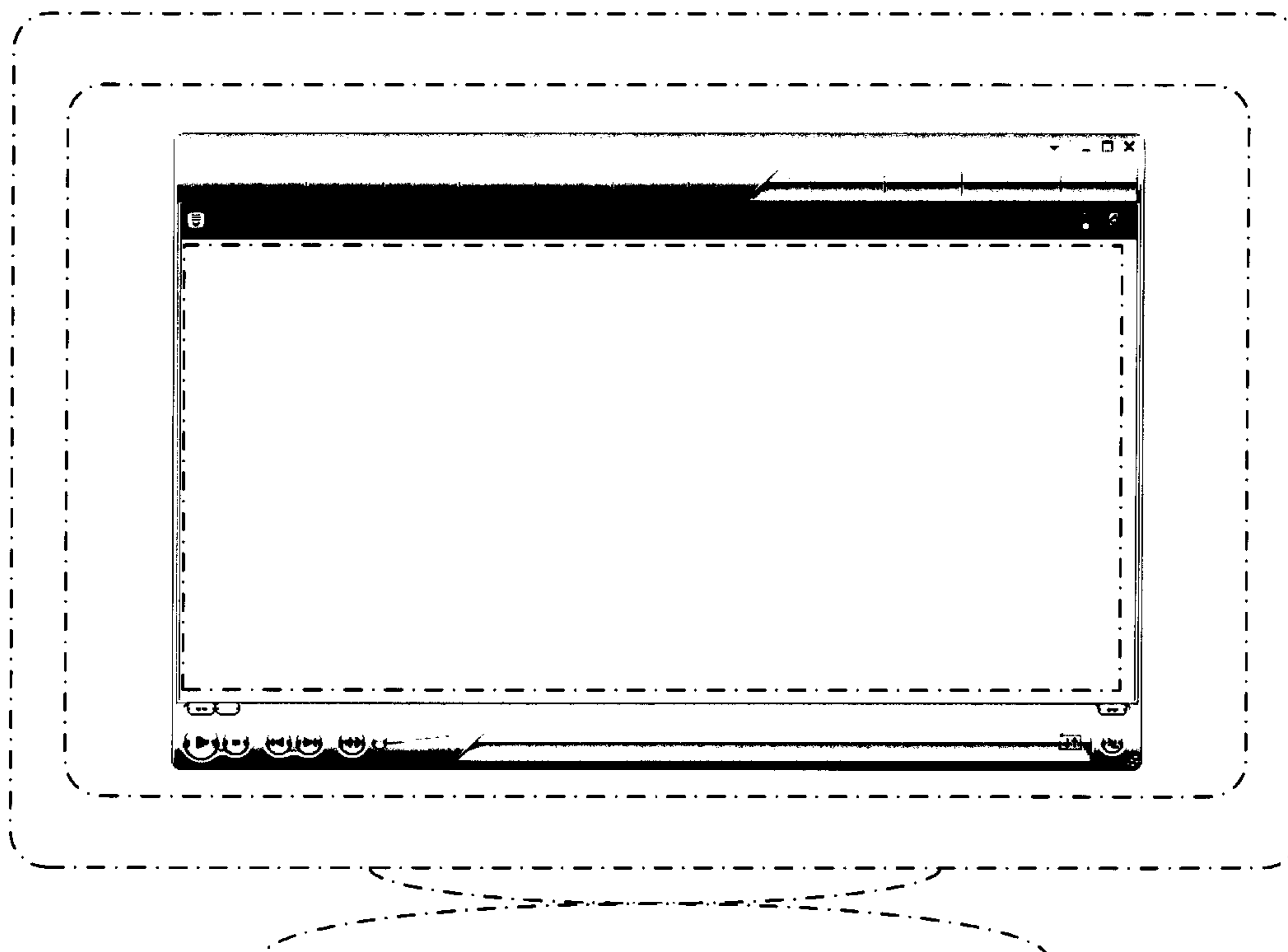
(57) **CLAIM**

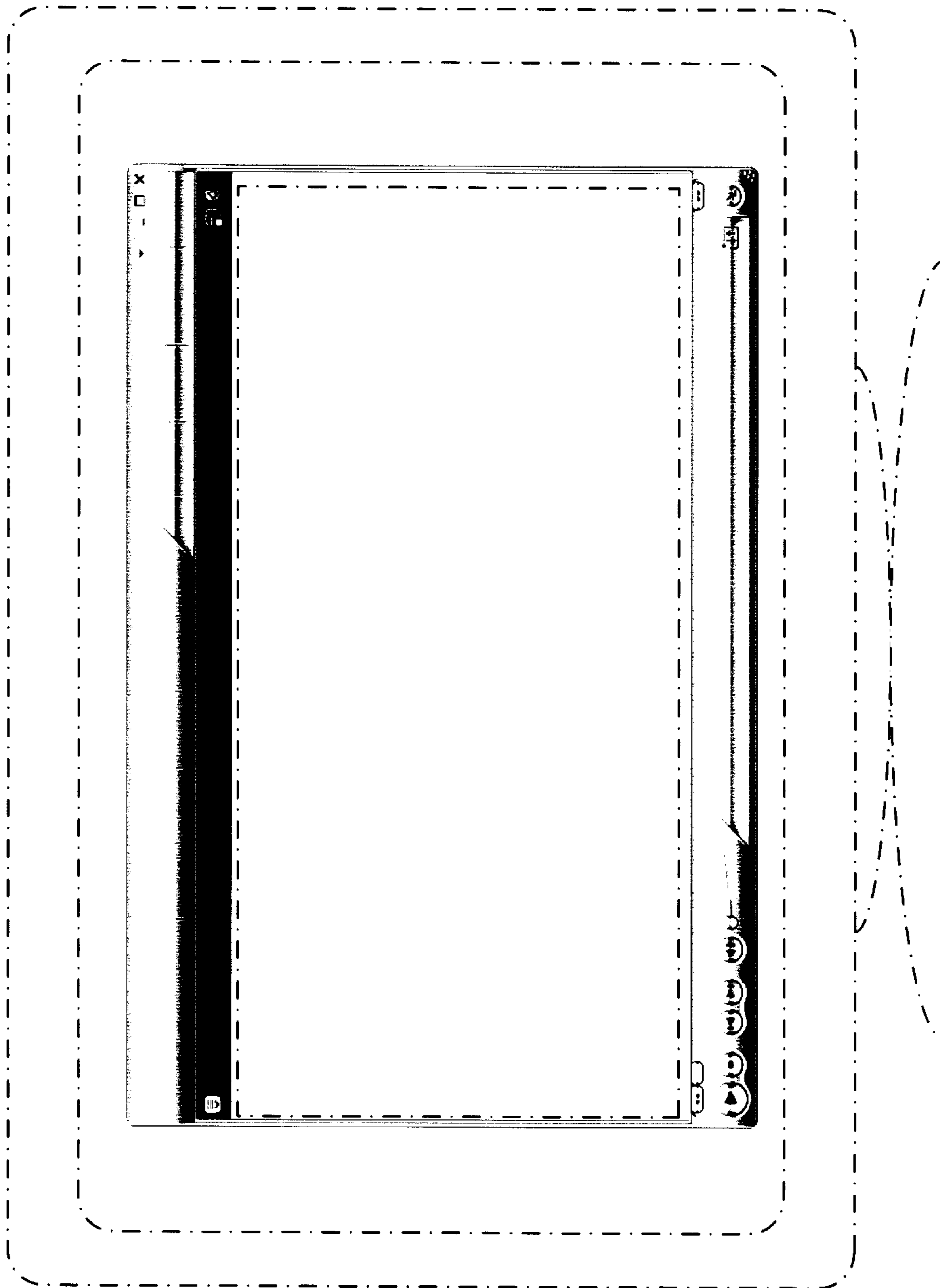
The ornamental design for a portion of an image for a display screen, as shown and described.
