FIG. 2 is a bottom view of the garment hanger of the present invention;

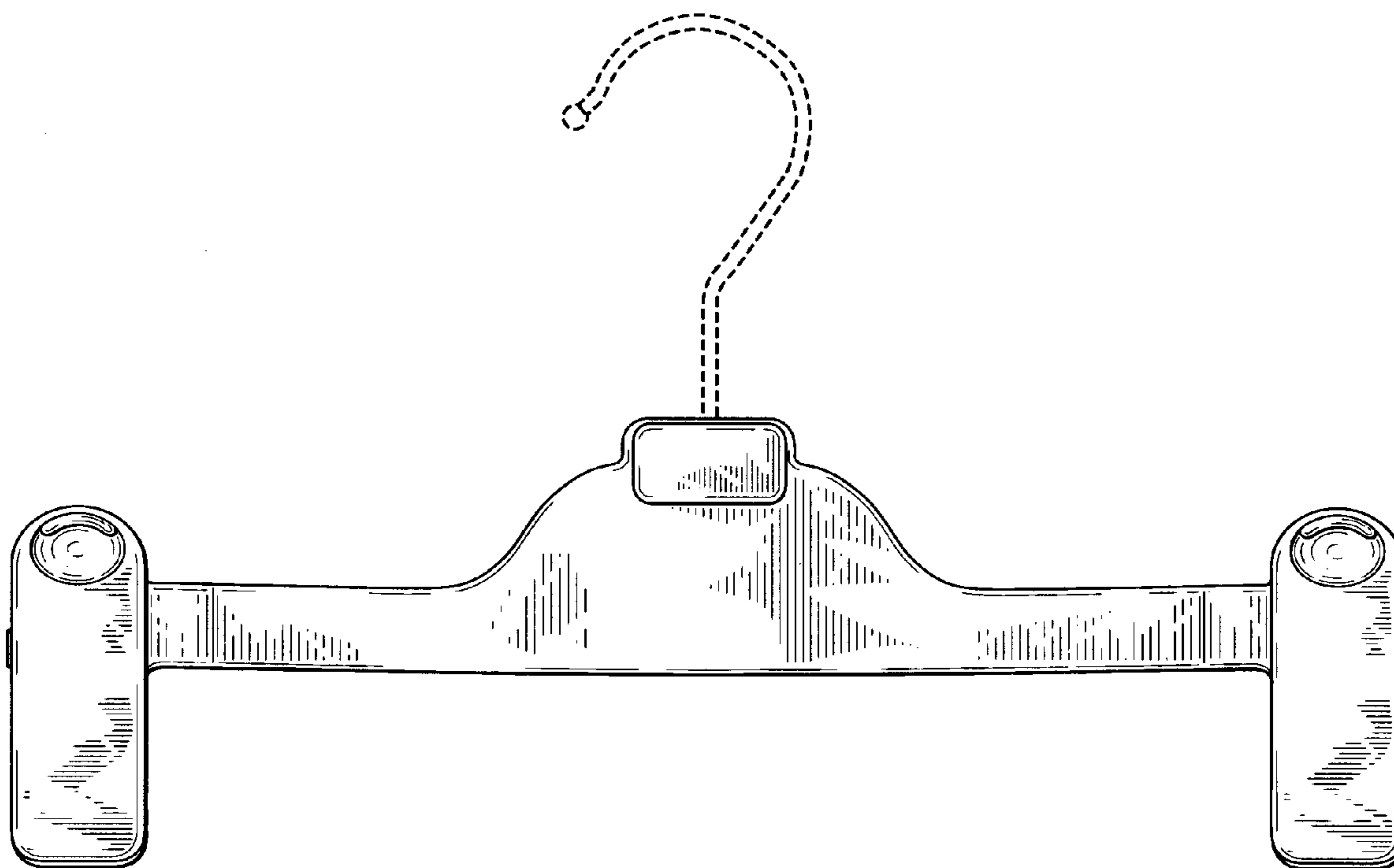
FIG. 3 is a left side view of the garment hanger of the present invention;

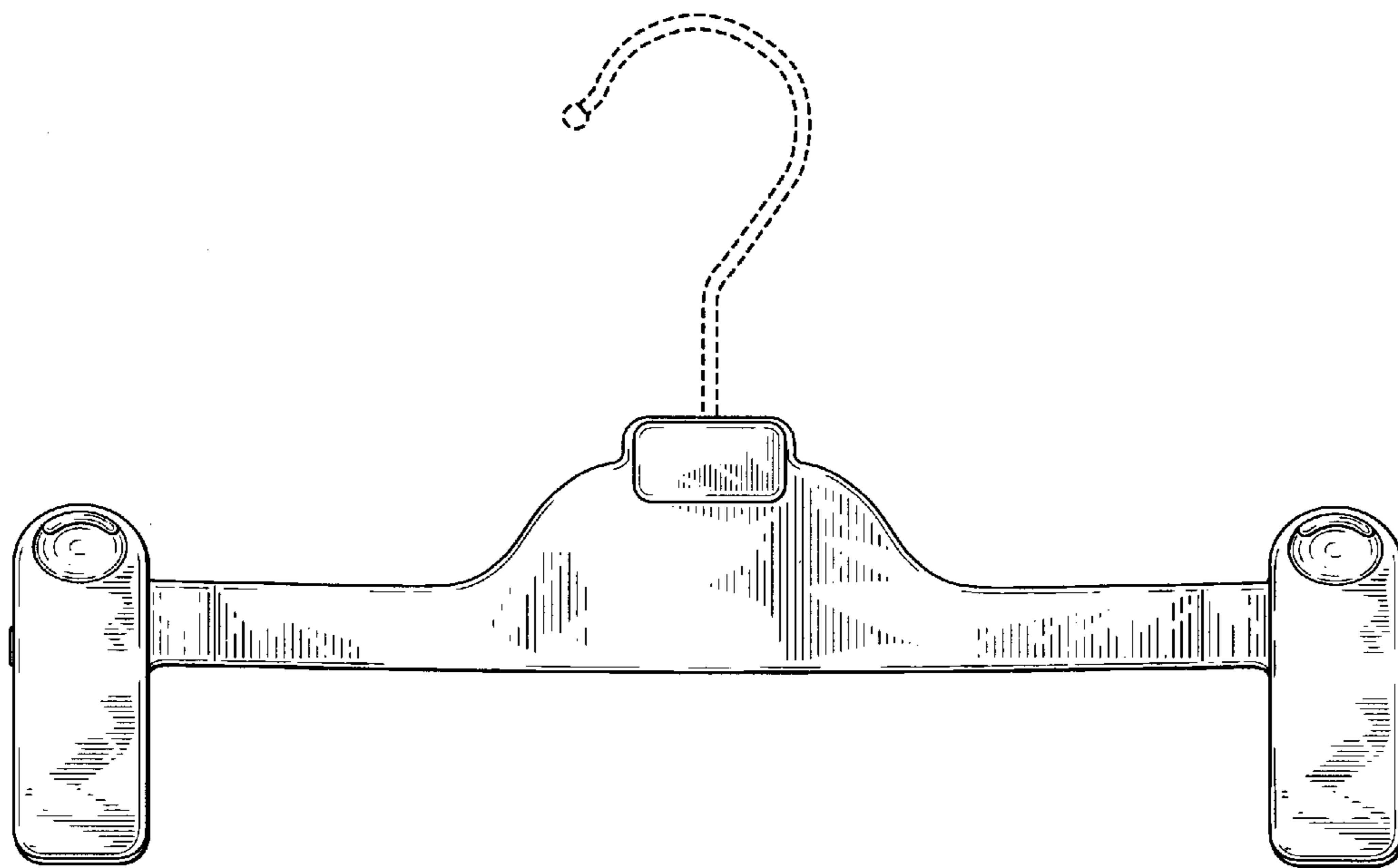

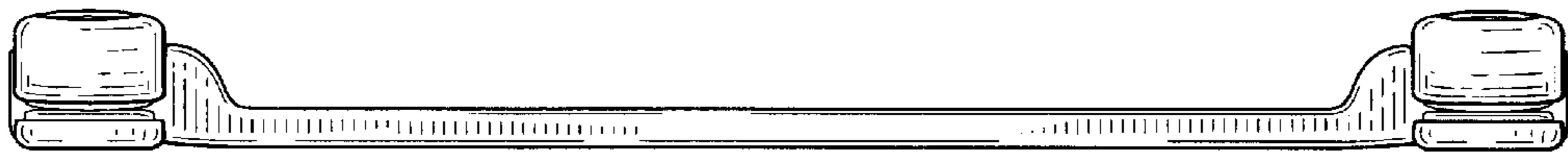

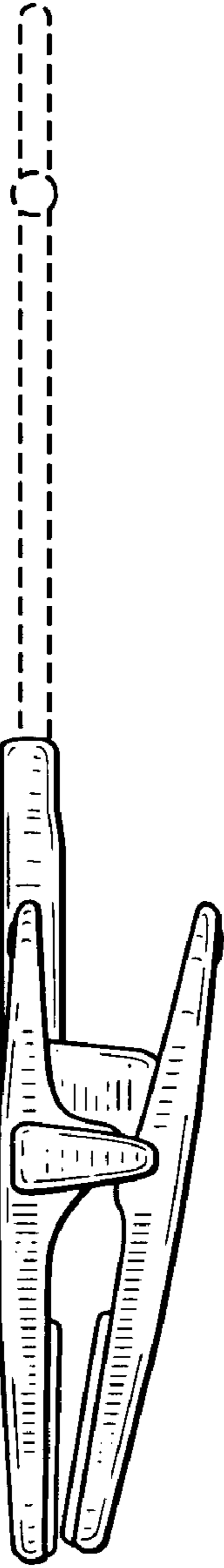

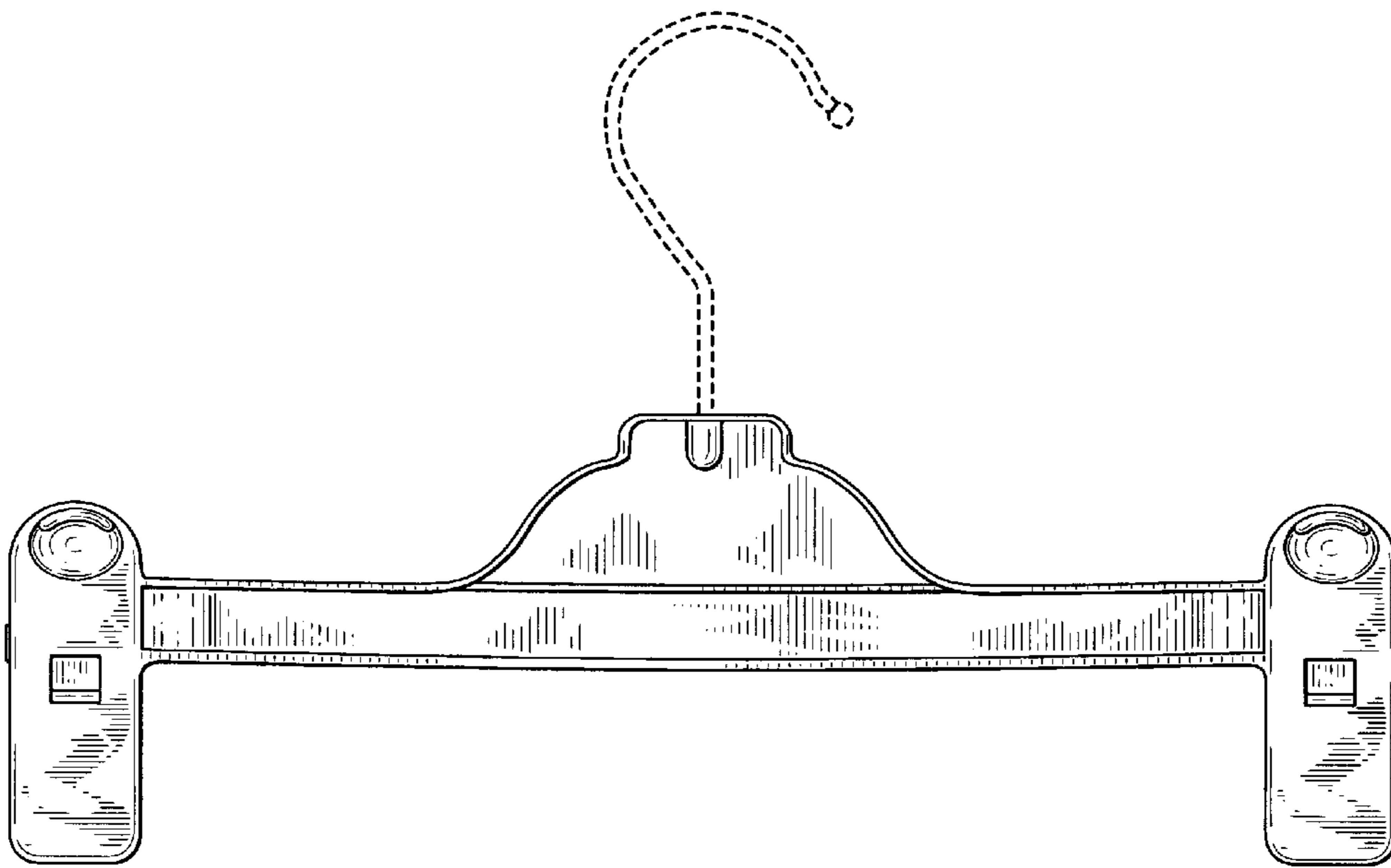

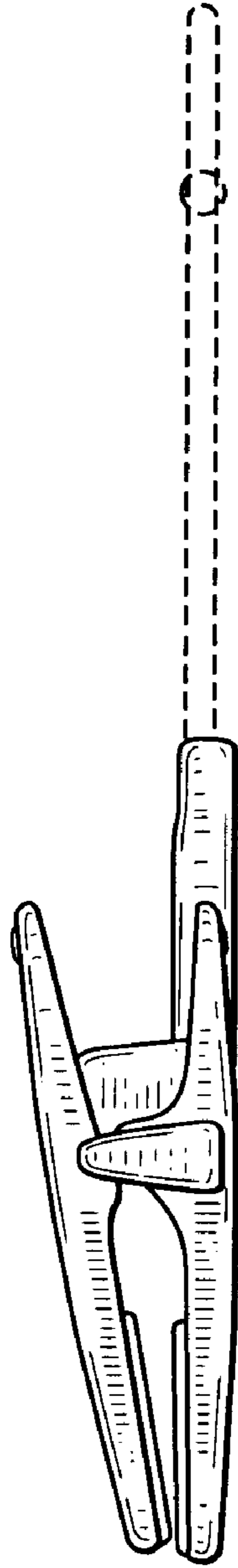
