(57) **CLAIM**

The ornamental design for an active material cartridge, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the active material cartridge; FIG. 2 is a front elevational view of the active material cartridge as depicted in FIG. 1, the back view being a mirror image thereof;

FIG. 3 is a side elevational view of the material cartridge as depicted in FIG. 1, the opposite side being a mirror image thereof;

FIG. 4 is a top plan view of the active material cartridge as depicted in FIG. 1;

FIG. 5 is an isometric view of the active material cartridge of FIG. 1 with a cover removed for ease of illustration;

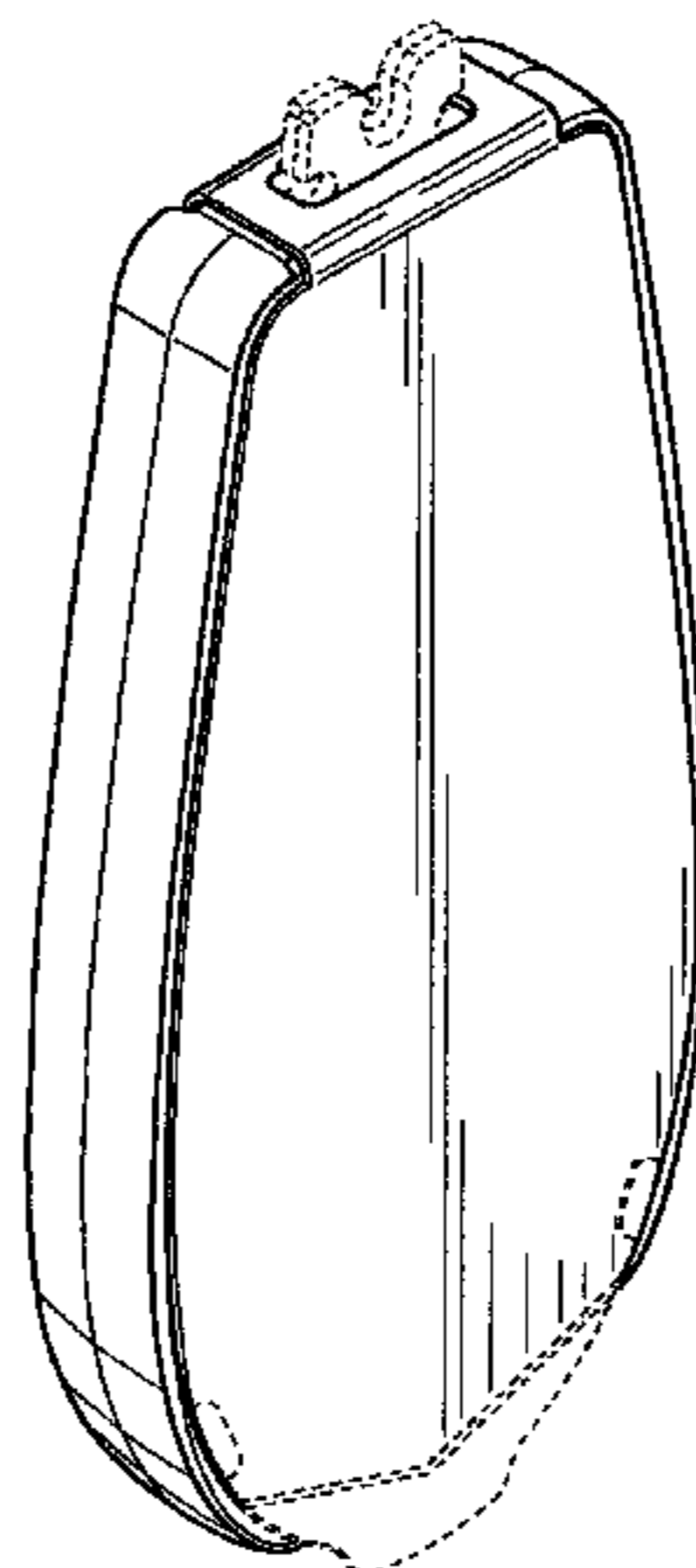
FIG. 6 is a front elevational view of the active material cartridge as depicted in FIG. 5, the back view being a mirror image thereof;

FIG. 7 is a side elevational view of the active material cartridge as depicted in FIG. 5, the opposite side view being a mirror image thereof; and,

FIG. 8 is a top plan view of the active material cartridge as depicted in FIG. 5.

The structure shown in broken lines in the drawings is for illustrative purposes only and forms no part of the claimed design.

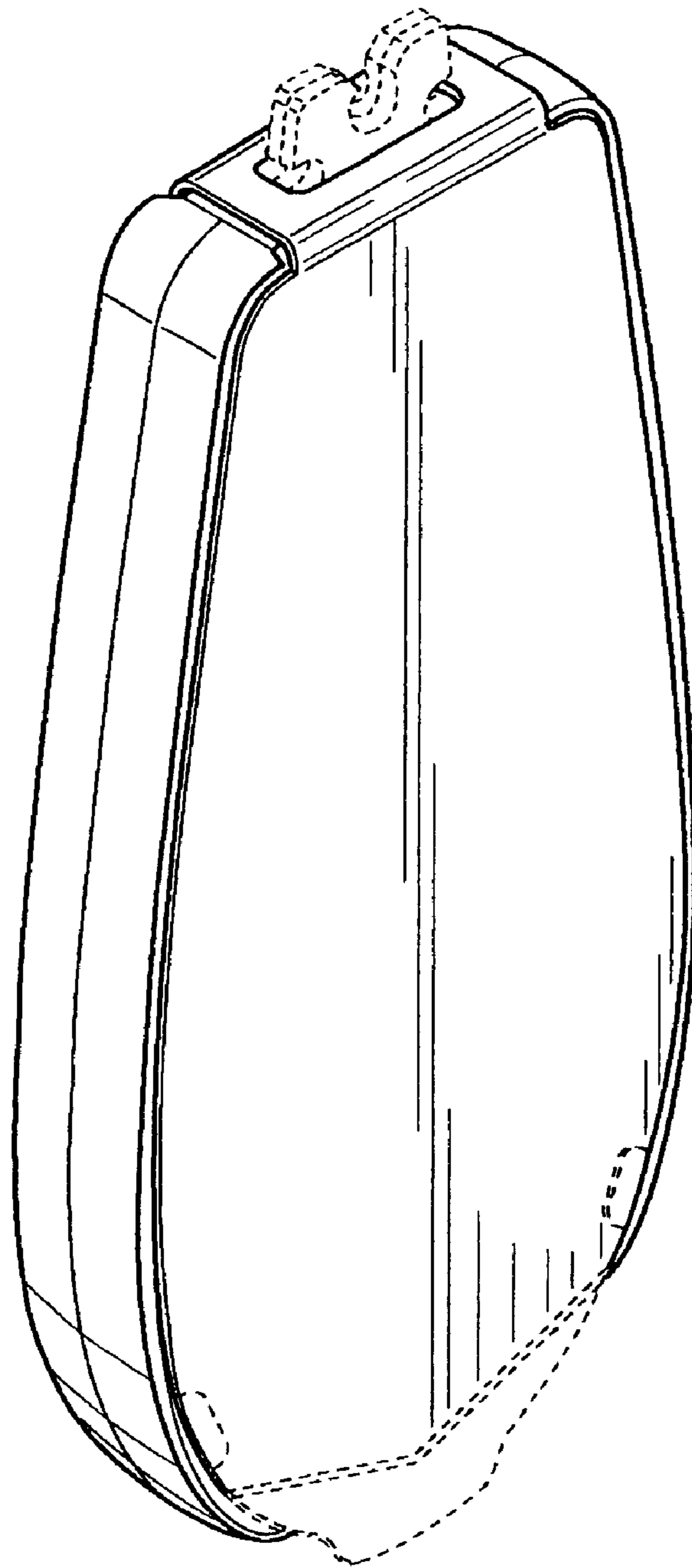

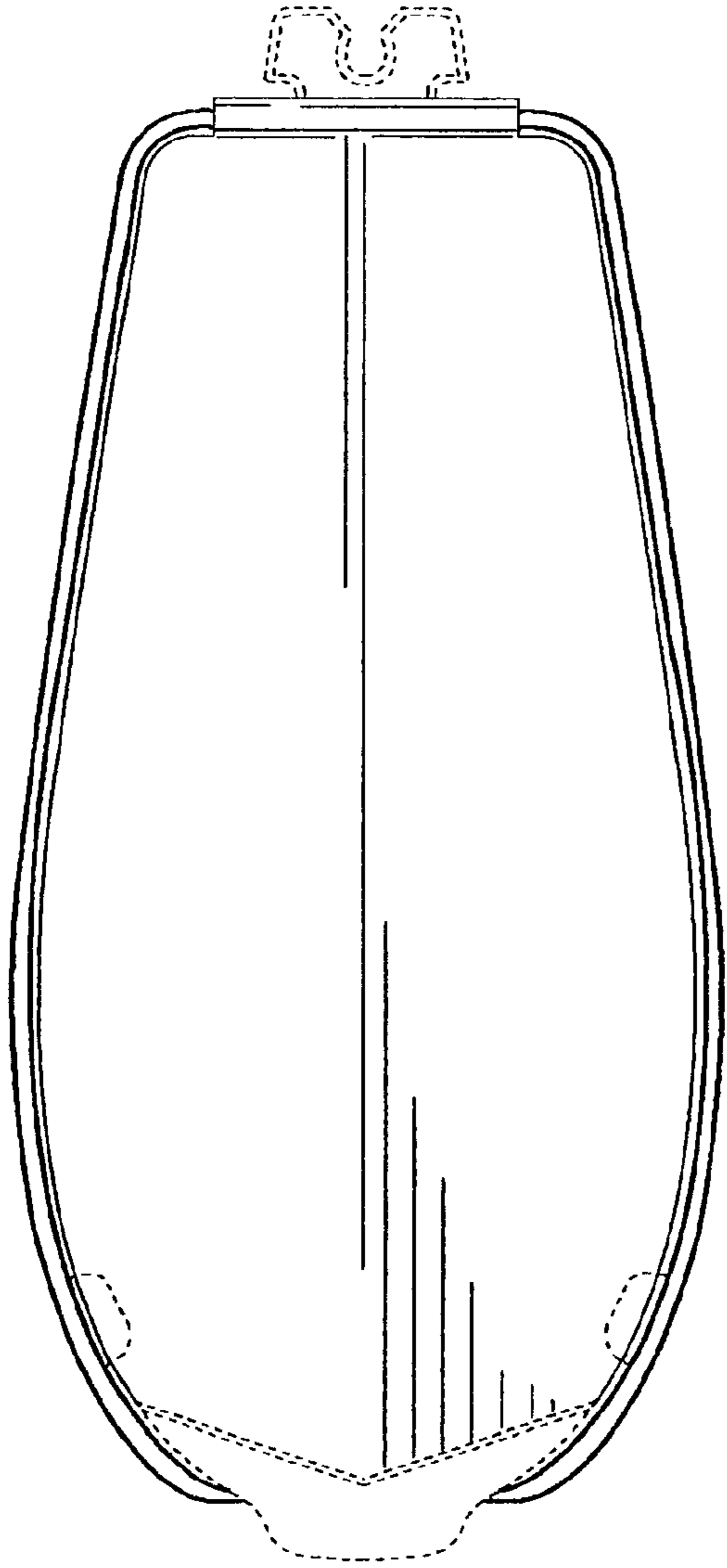

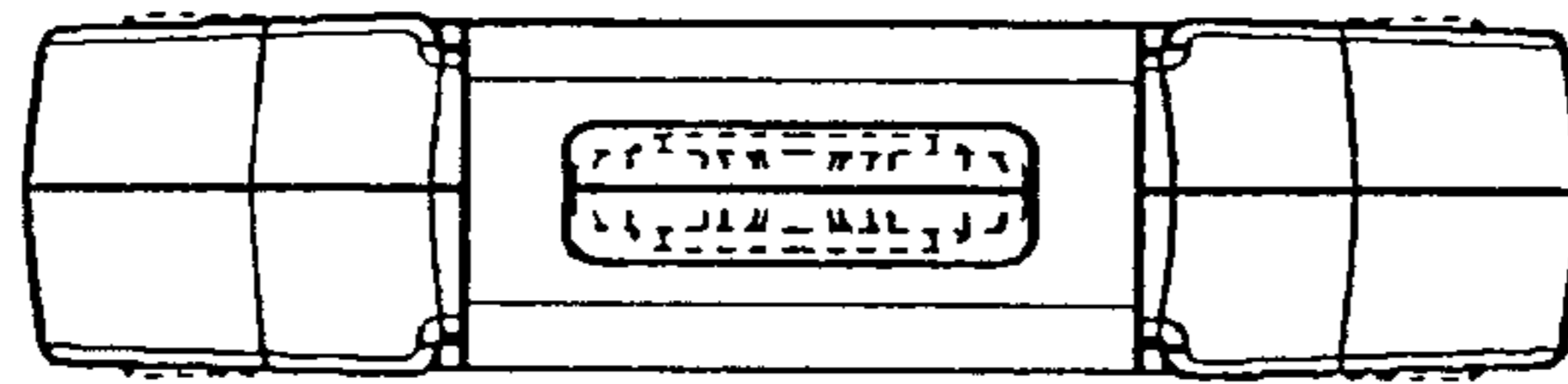

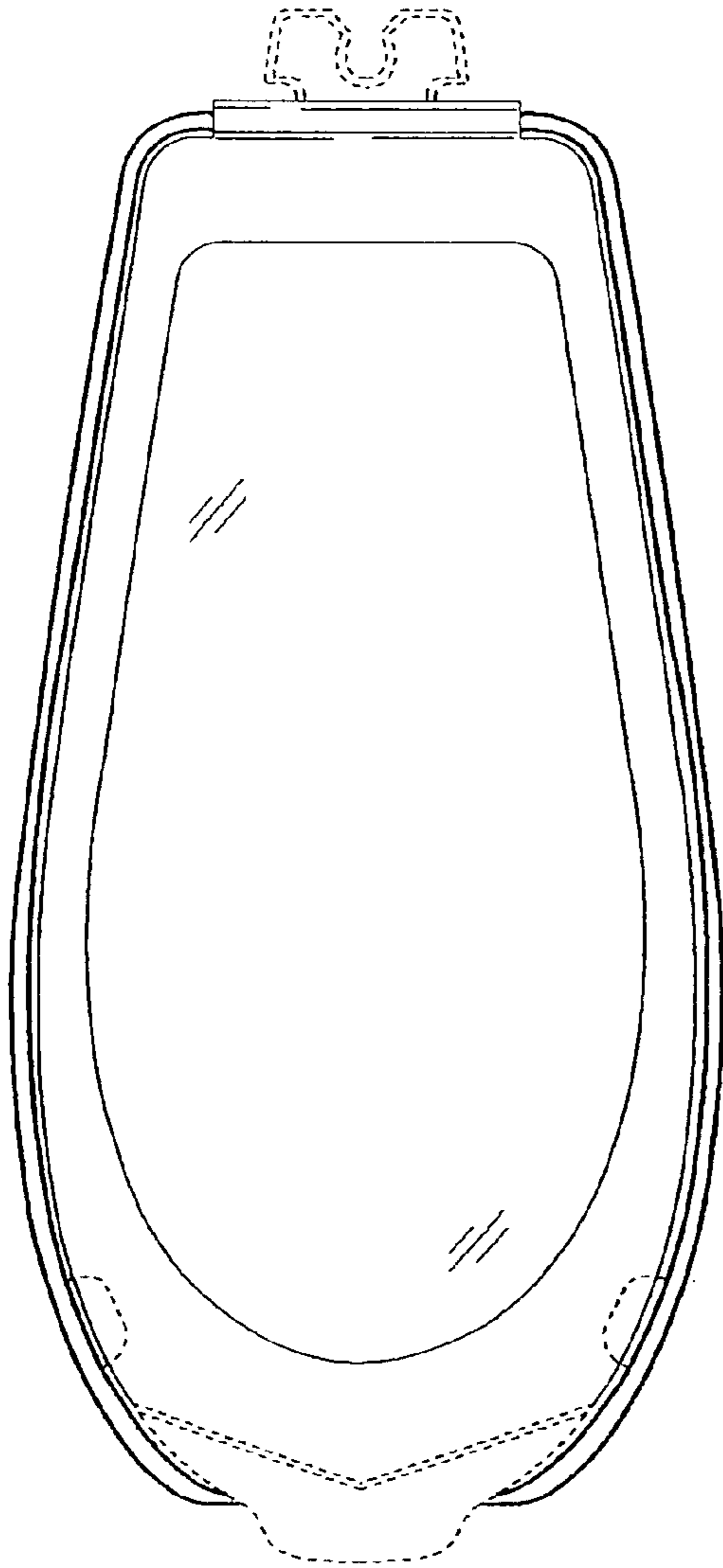
