FIG. 8 is a top view of the second embodiment of the electric iron of the present invention;

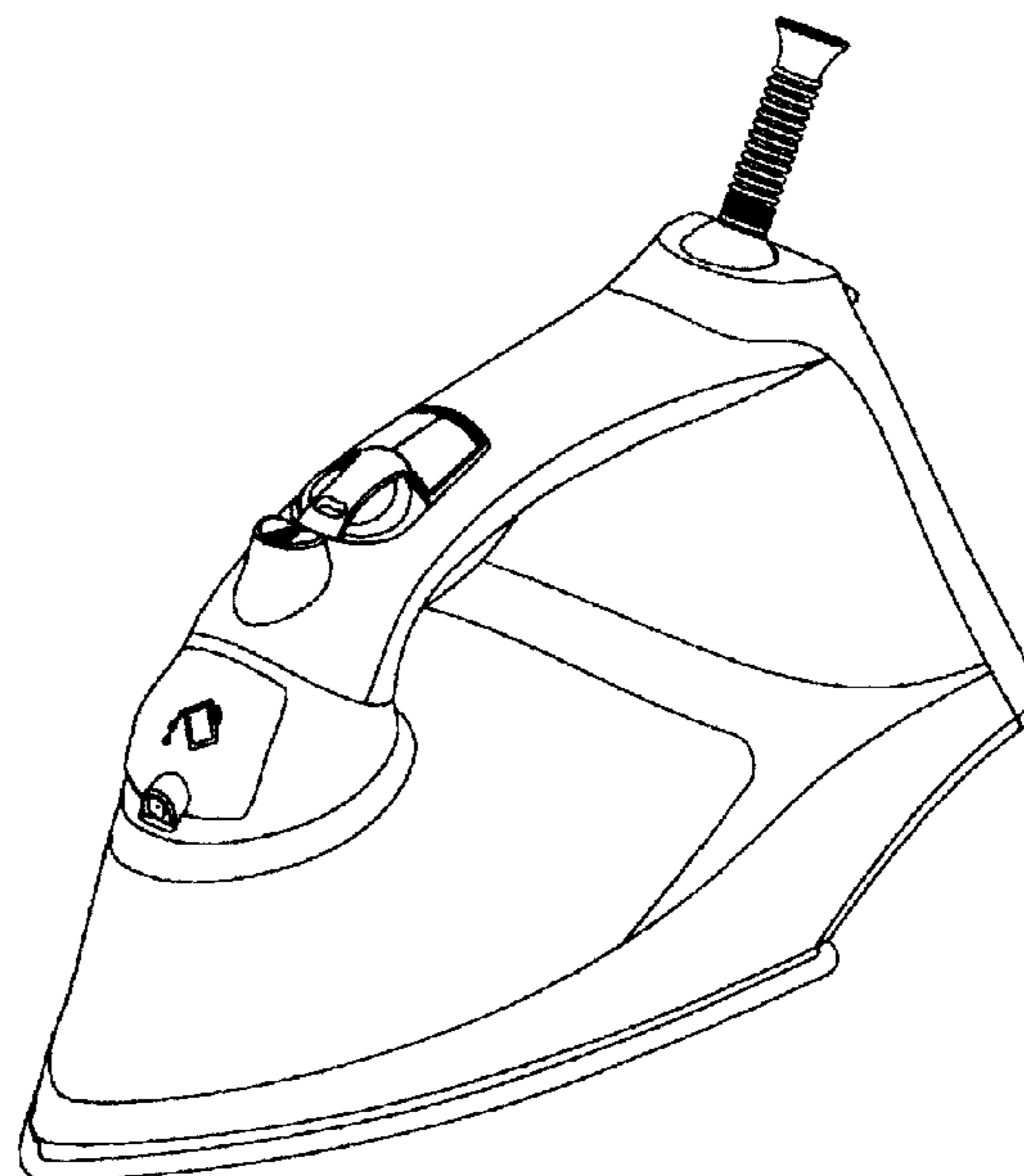
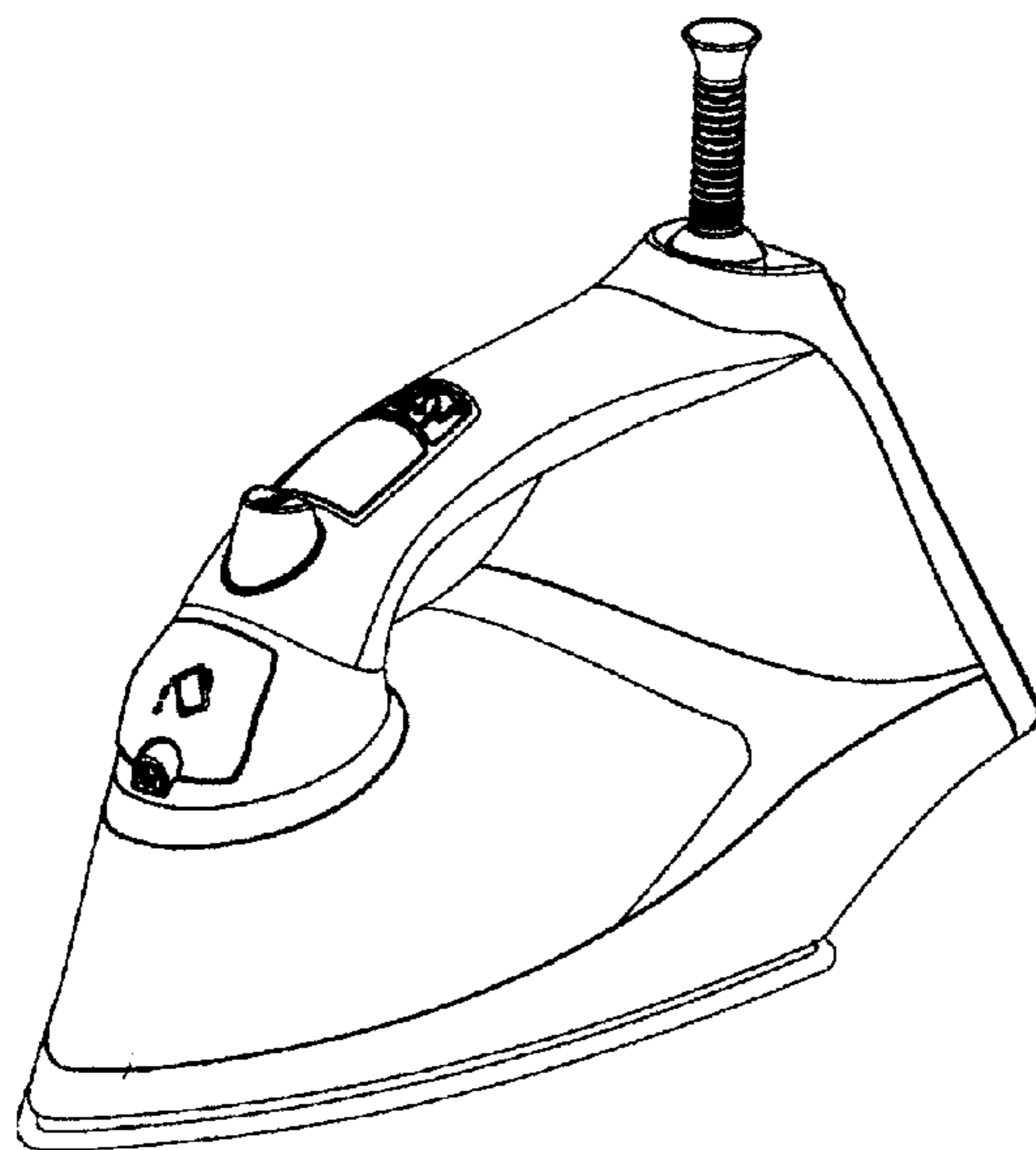
FIG. 9 is a side view of the second embodiment of the electric iron of the present invention;

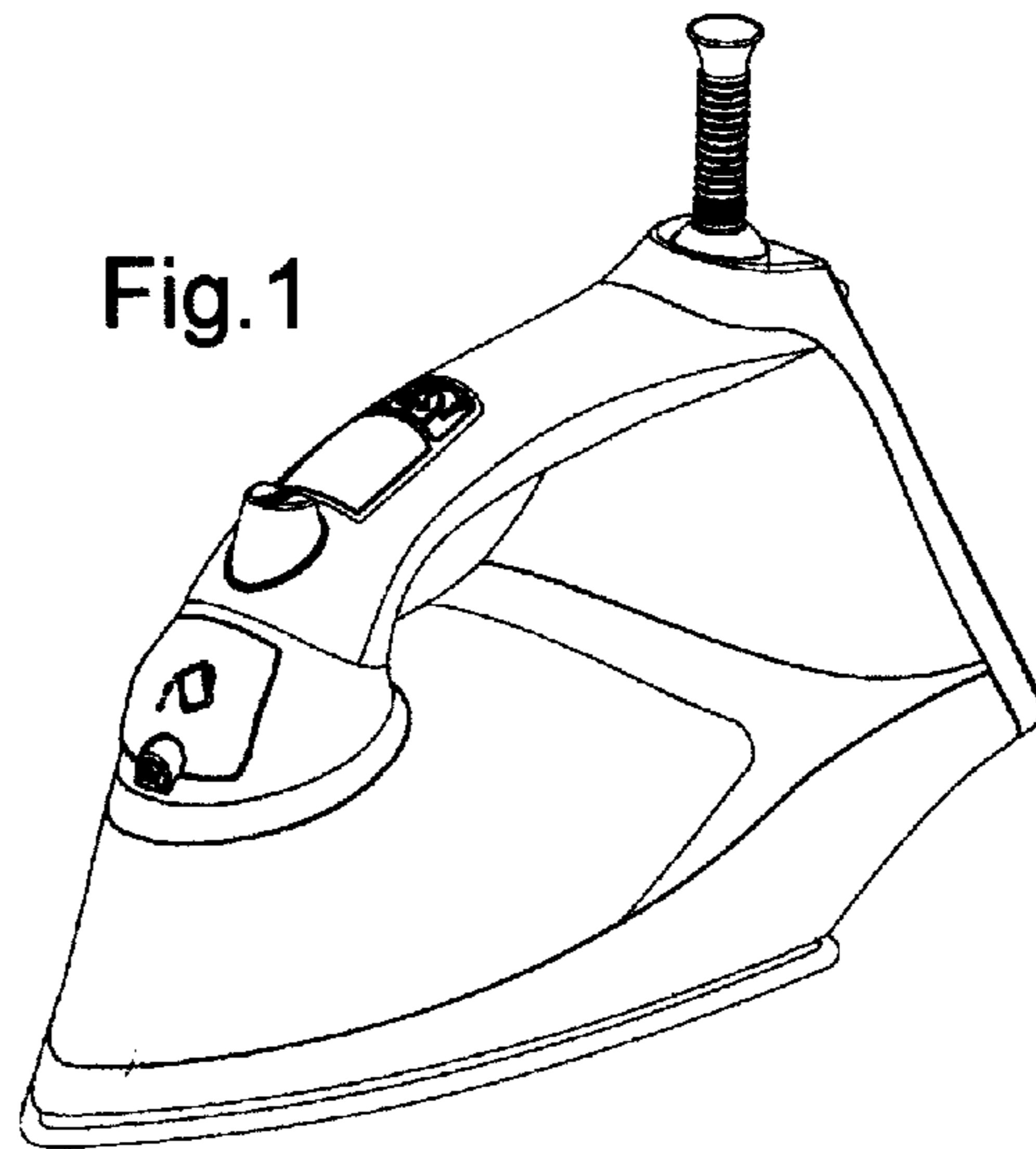
FIG. 10 is a bottom view of a second embodiment of the electric iron of the present invention;

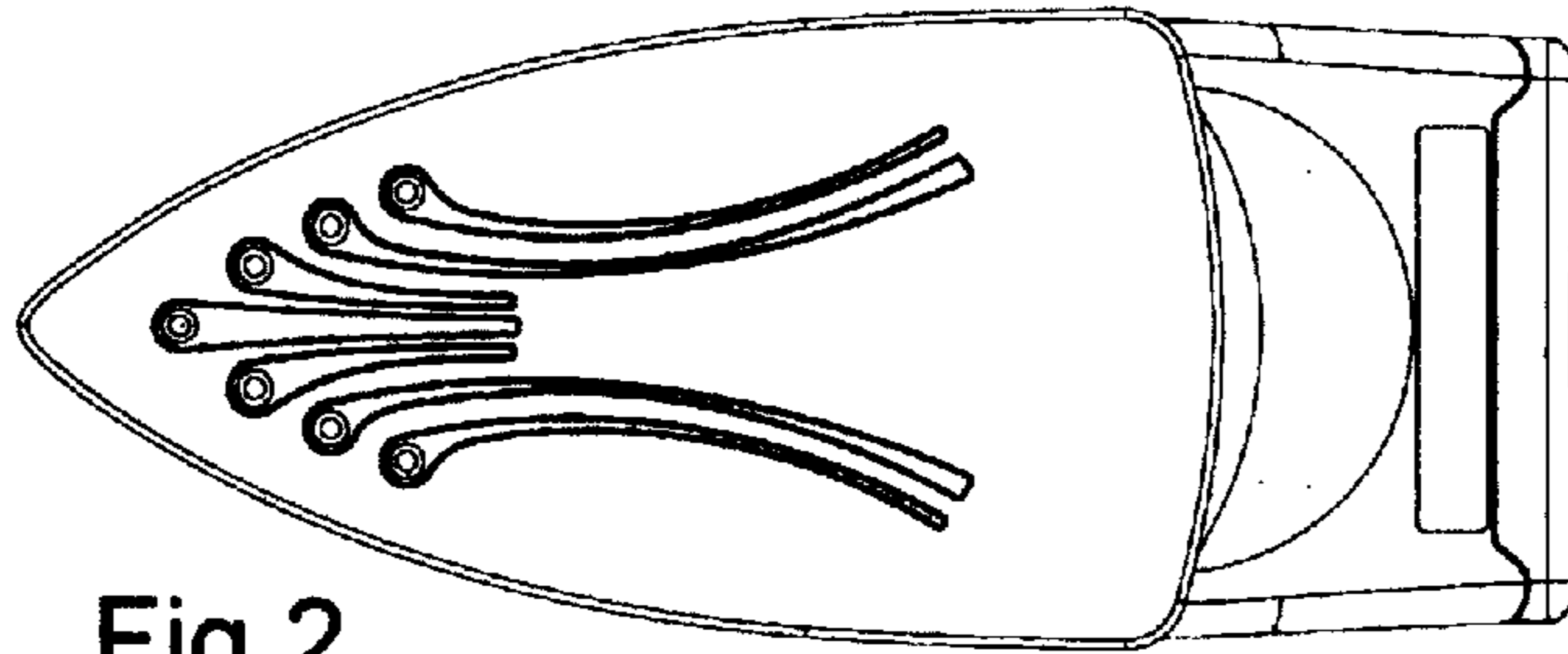

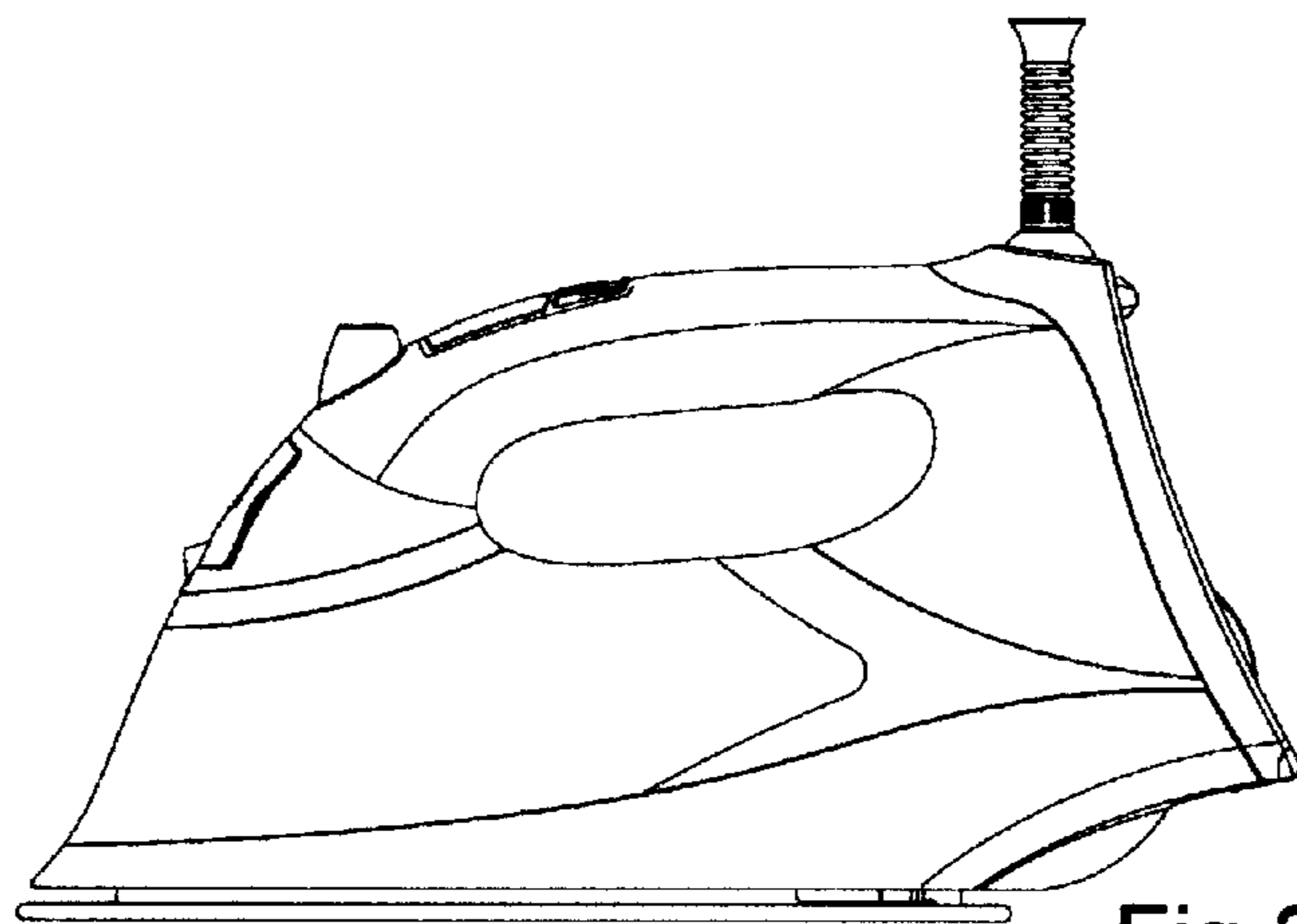

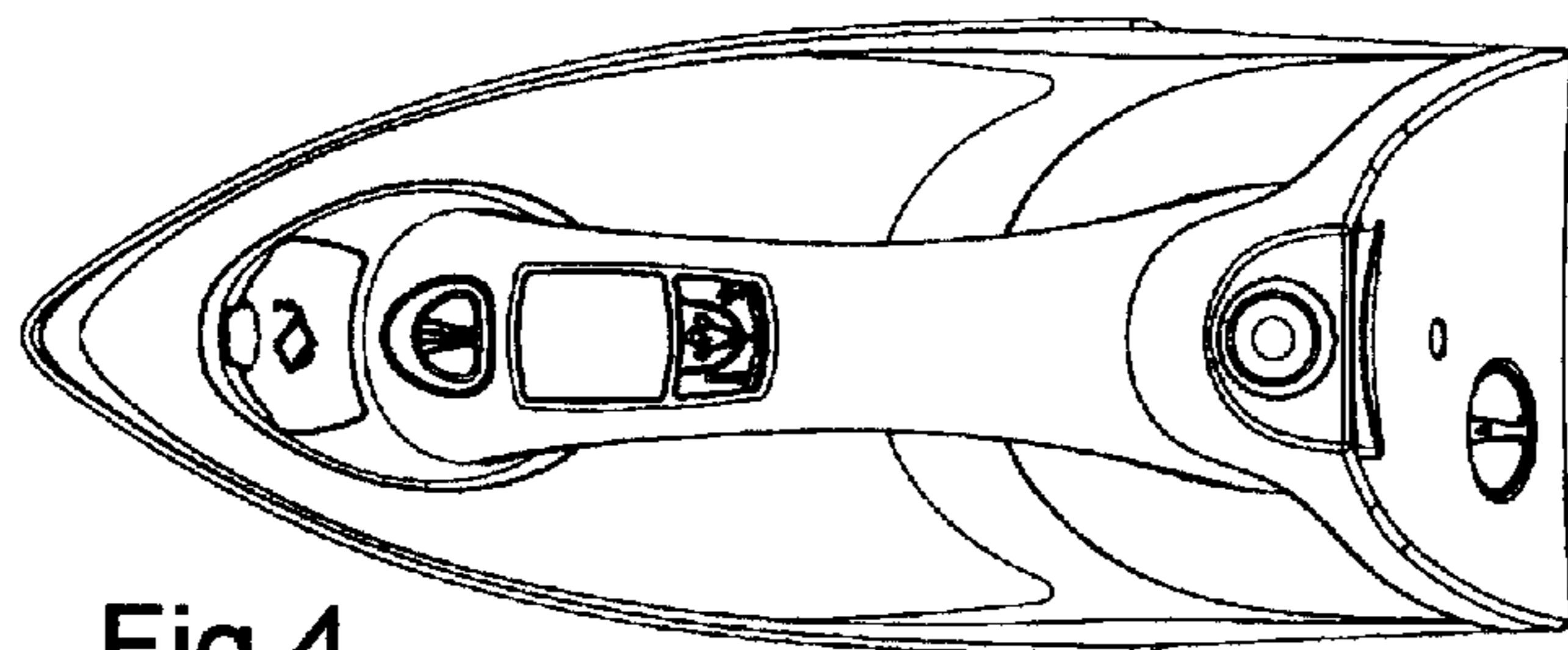

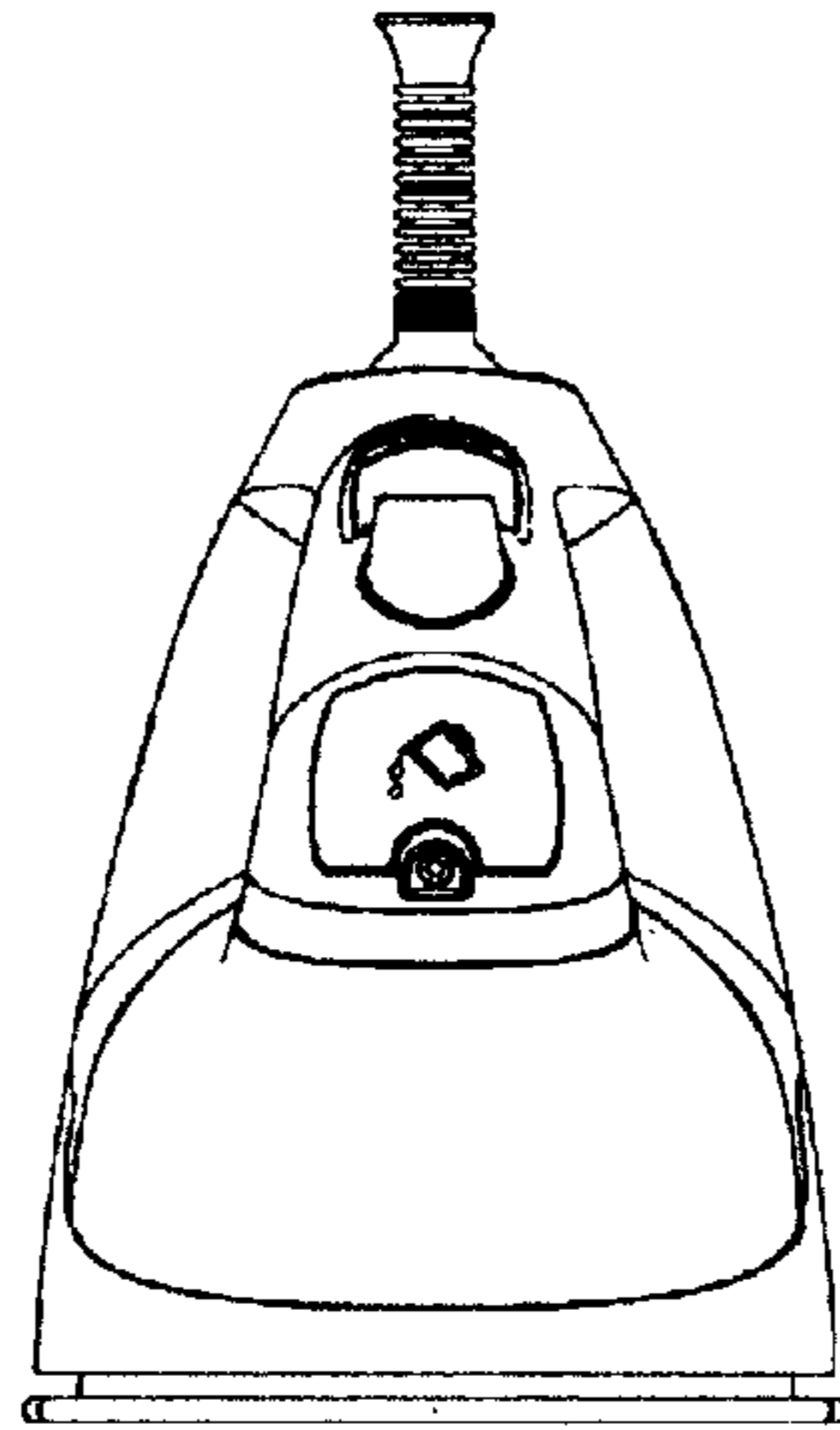

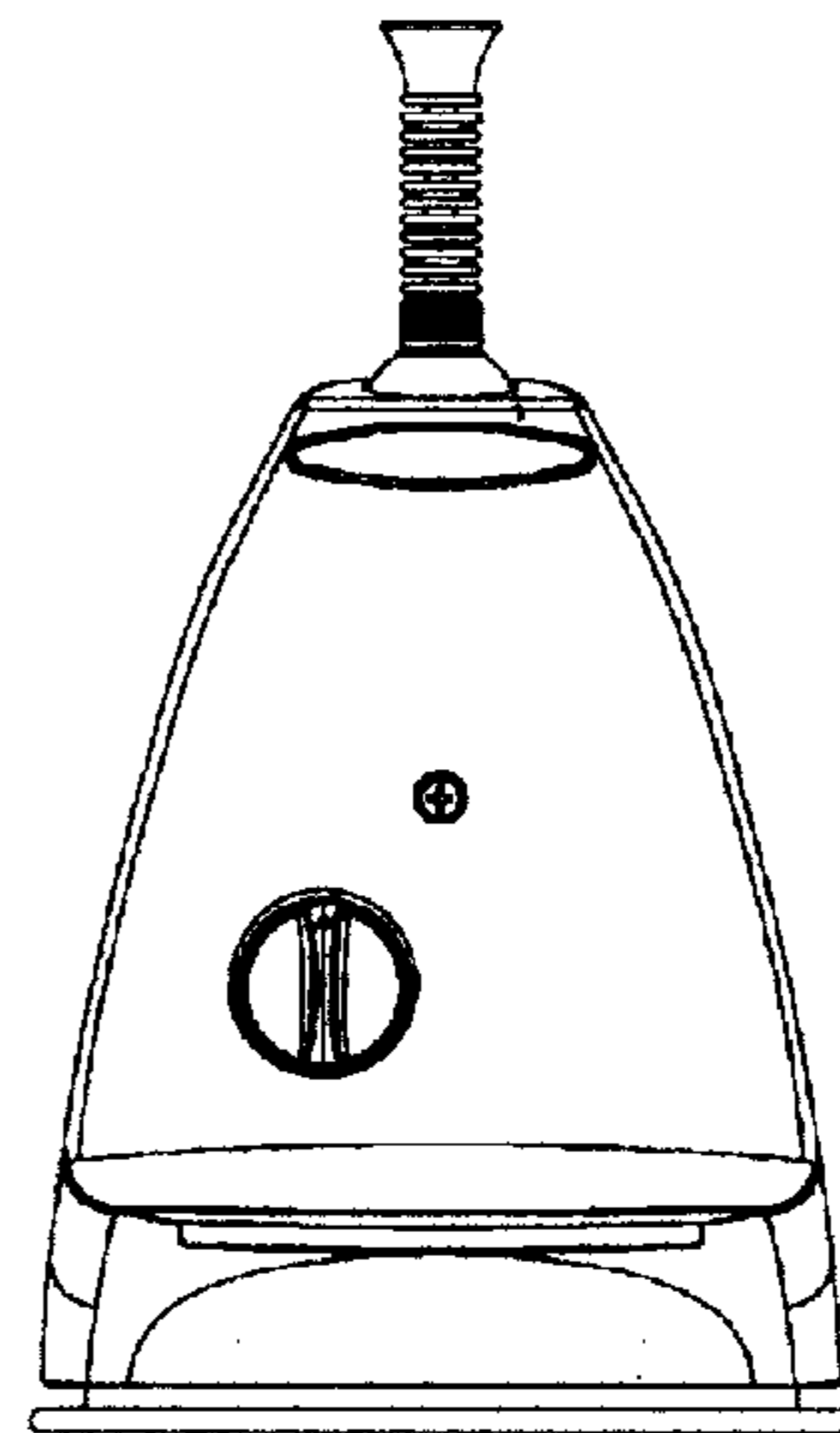
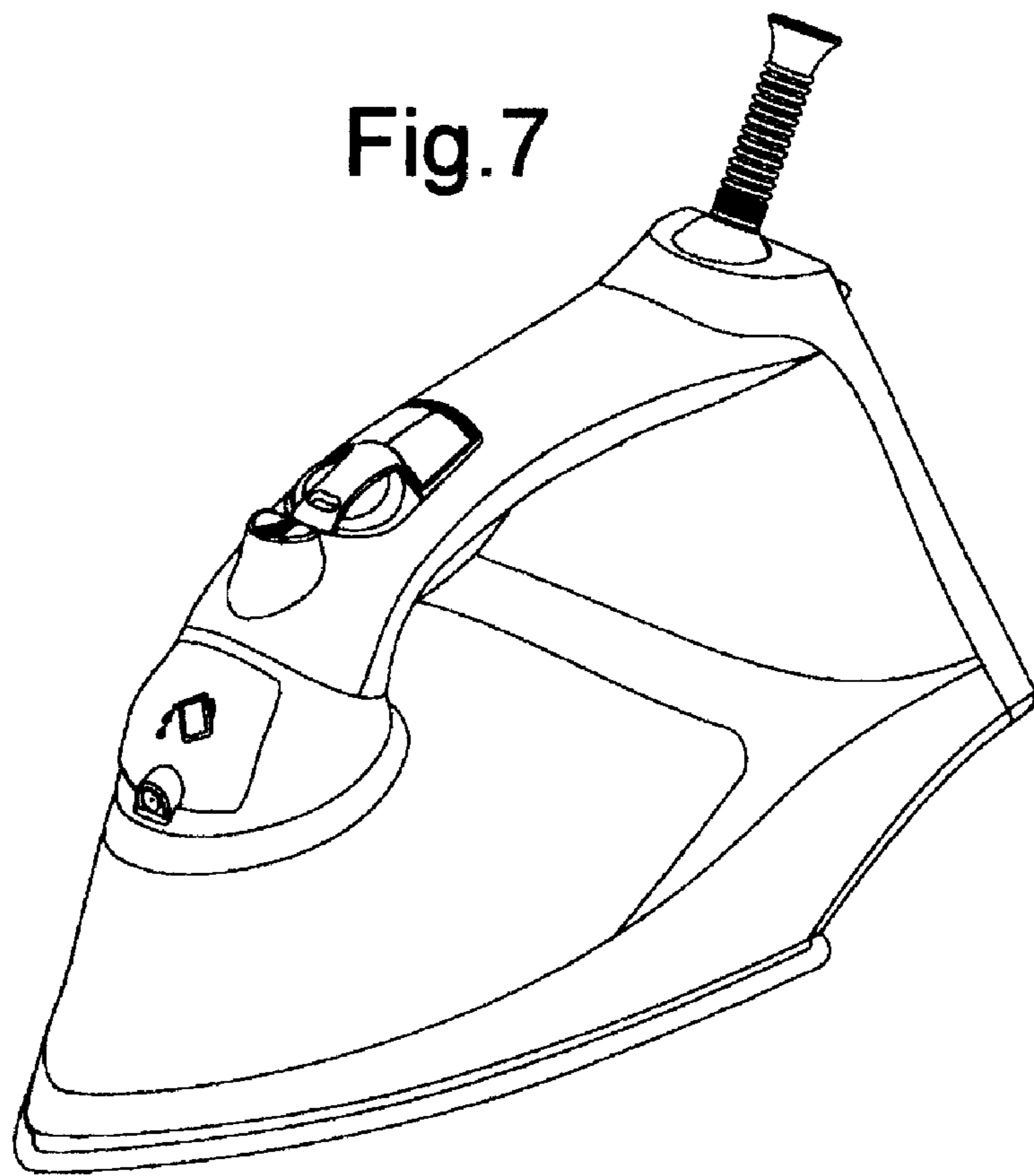

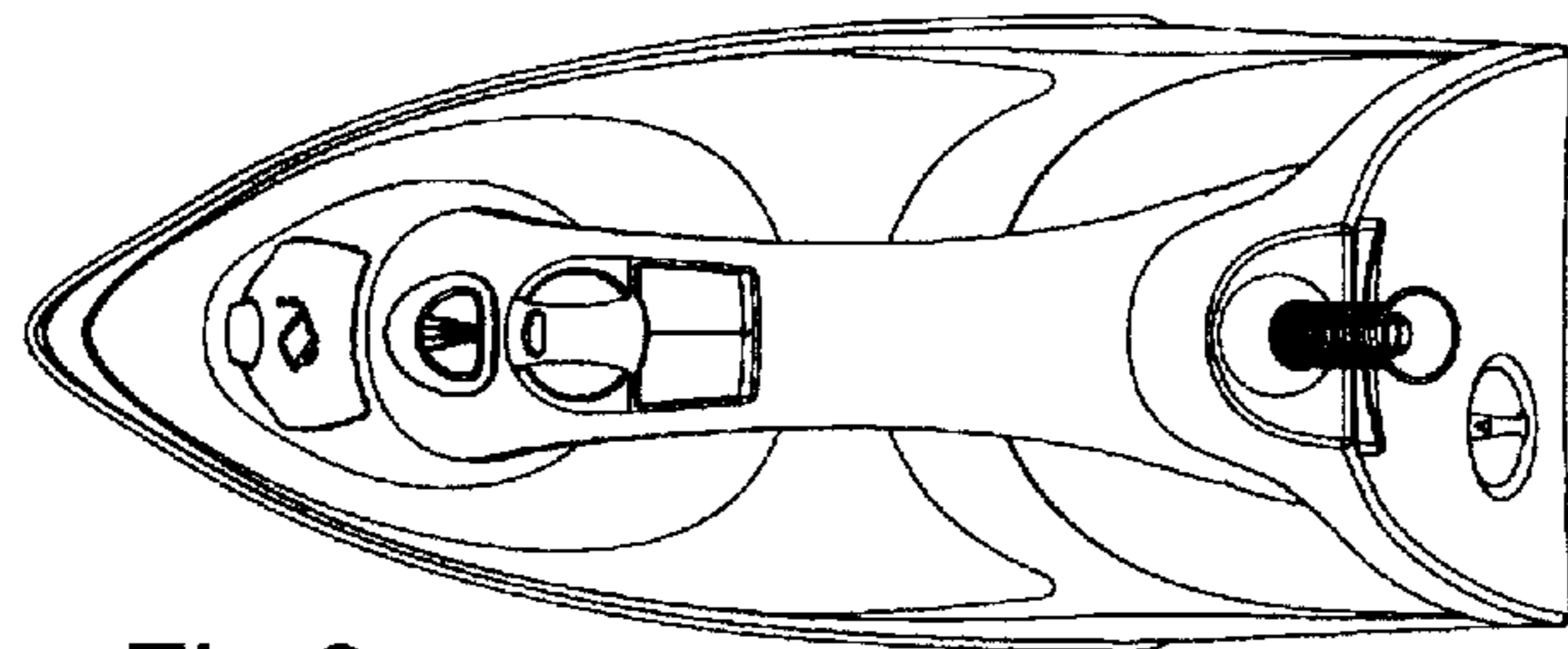

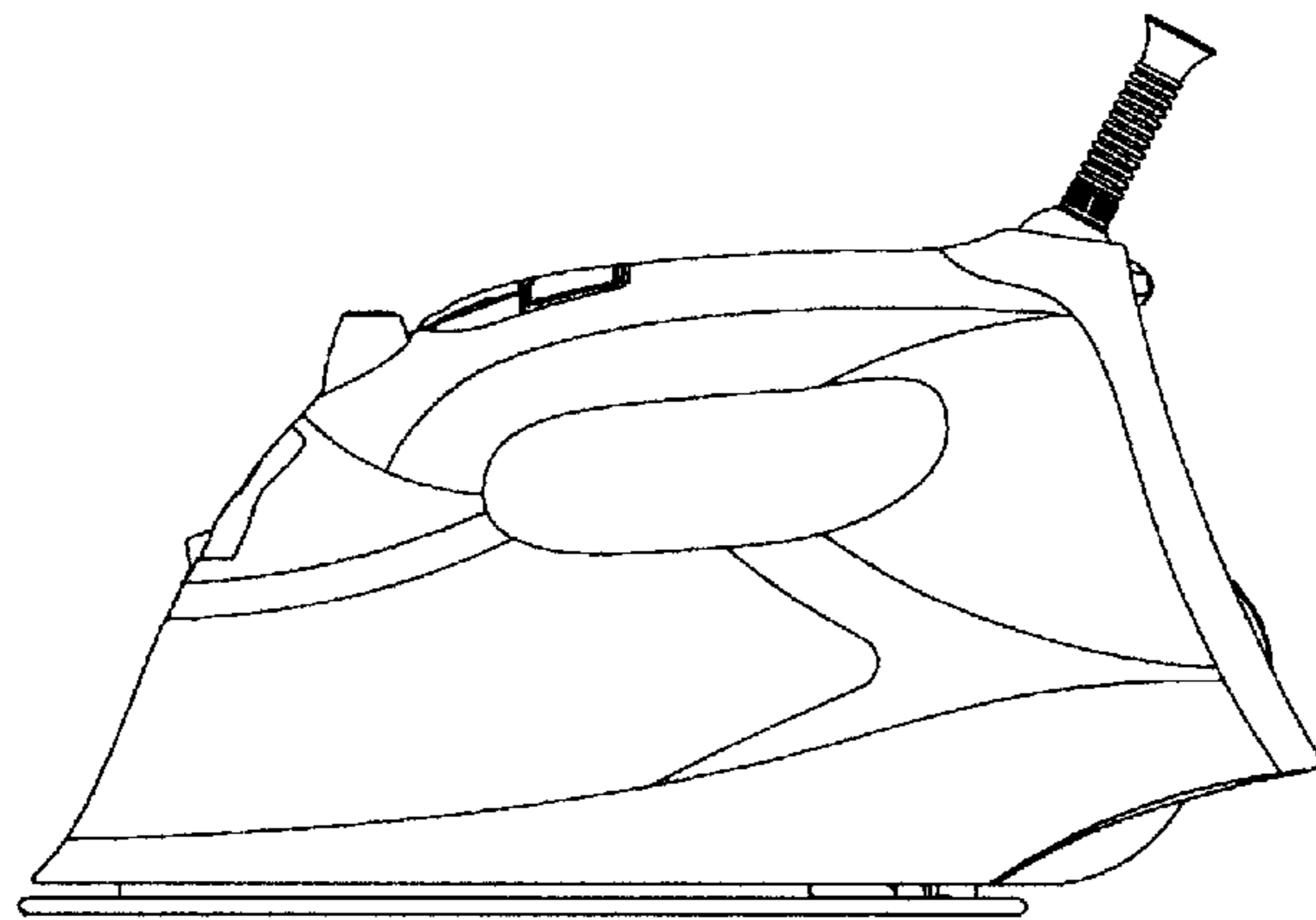

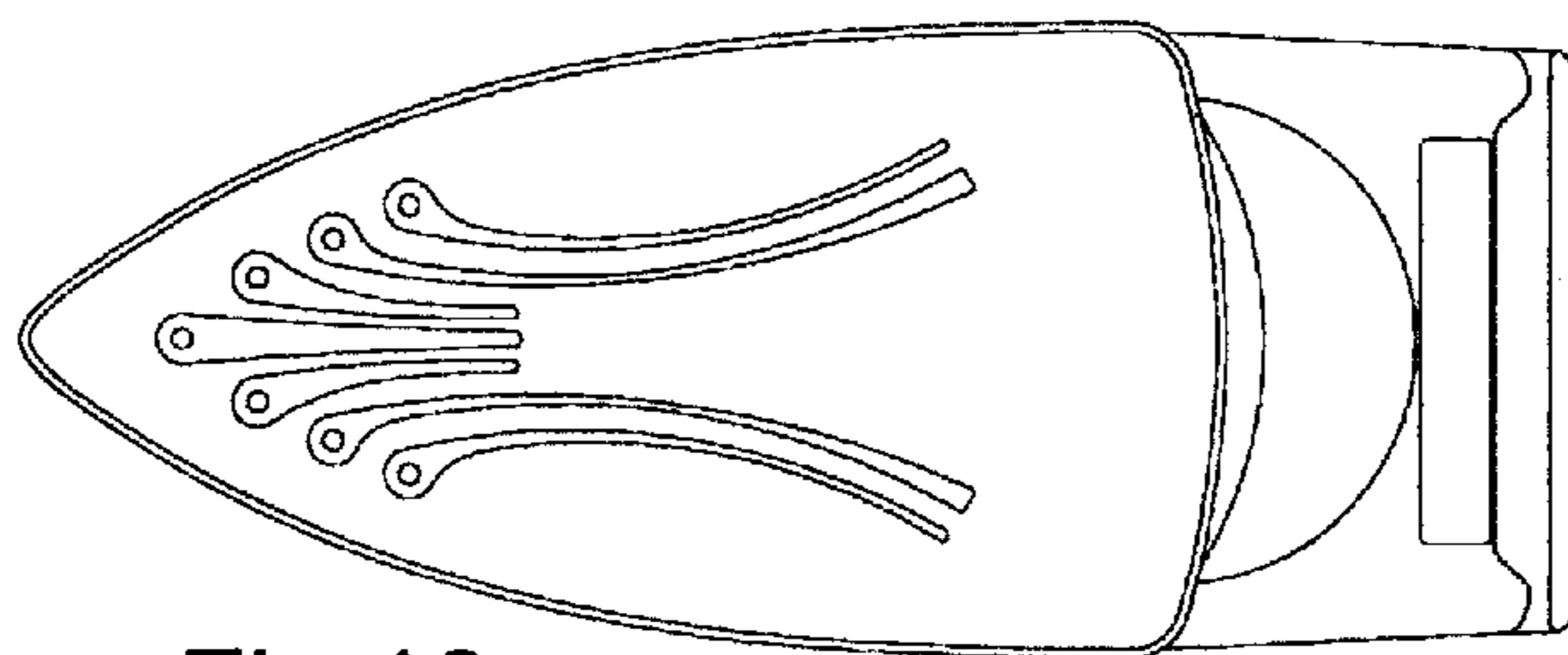

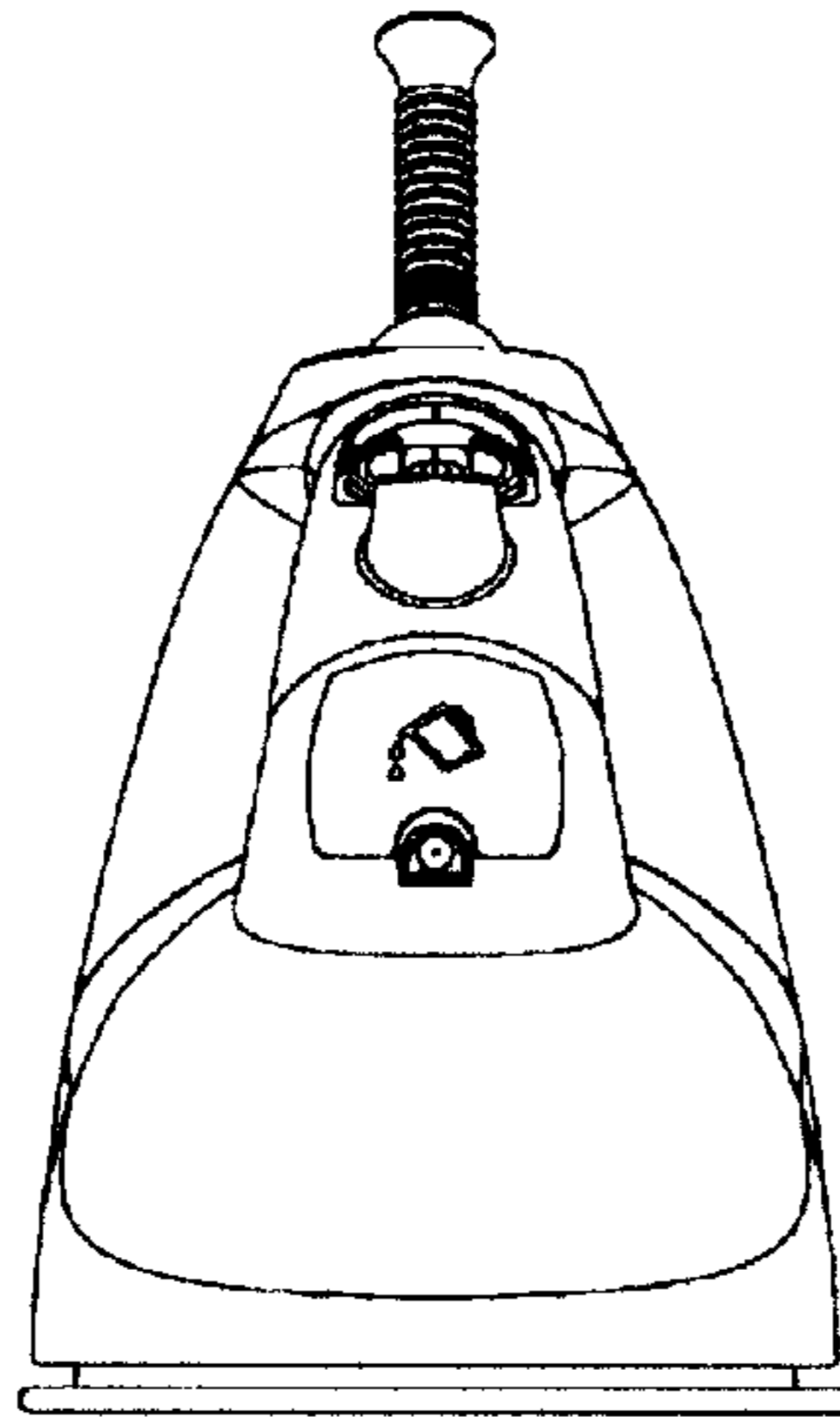

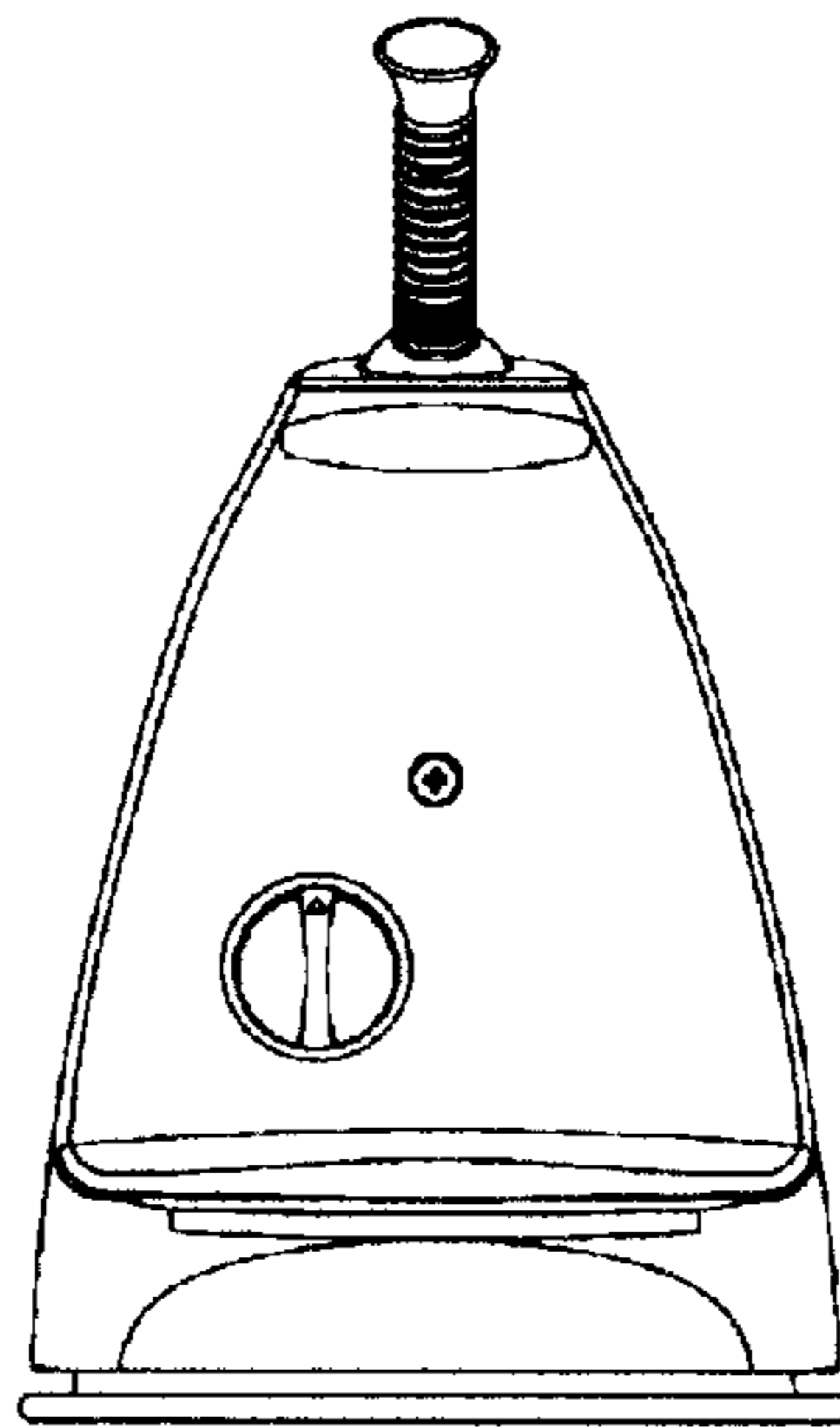
