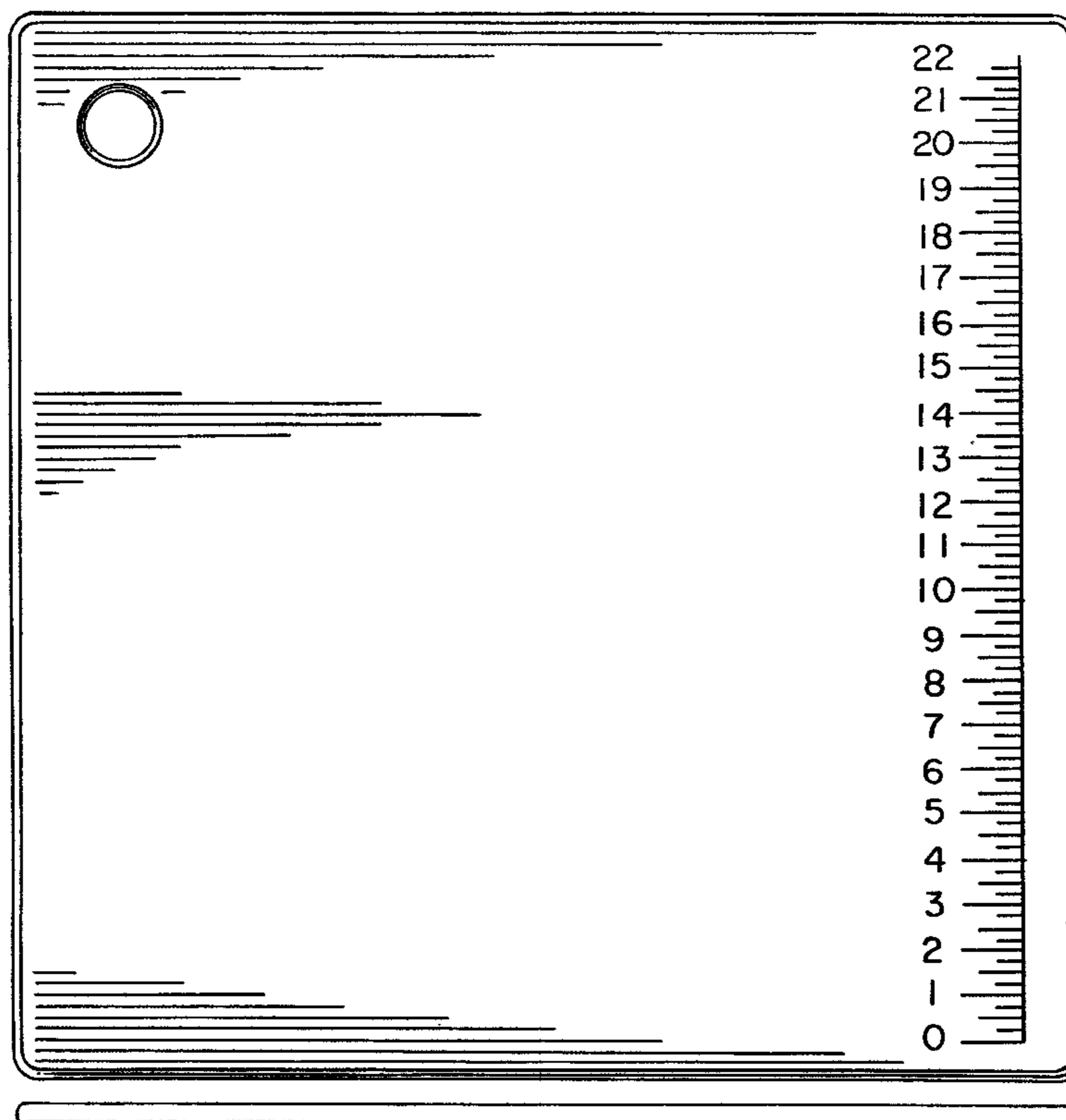
(57) **CLAIM**

The ornamental design for a construction board, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the construction board showing my new design;
FIG. 2 is front elevational view of FIG. 1, the rear, left side and right side elevational views being identical;
FIG. 3 is a bottom plan view of FIG. 1; and,
FIG. 4 is a sectional view taken along the line 4—4 in FIG. 3.

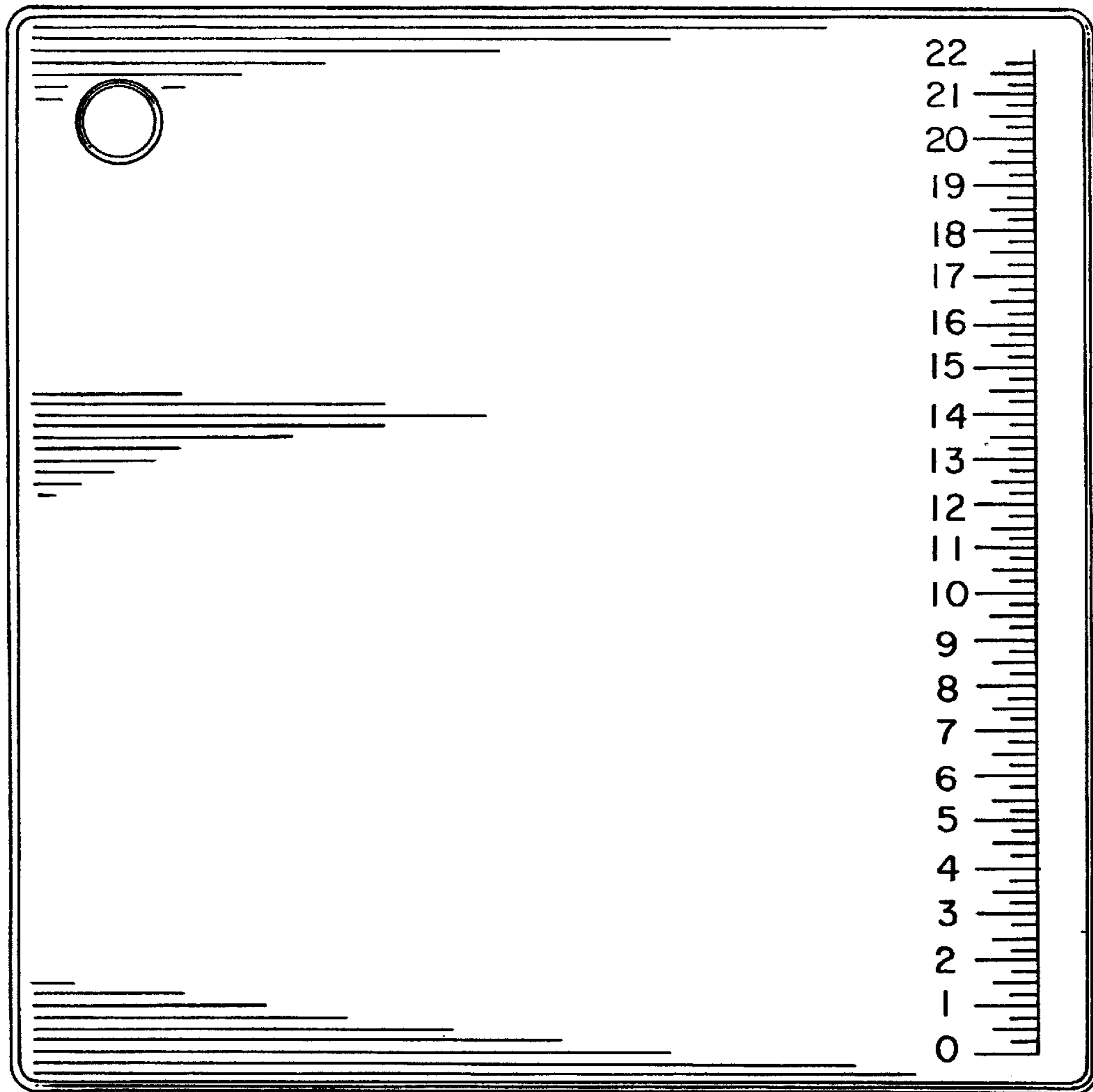

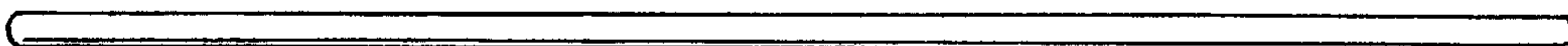

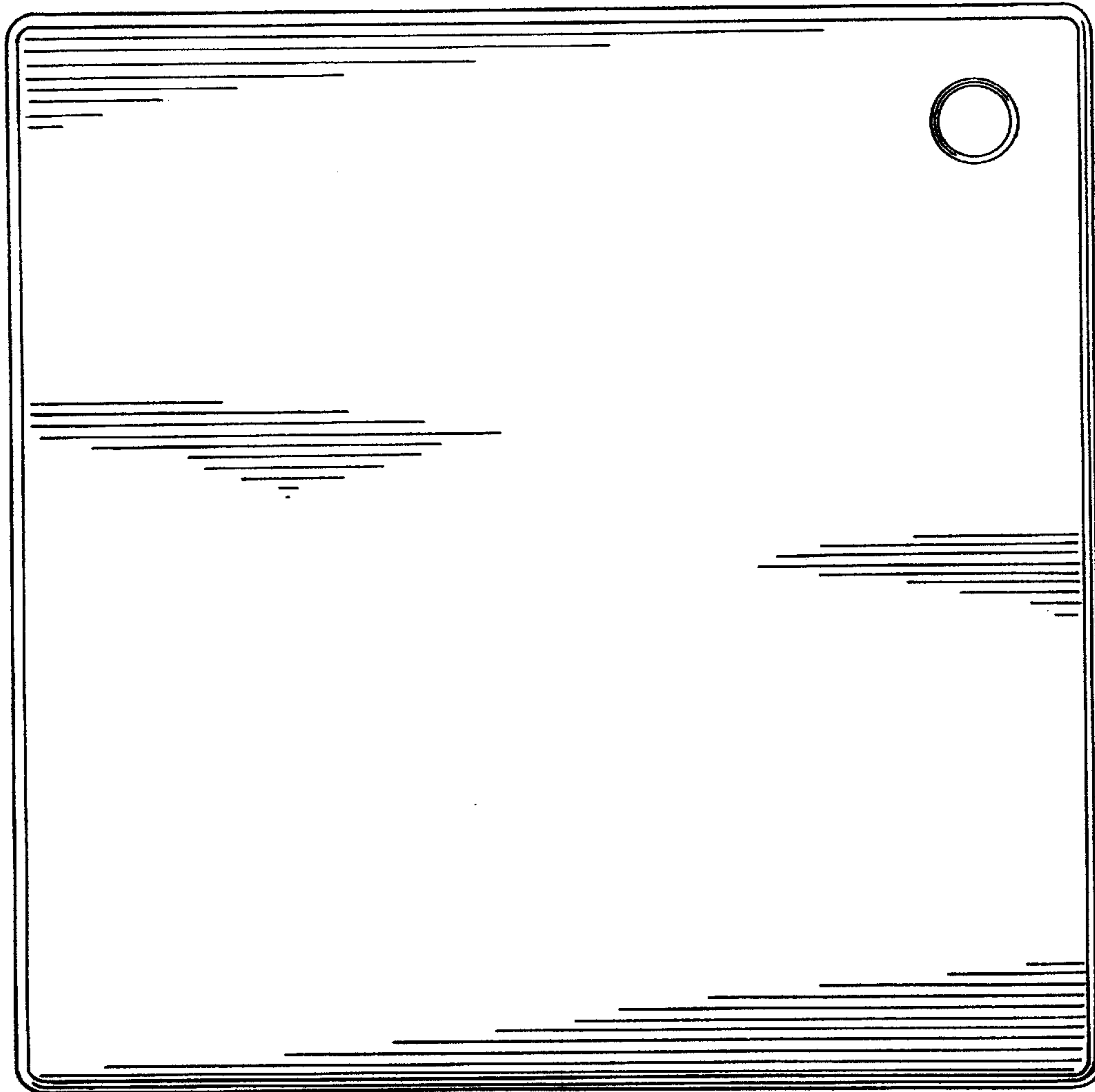
