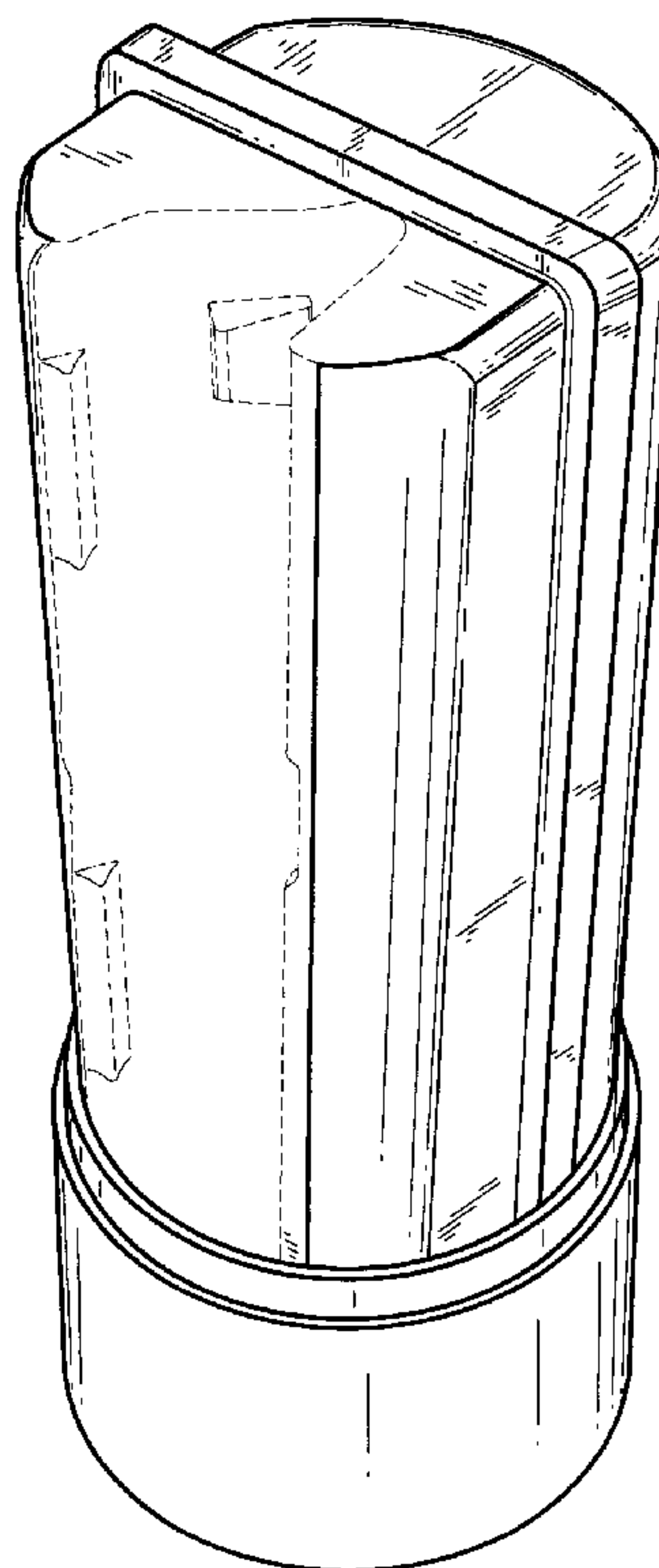
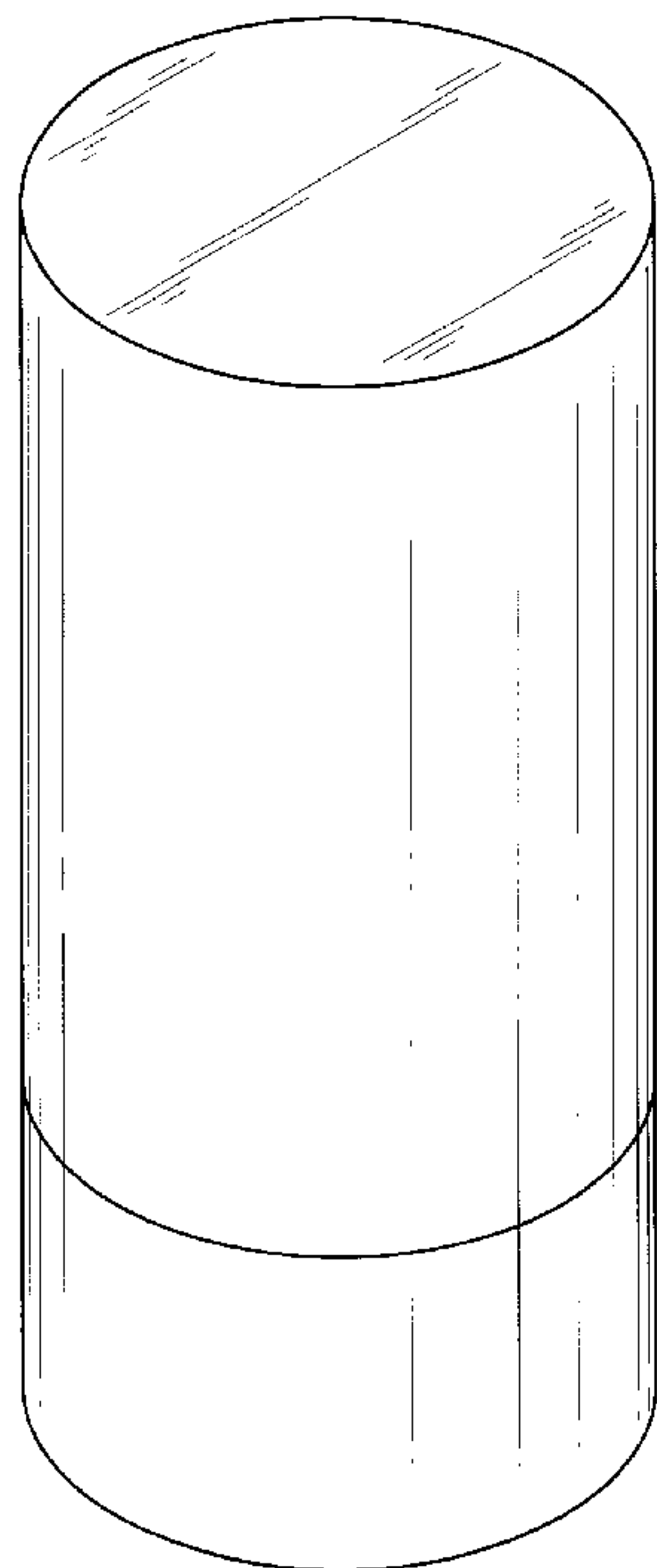
The ornamental design for hair appliance packaging, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of hair appliance packaging showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a front right perspective view of FIG. 1, the only difference being that the cover is removed;
FIG. 5 is a front left perspective view of FIG. 1, the only difference being that the cover is removed;
FIG. 6 is a front view of FIG. 1, the only difference being that the cover is removed;
FIG. 7 is a back view of FIG. 1, the only difference being that the cover is removed;
FIG. 8 is a left side view of FIG. 1, the only difference being that the cover is removed;

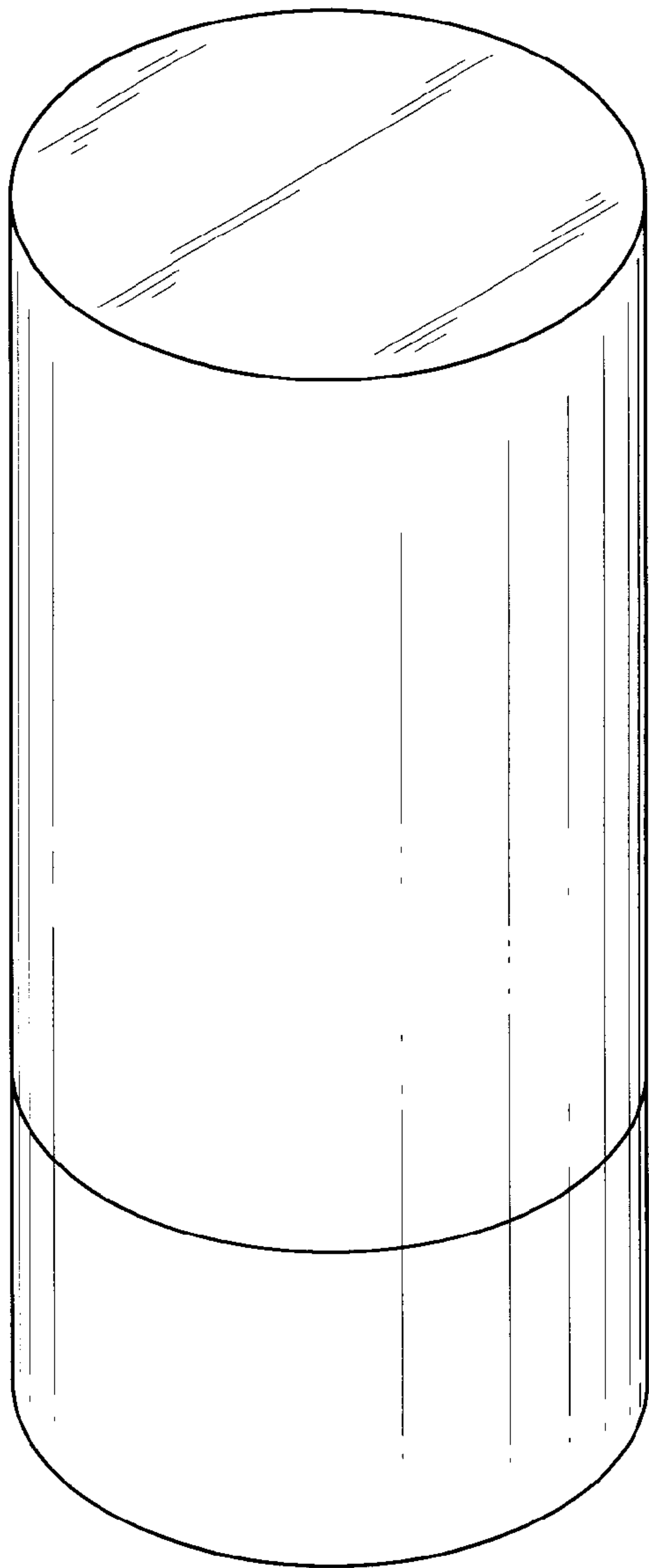

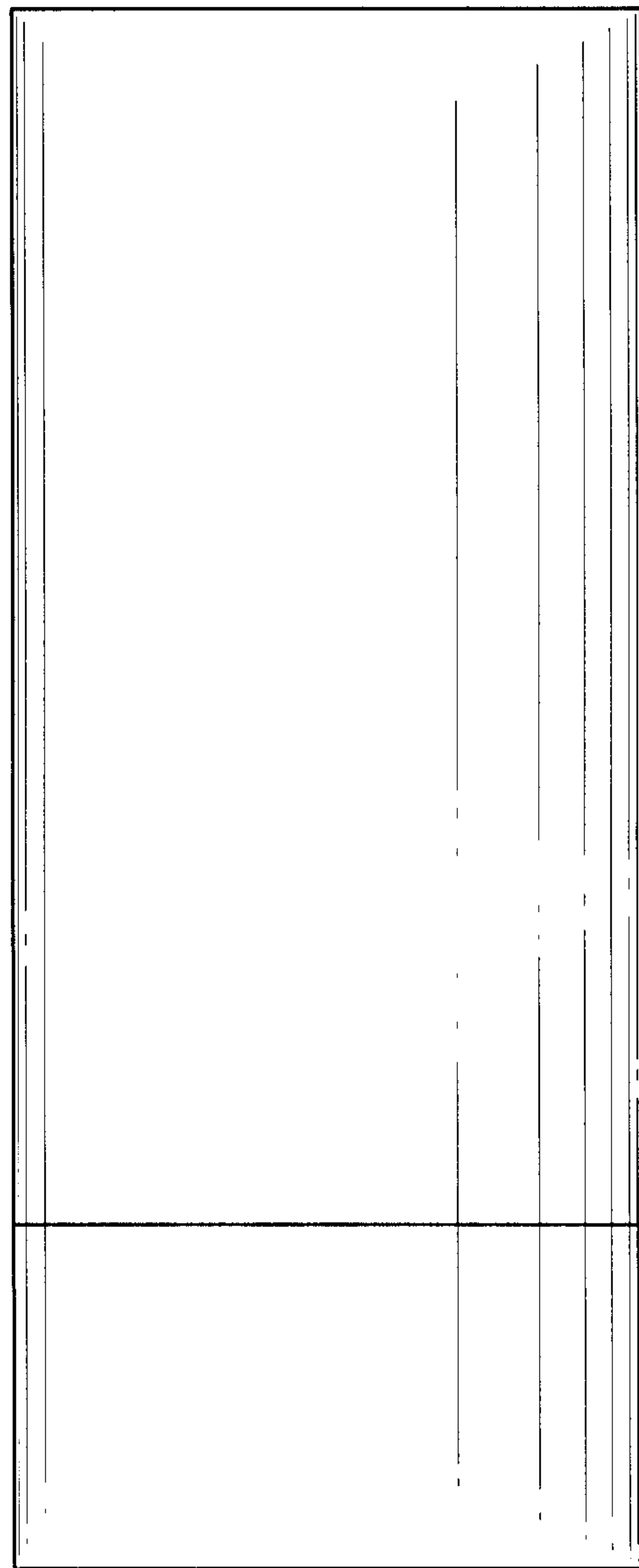

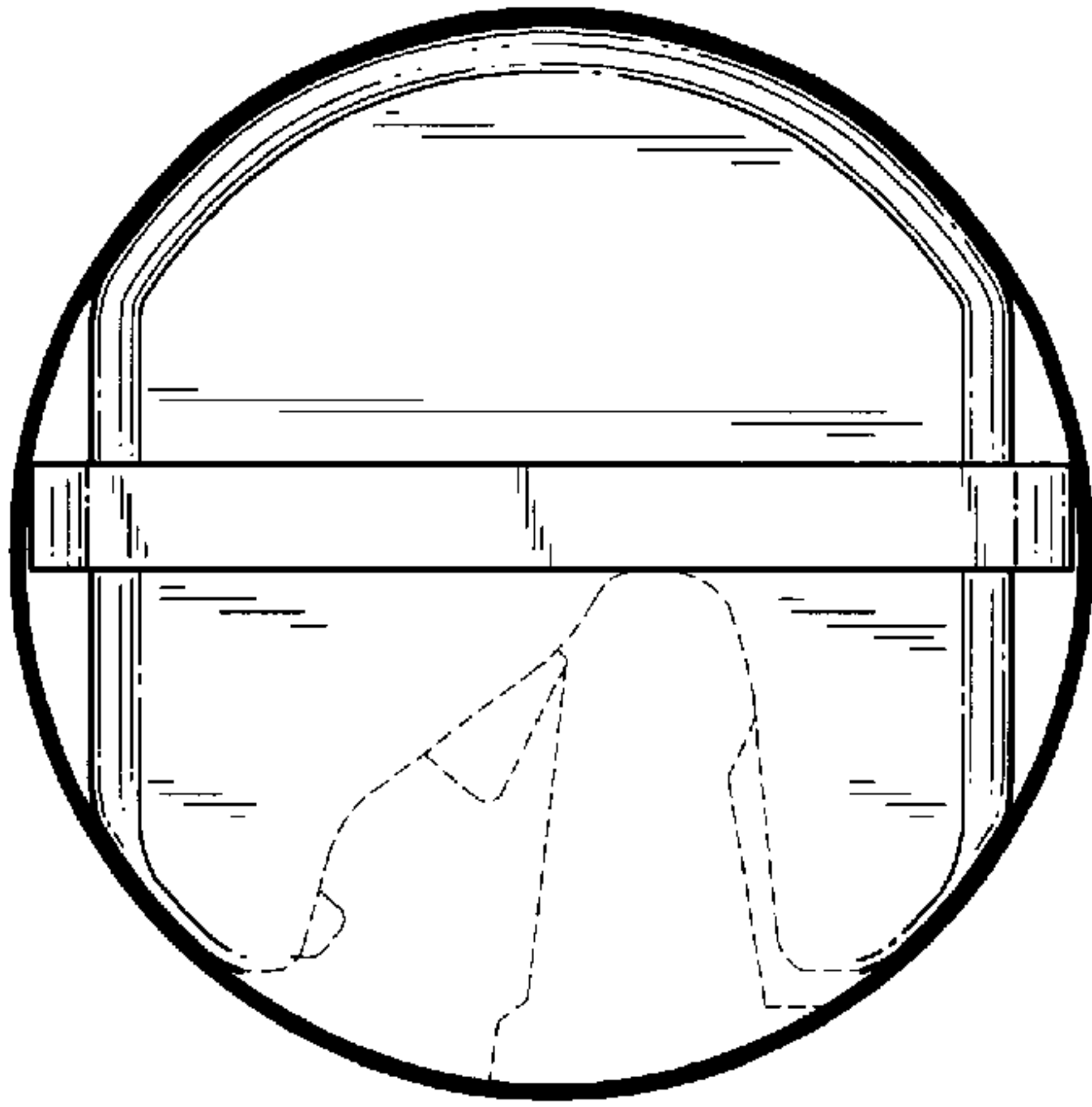

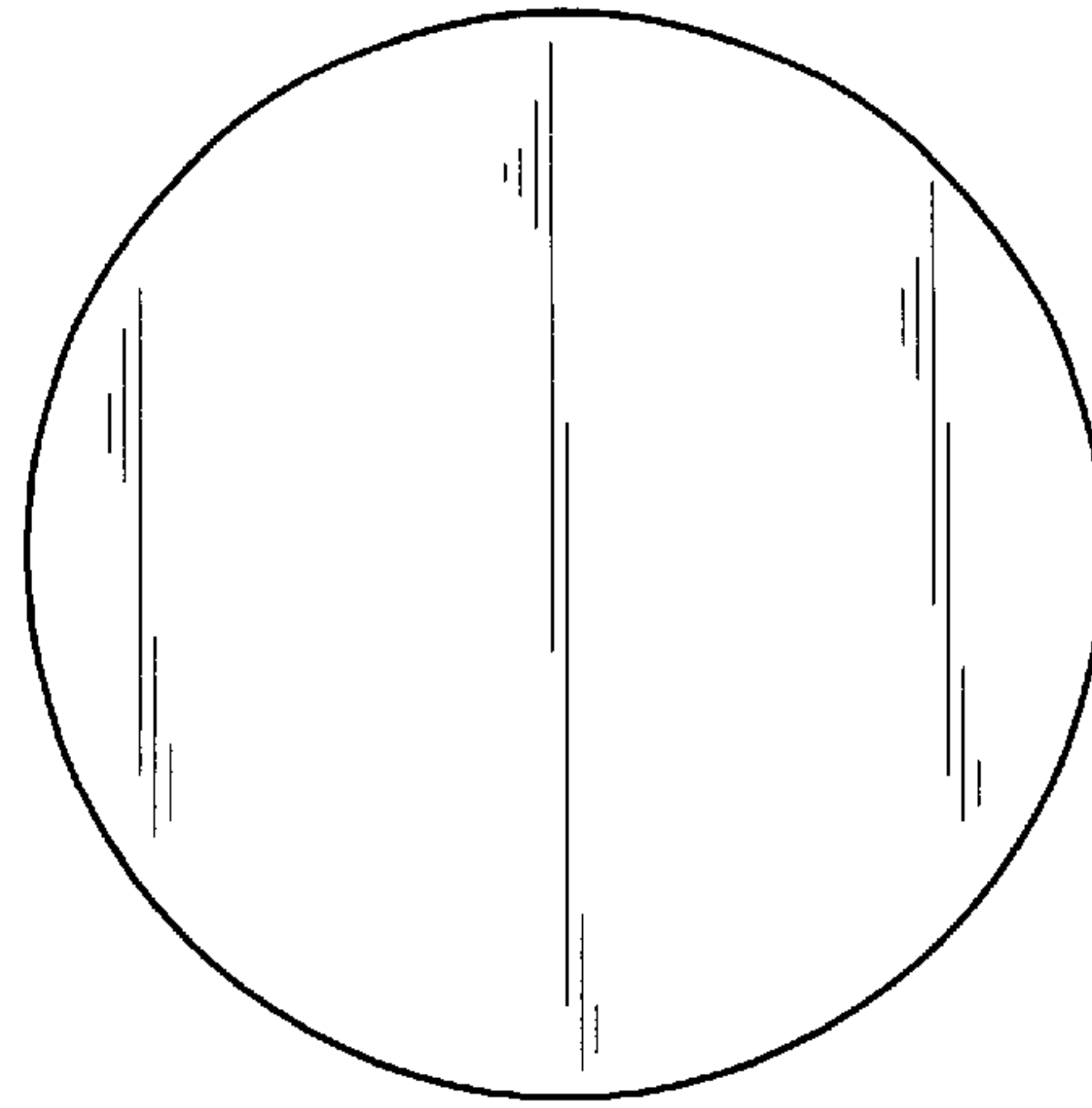

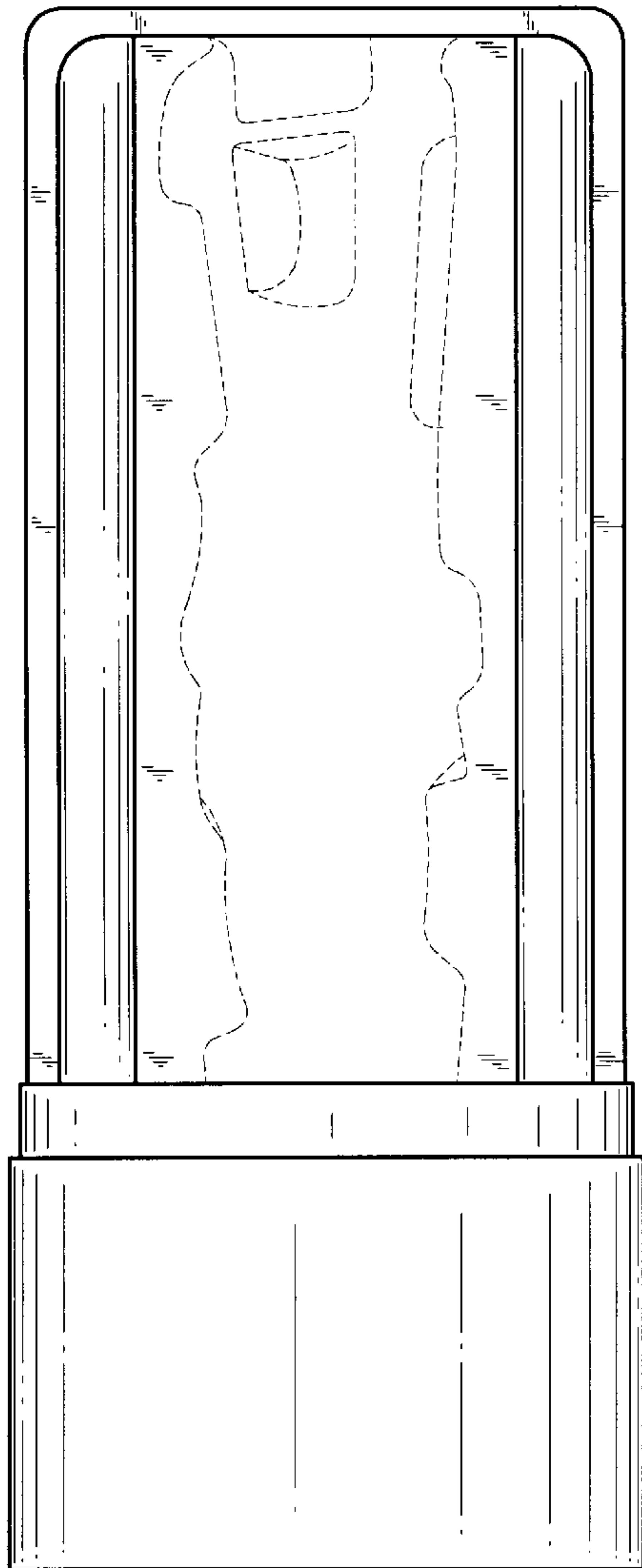

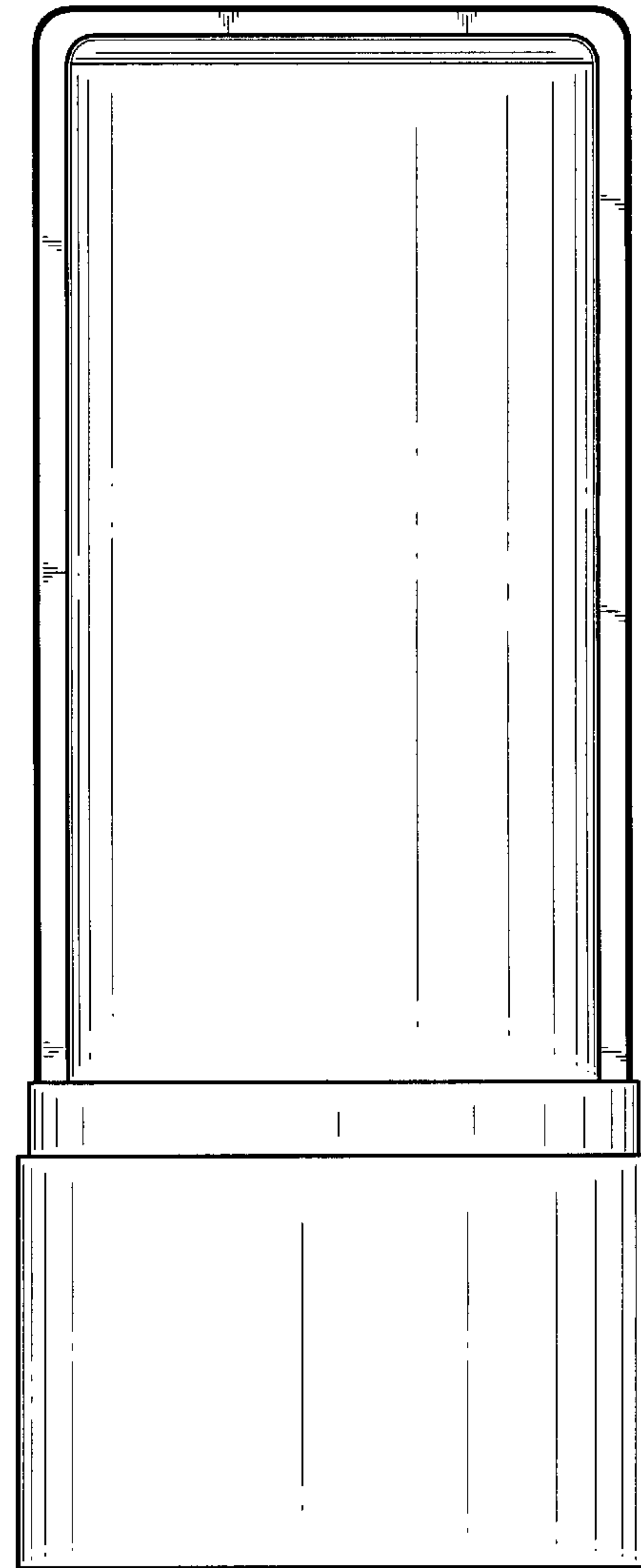

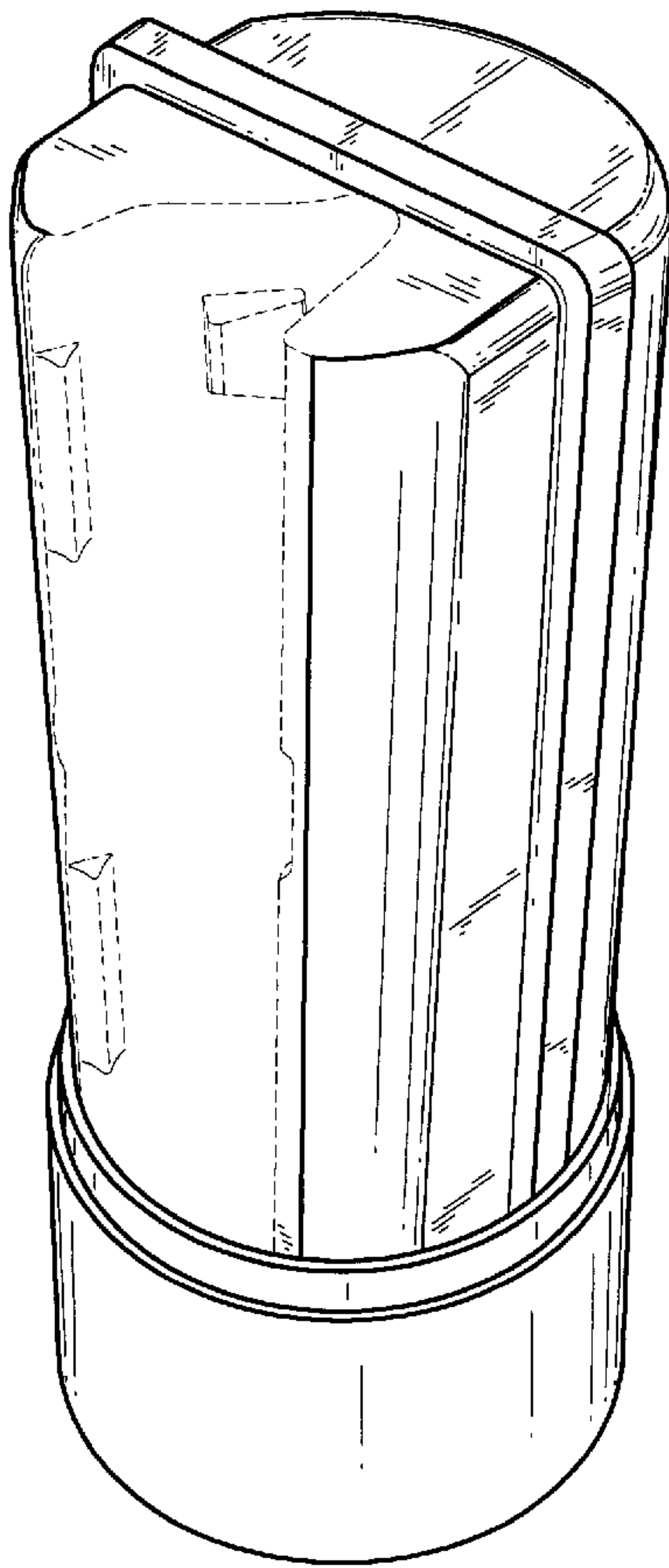

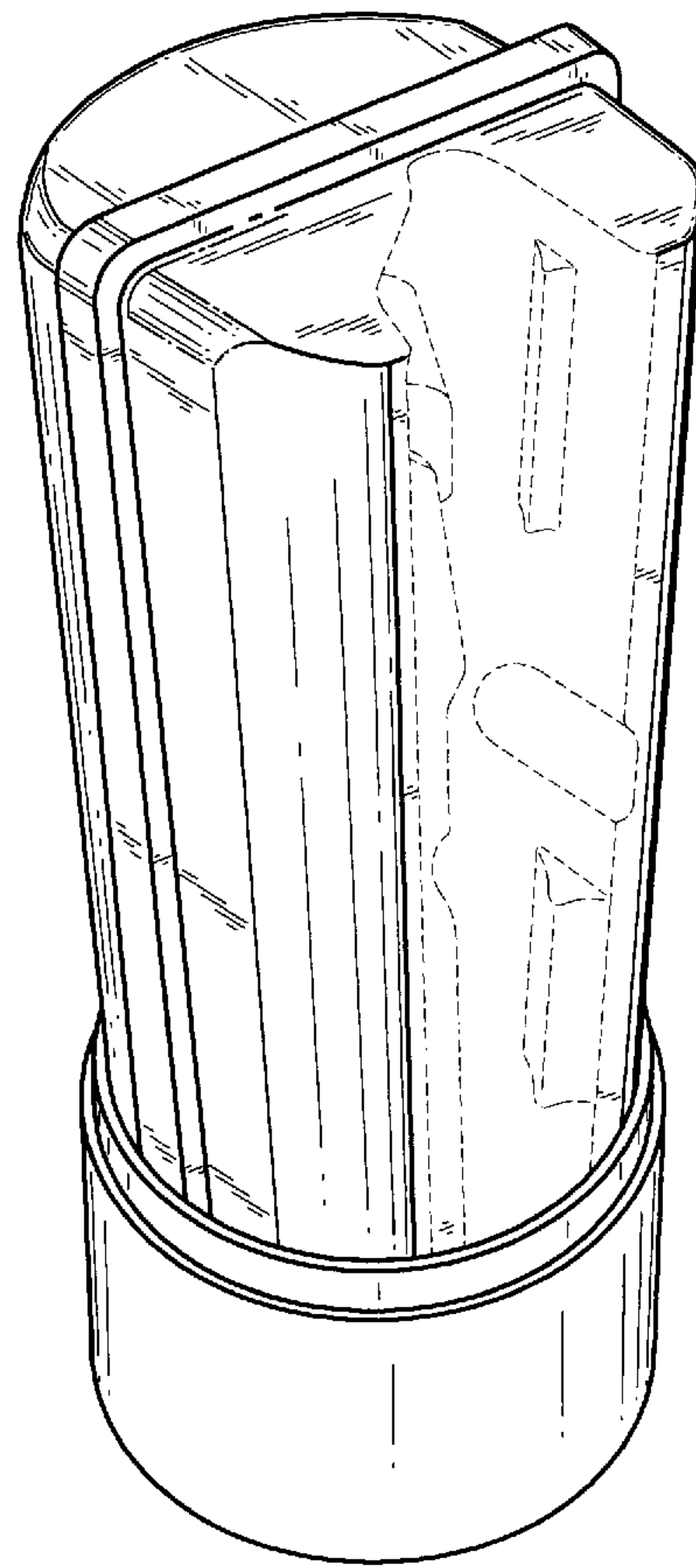

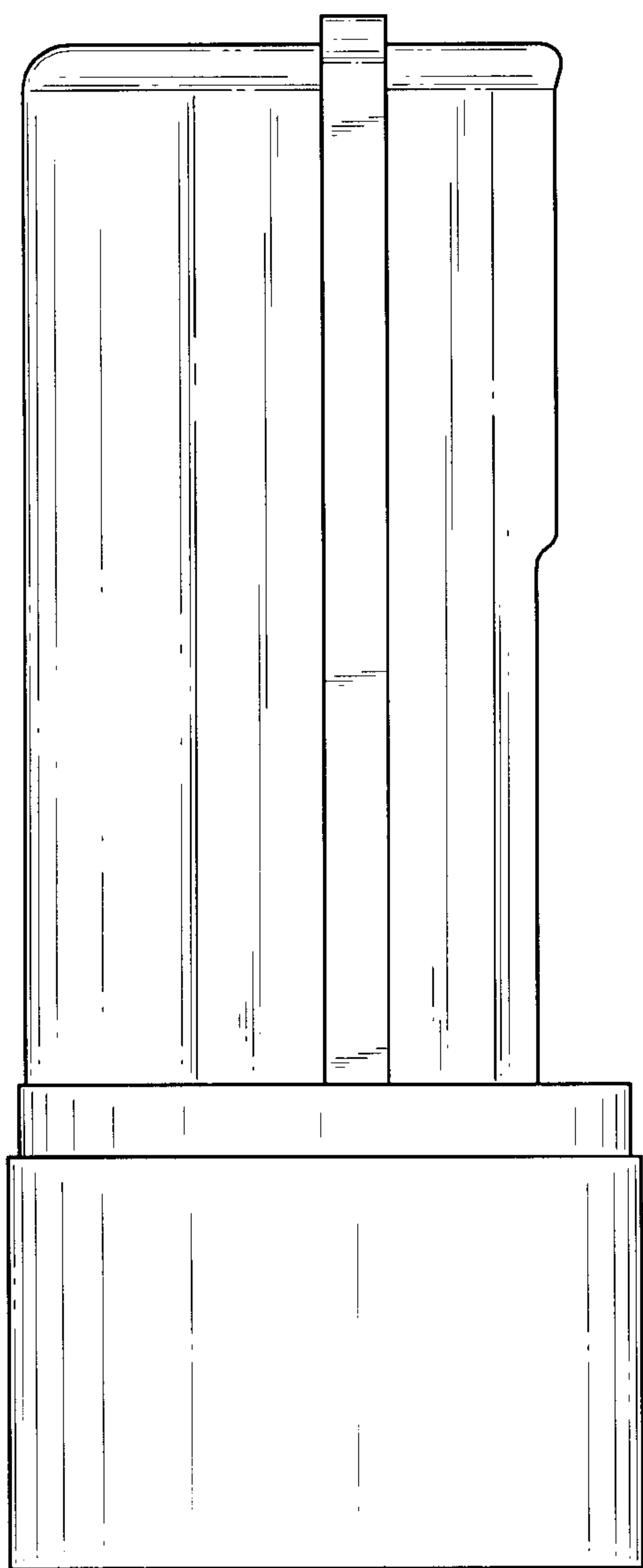

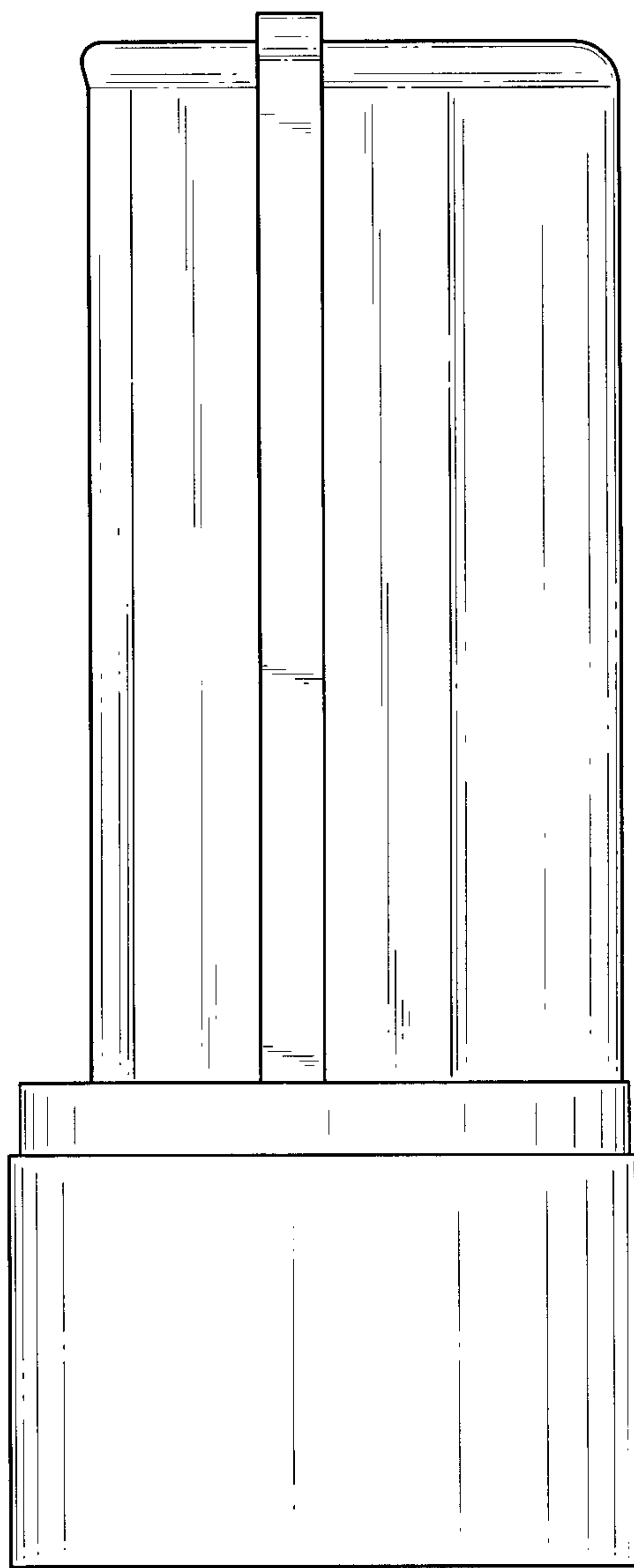
