FIG. 11 is a rear view of the pill dispenser of FIG. 1; and,

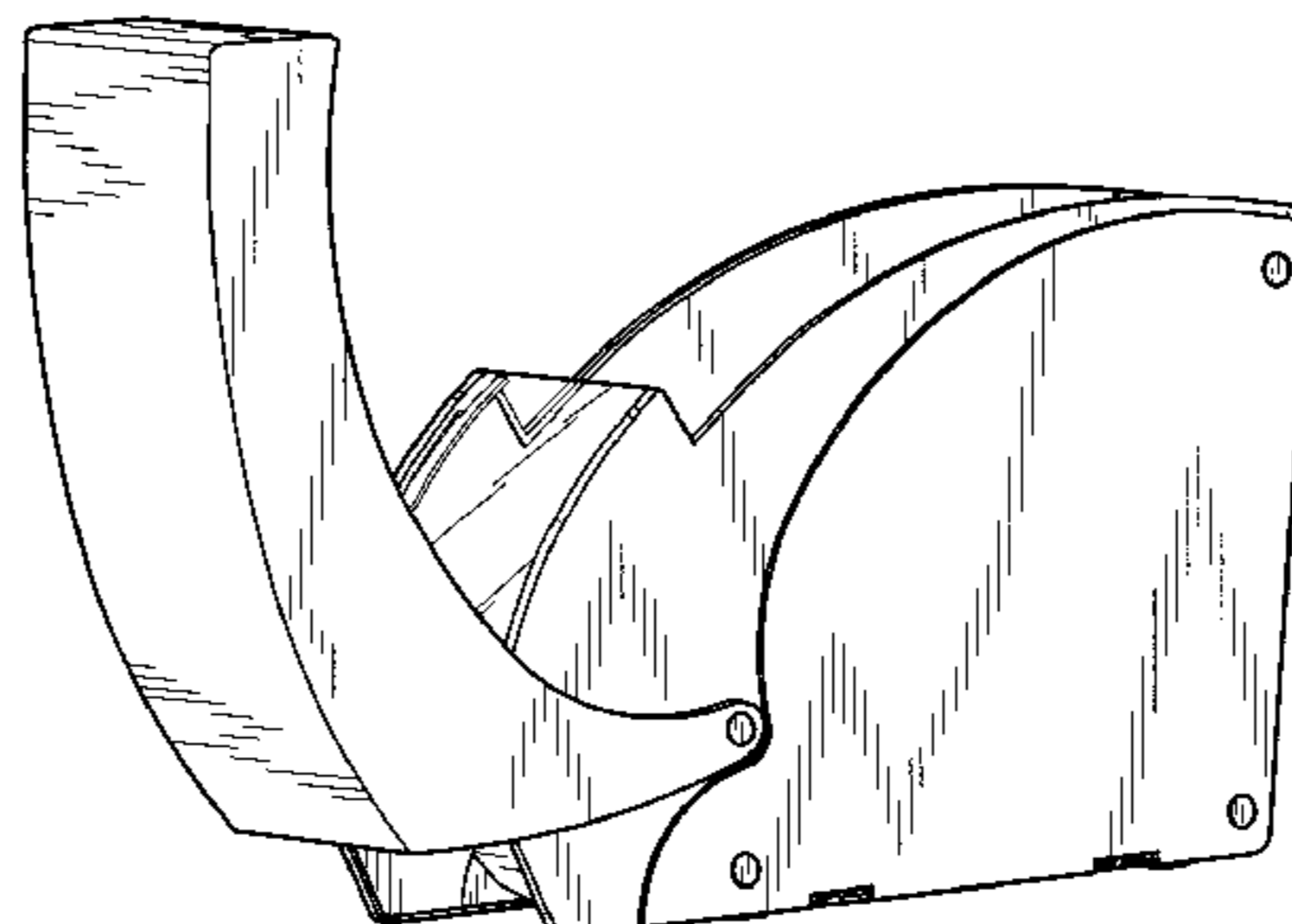
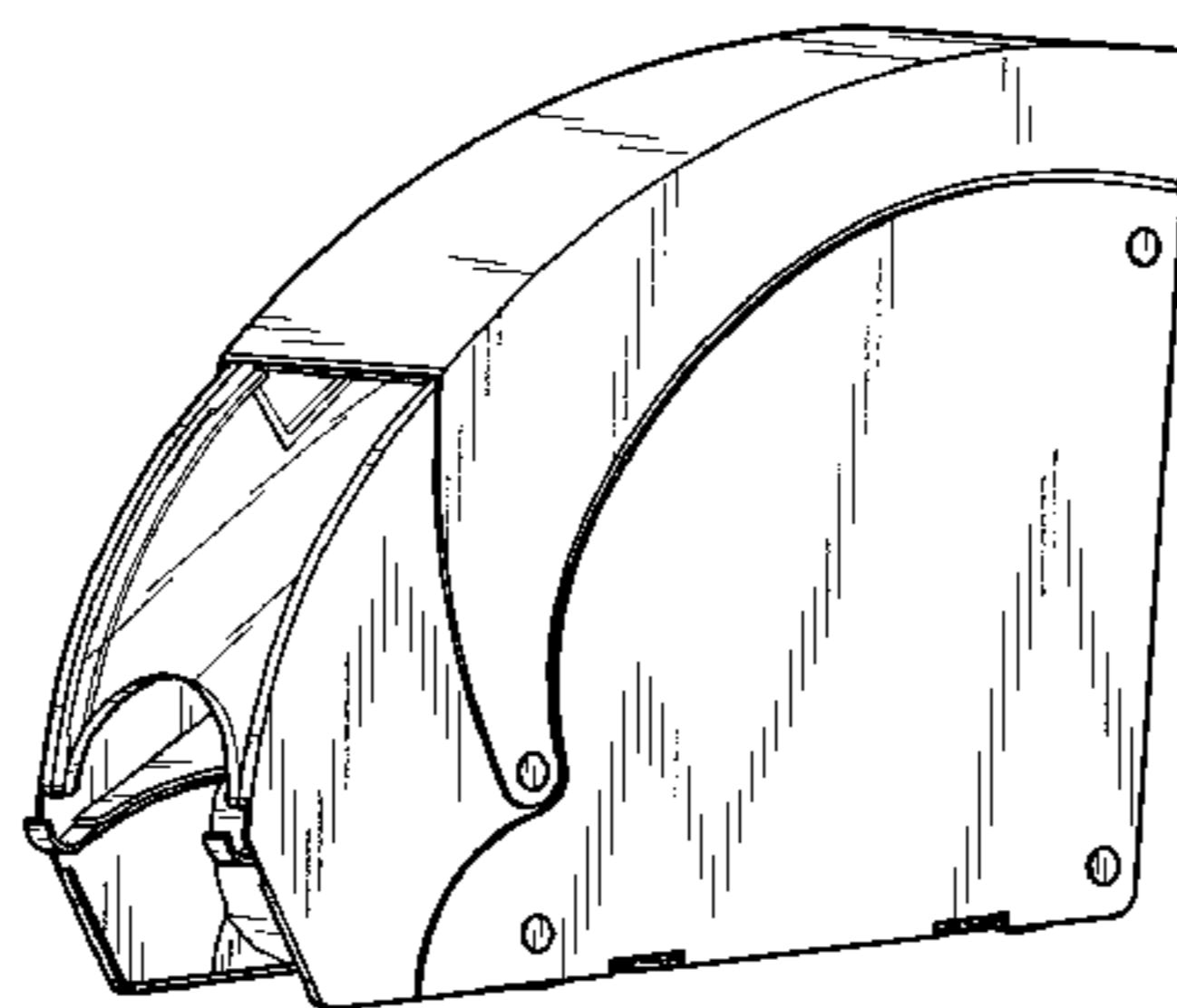
FIG. 12 is a rear view of the pill dispenser of FIG. 2.

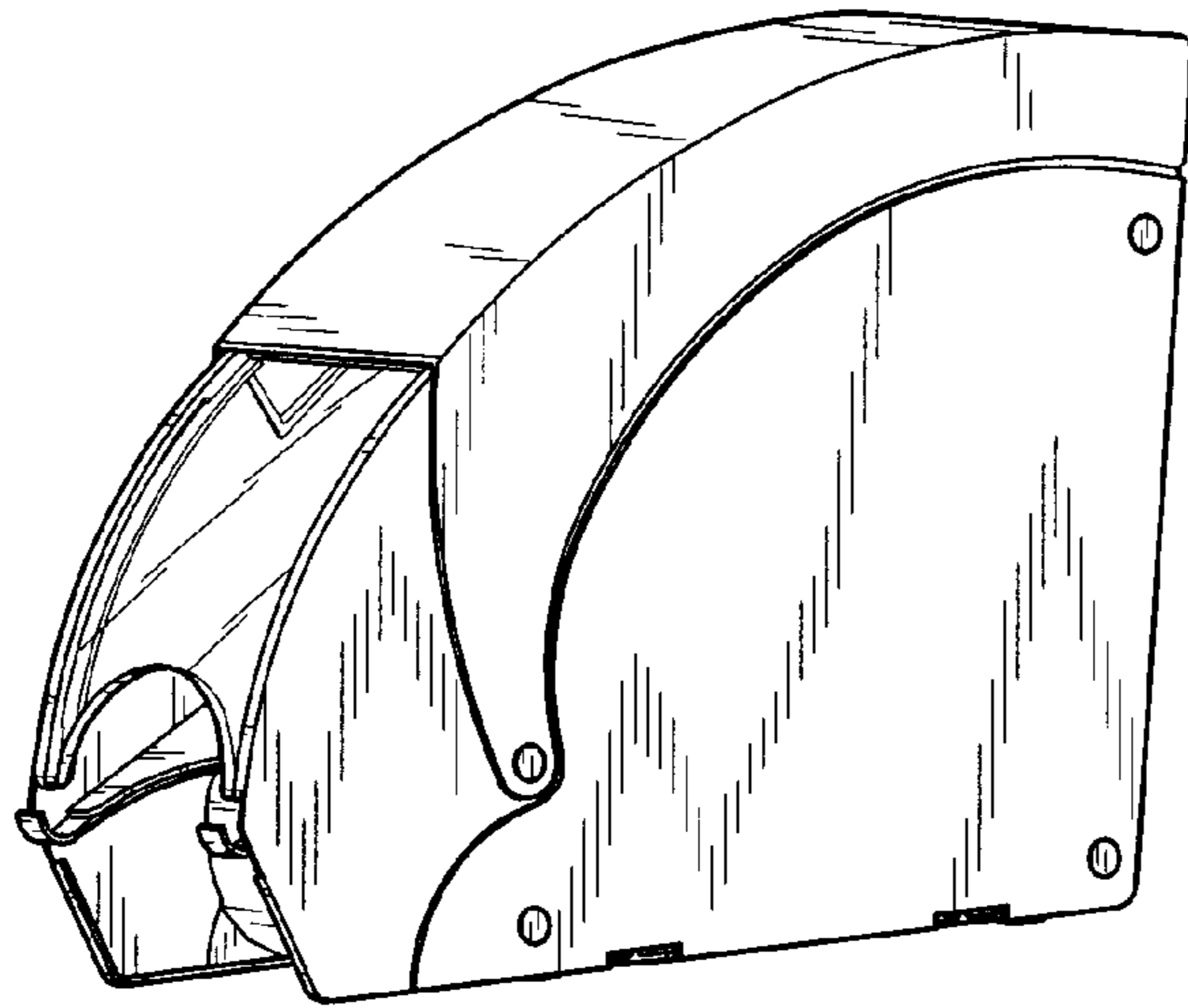

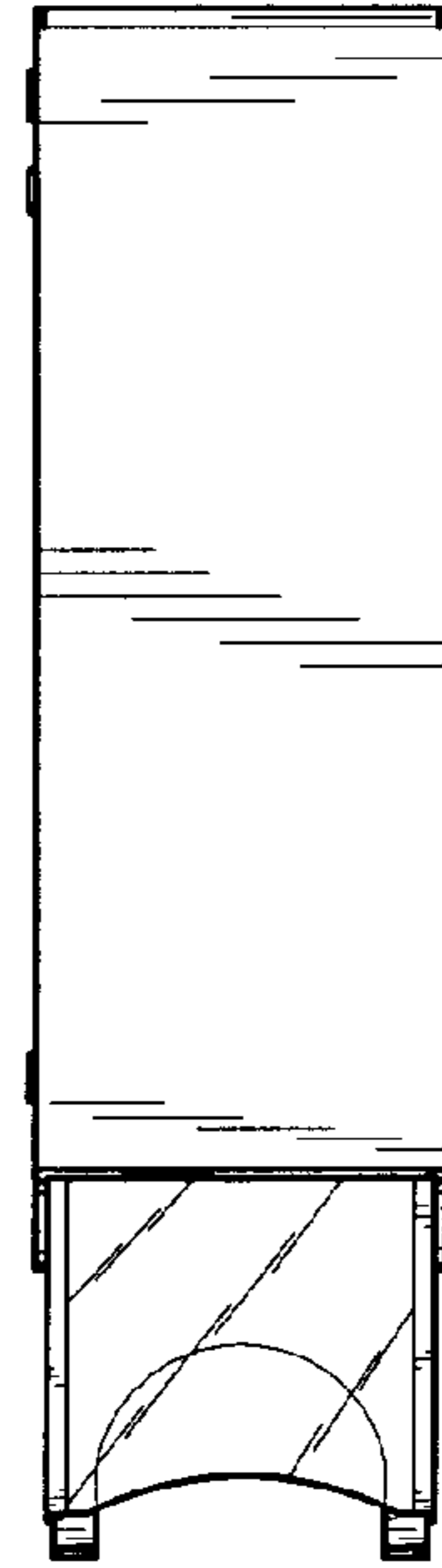

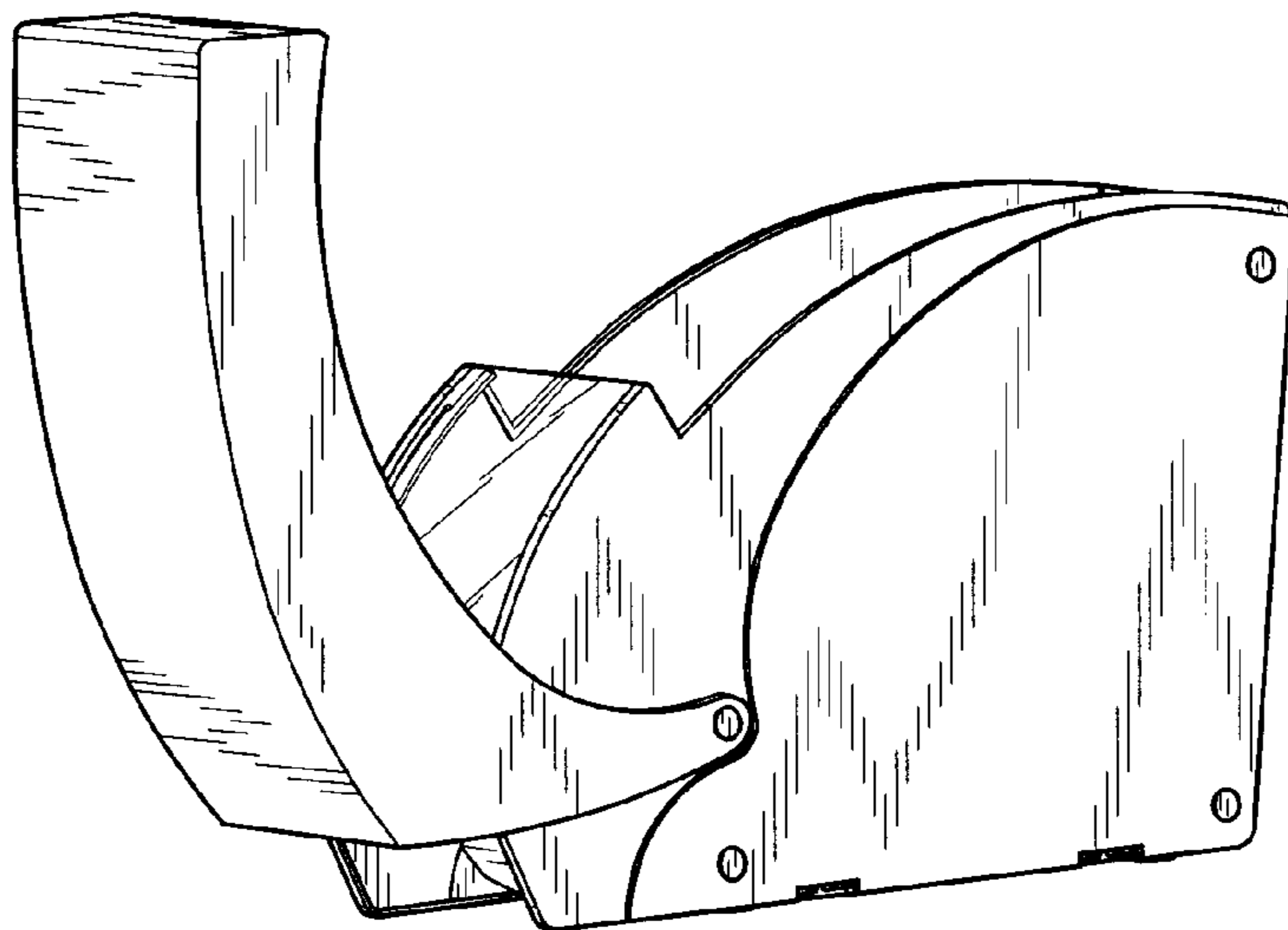

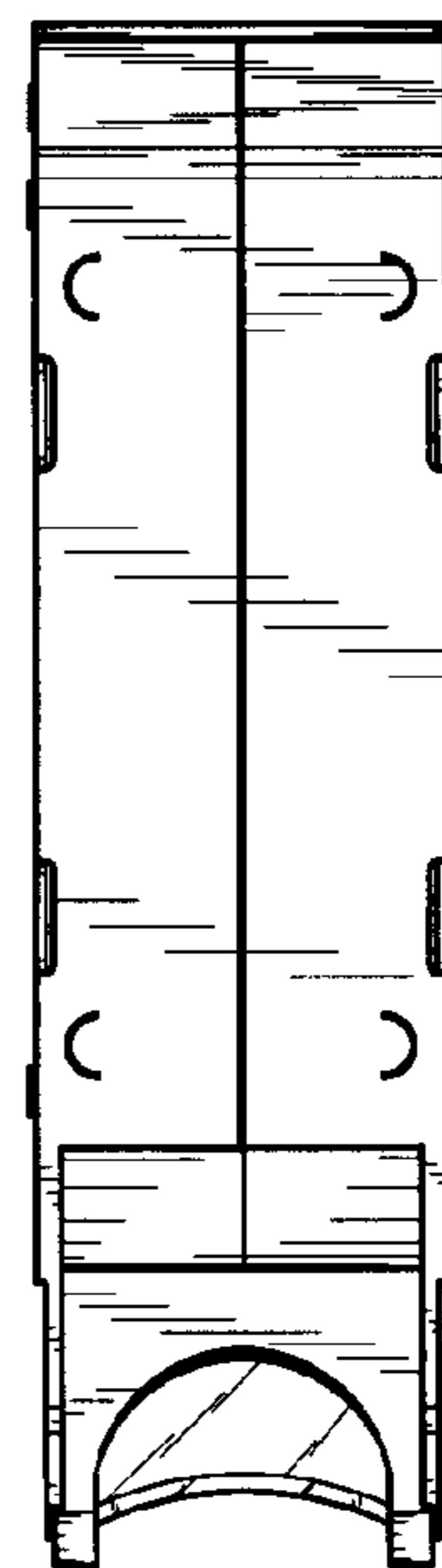

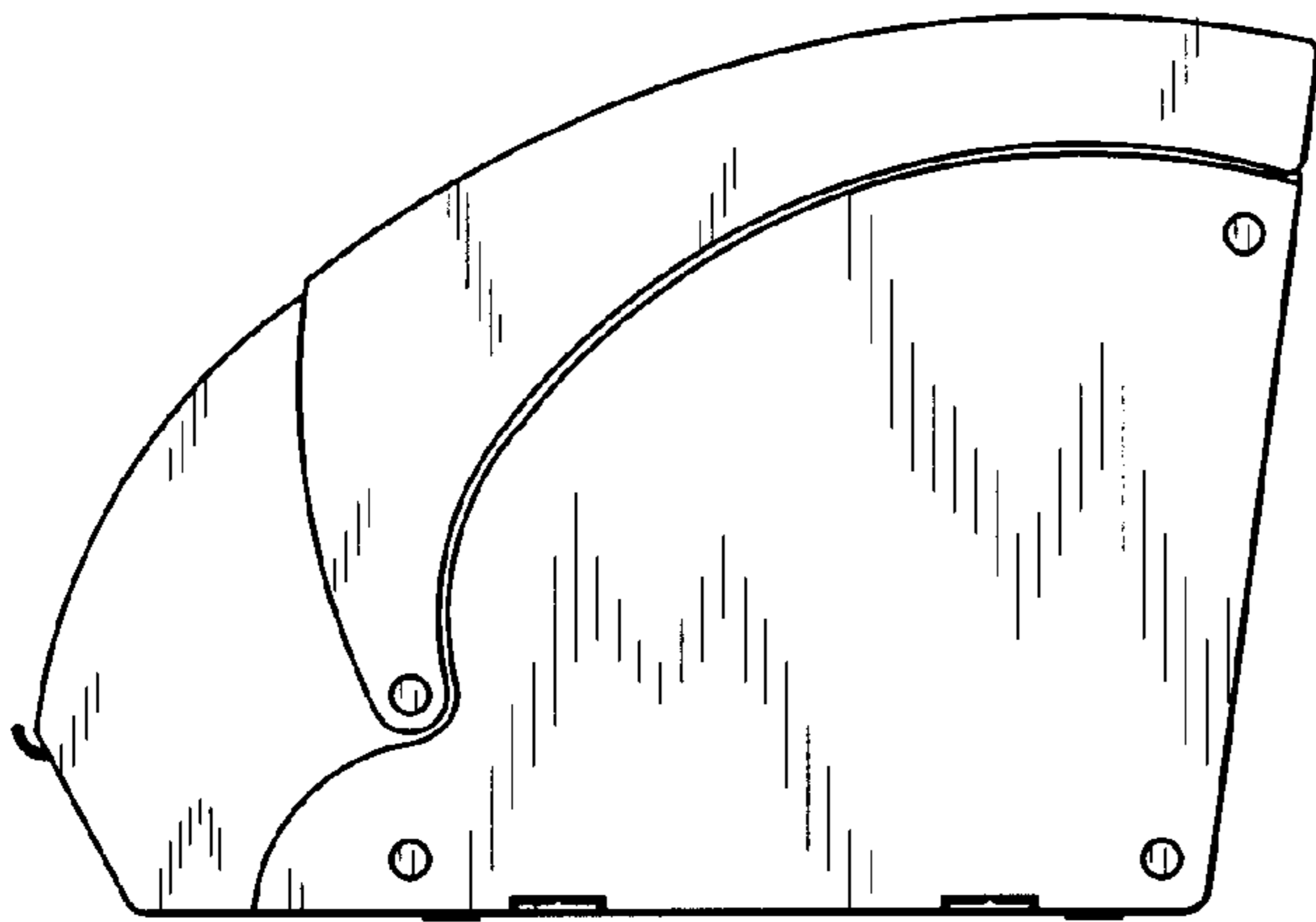

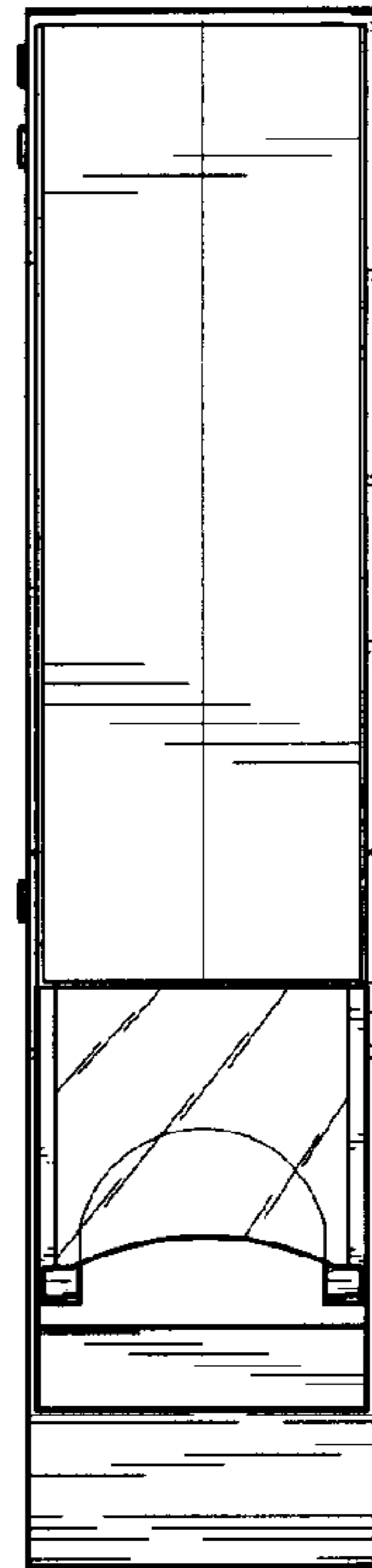

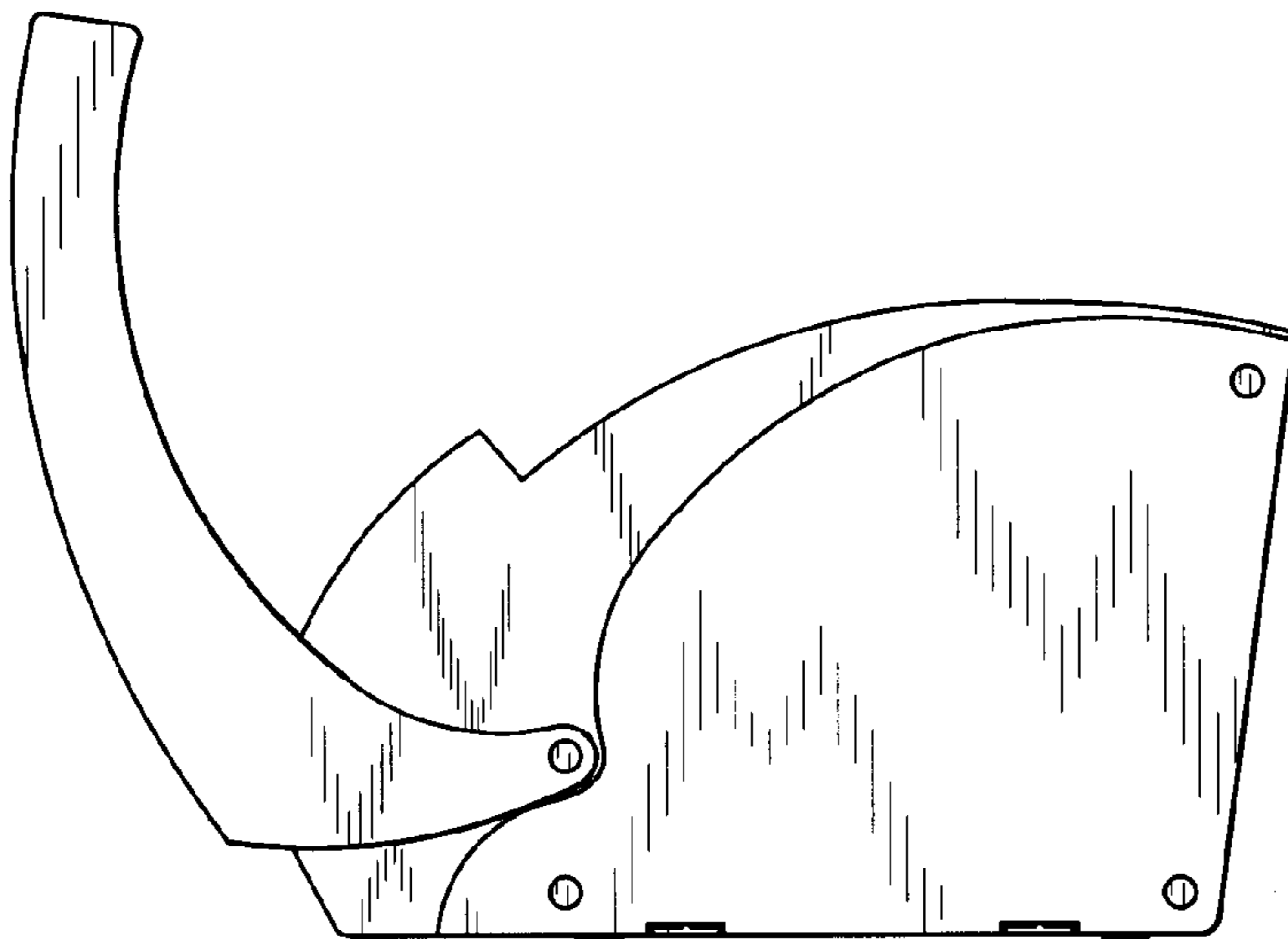

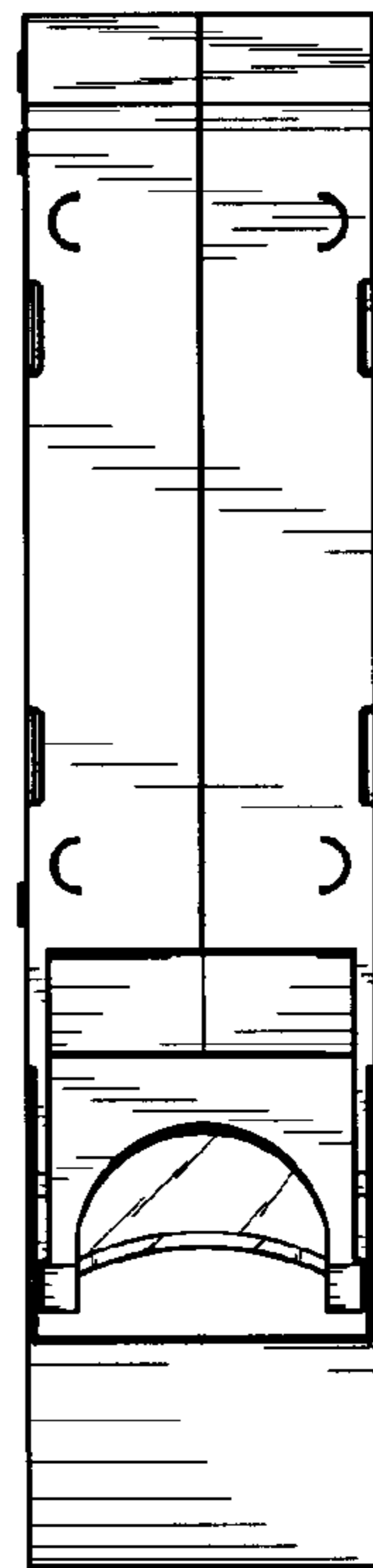

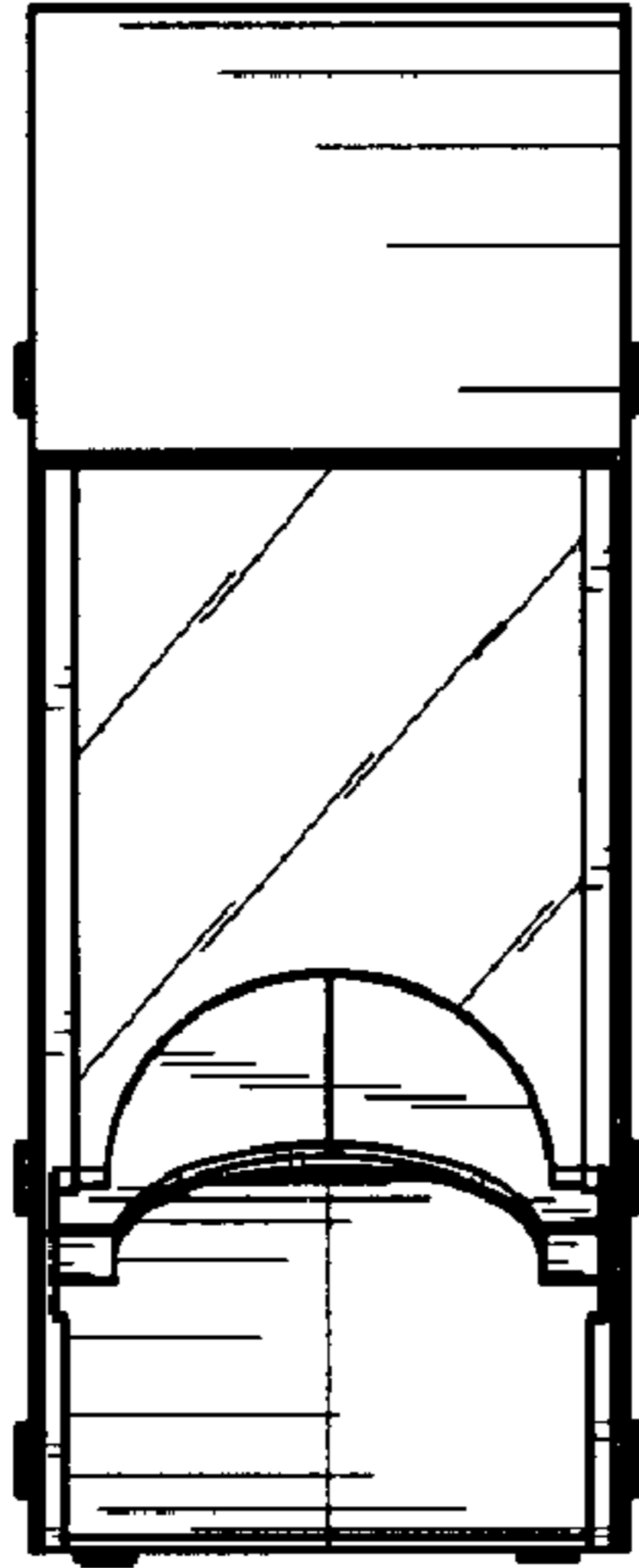

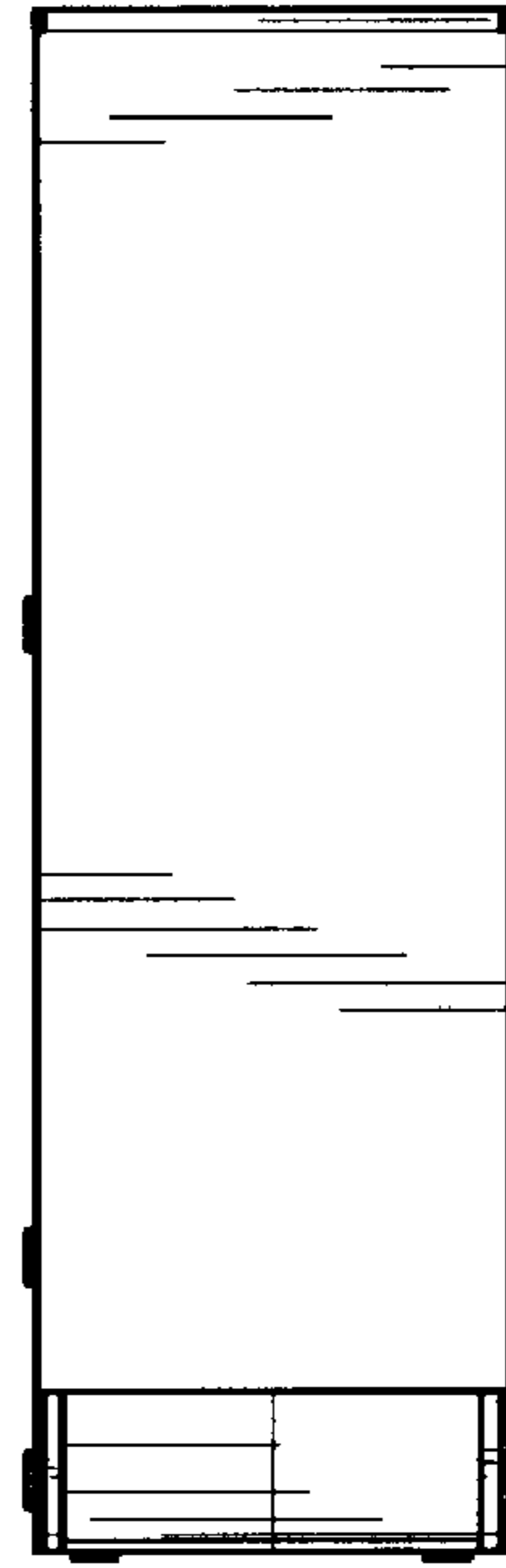

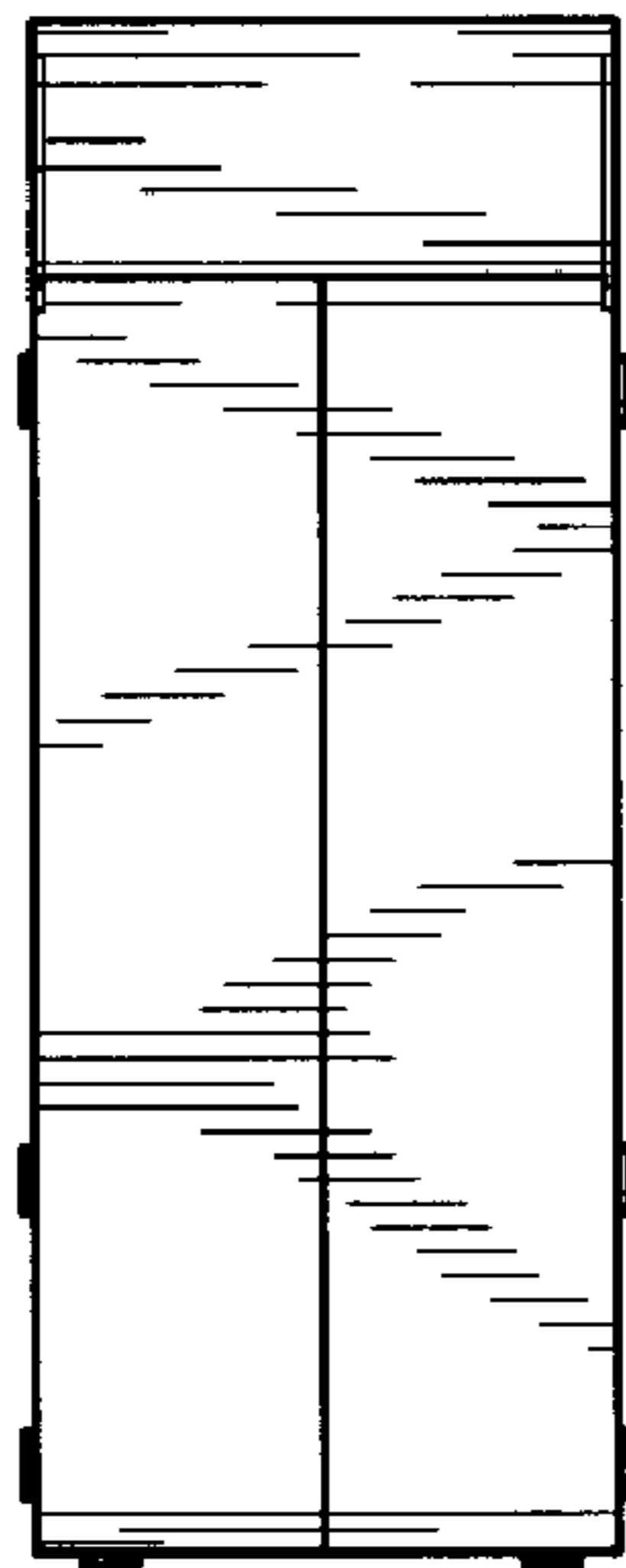

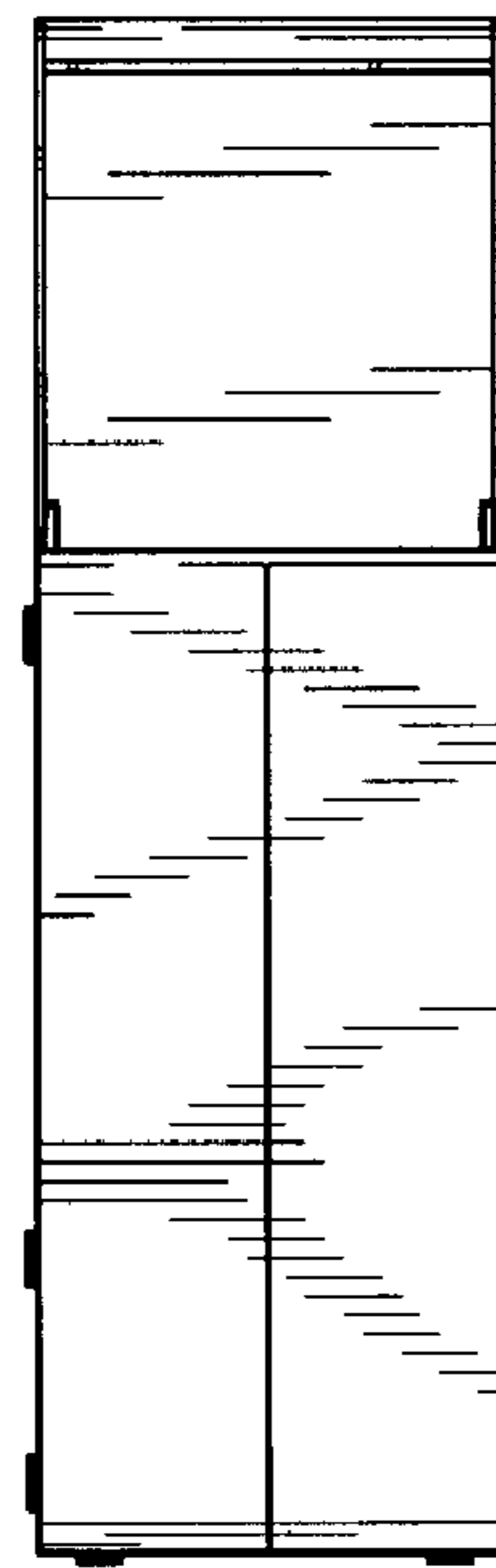
