DESCRIPTION

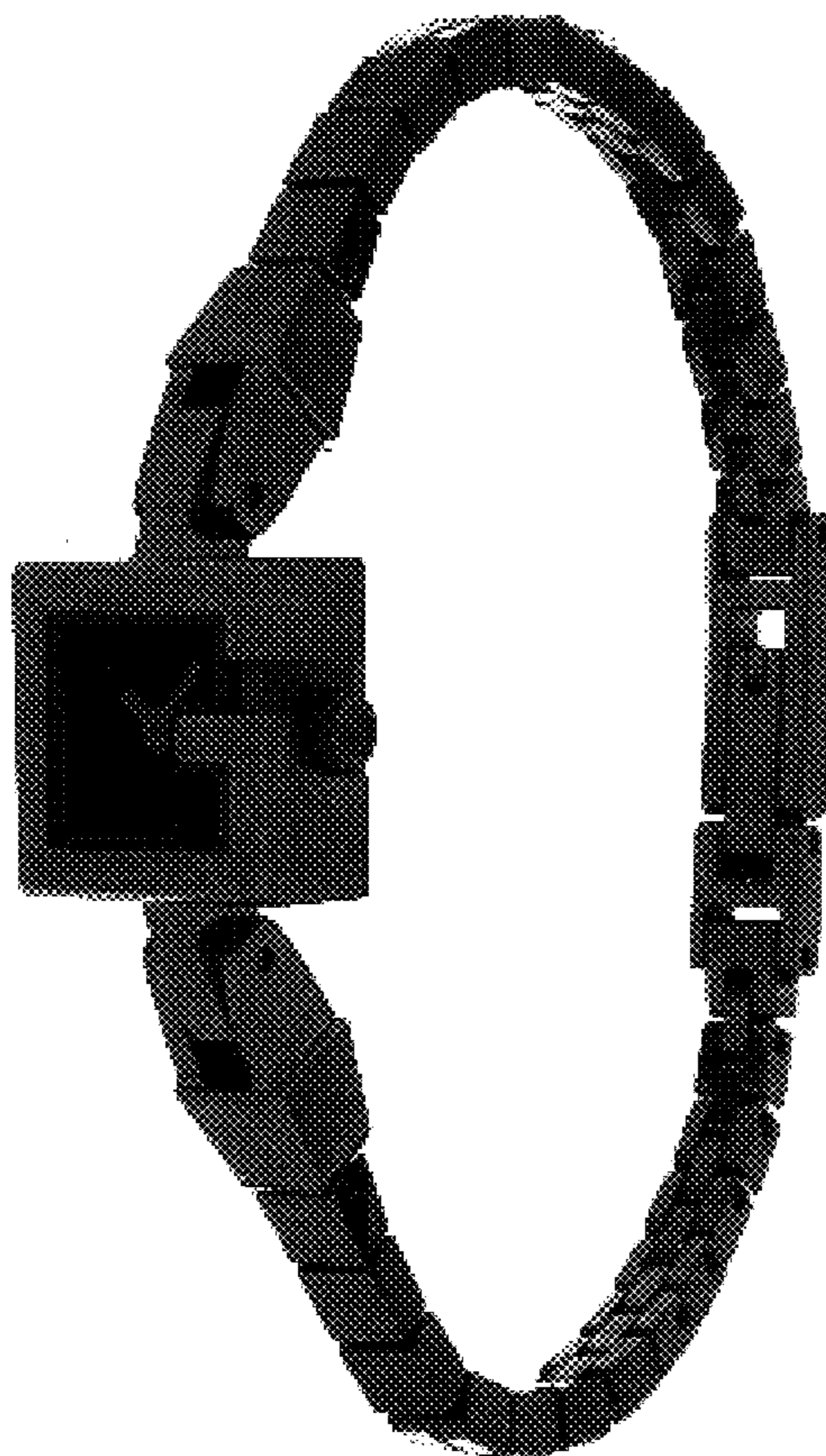

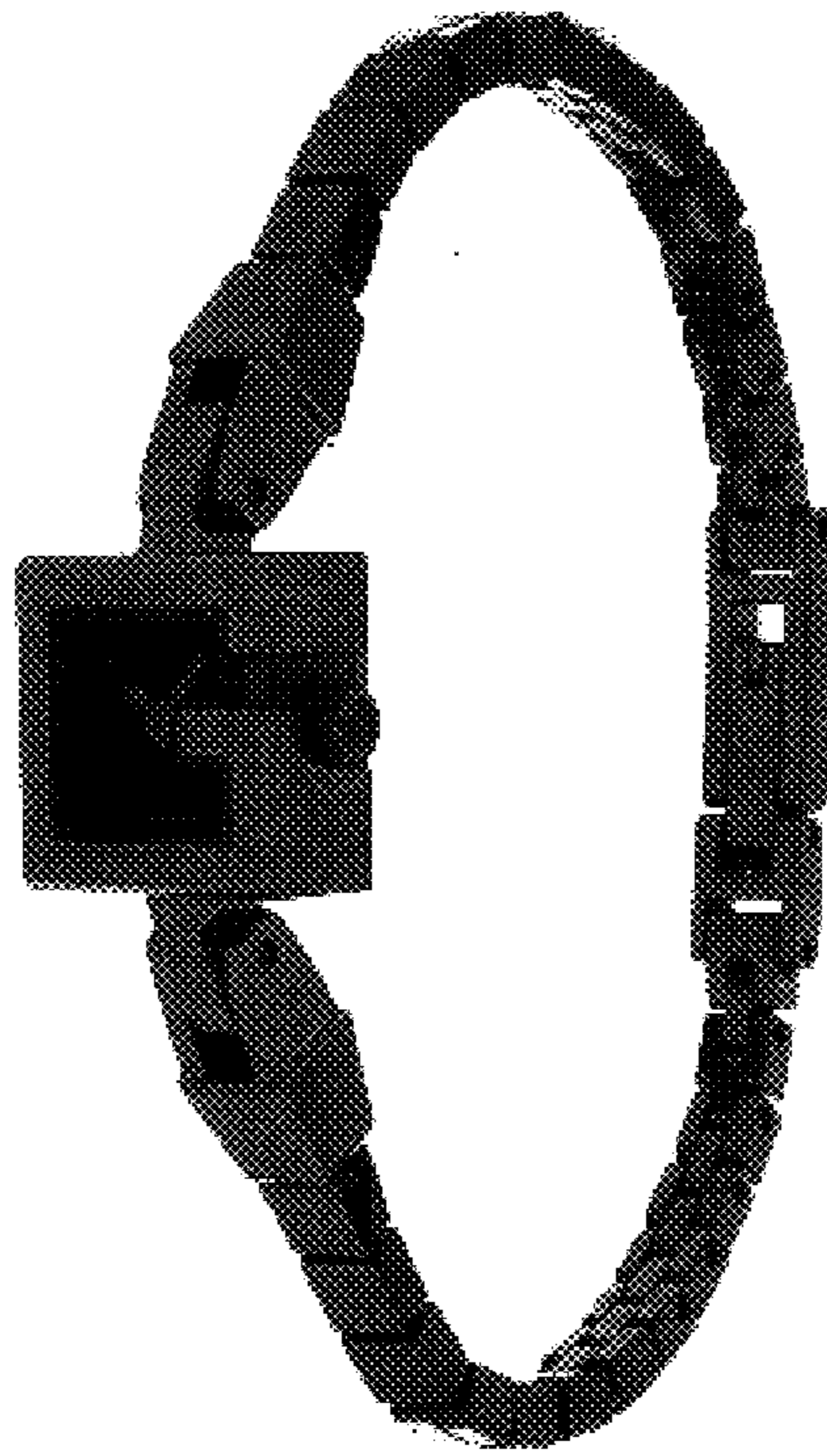

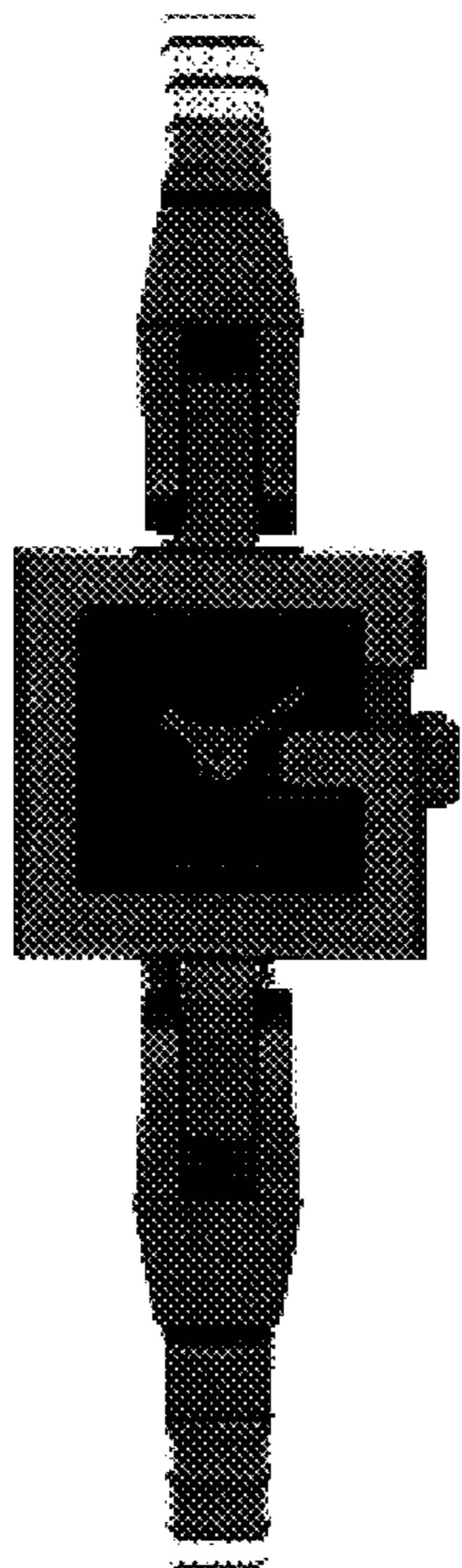

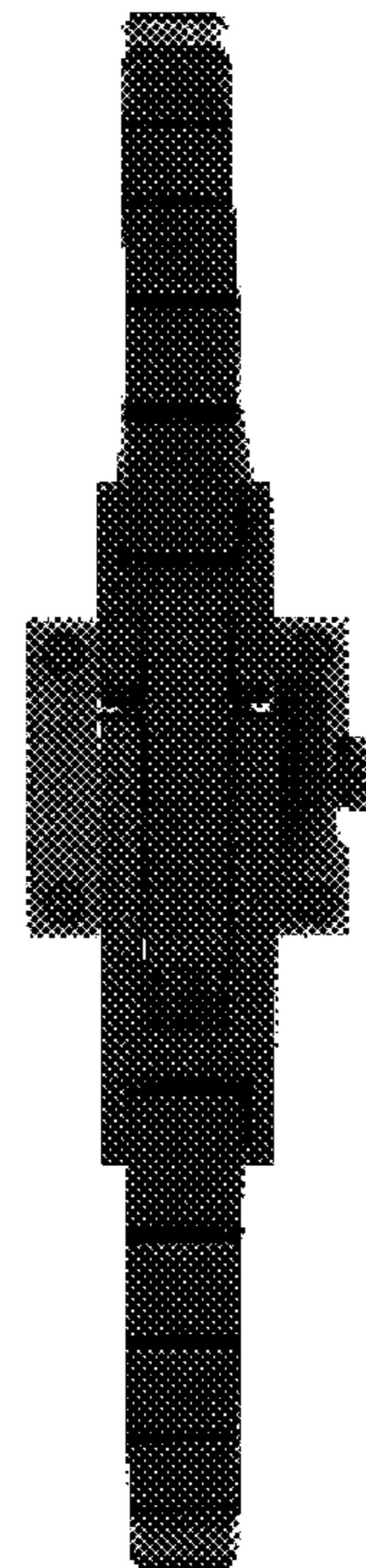

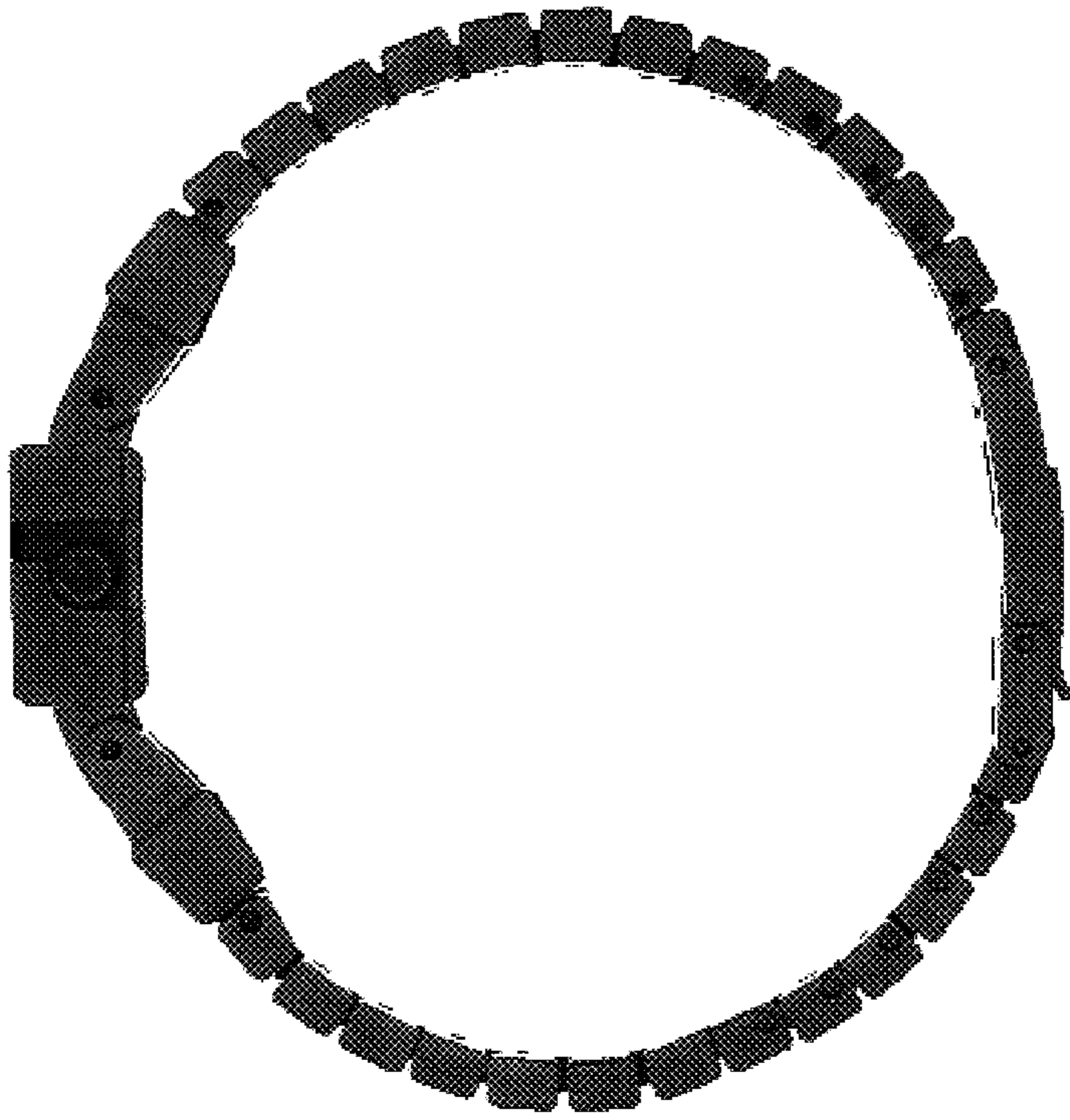

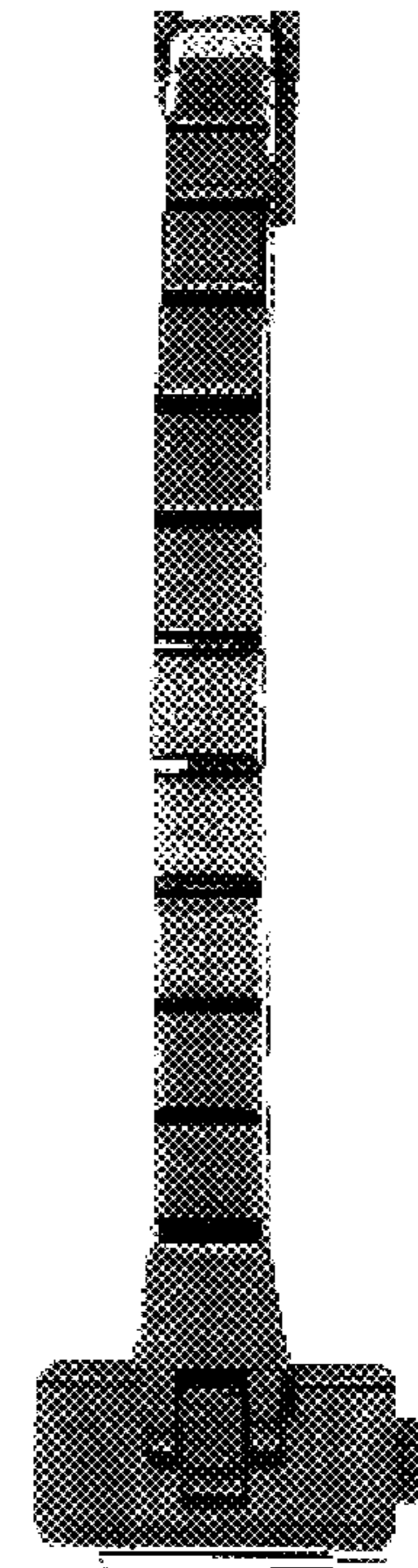

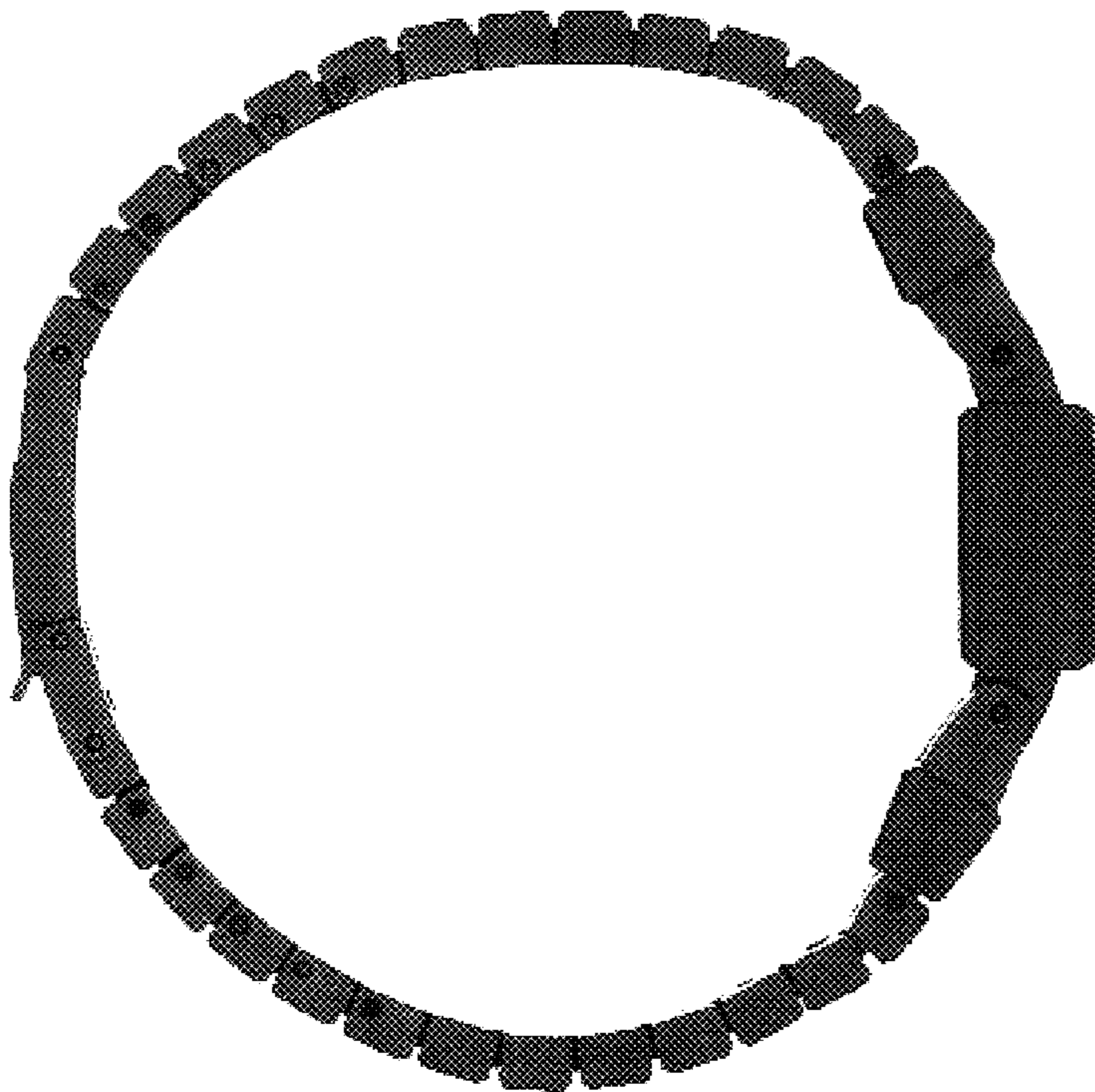
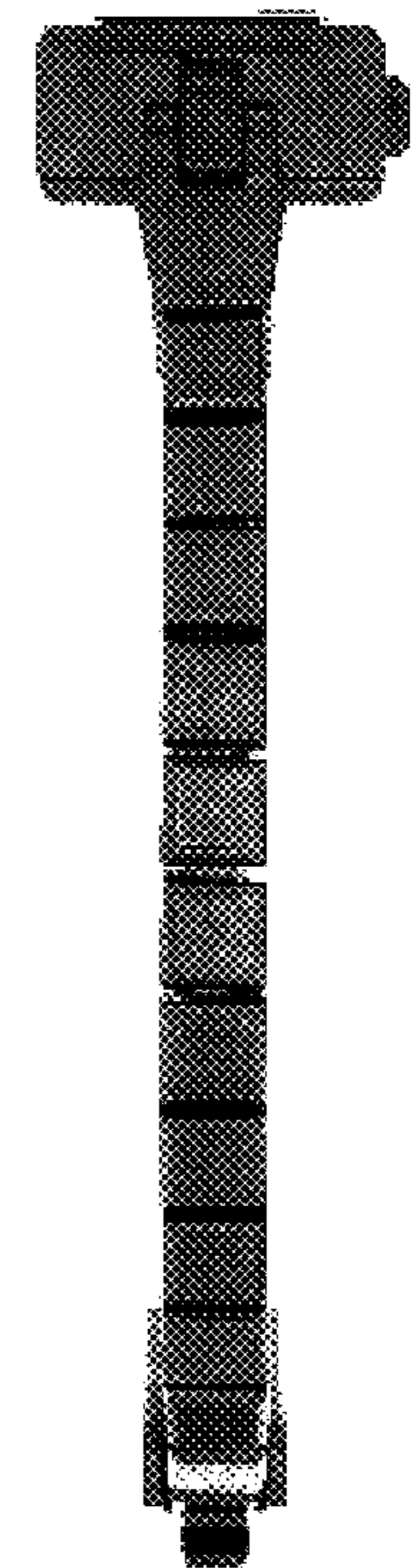
