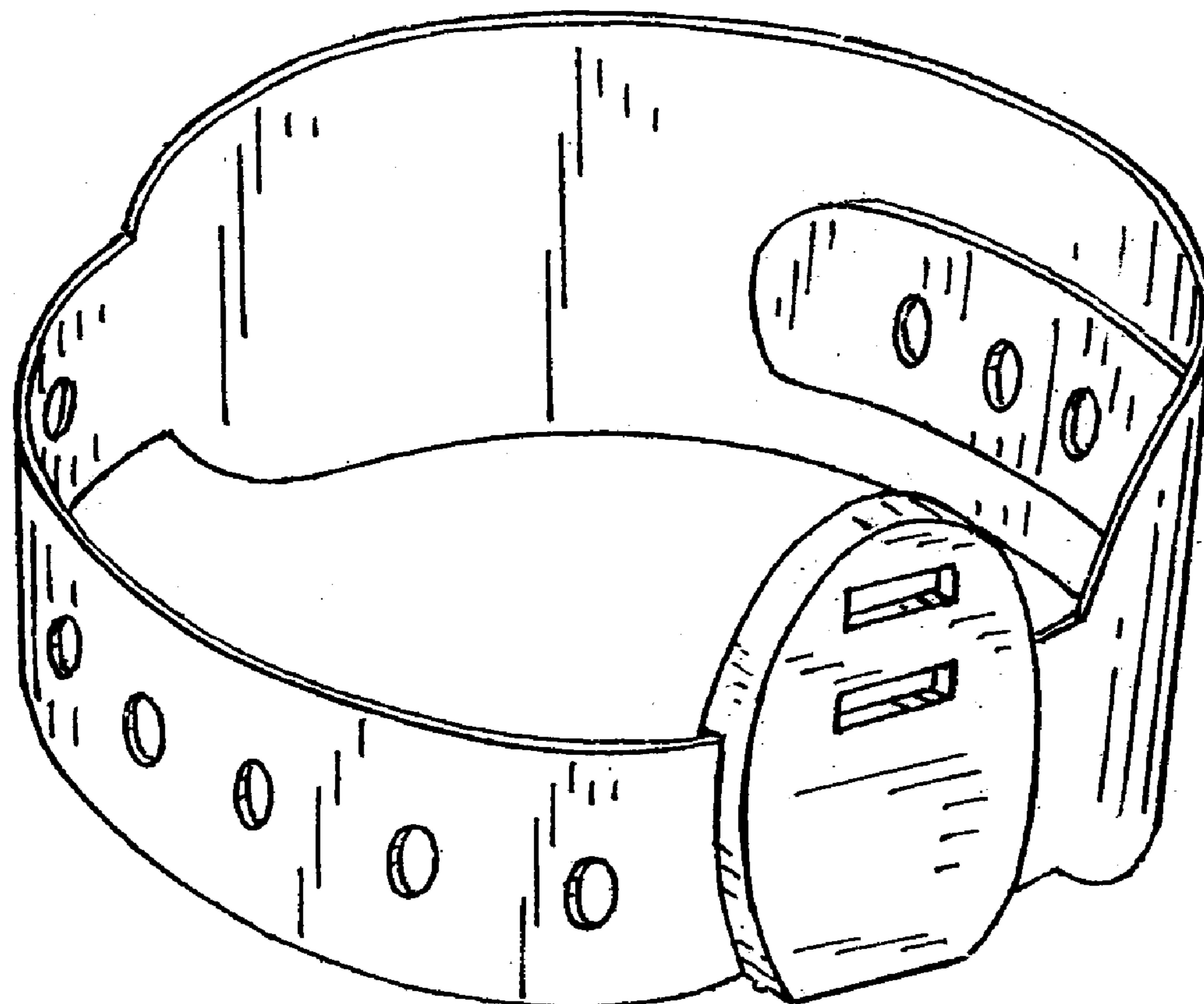
(57) **CLAIM**

The ornamental design for a combination wristband and clasp, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, perspective view of a combination wristband and clasp, showing my new design;  
FIG. 2 is a bottom, rear perspective view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a view thereof showing the front side of the clasp with the wristband removed for ease of illustration;  
FIG. 6 is a rear view thereof showing the side of the clasp;  
FIG. 7 is a top view thereof;  
FIG. 8 is a bottom view thereof;  
FIG. 9 is one side view thereof; and,  
FIG. 10 is the opposite side view thereof.

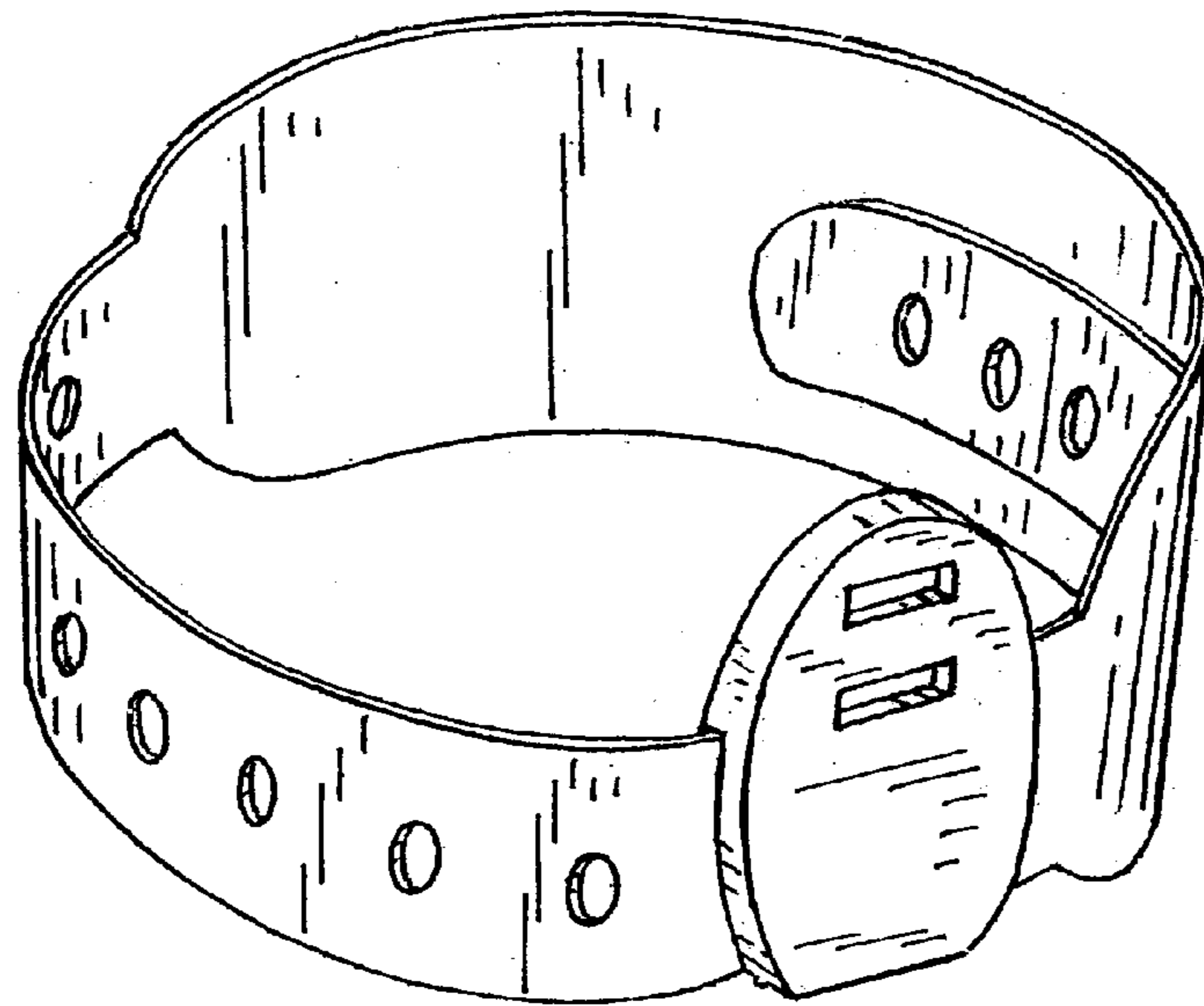

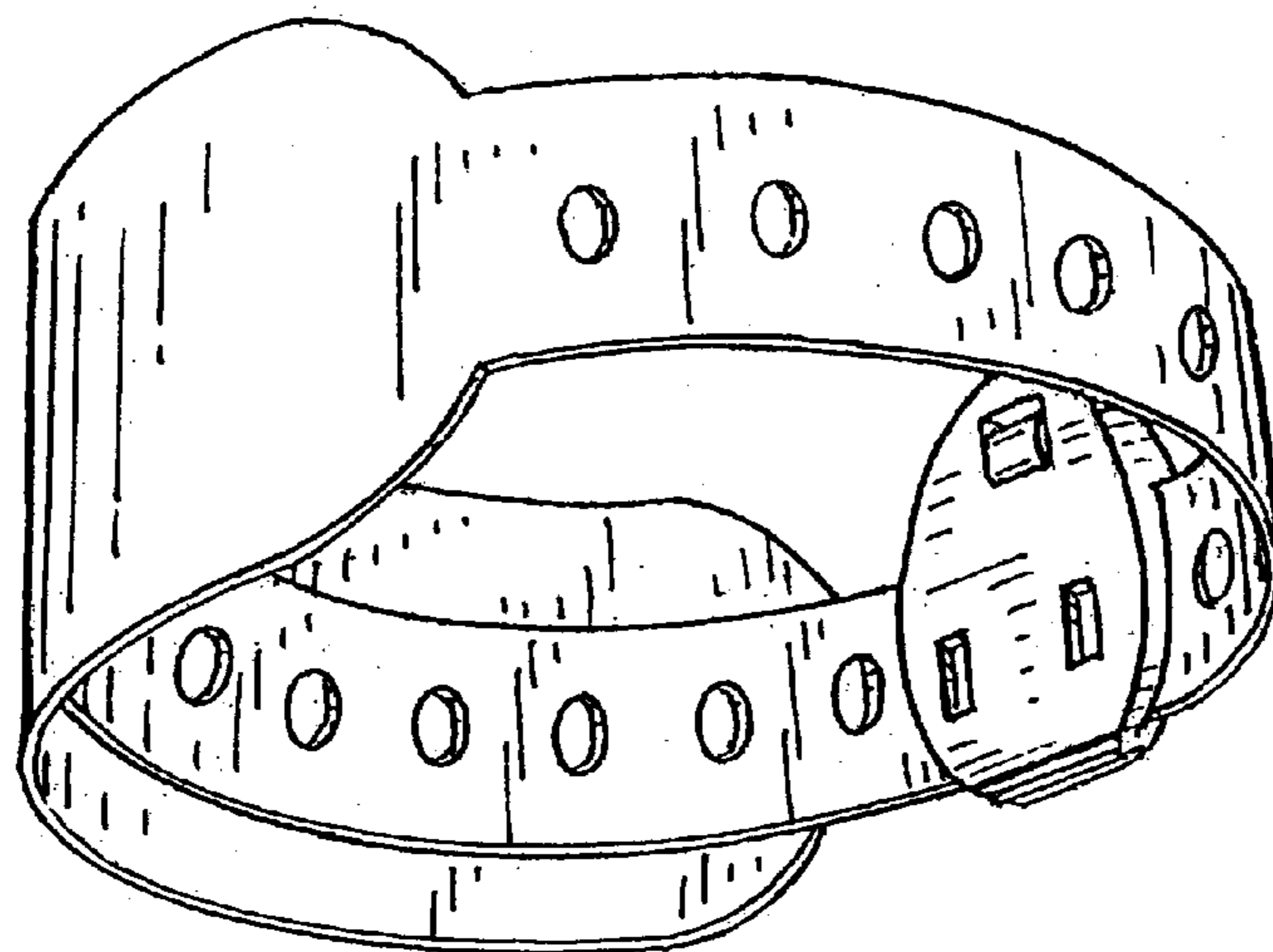

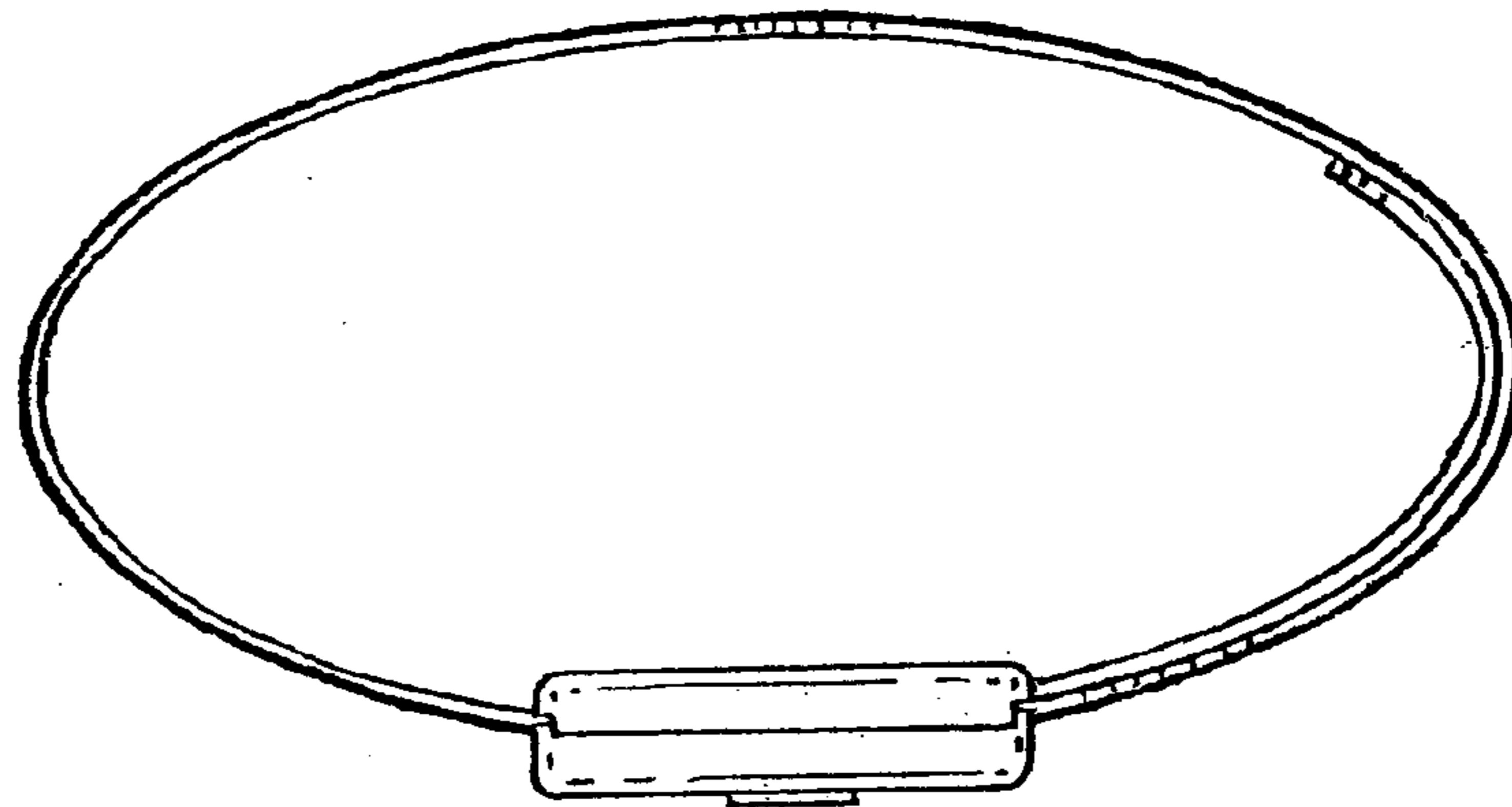

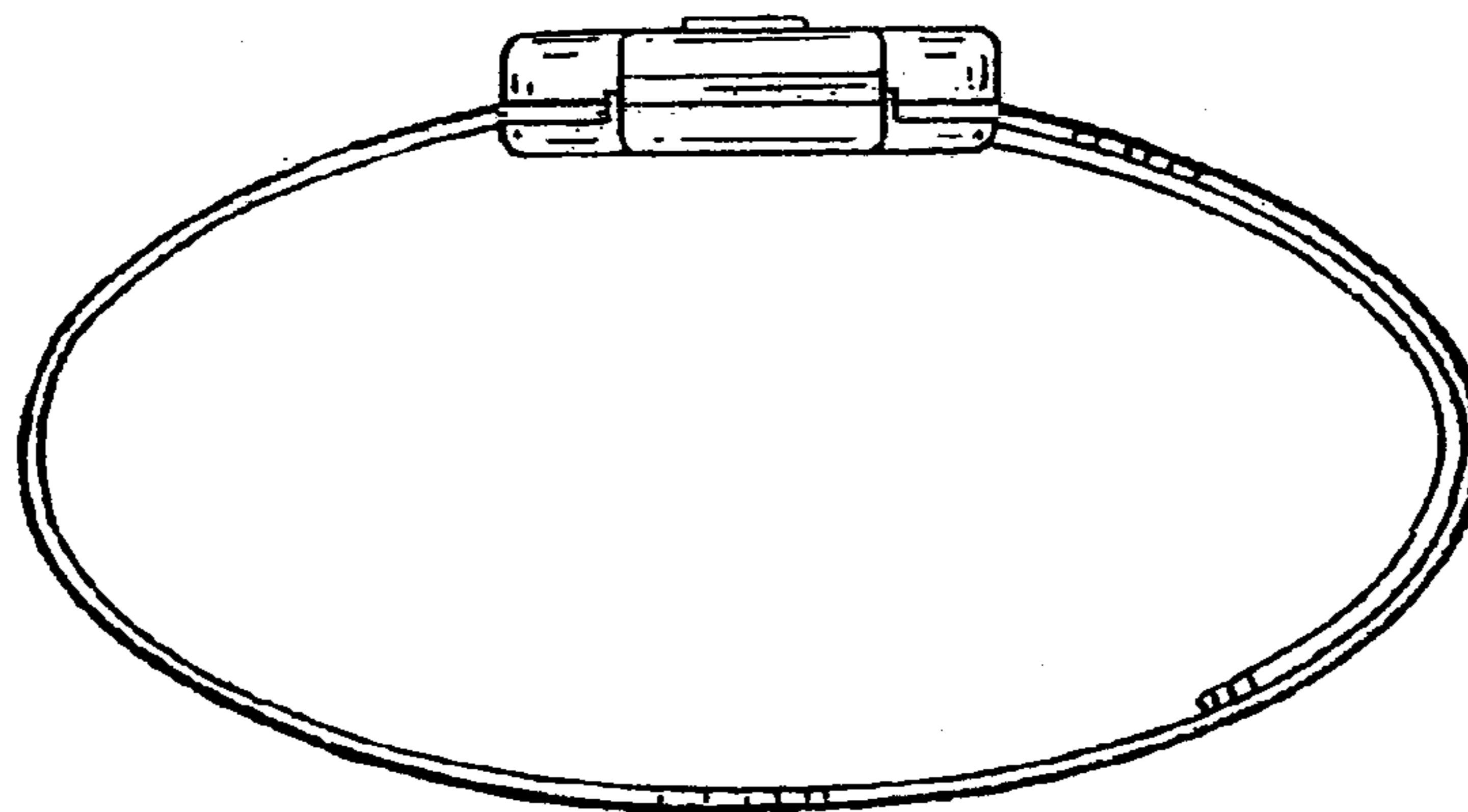

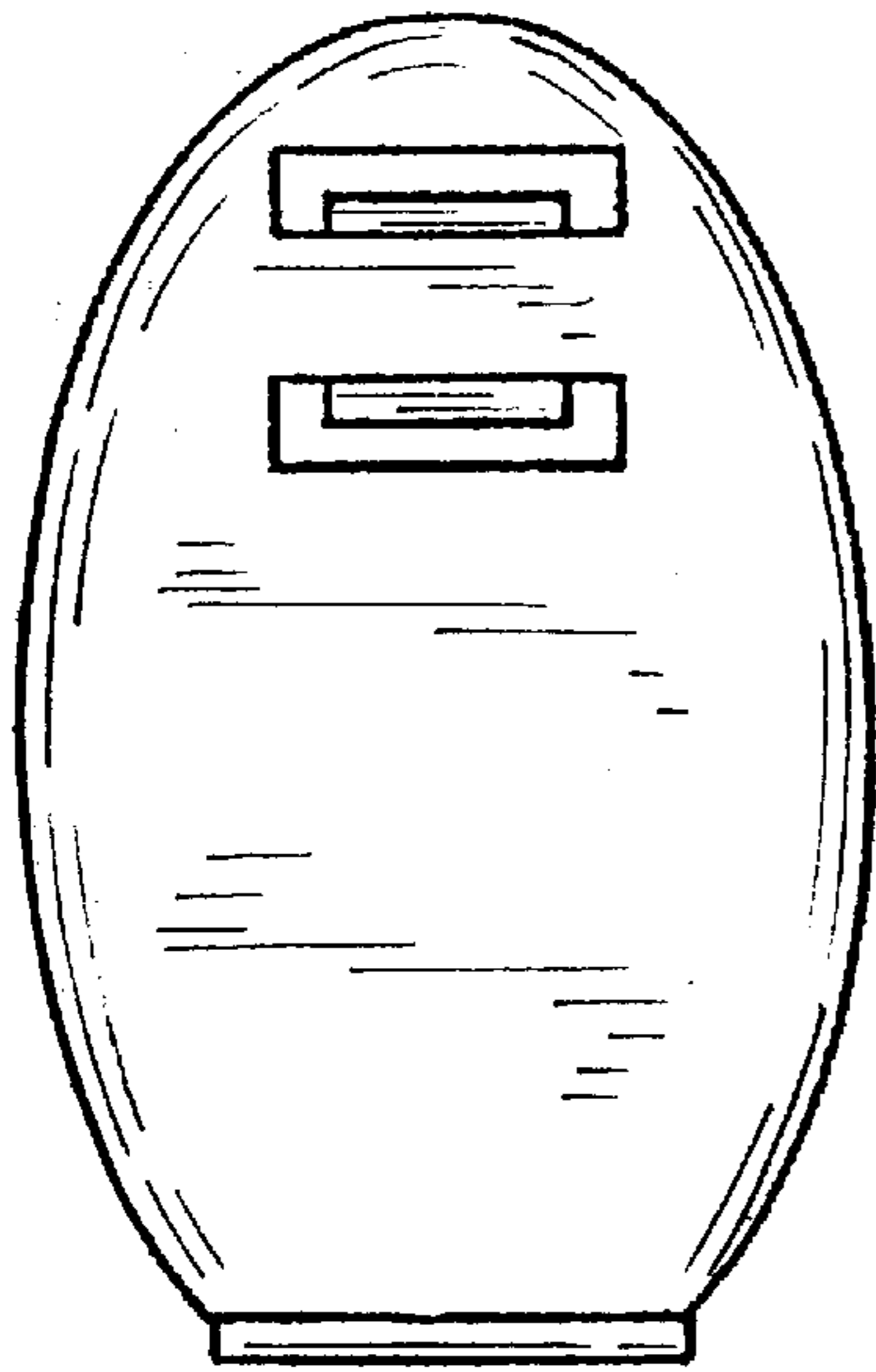

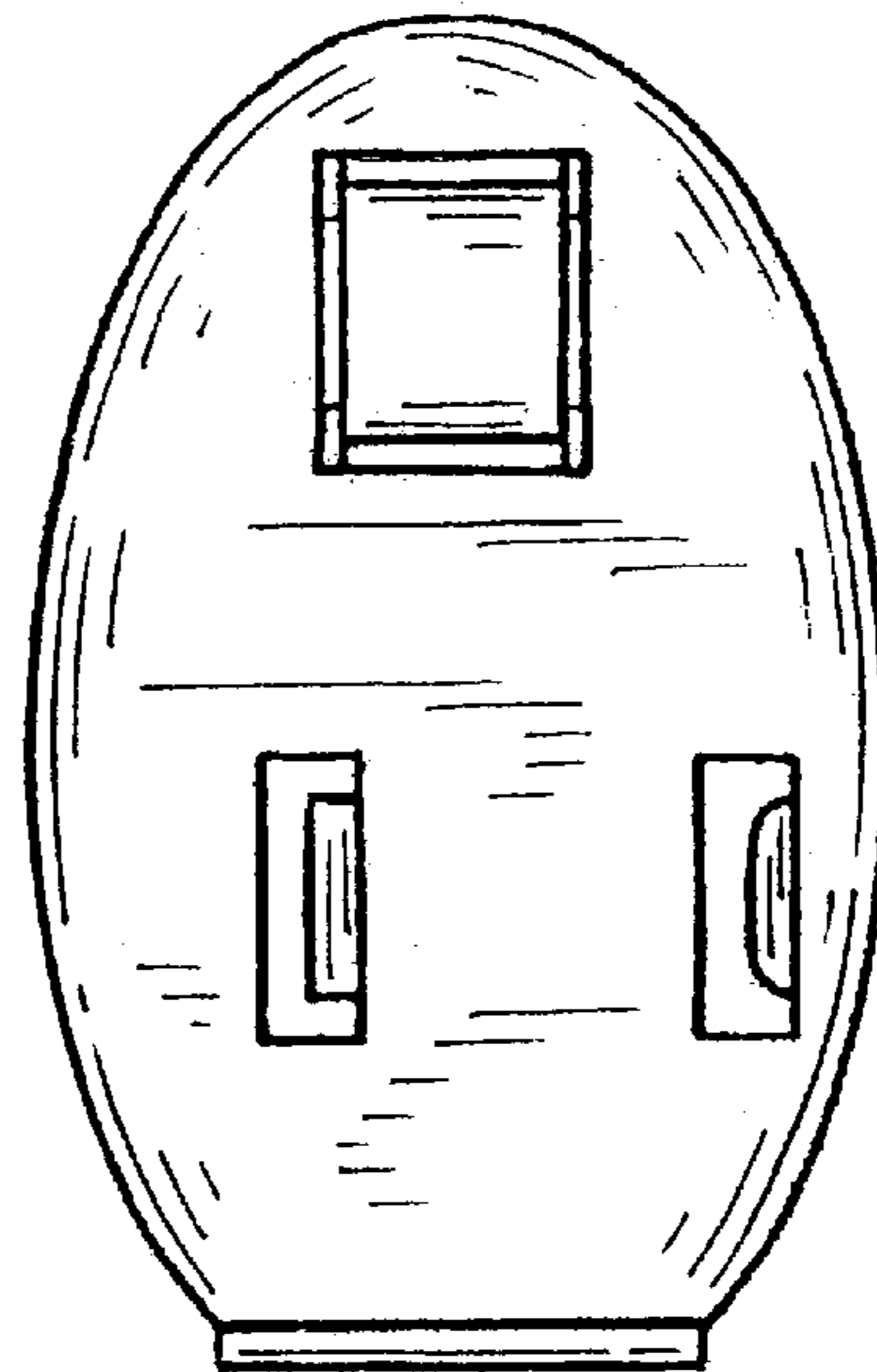

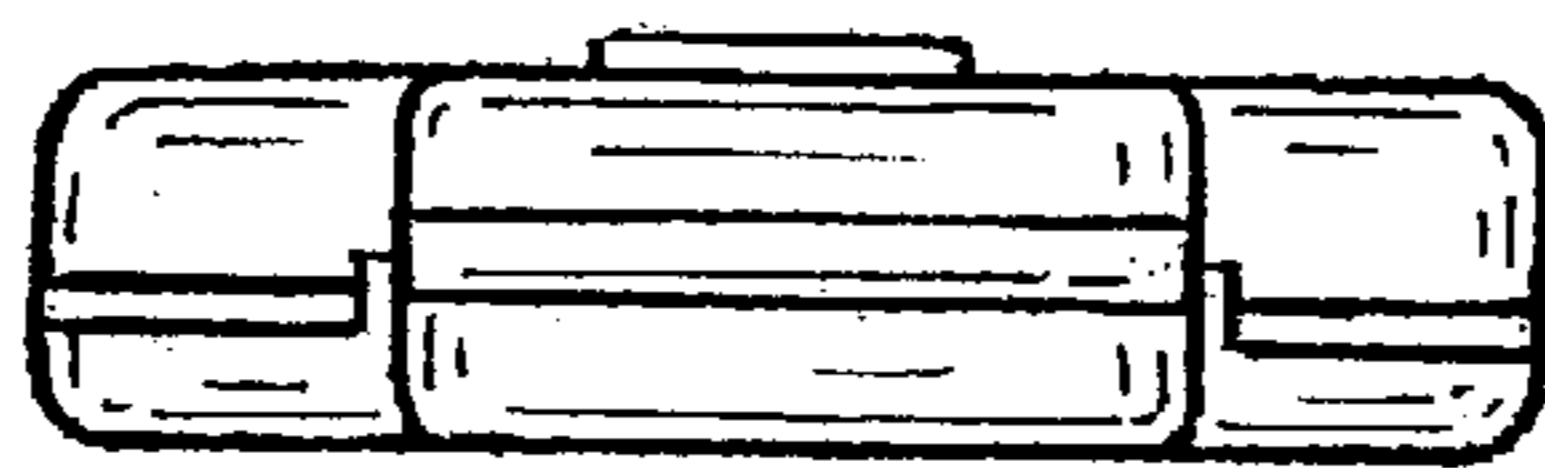
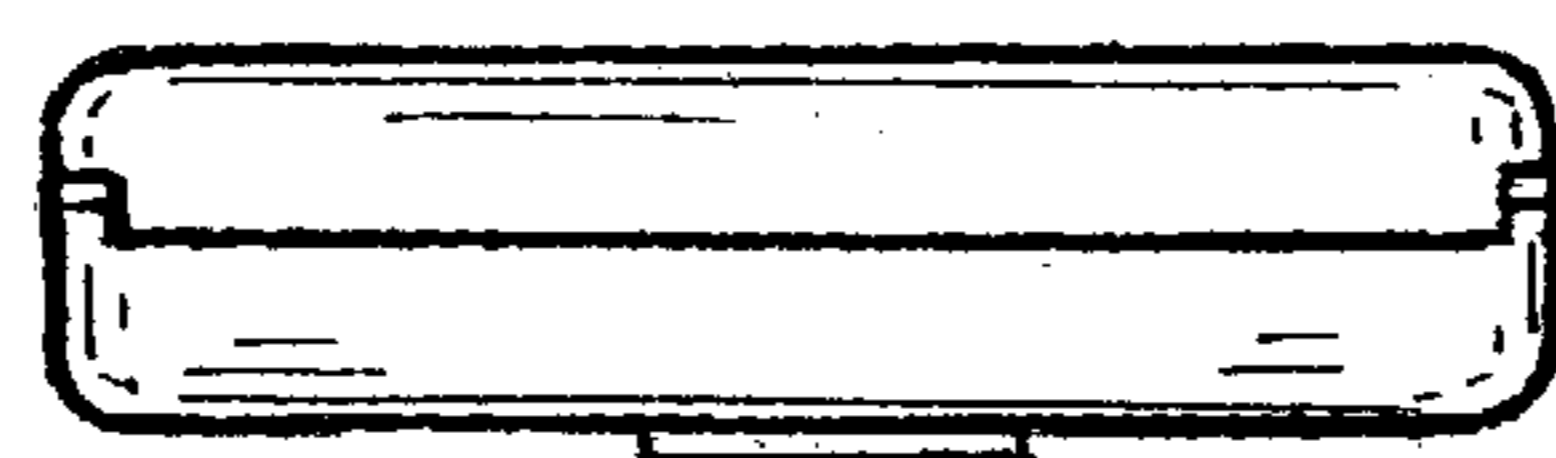
