(57) **CLAIM**

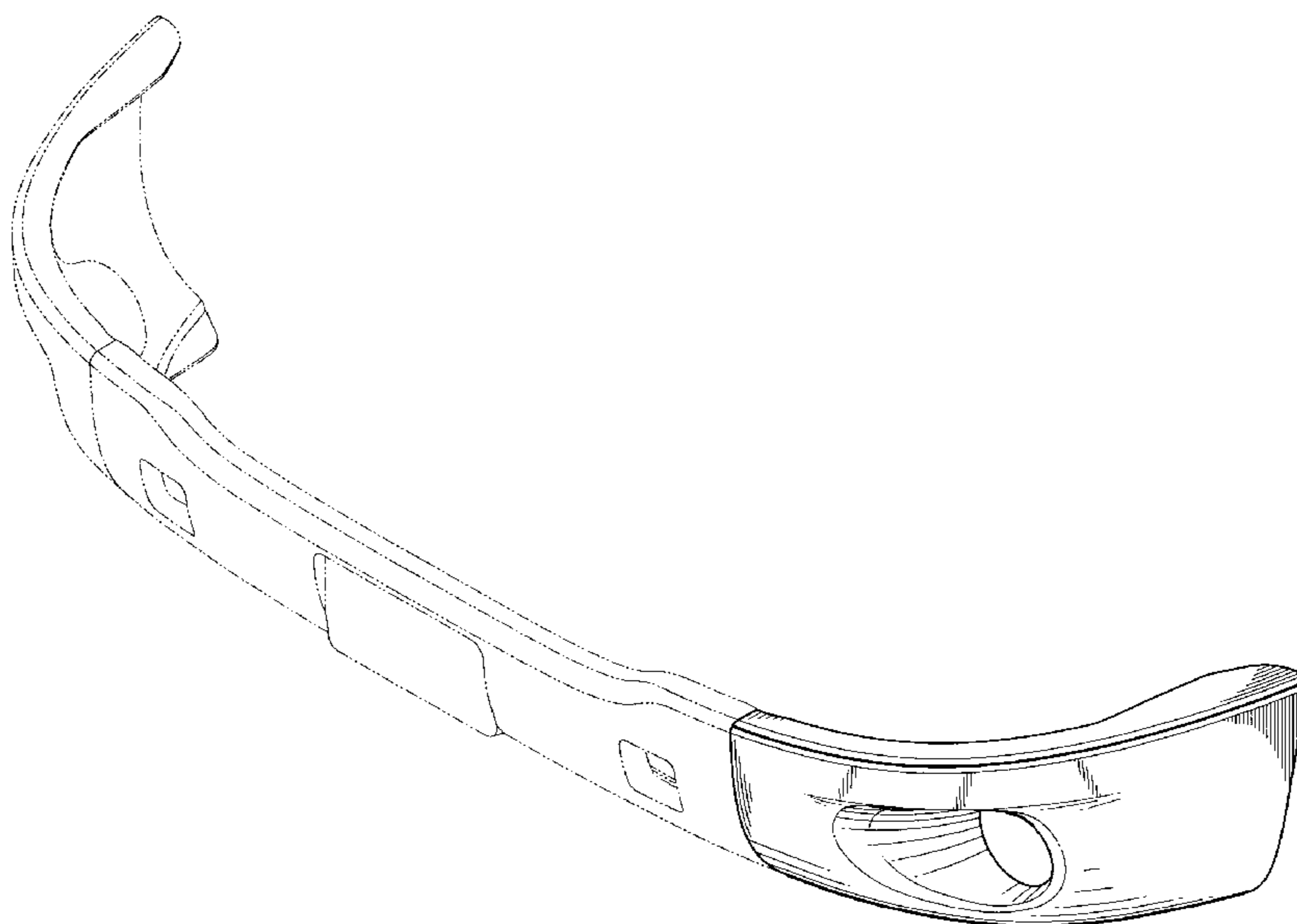
The ornamental design for a vehicle side bumper, as shown

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of
a vehicle side bumper showing our new design;
FIG. 2 is a front elevational view thereof;

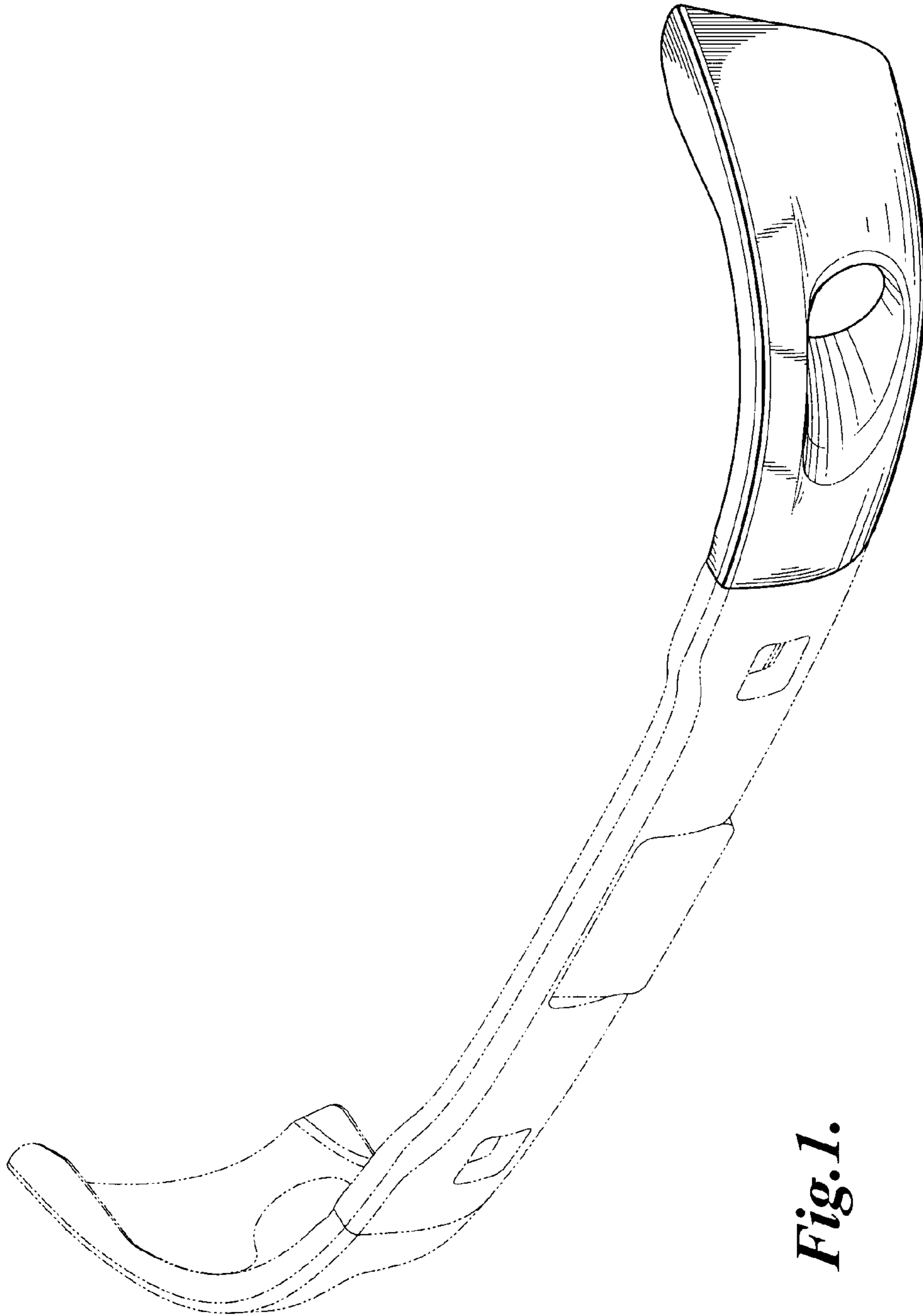

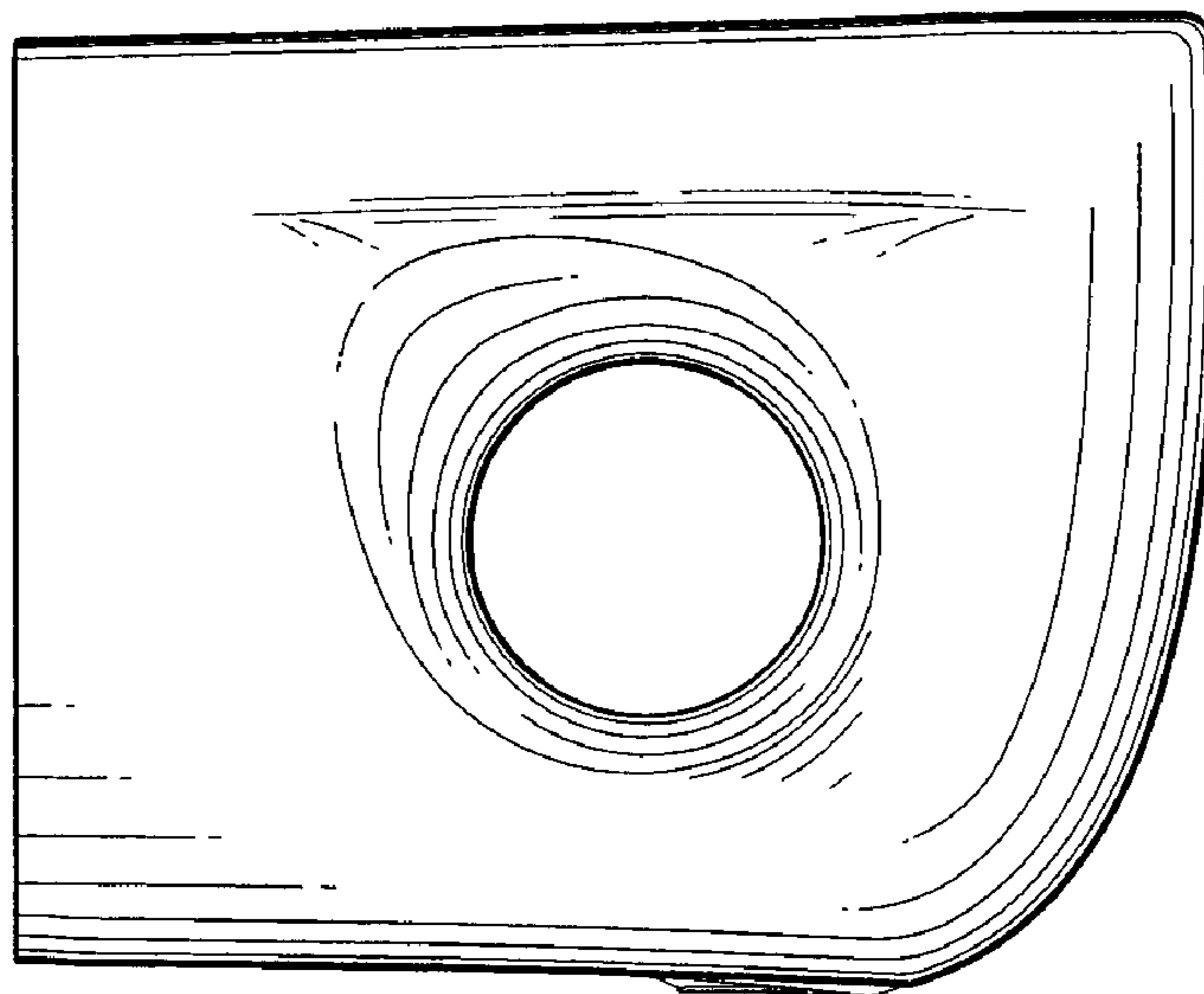

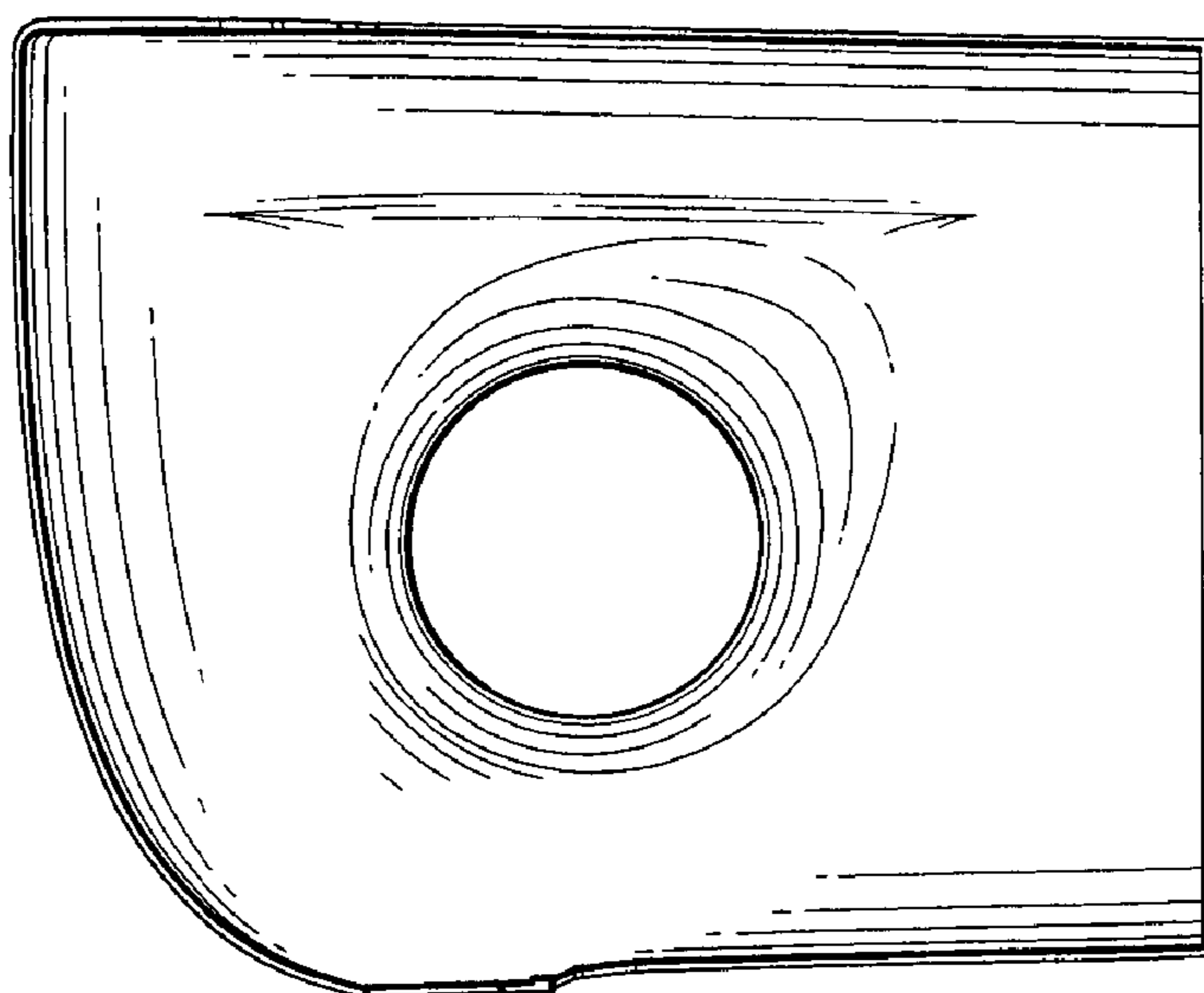

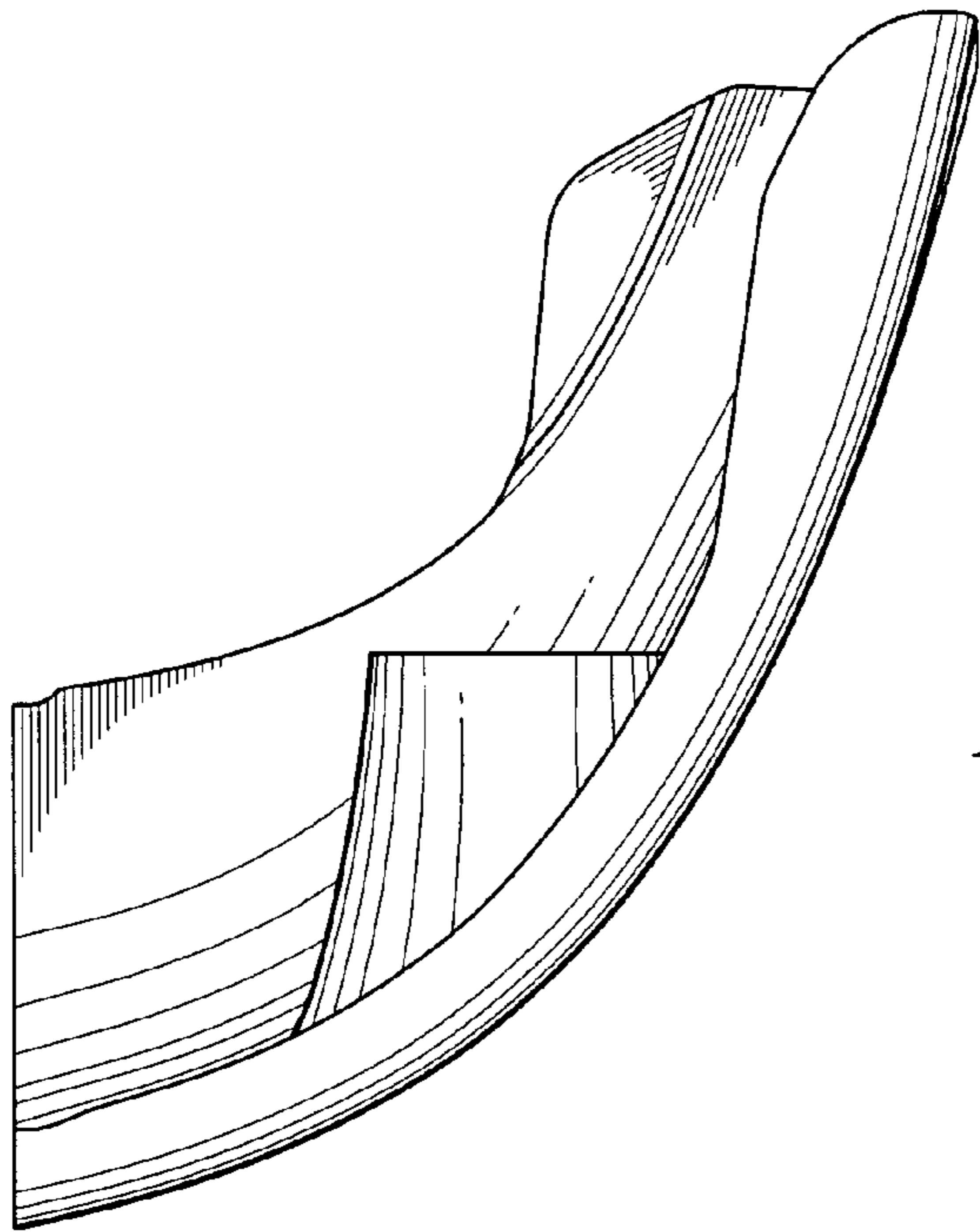

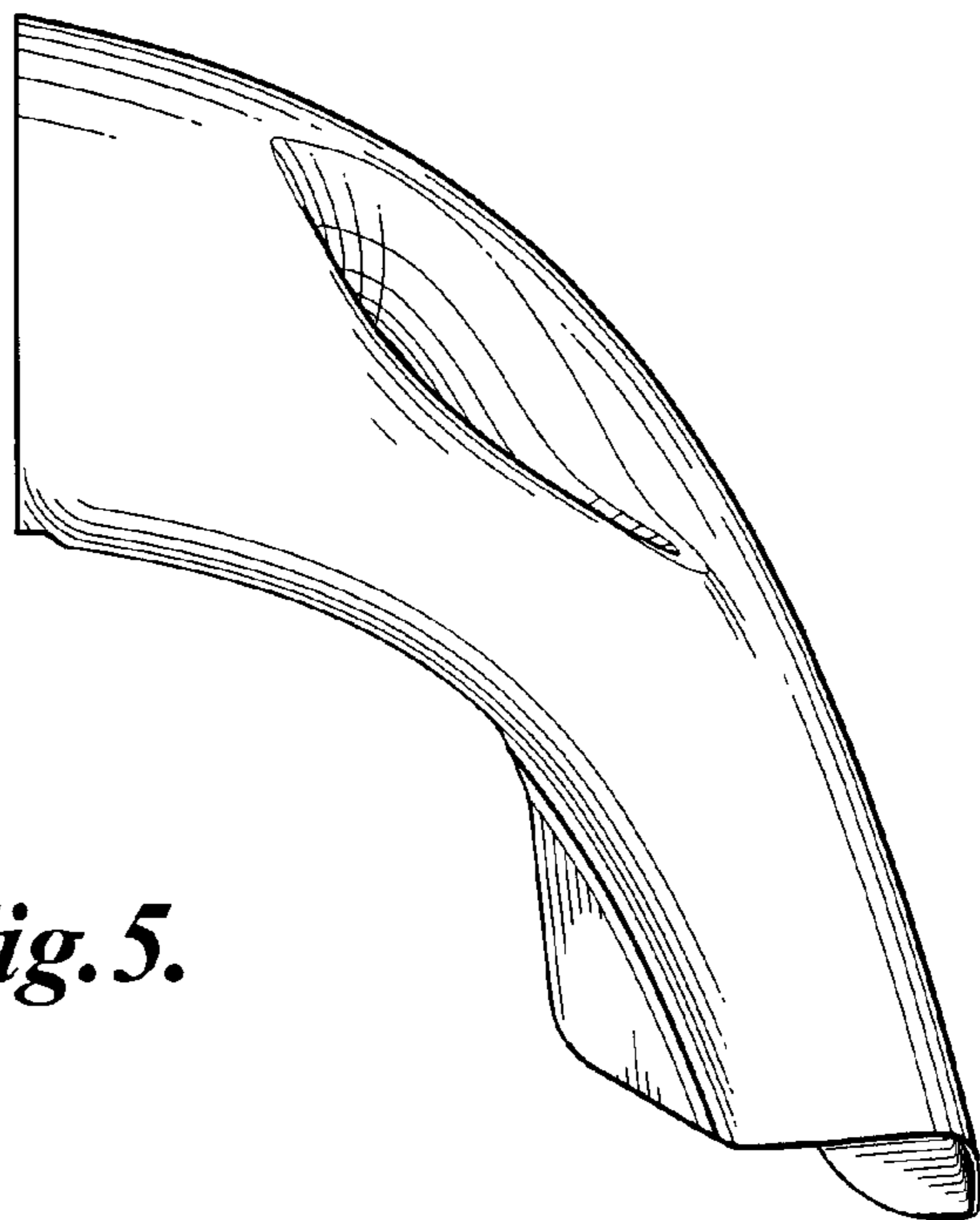

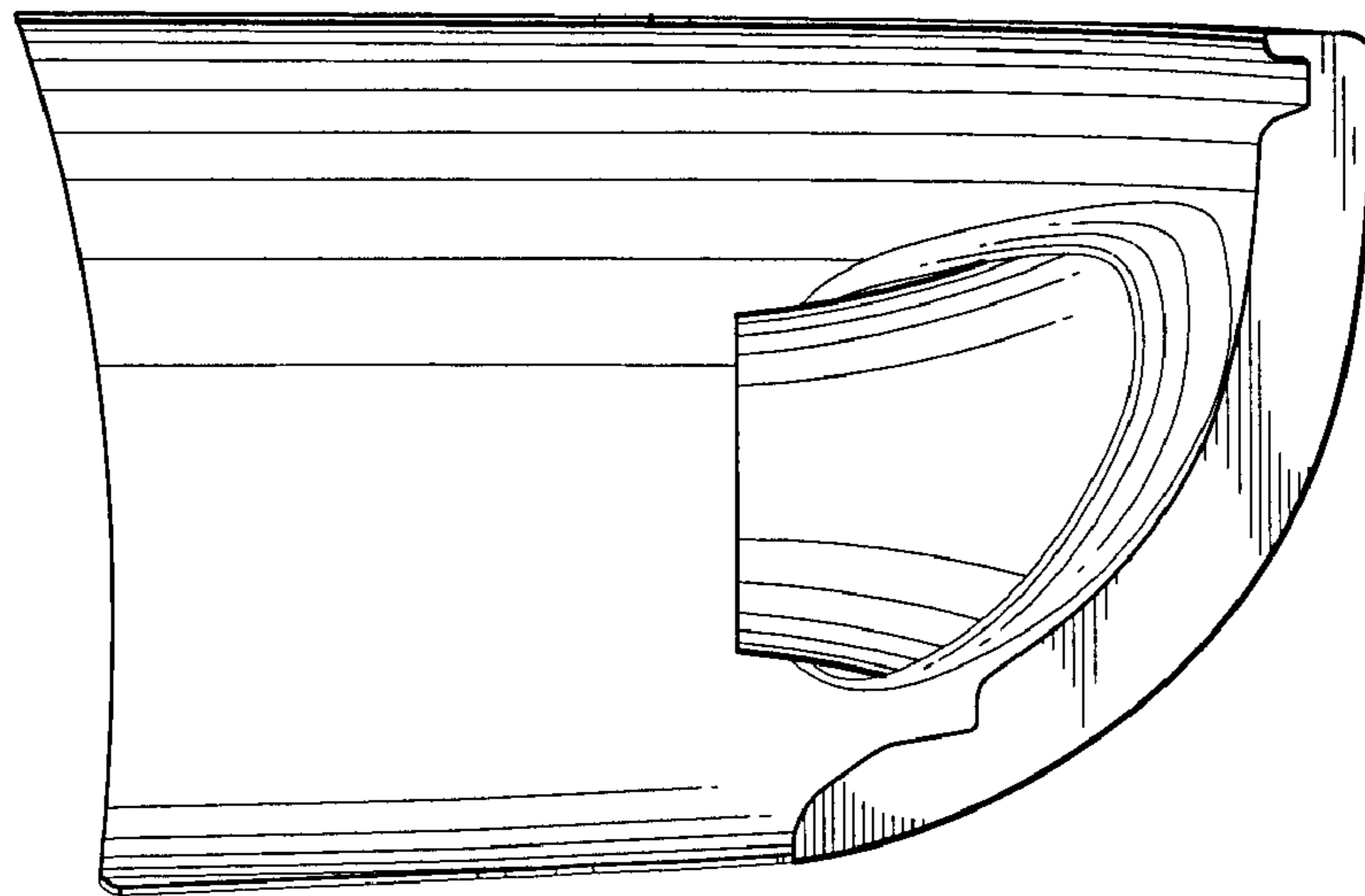

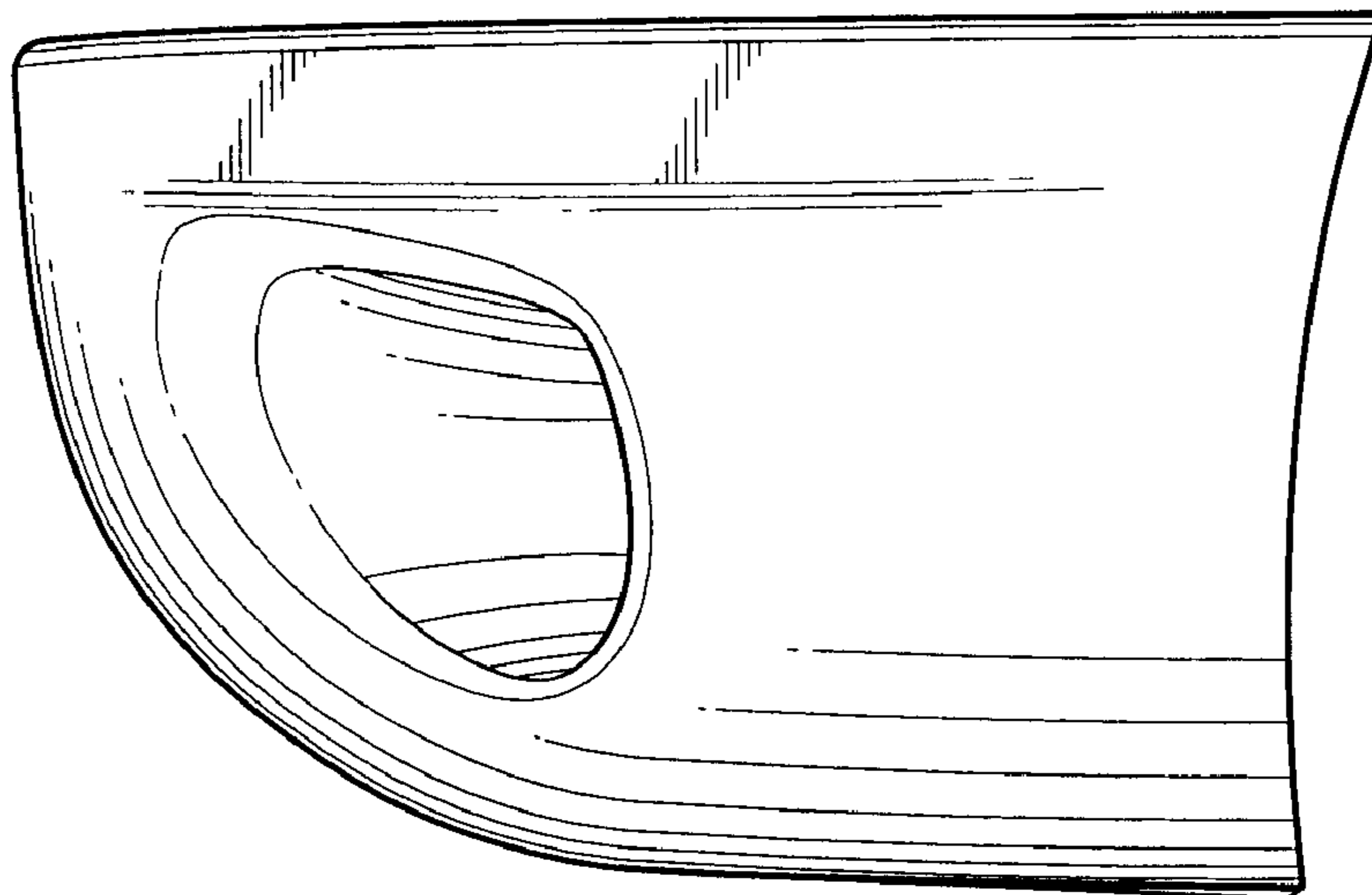

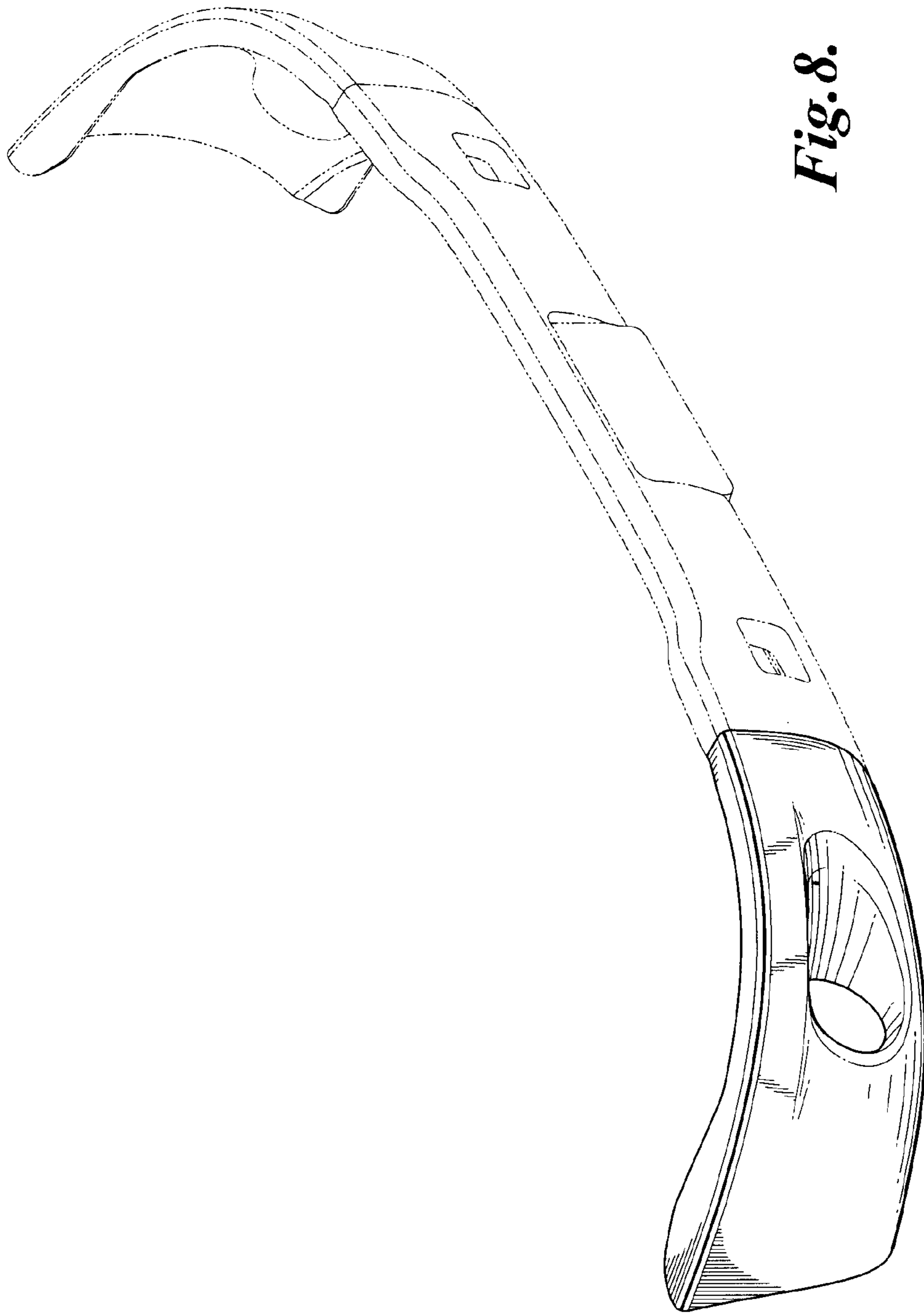

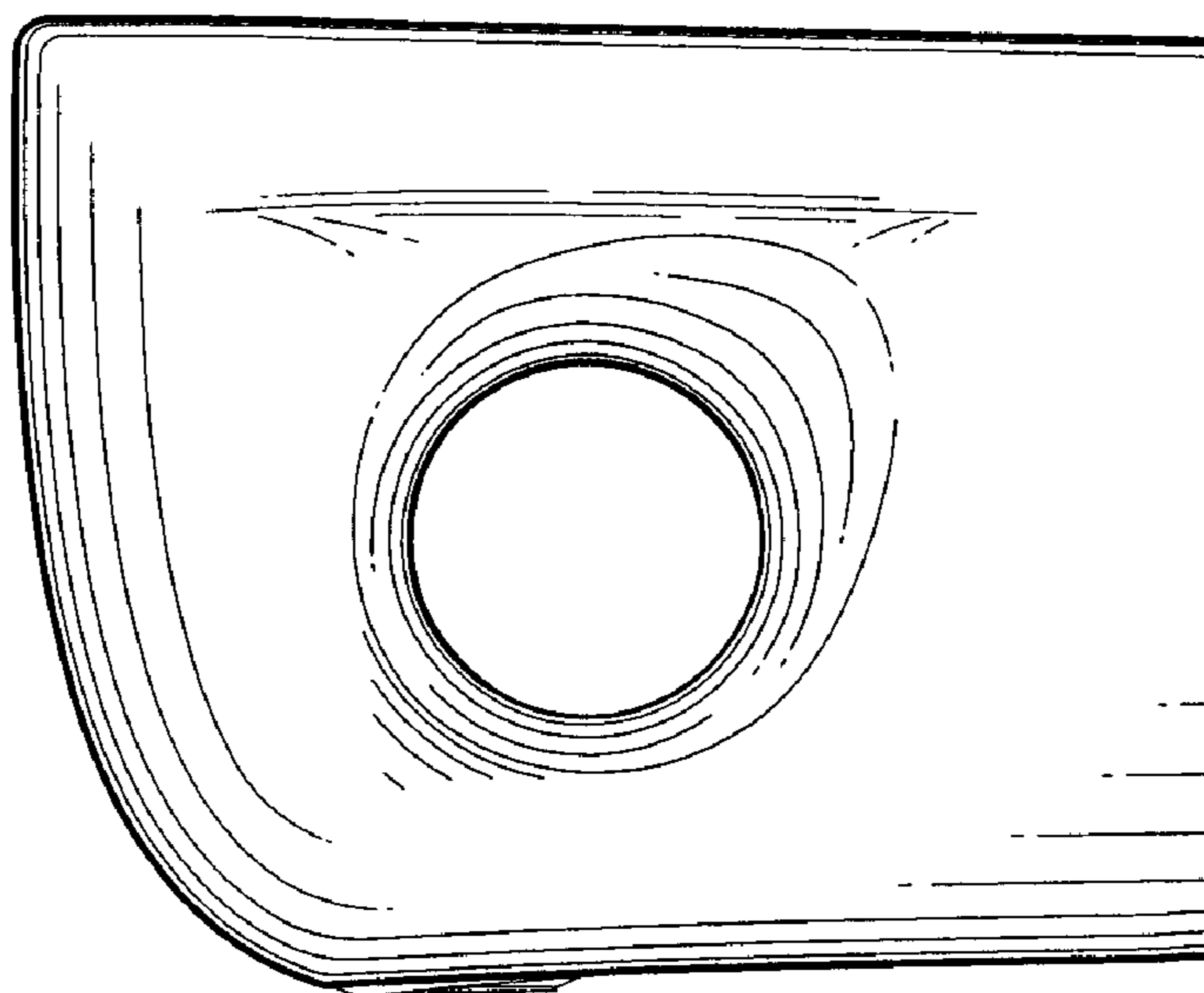

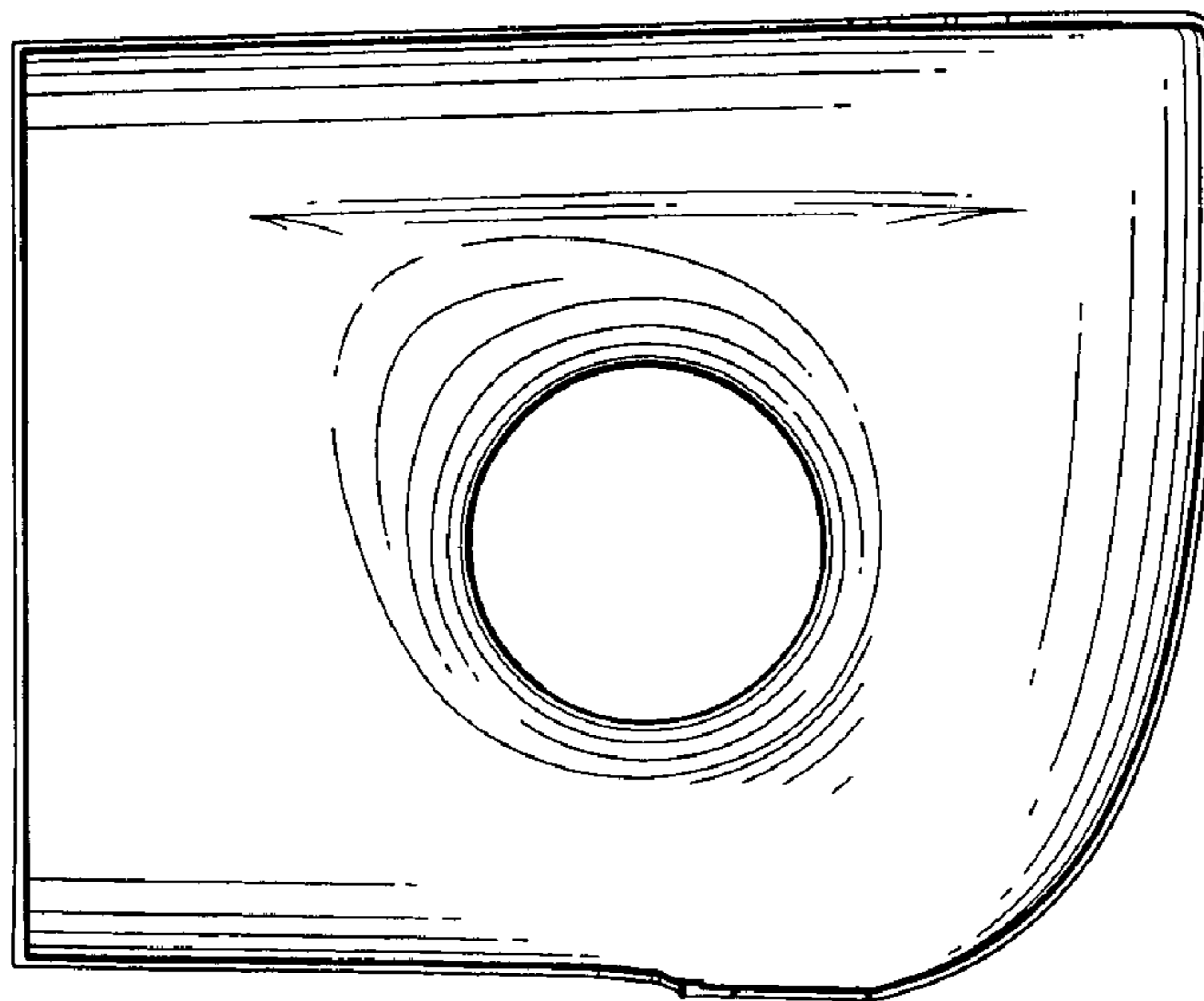

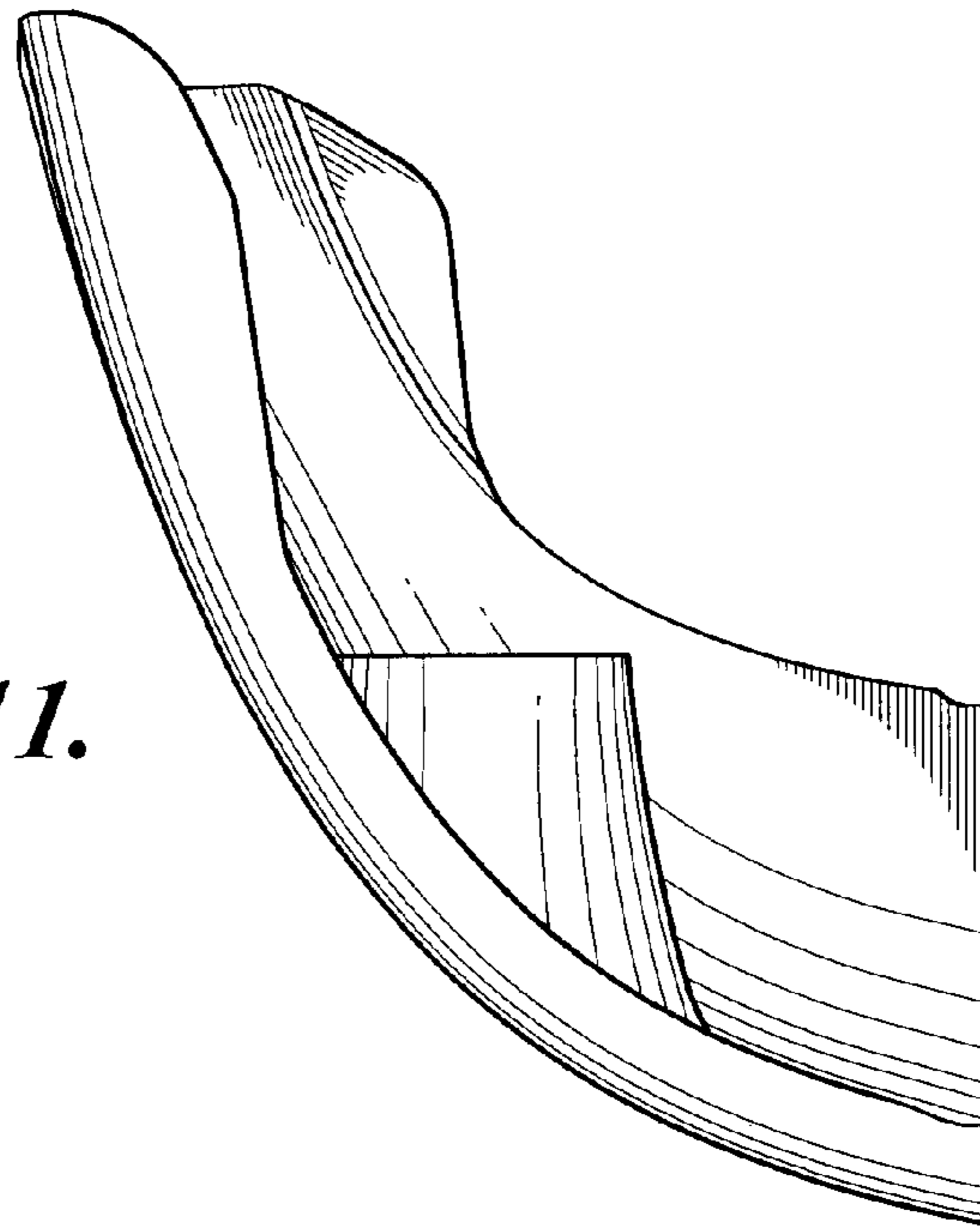
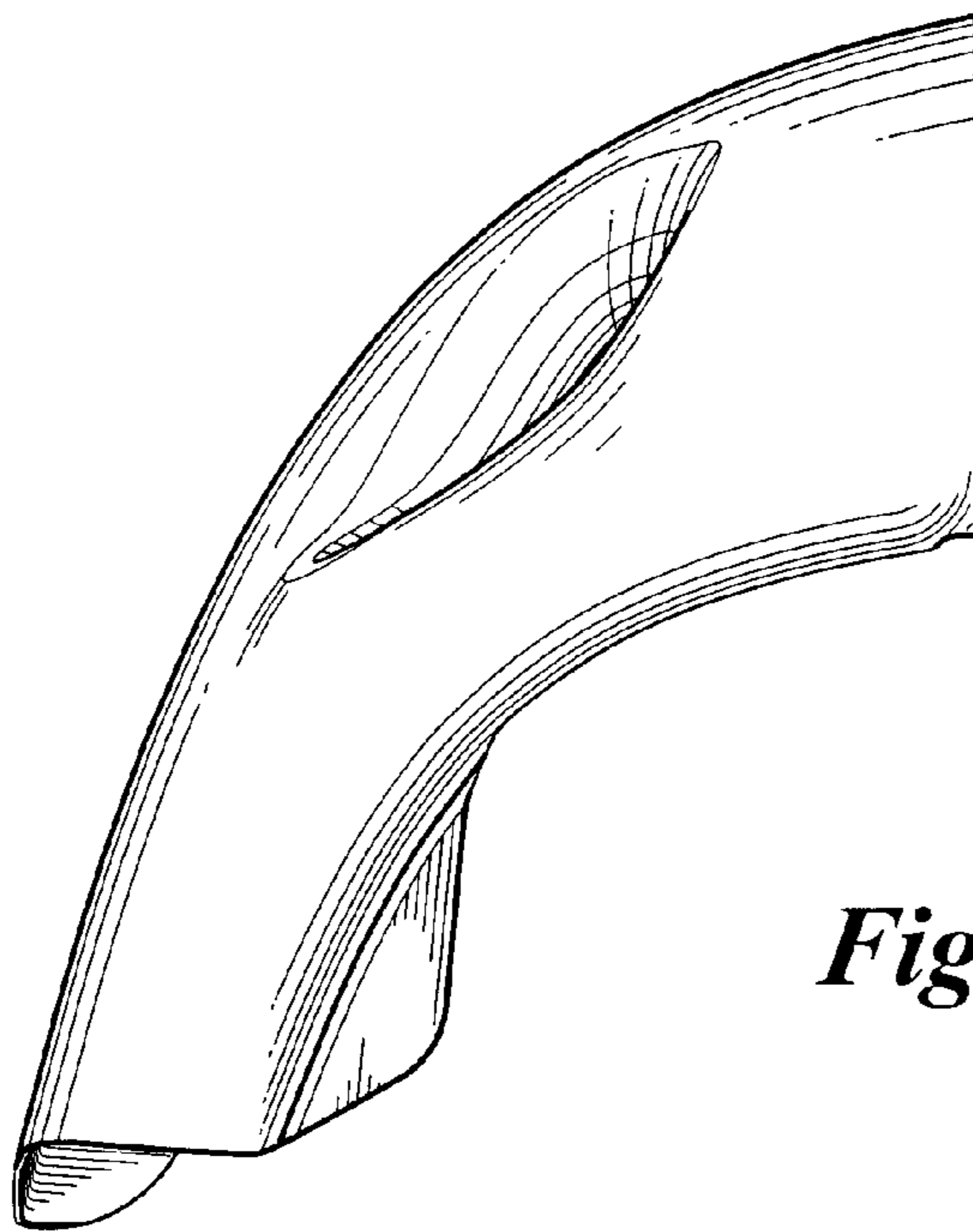

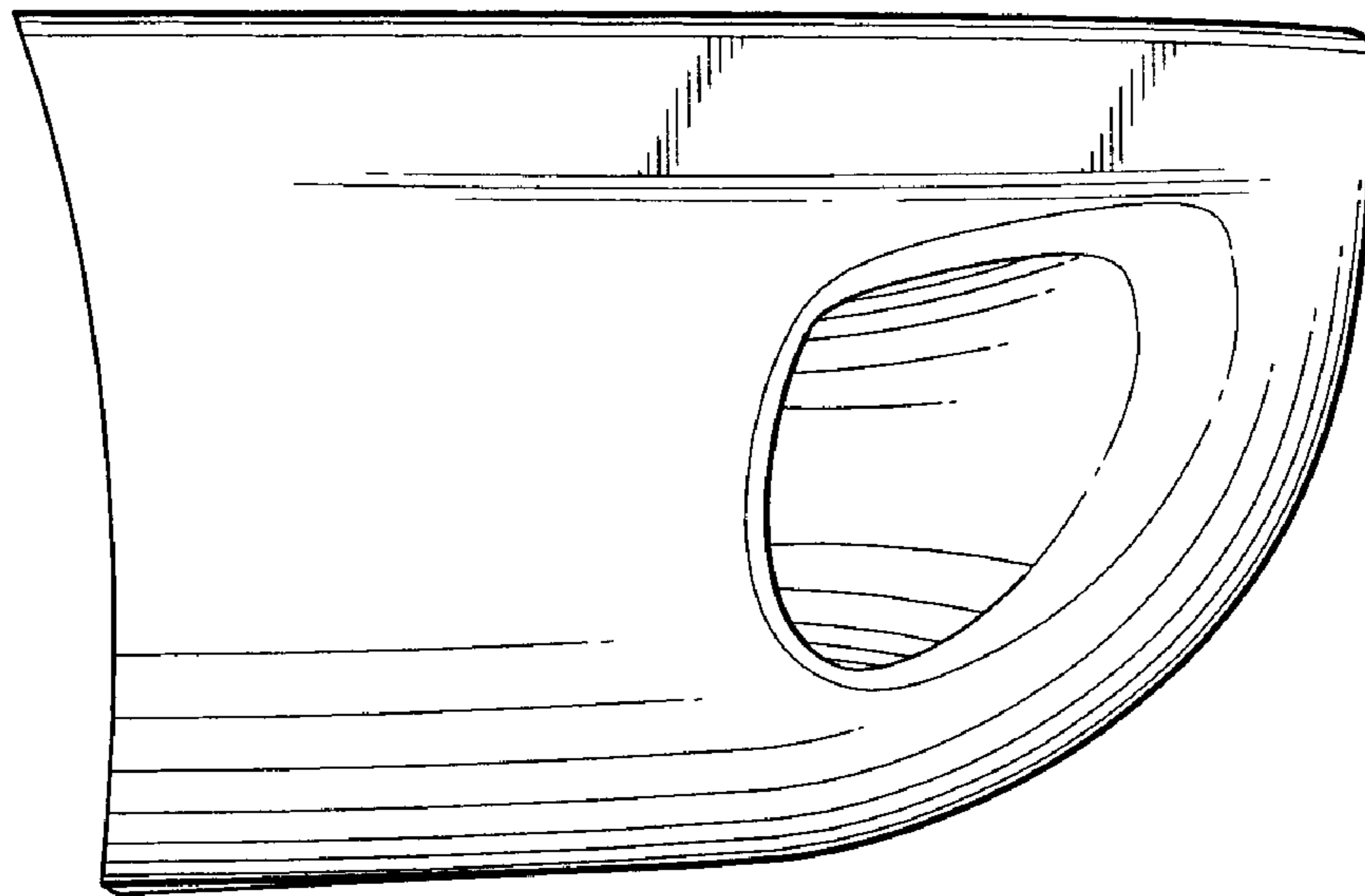

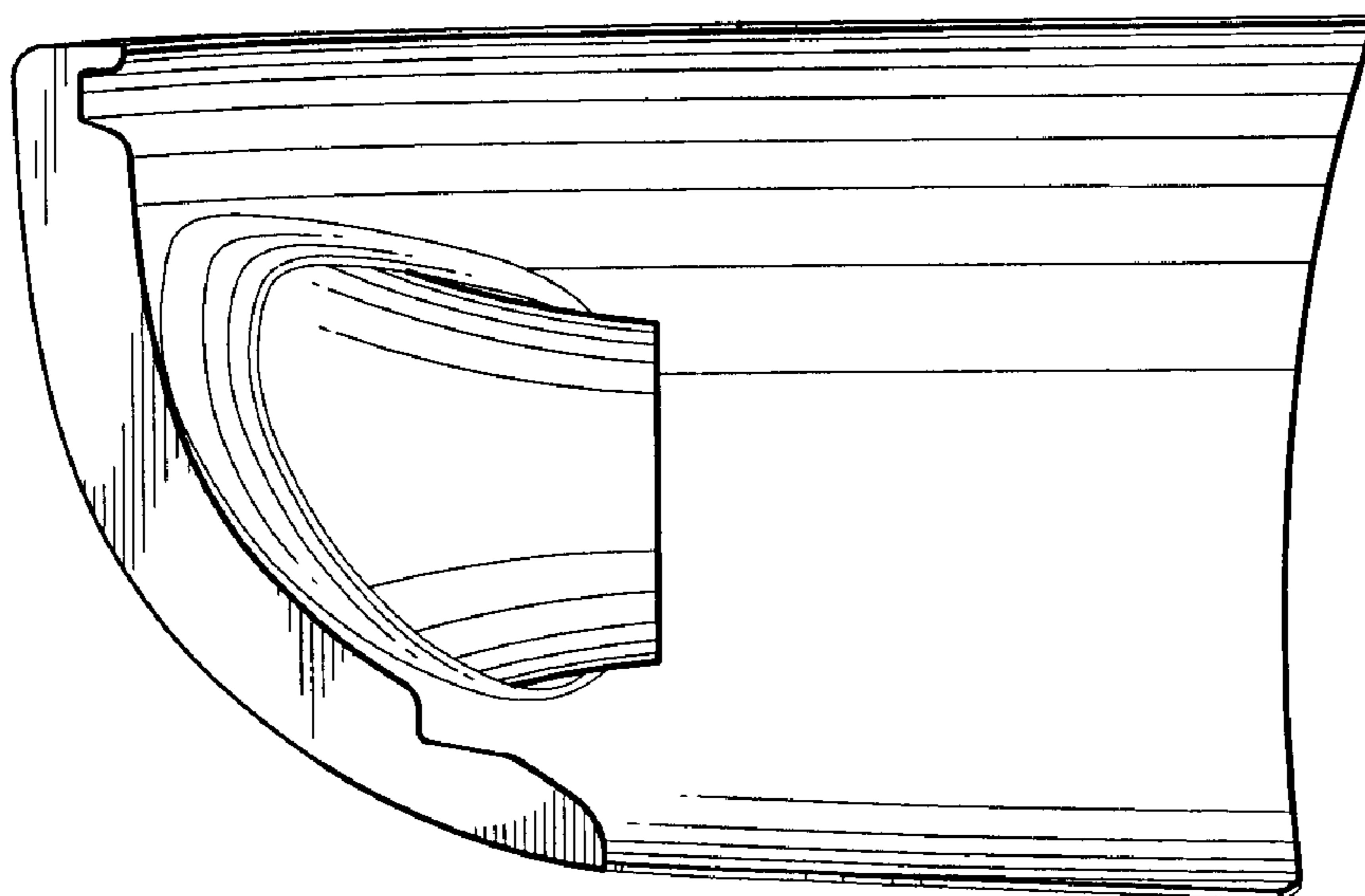
