We claim the ornamental design for a combined digital video disc recorder and video tape recorder, as shown.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a combined digital video disc recorder and video tape recorder showing our new design;

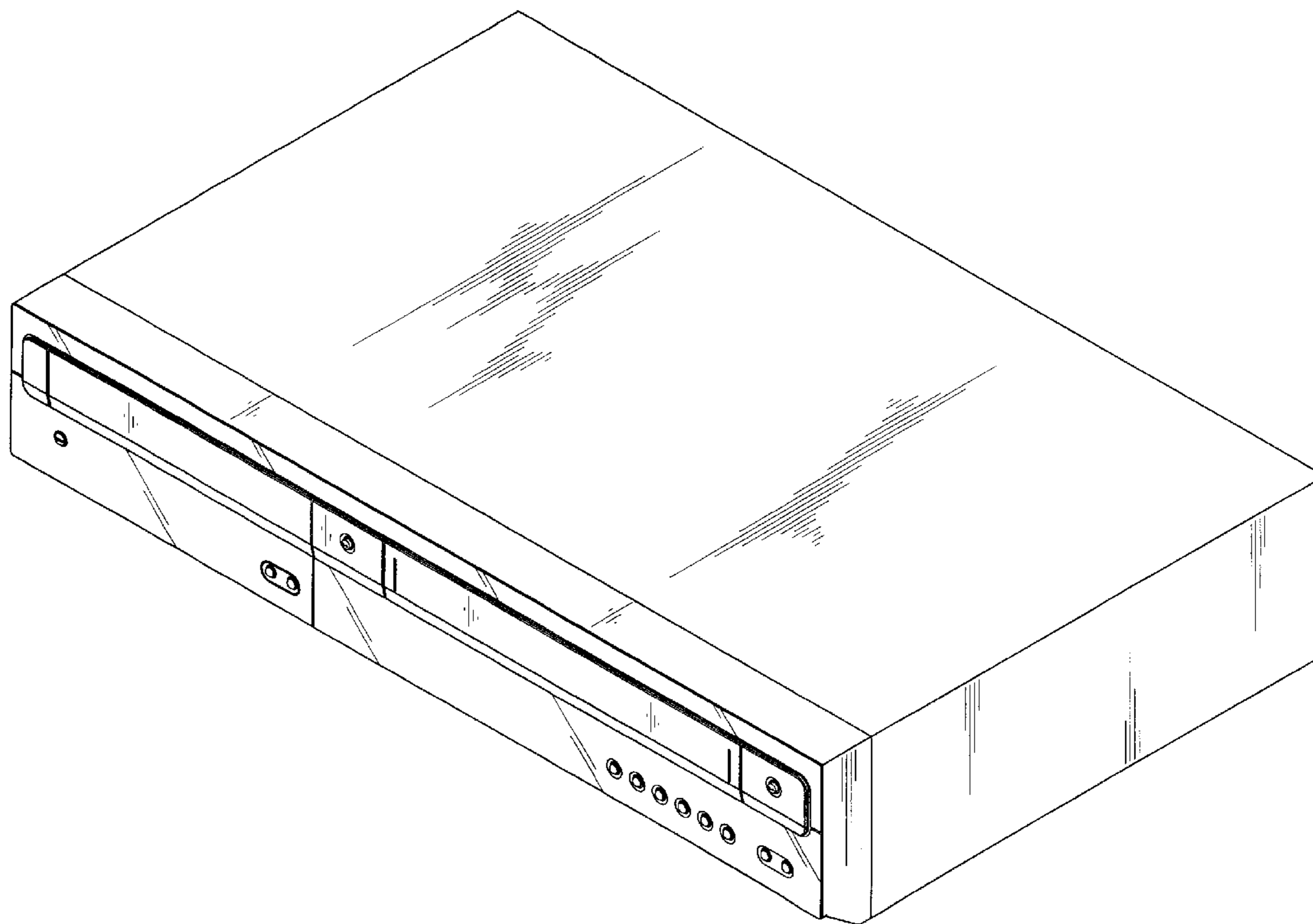

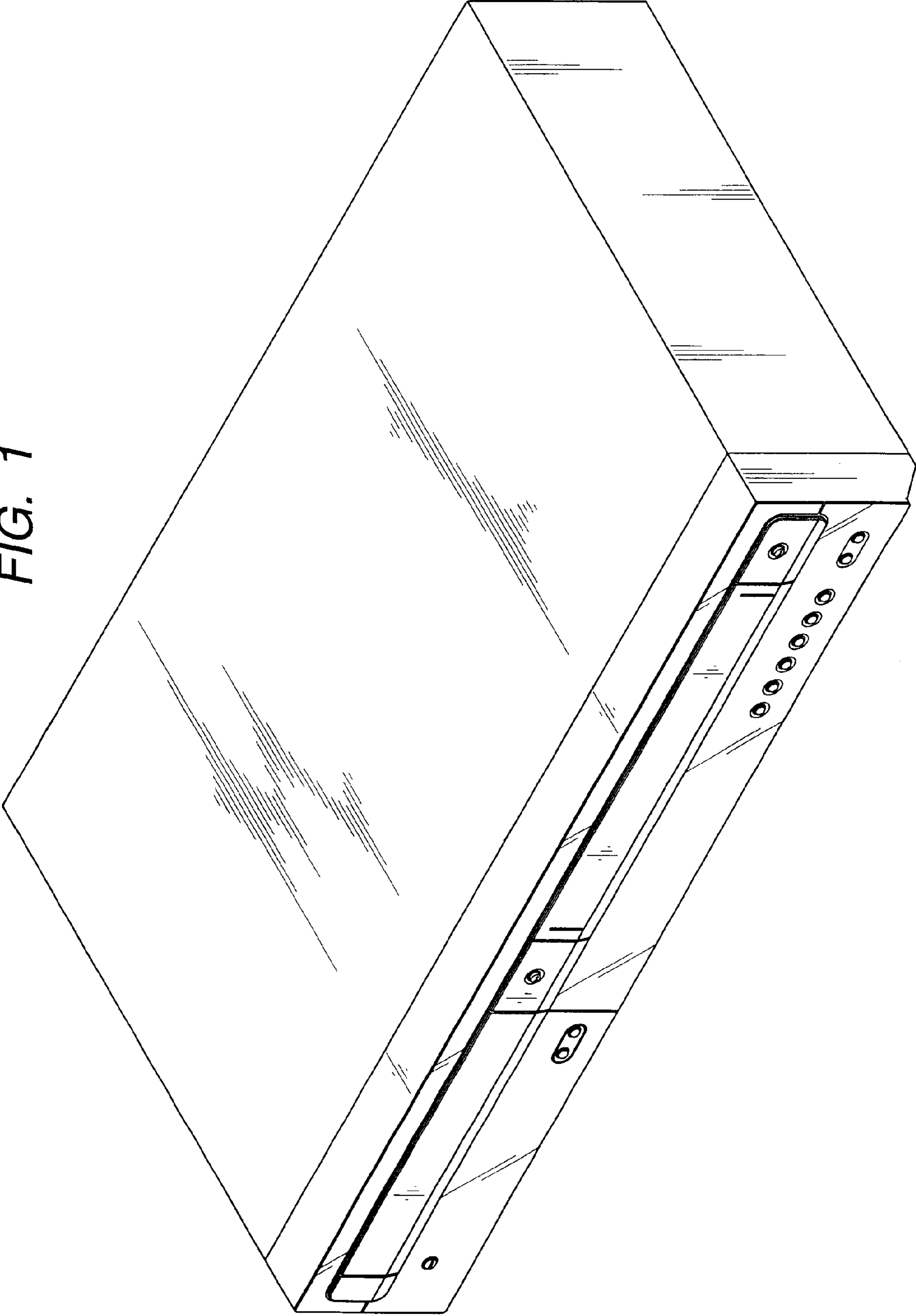

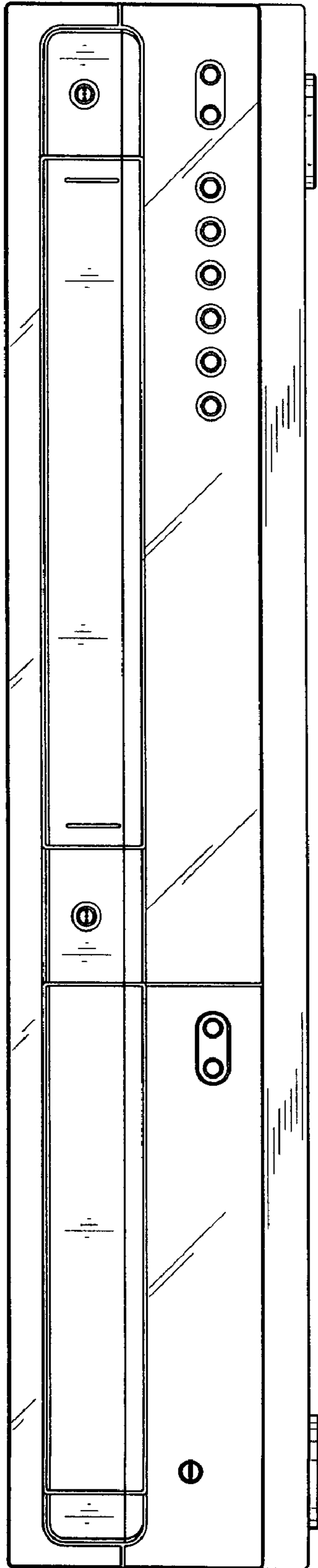
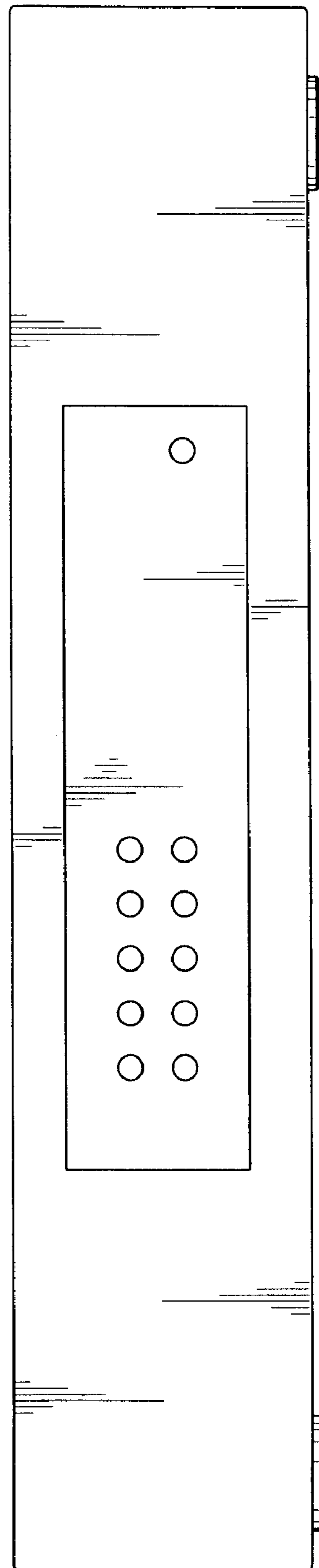
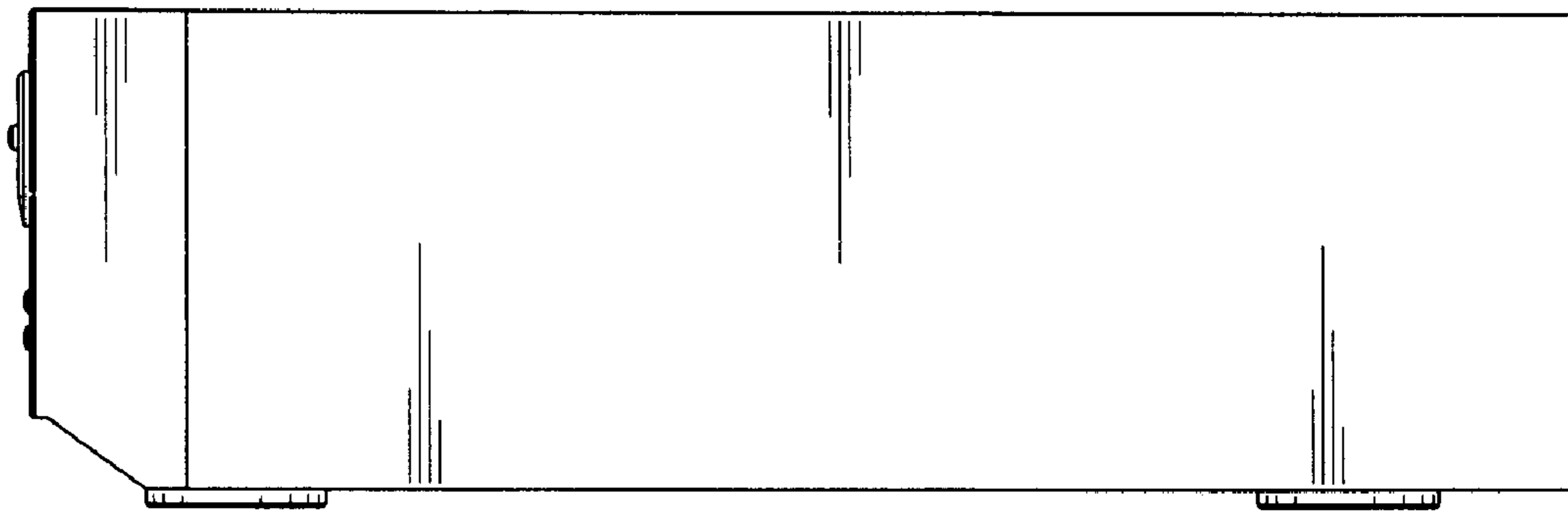

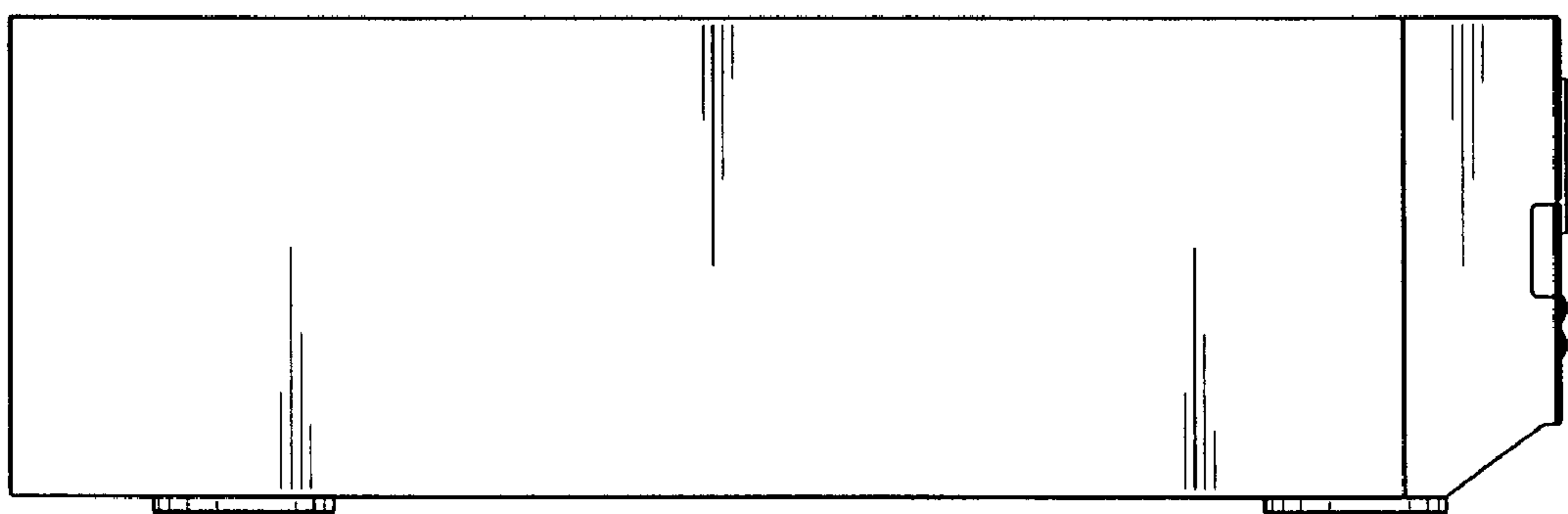

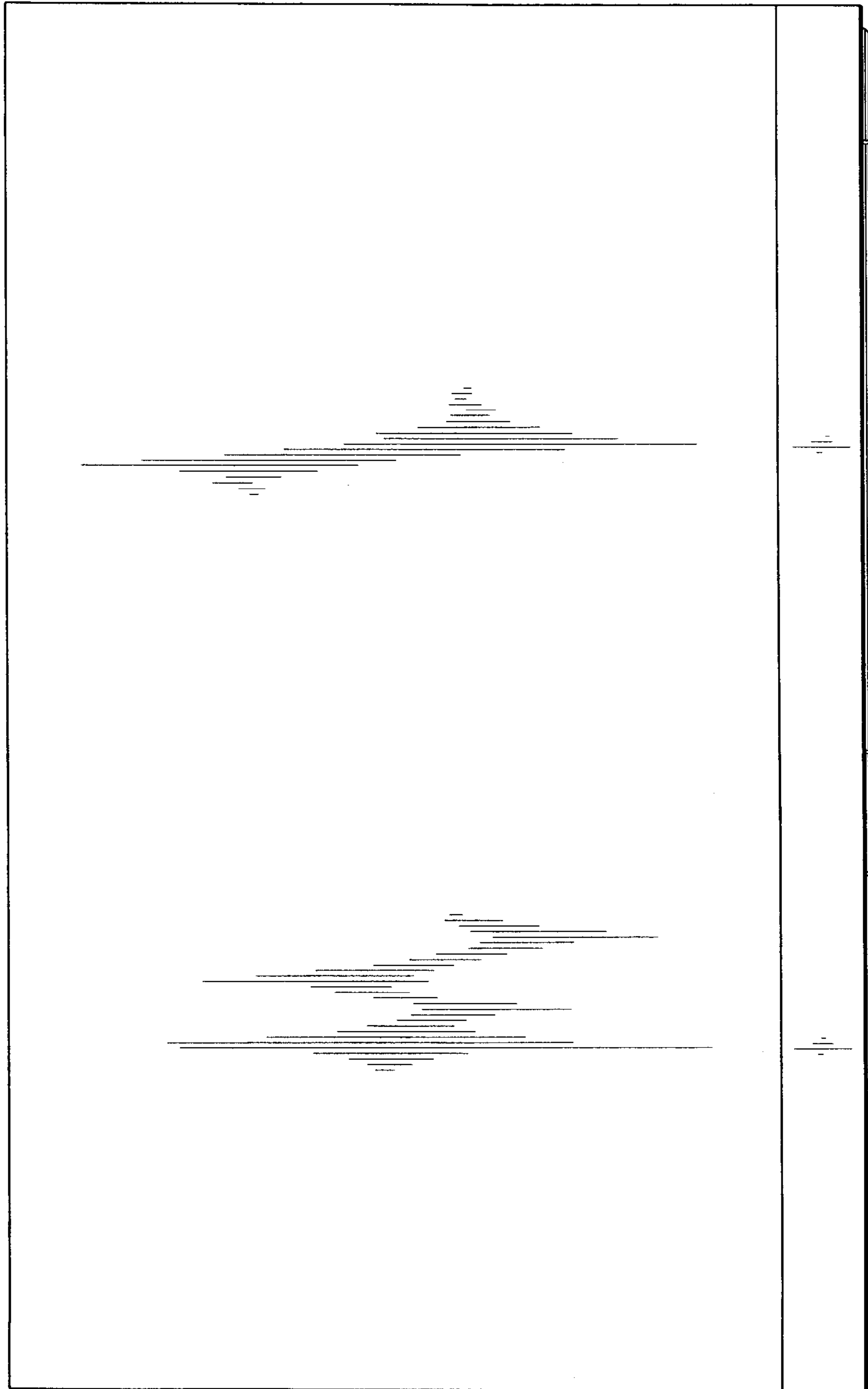
