(57) **CLAIM**

The ornamental design for a golf club head, as shown.

**DESCRIPTION**

FIG. 1 is a first perspective view of a first embodiment of a golf club head in accordance with my new design.

FIG. 17 is a cross-section view taken along line A—A in FIG. 11.

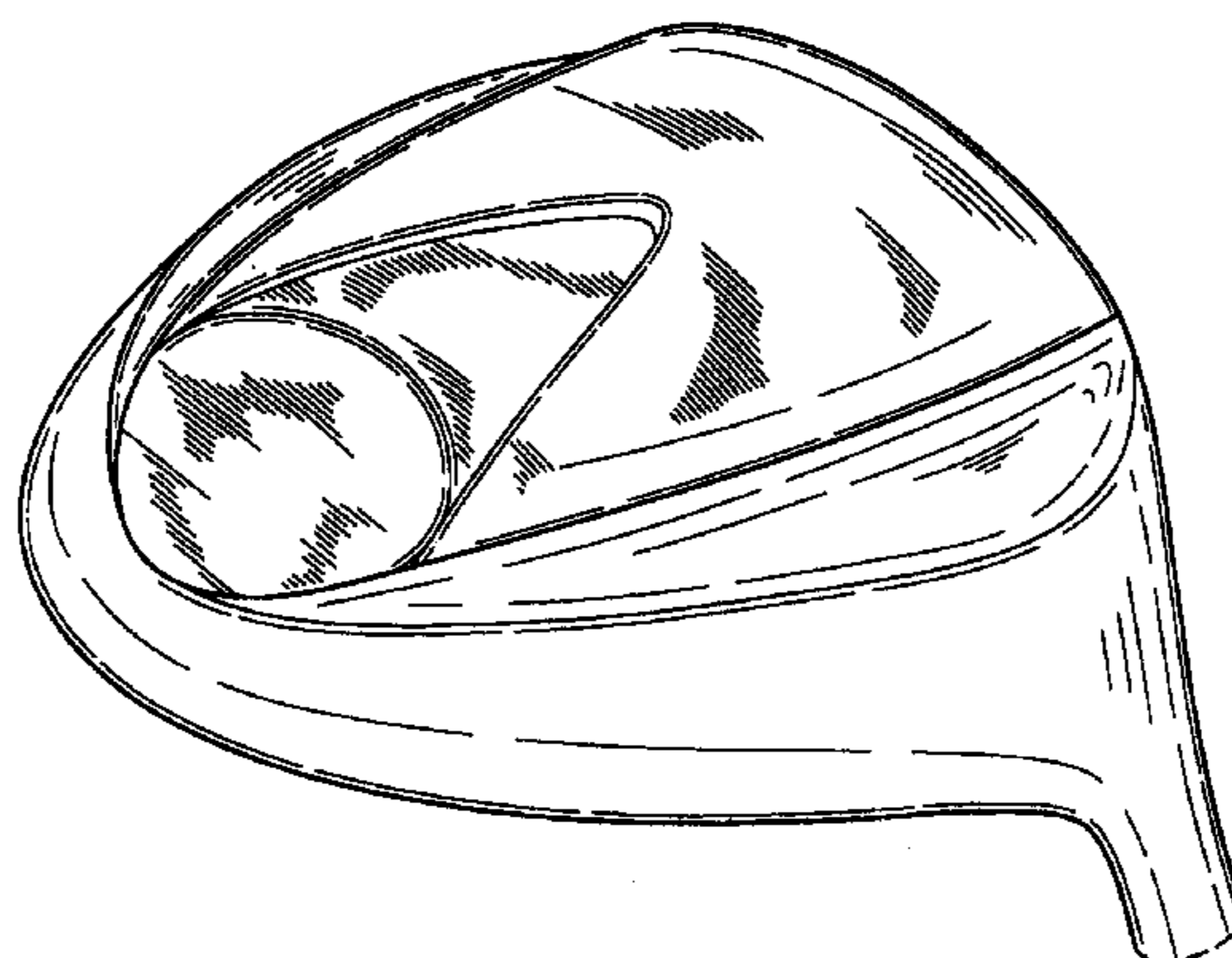


FIG. 18 is a cross-section view taken along line B—B in FIG. 13.

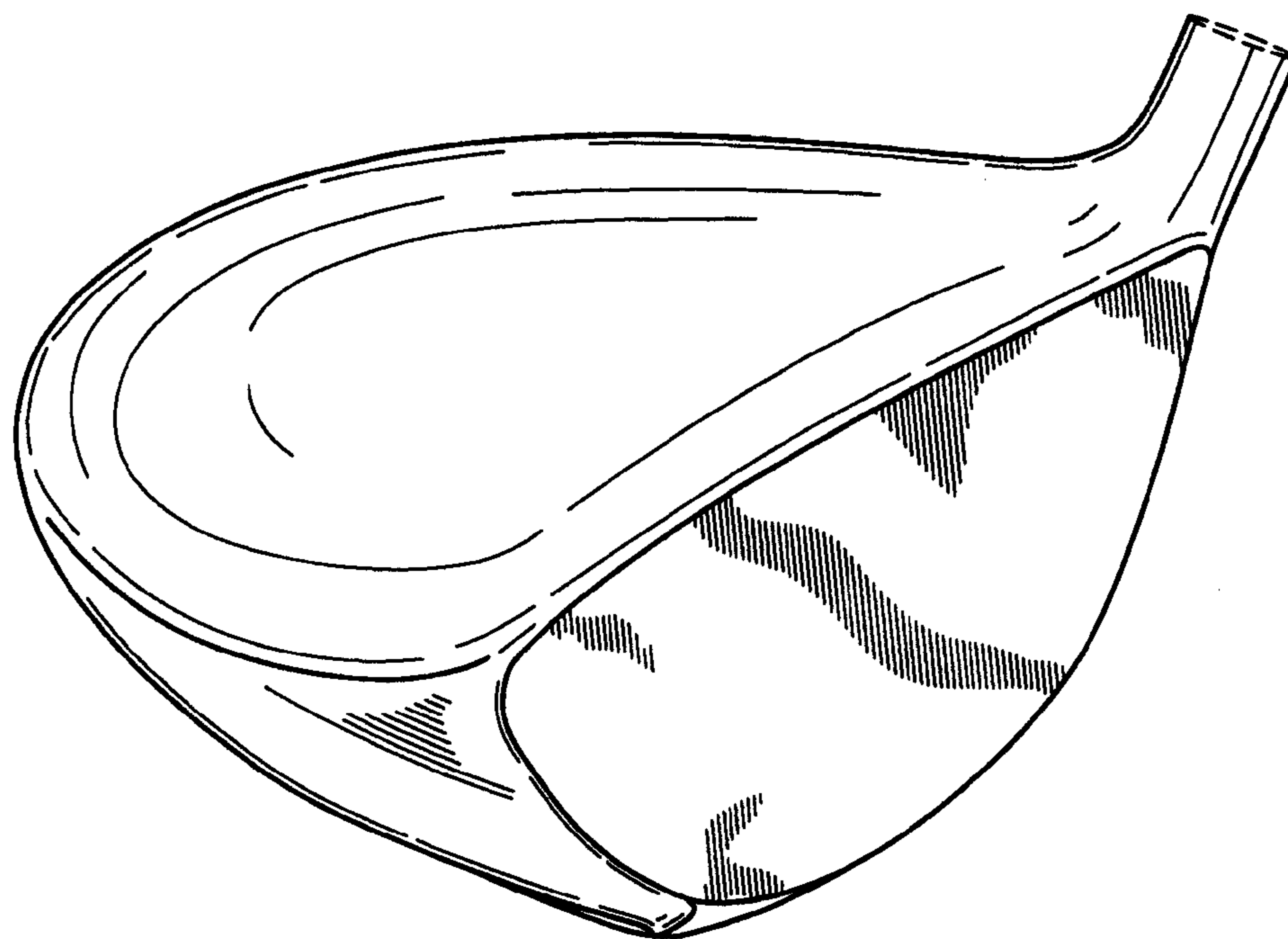

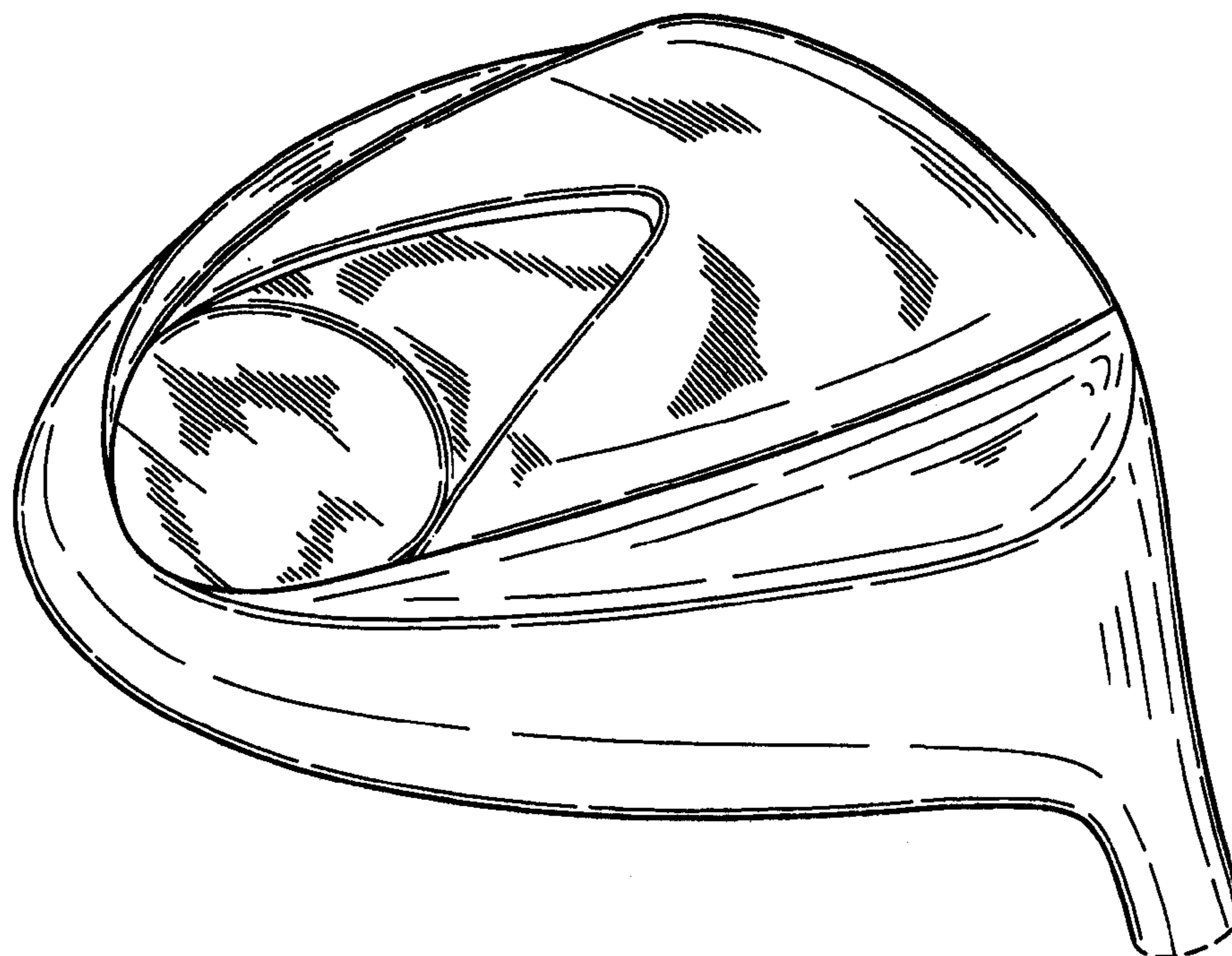

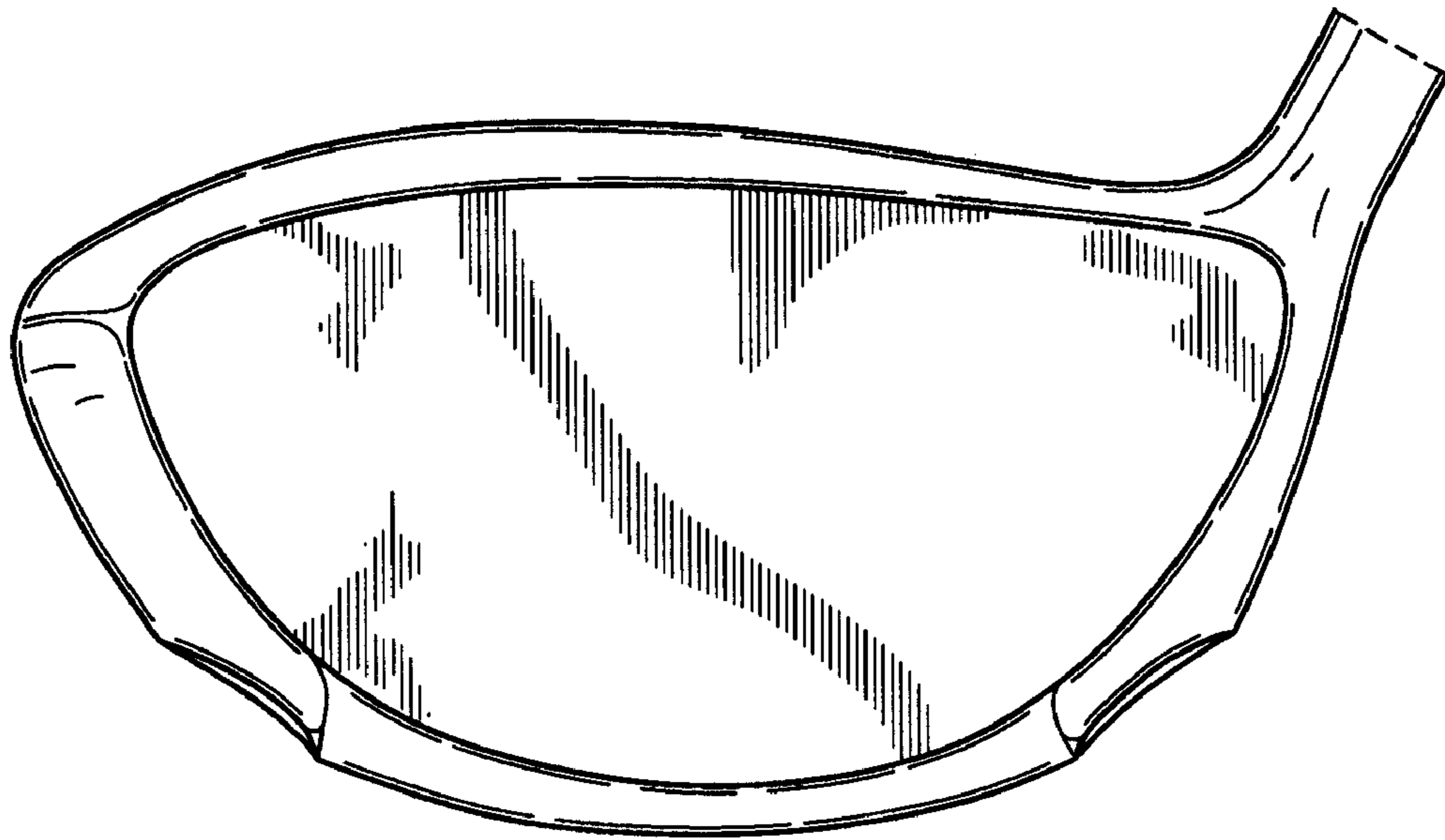

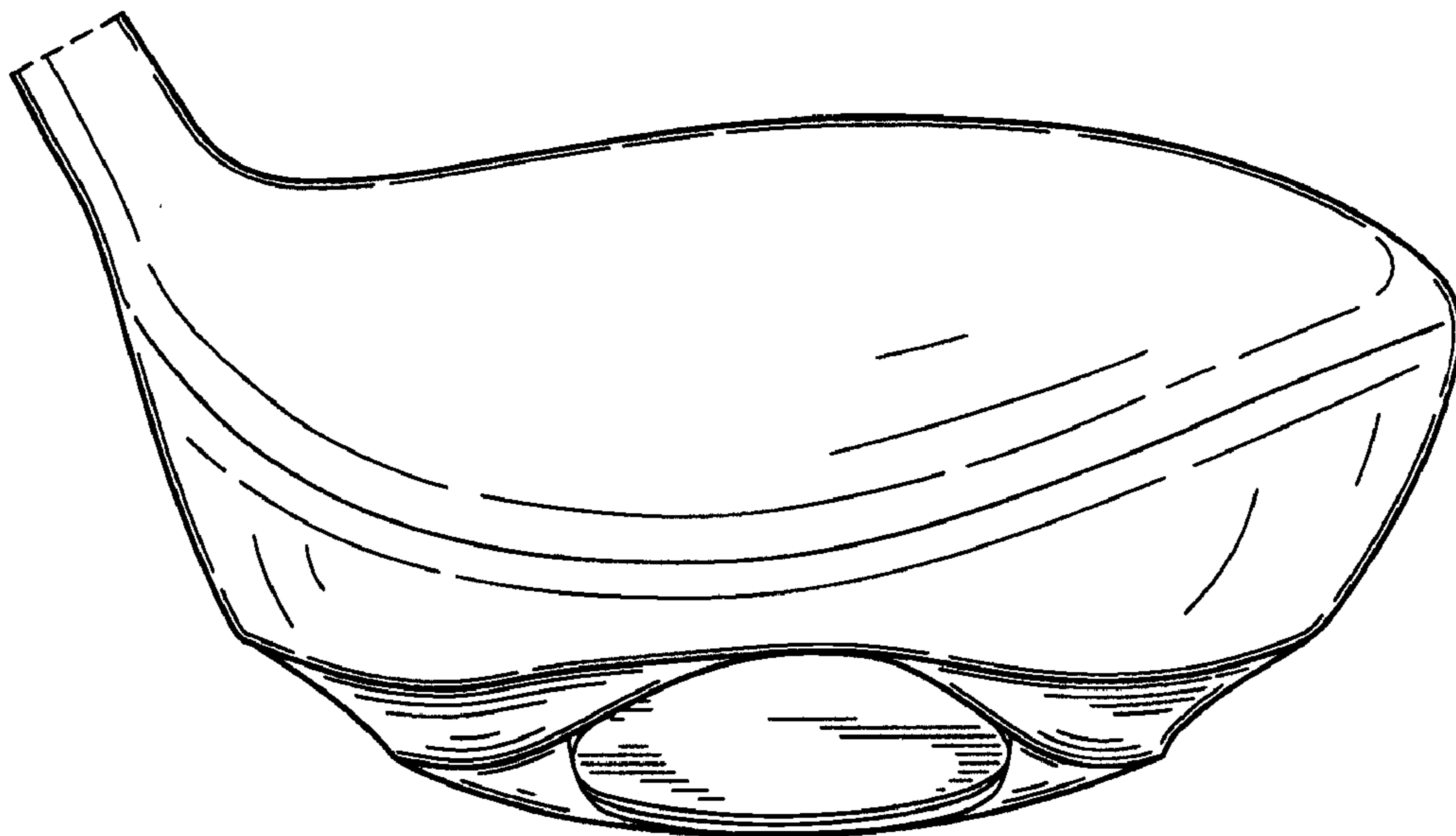

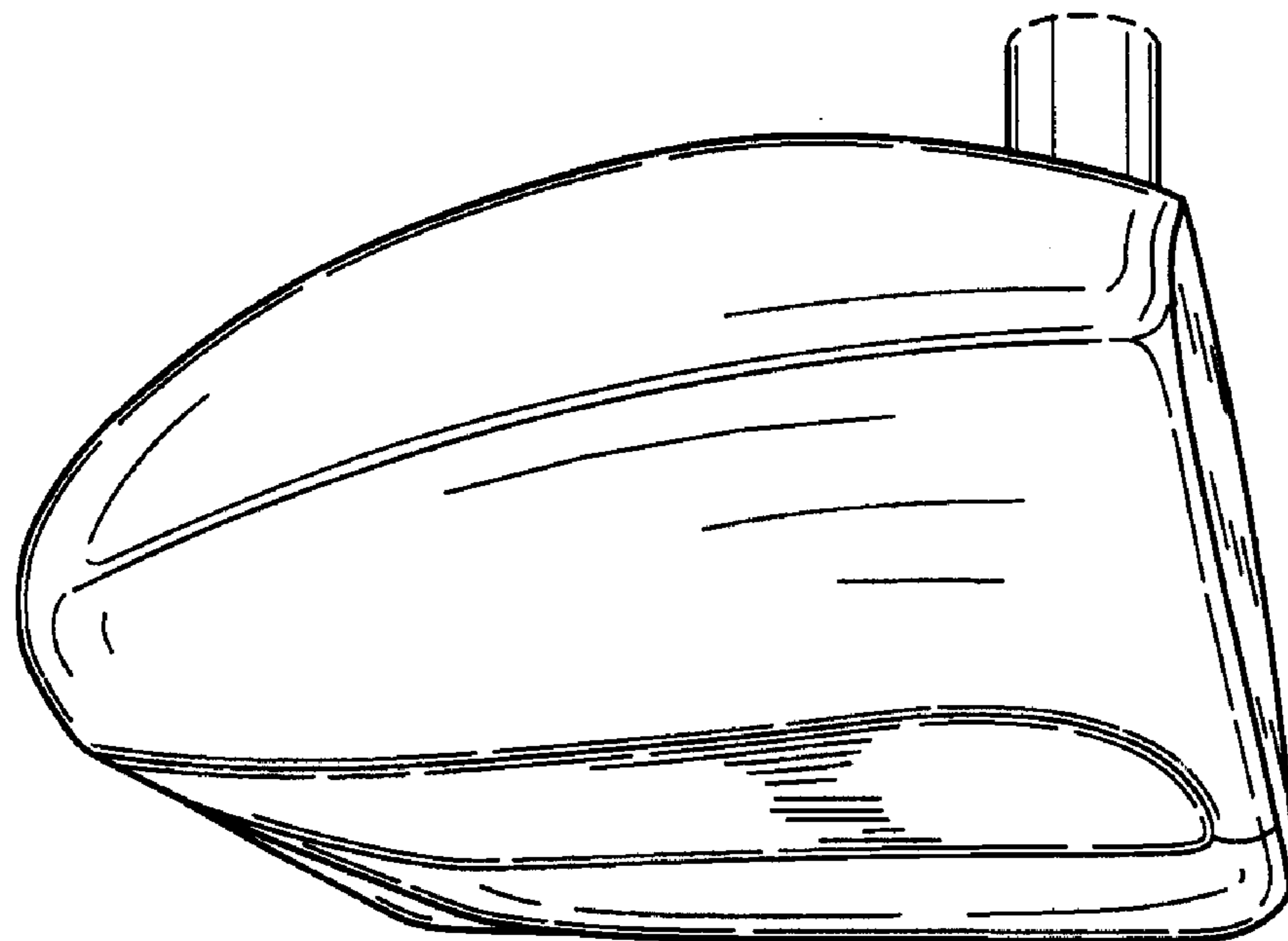

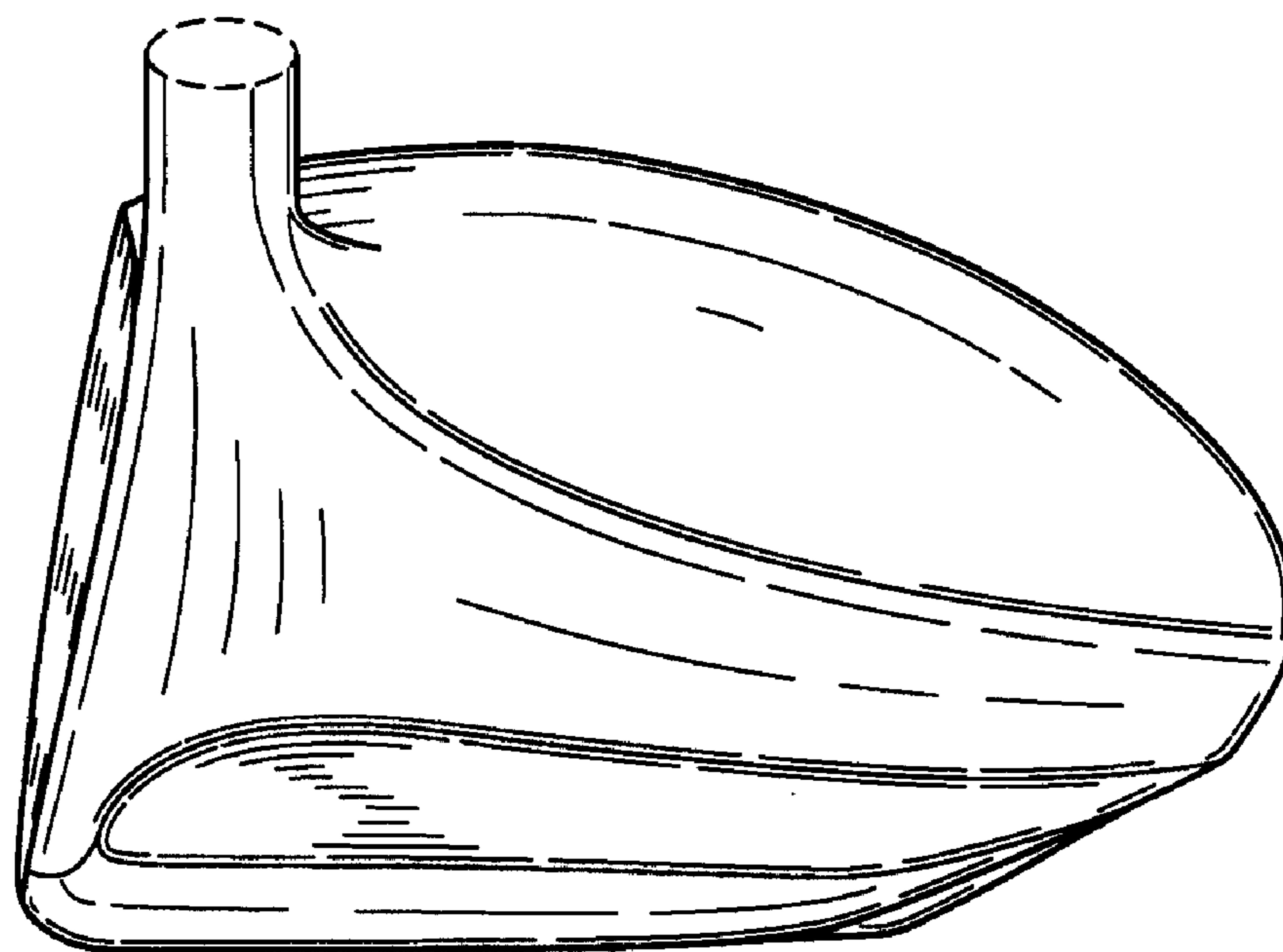

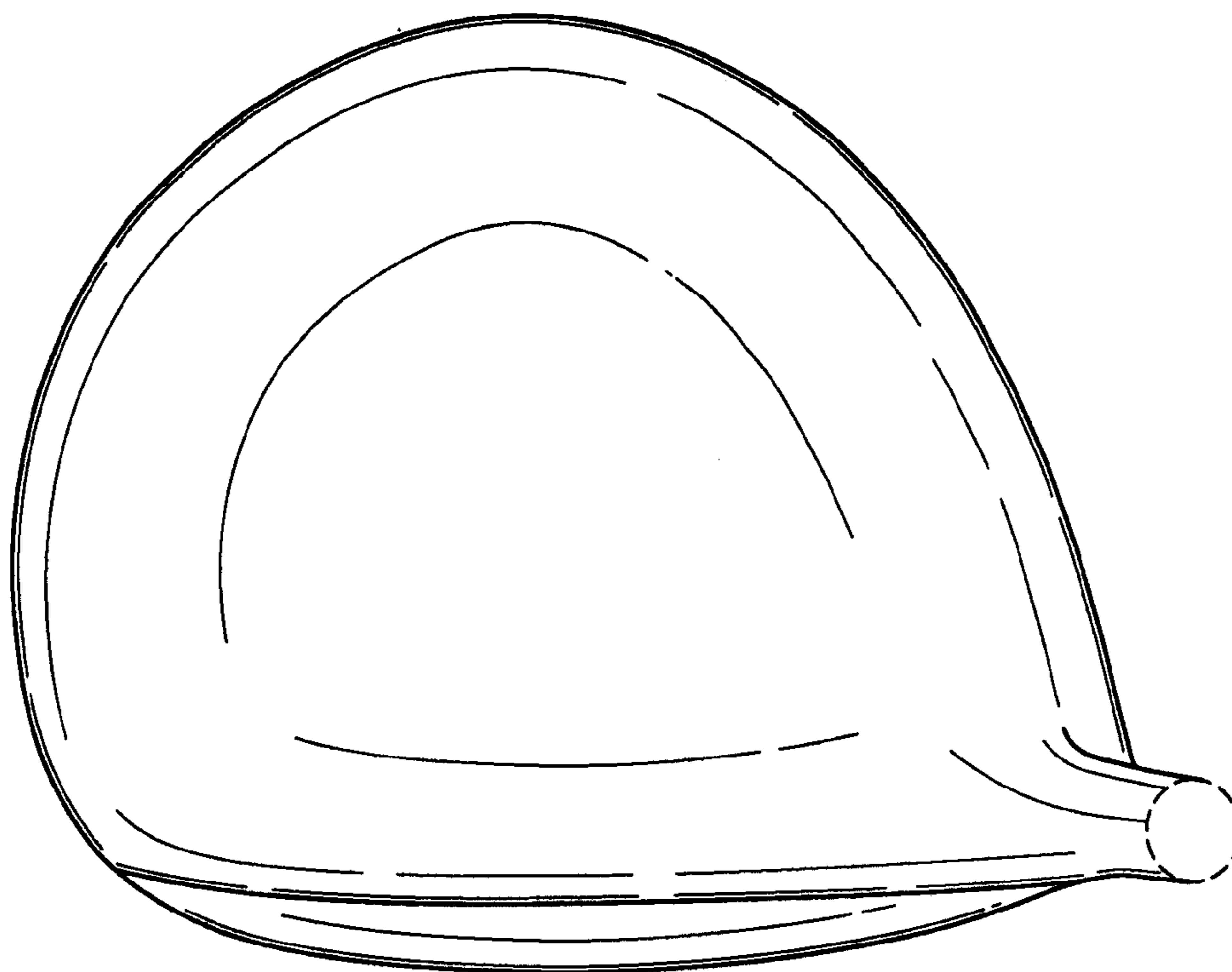

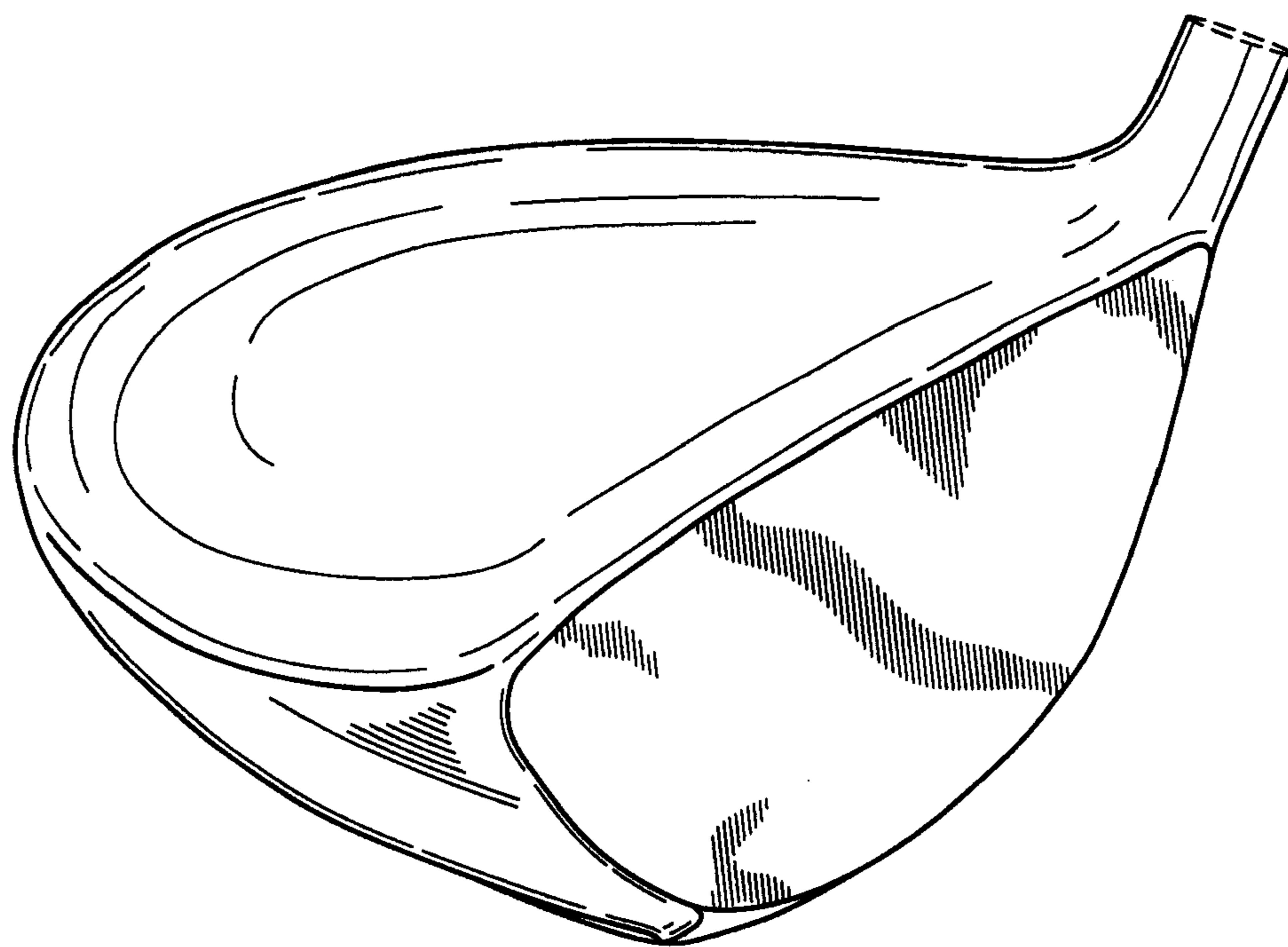

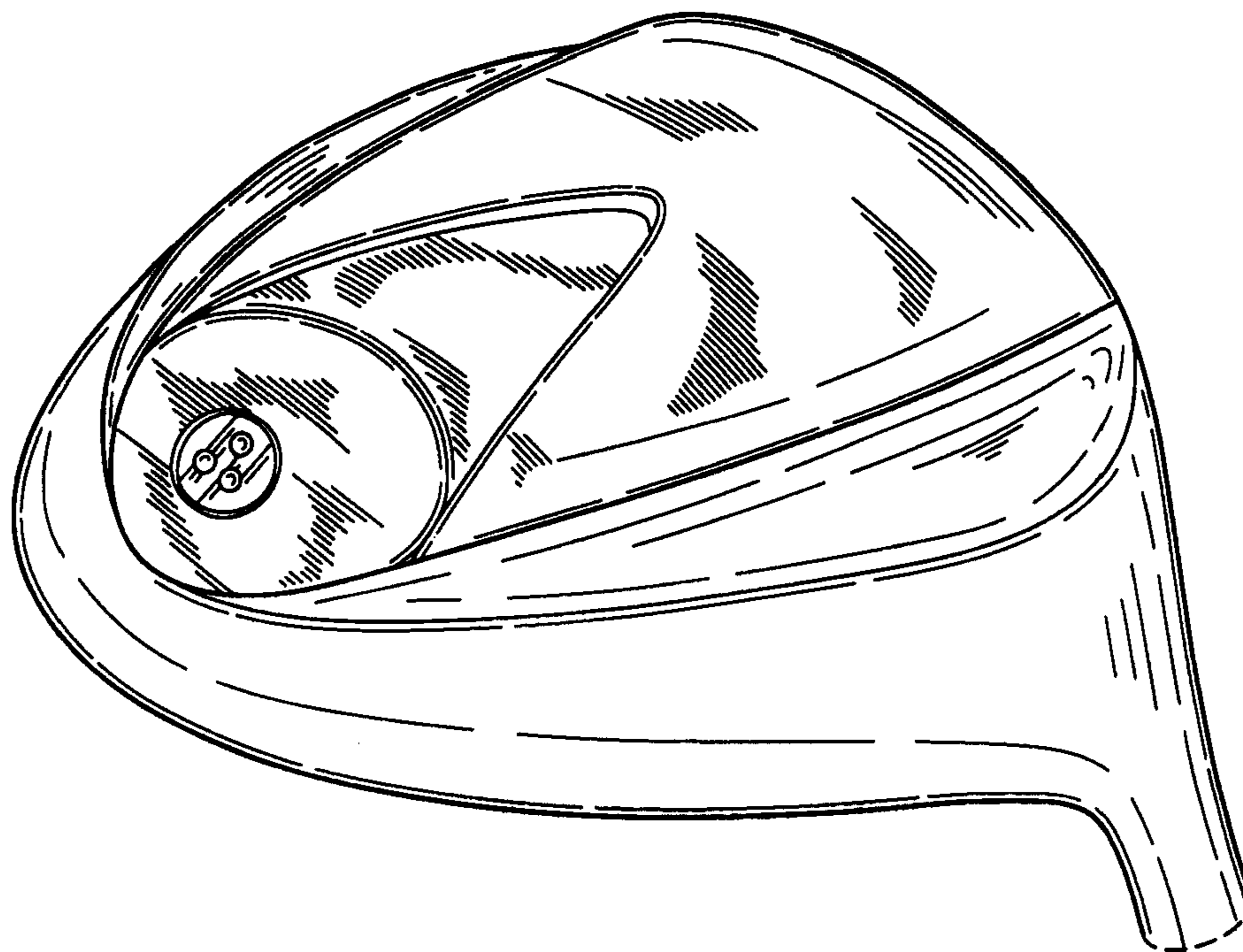

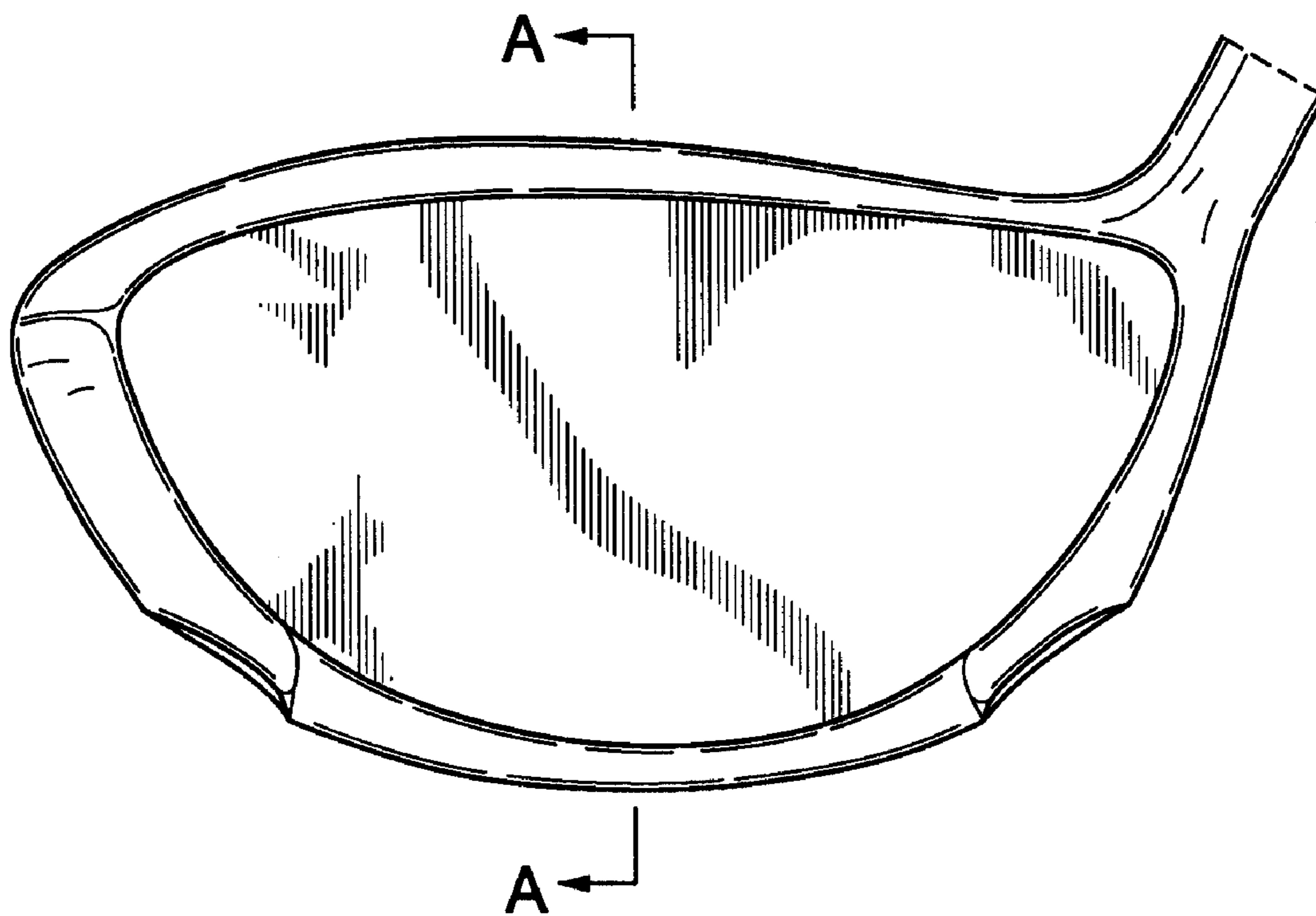

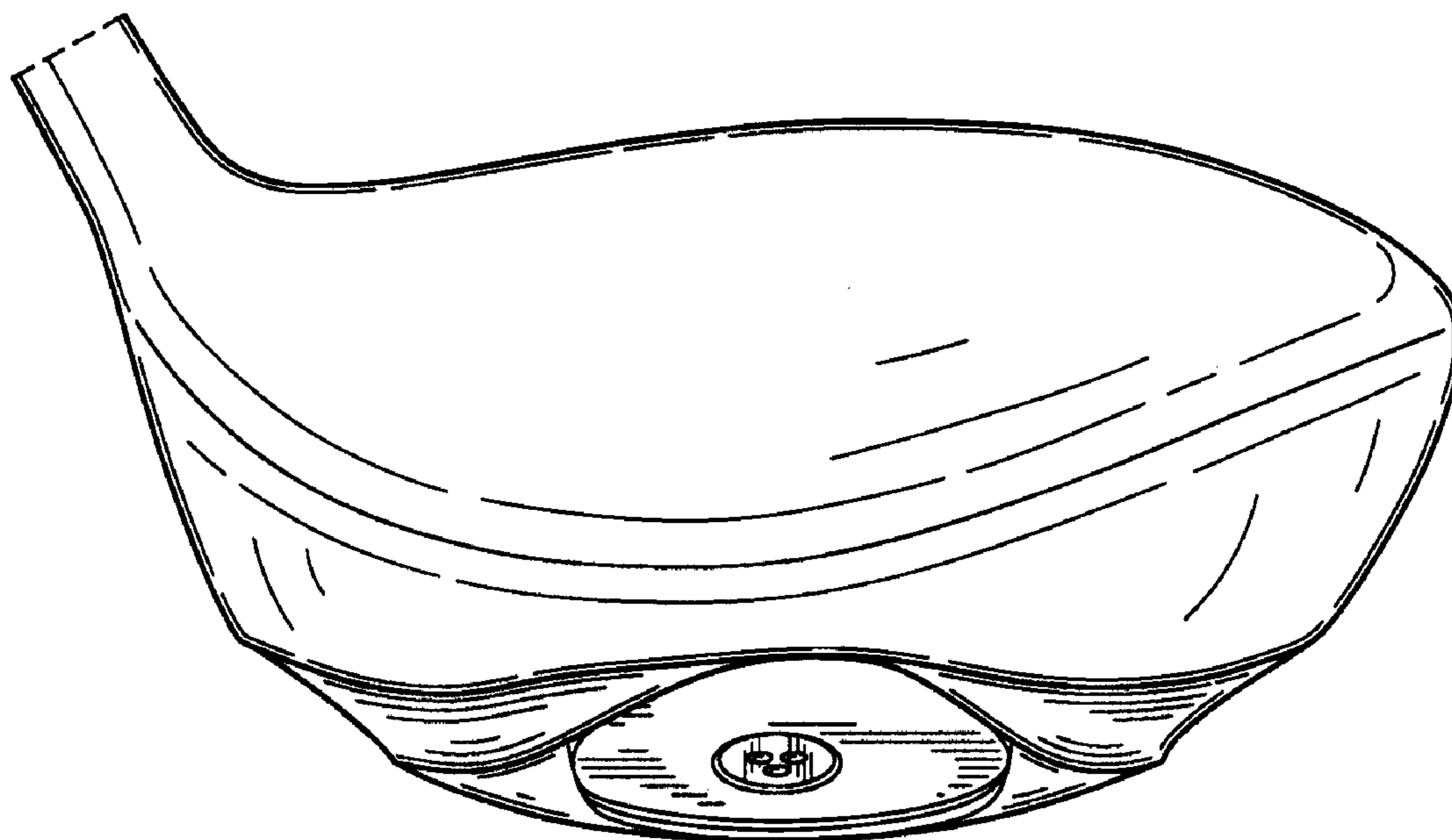

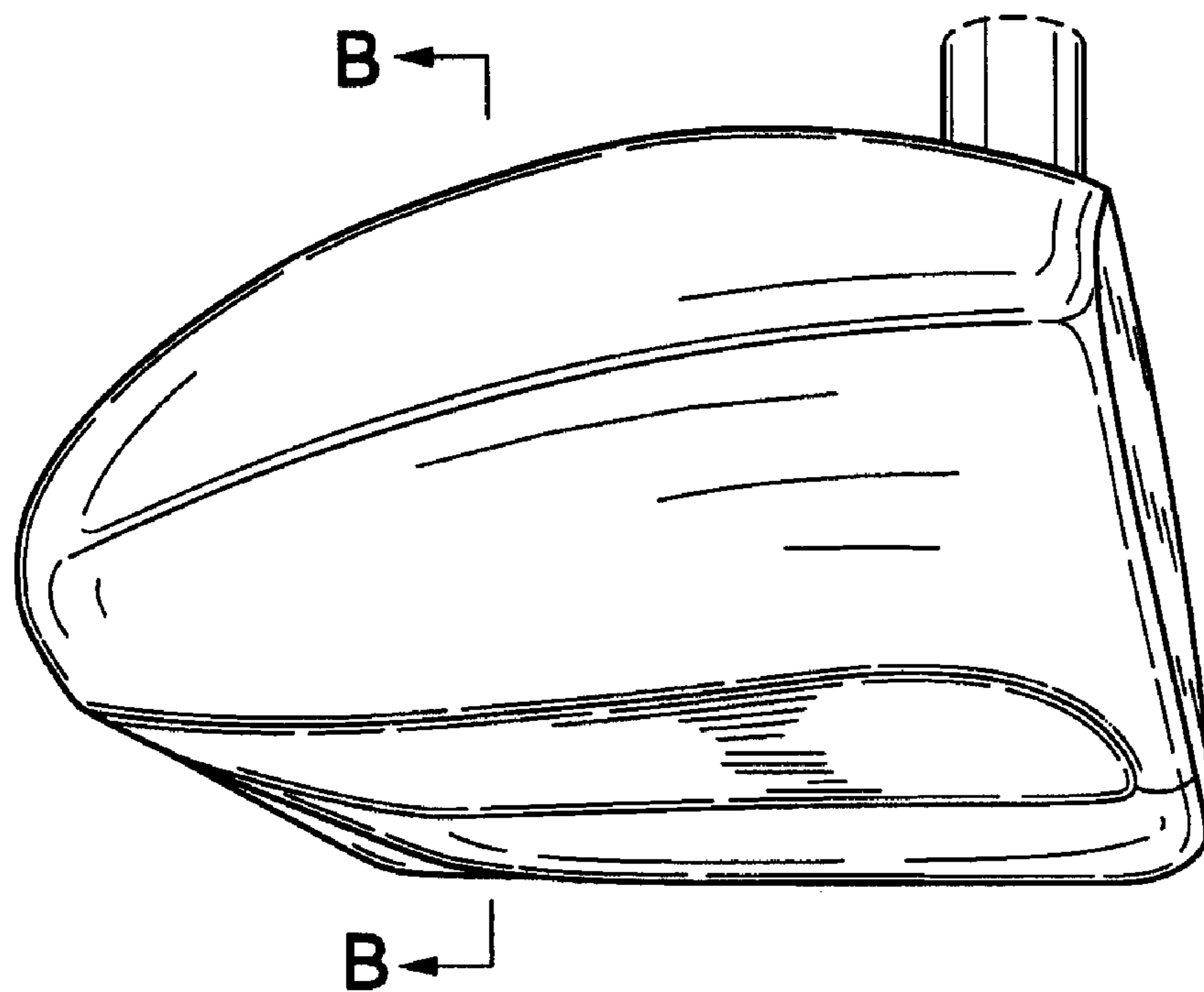

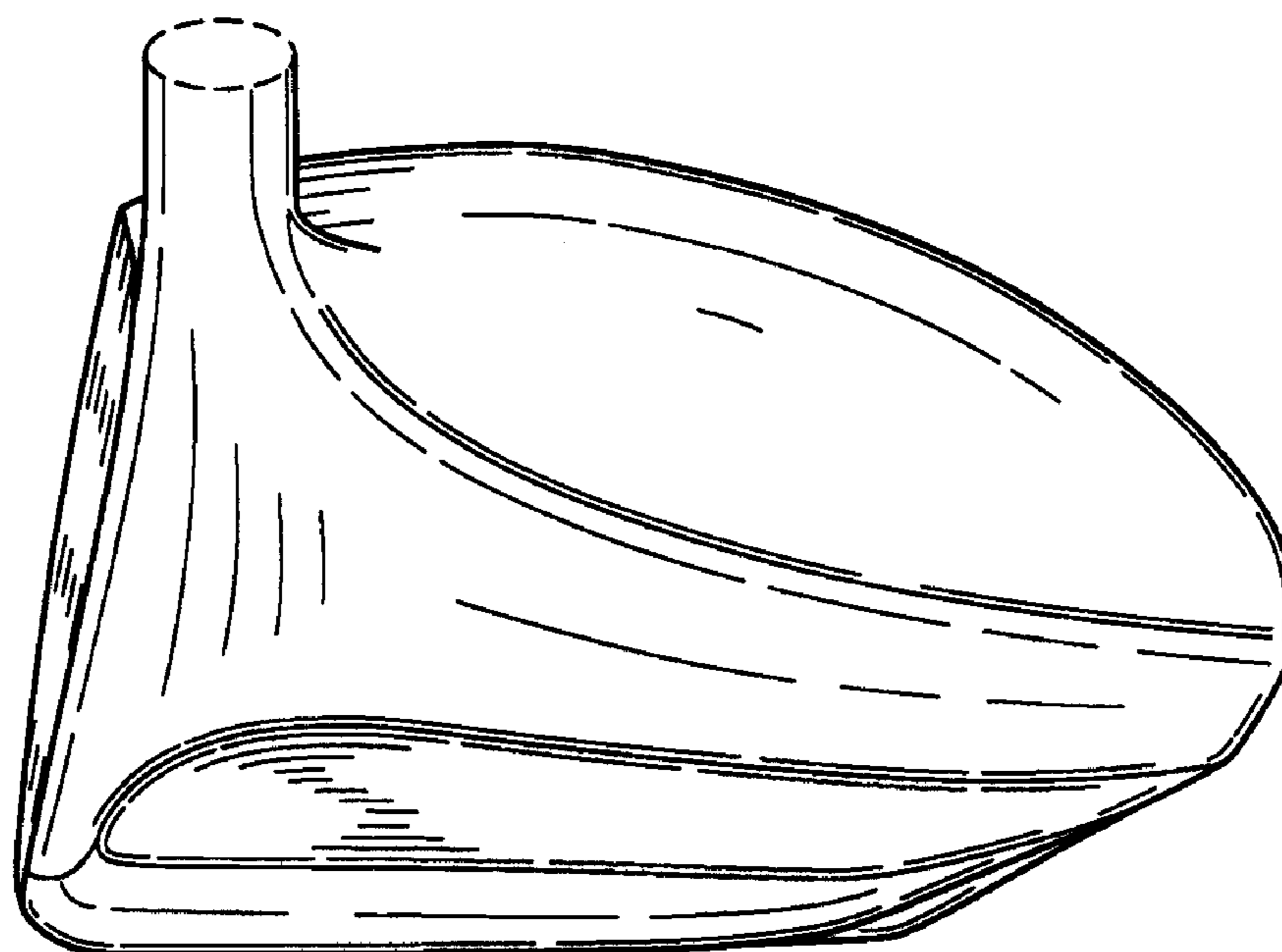

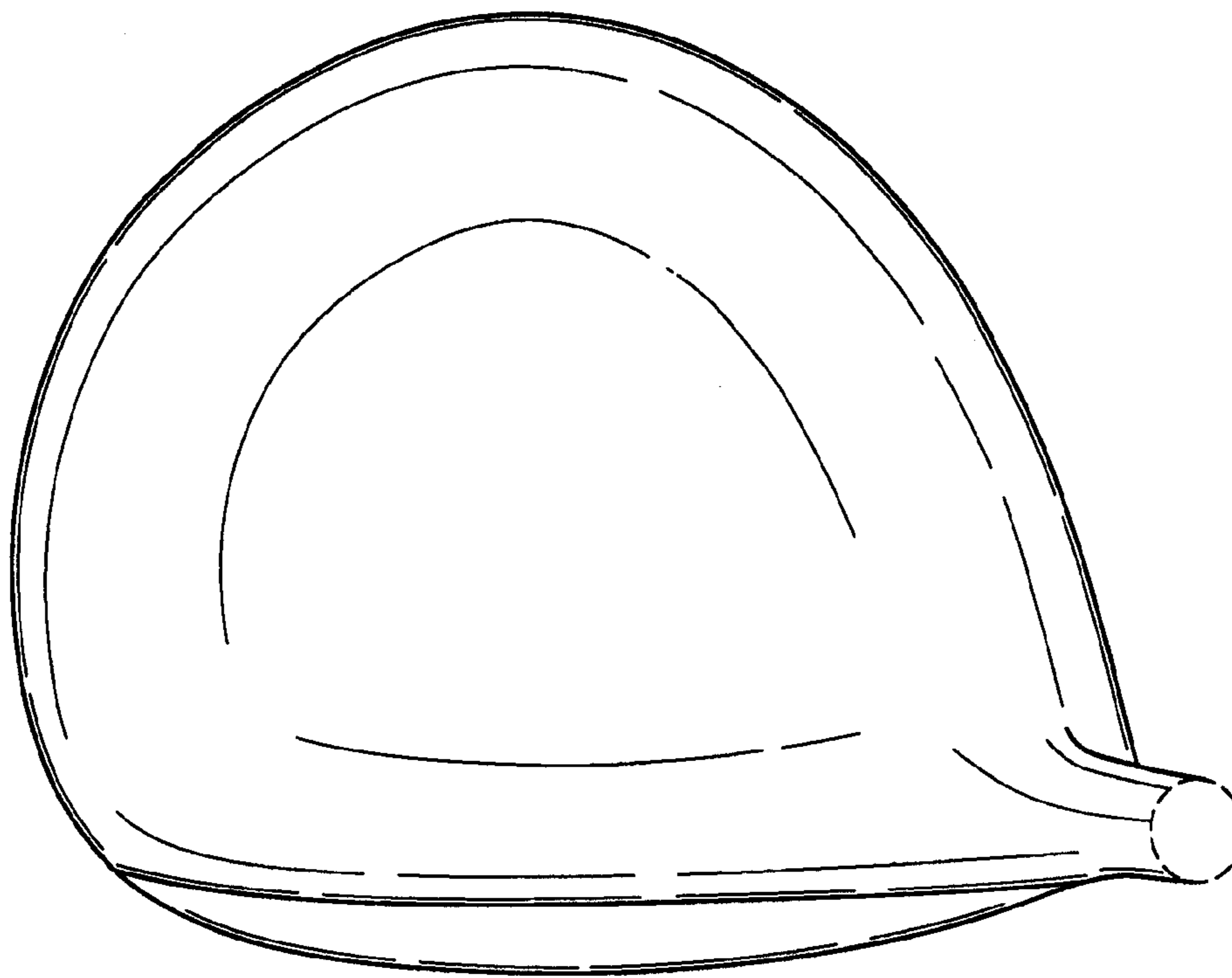

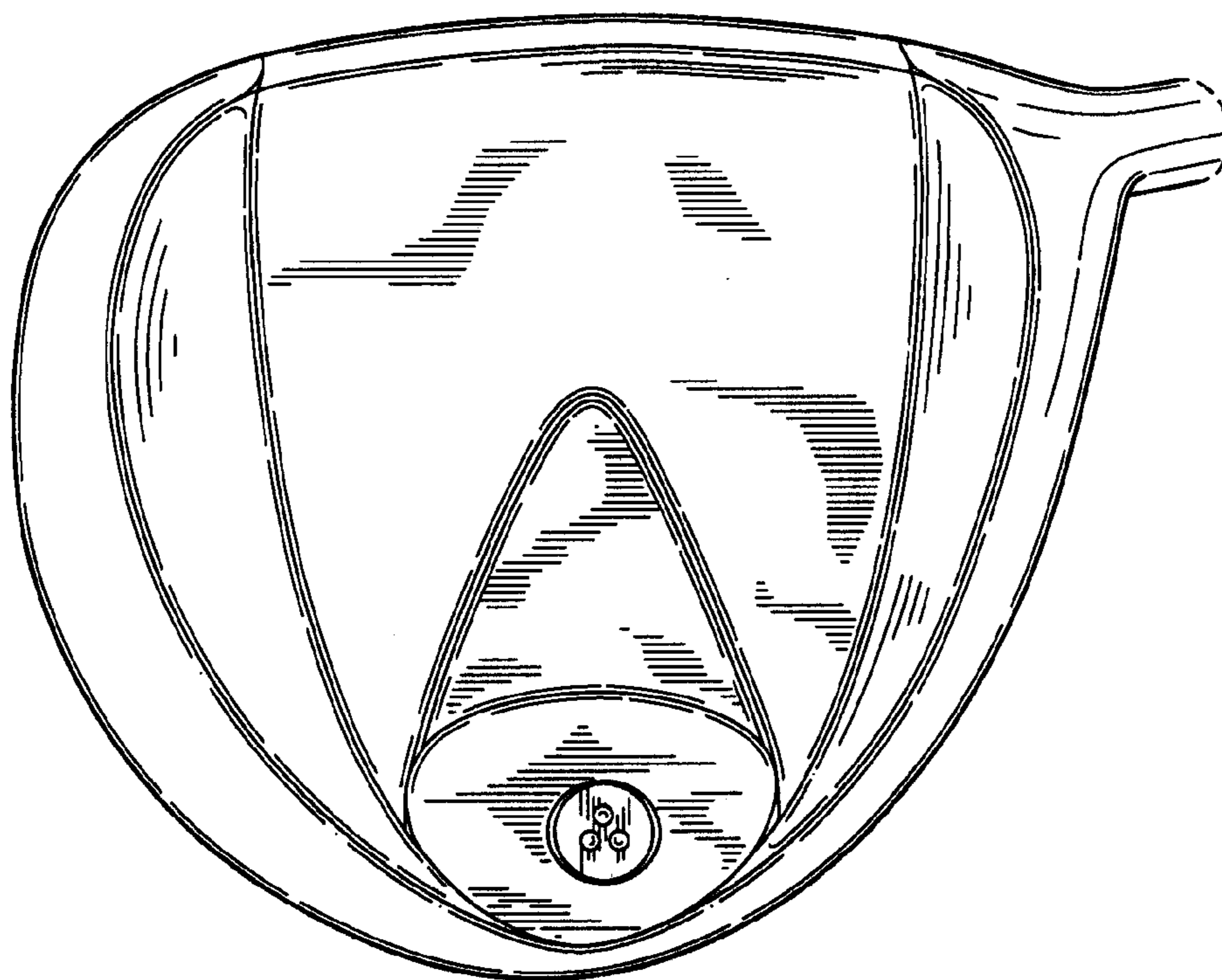

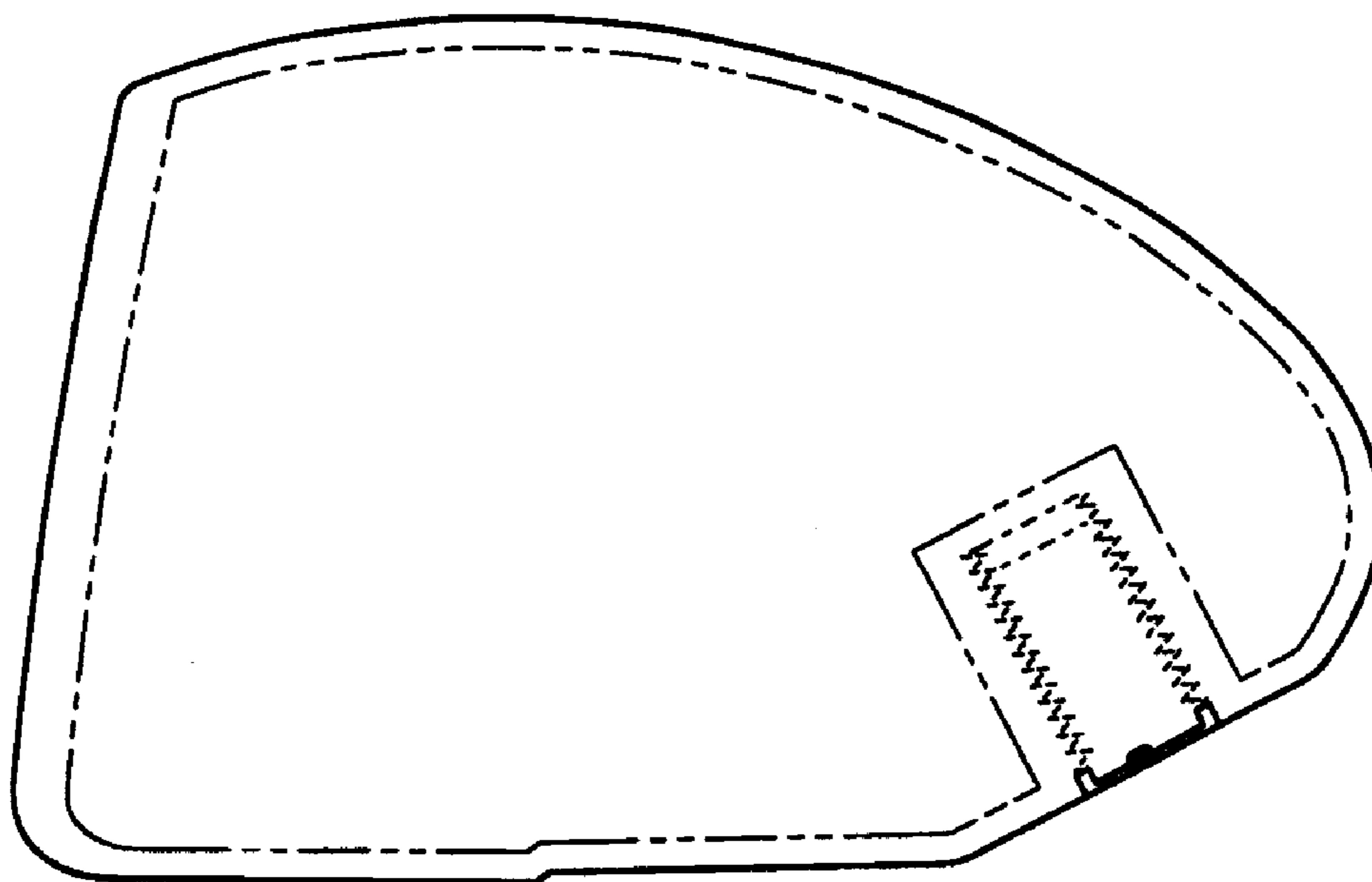

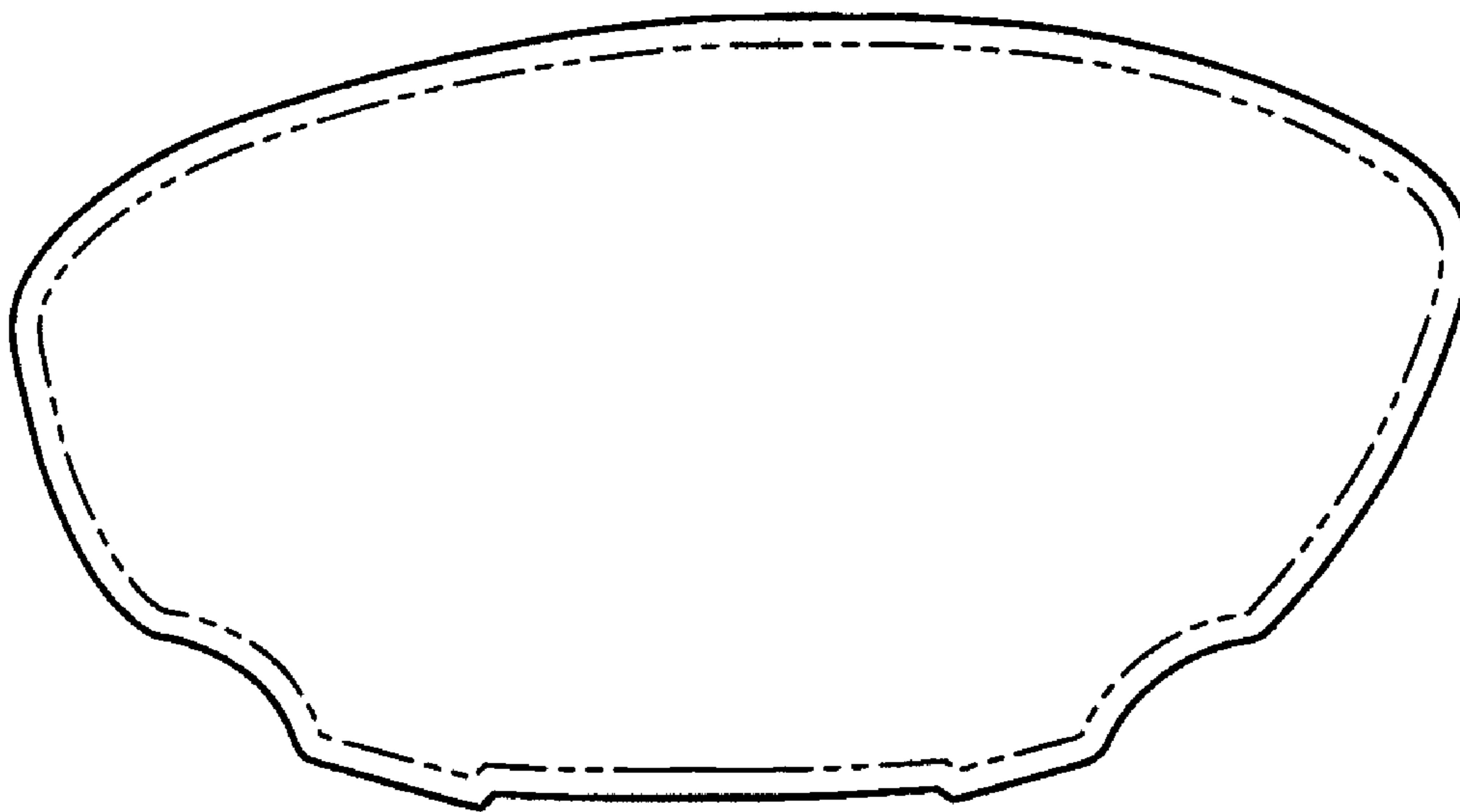

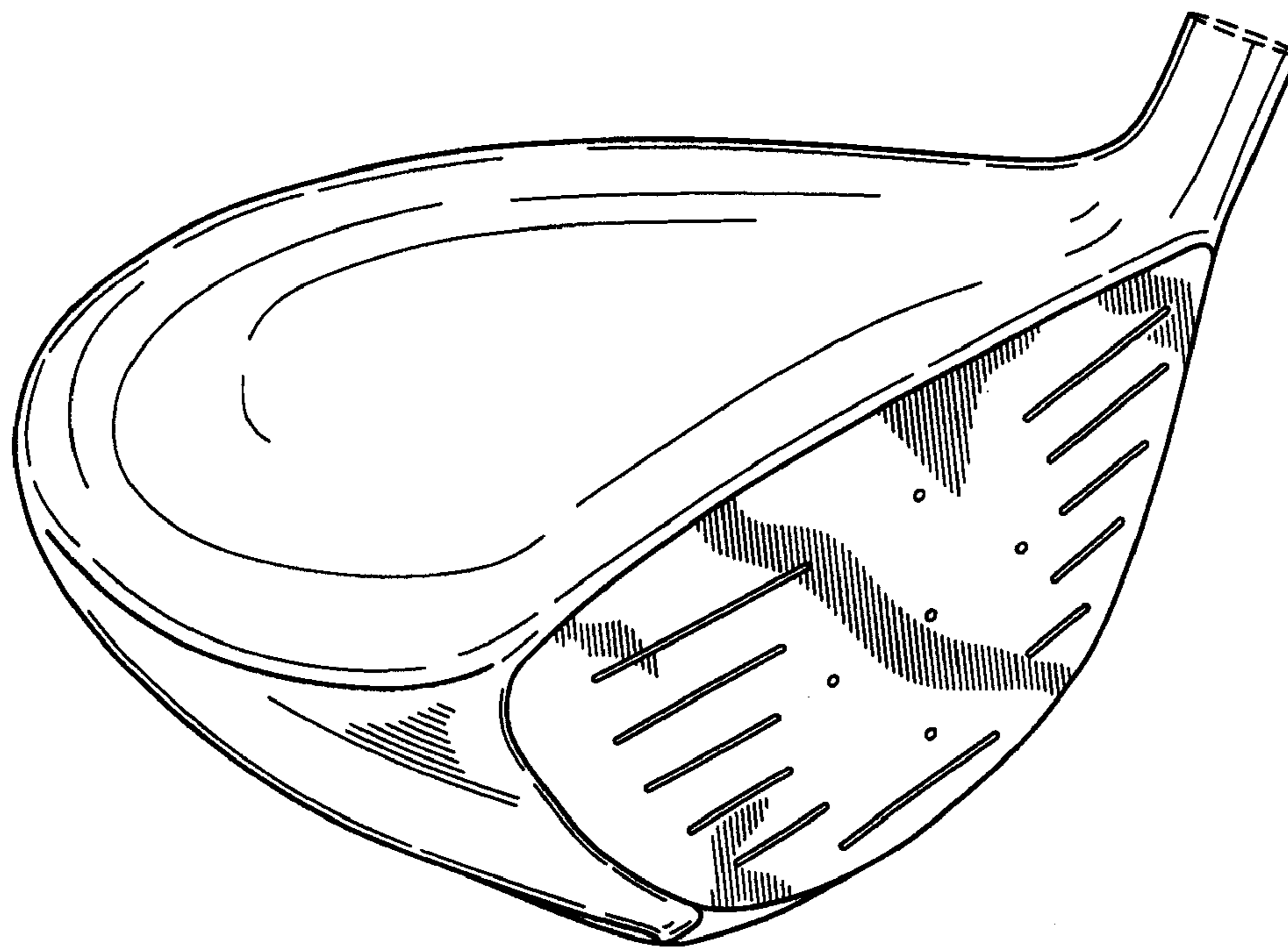

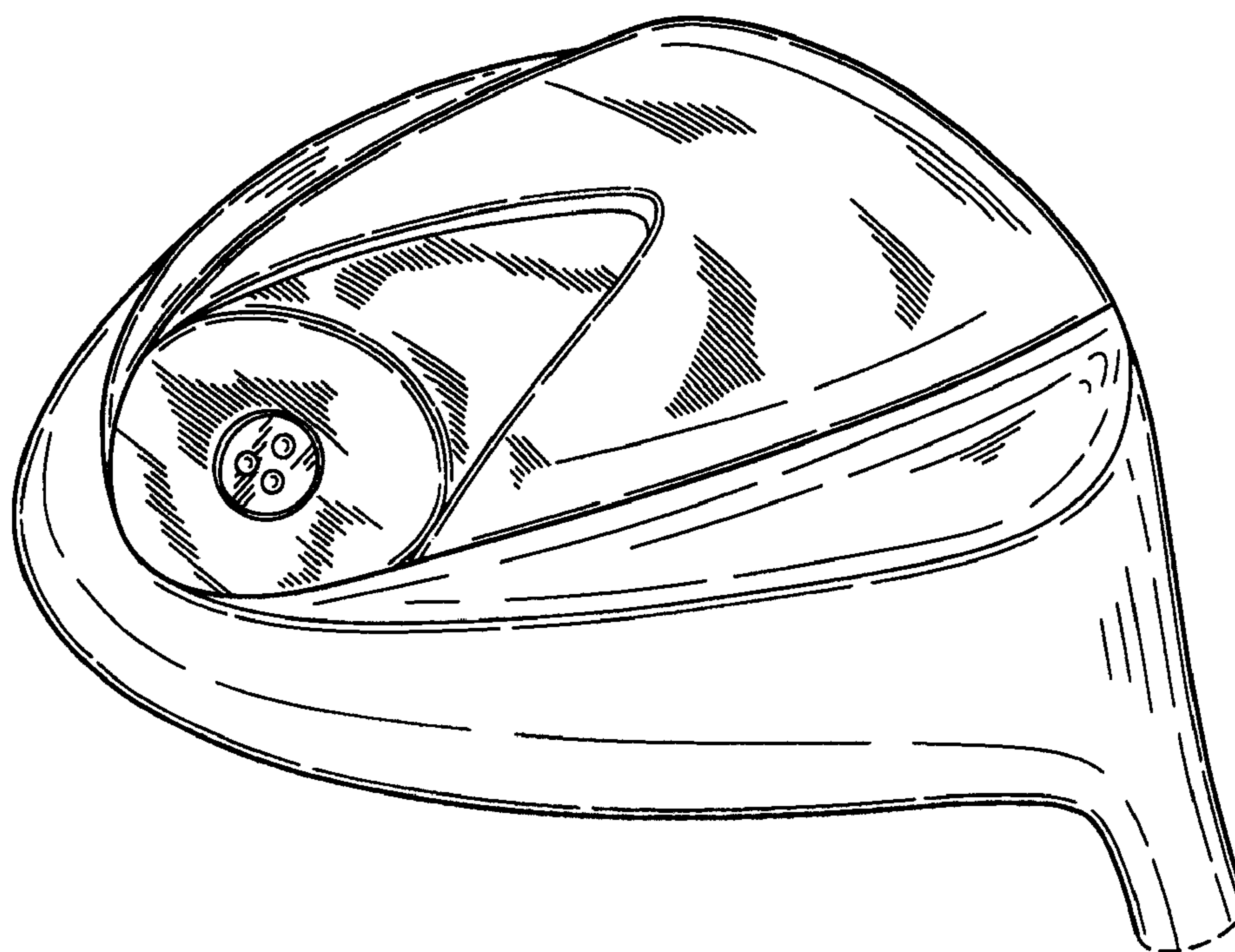

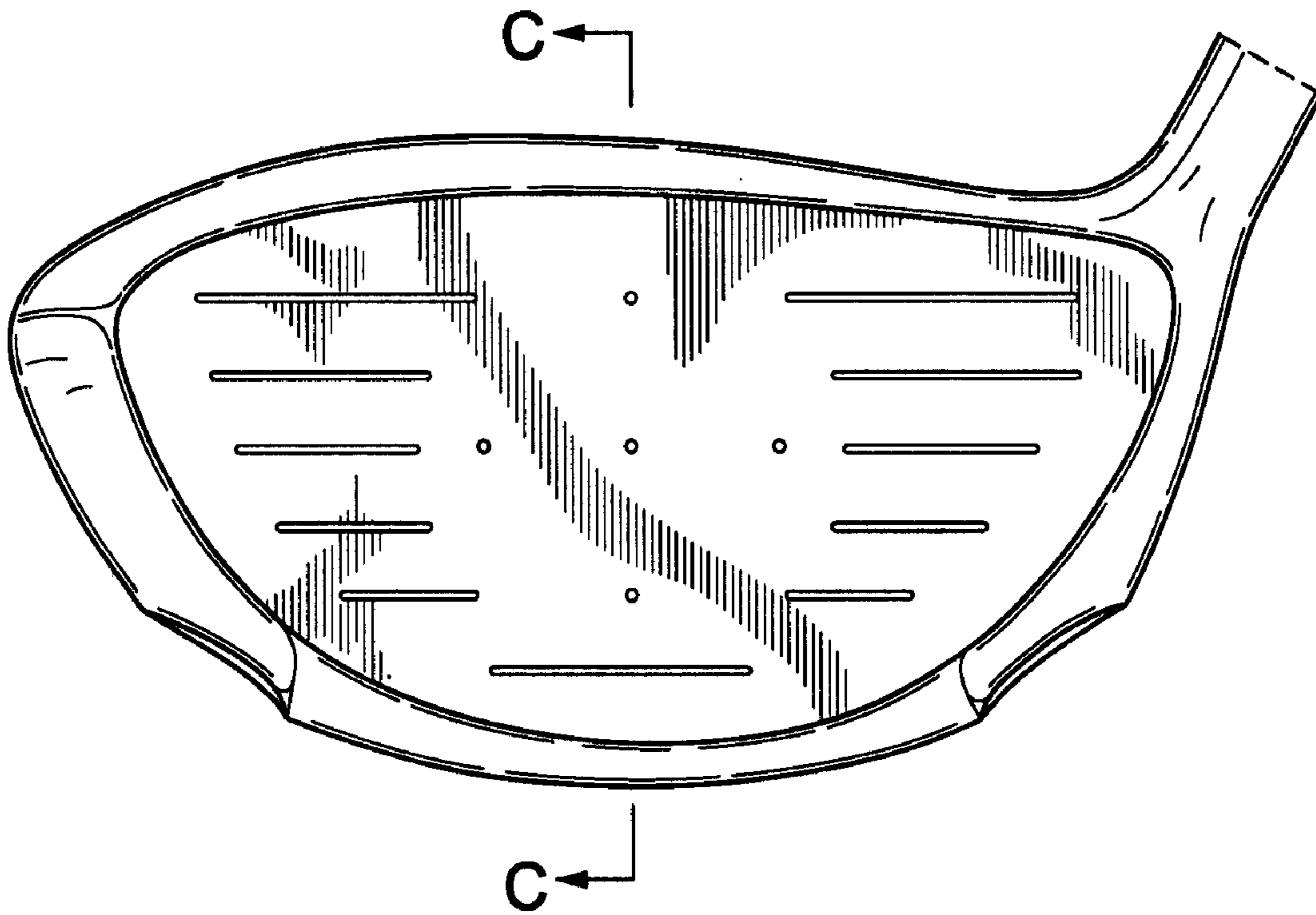

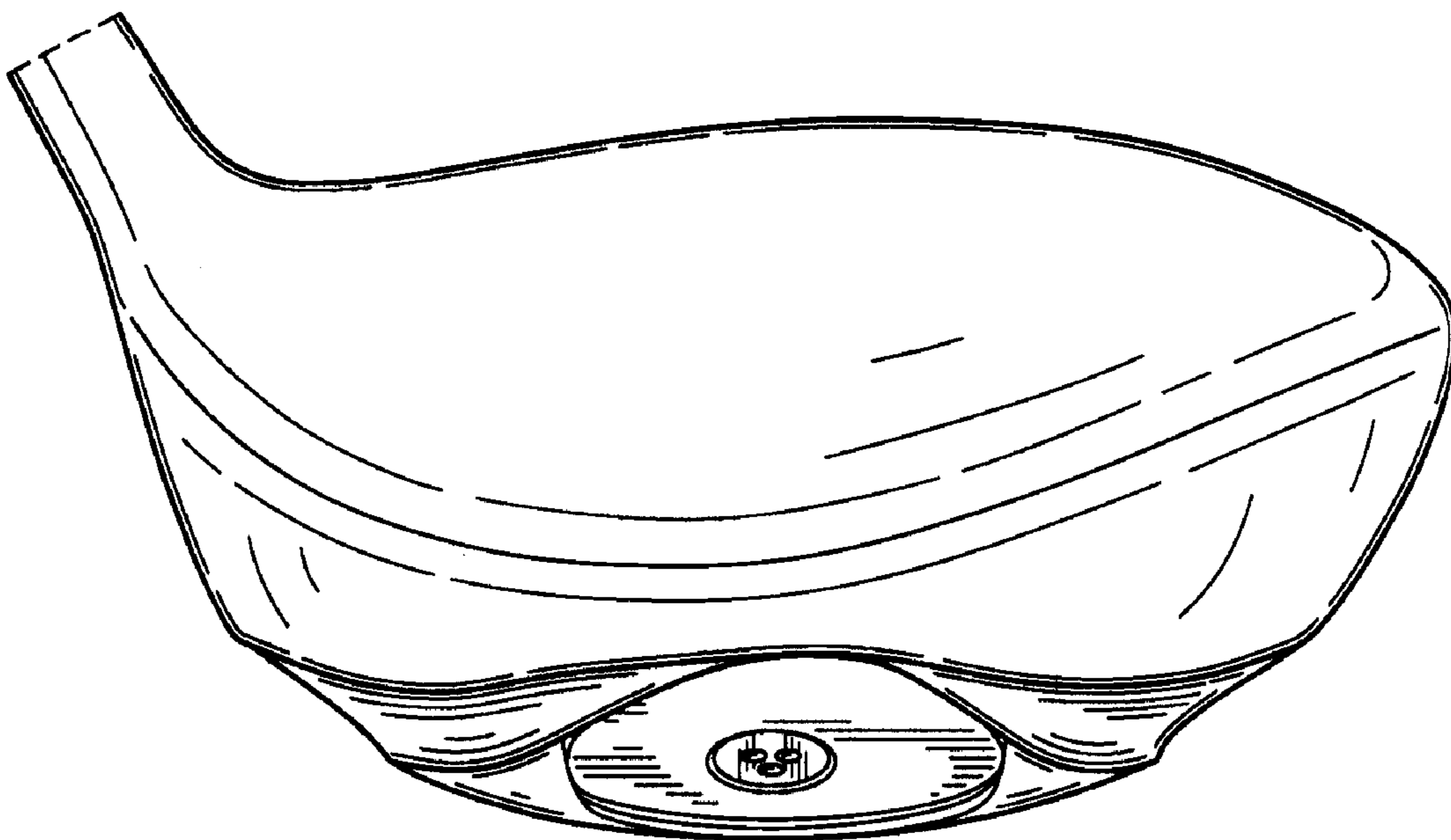

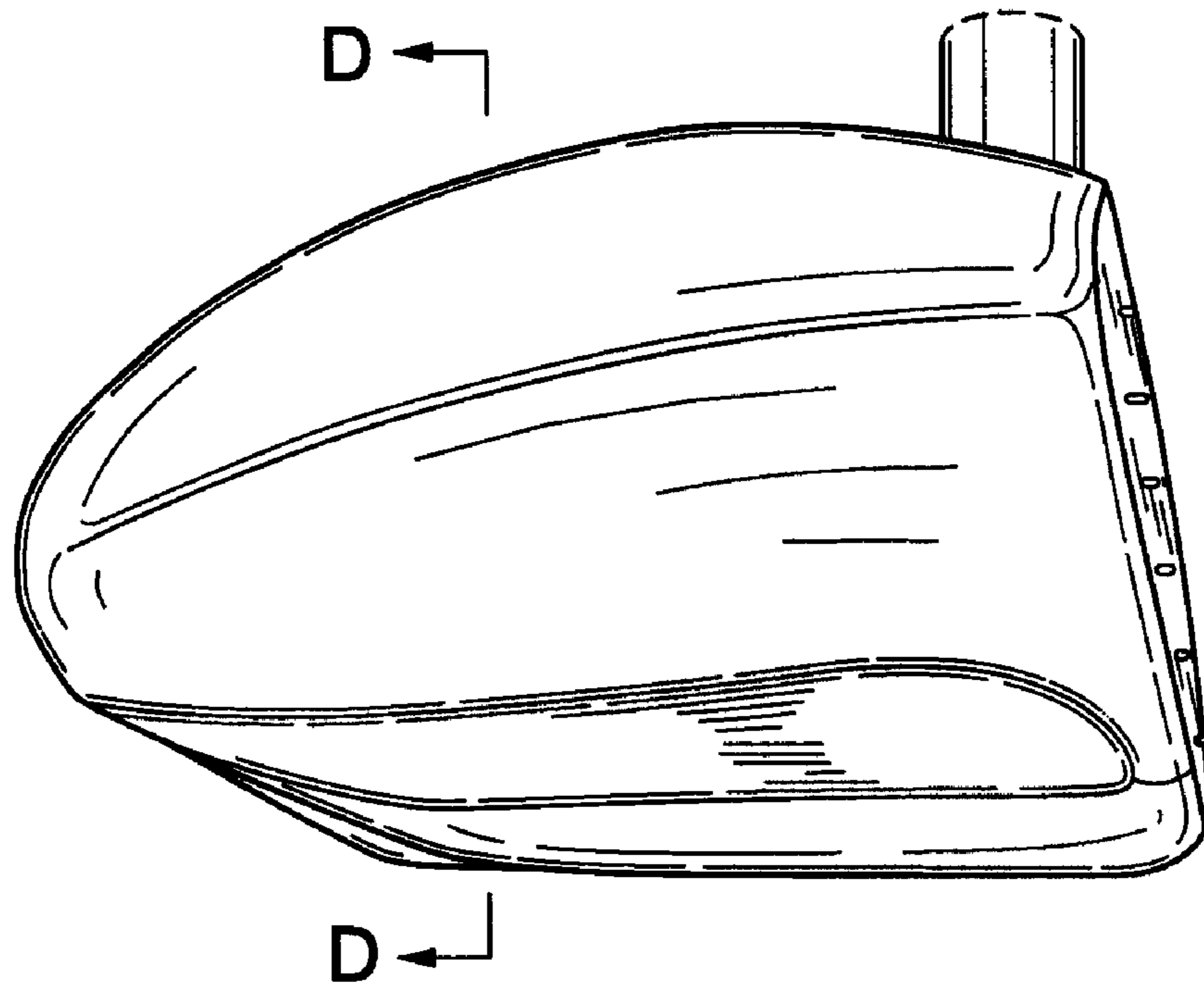

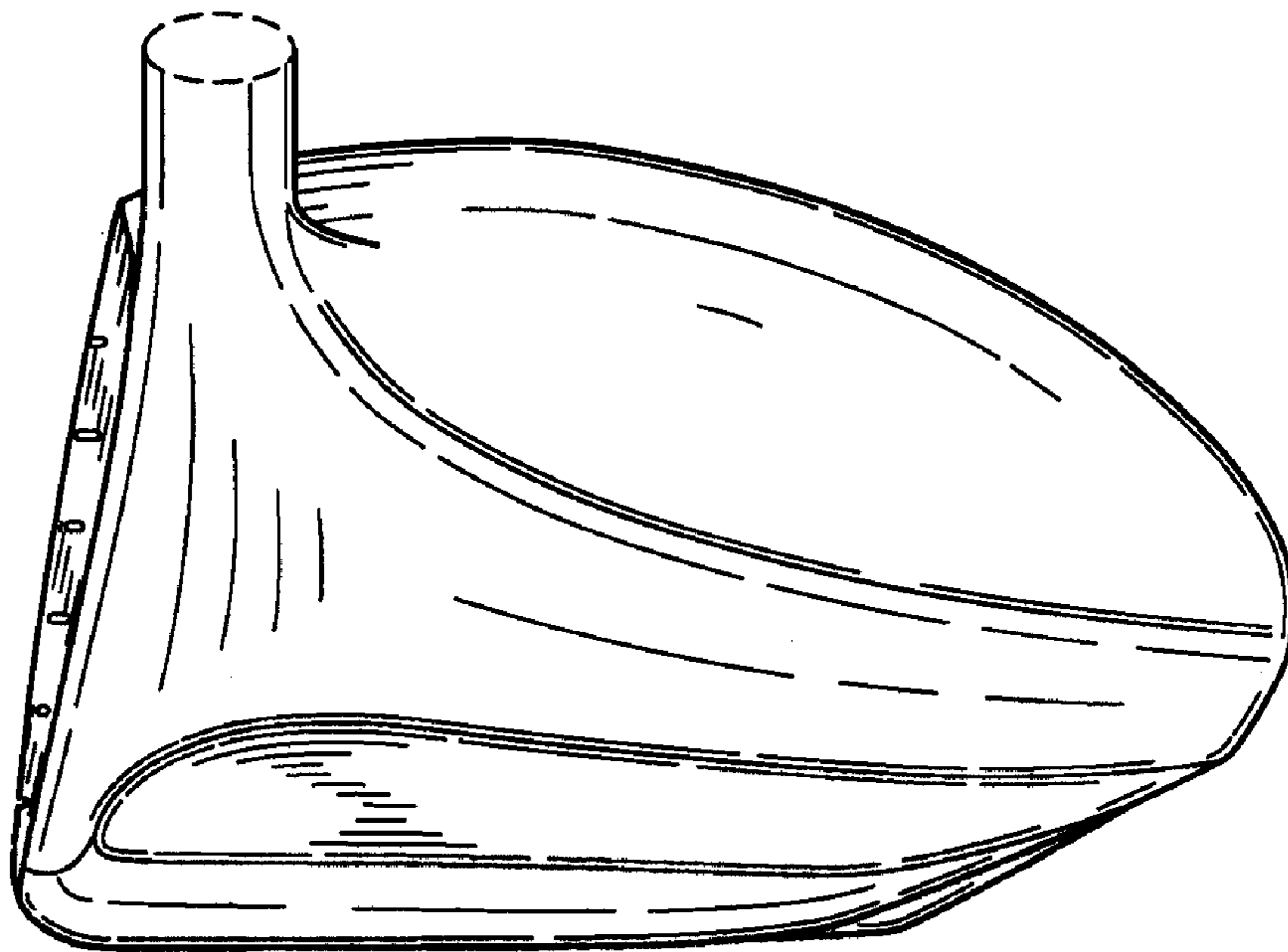

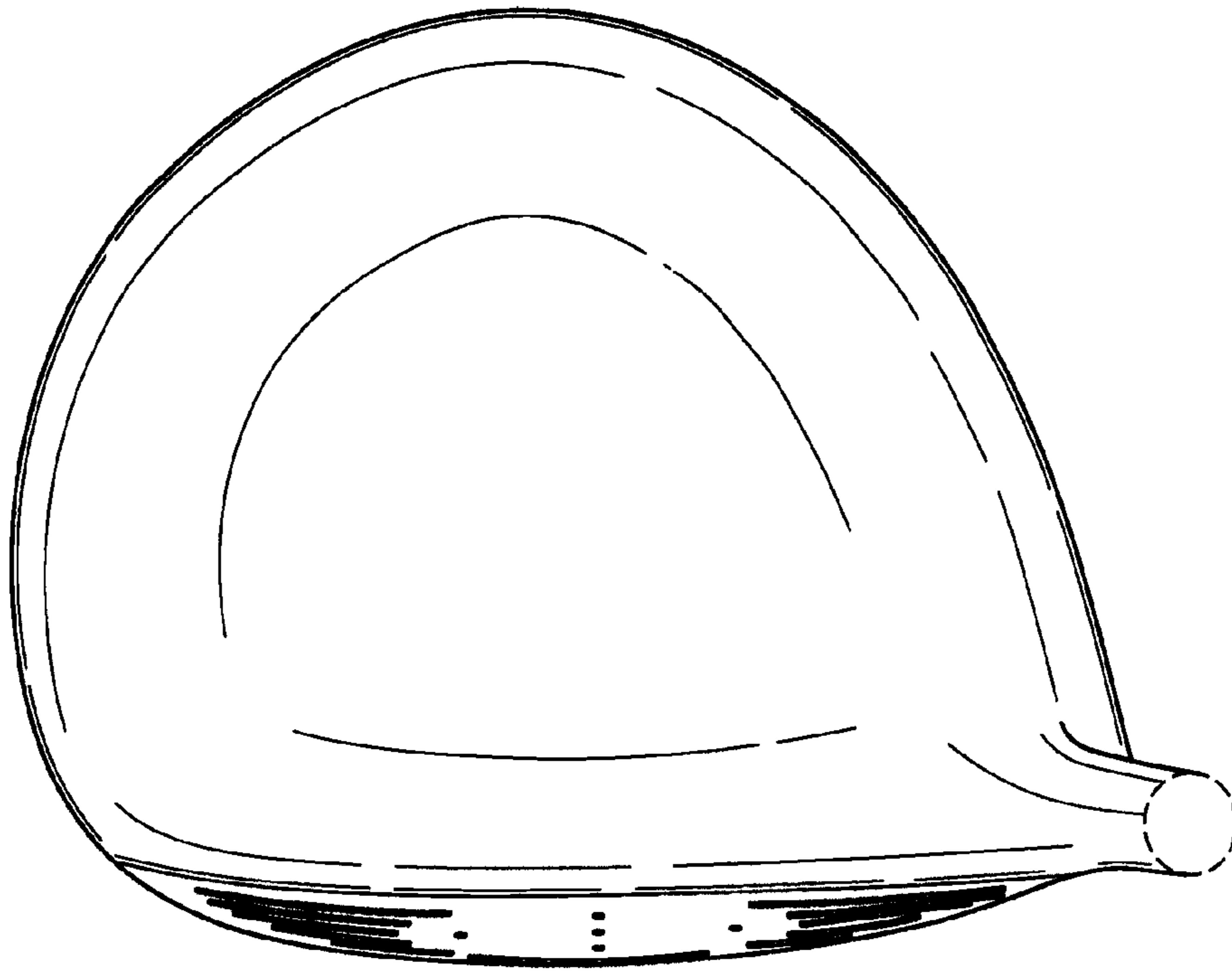

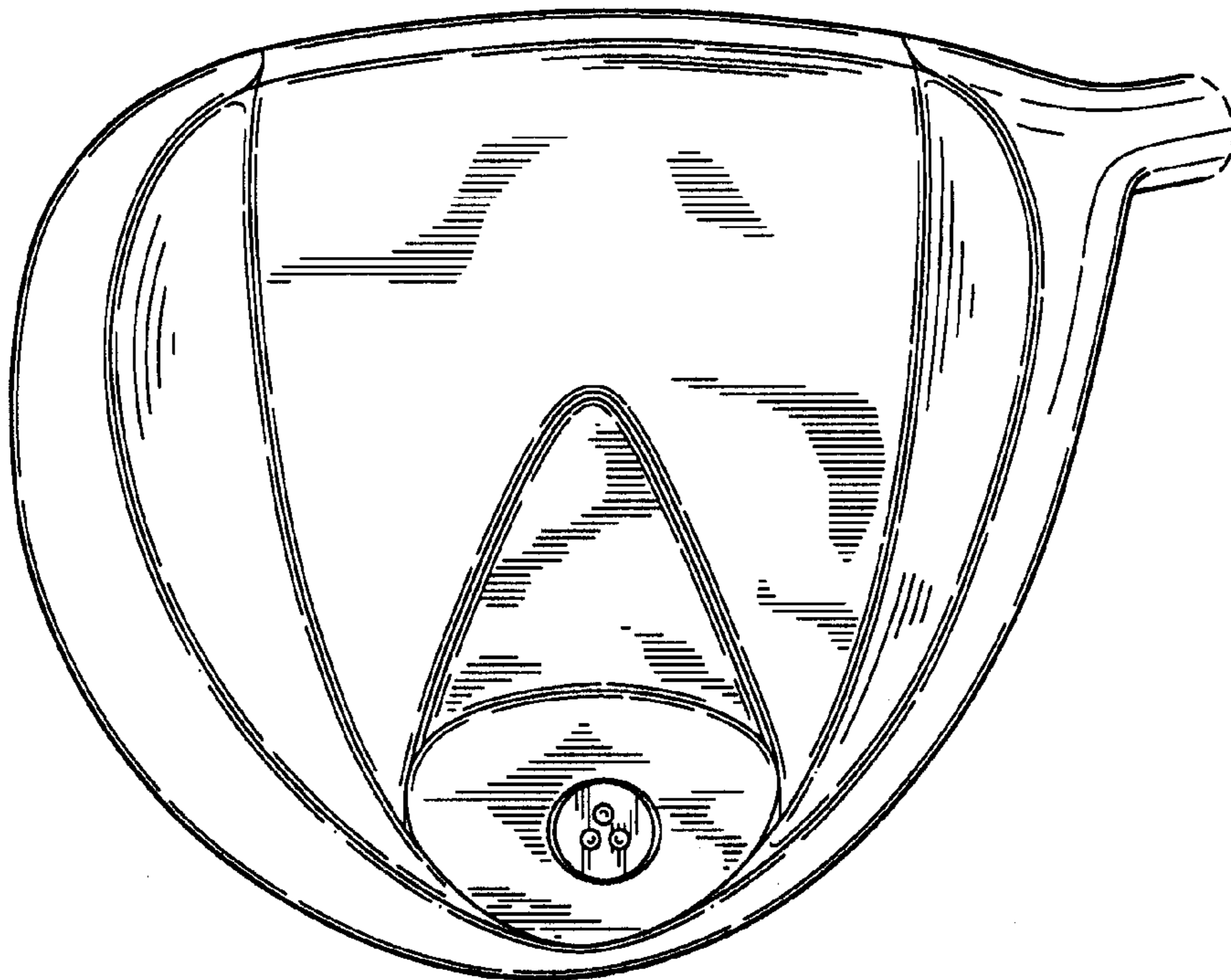

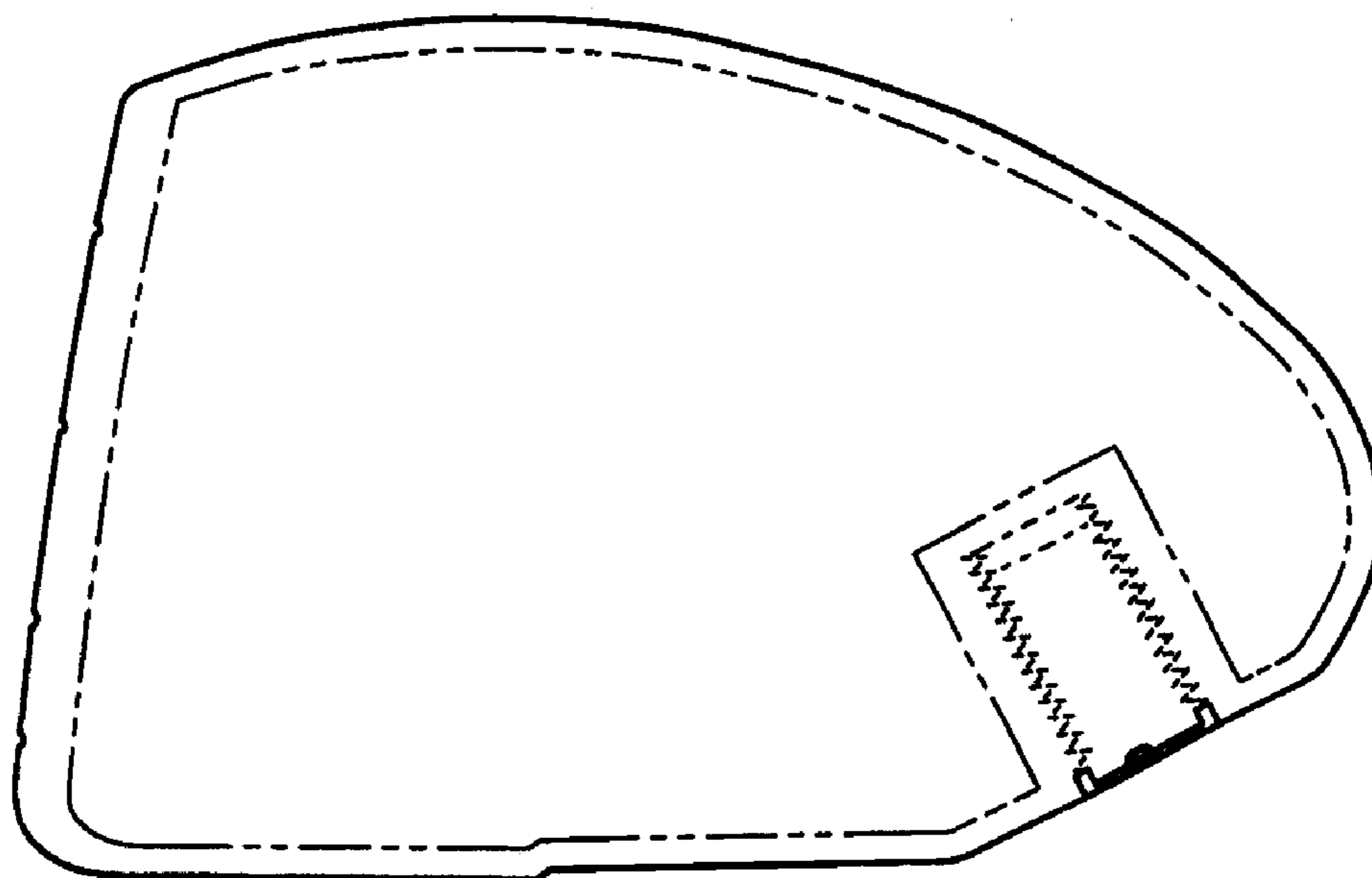

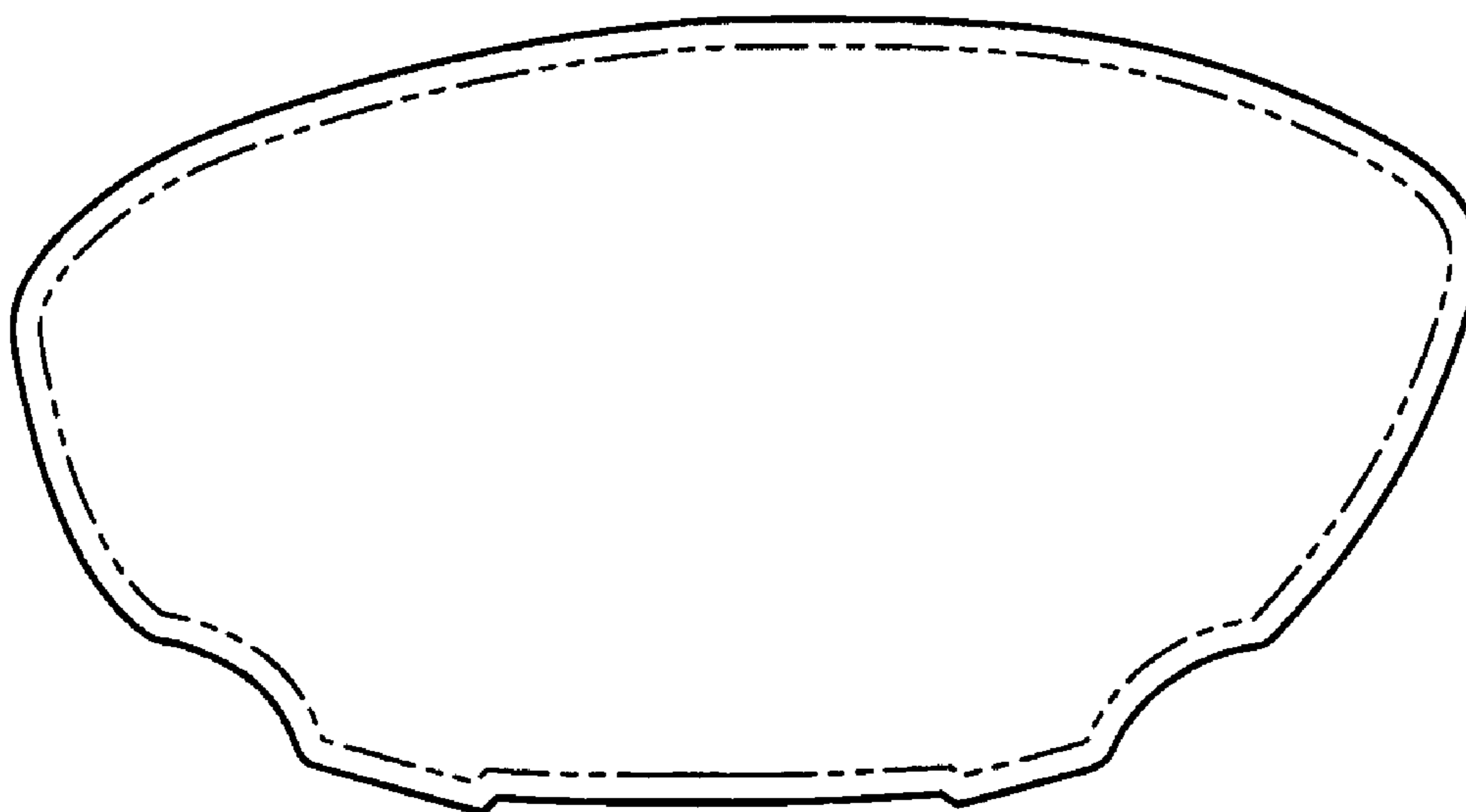
