DESCRIPTION

FIG. 1 is a front perspective view of a toe cap for a shoe in accordance with the new design;

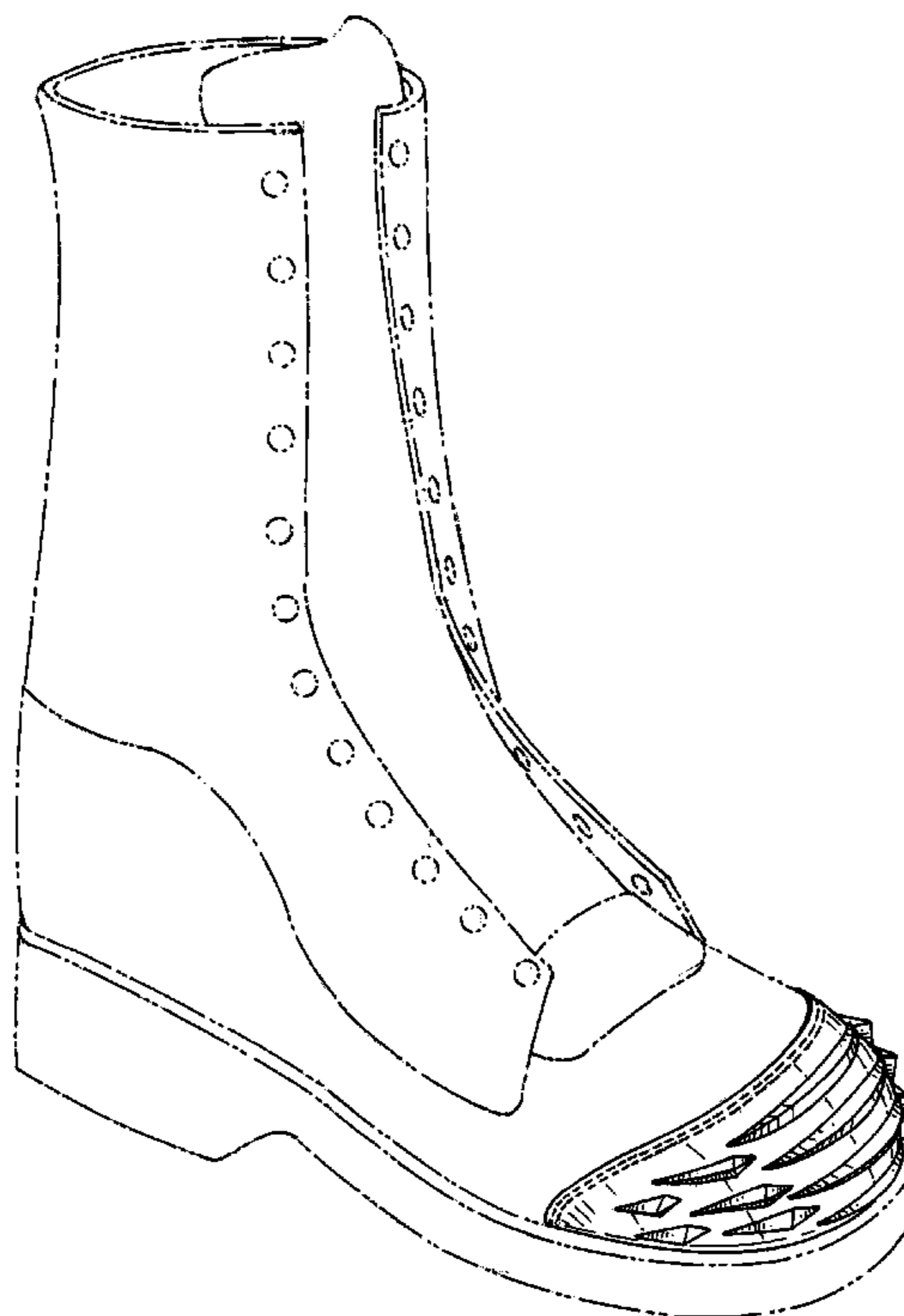
FIG. 2 is a front view of the toe cap in accordance with the new design shown in FIG. 1;

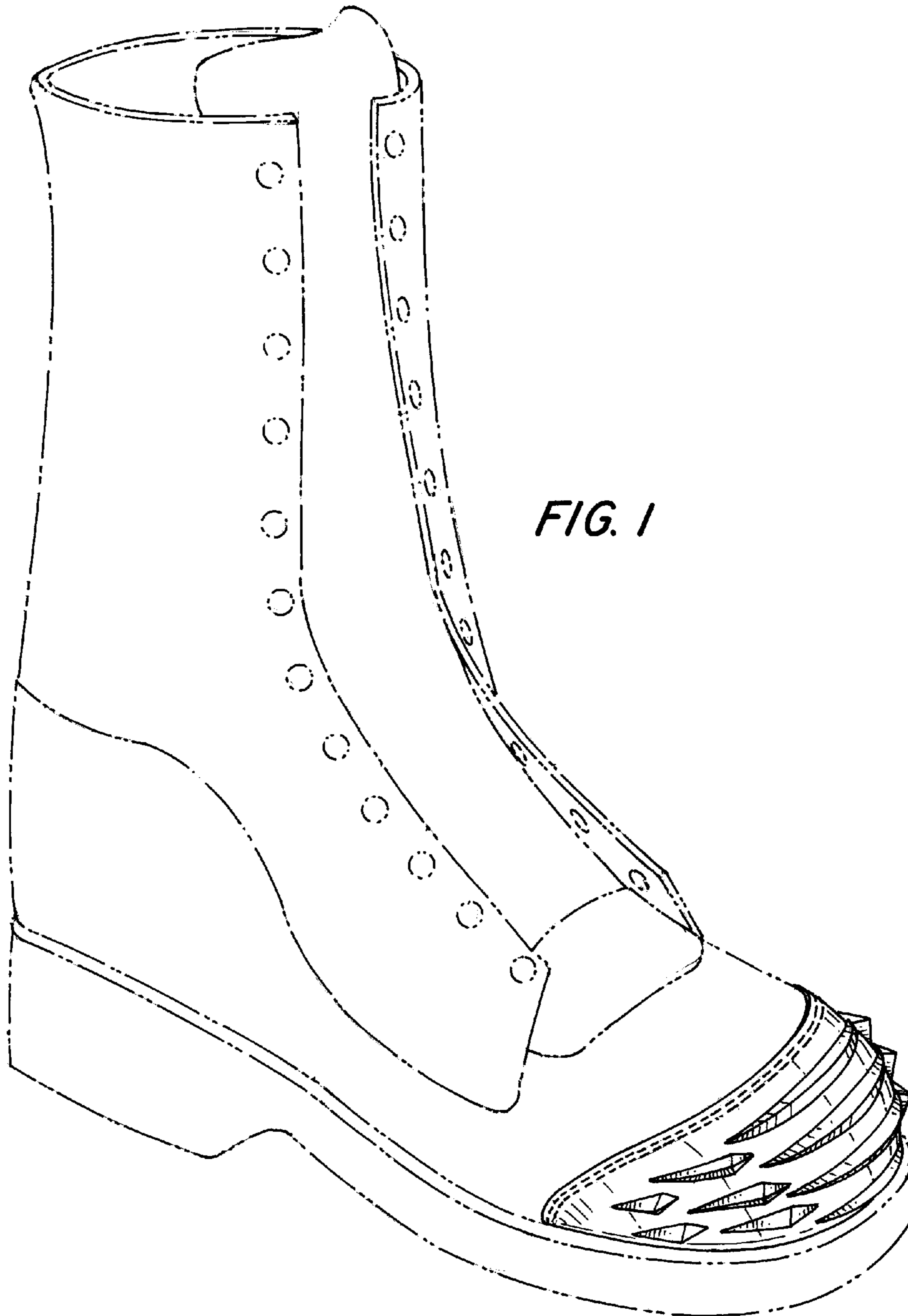

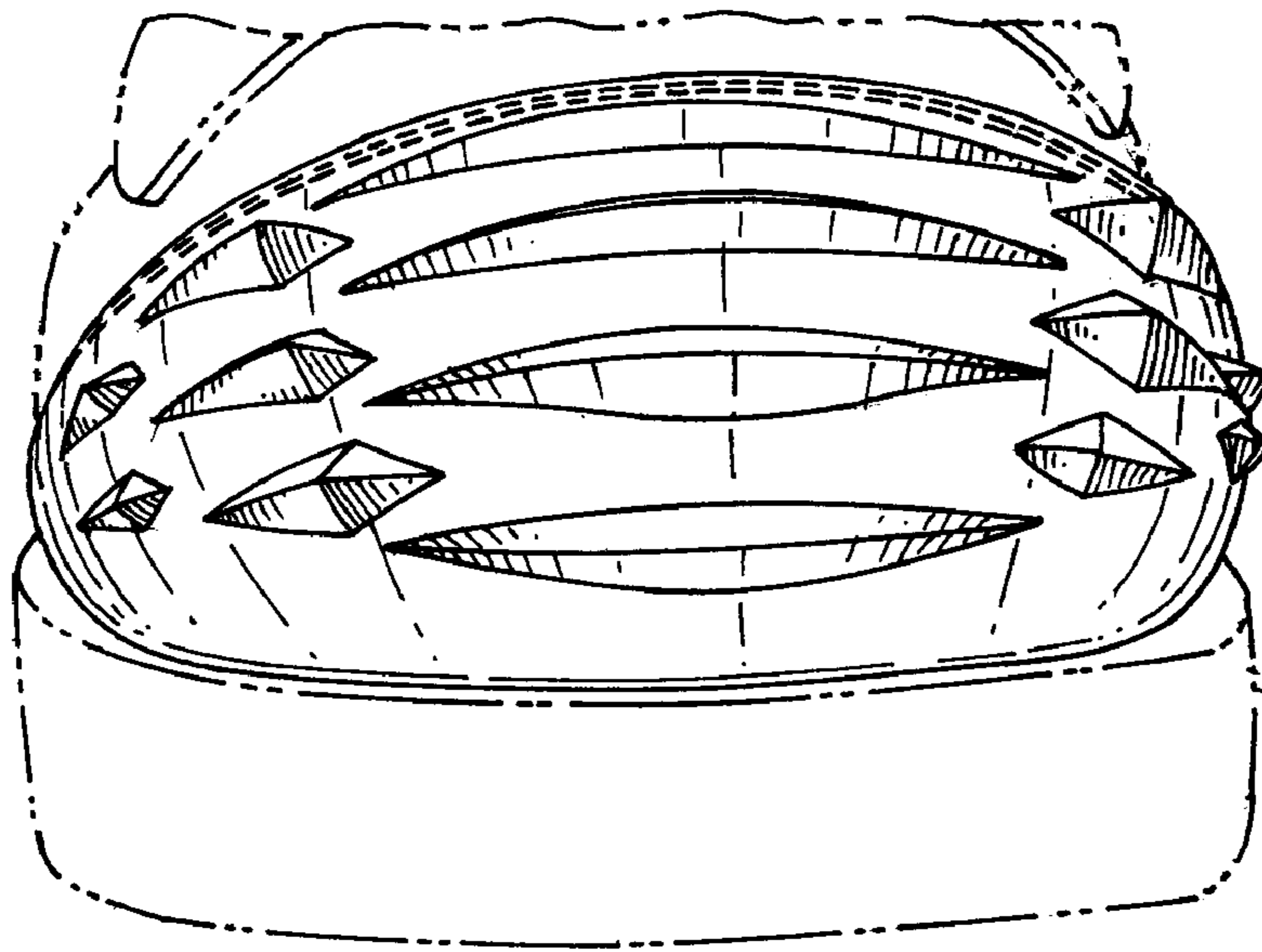

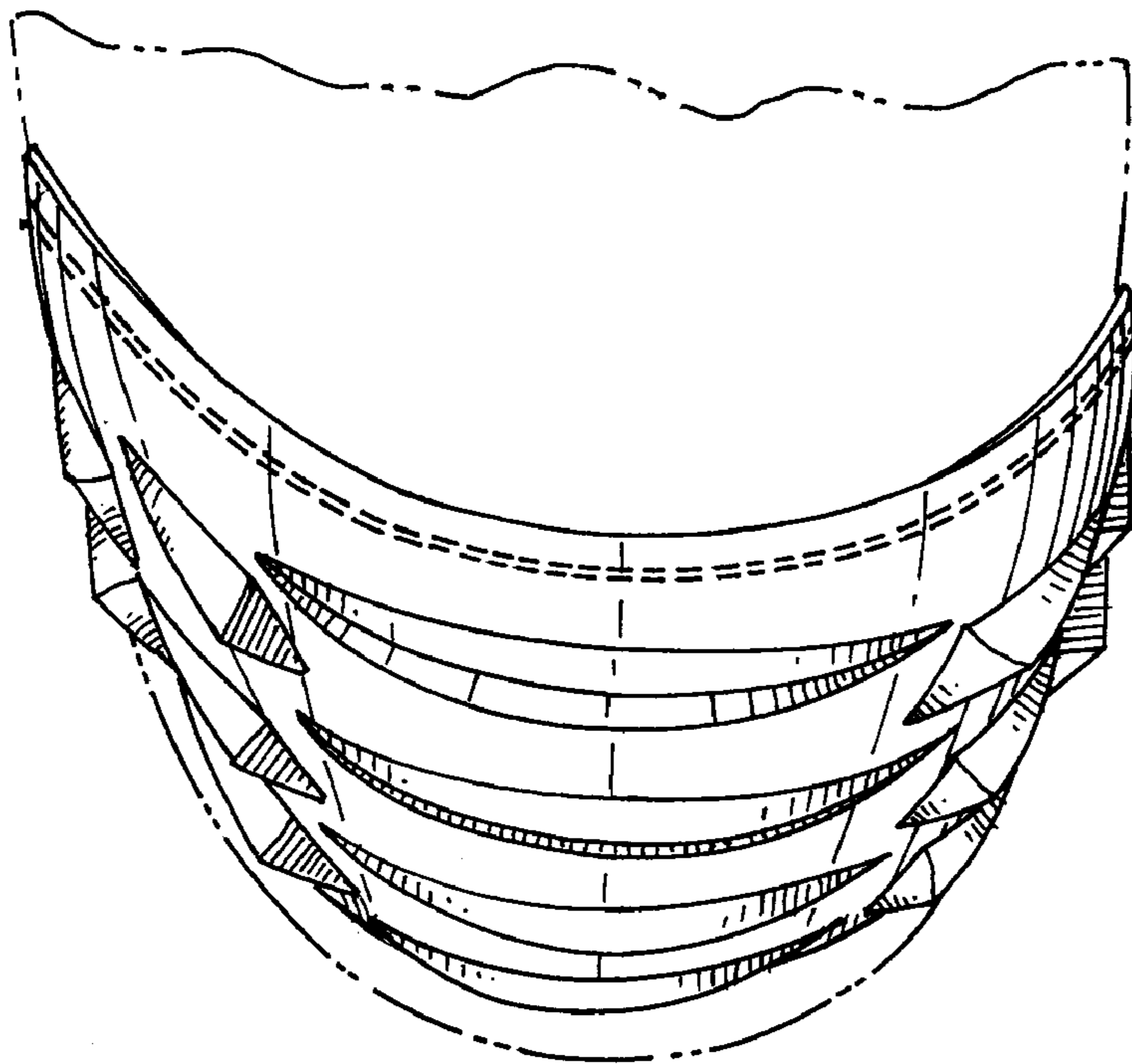

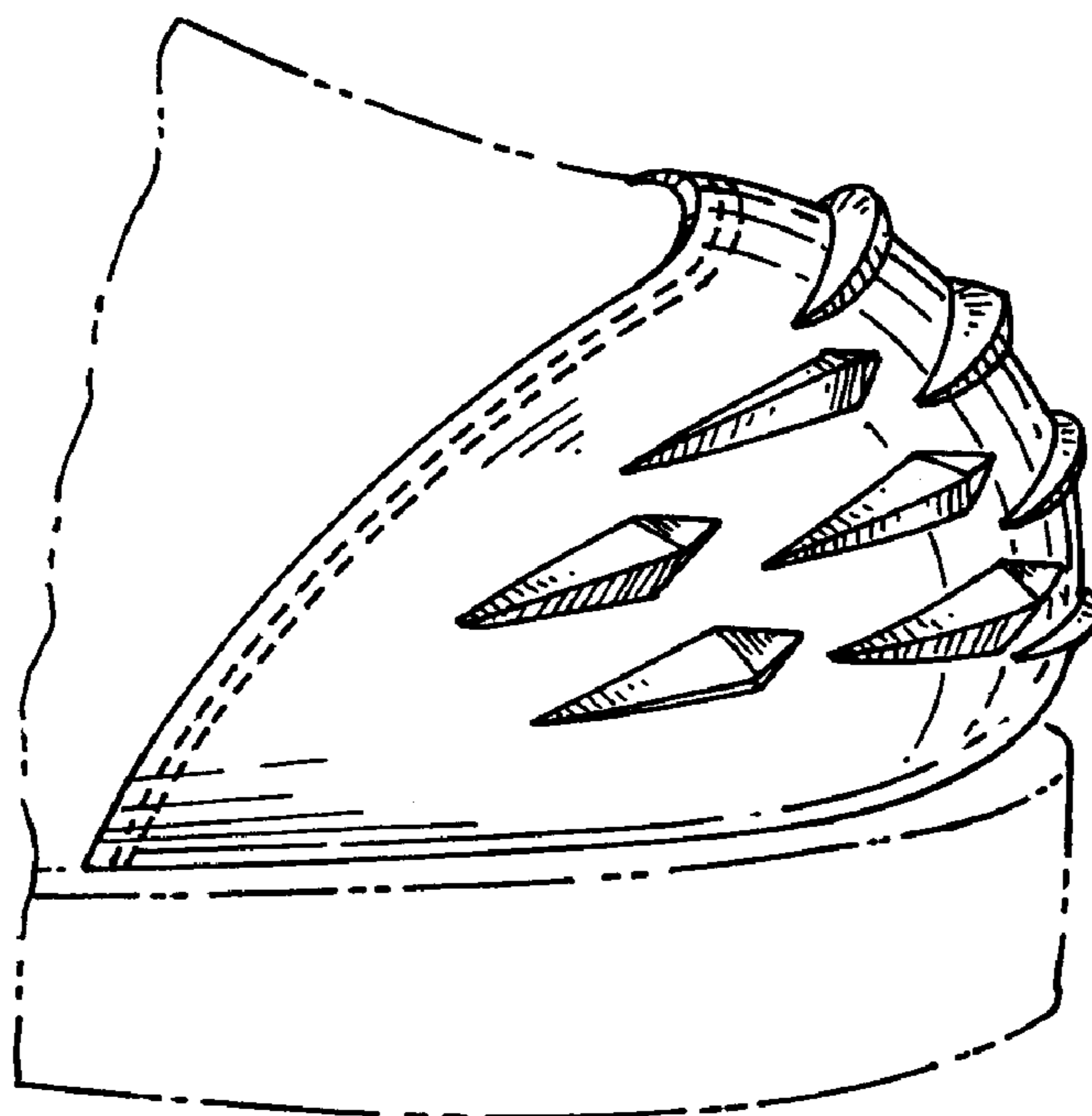
