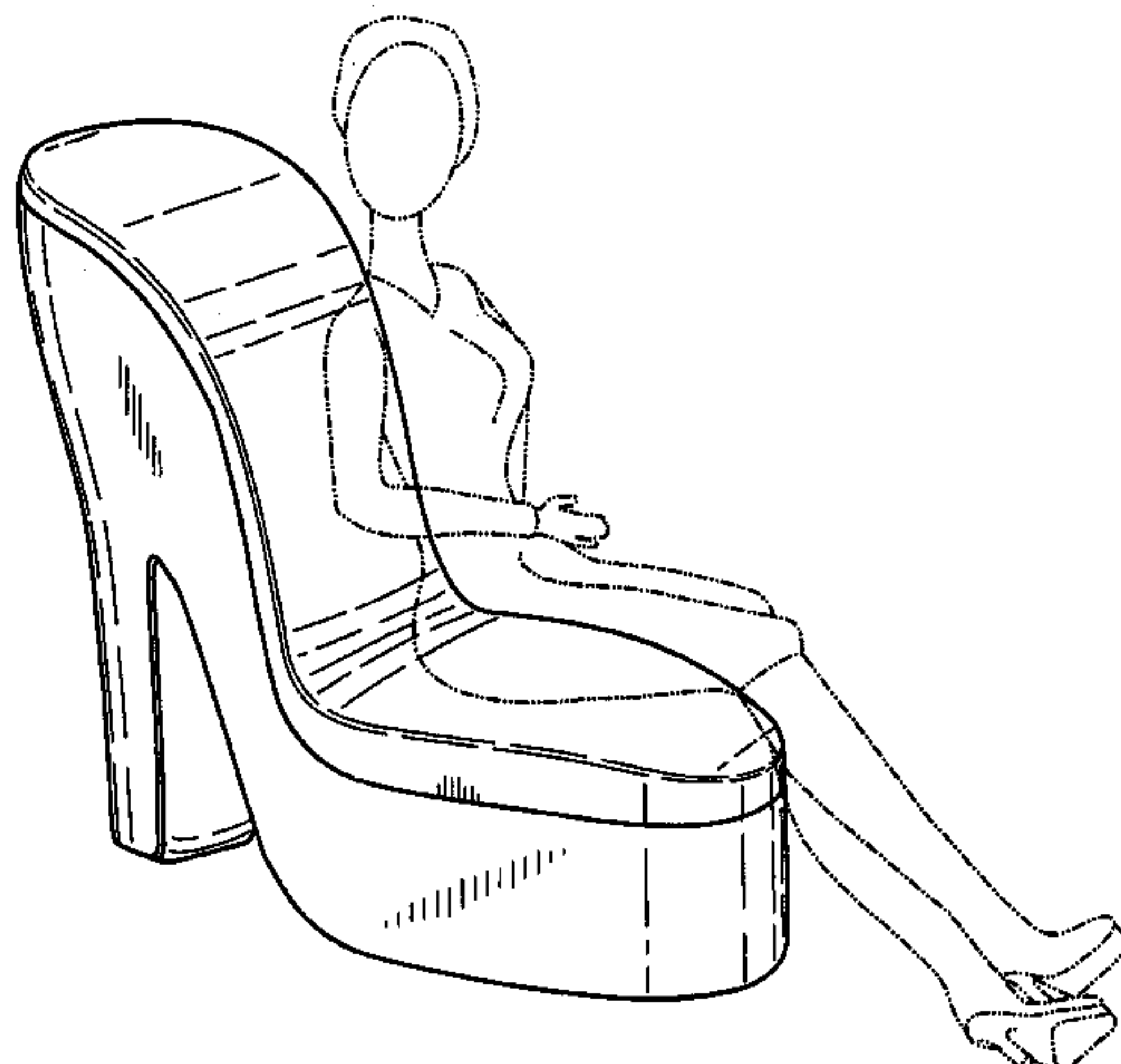
(57) **CLAIM**

I claim the ornamental design for a shoe chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a top right front perspective view of a shoe chair showing my new design.  
FIG. 2 is a right side elevational view of the shoe chair of FIG. 1, the left side elevational view being a mirror image thereof.  
FIG. 3 is a rear elevational view of the shoe chair of FIG. 1.  
FIG. 4 is a front elevational view of the shoe chair of FIG. 1.  
FIG. 5 is a bottom plan view of the shoe chair of FIG. 1; and, FIG. 6 is a top plan view of the shoe chair of FIG. 1.

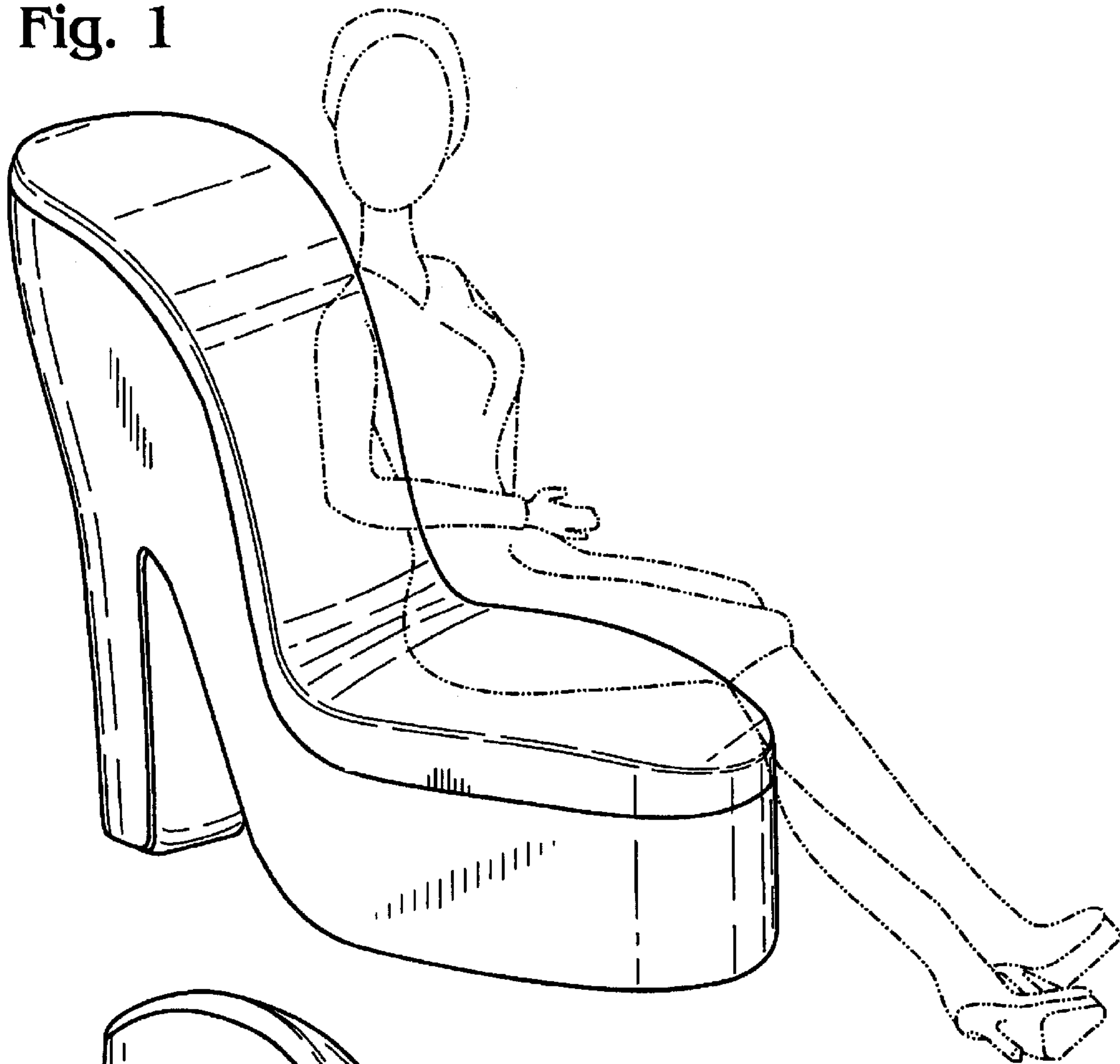

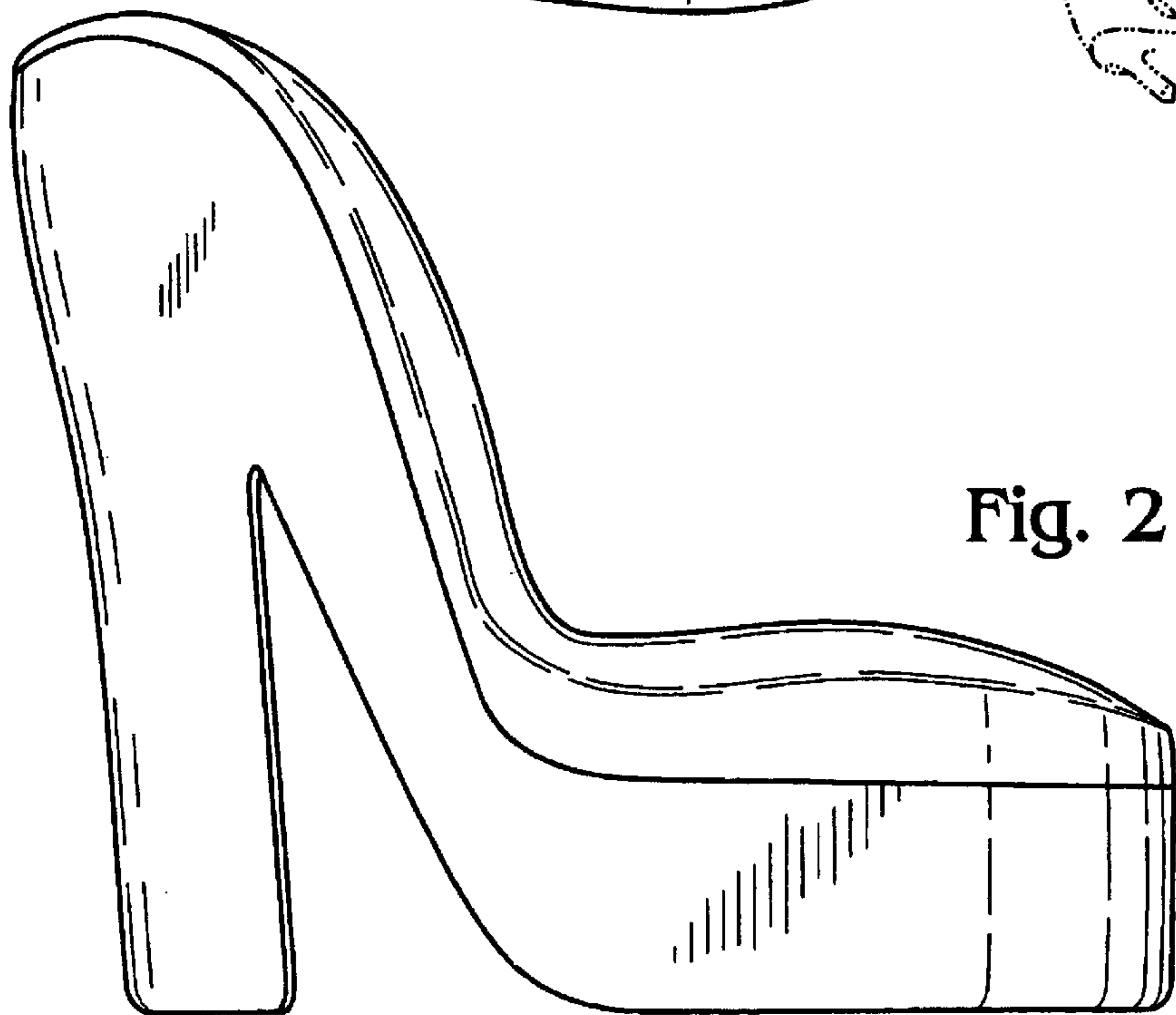

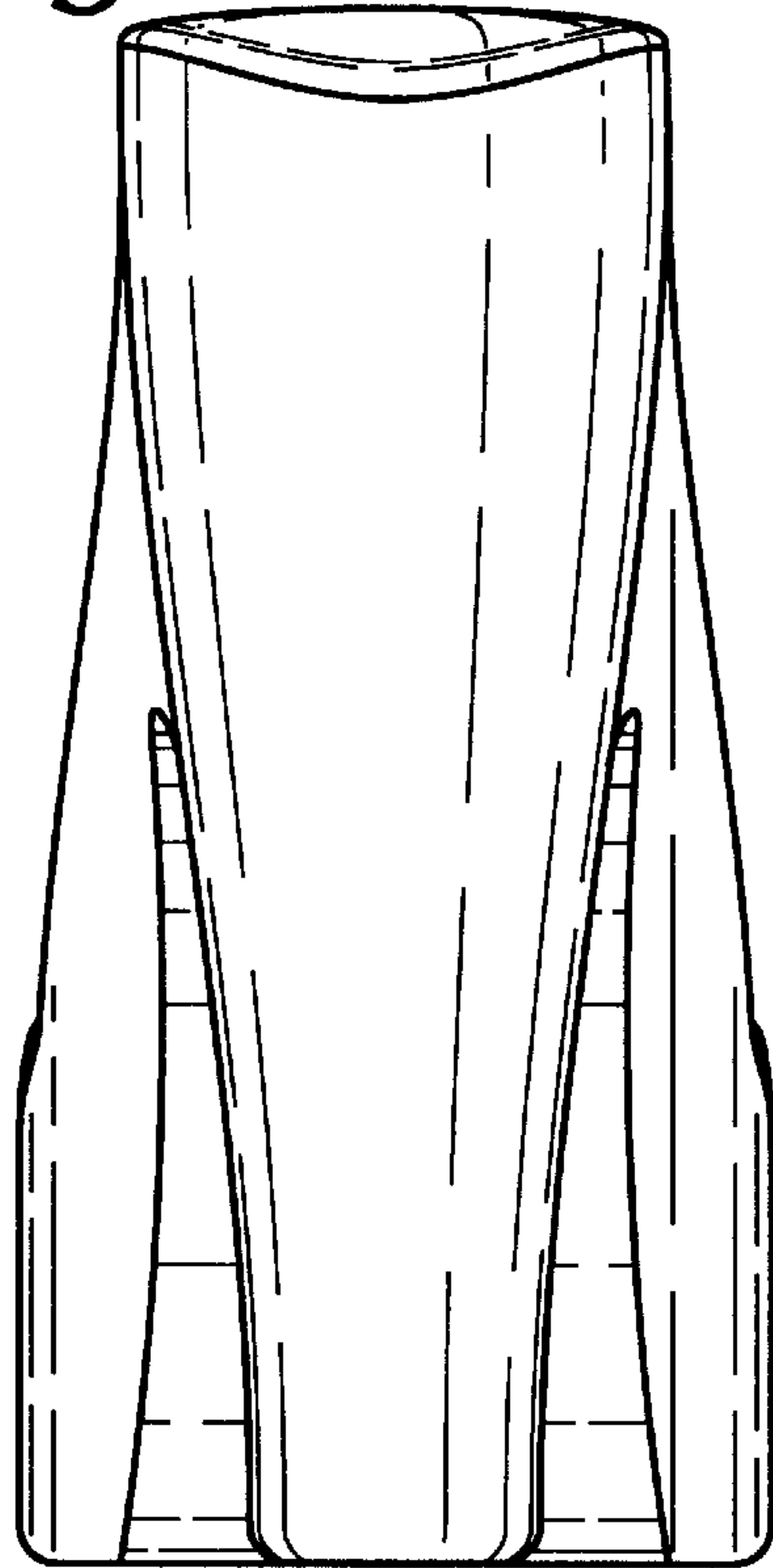

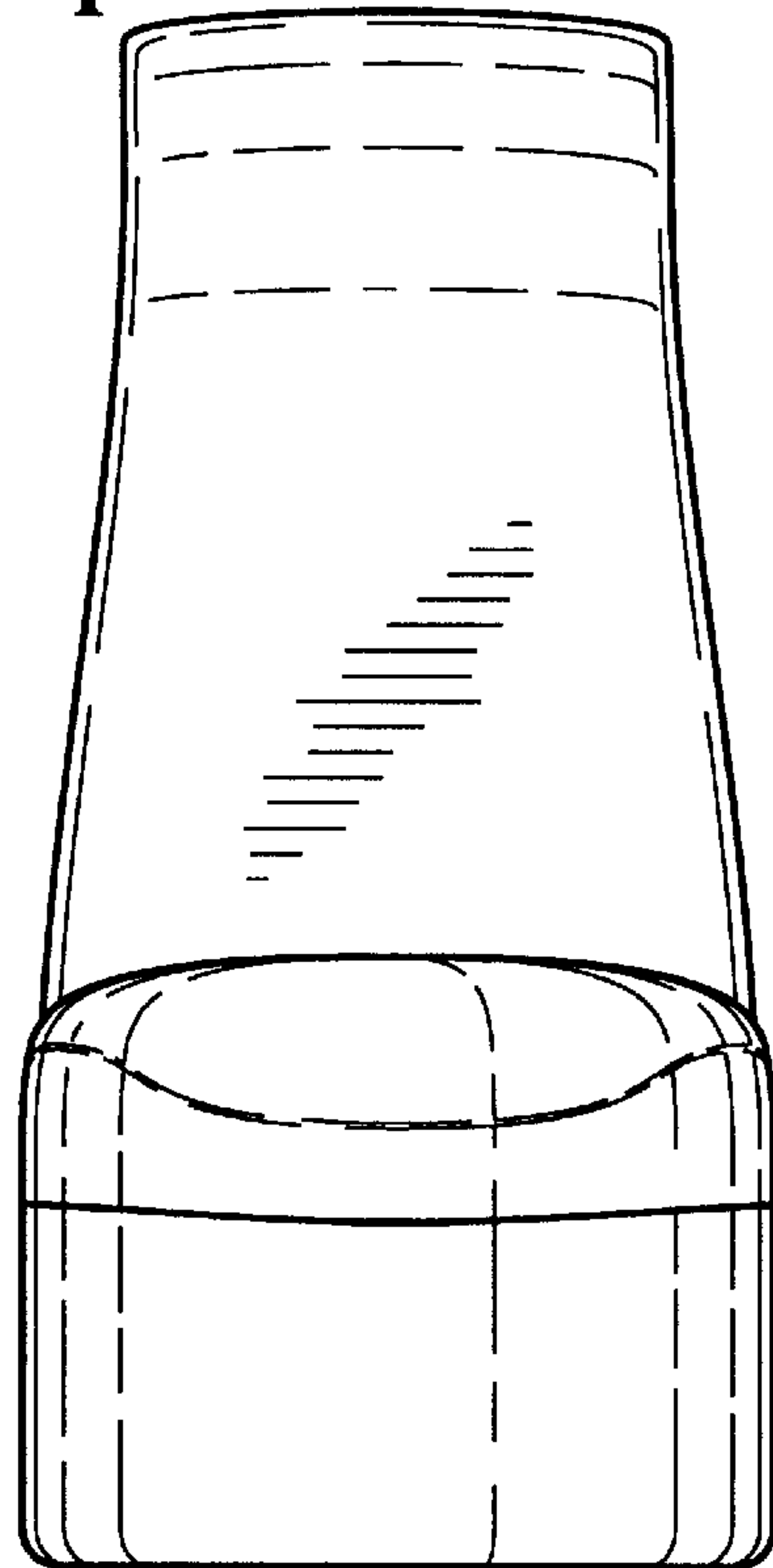

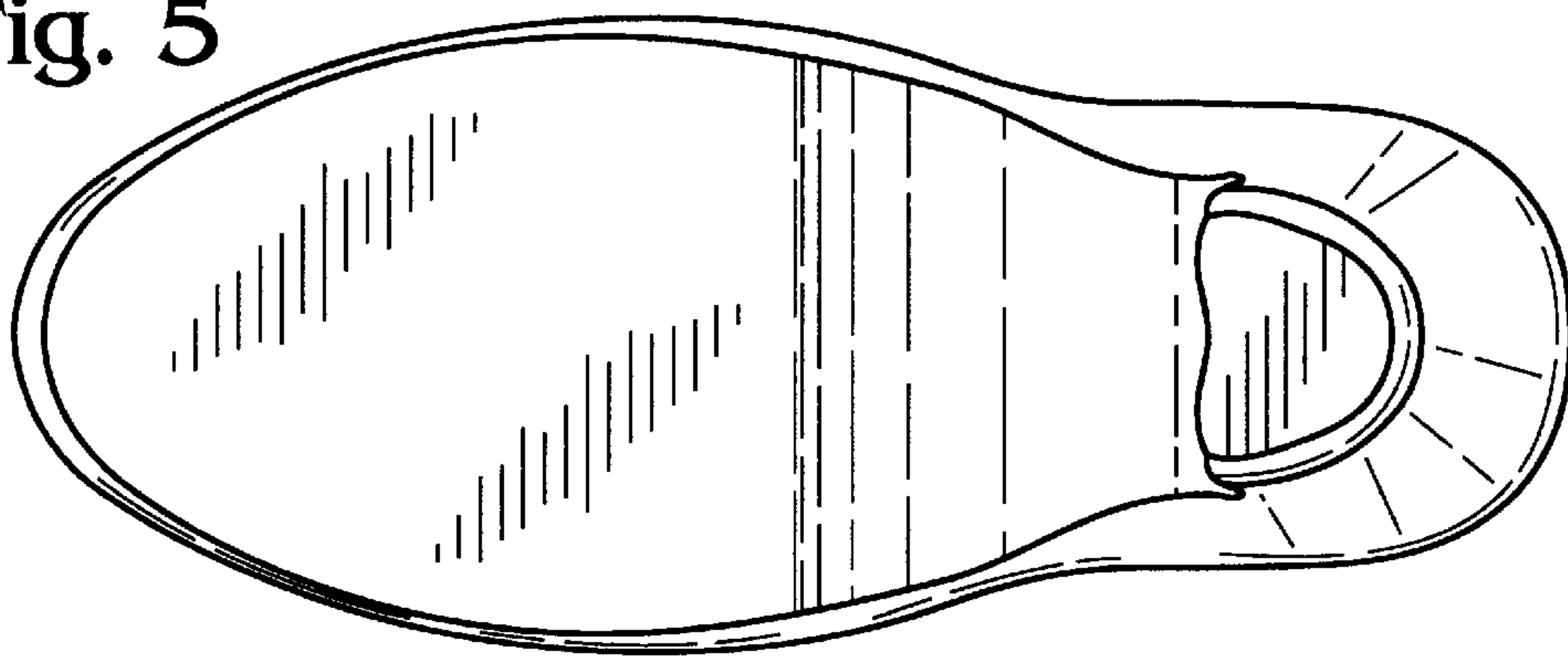
