**DESCRIPTION**

FIG. 20 is a rear elevational view thereof;

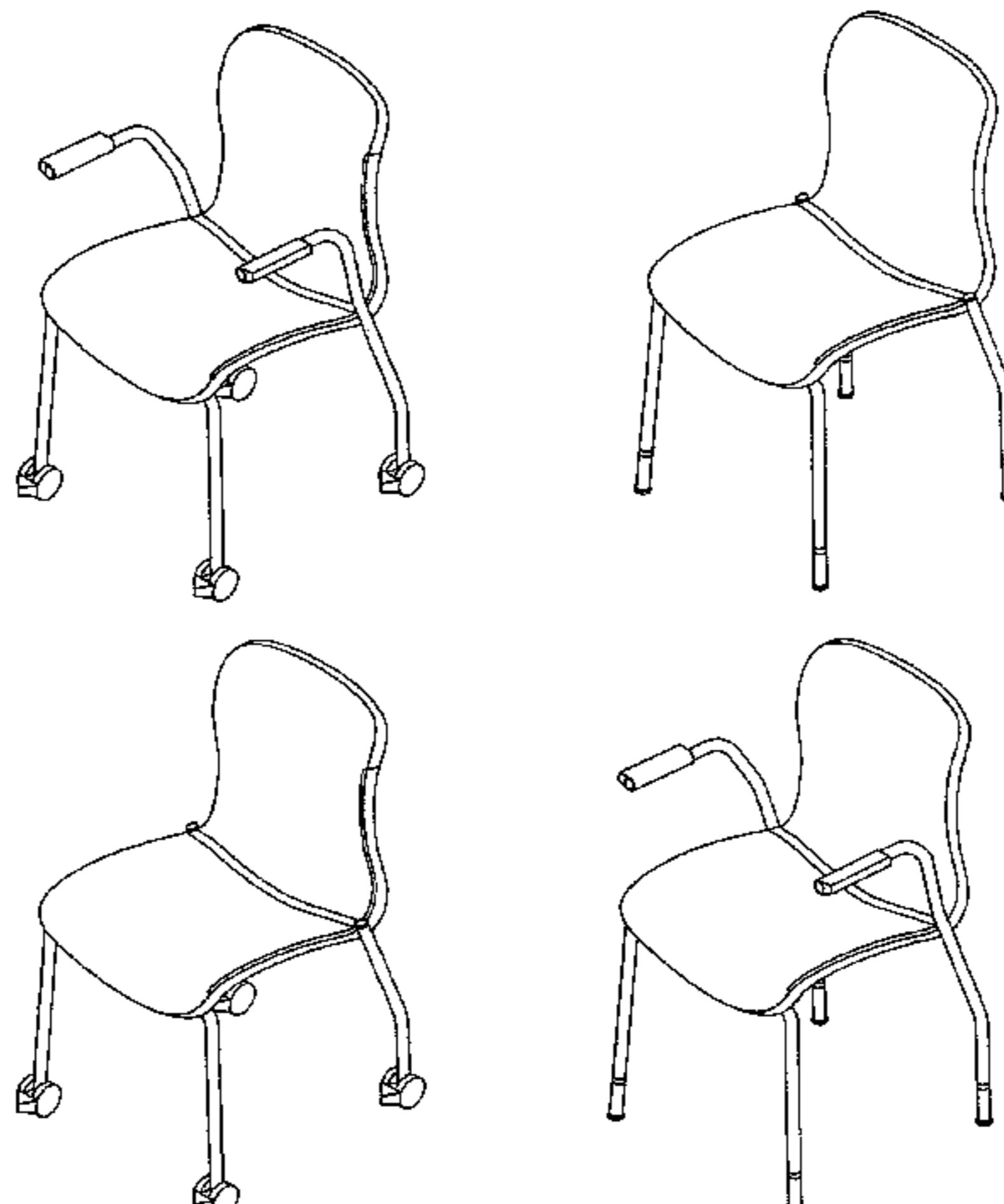
FIG. 21 is a top plan view thereof;

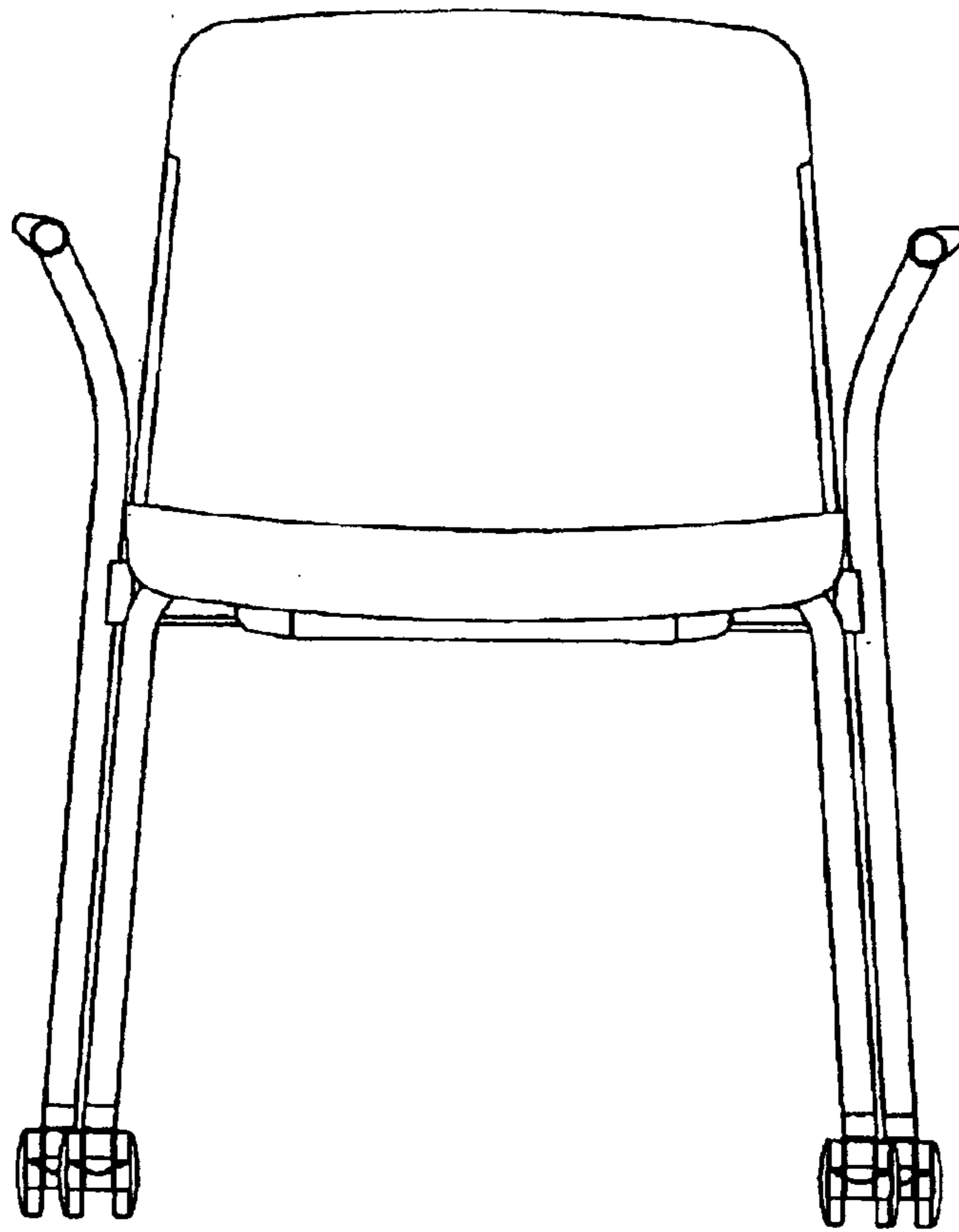

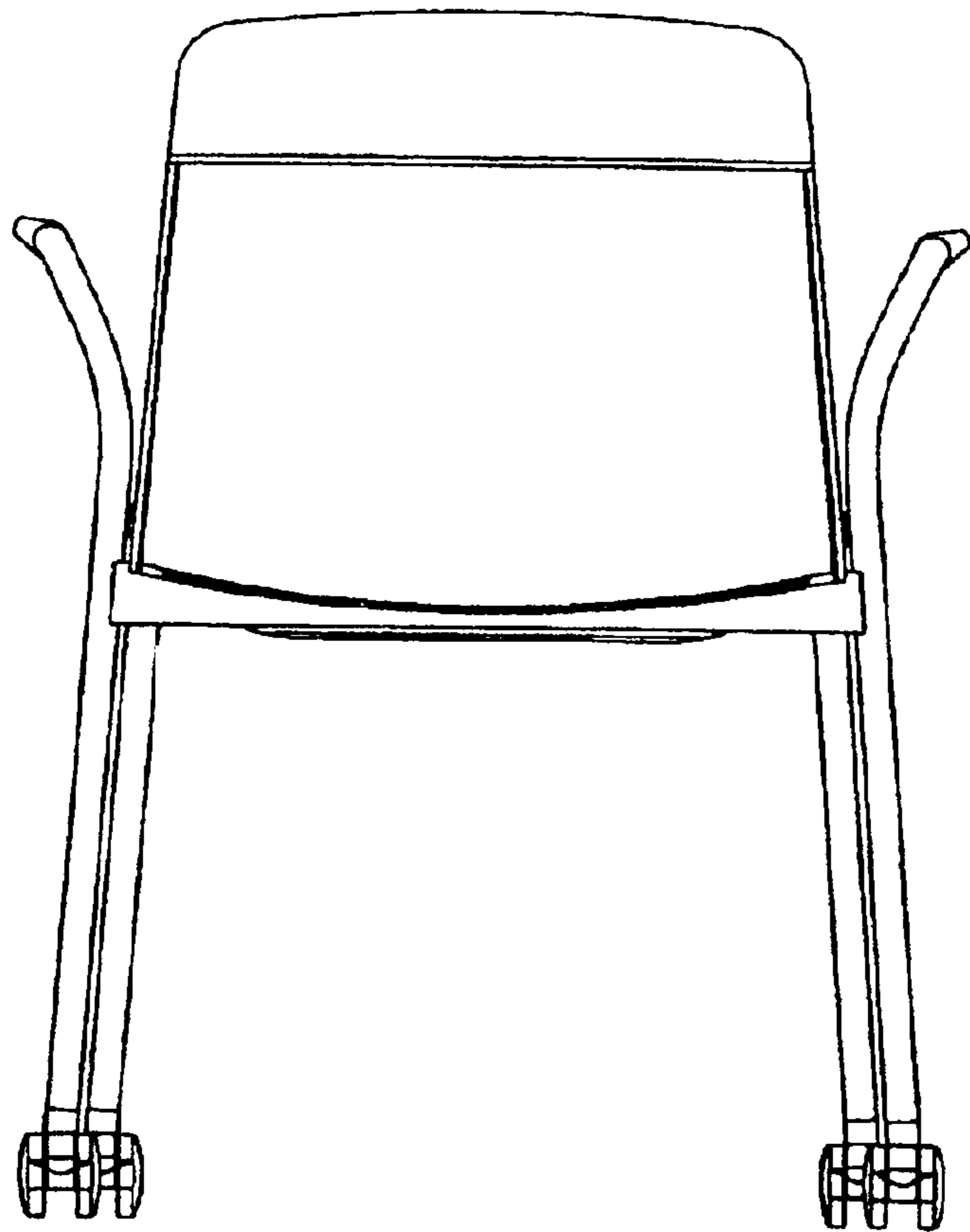

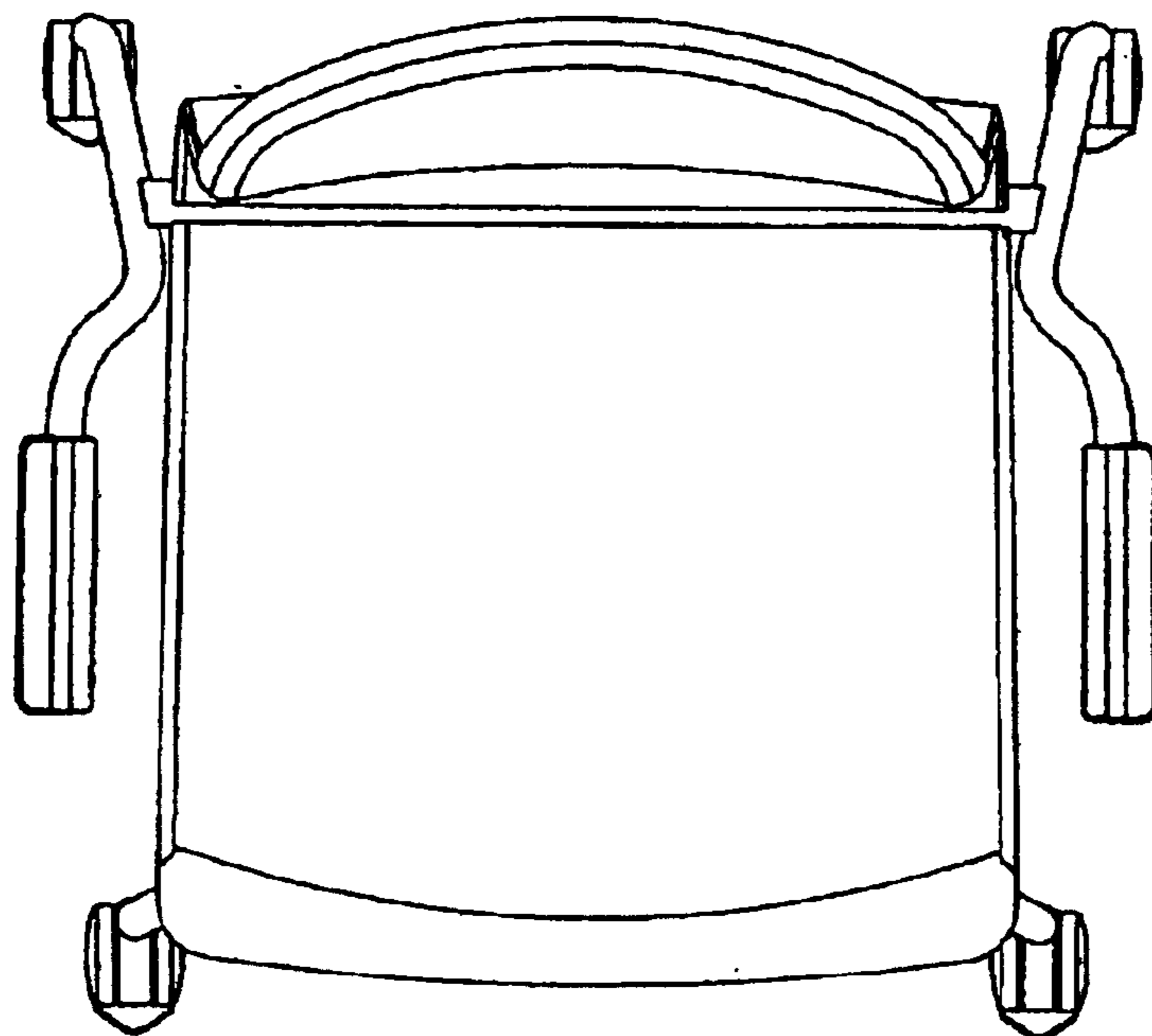

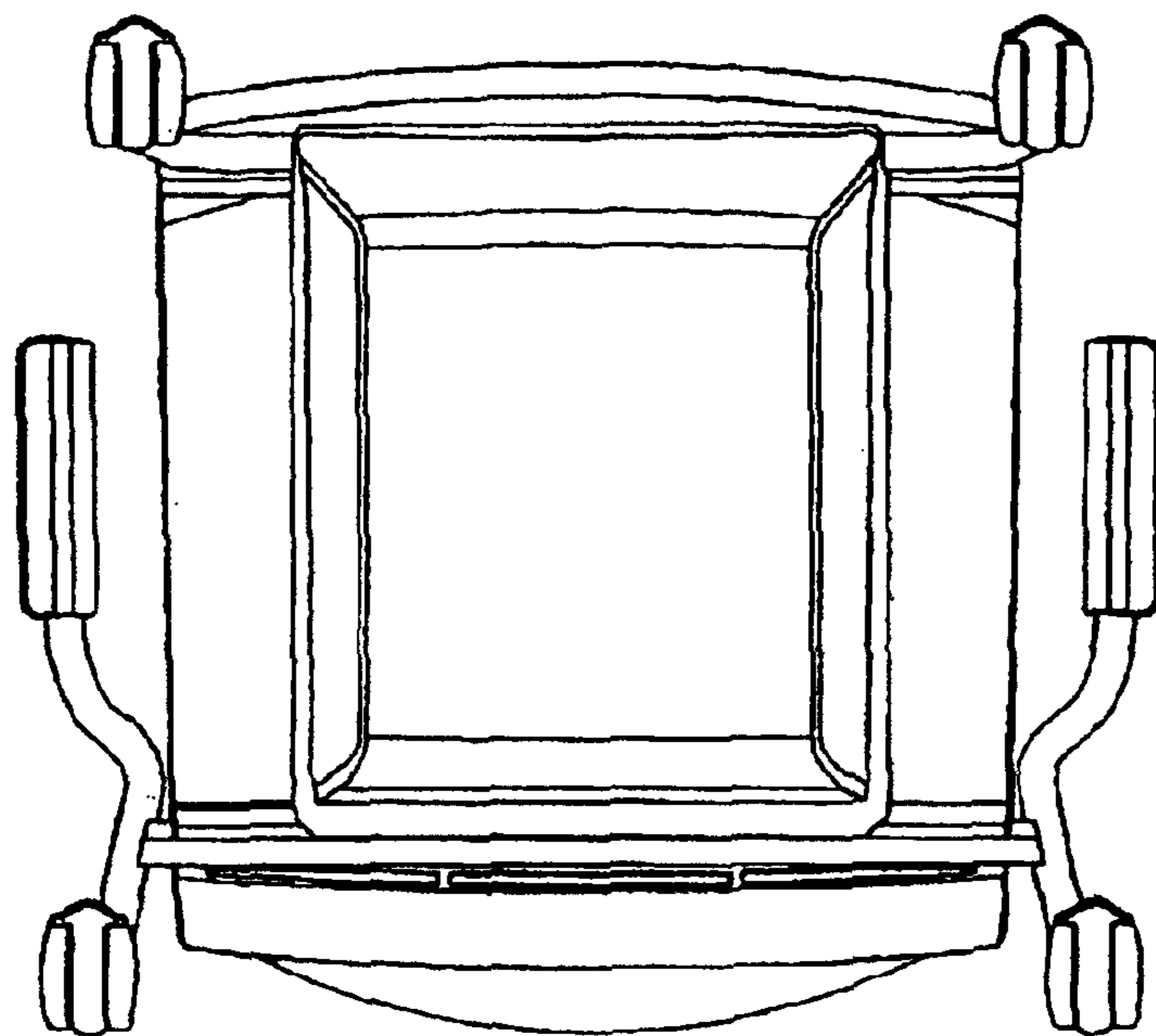

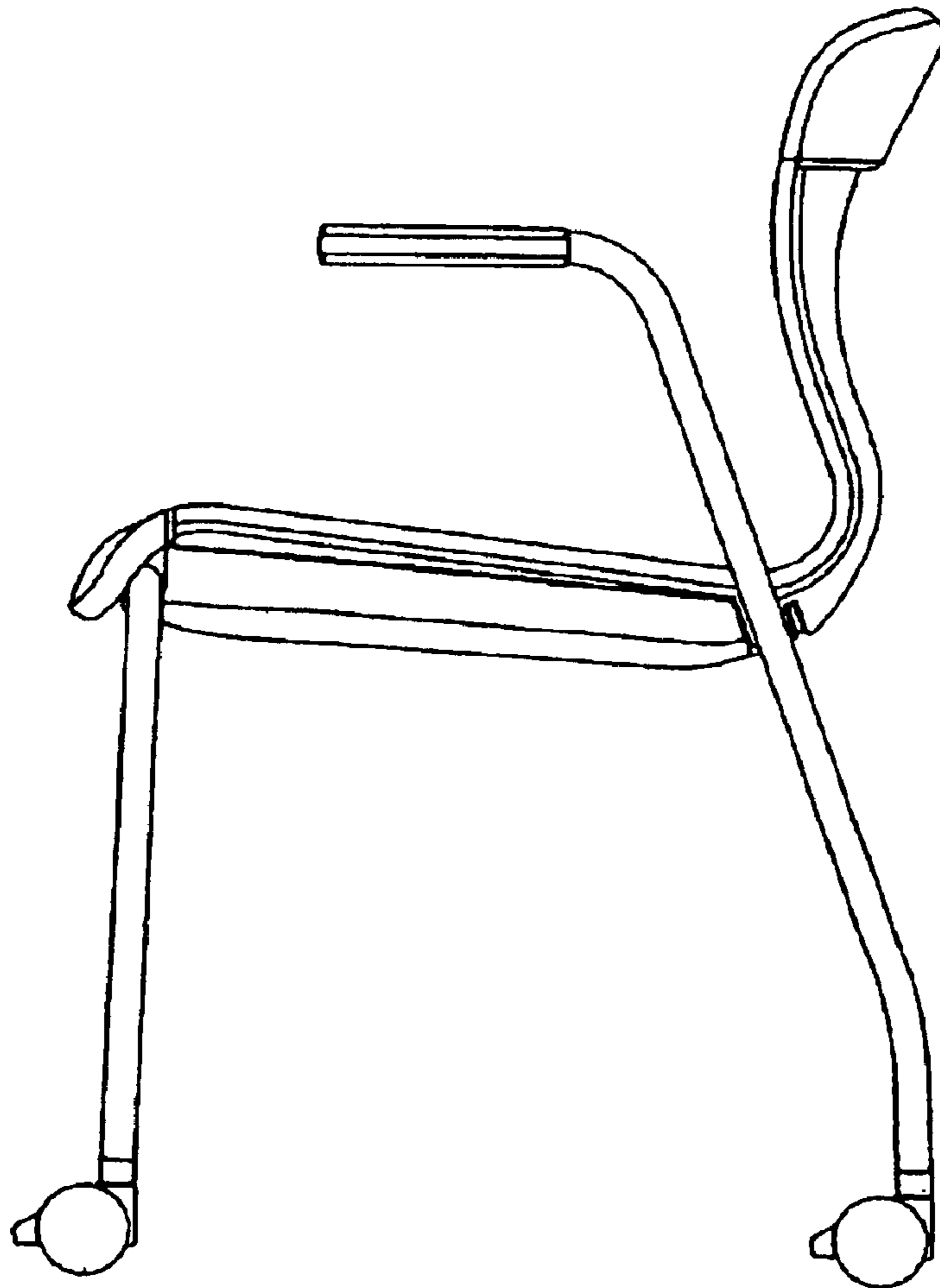

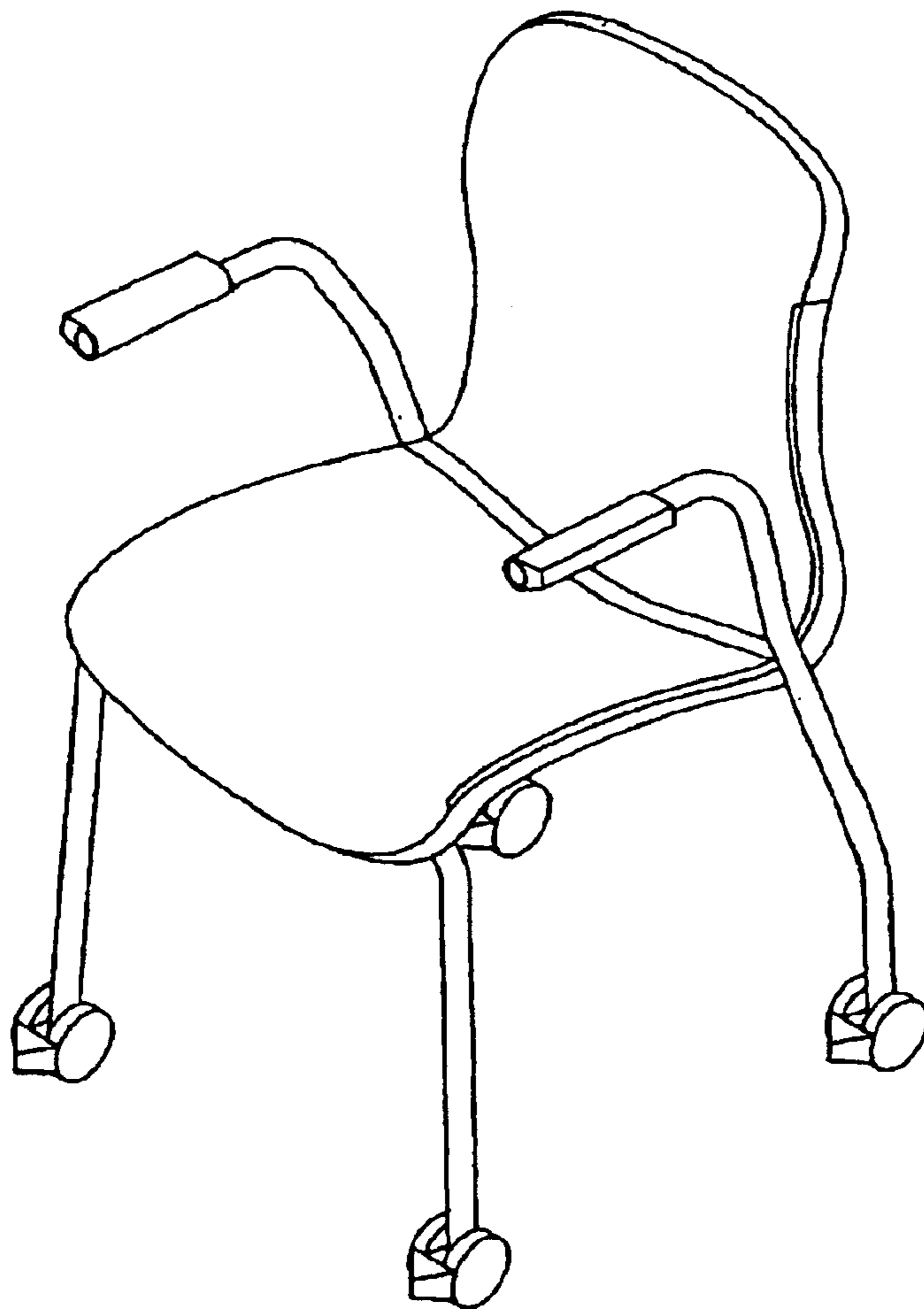

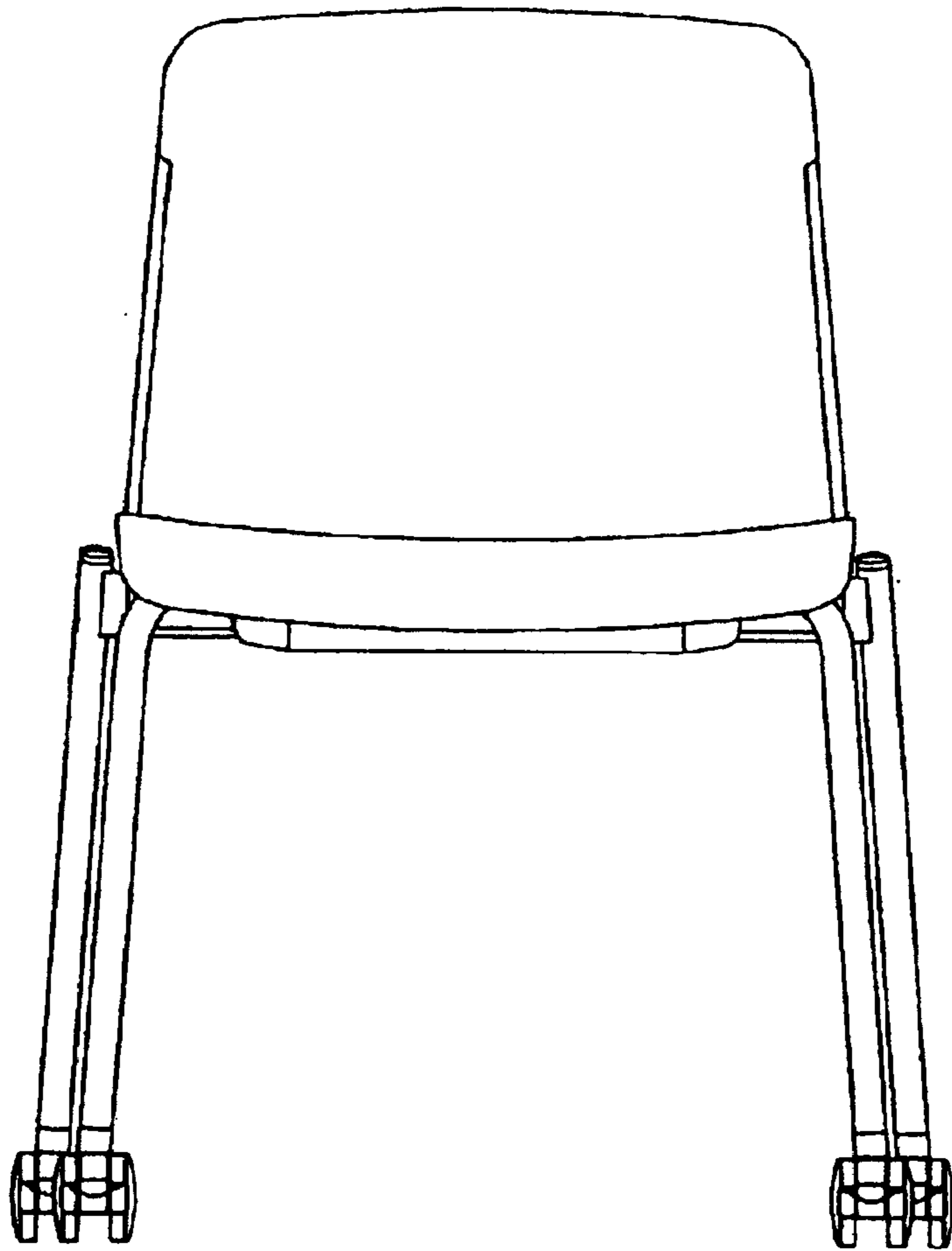

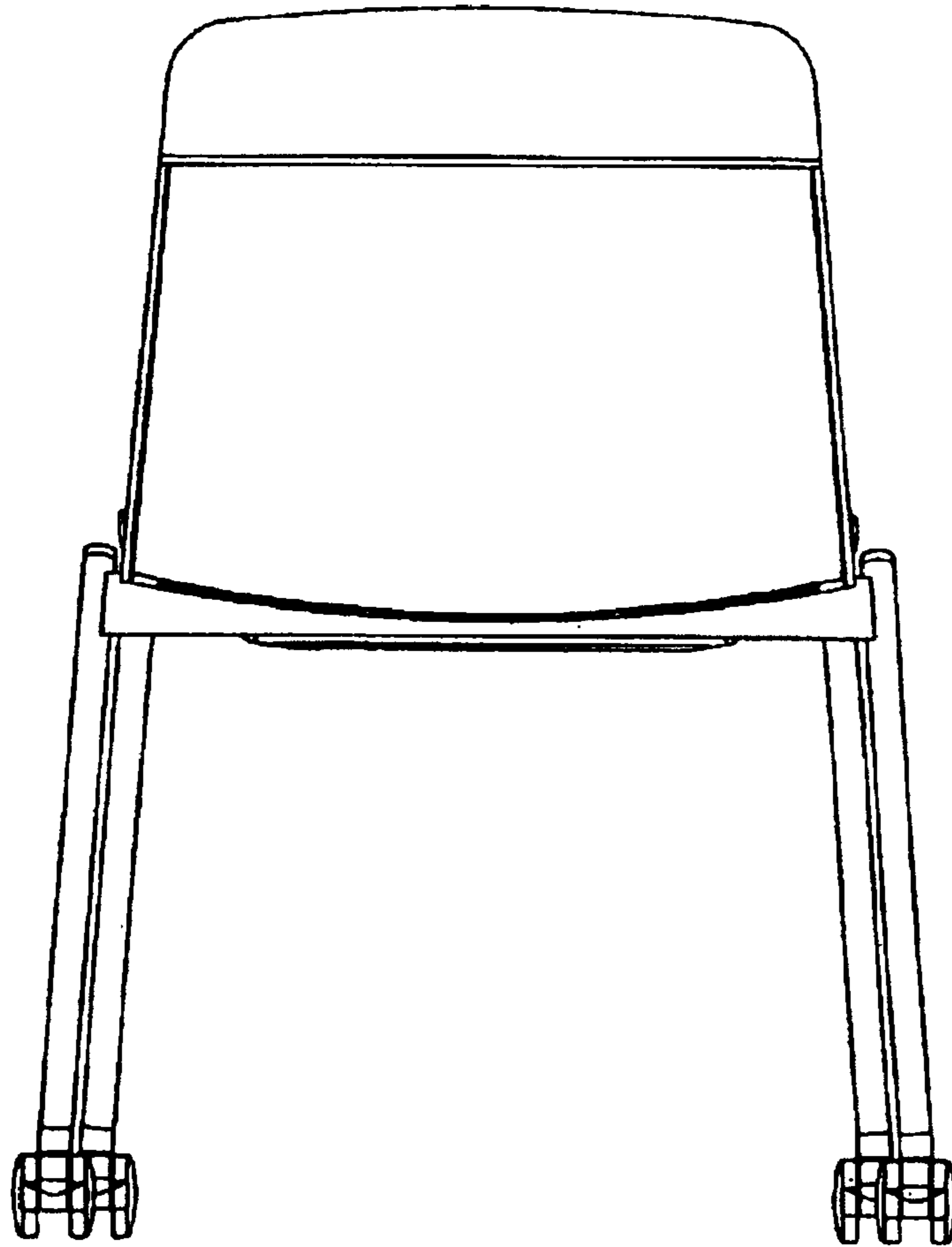

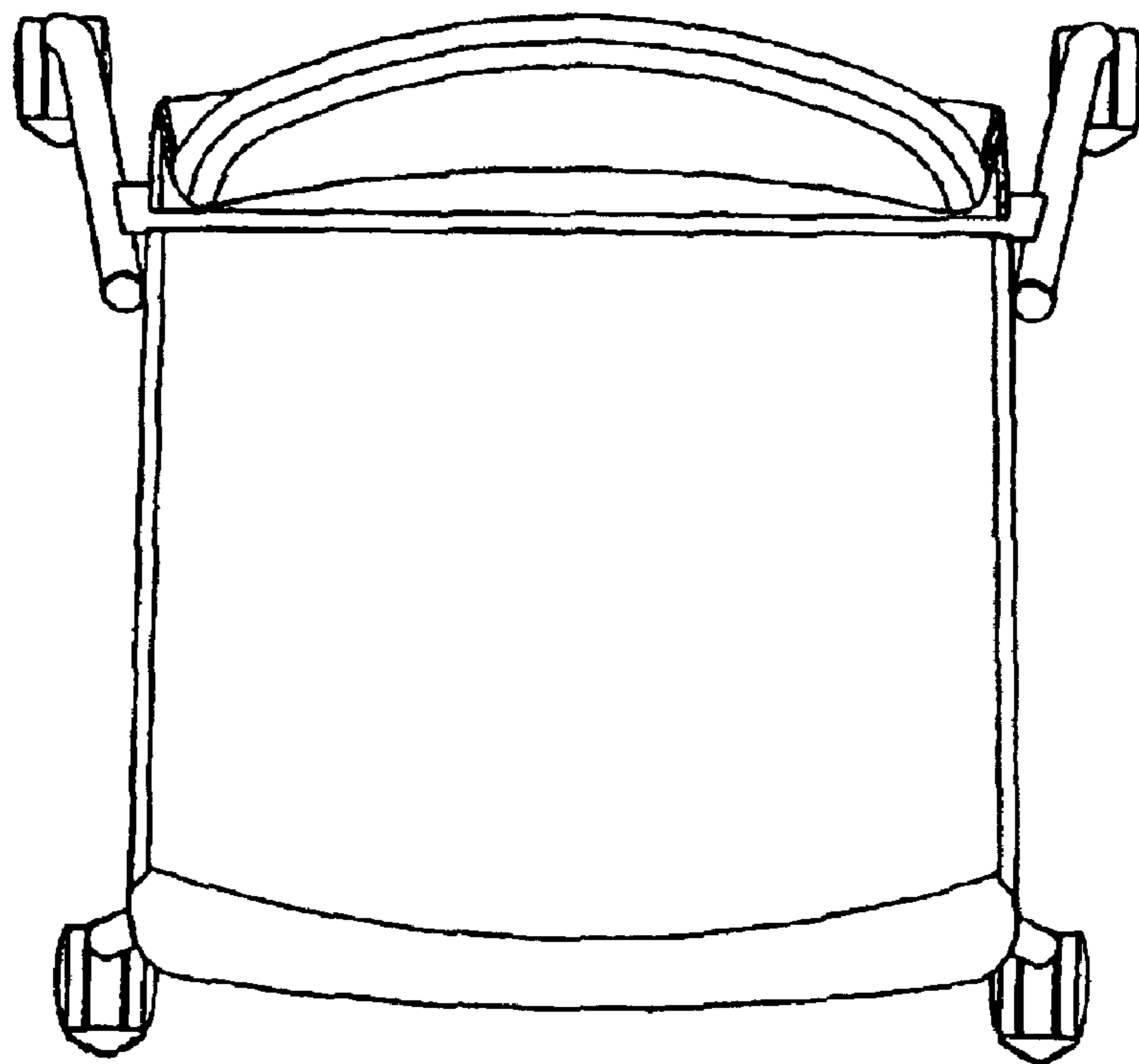

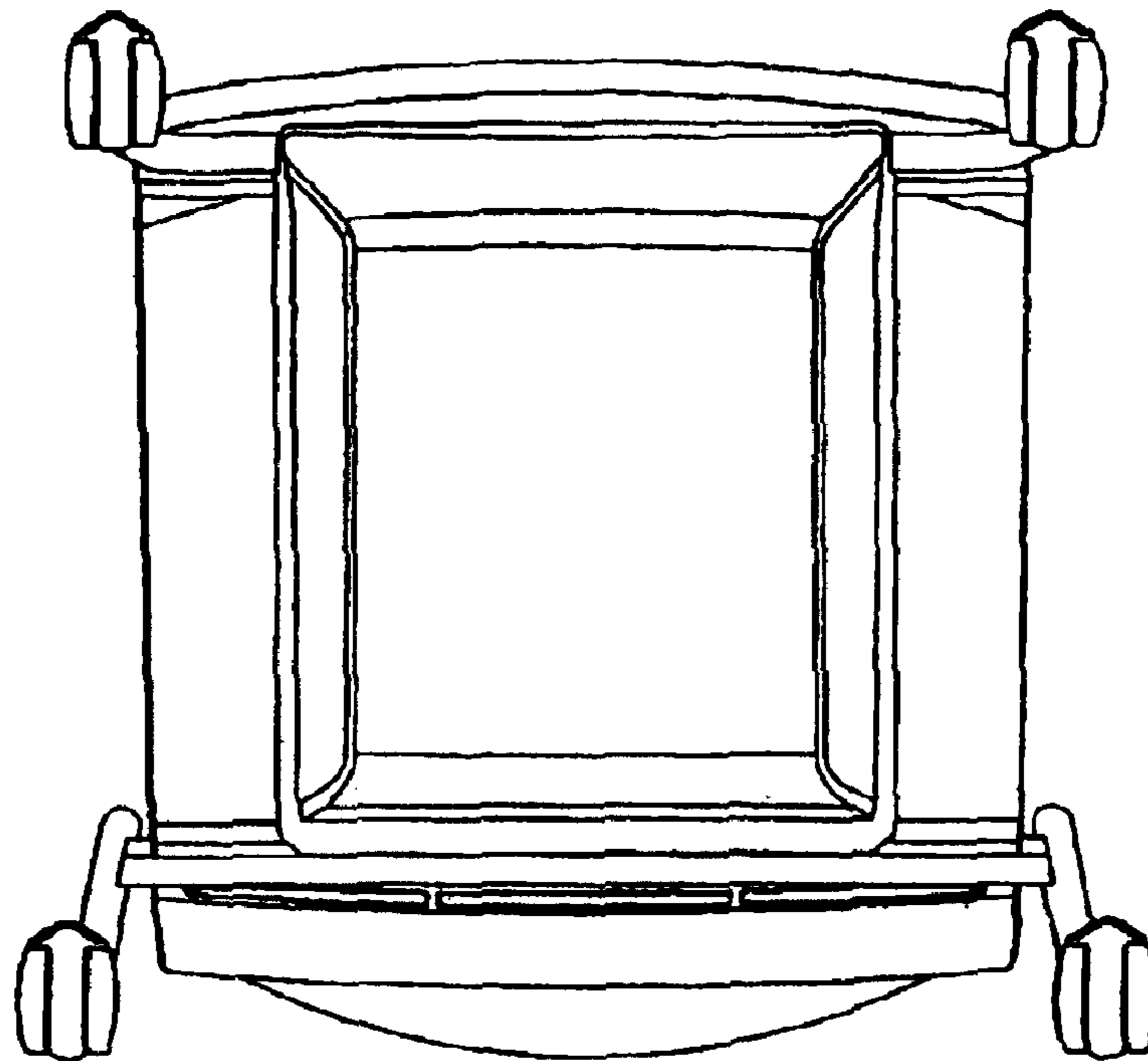

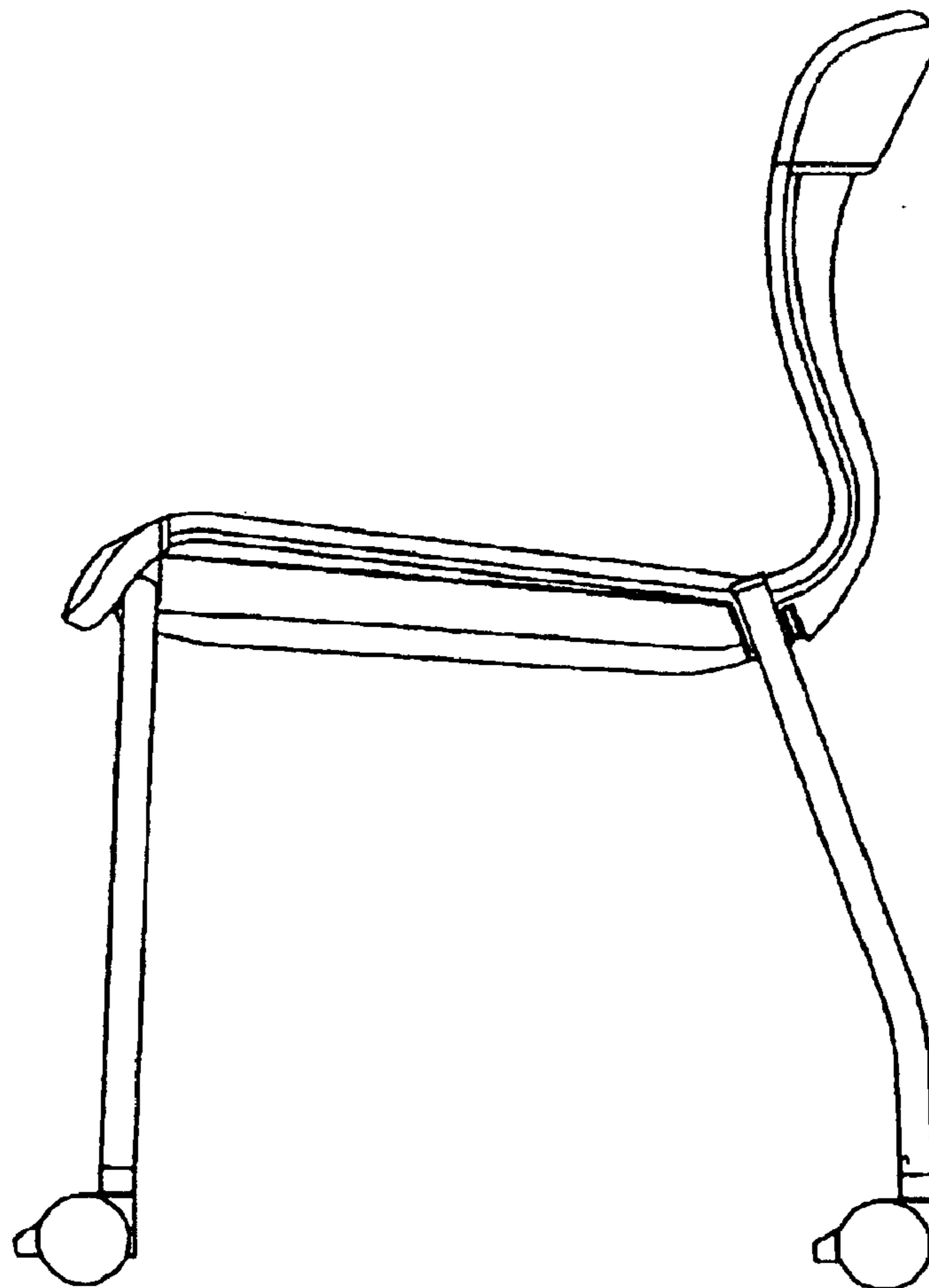

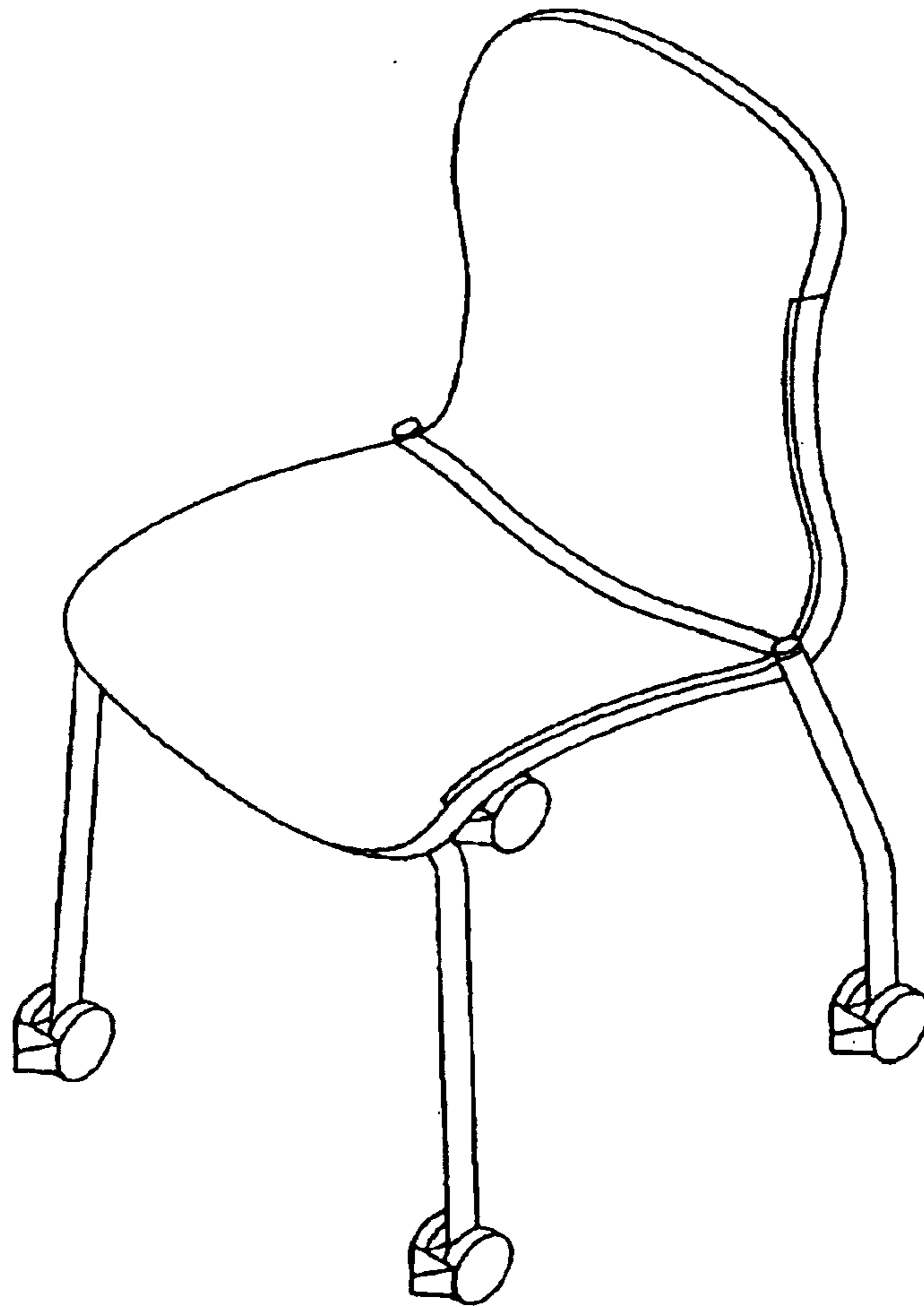

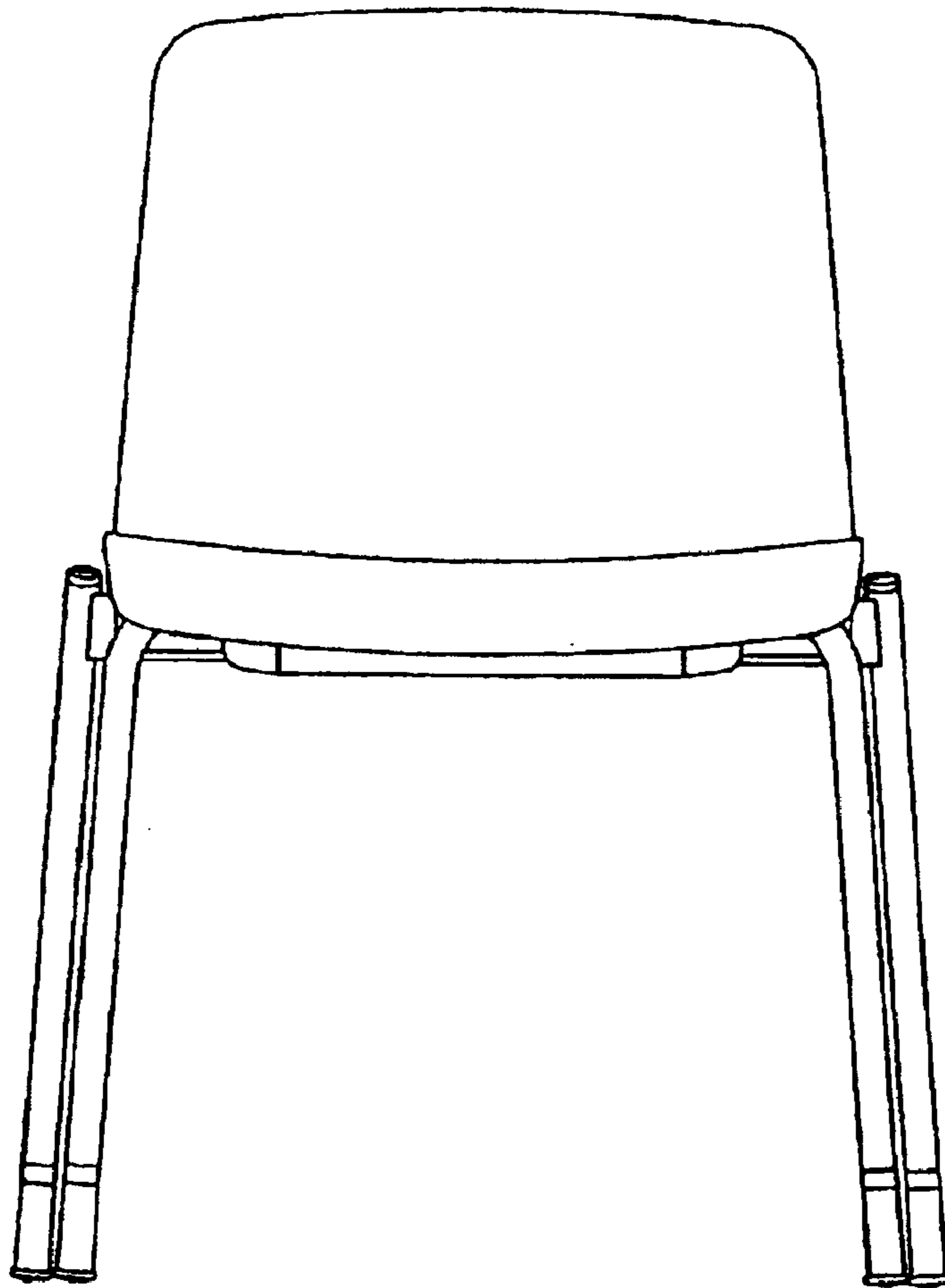

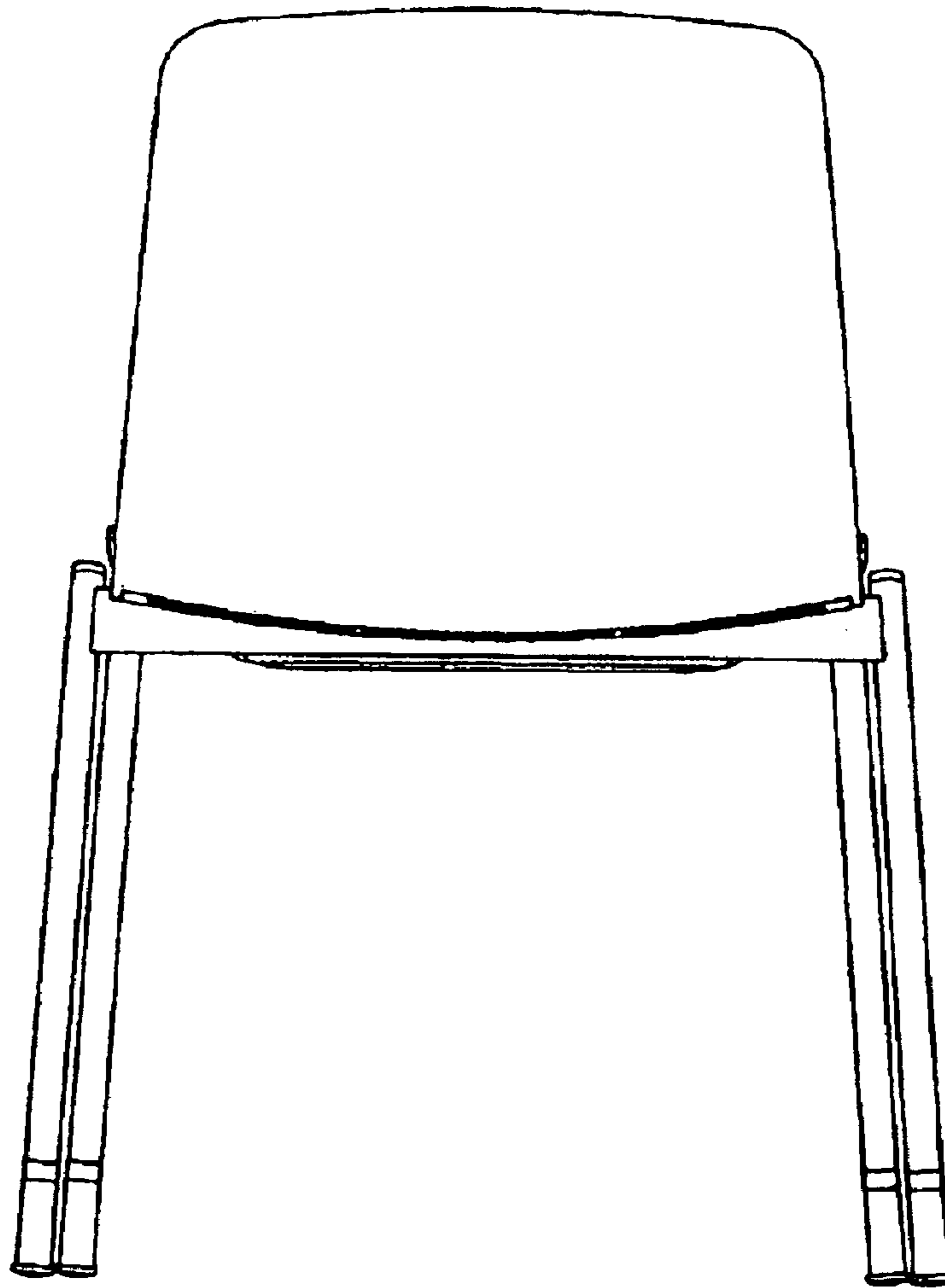

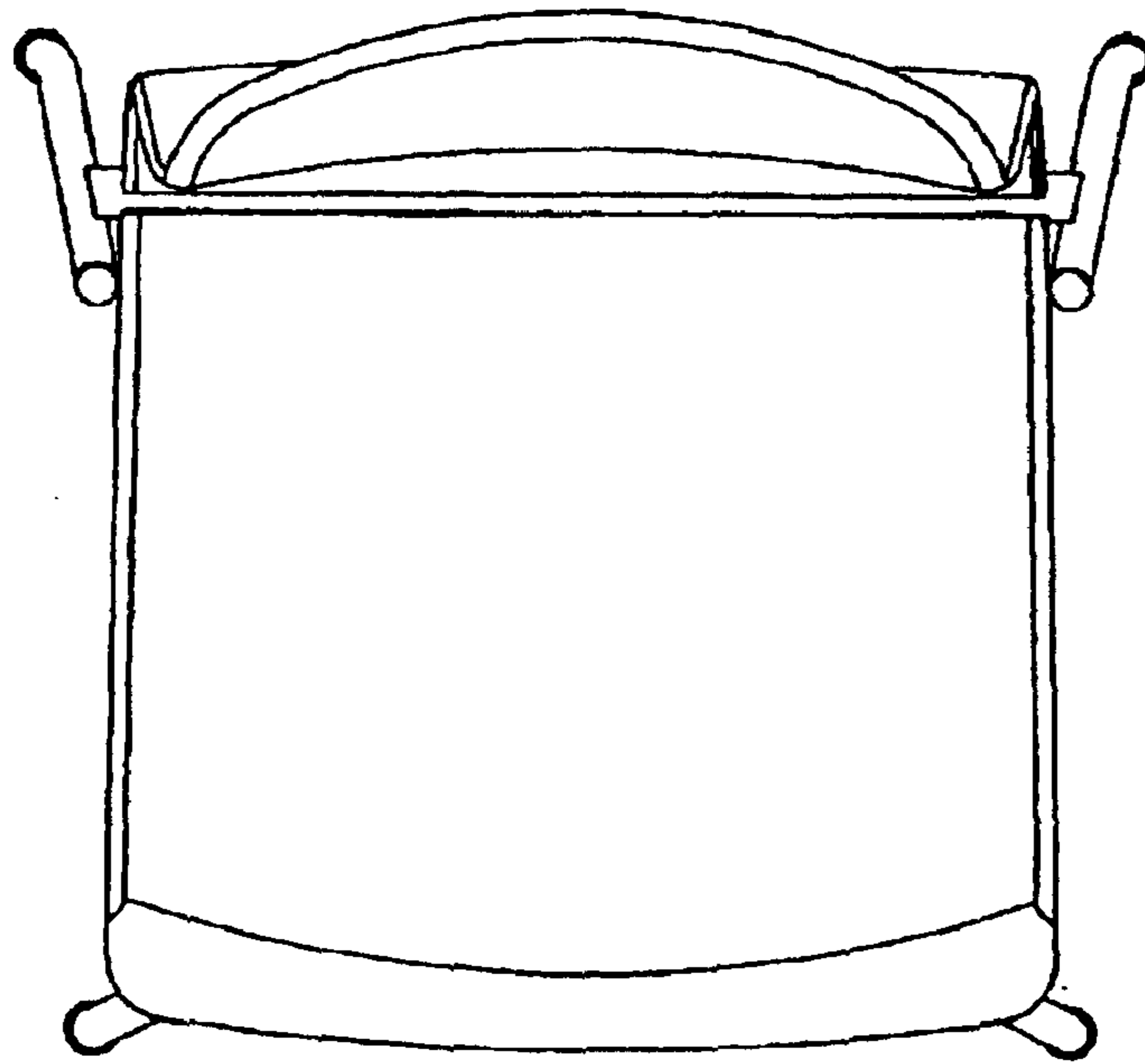

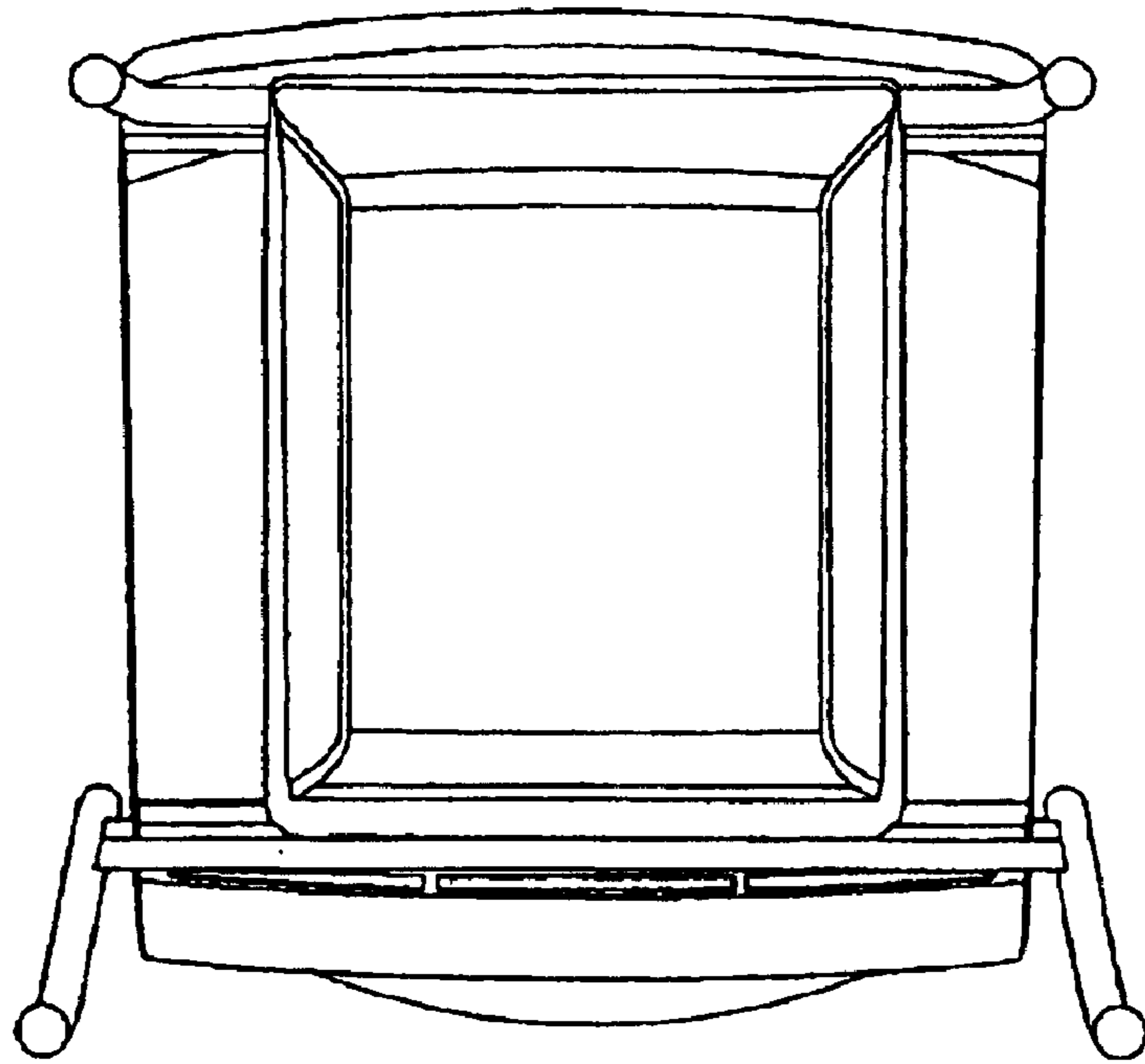

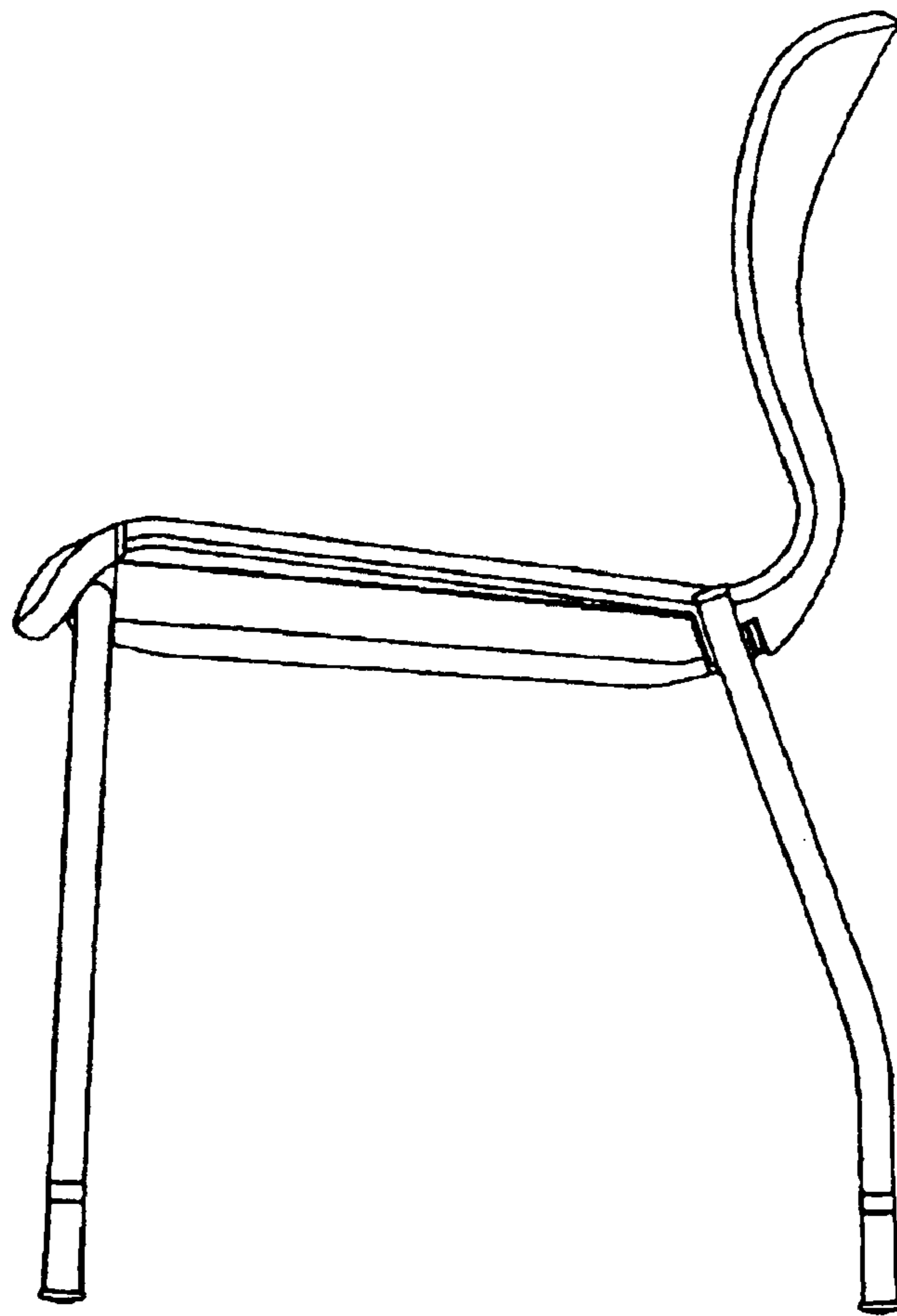

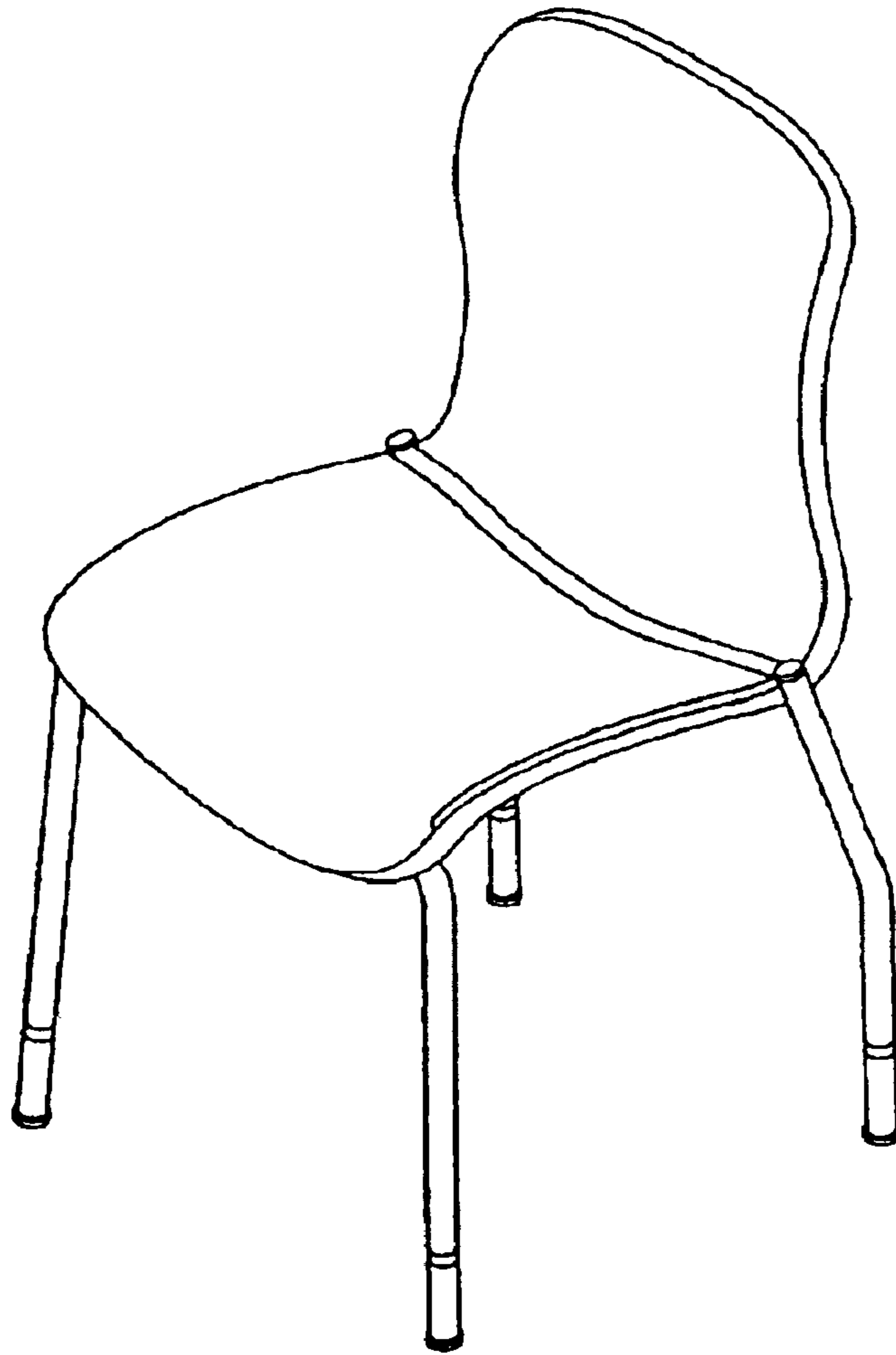

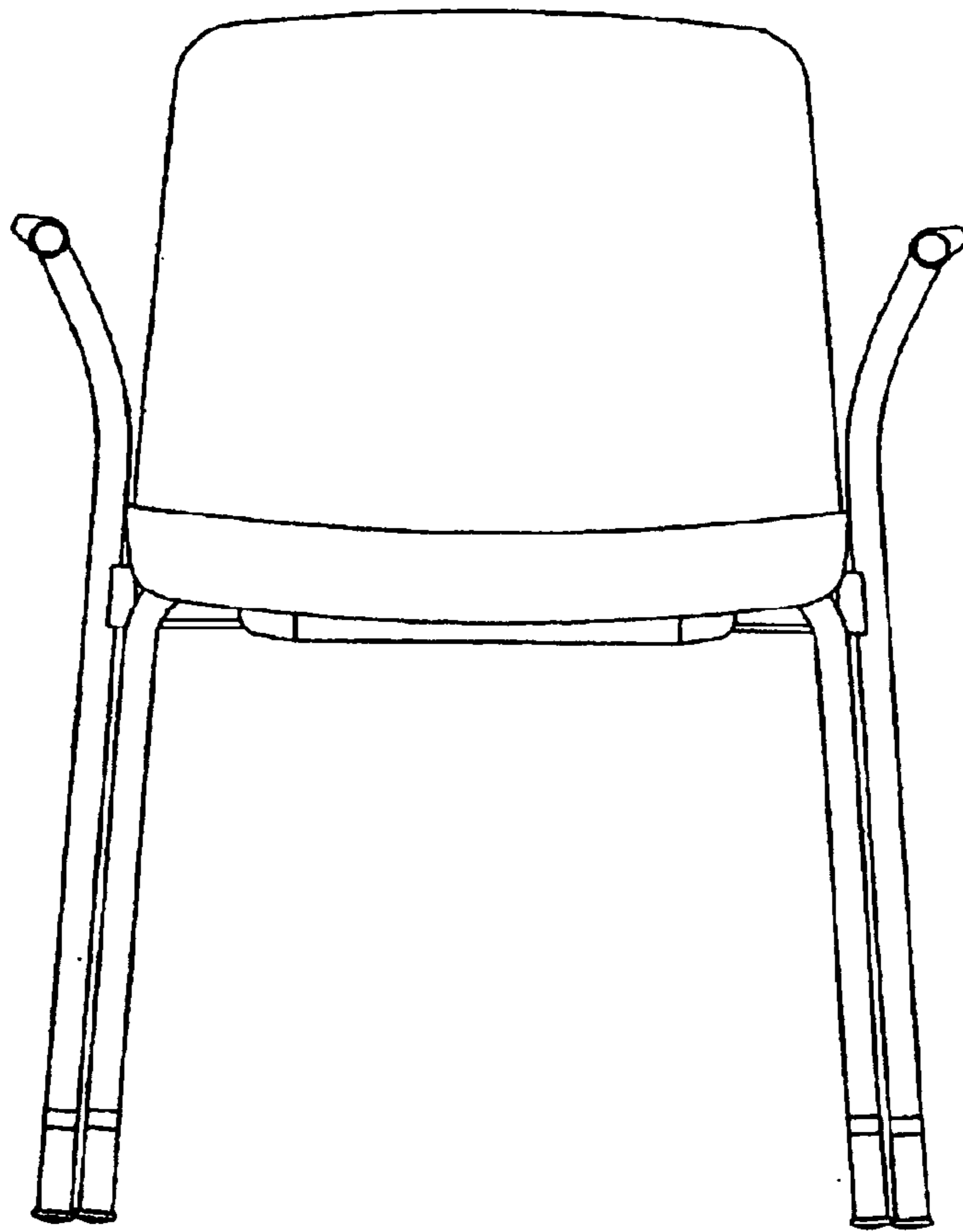

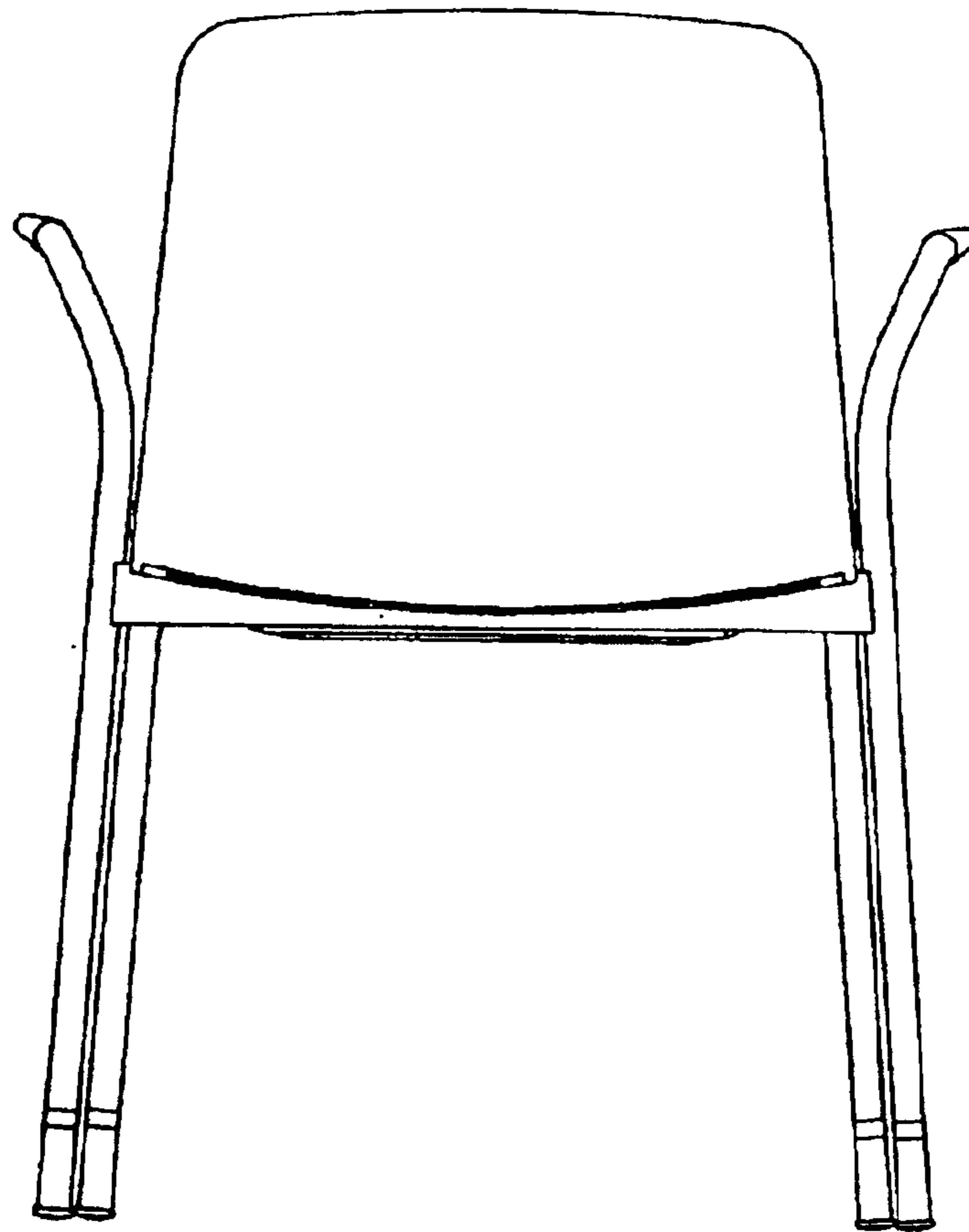

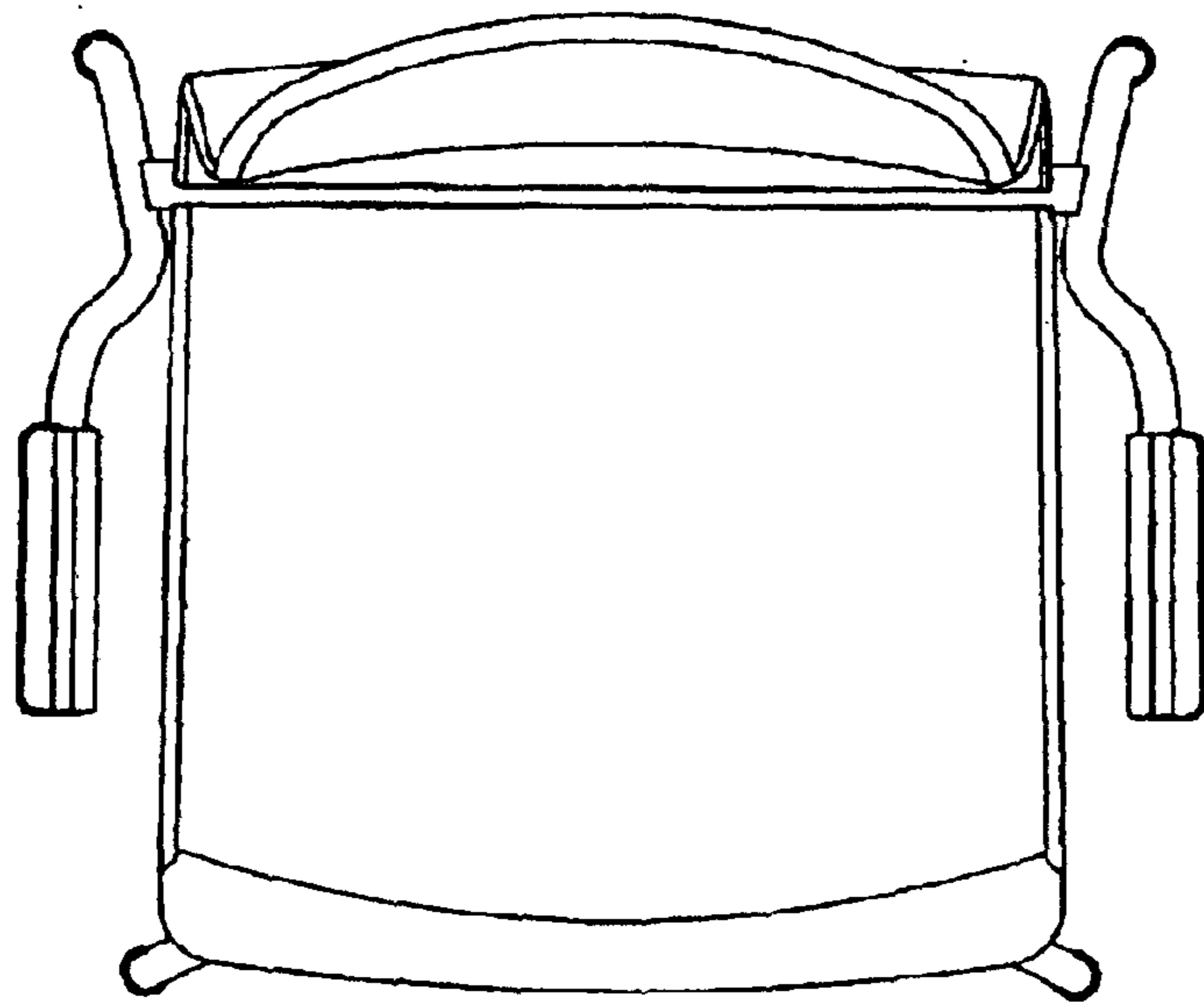

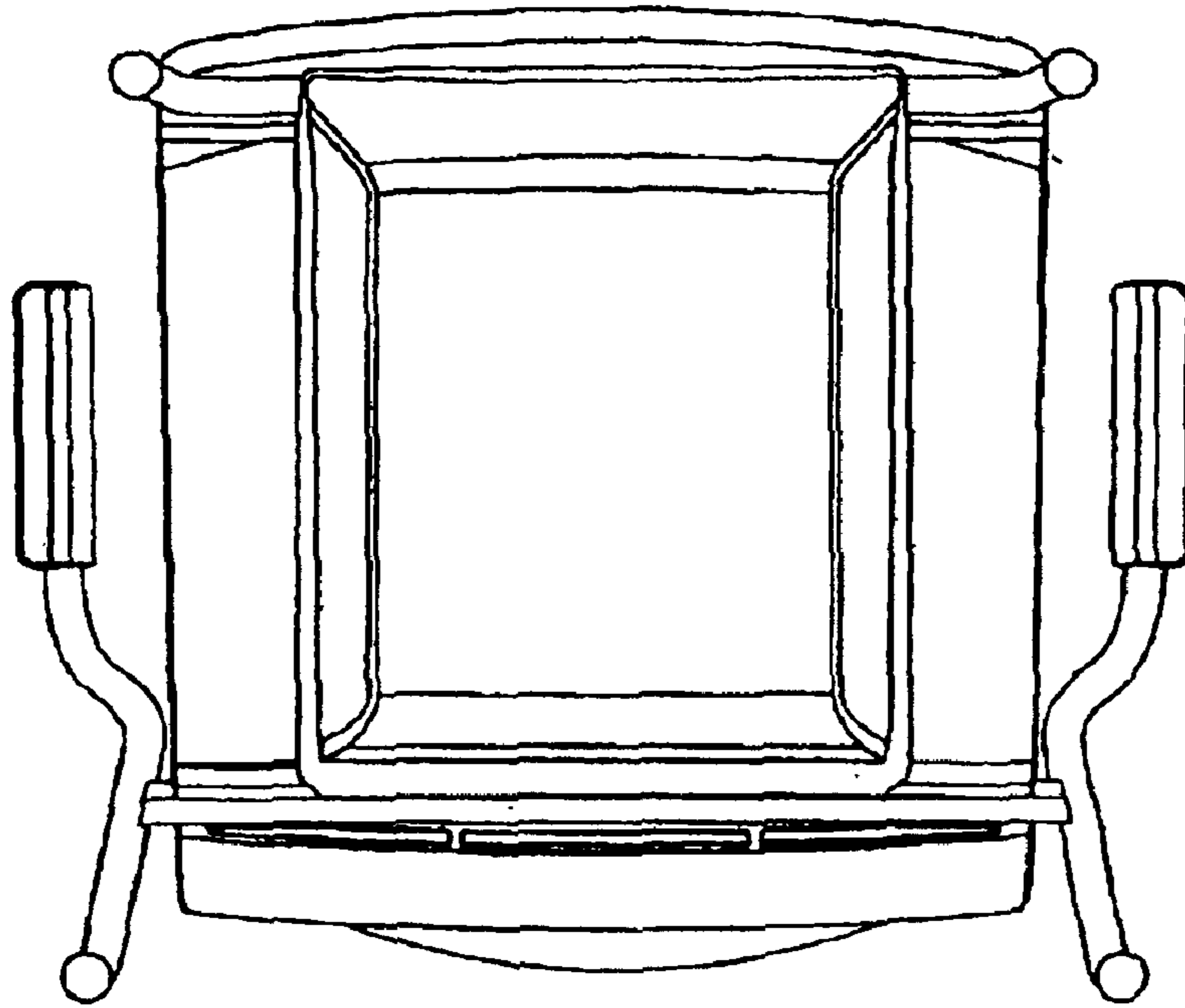

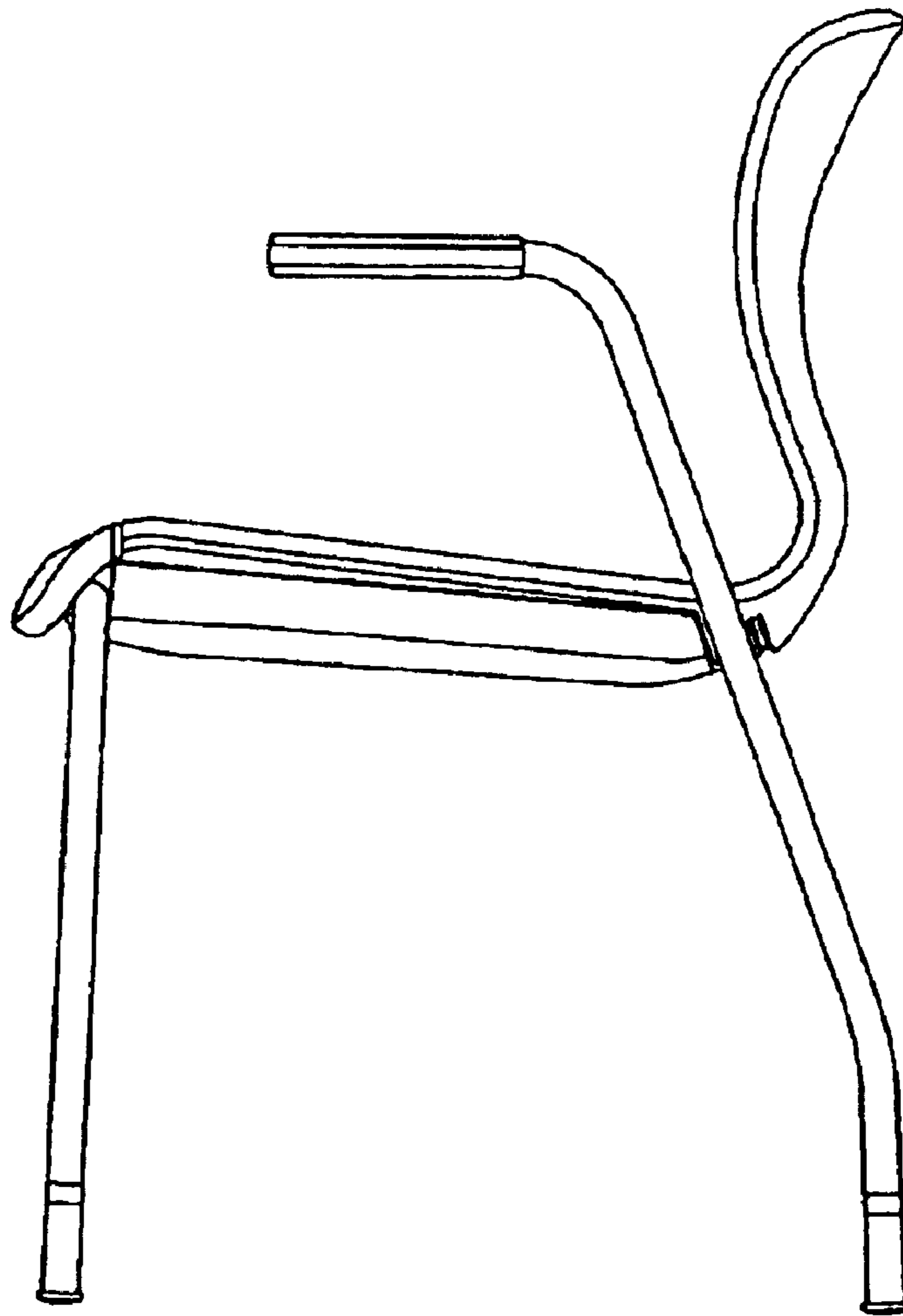

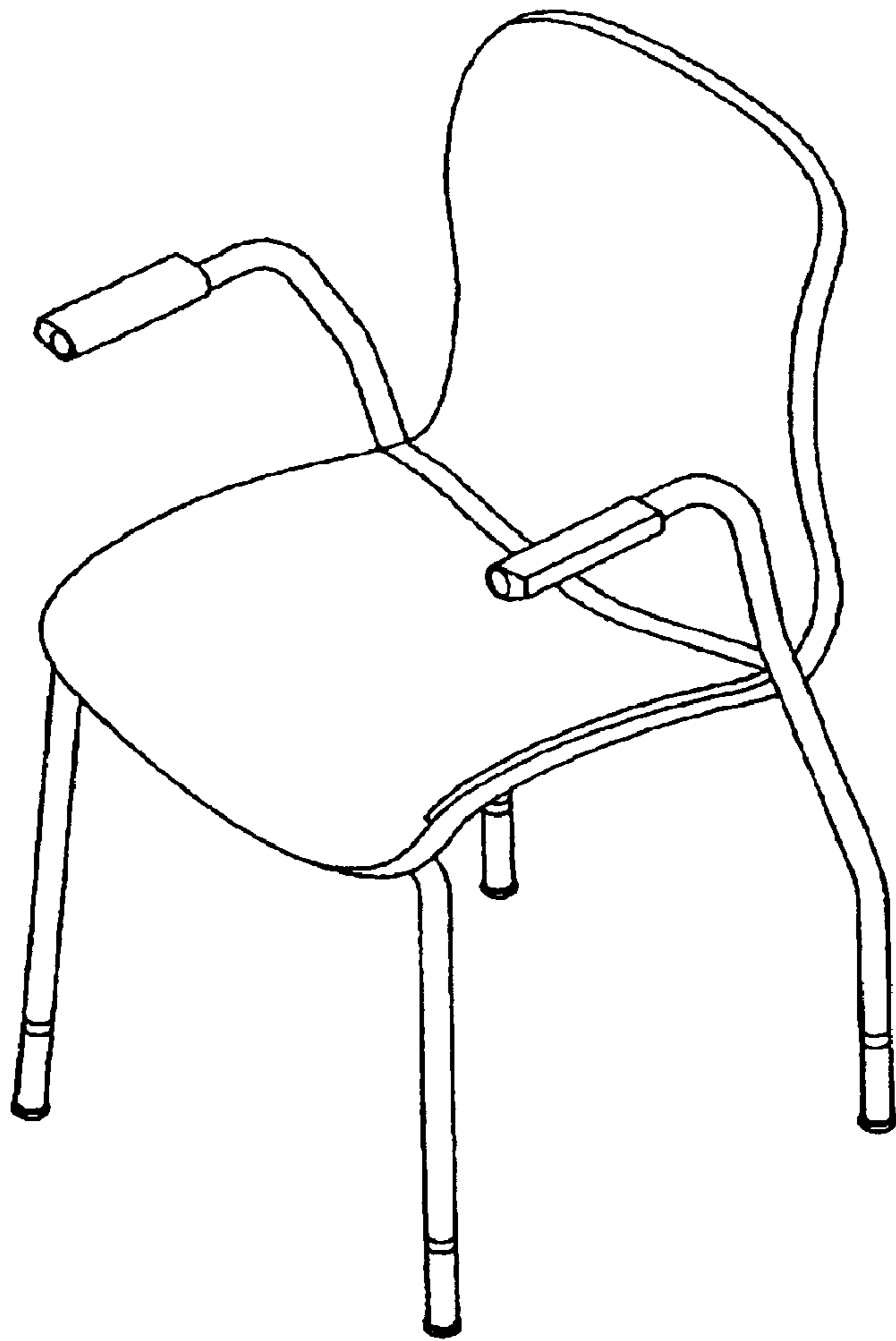
