FIG. 4 is a rear view of the handle shown in FIG. 1;

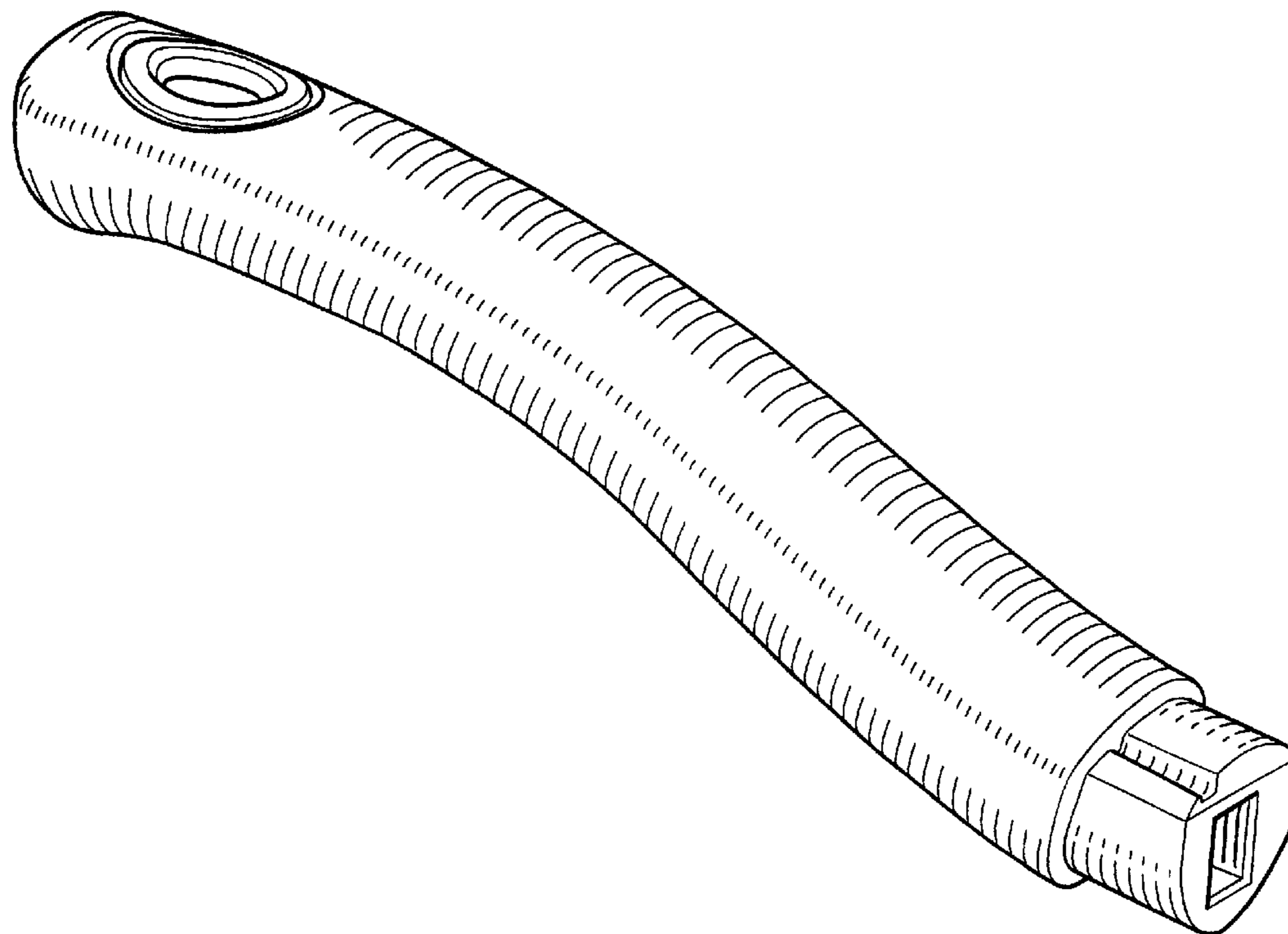
FIG. 5 is a top view of the handle shown in FIG. 1;

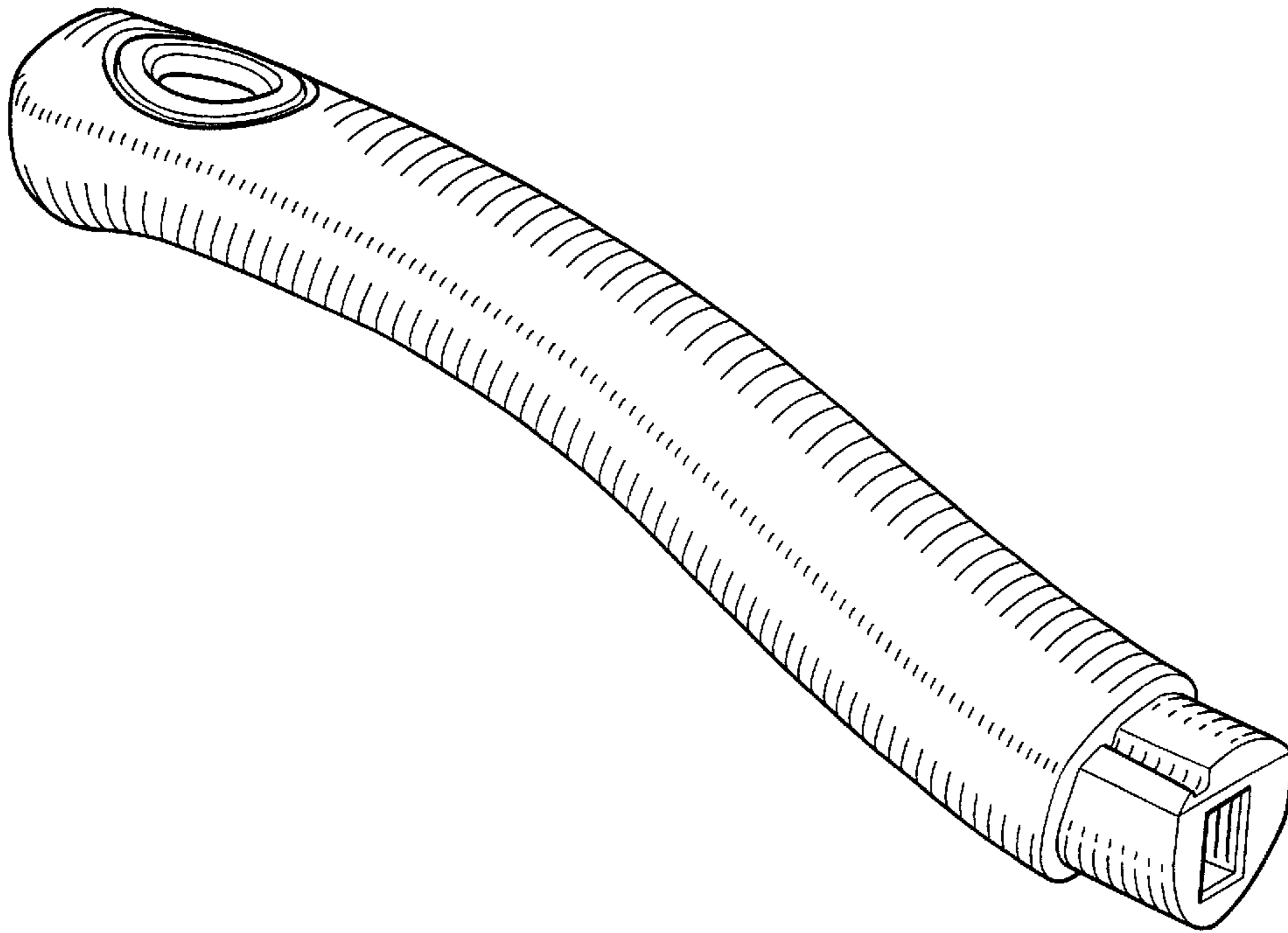

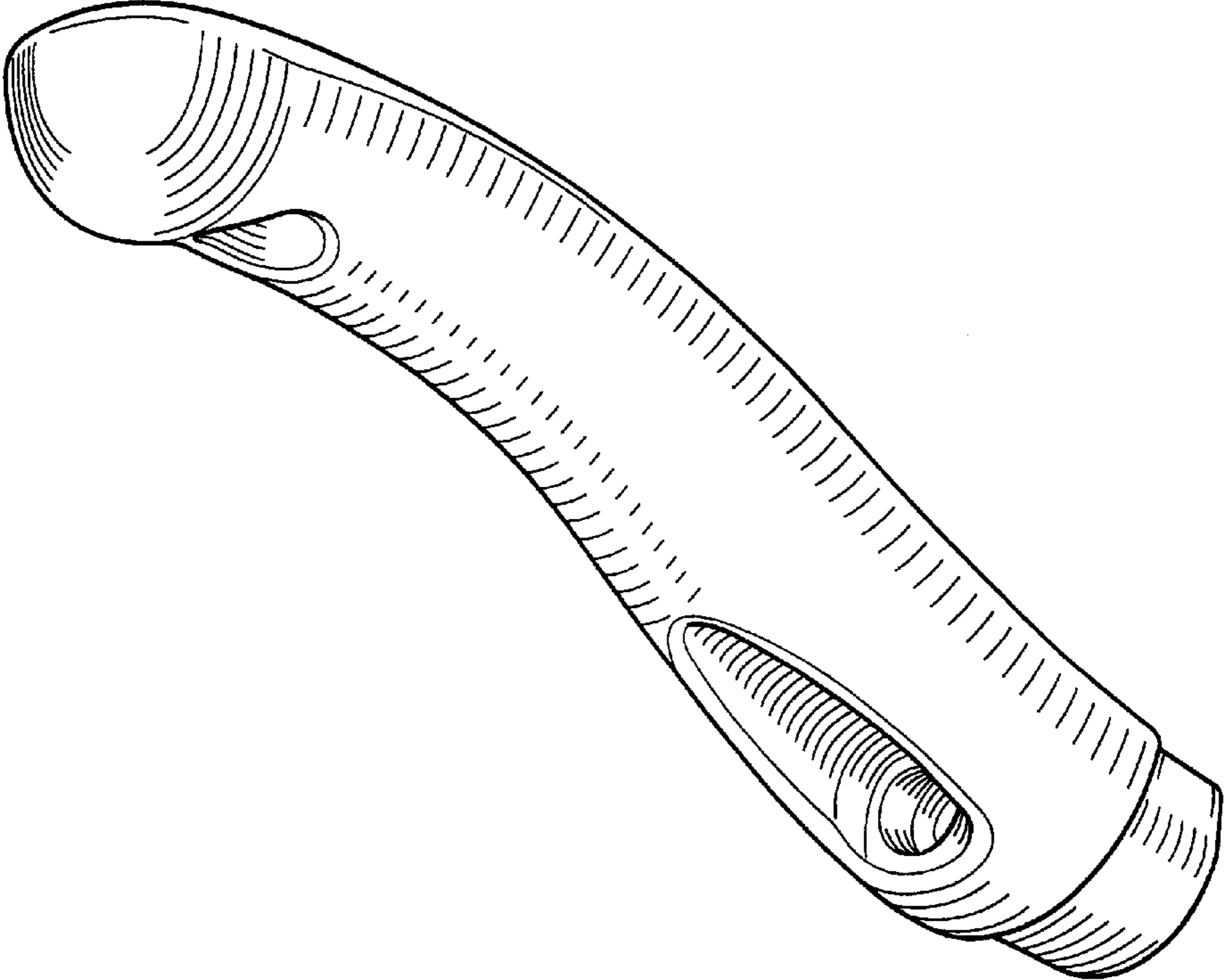

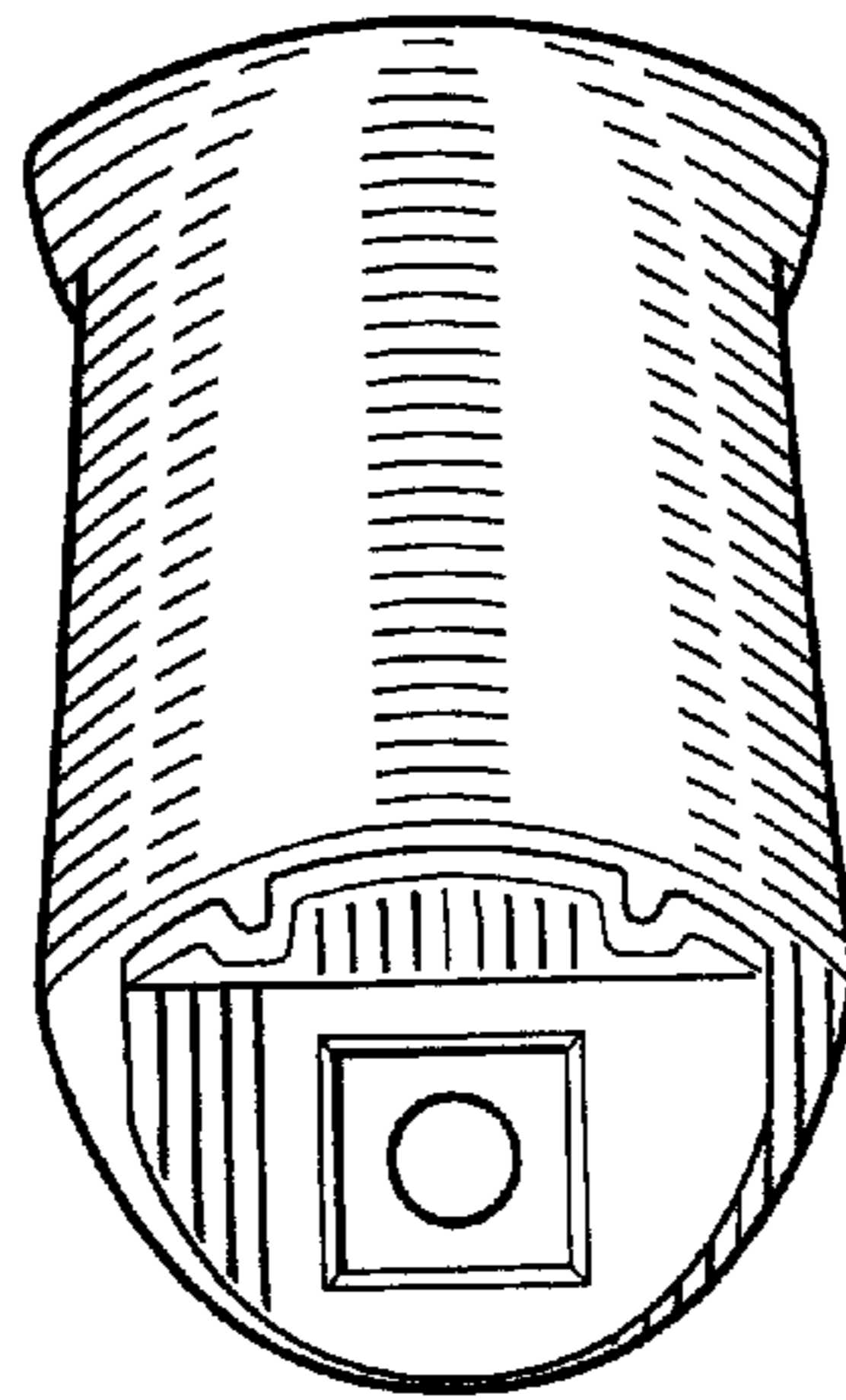

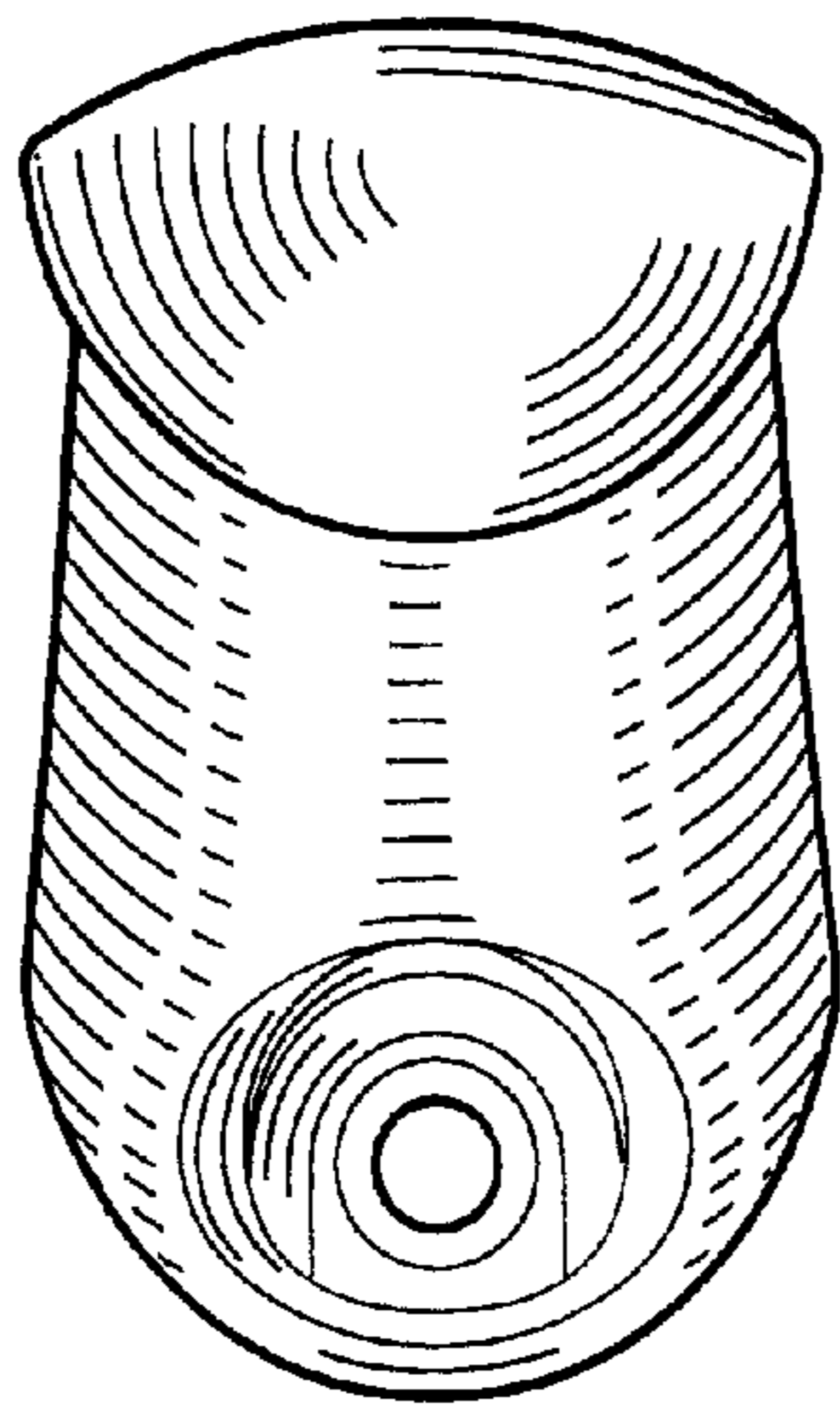

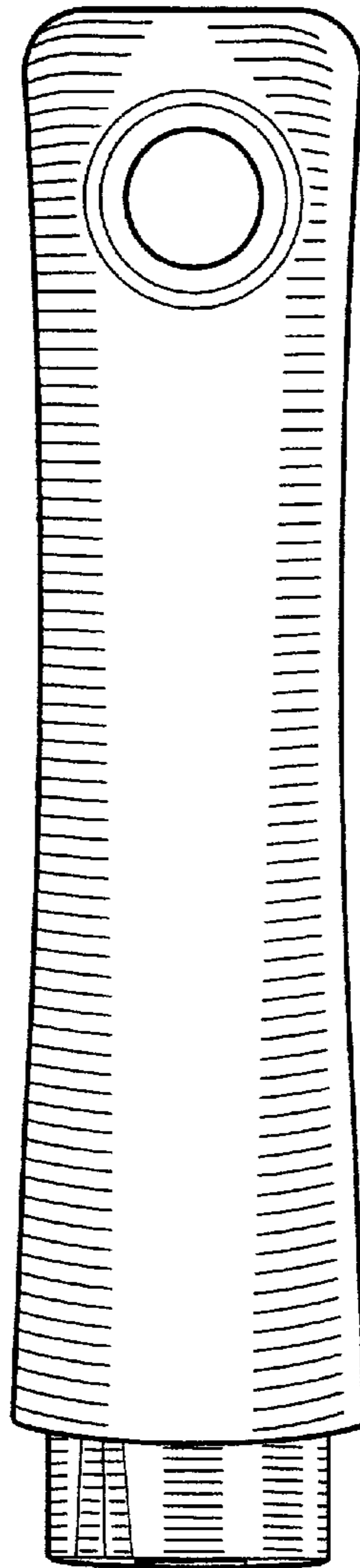

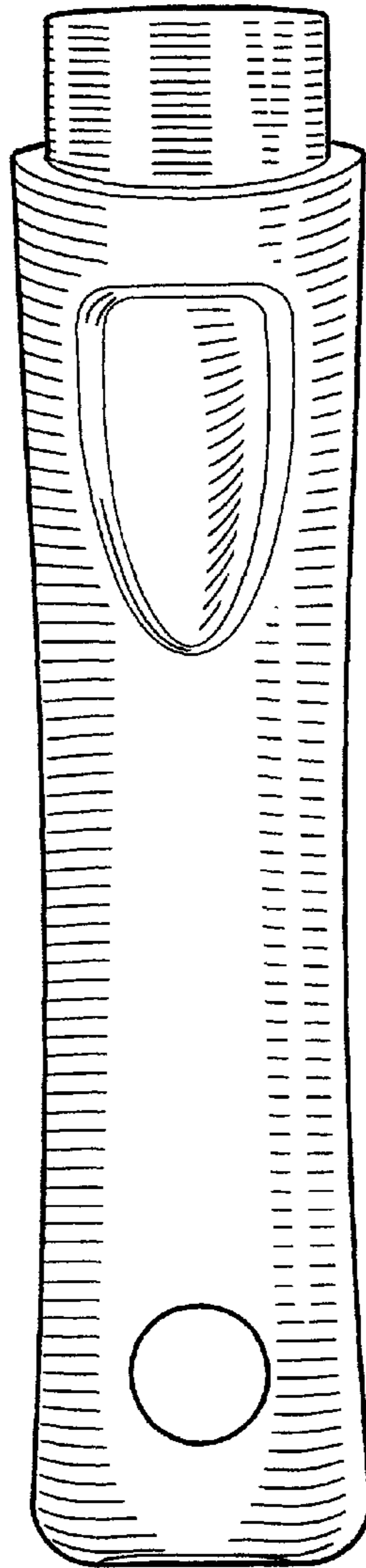

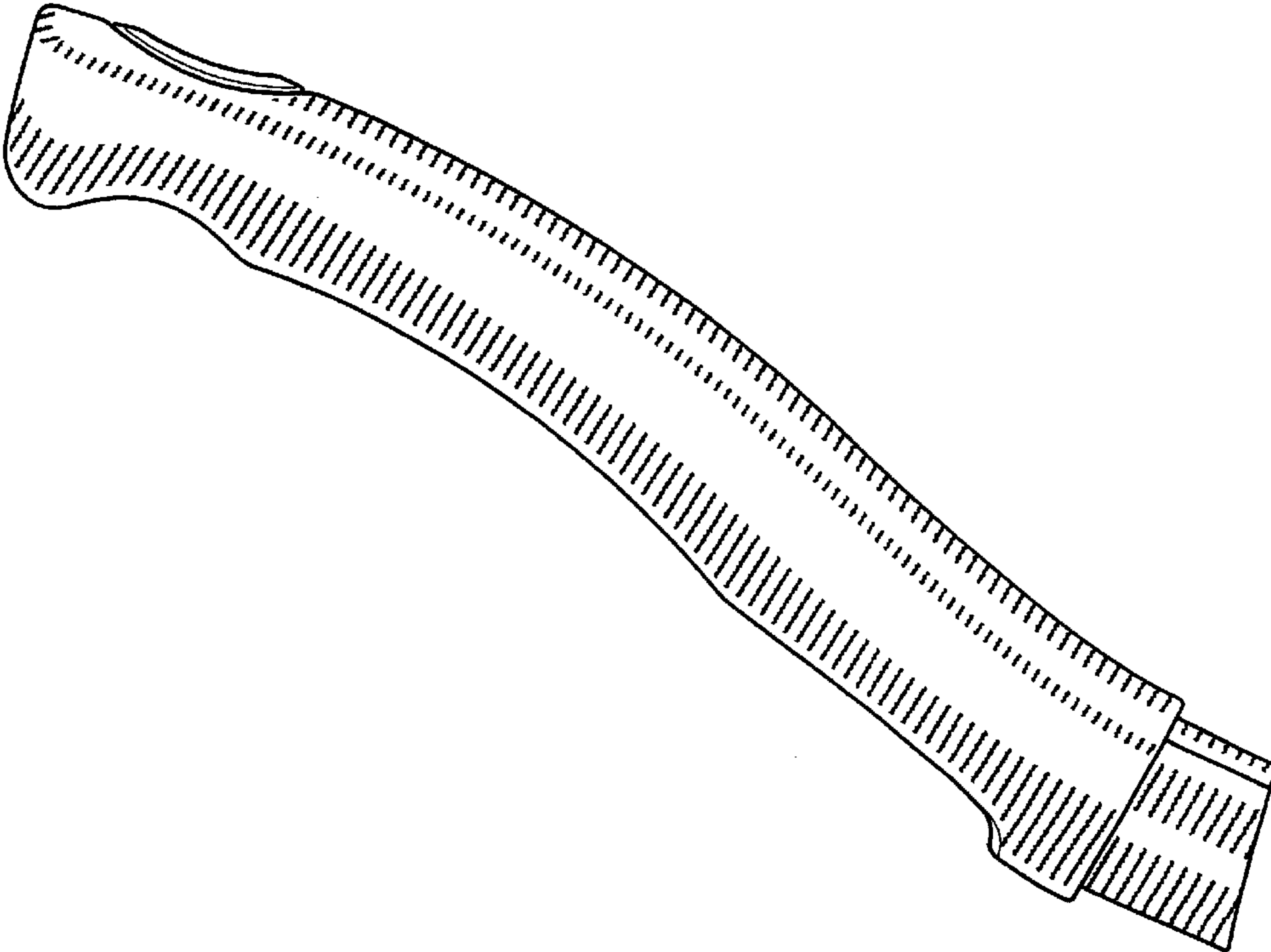

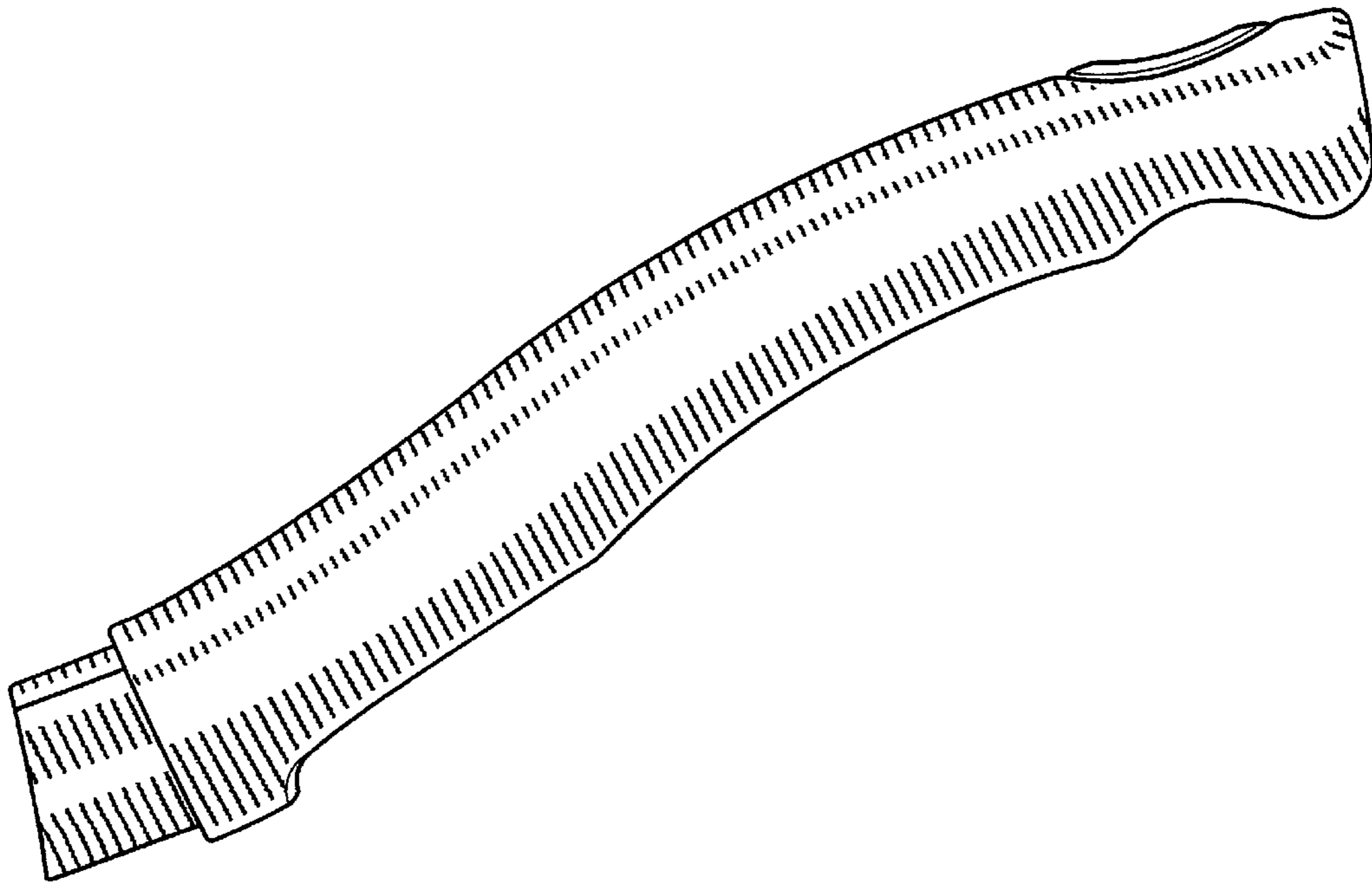
