DESCRIPTION

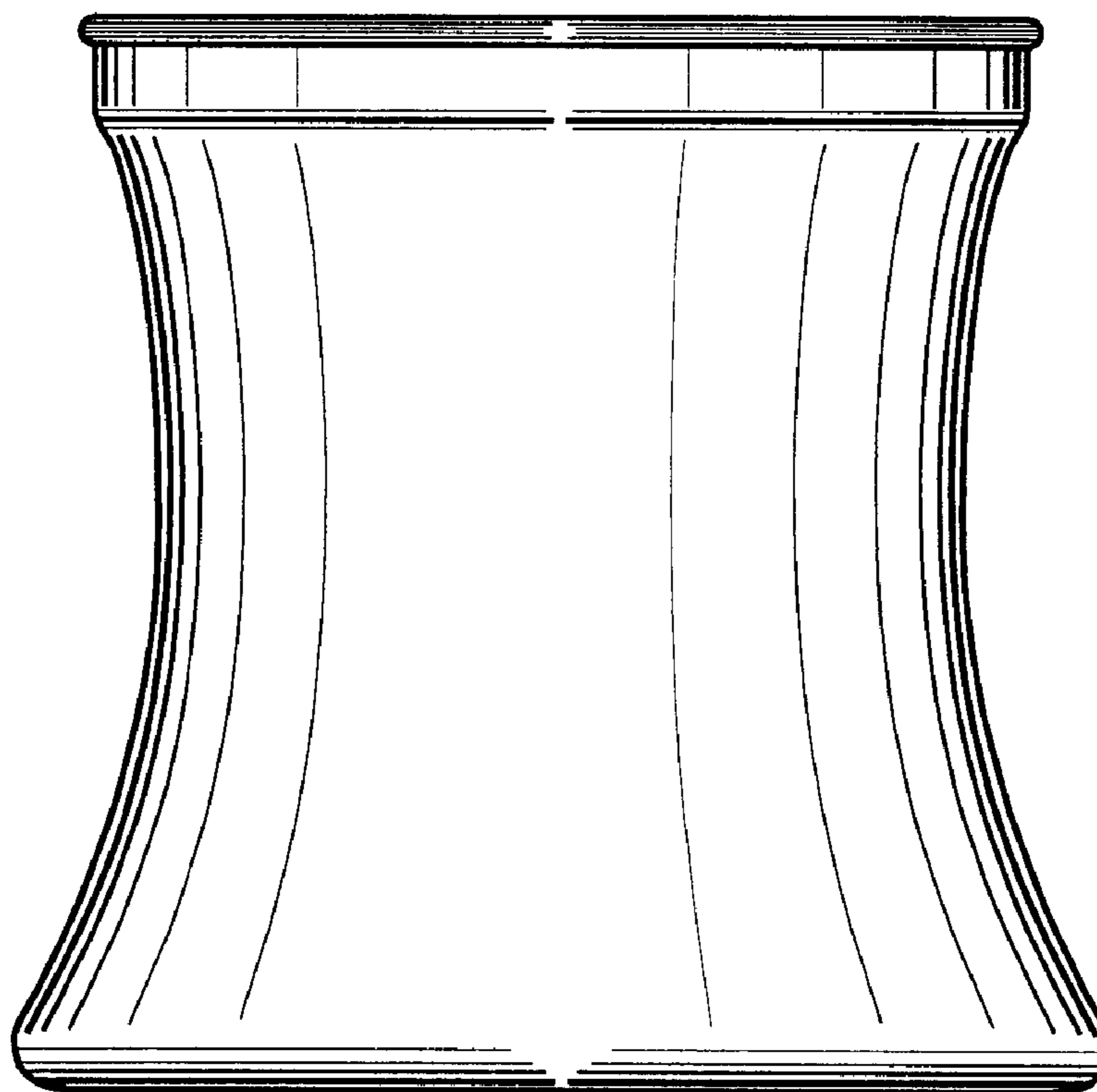
FIG. 1 is a top perspective view of a tumbler according to the present design;

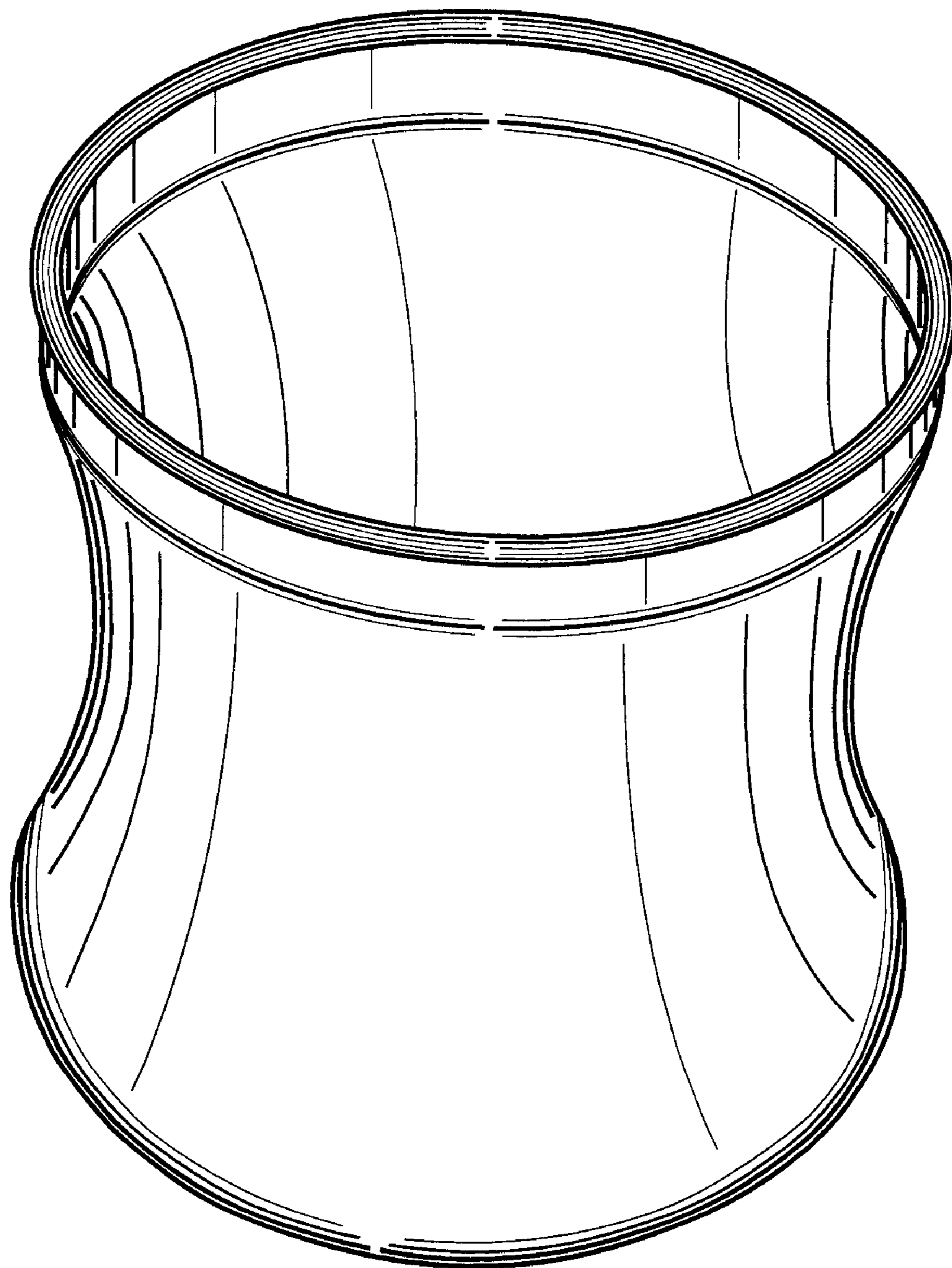
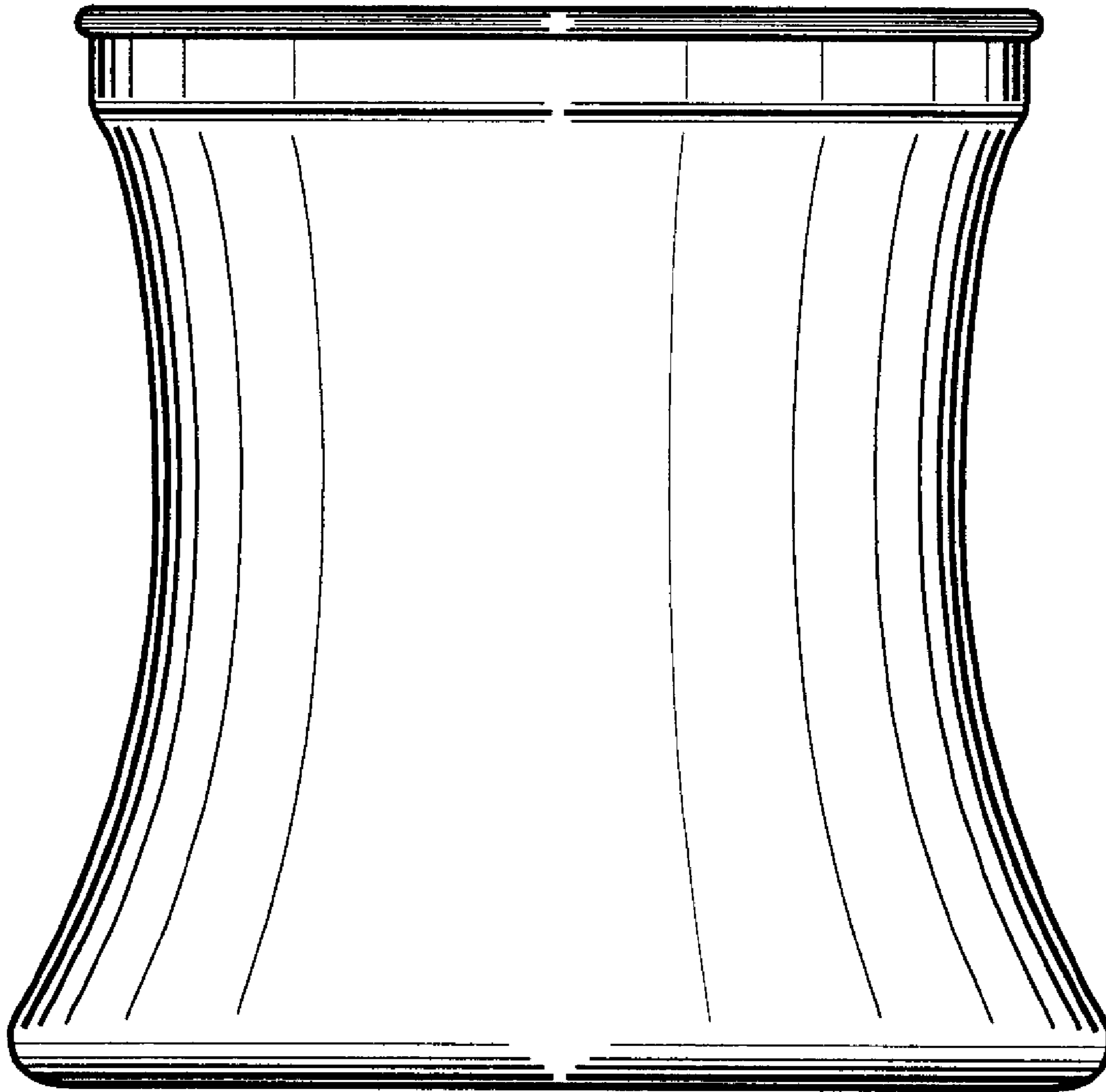
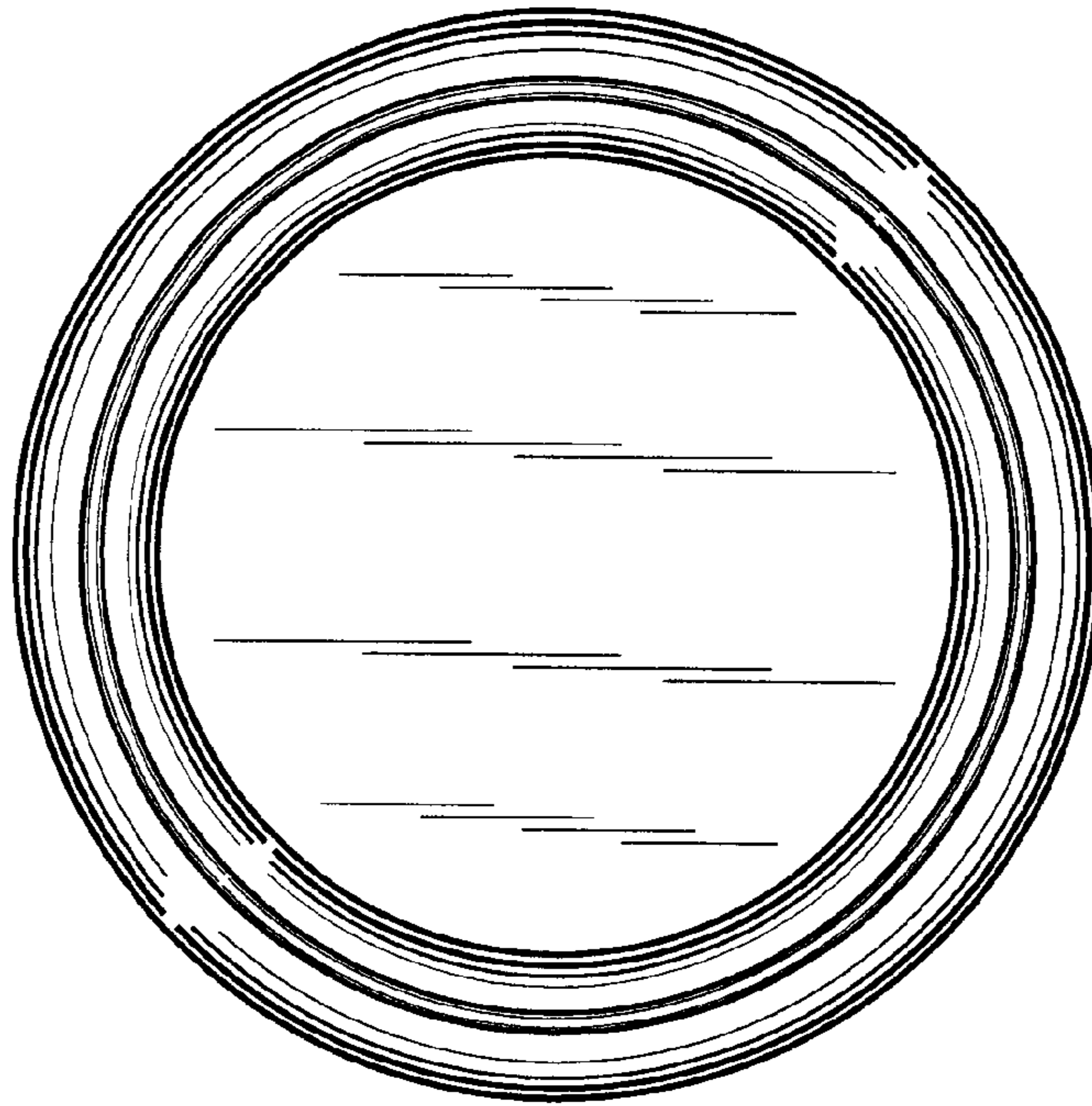


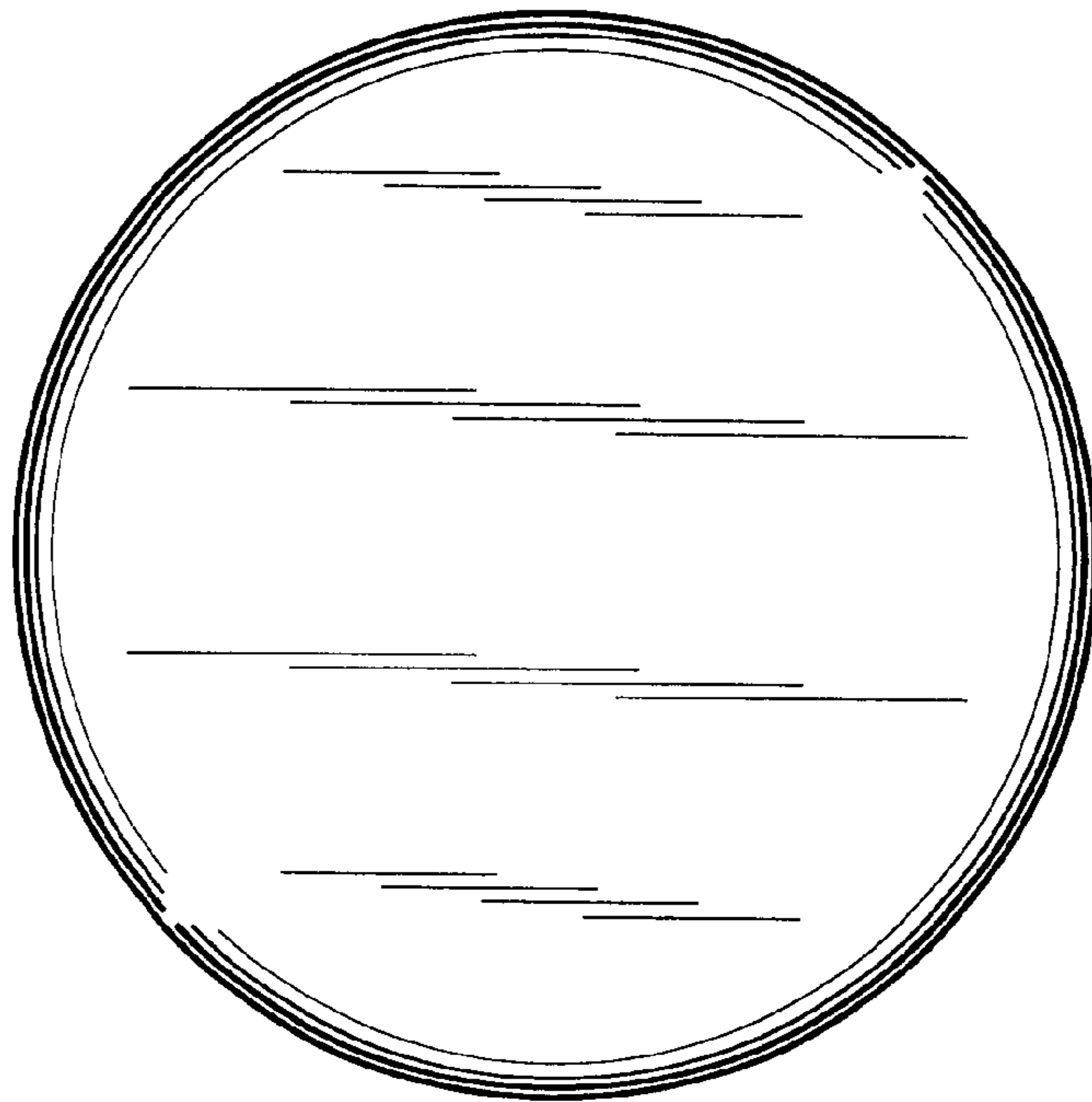
