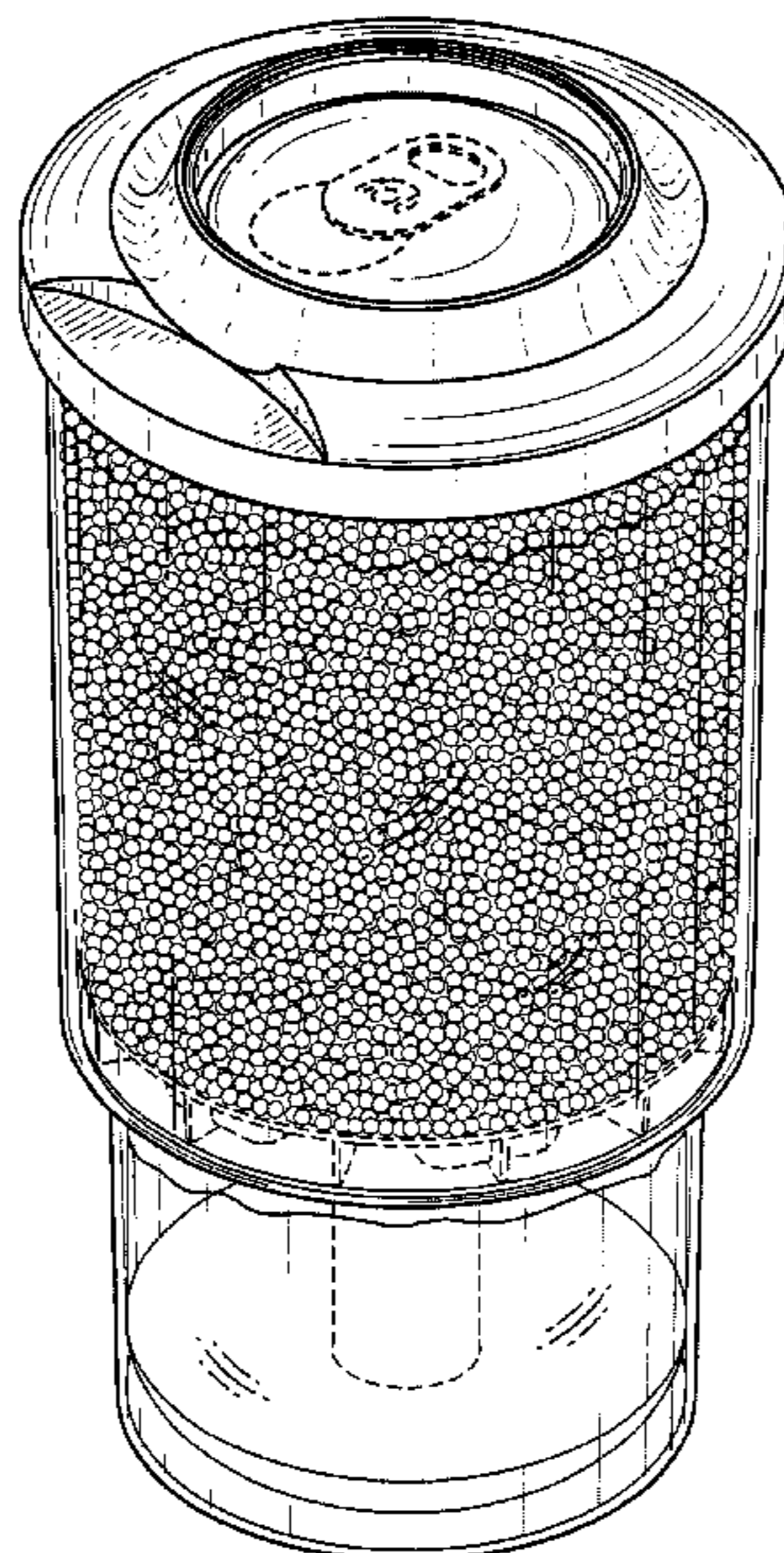
(57) **CLAIM**

The ornamental design for a food and/or beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the container showing our new design;
FIG. 2 is a front view of the container showing our new design;
FIG. 3 is a back view of the container showing our new design;
FIG. 4 is a right side view of the container, with a left side view being omitted since it is a mirror image of the right side view from side-to-side.
FIG. 5 is a top view of the container showing our new design; and,
FIG. 6 is a bottom view of the container showing our new design.

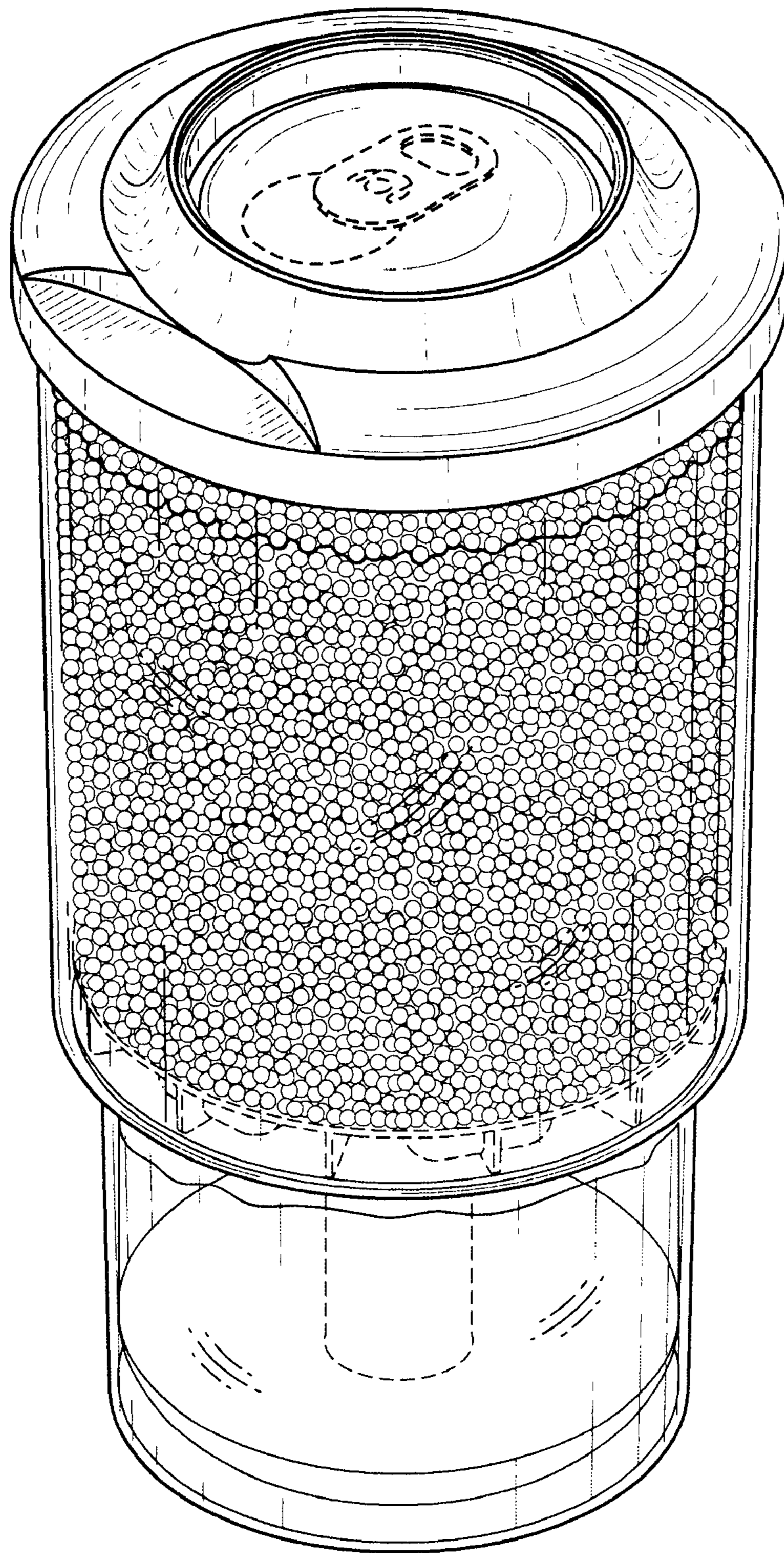

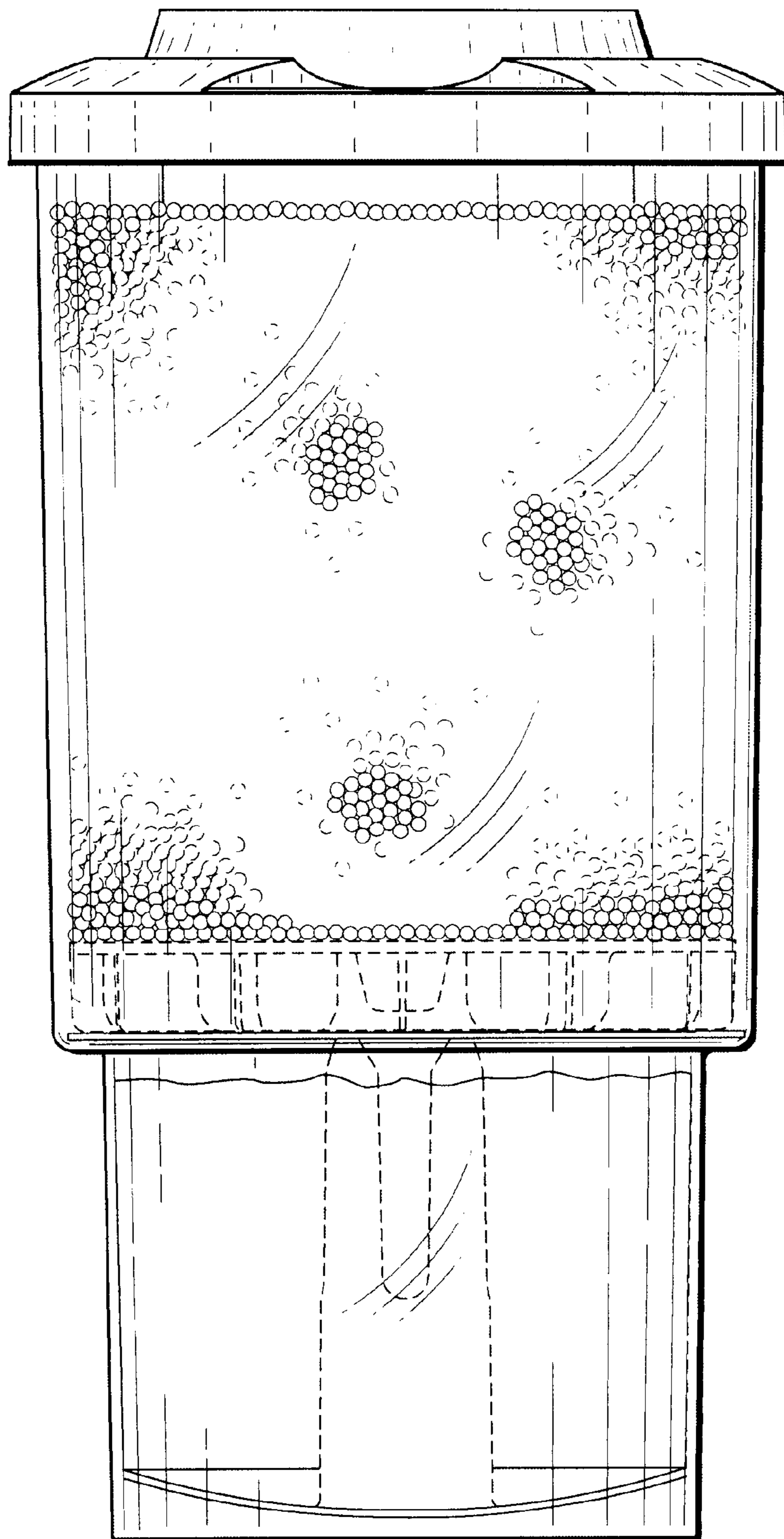

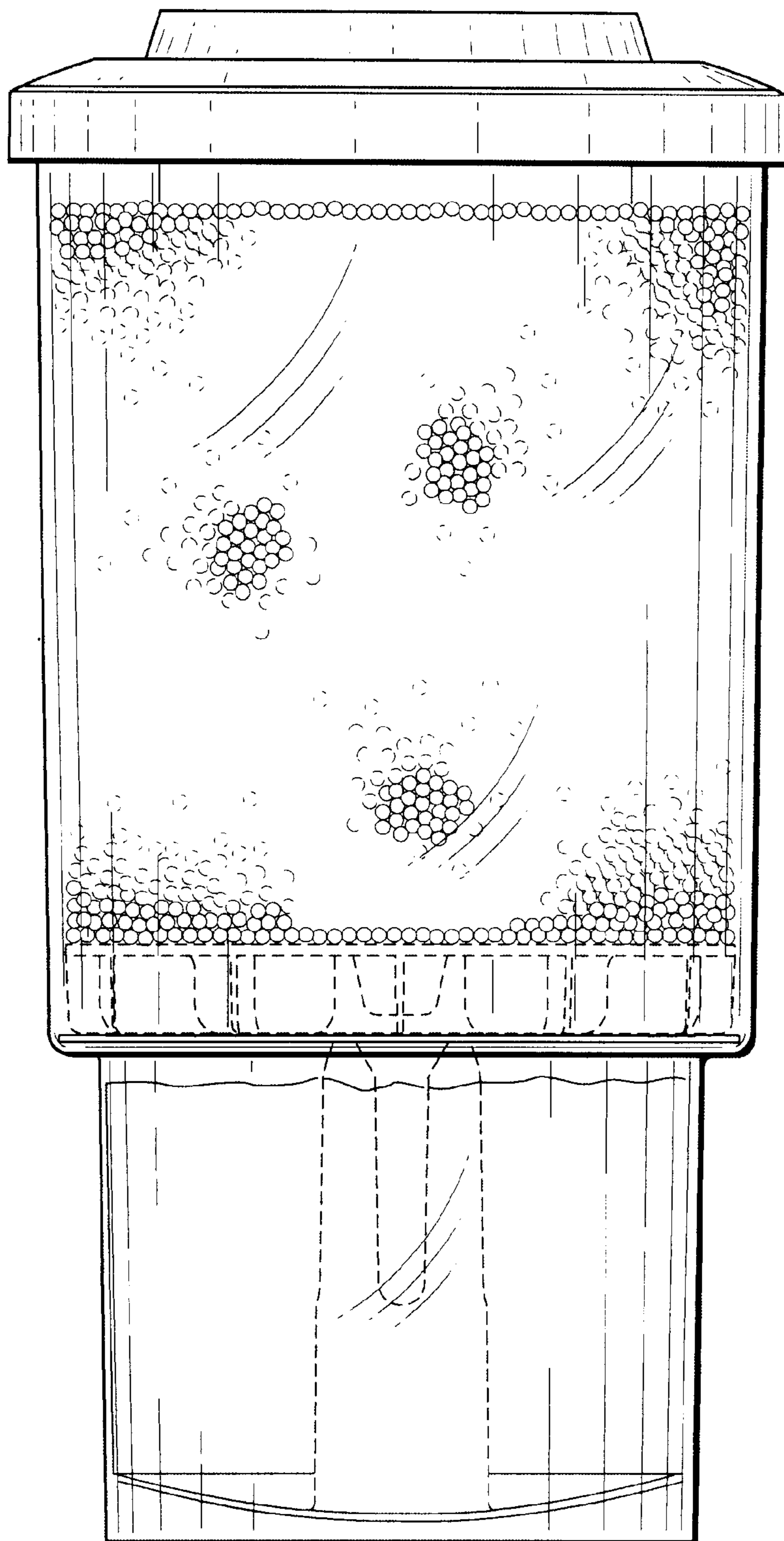

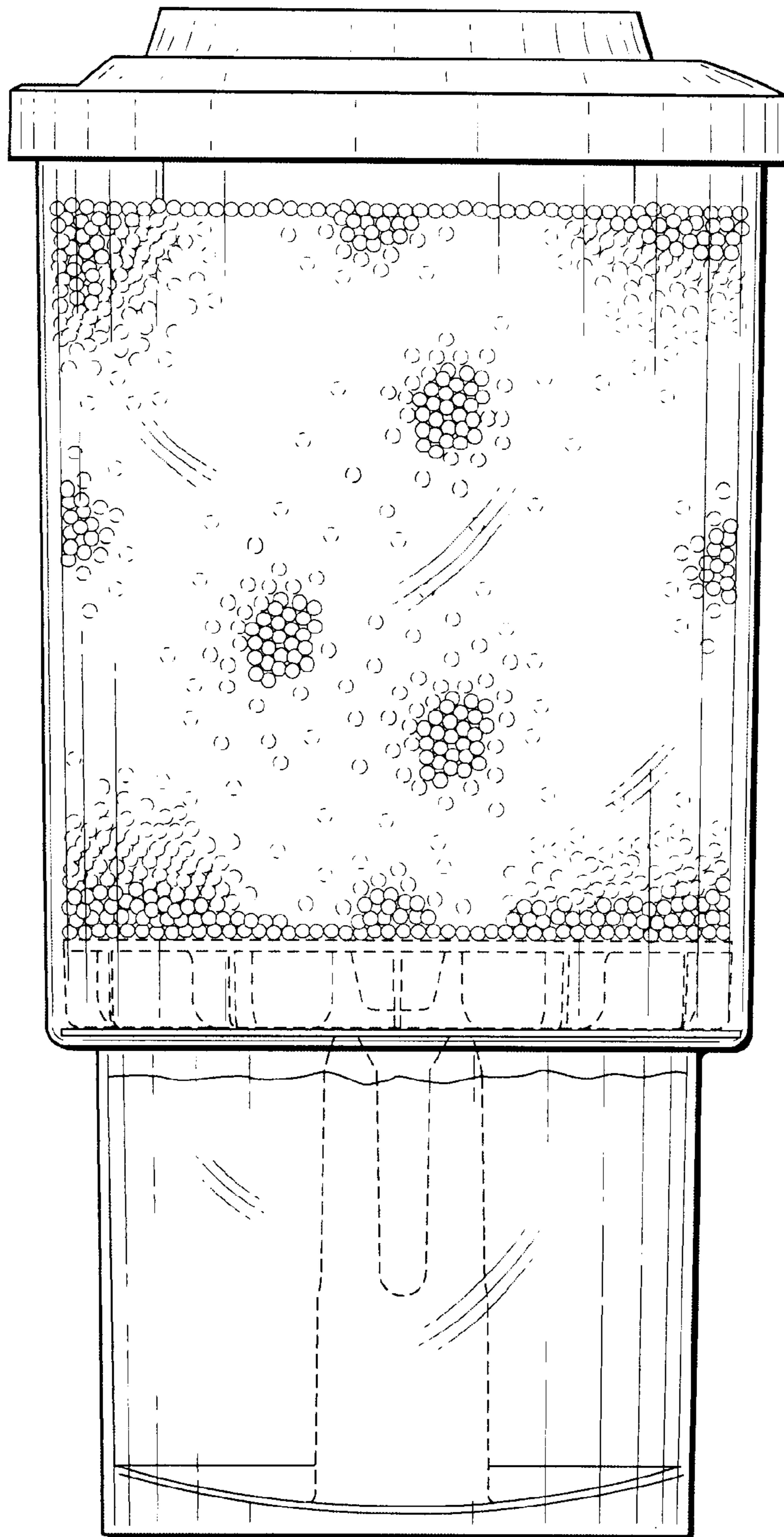

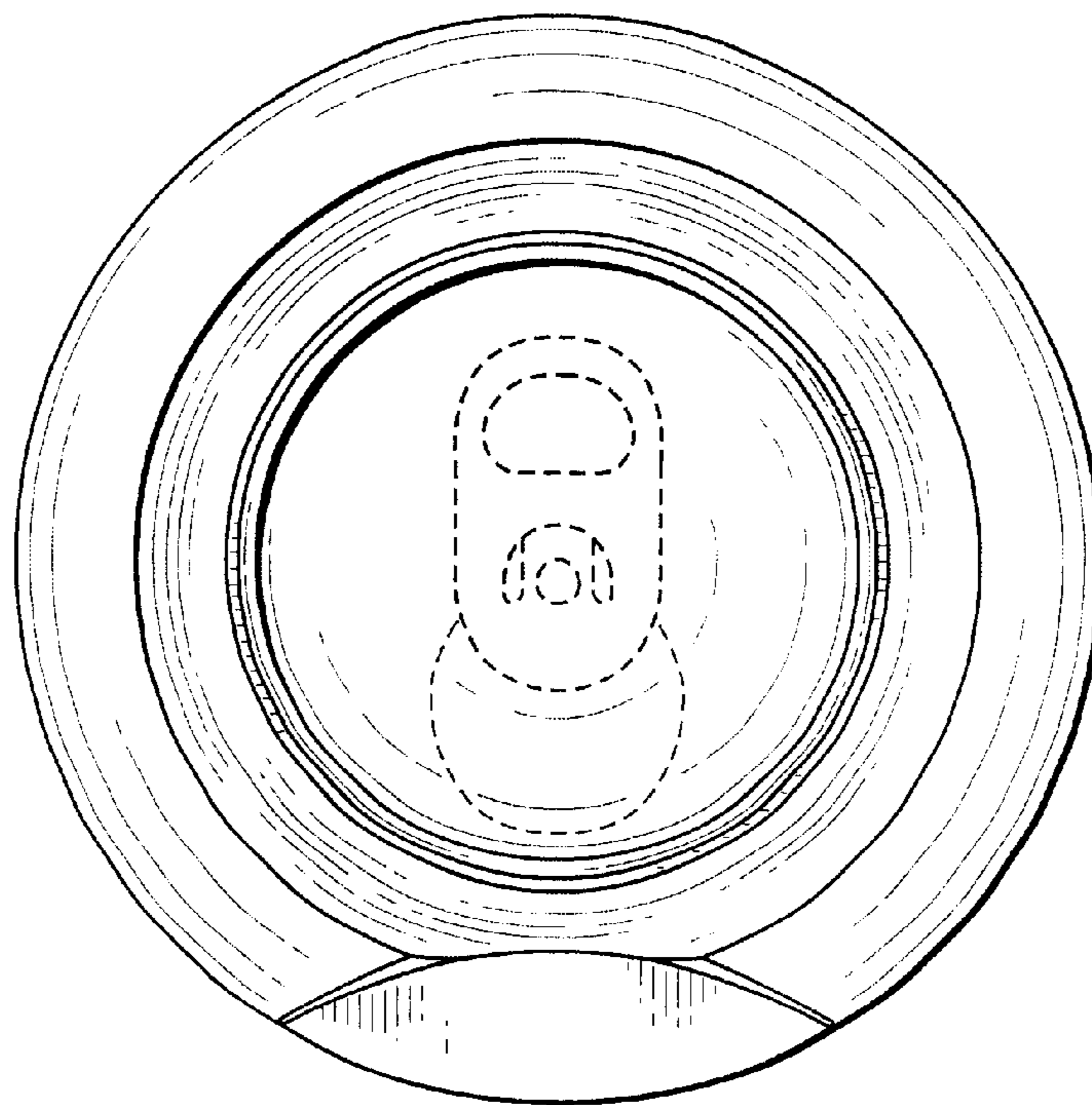

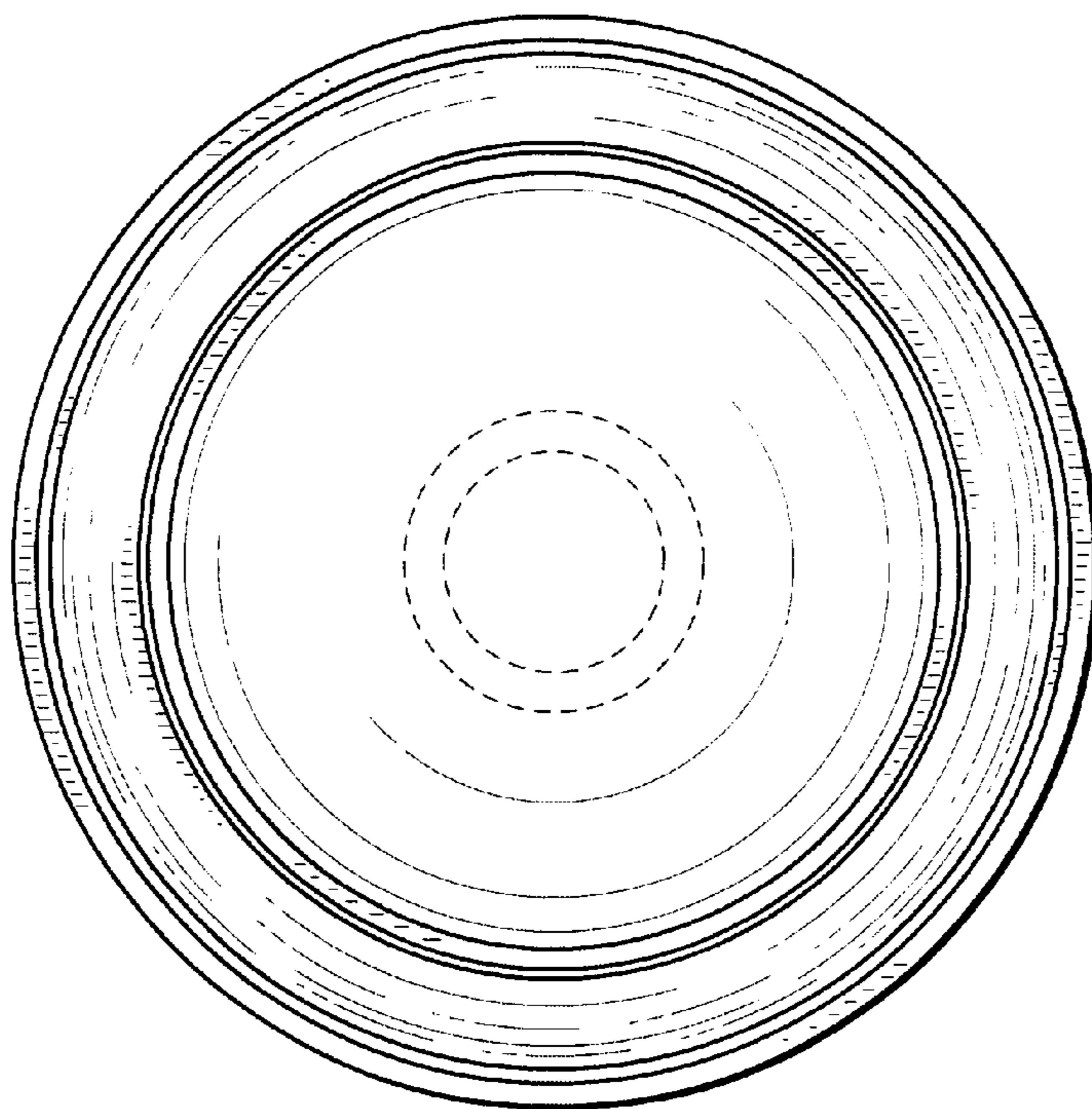
