DESCRIPTION

FIG. 1 is a perspective view of one embodiment of the container of the present invention showing the front and right side thereof.

FIG. 2 is a side view of the container of FIG. 1 showing the front thereof.

FIG. 3 is a side view of the container of FIG. 1 showing the front and/or left side thereof.

FIG. 4 is a bottom view of the container of FIG. 1.

FIG. 5 is a top view of the container of FIG. 1.

FIG. 6 is a perspective view of an alternate embodiment of the container of the present invention showing the front and right side thereof.

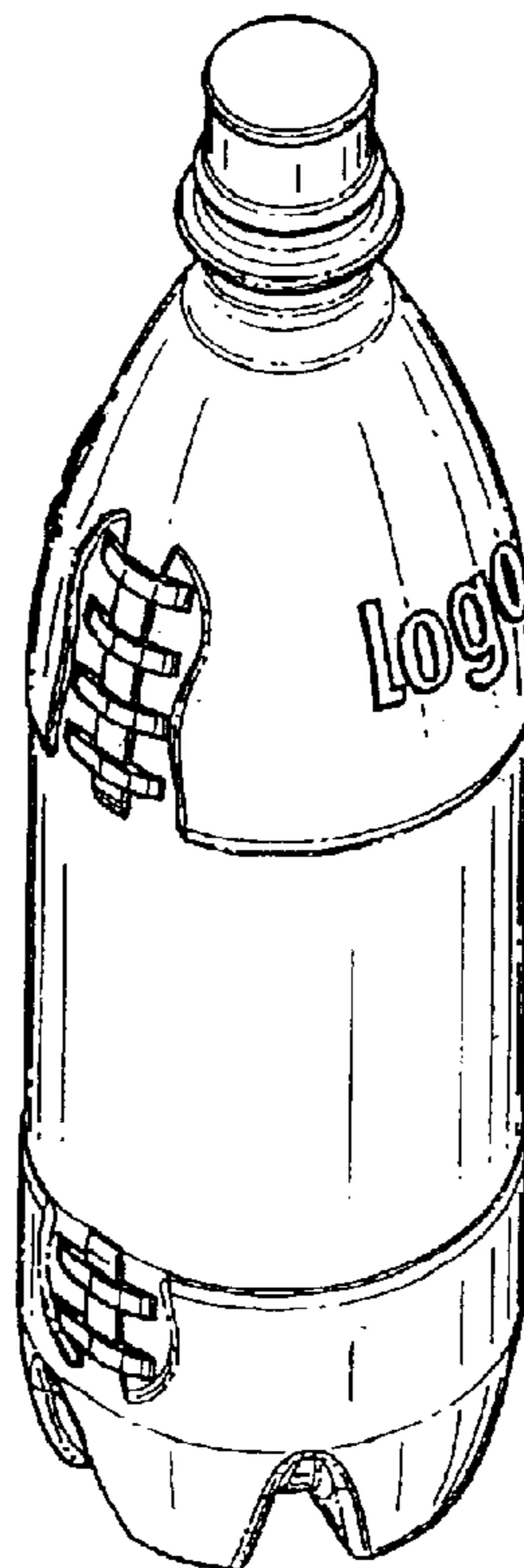
FIG. 7 is a side view of the container of FIG. 6 showing the front thereof.

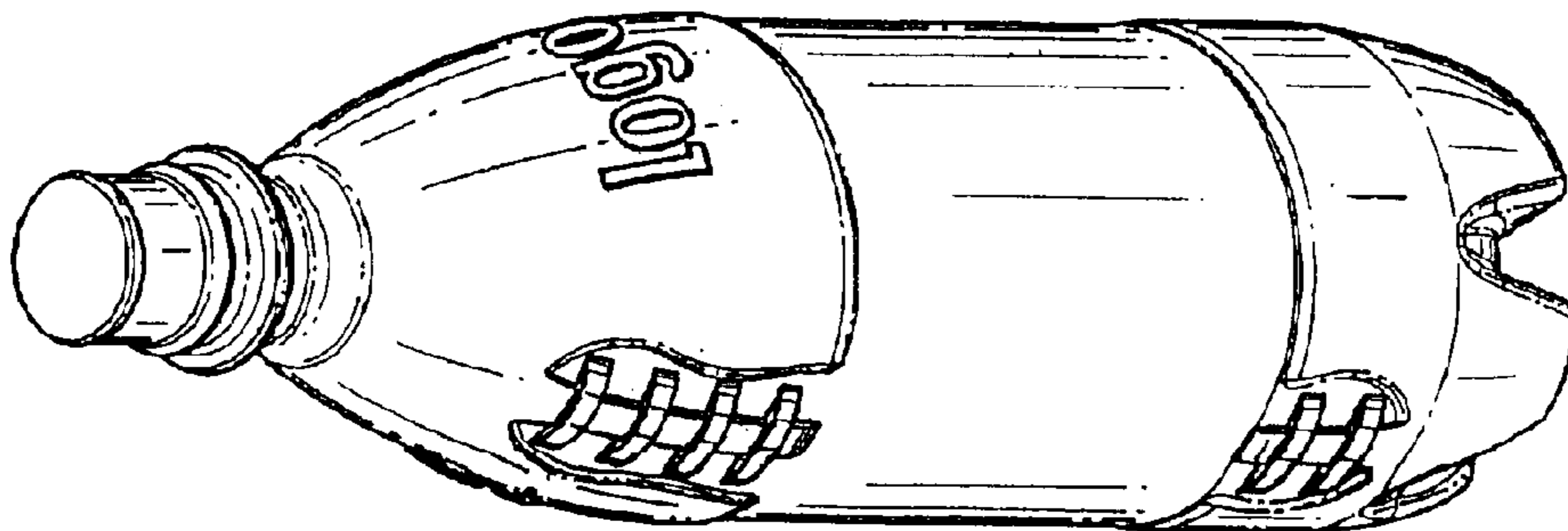

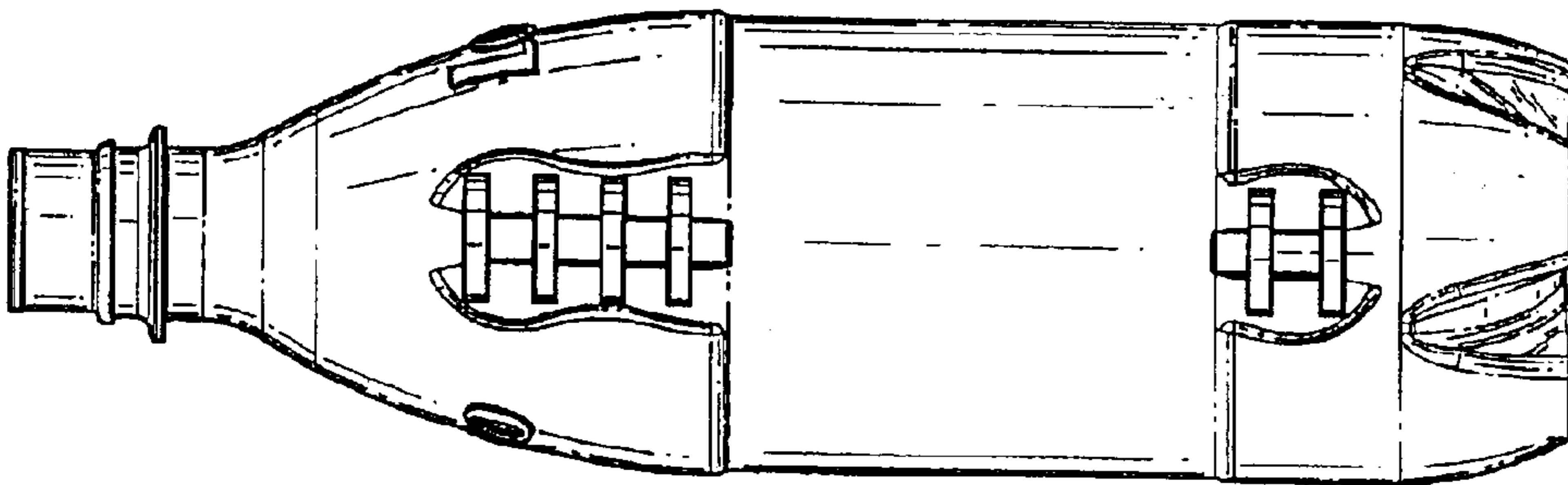

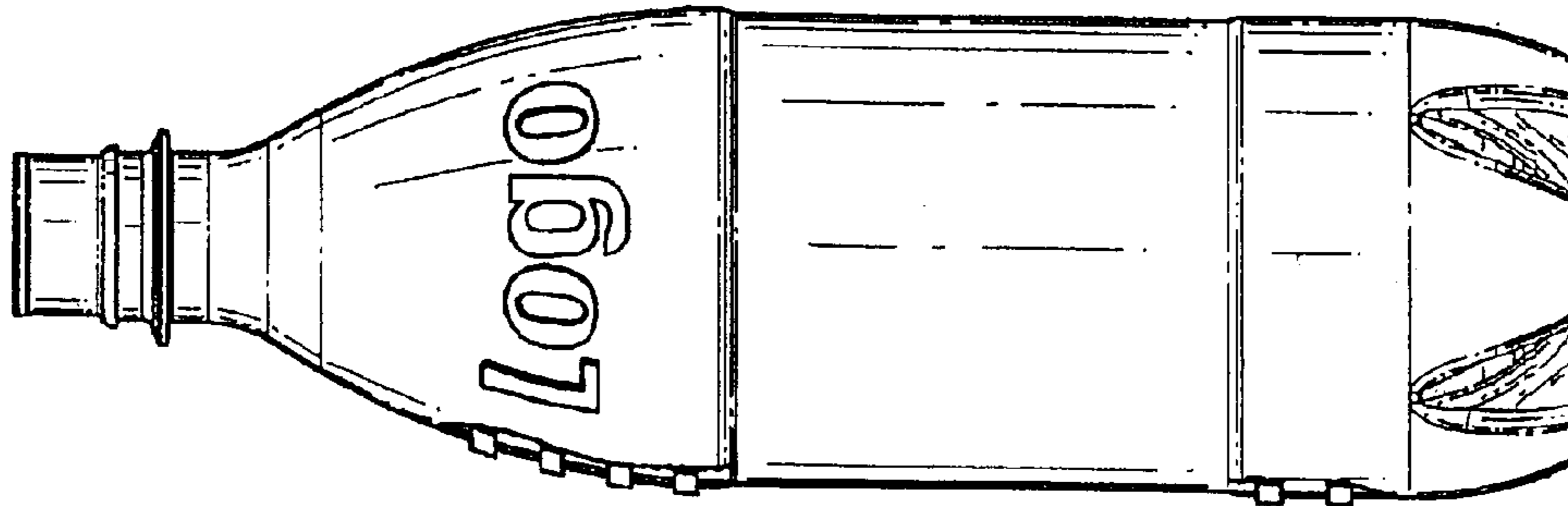

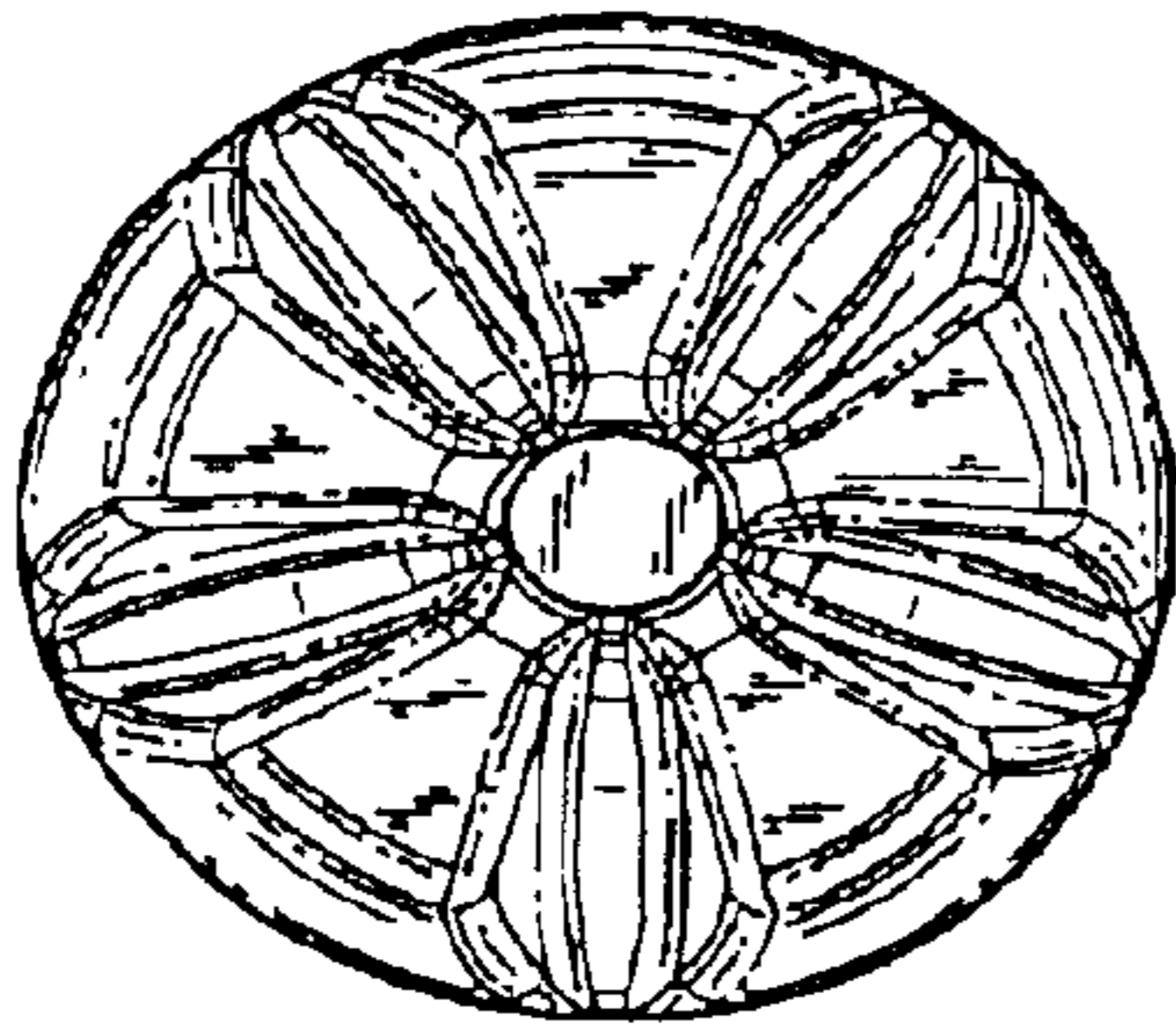

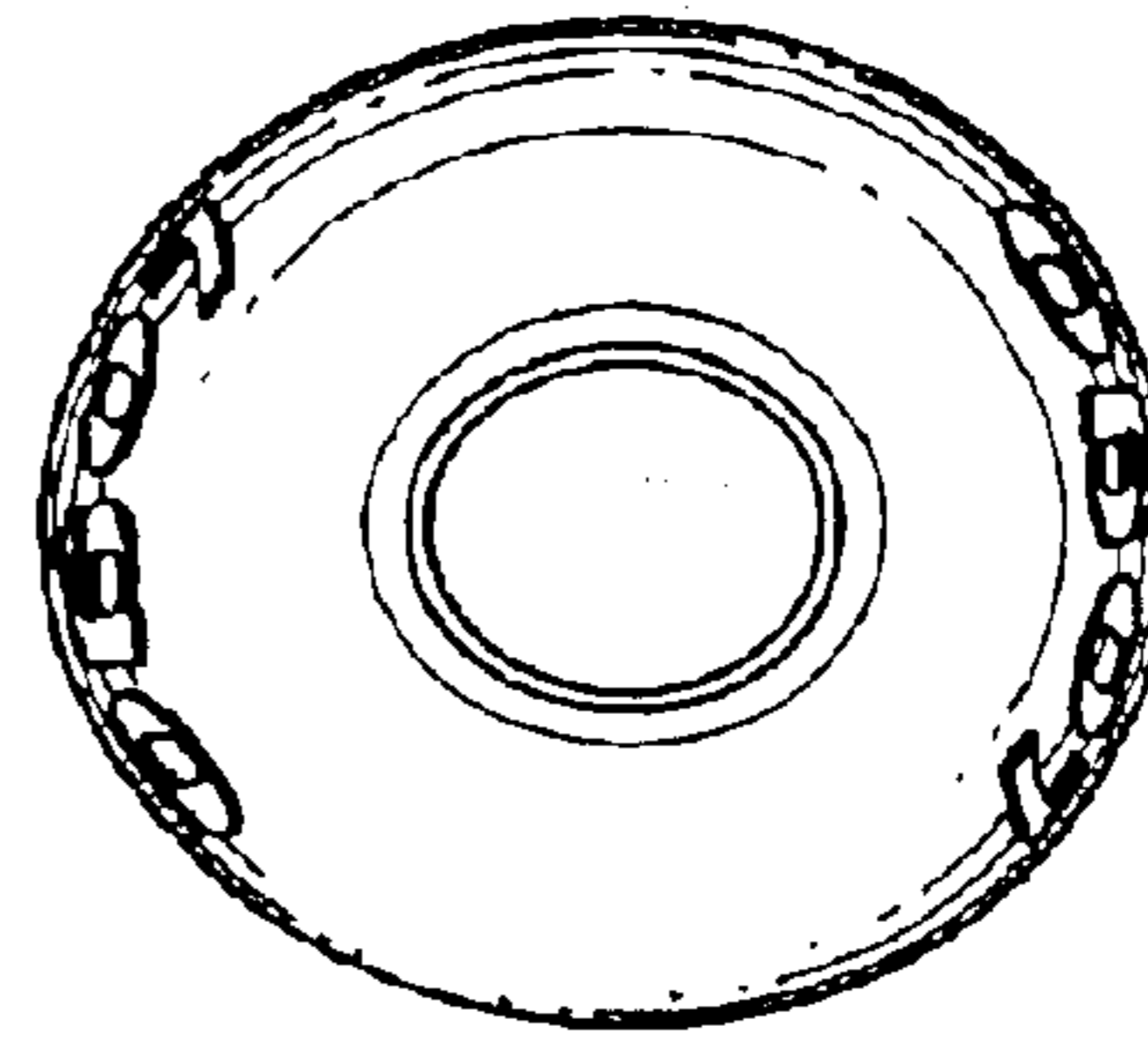

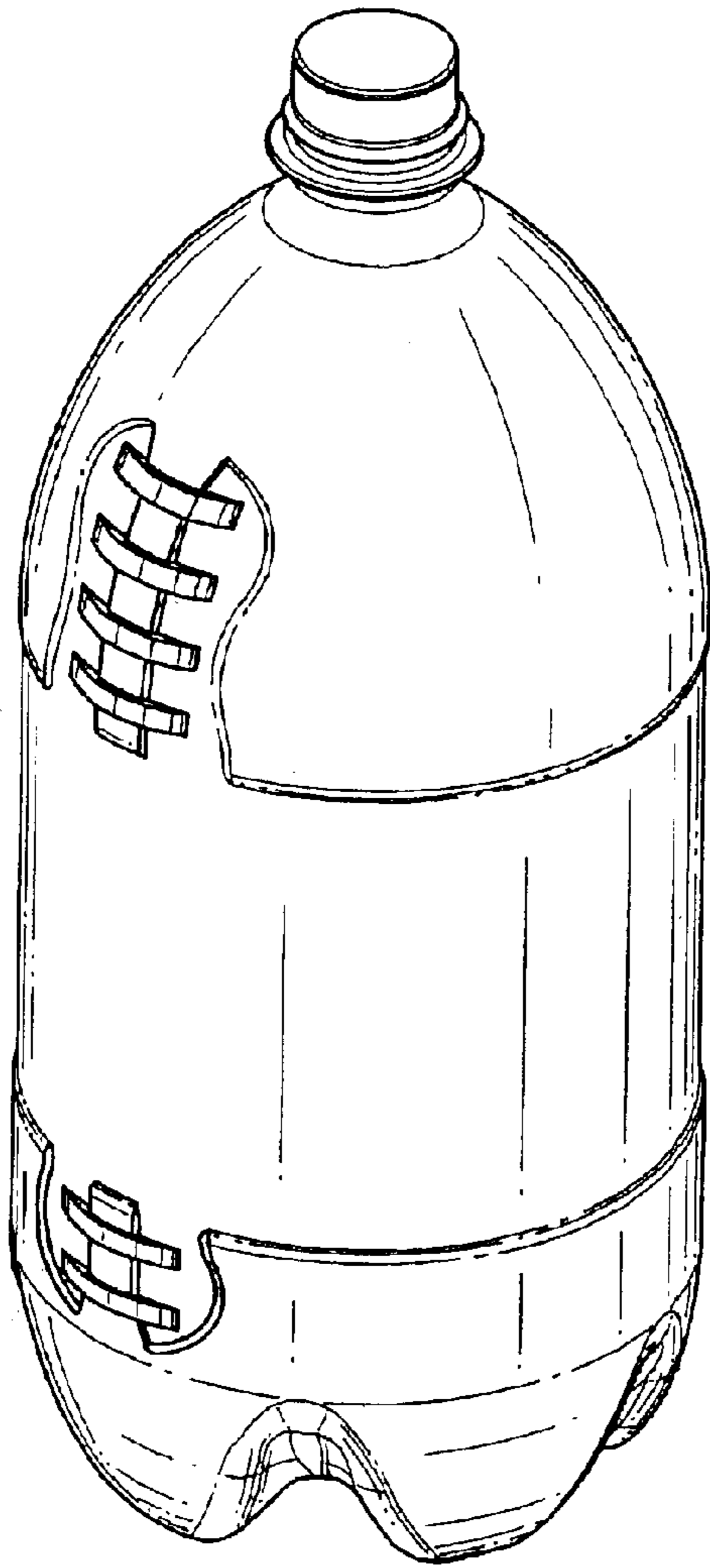

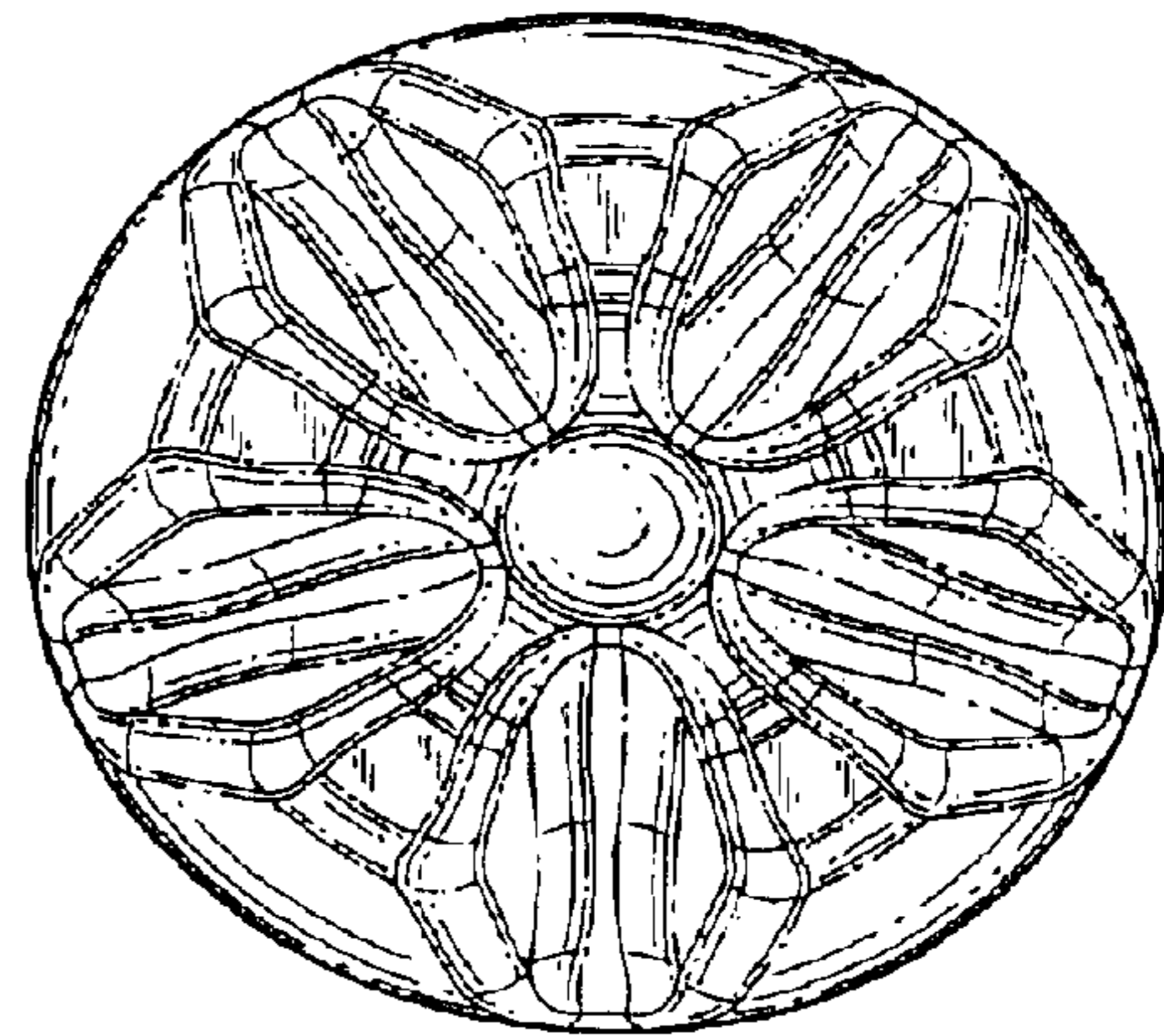

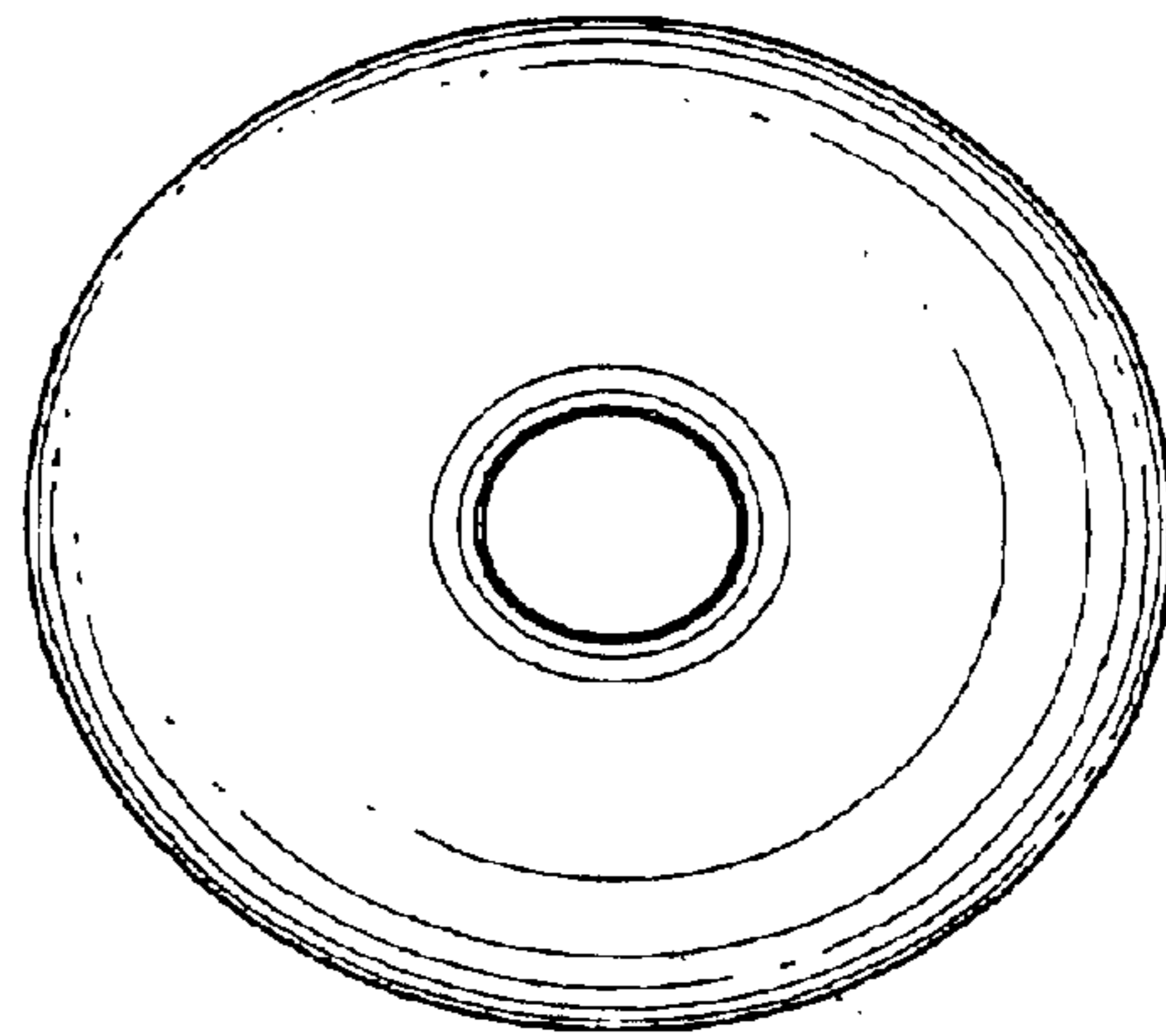

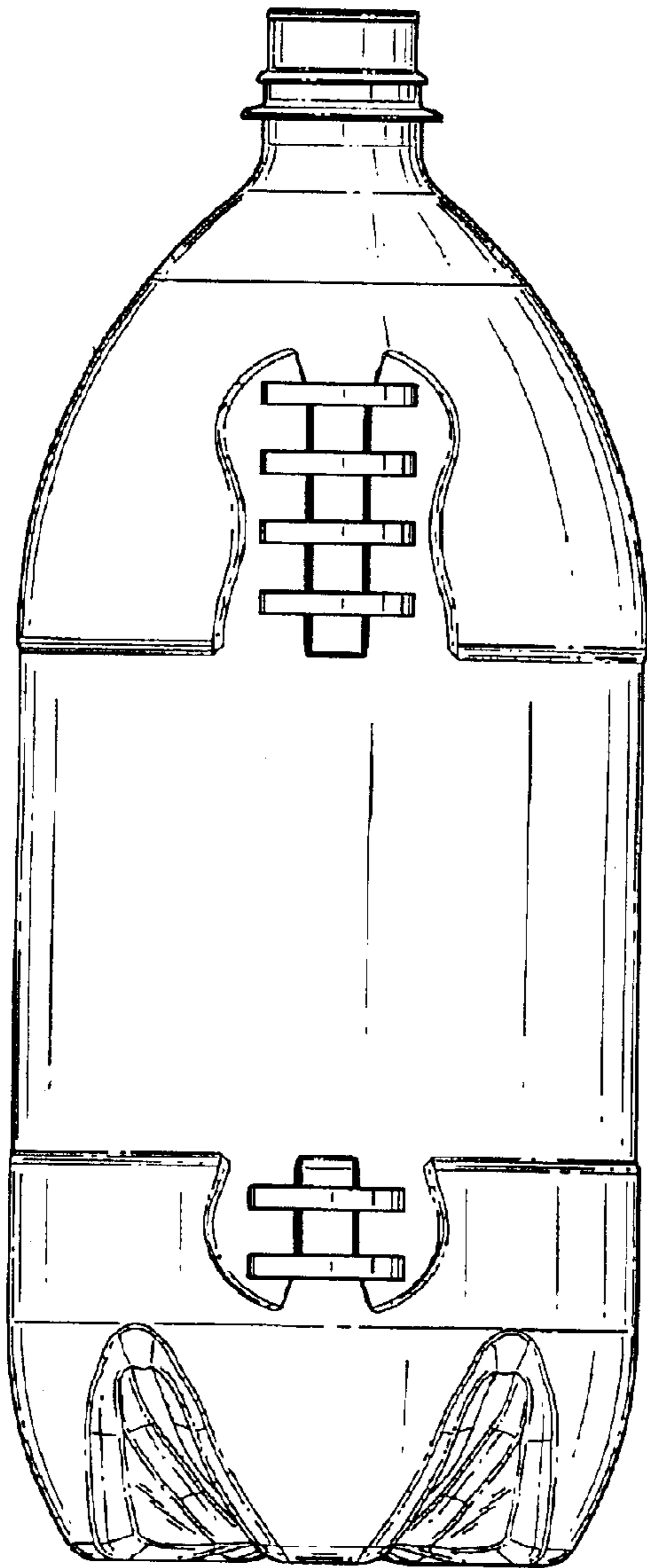

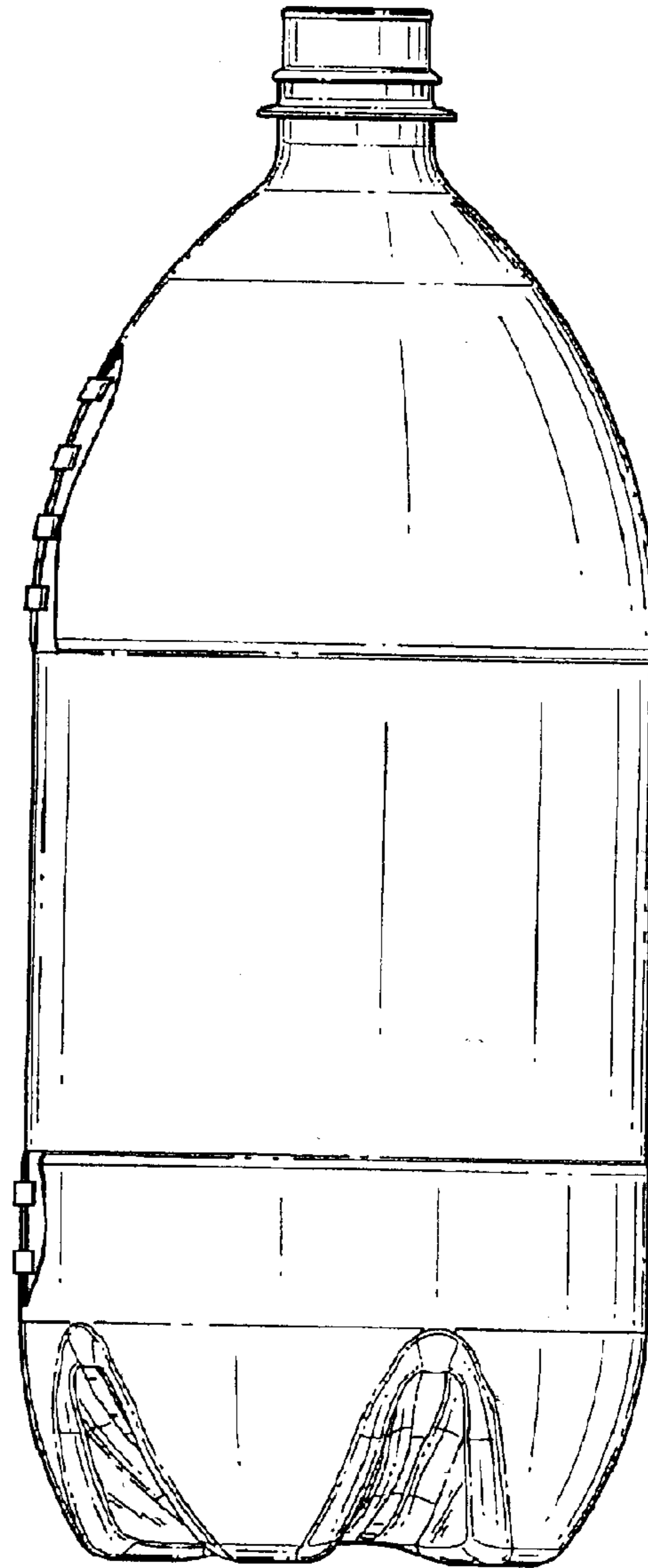
