DESCRIPTION

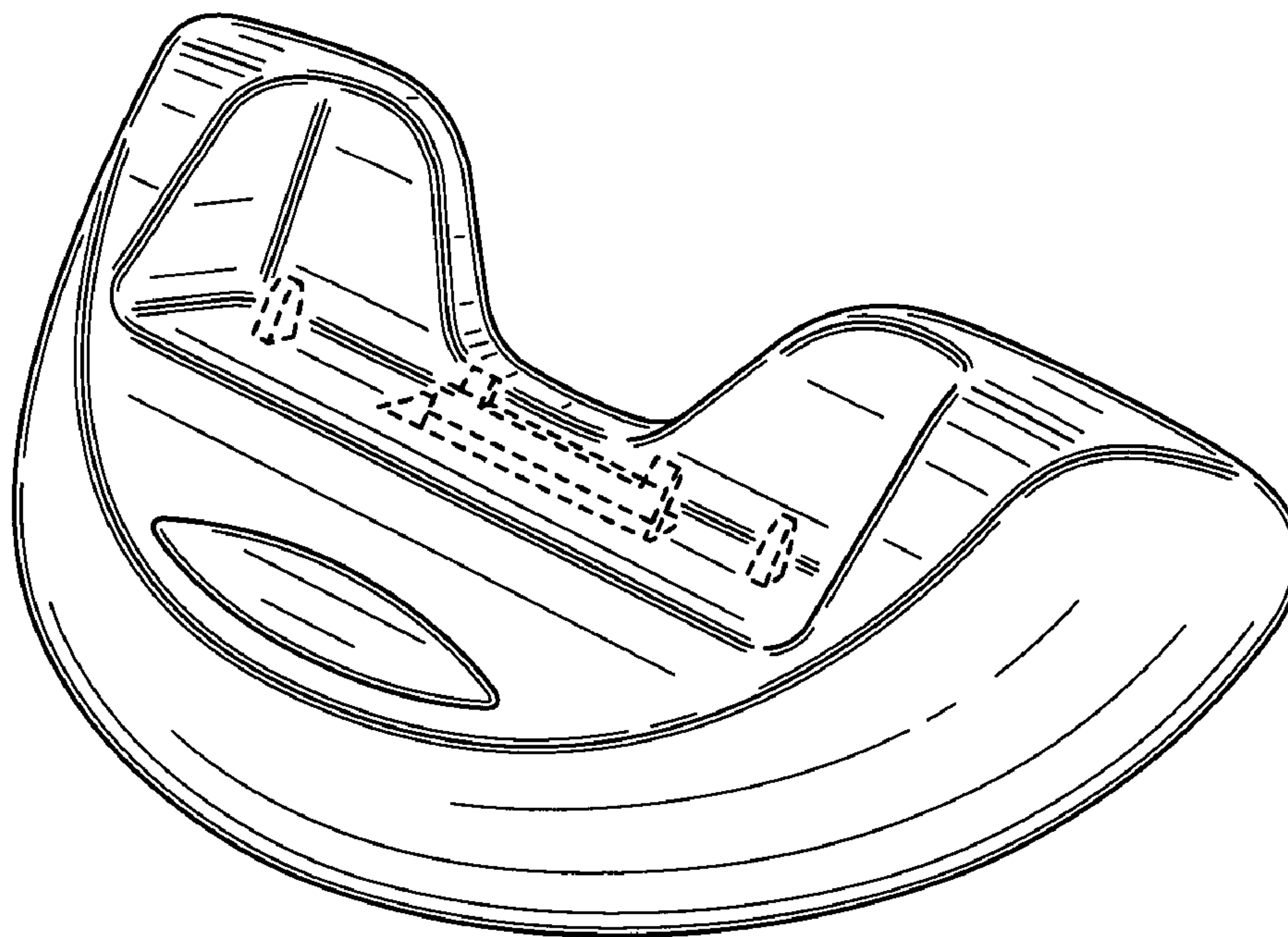
FIG. 1 is a perspective top-front view showing my new design;

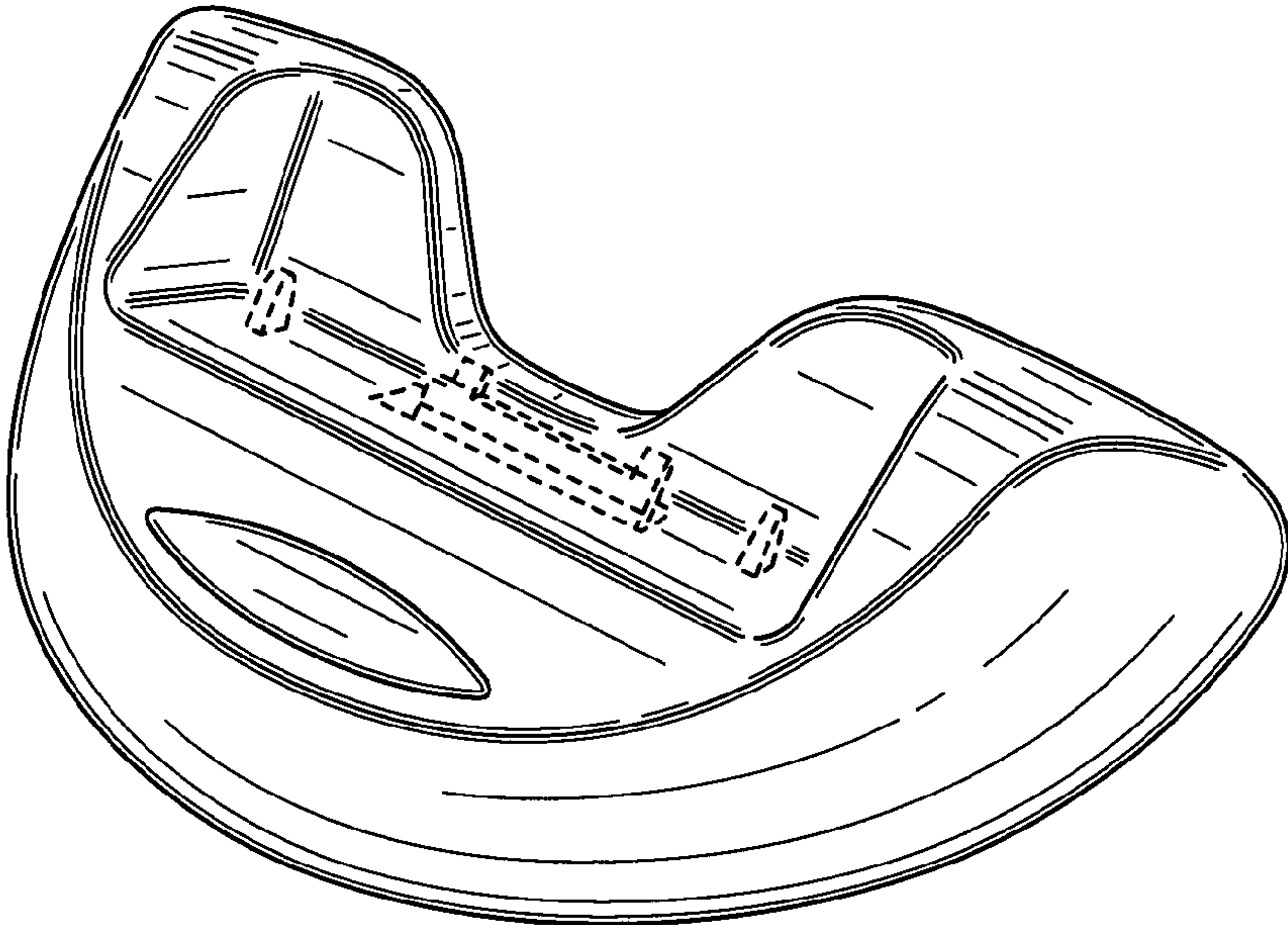

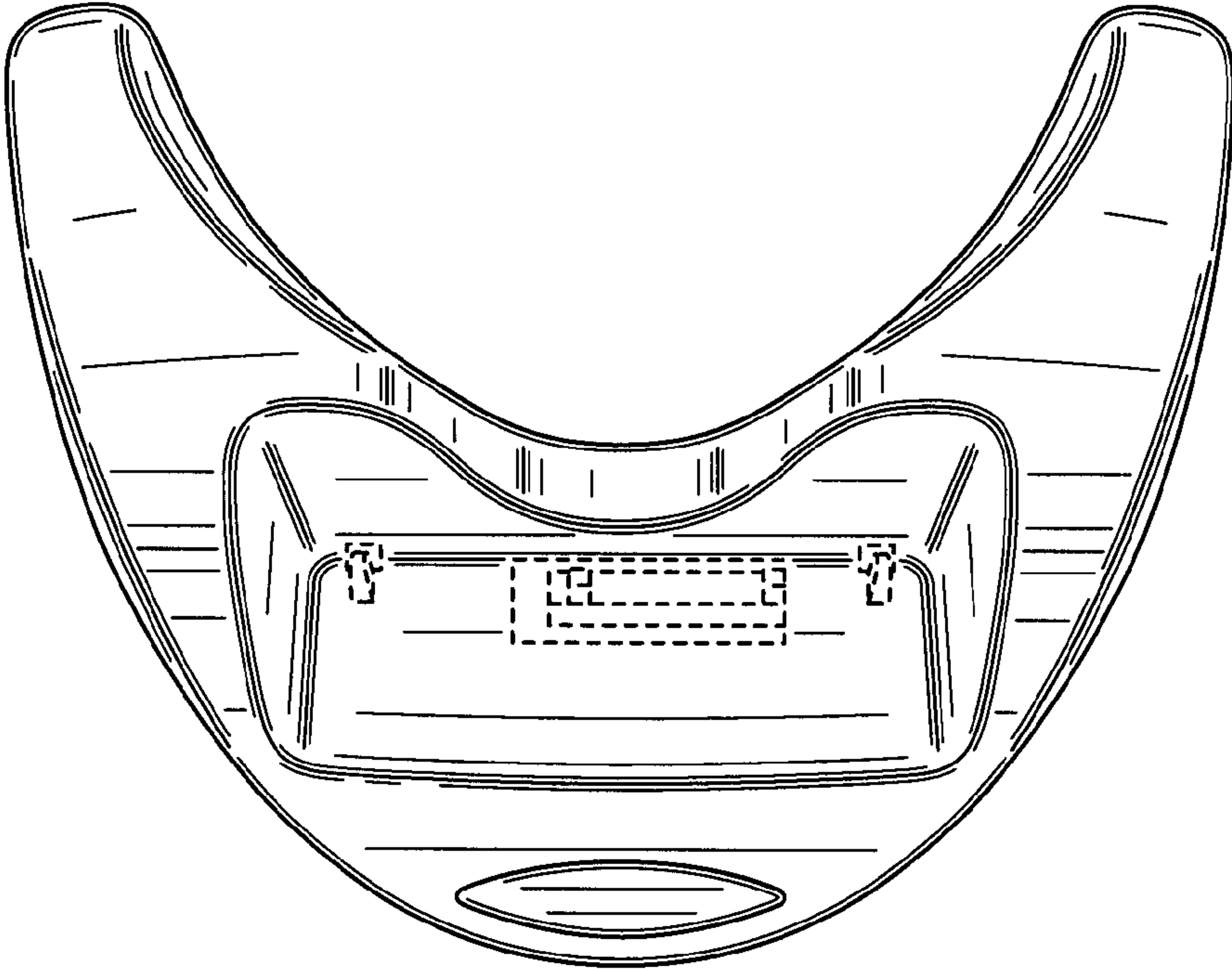

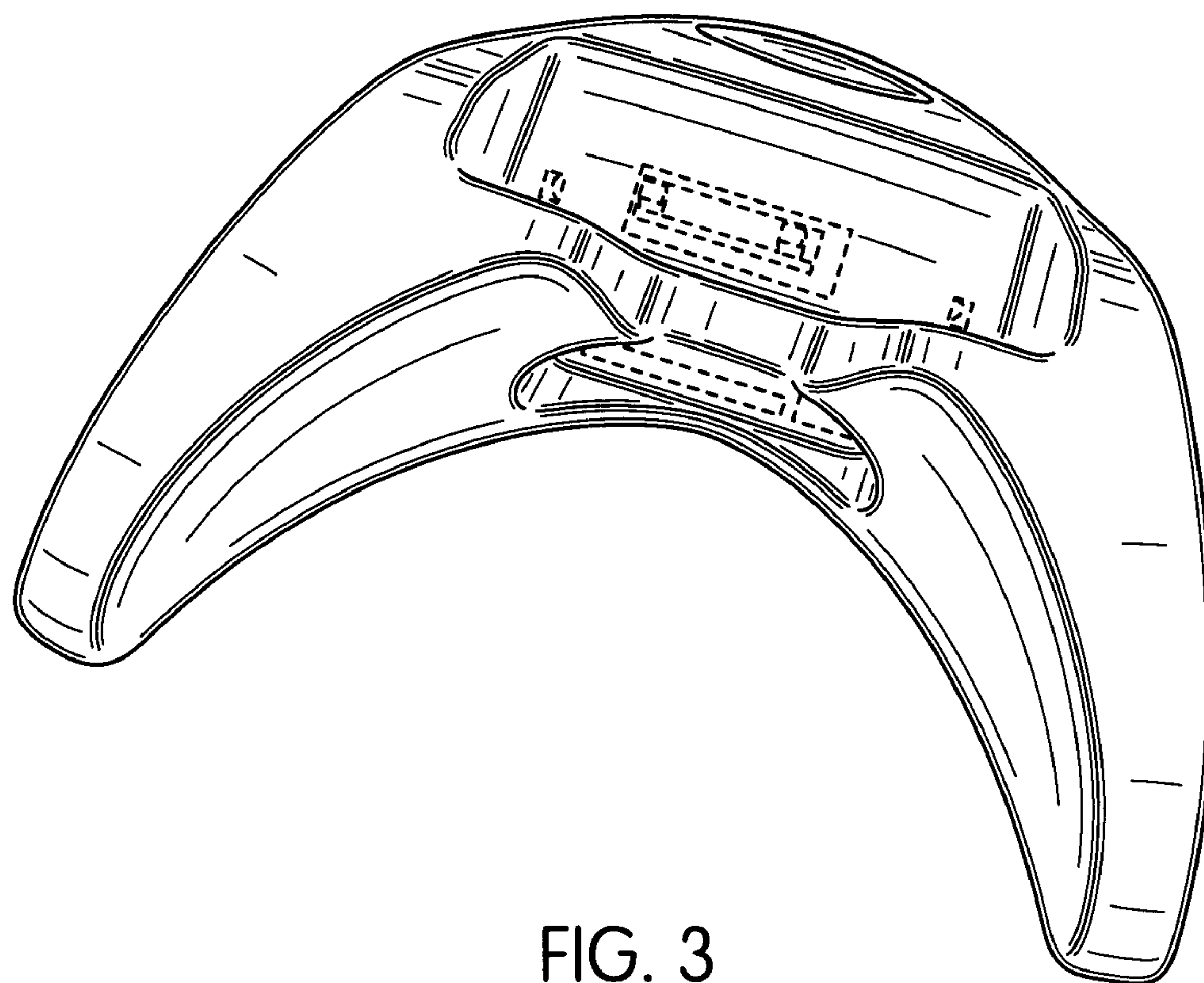
