We claim the ornamental design for mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a Perspective View of mobile phone showing the new design;  
FIG. 2 is a Front Elevation View thereof;  
FIG. 3 is a Rear Elevation View thereof;  
FIG. 4 is a Left-side Elevation View thereof;  
FIG. 5 is a Right-side Elevation View thereof;  
FIG. 6 is a Top Plan View thereof;  
FIG. 7 is a Bottom Plan View thereof; and,  
FIG. 8 is a Front Elevation View thereof in the open position.

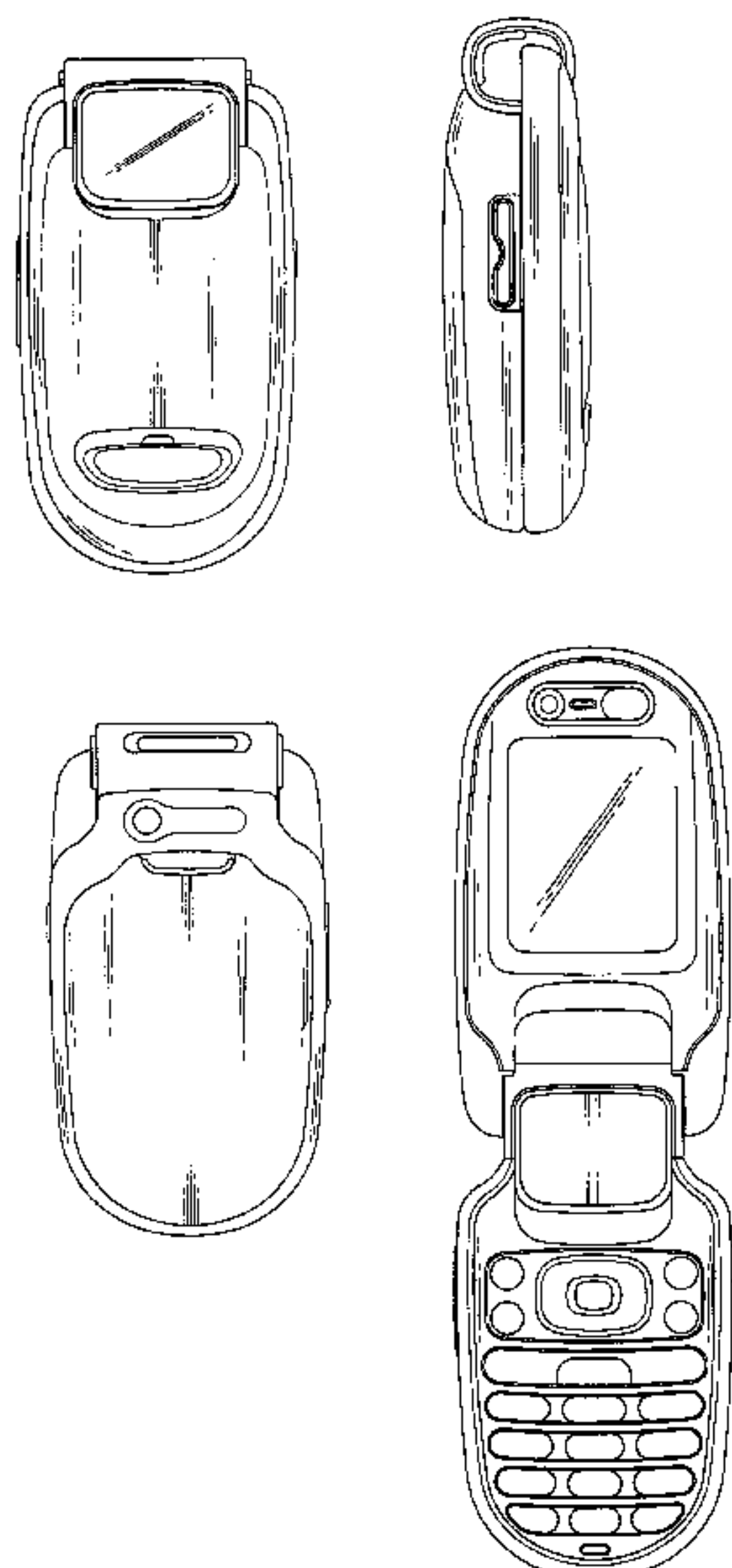

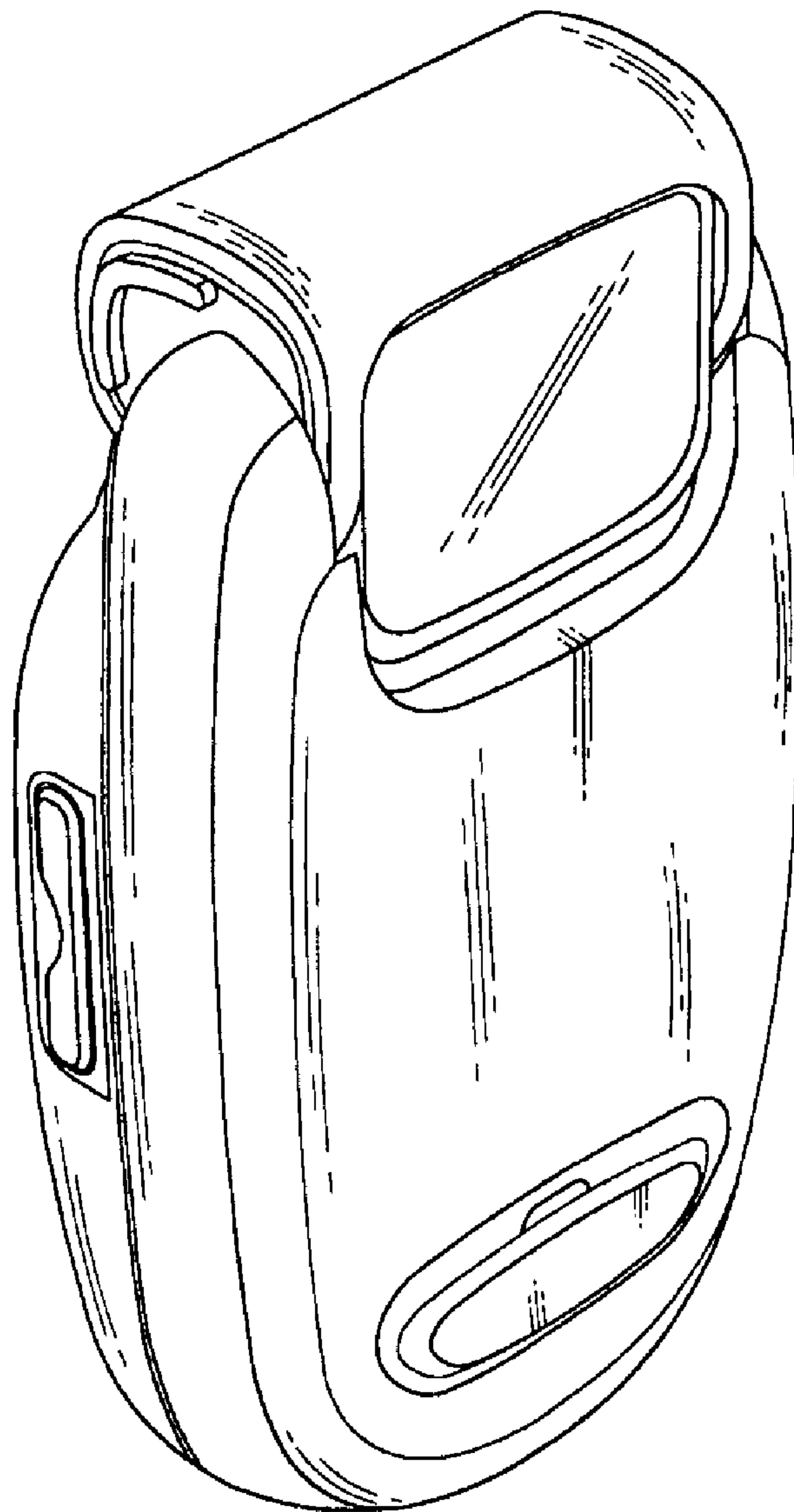

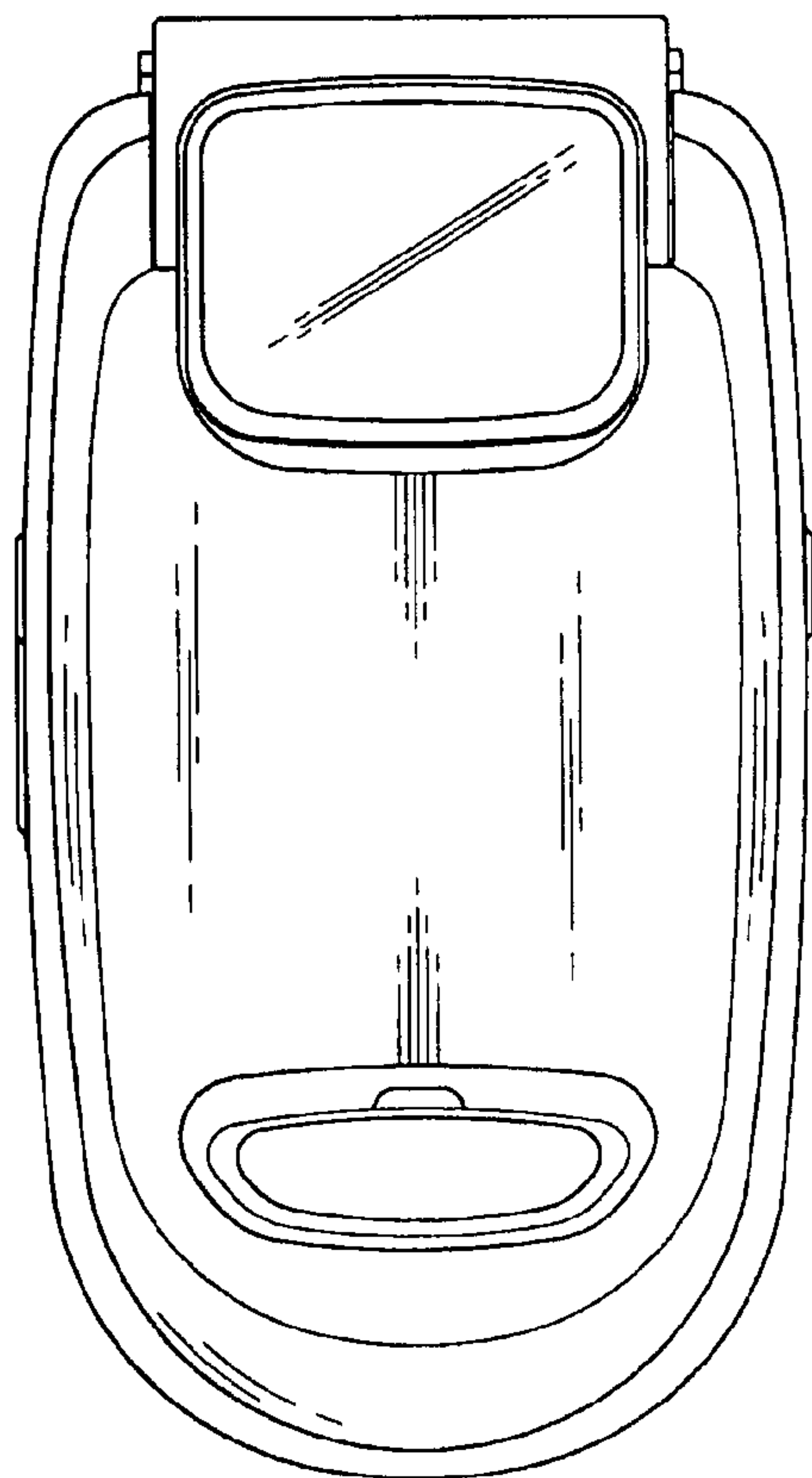

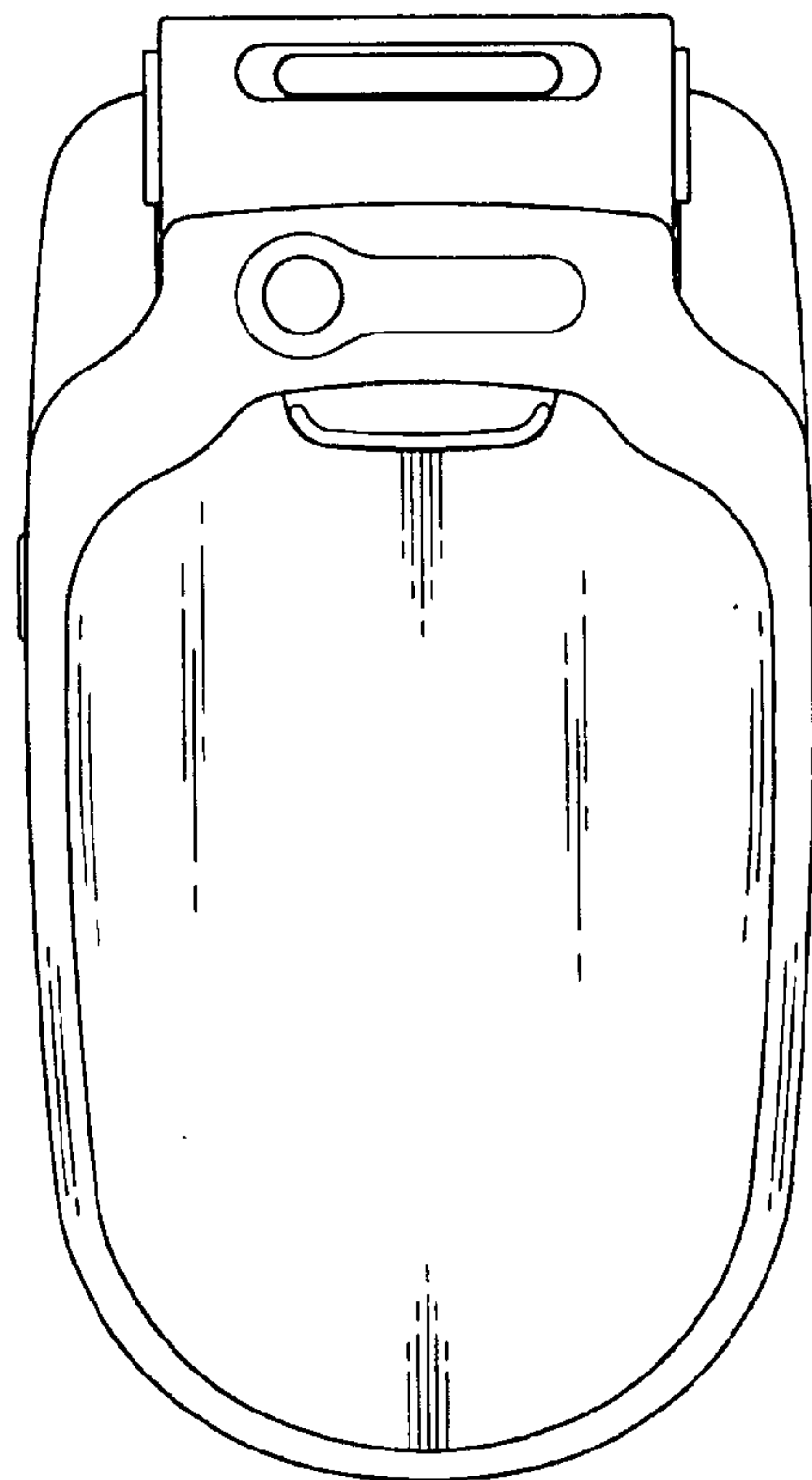

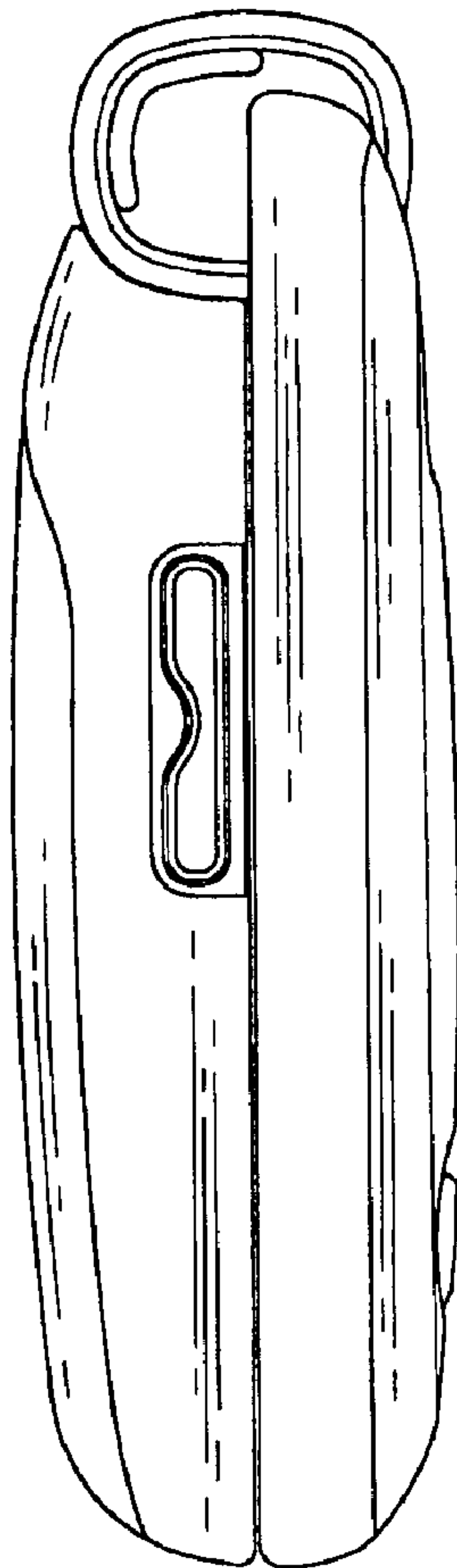

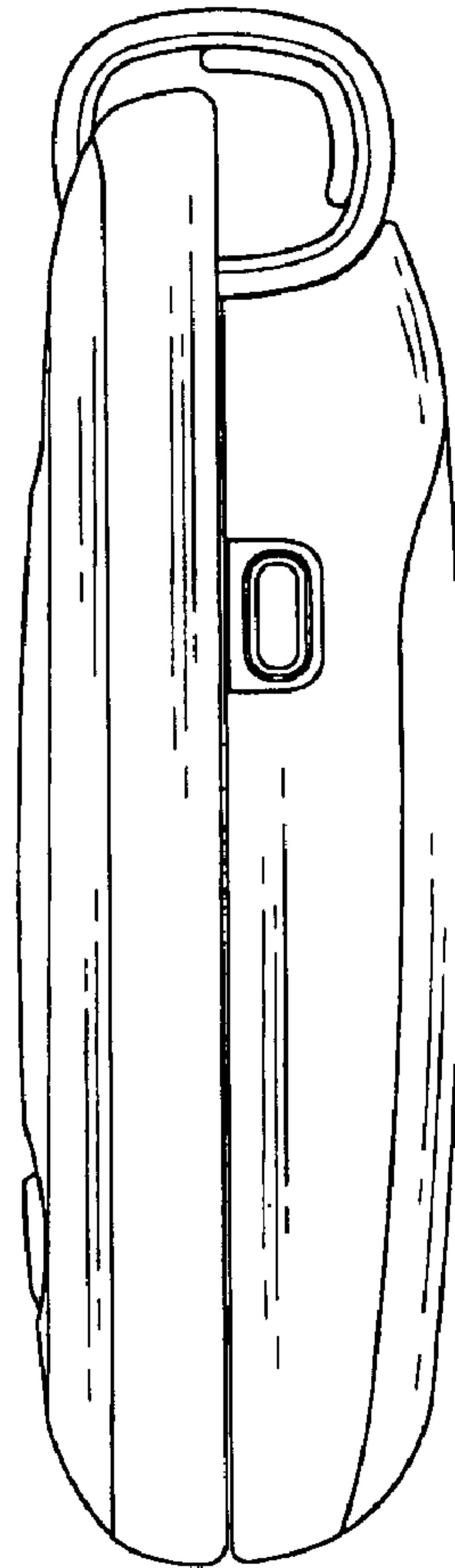

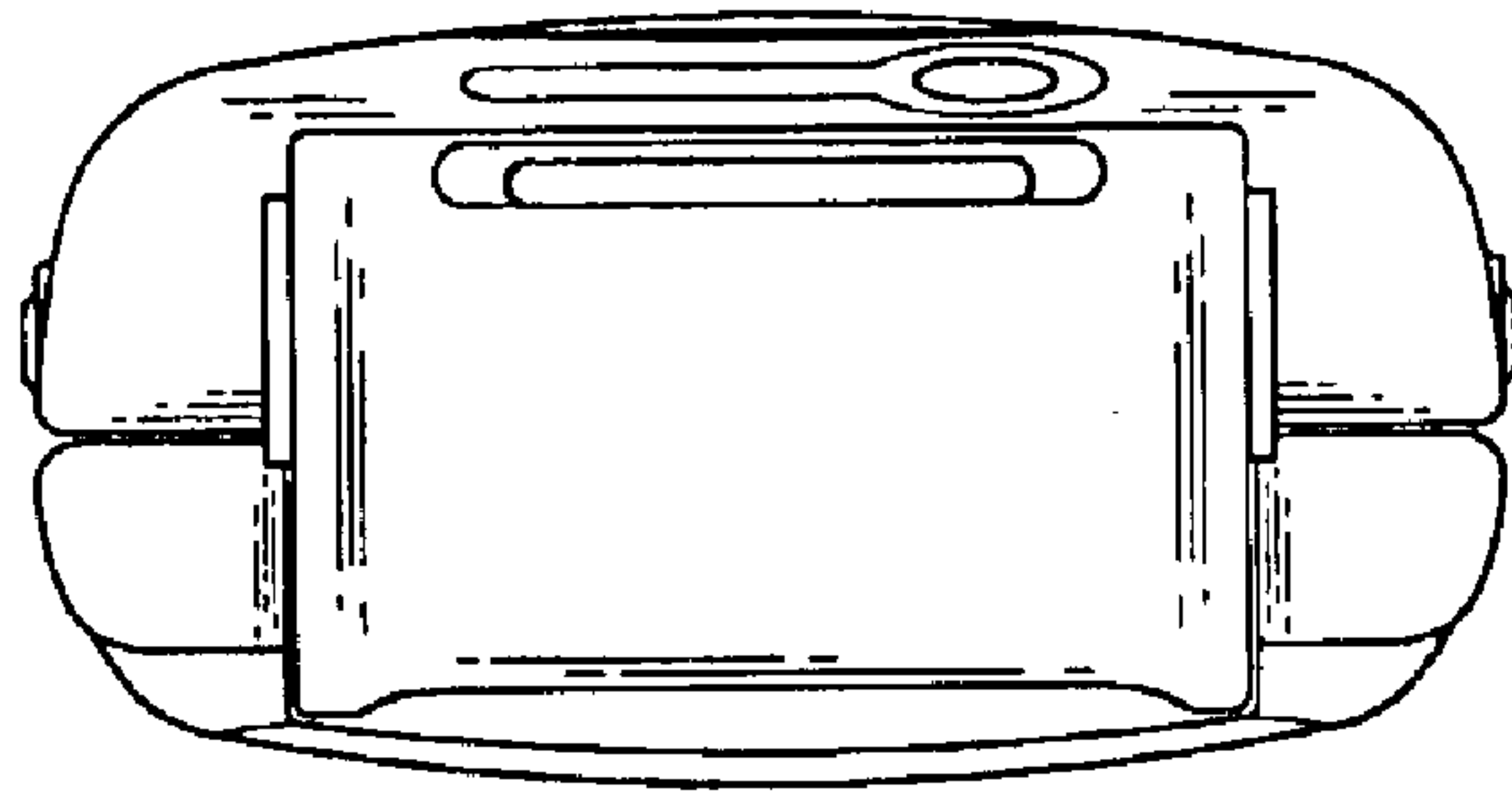
