(57) **CLAIM**

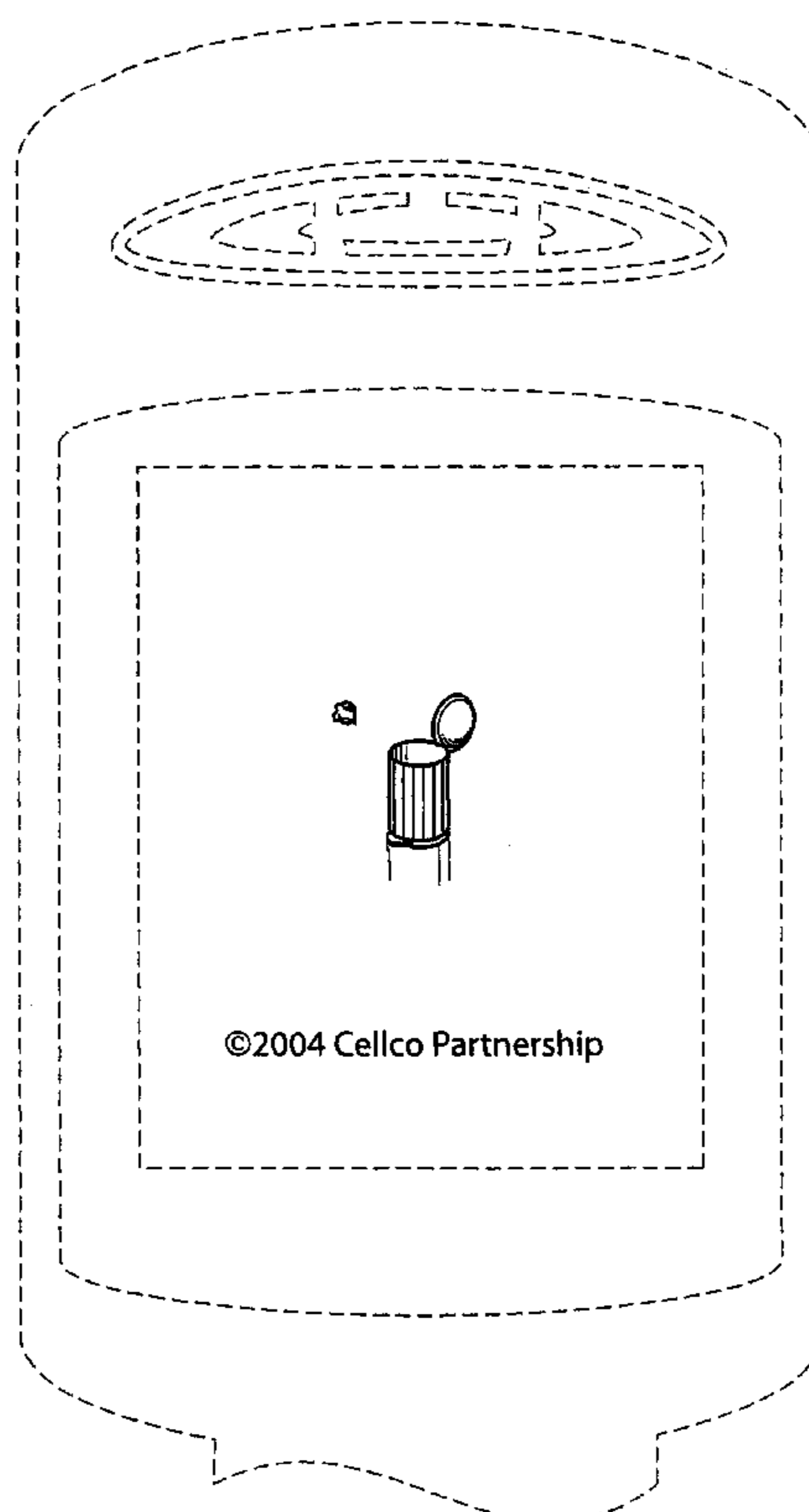
The ornamental design for an icon for the display screen of a cellularly communicative electronic device, as shown and described.

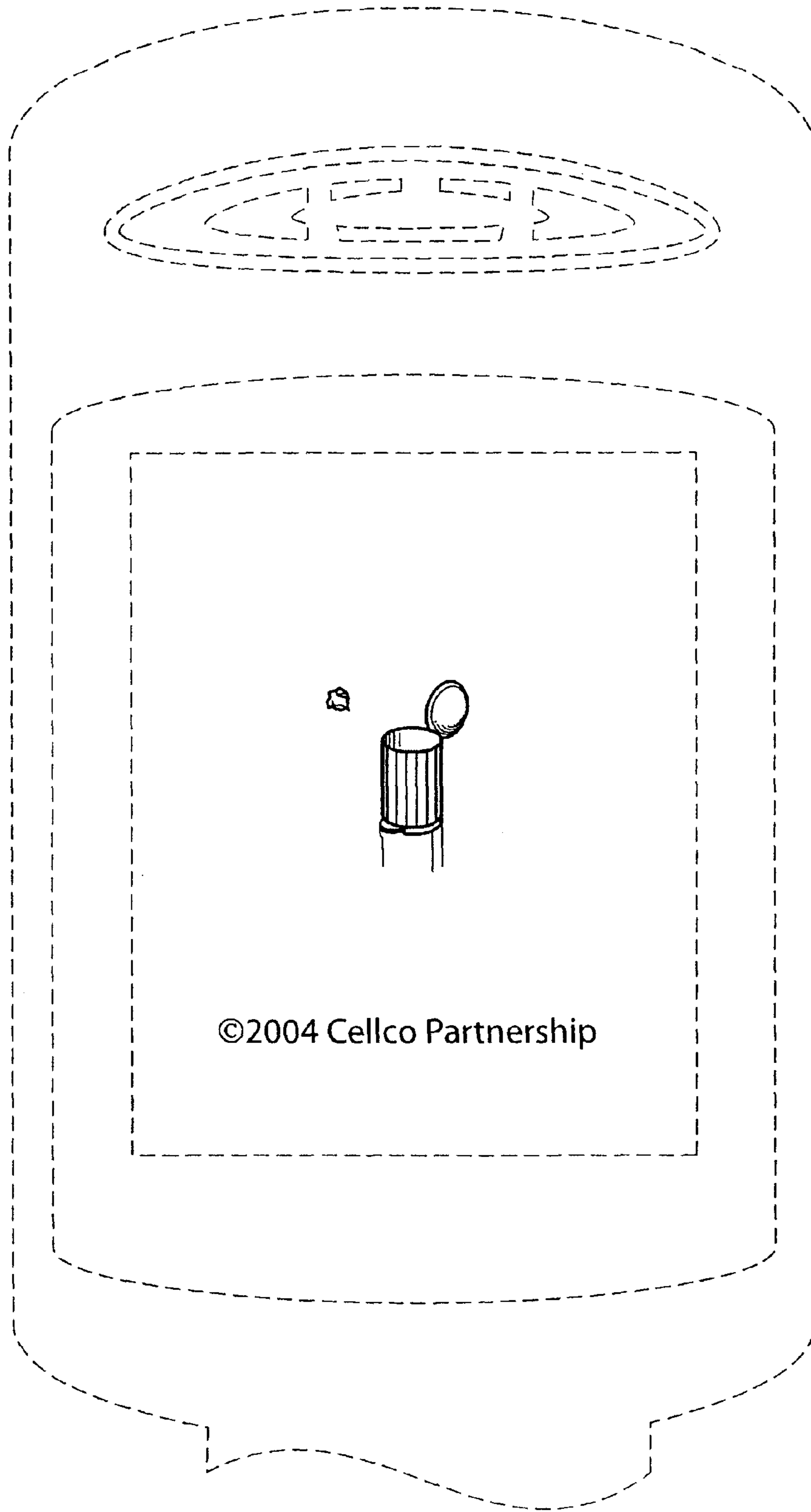
**DESCRIPTION**
