(57) **CLAIM**

The ornamental design for a turtle-shaped water trampoline, as shown and described.

FIG. 2 is a left side elevational view which is a mirror image of the right side;

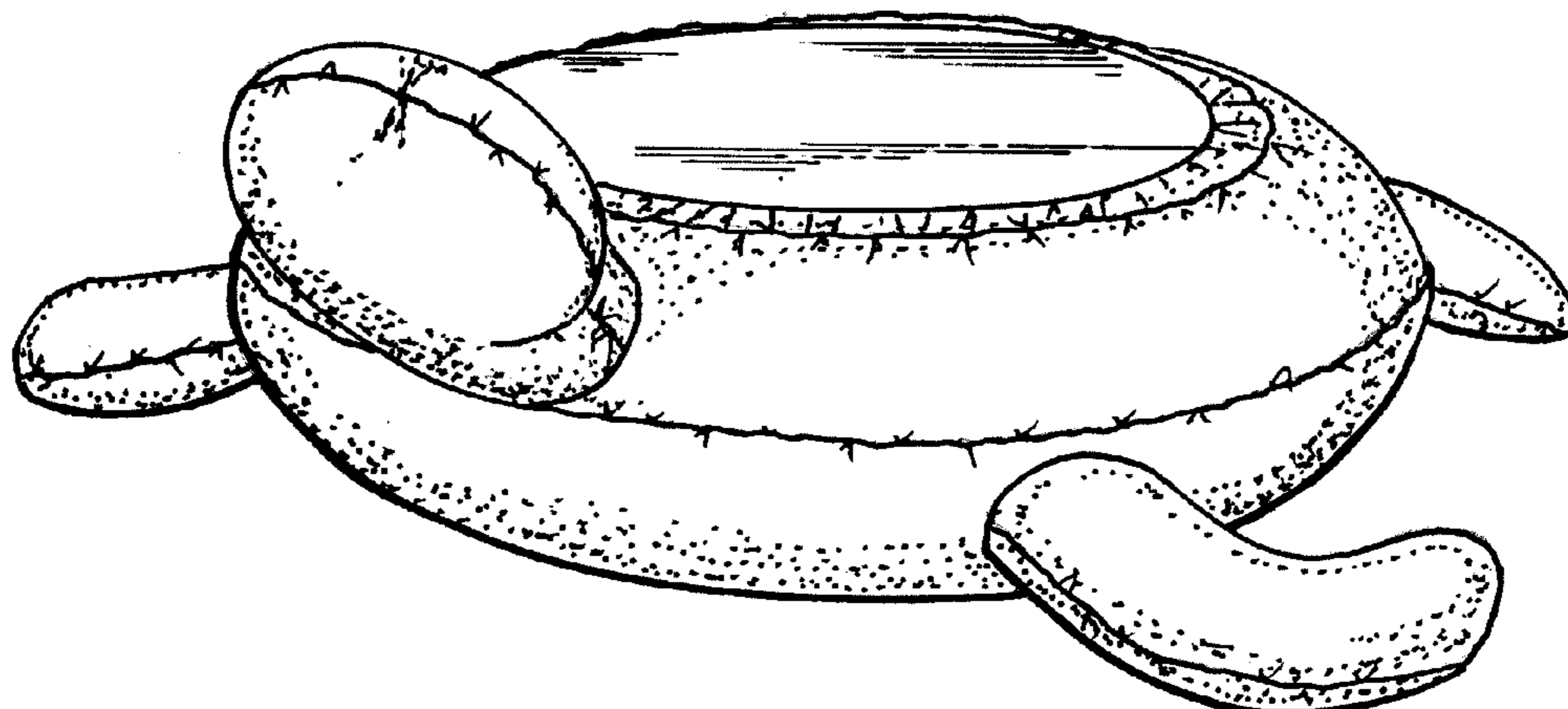
FIG. 3 is a rear elevational view;

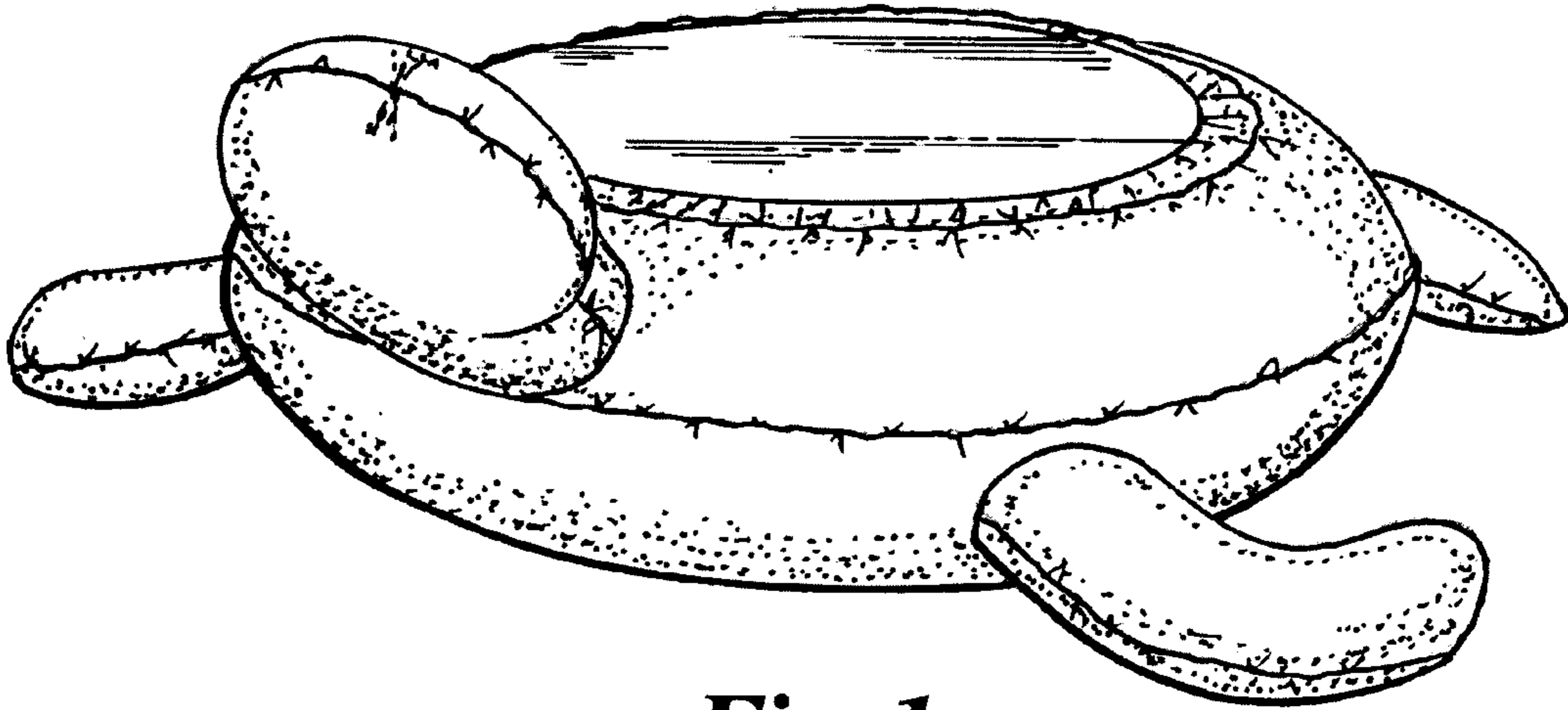
FIG. 4 is a top plan view; and

FIG. 5 is a bottom plan view; and,

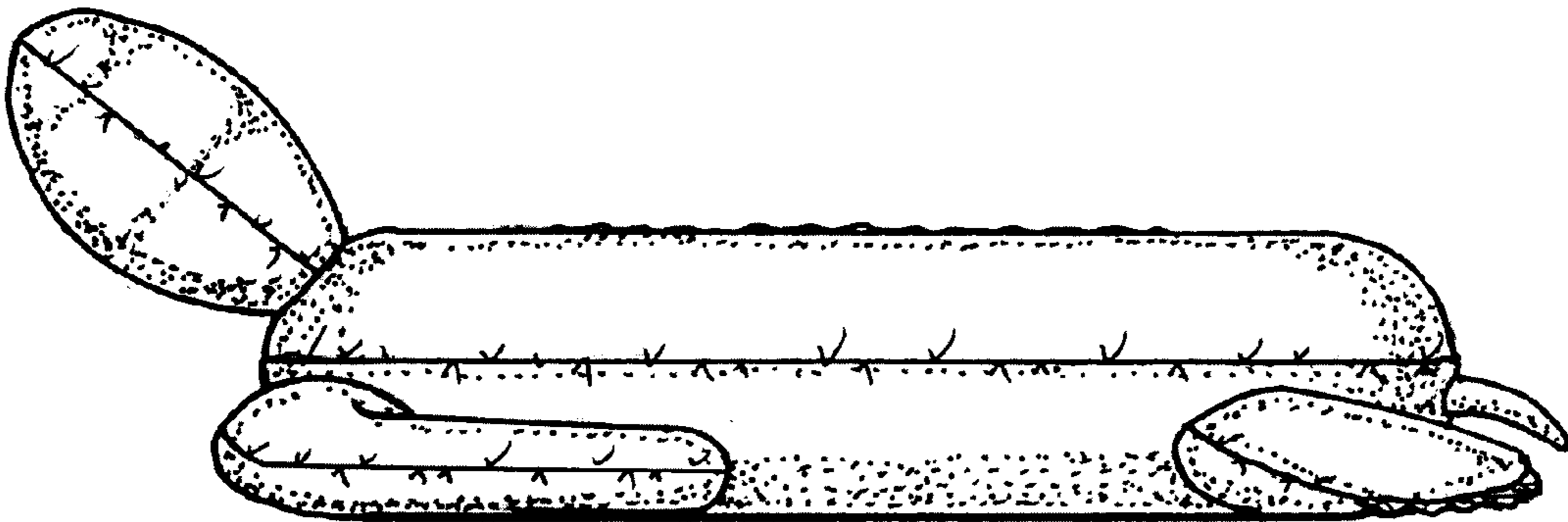
FIG. 6 is a front elevational view.

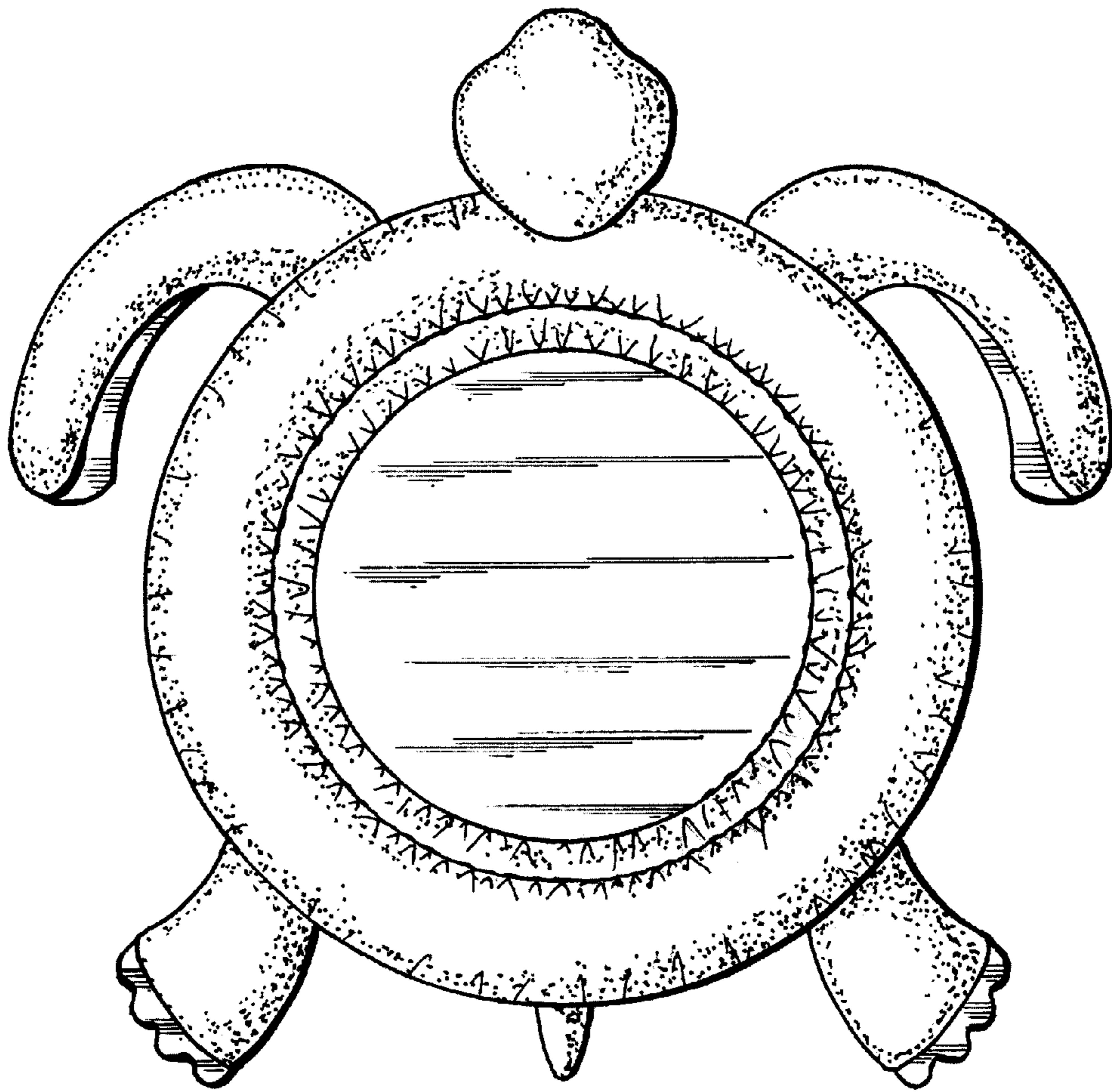




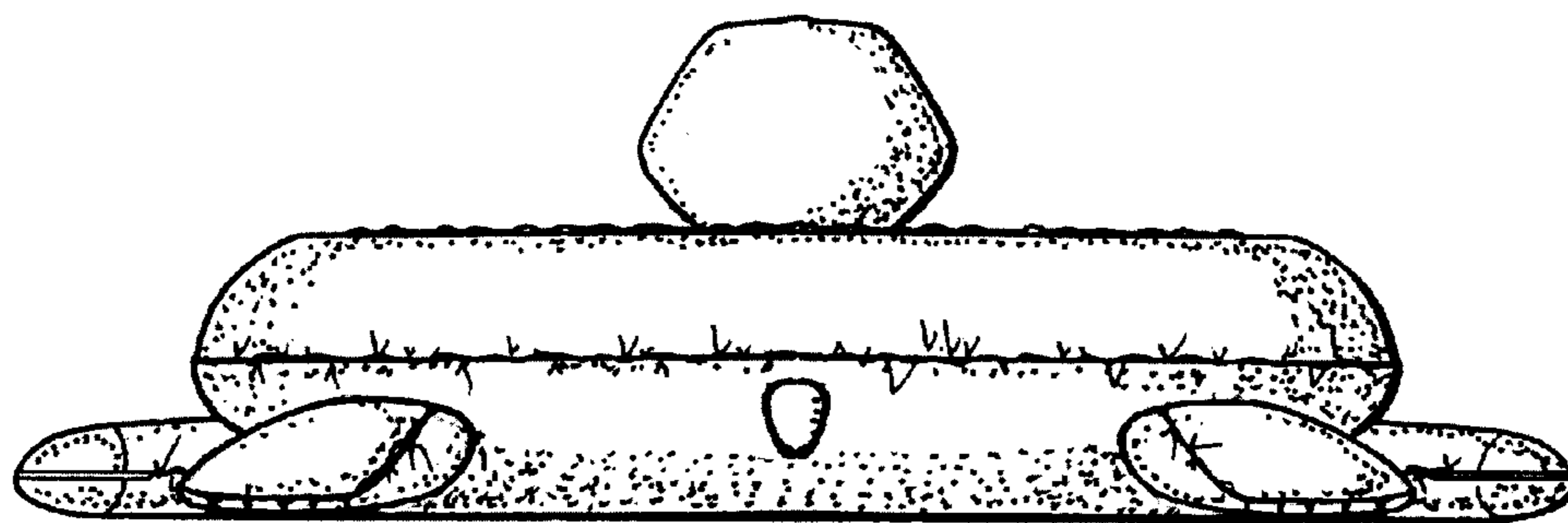

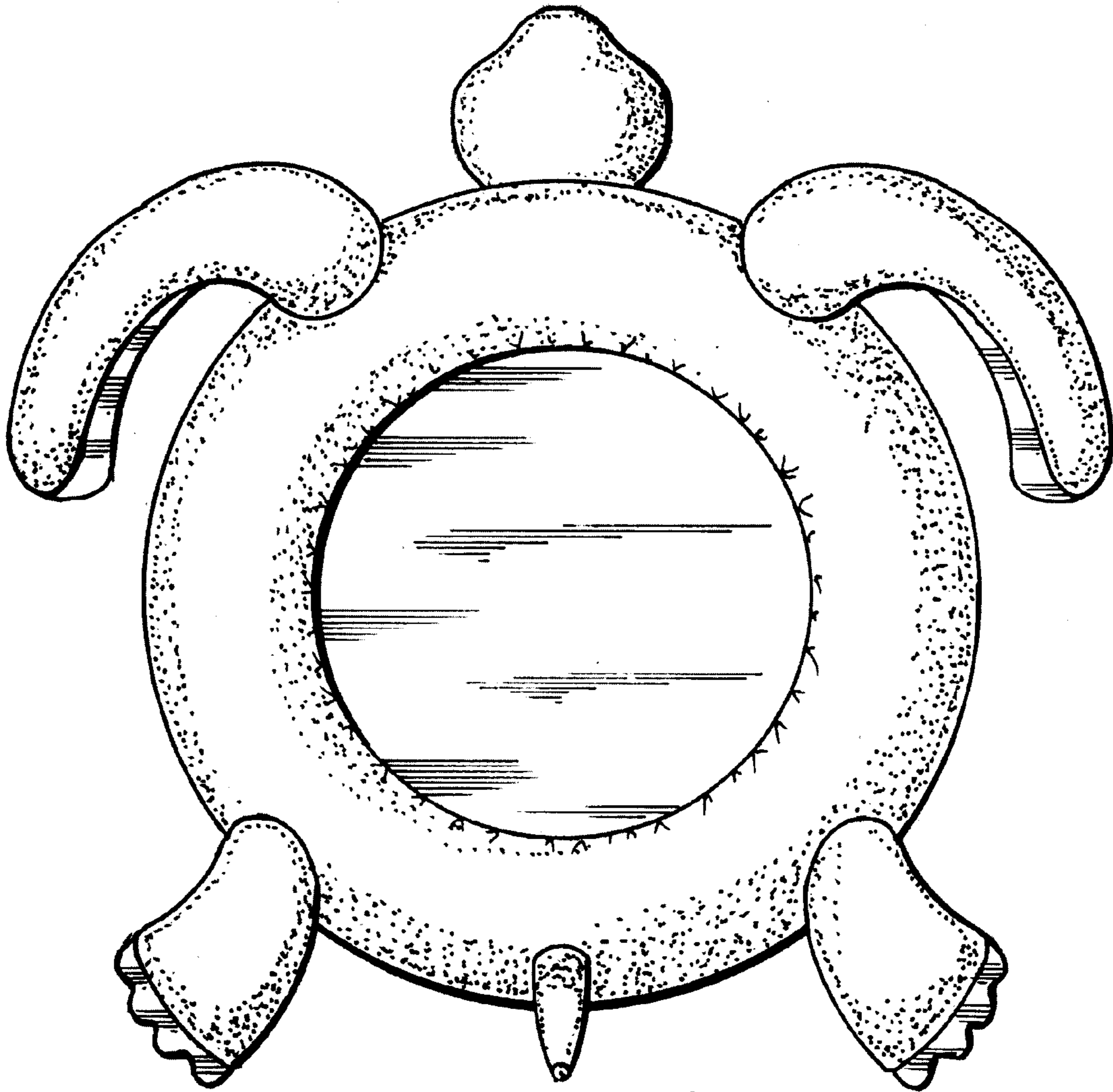

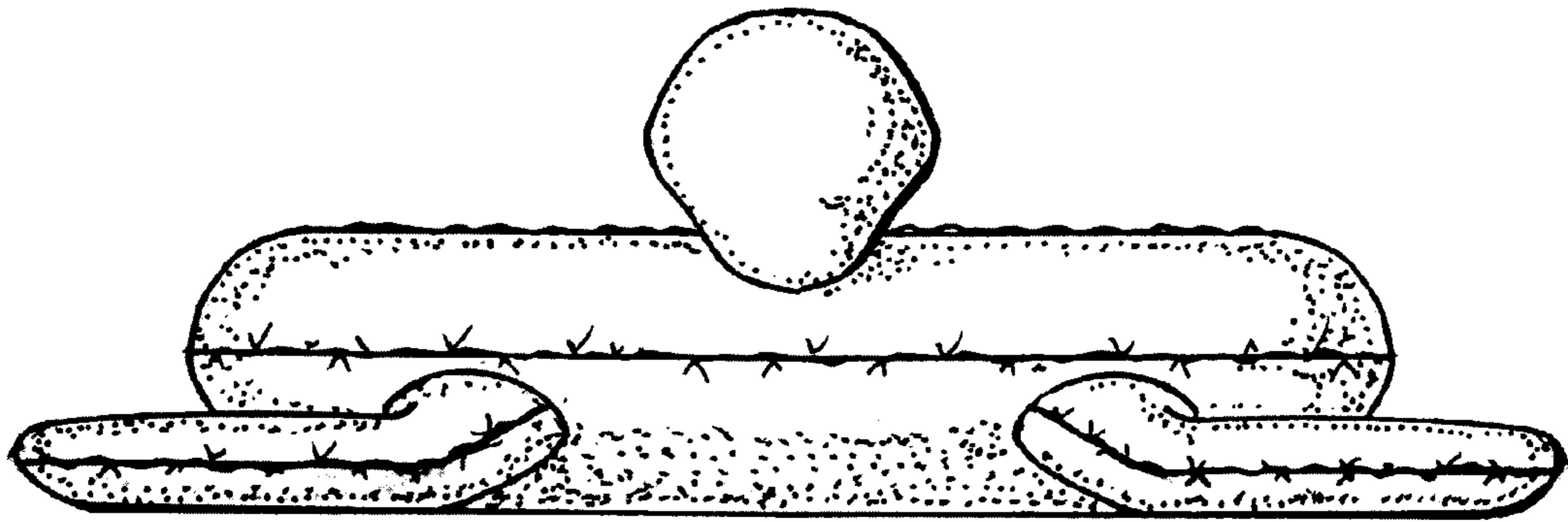
