FIG. 2 is a bottom view of the apparatus depicted in FIG. 1.

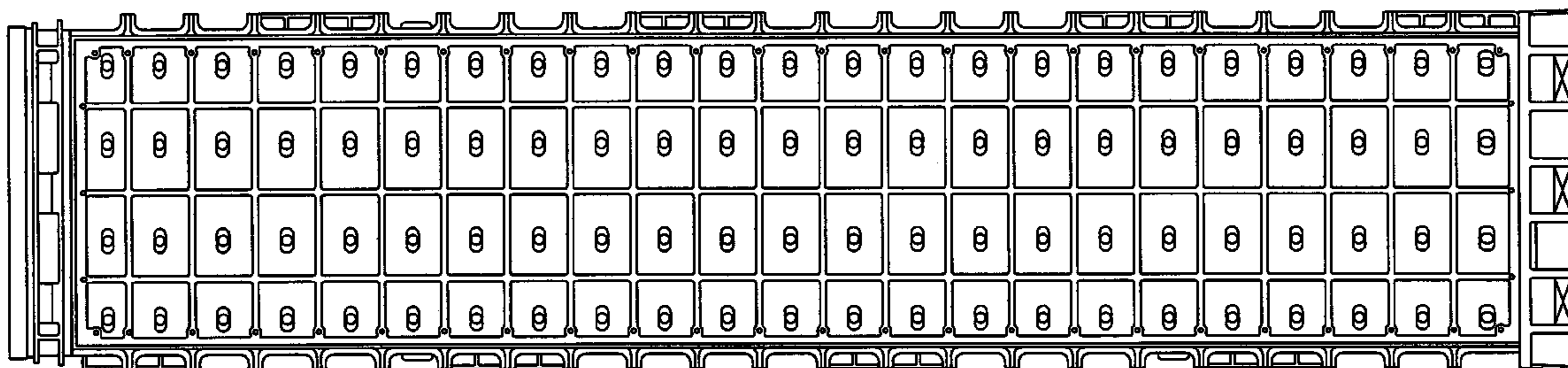
FIG. 3 is a front elevation view of the apparatus depicted in FIG. 1.

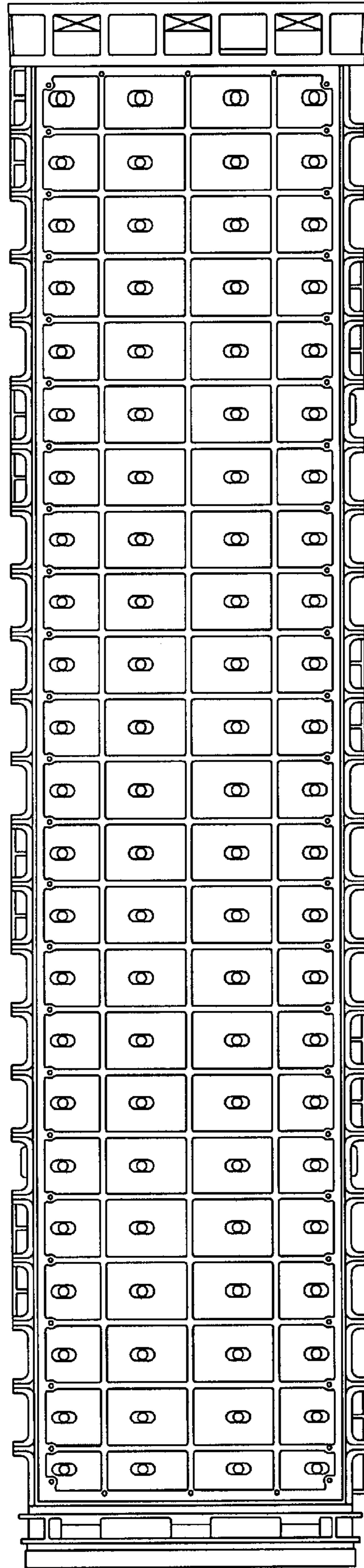

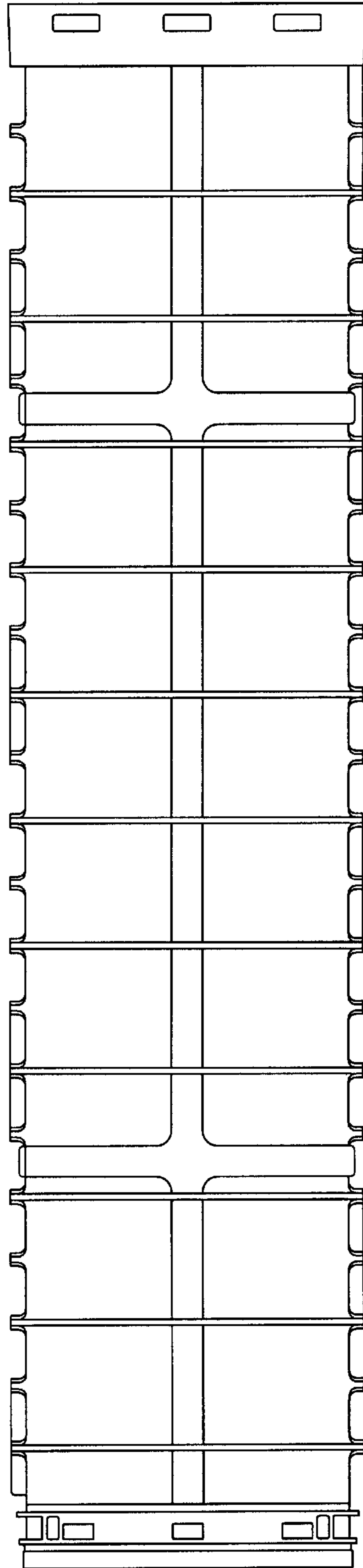

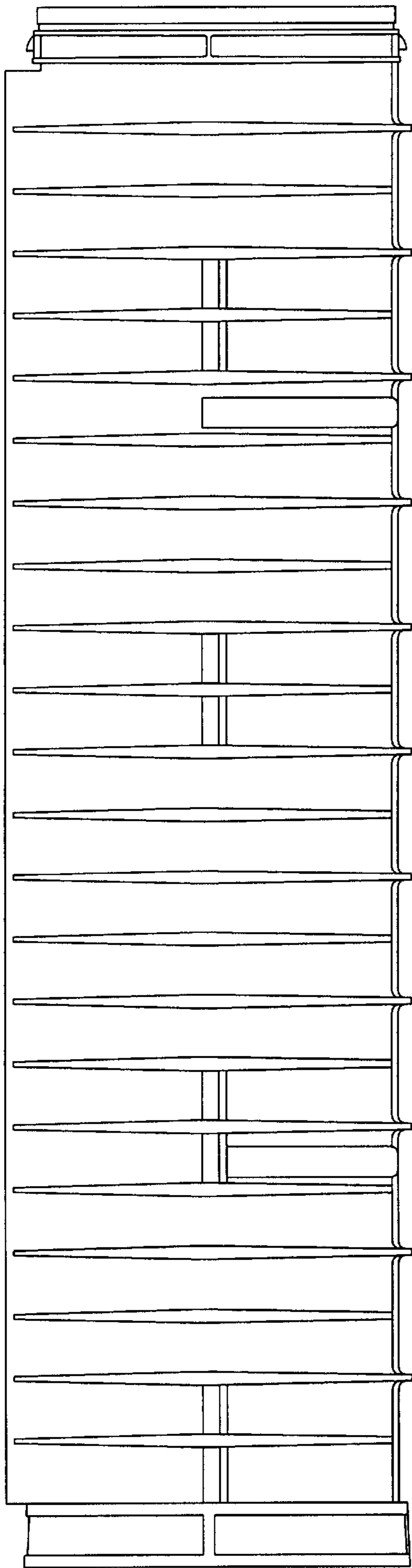

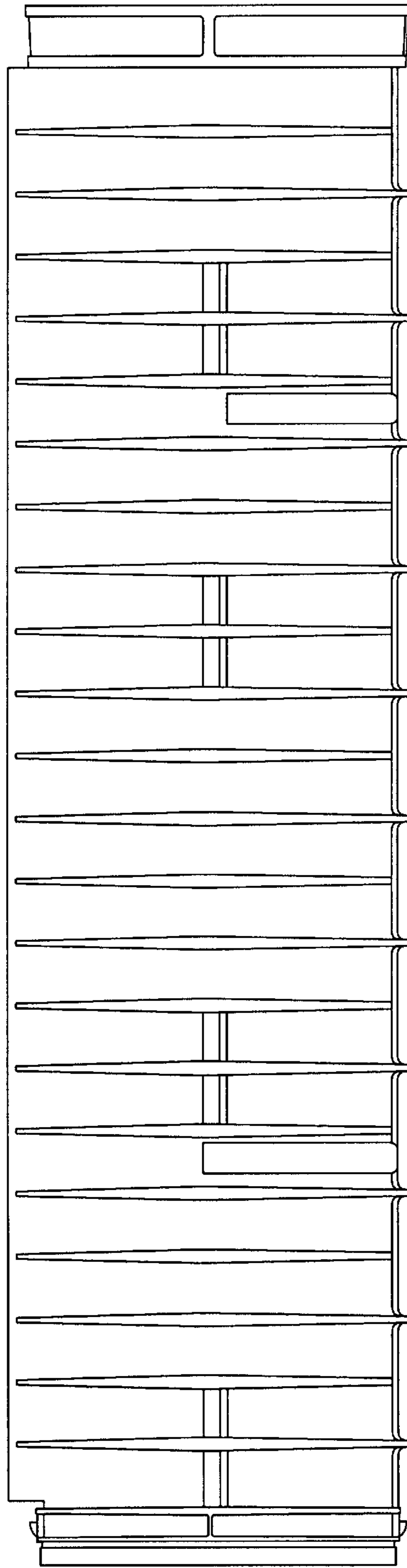

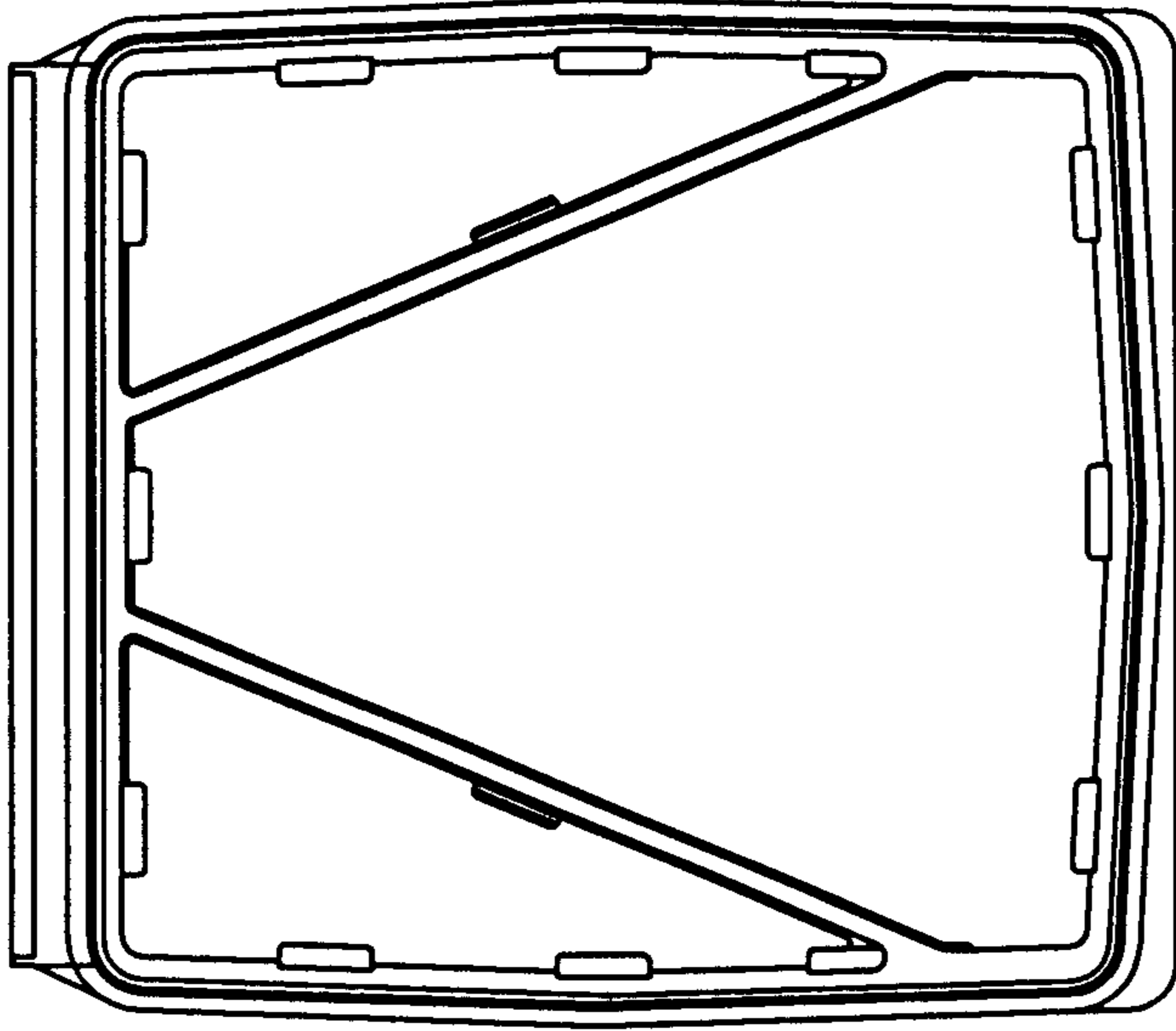

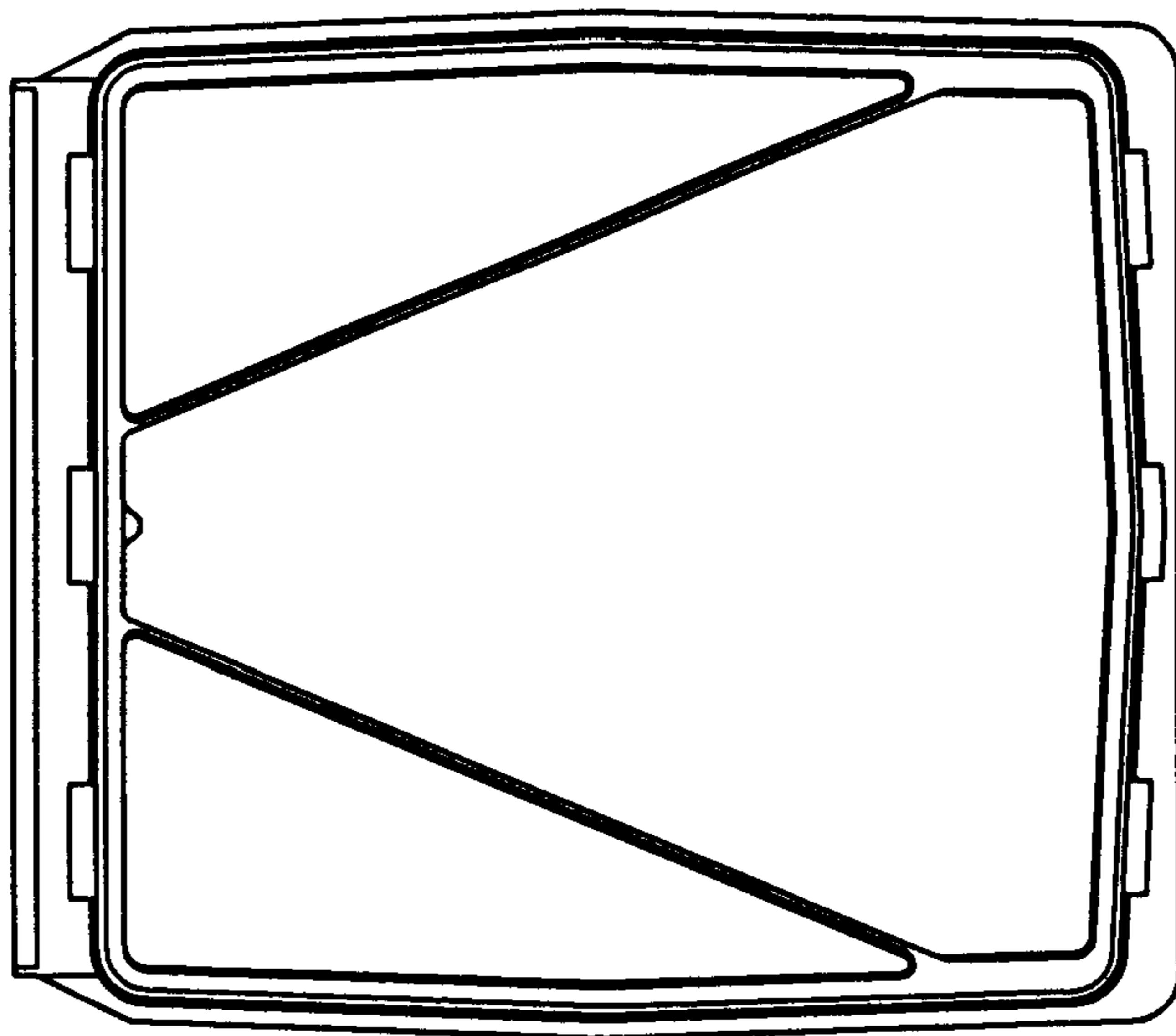
