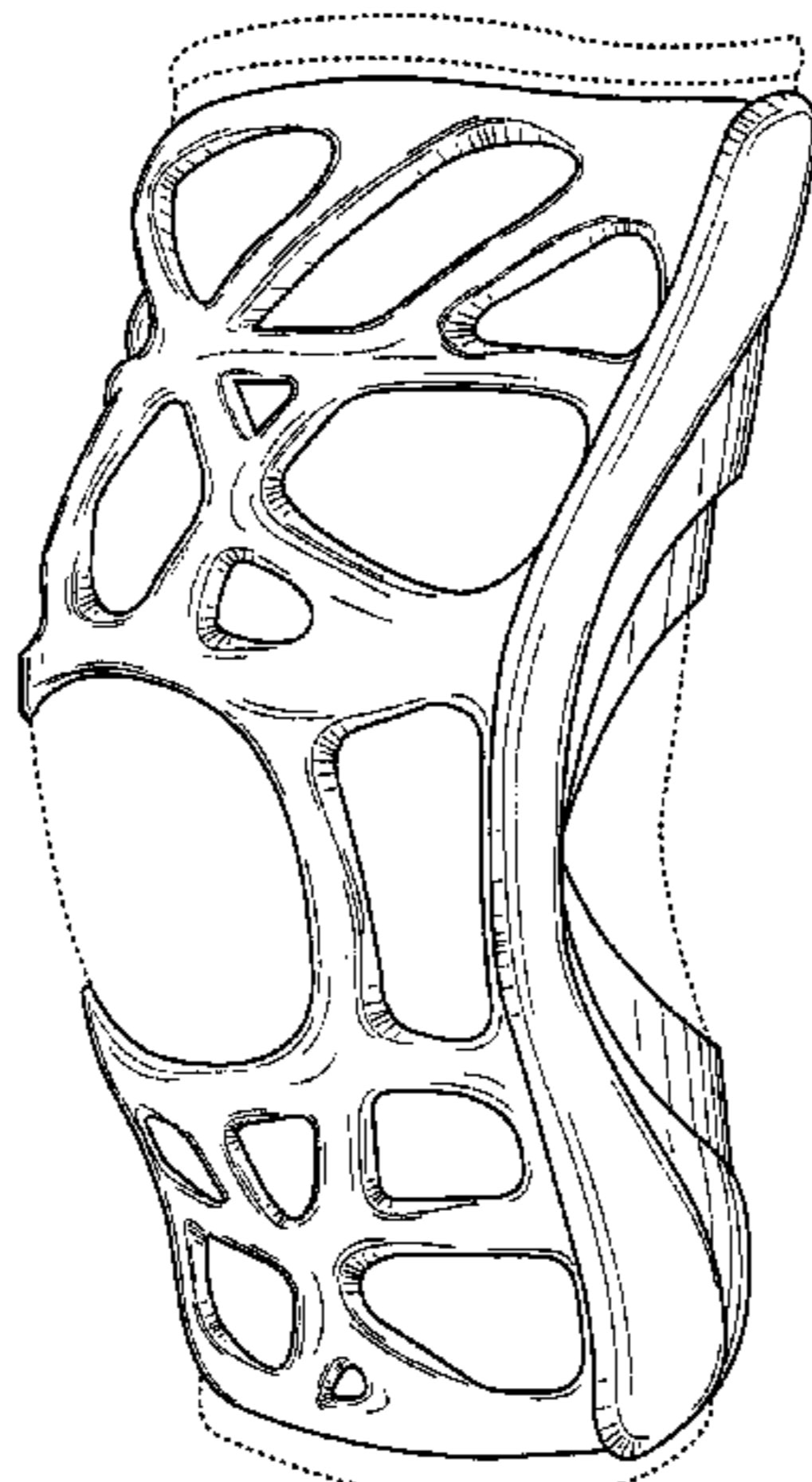
(57) **CLAIM**

The ornamental design for a support brace member, as shown and described.

DESCRIPTION

FIG. 1 represents a first perspective view of the front of support brace member of the present invention;
FIG. 2 represents a second perspective view of the back of the support brace member of the present invention;
FIG. 3 represents a second perspective view of the front of the support brace member of the present invention; and,
FIG. 4 represents a second perspective view of the back of the support brace member of the present invention.
The broken lines represent no part of the design to be patented and represent only the environmental element of the support brace member, namely, a liner or sleeve of fabric material underlying the support brace member.

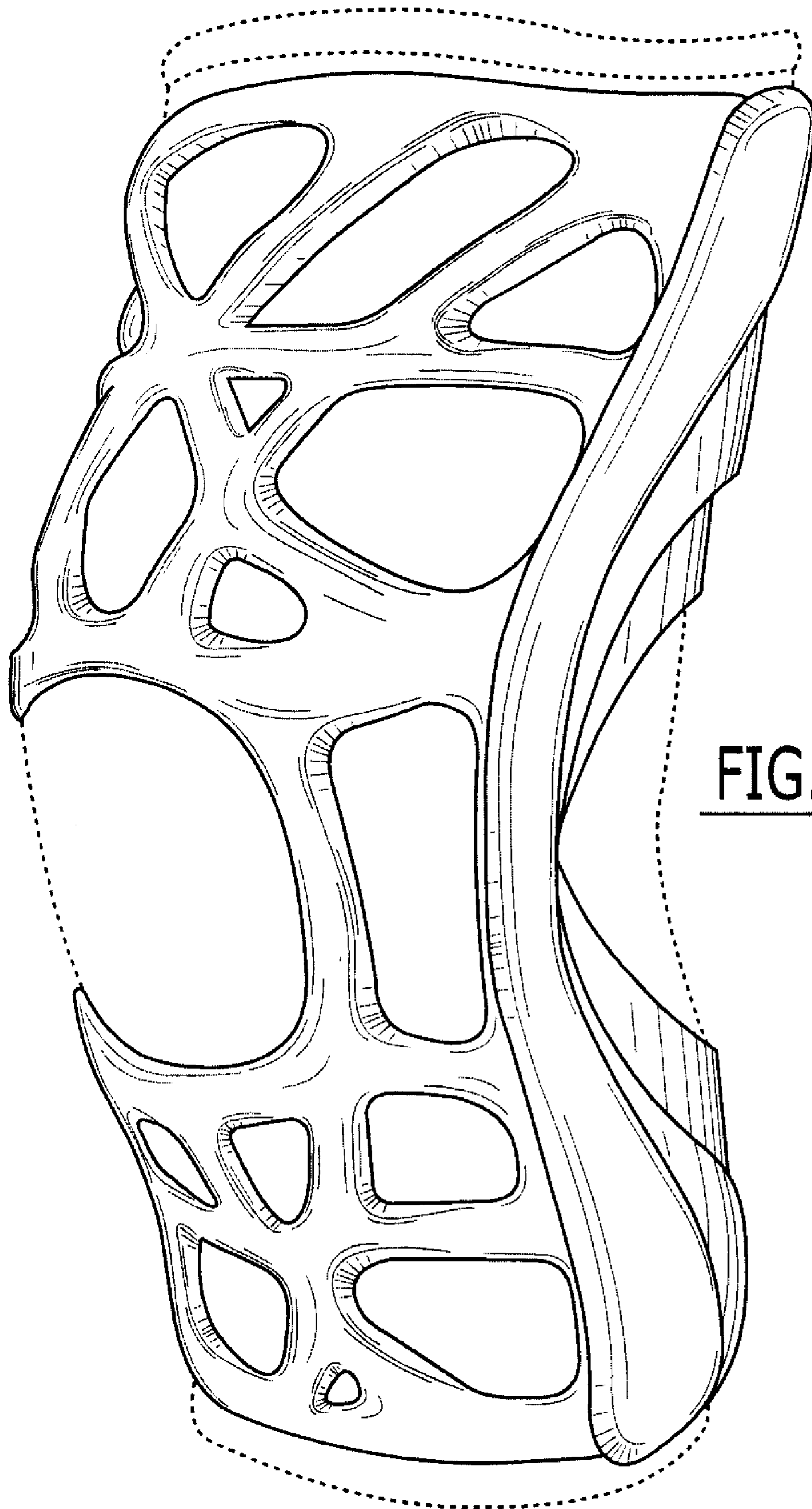

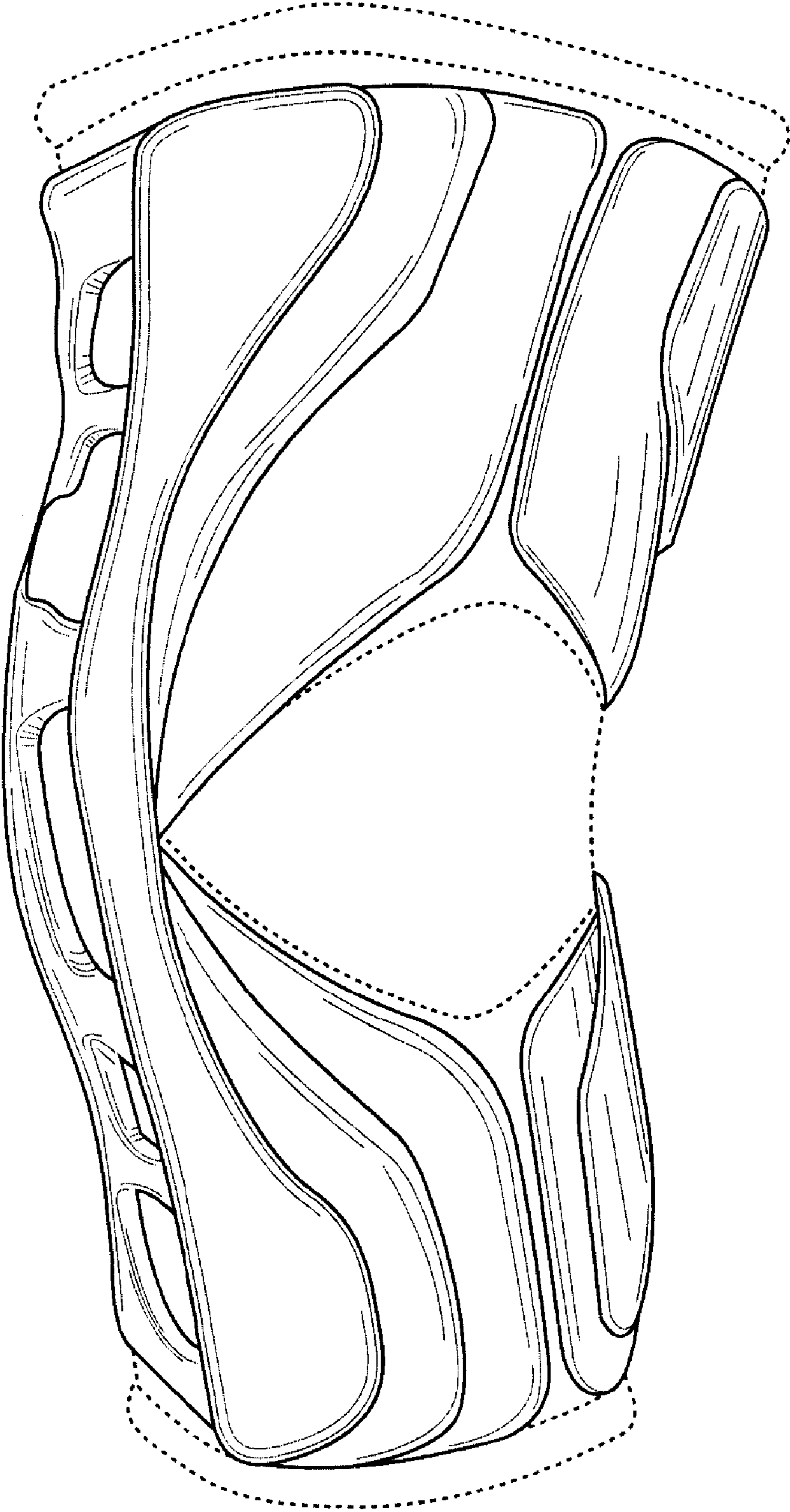

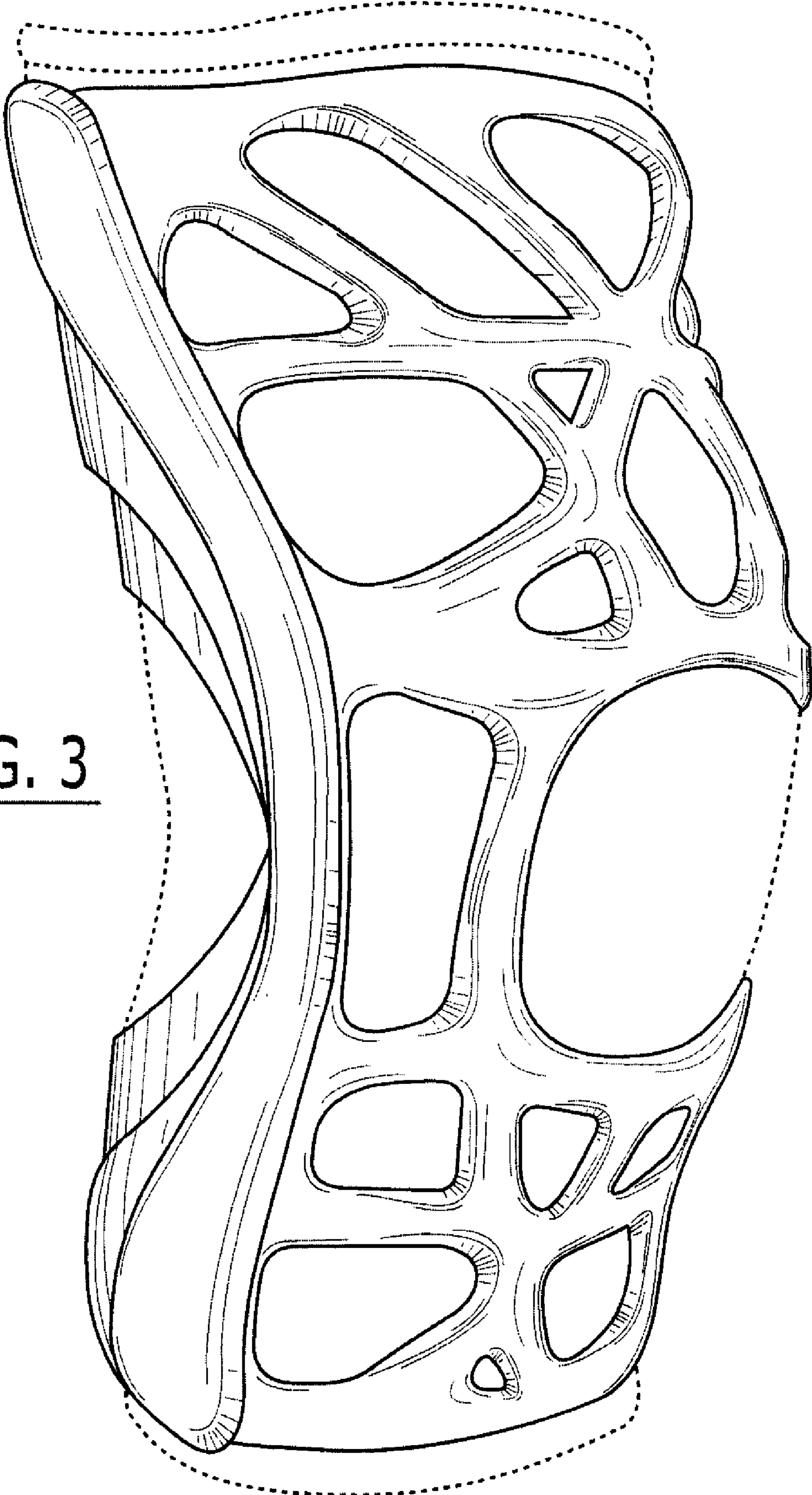

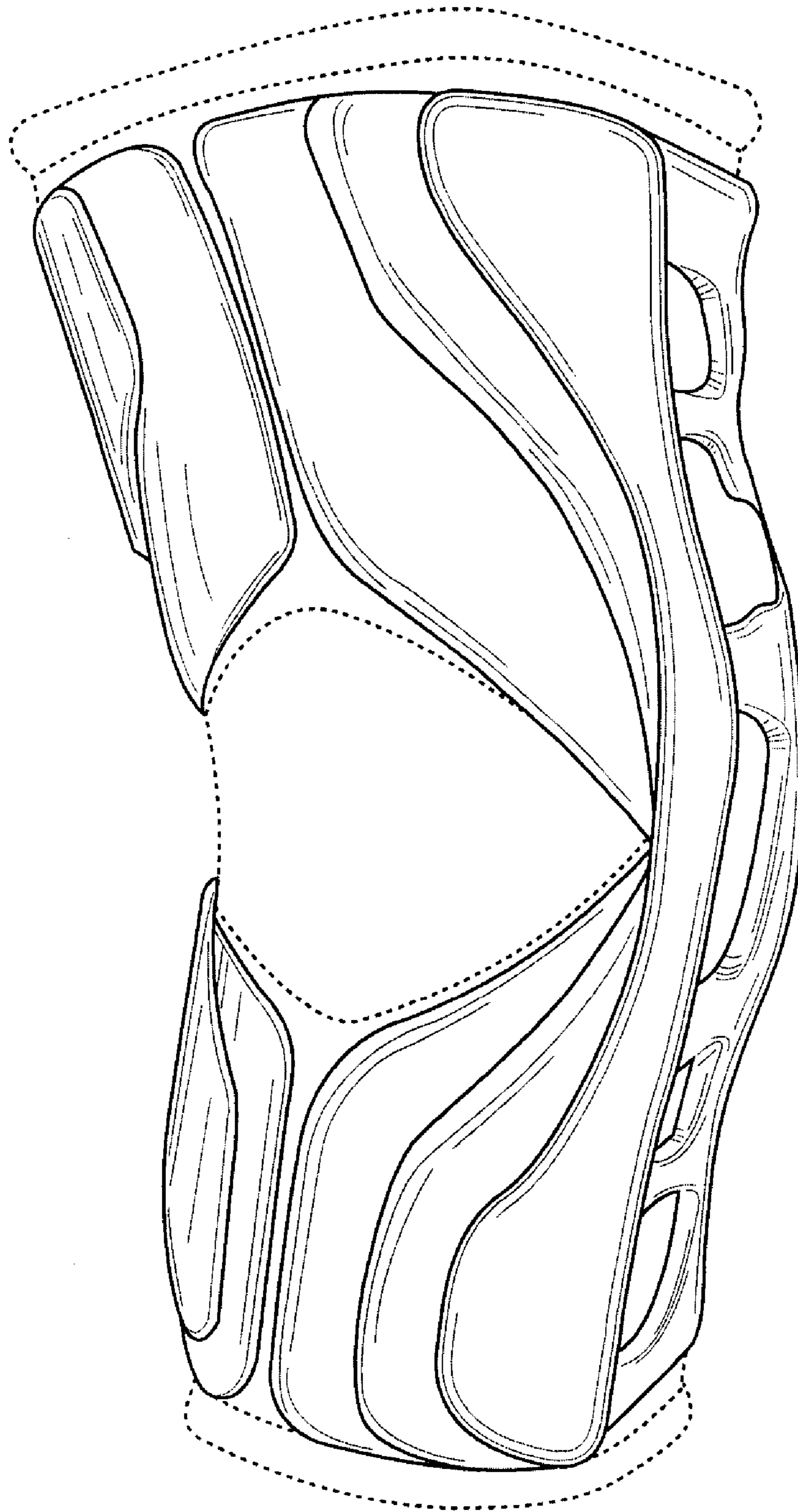
