The ornamental design for a block, as shown and described.

DESCRIPTION

FIG. 1 is a top/side isometric view of a block of my new design, according to one embodiment;

FIG. 2 is a top plan view of the embodiment of FIG. 1;

FIG. 3 is a bottom plan view of the embodiment of FIG. 1;

FIG. 4 is a side elevational view of the embodiment of FIG. 1, the other sides being identical to that shown;

FIG. 5 is a cross sectional view thereof with the other sides being identical to that shown

FIG. 6 is a top/side isometric view of a block of my new design, according to an additional embodiment;

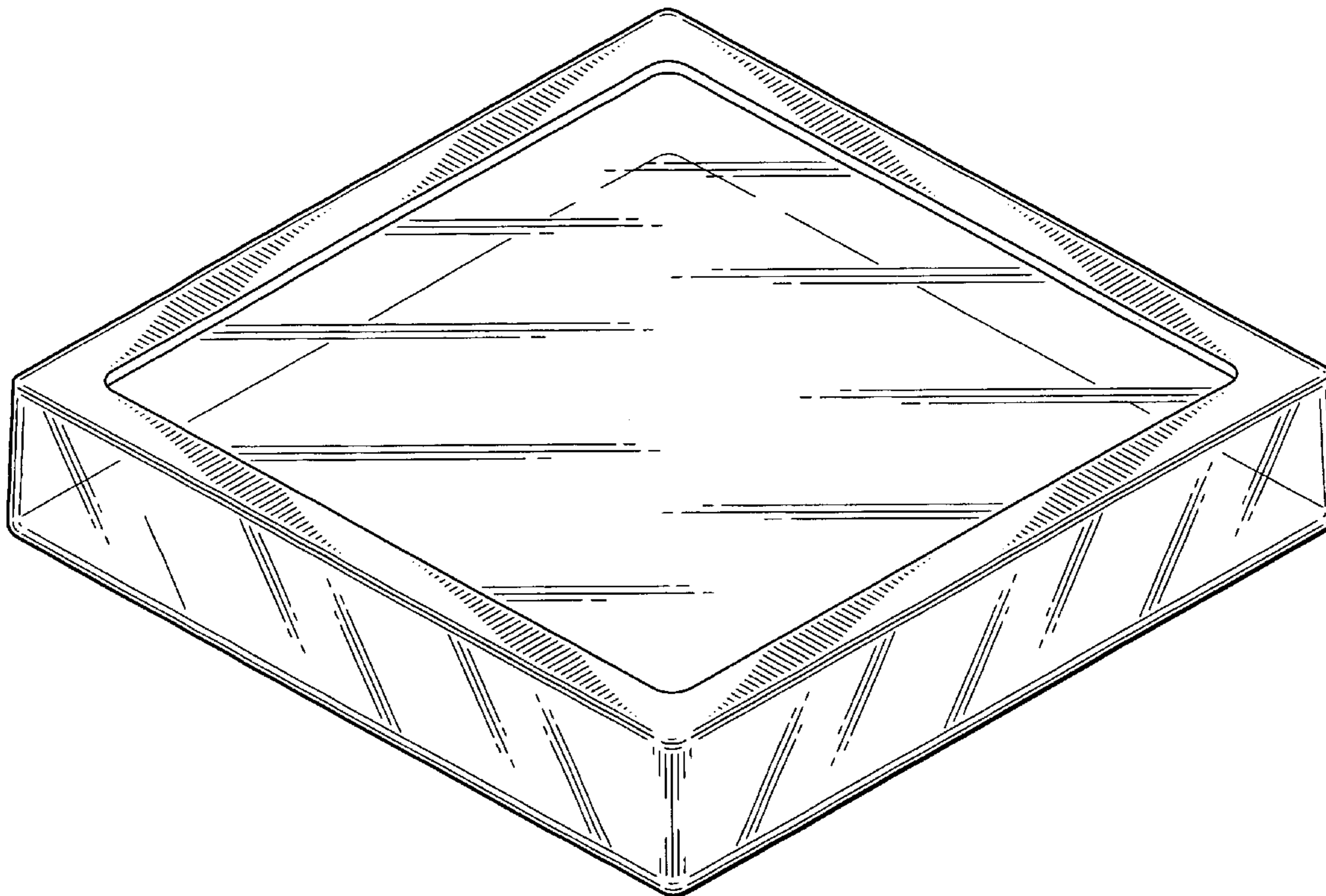
FIG. 7 is a top plan view of the embodiment of FIG. 6;

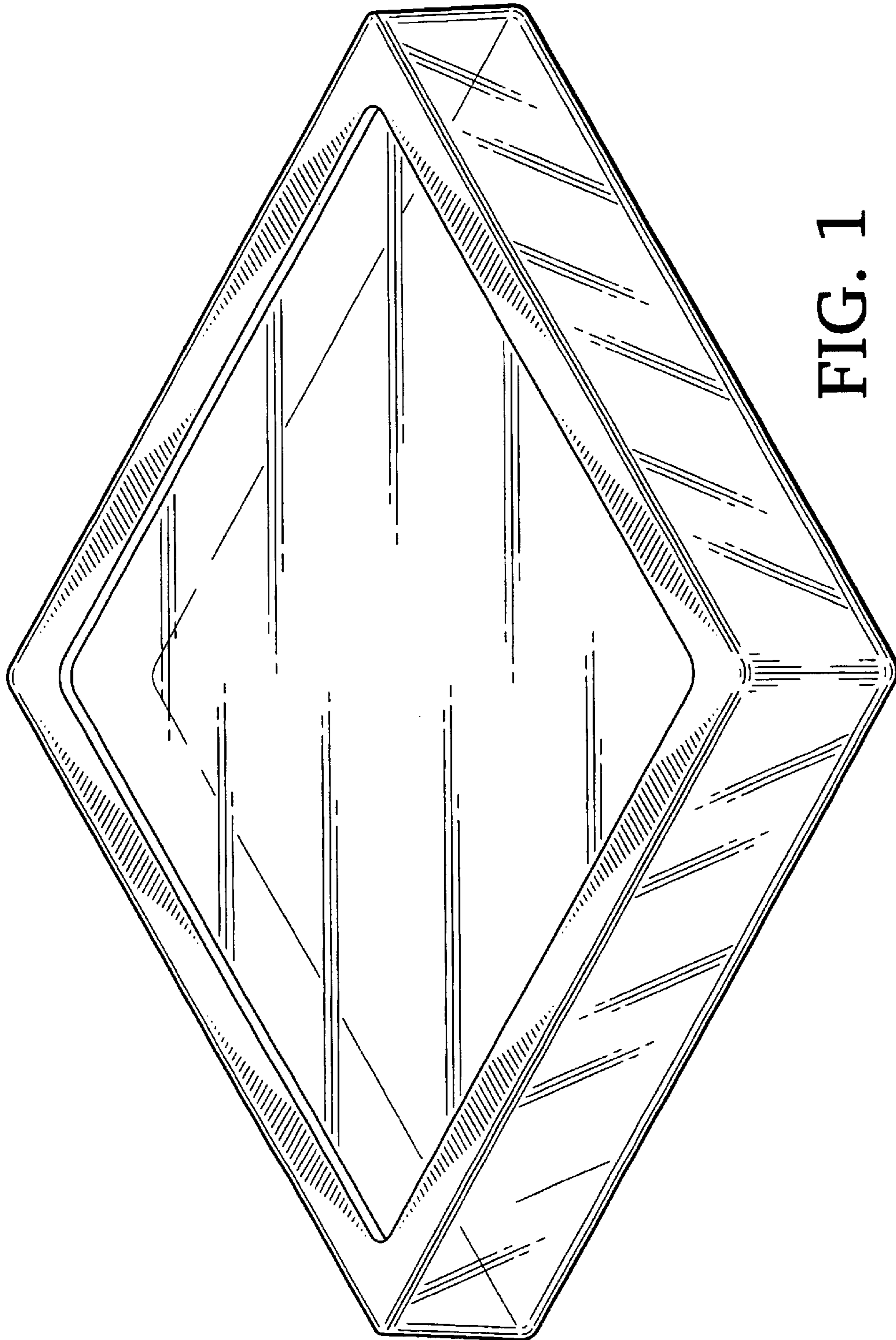

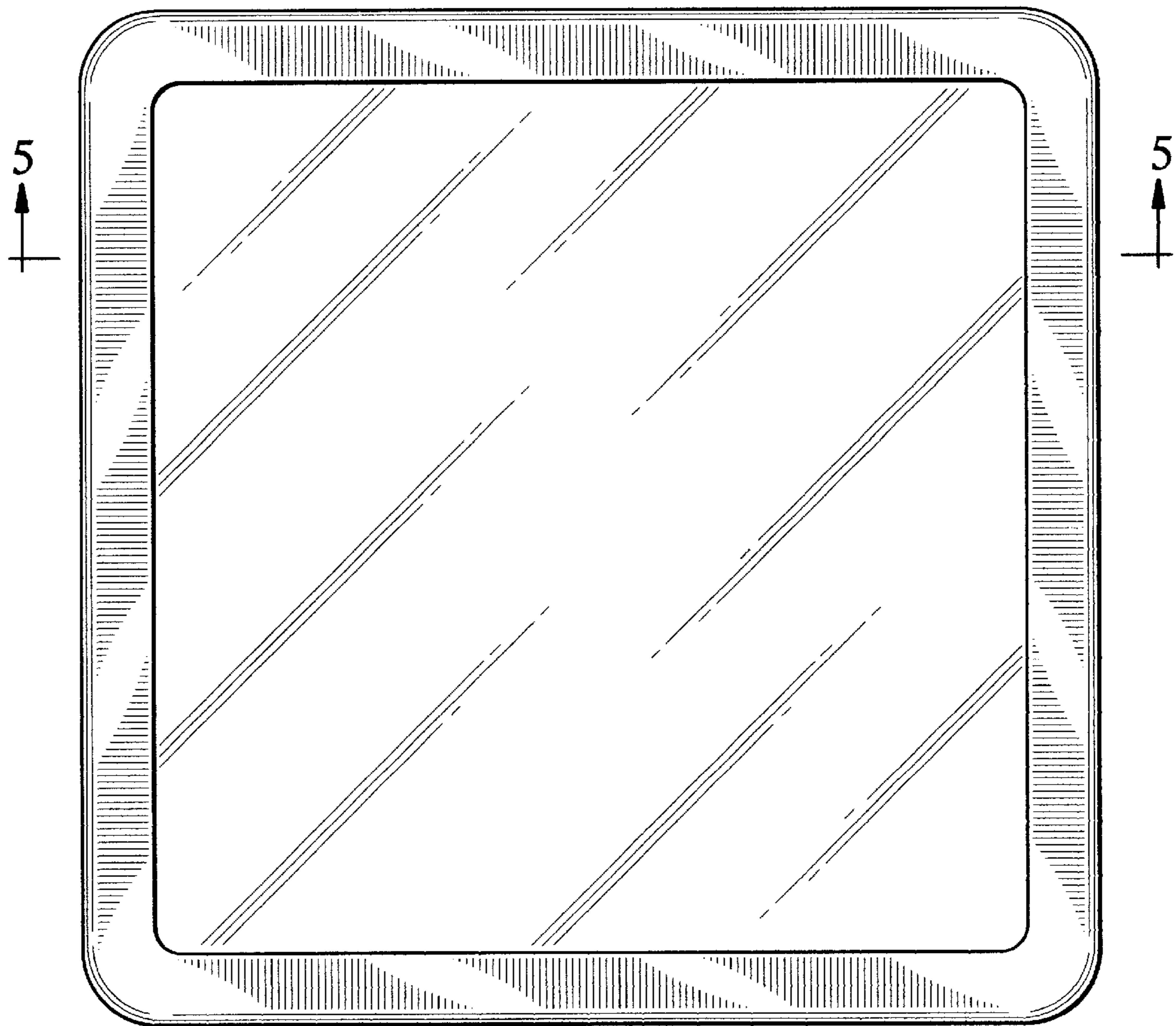

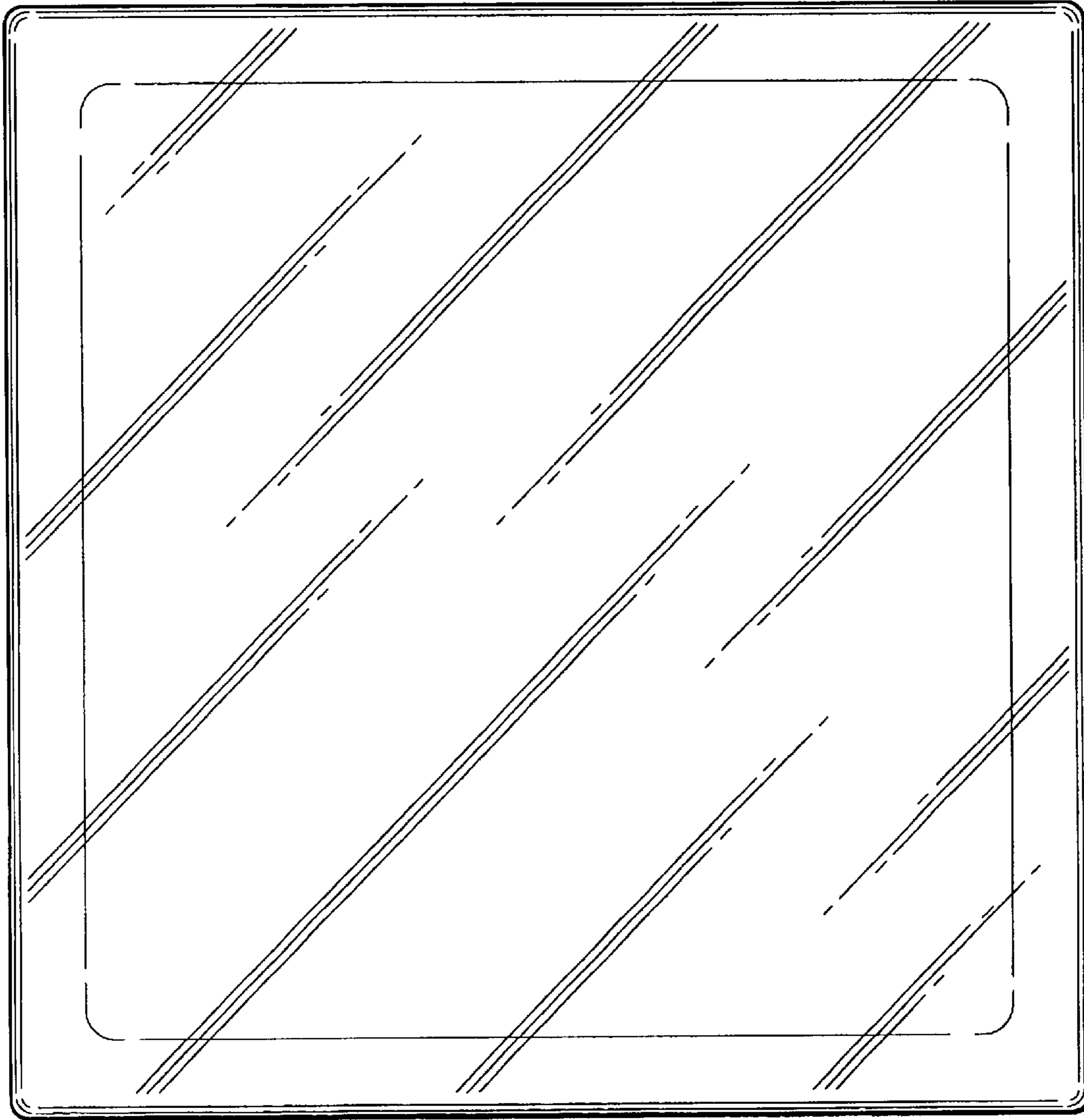

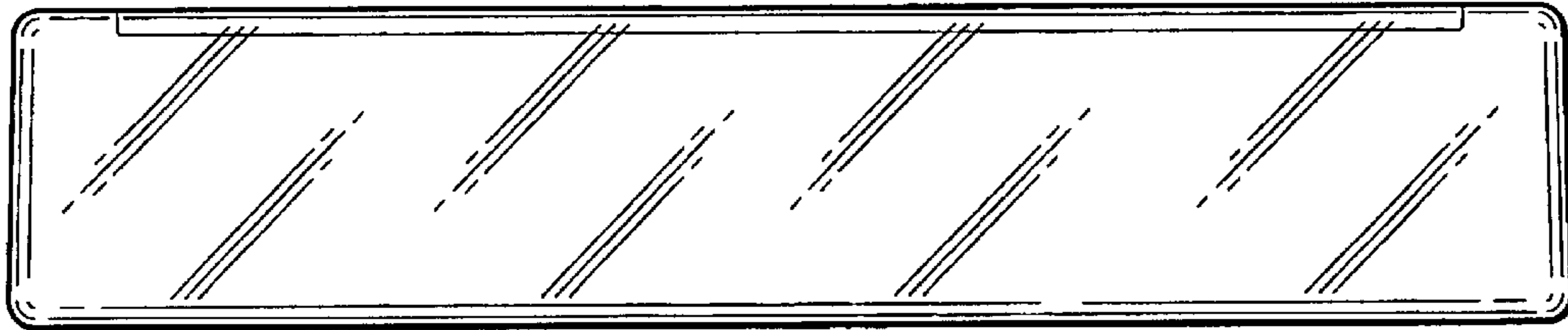

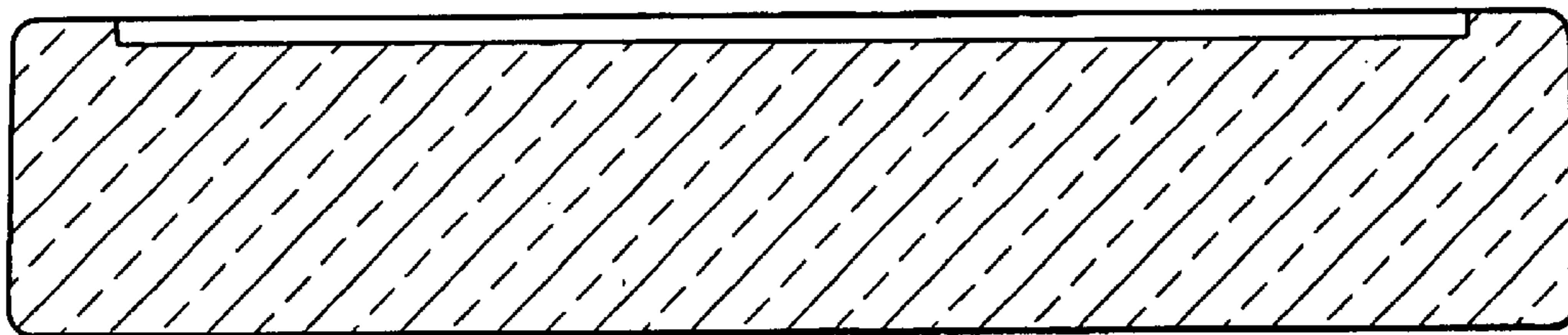

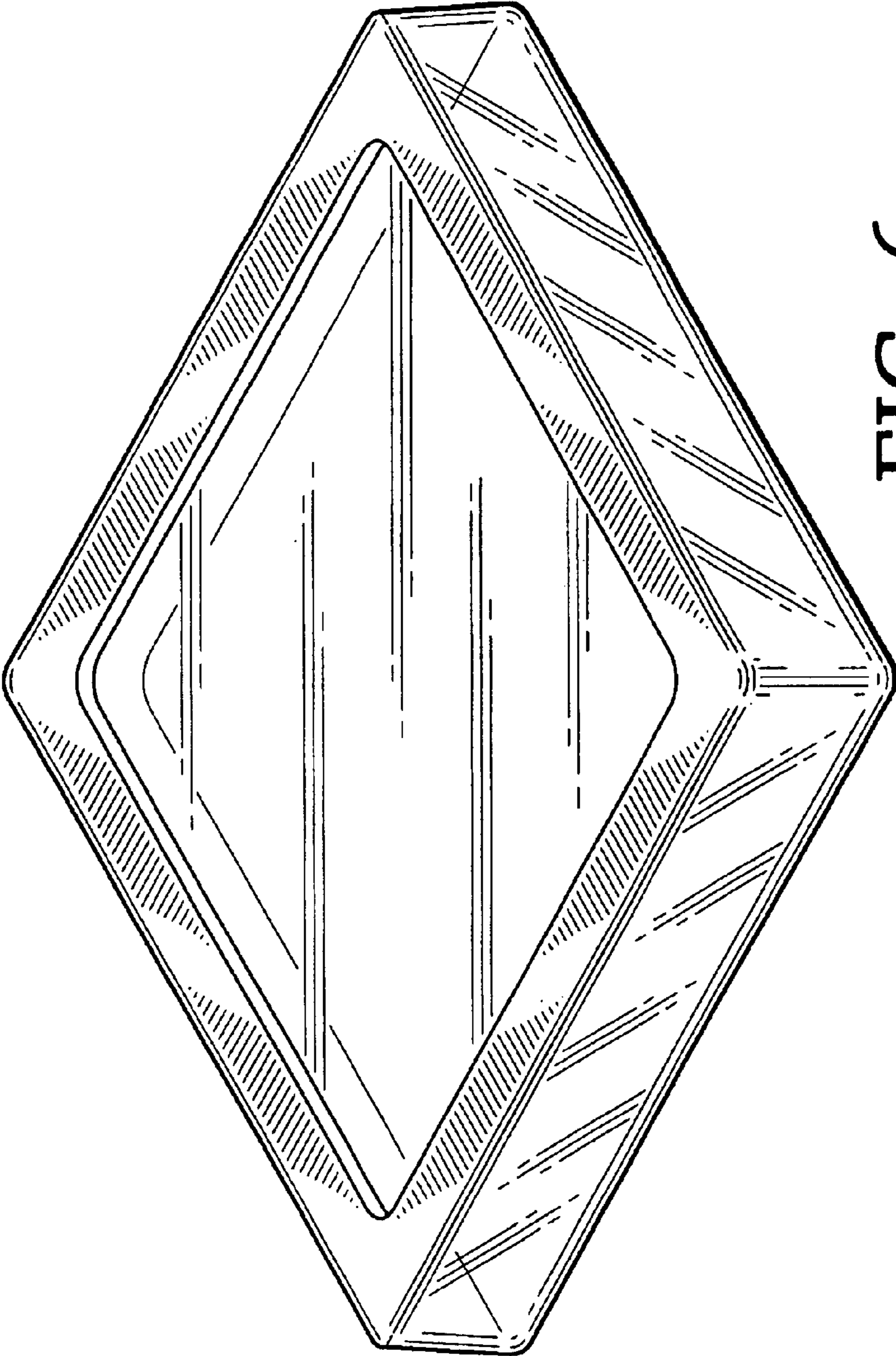

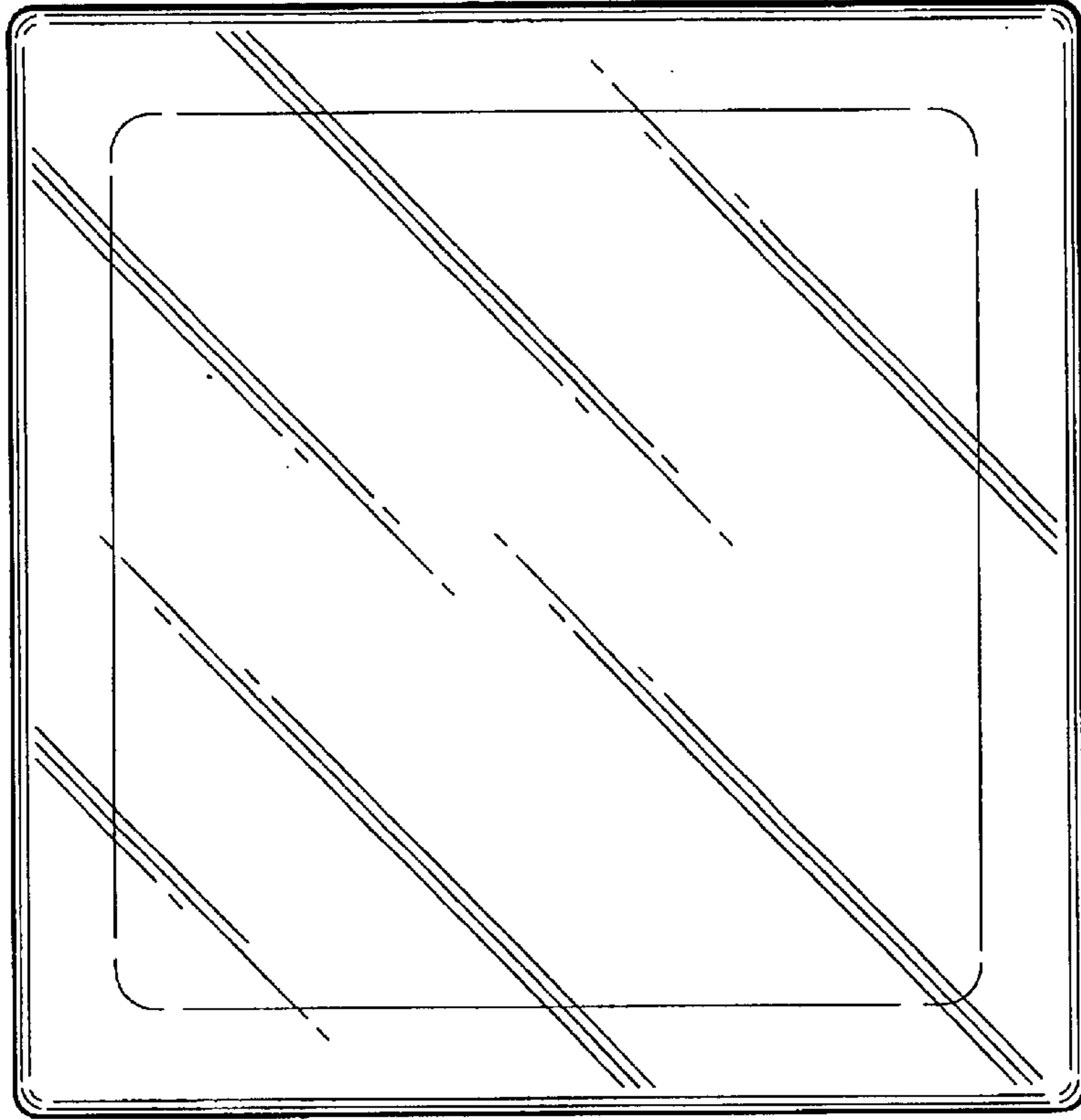

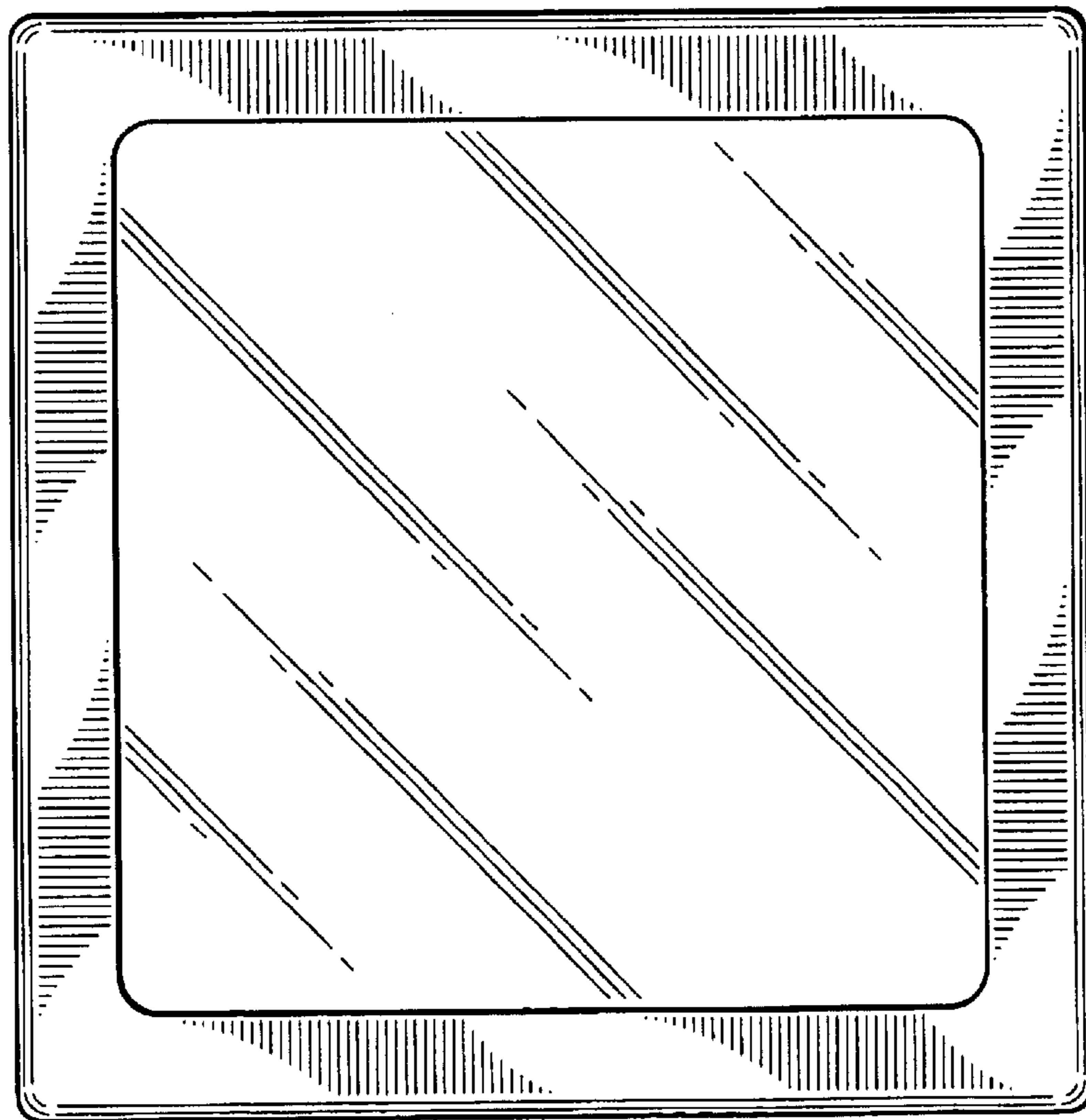

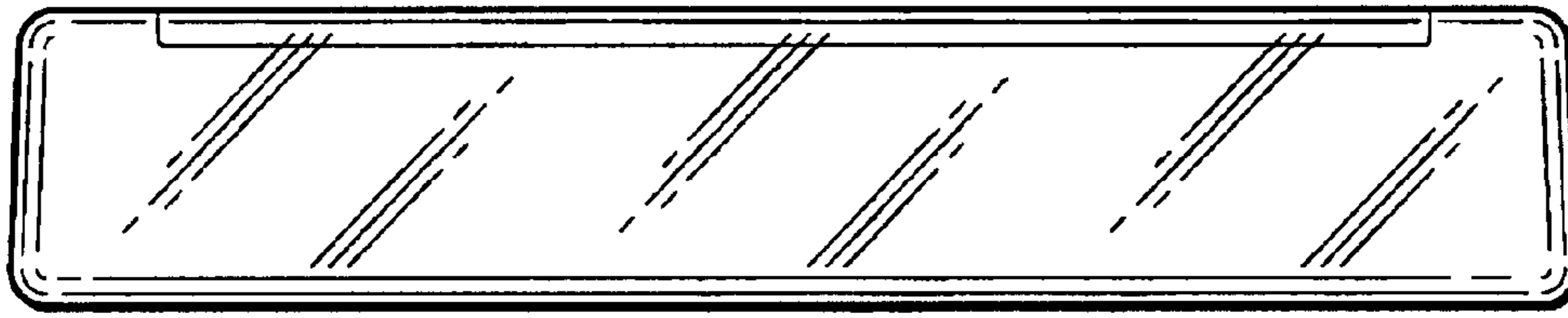

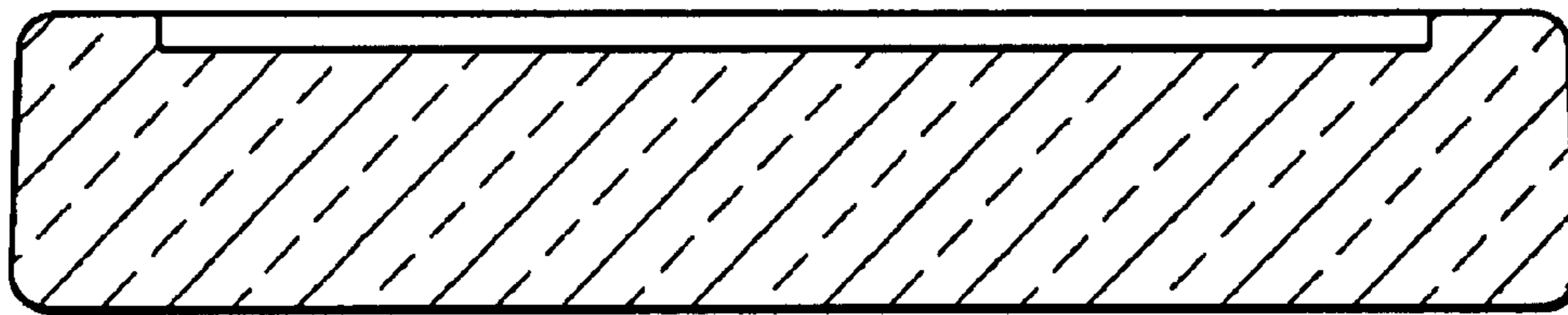
