(57) **CLAIM**

I claim the ornamental design for the ornamental light fixture with frog and lily pad motif, as shown.

**DESCRIPTION**

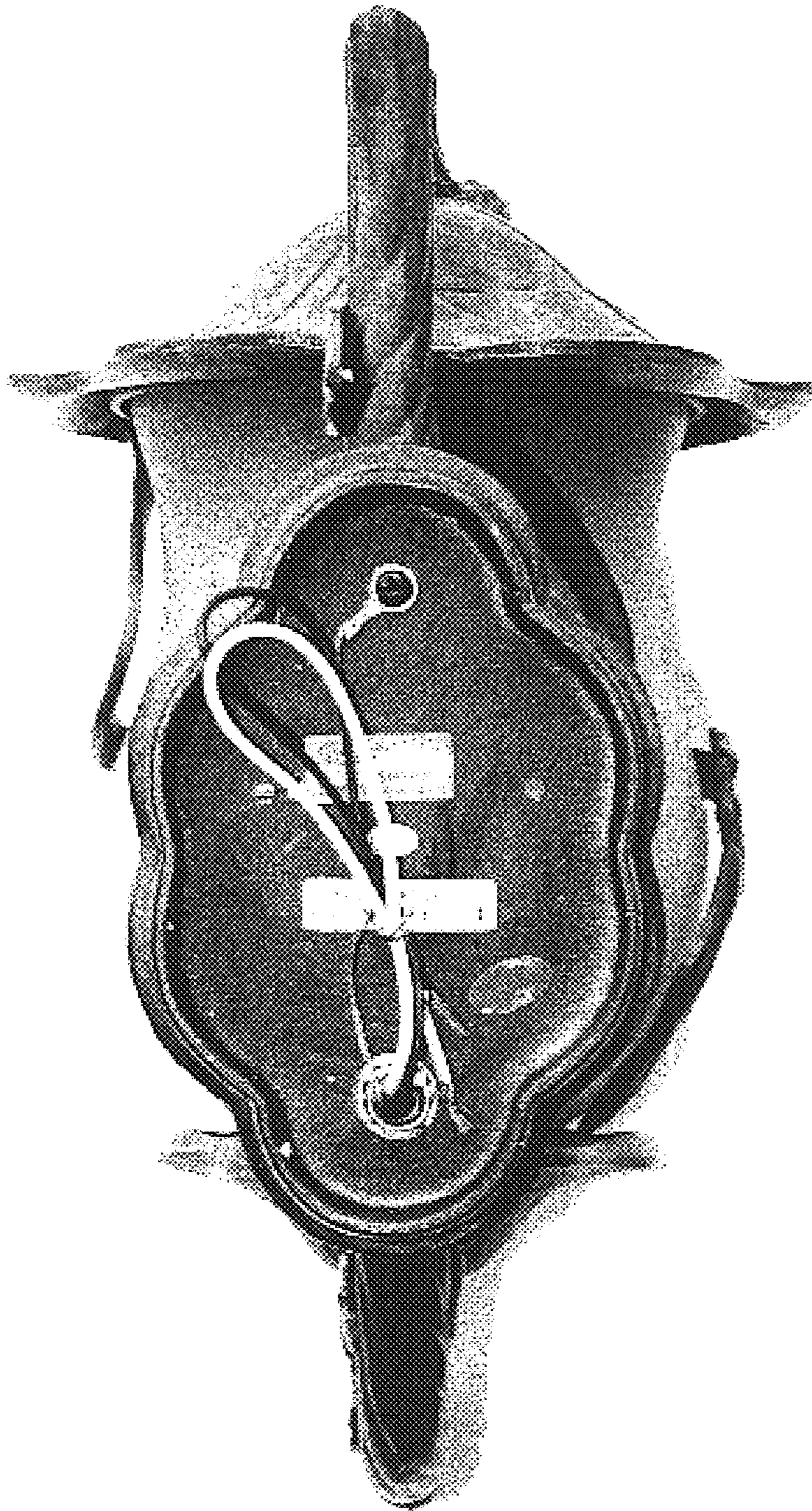

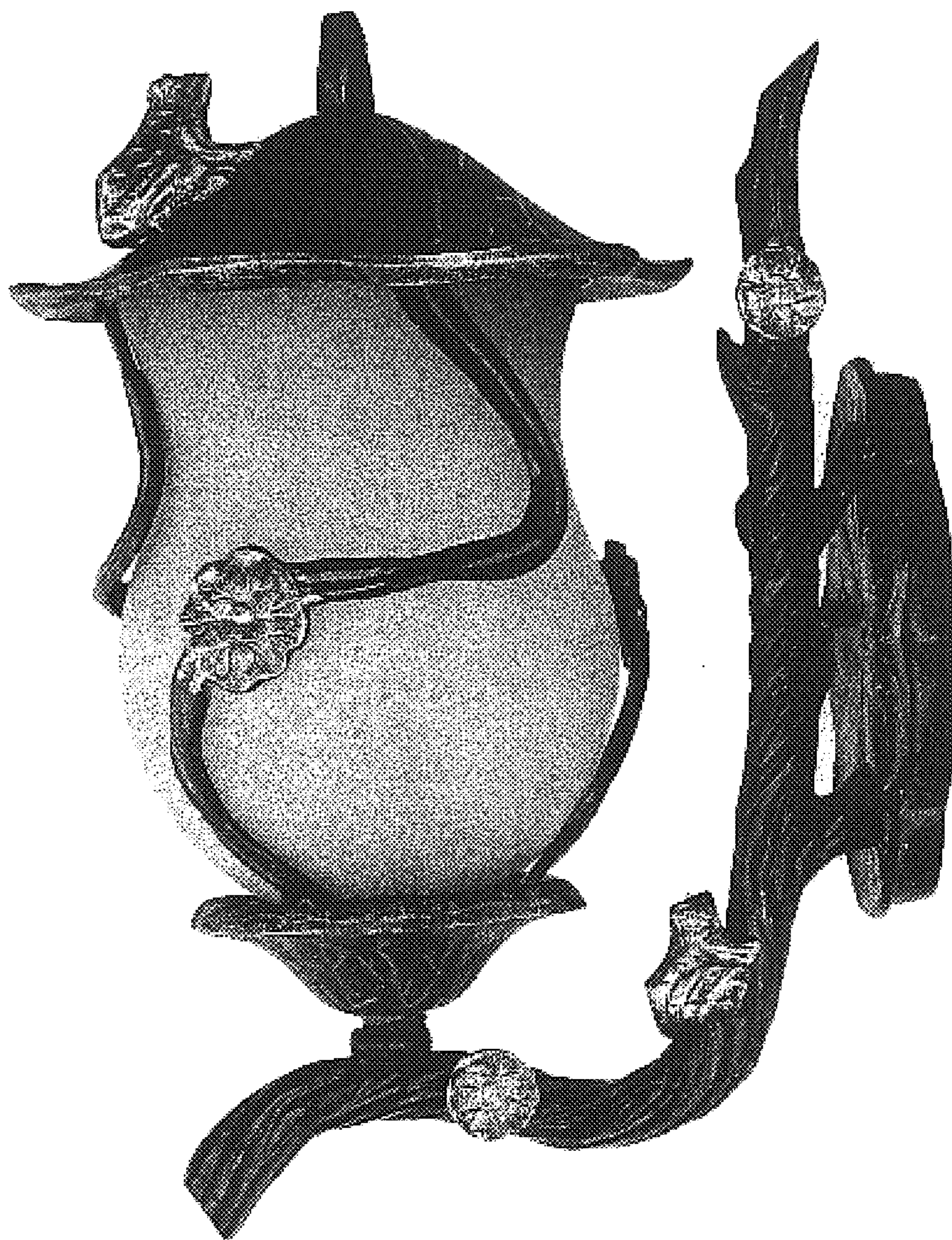

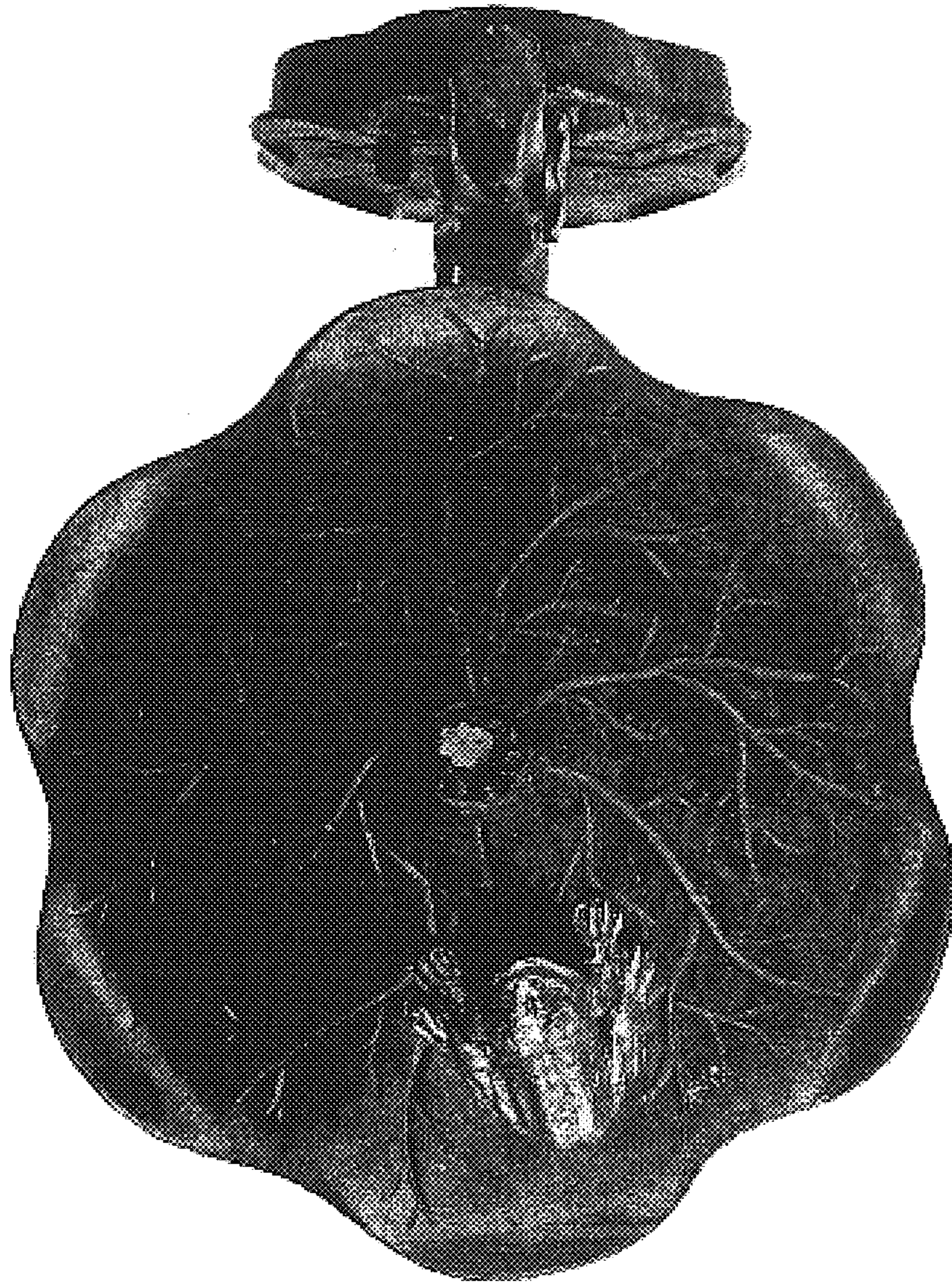

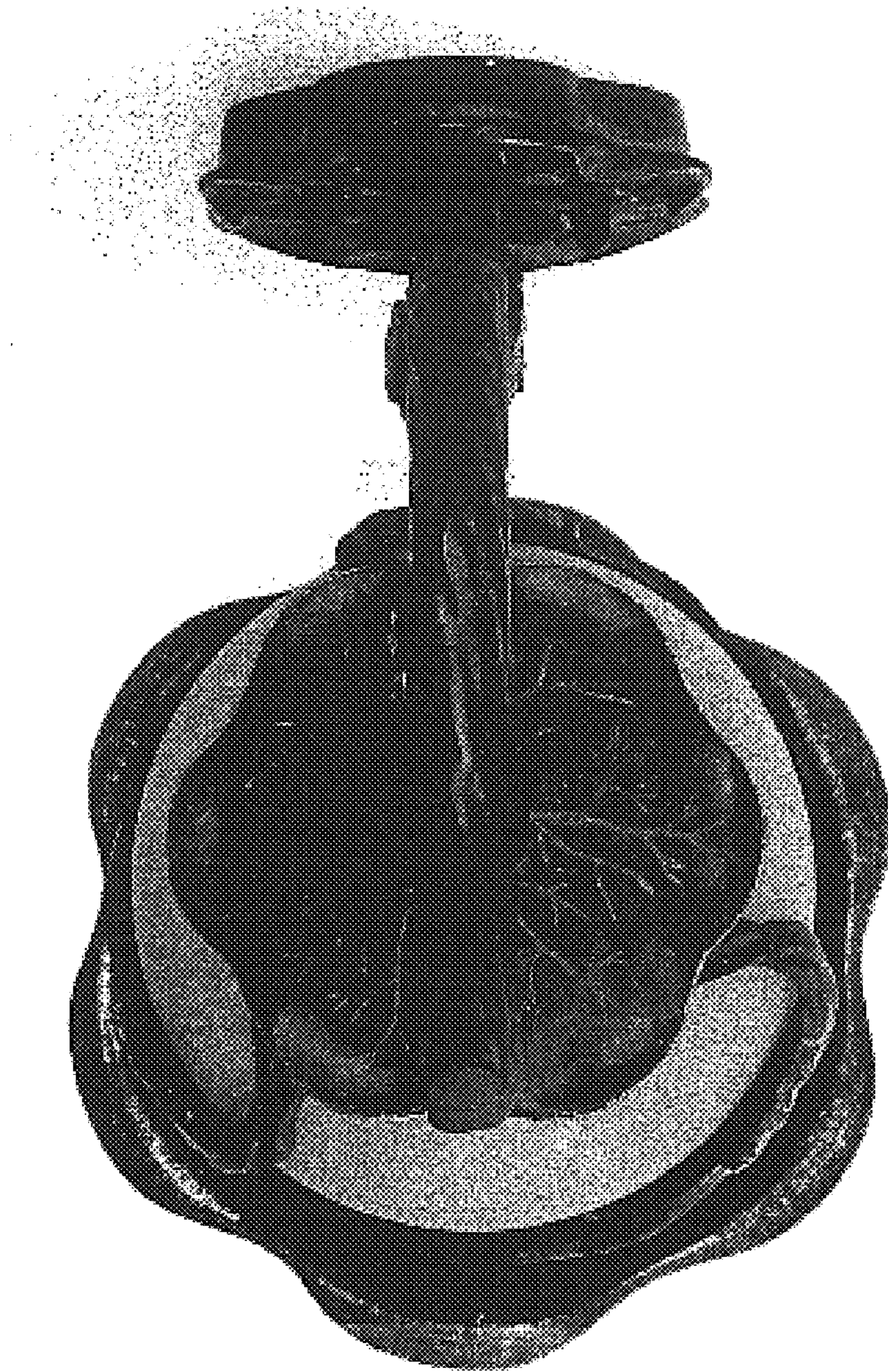
