FIG. 11 shows a front view of the second preferred embodiment of the present design.

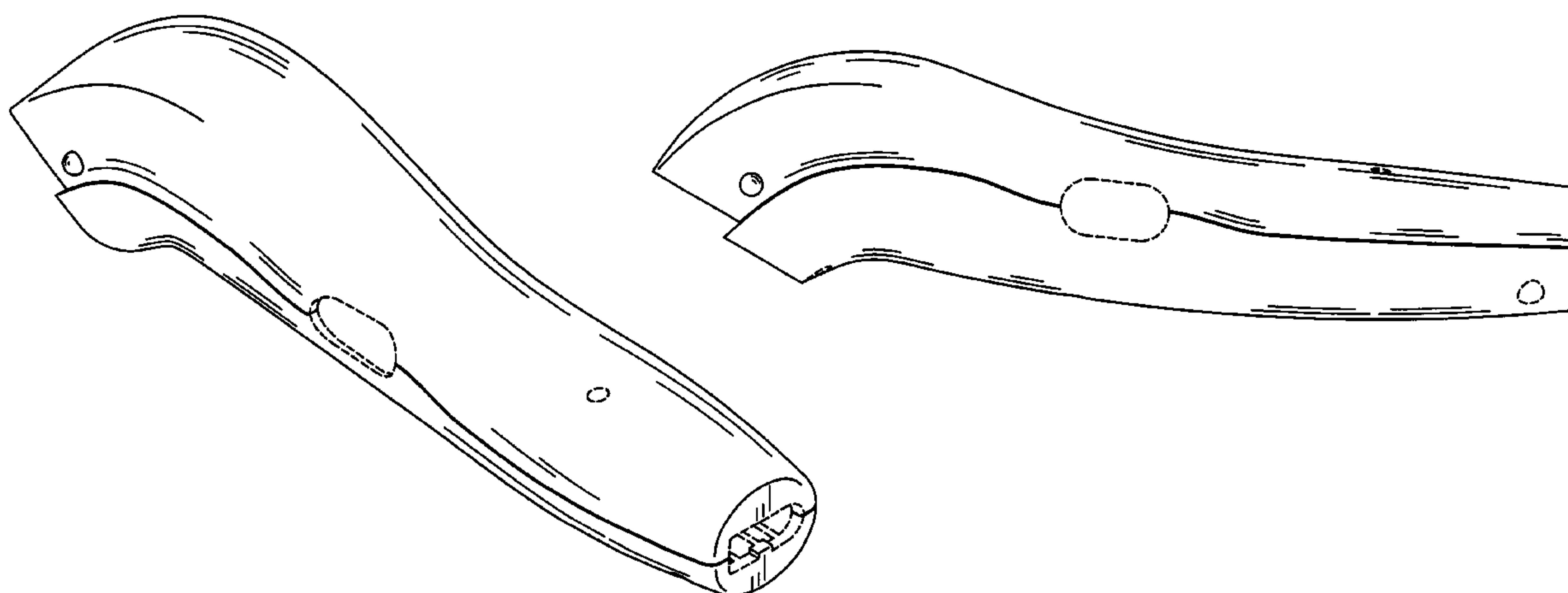
FIG. 12 shows a bottom view of the second preferred embodiment of the present design.

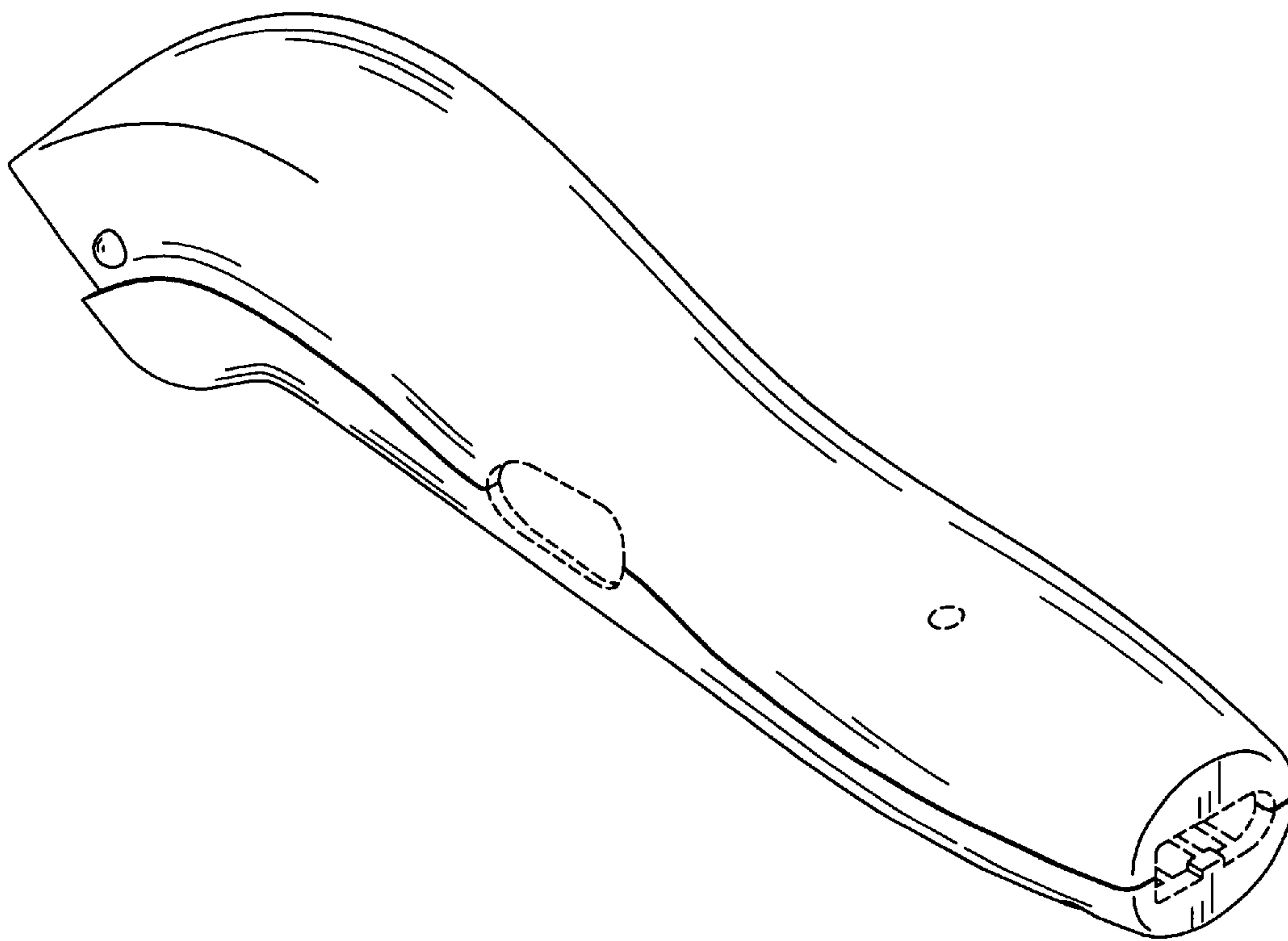

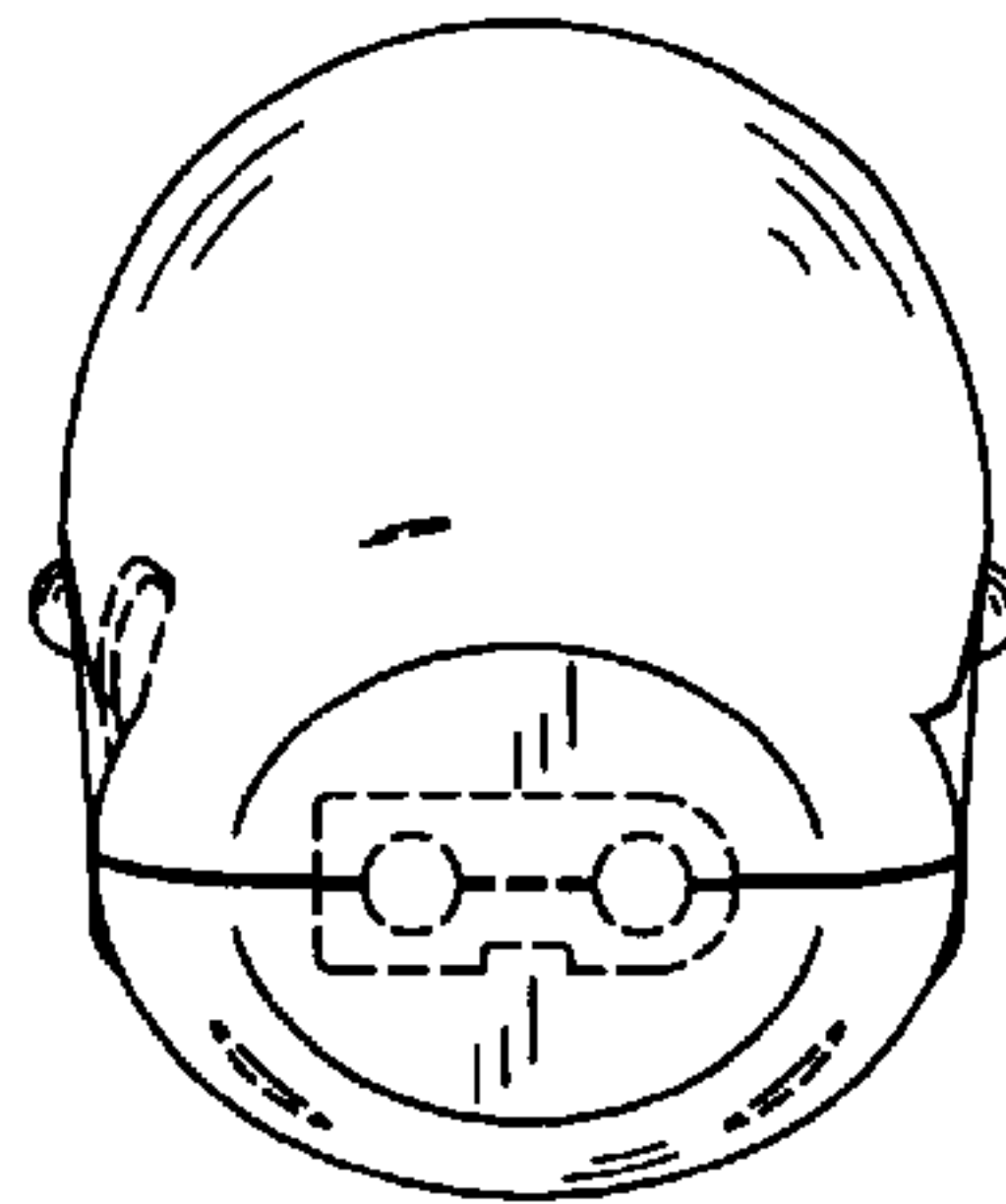

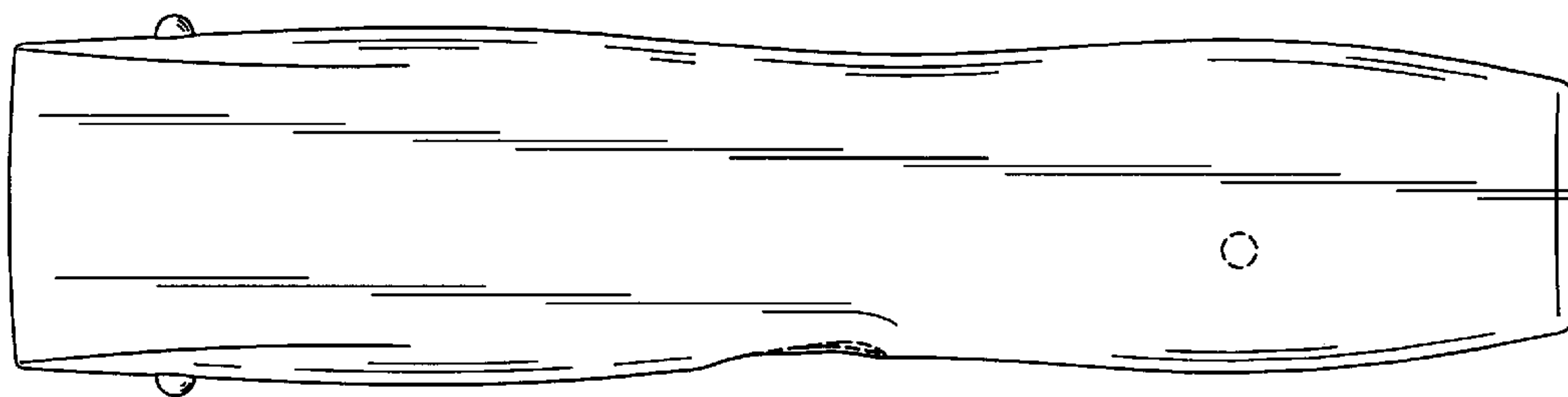

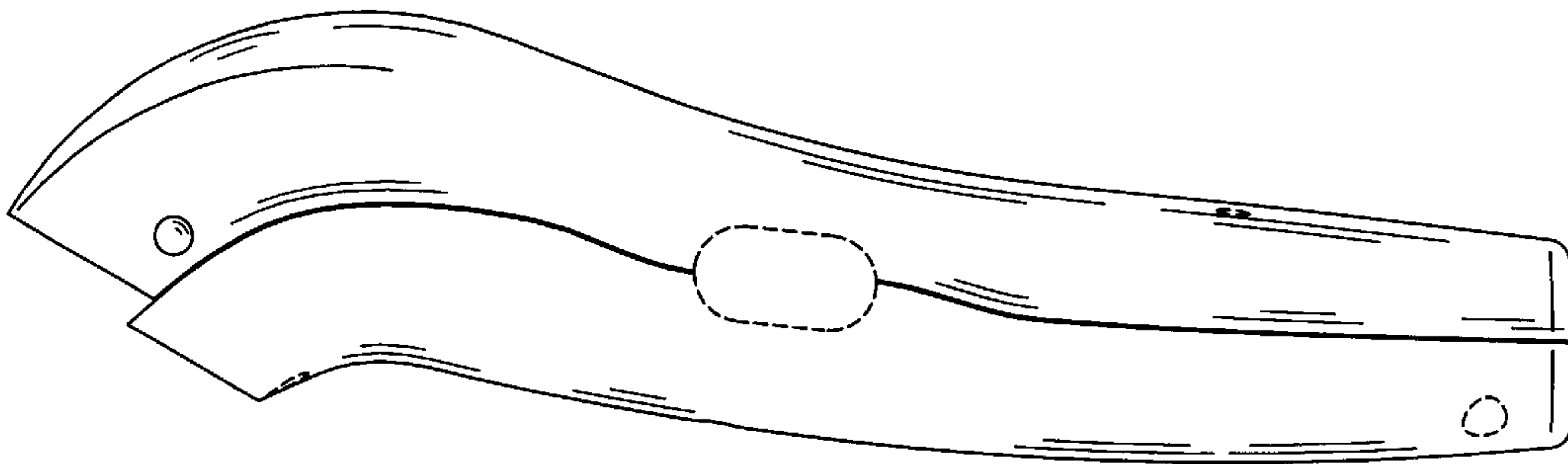

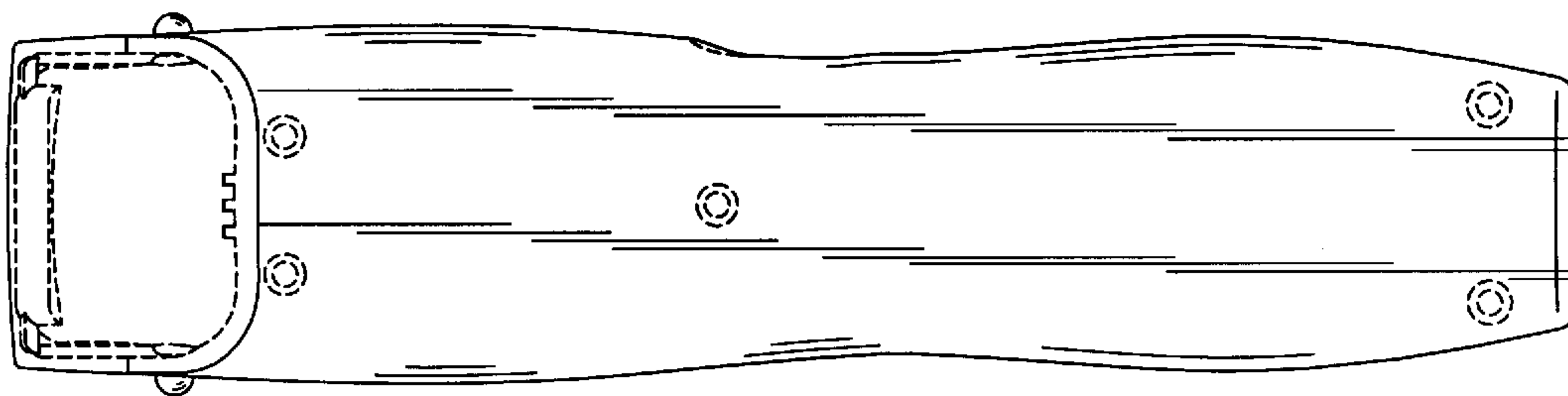

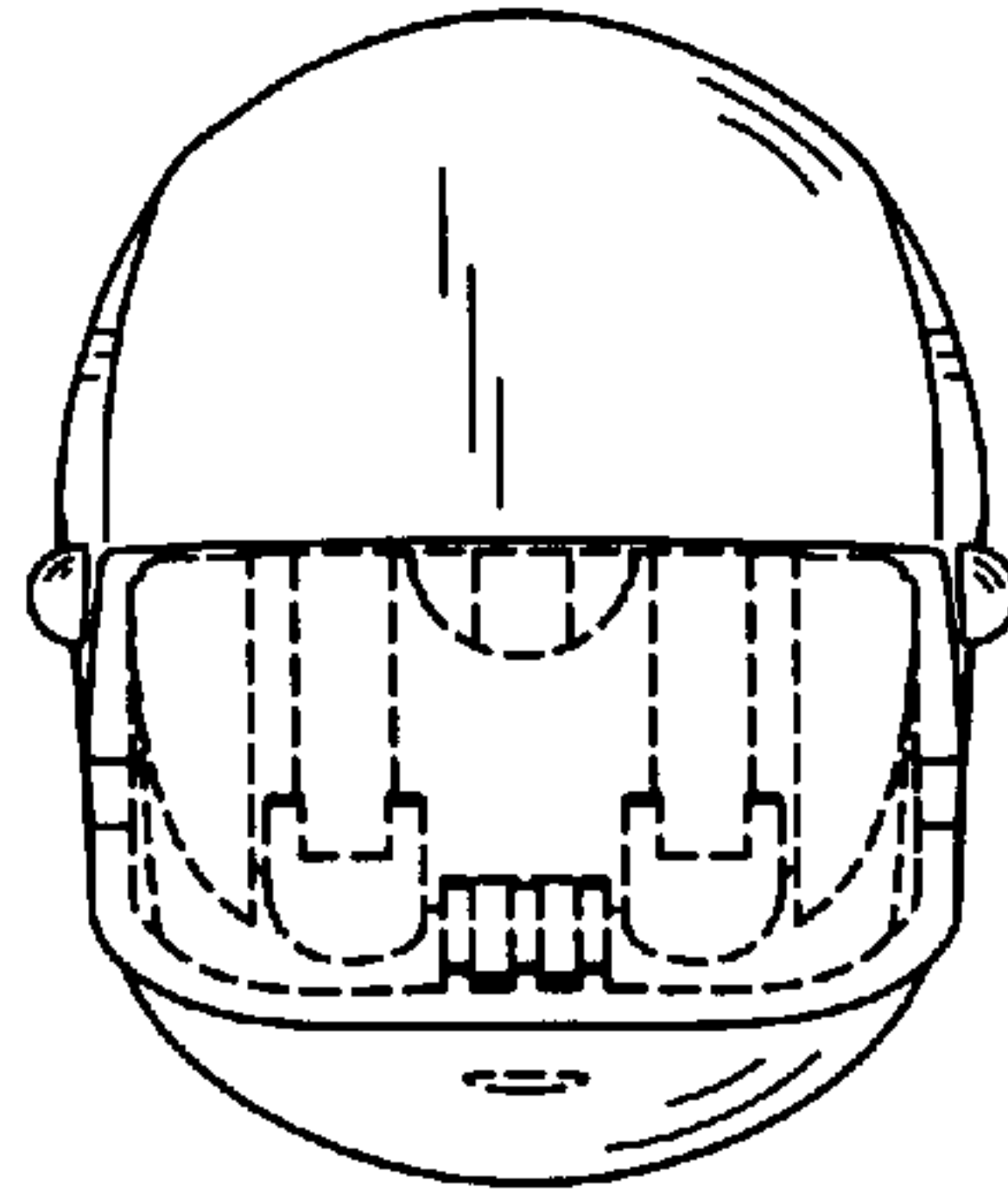

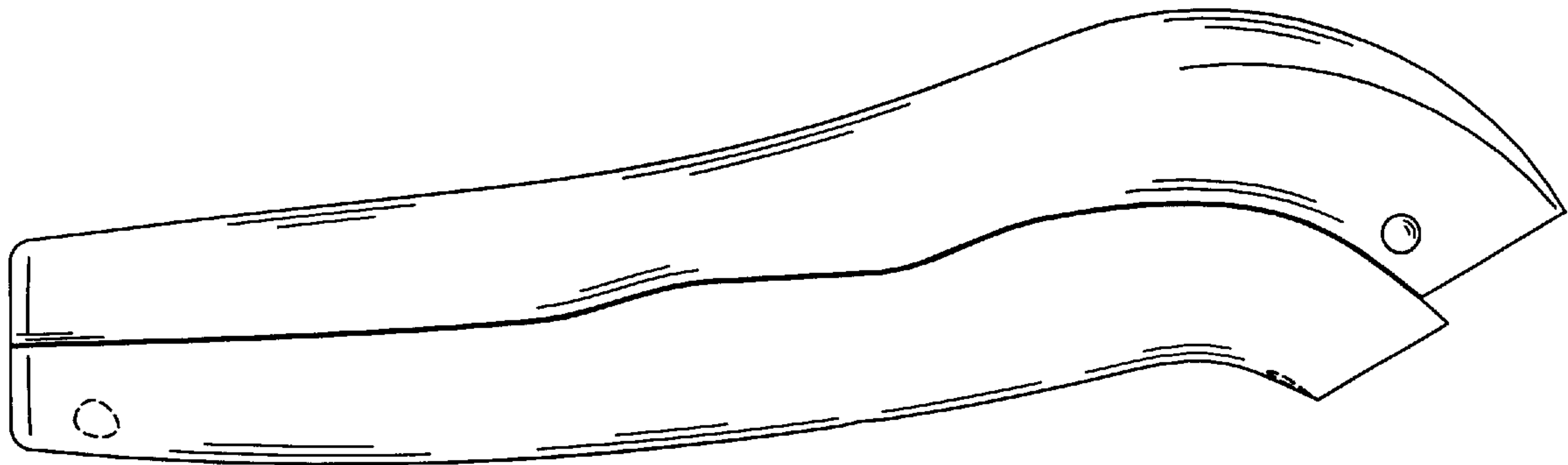

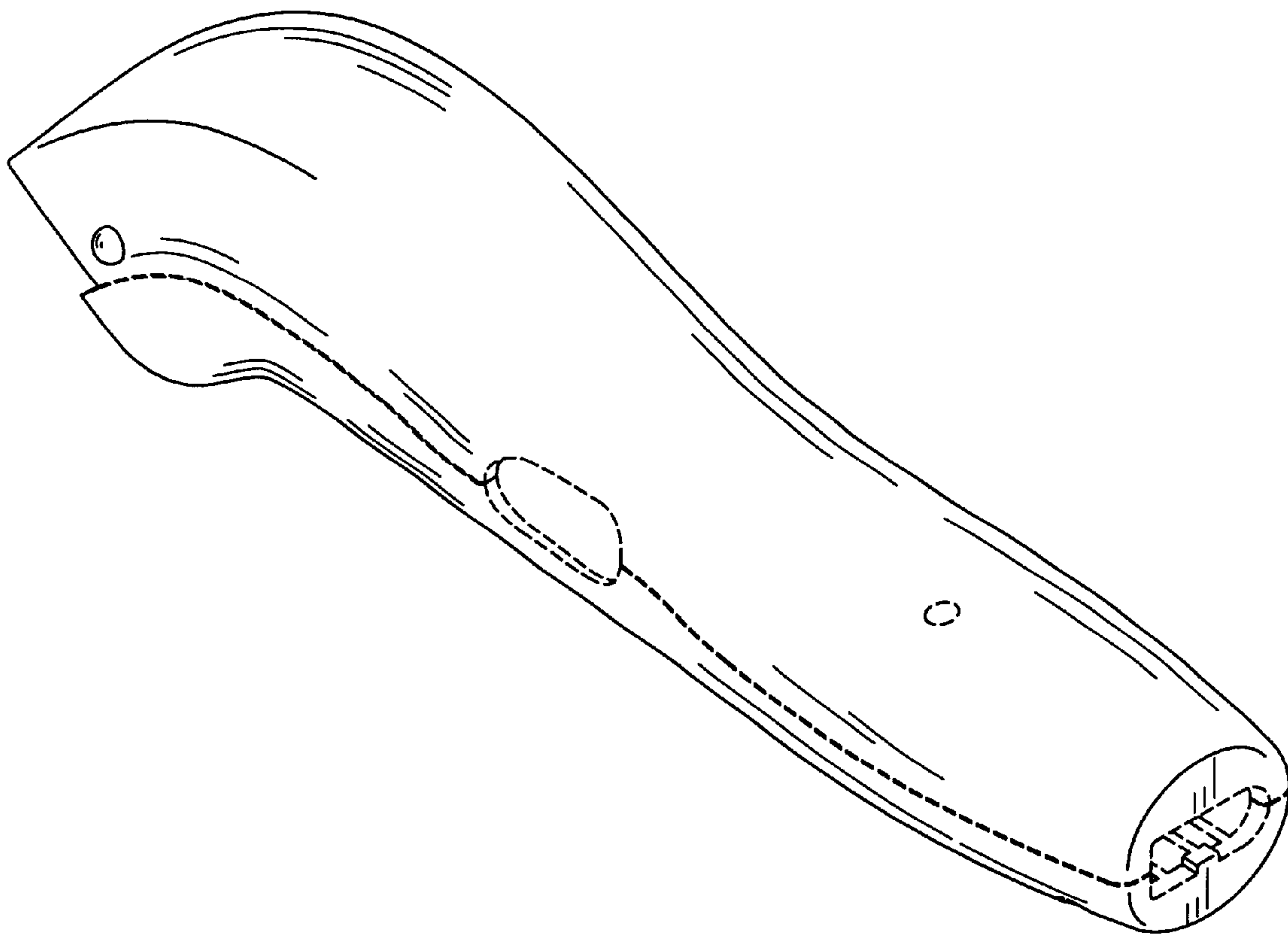

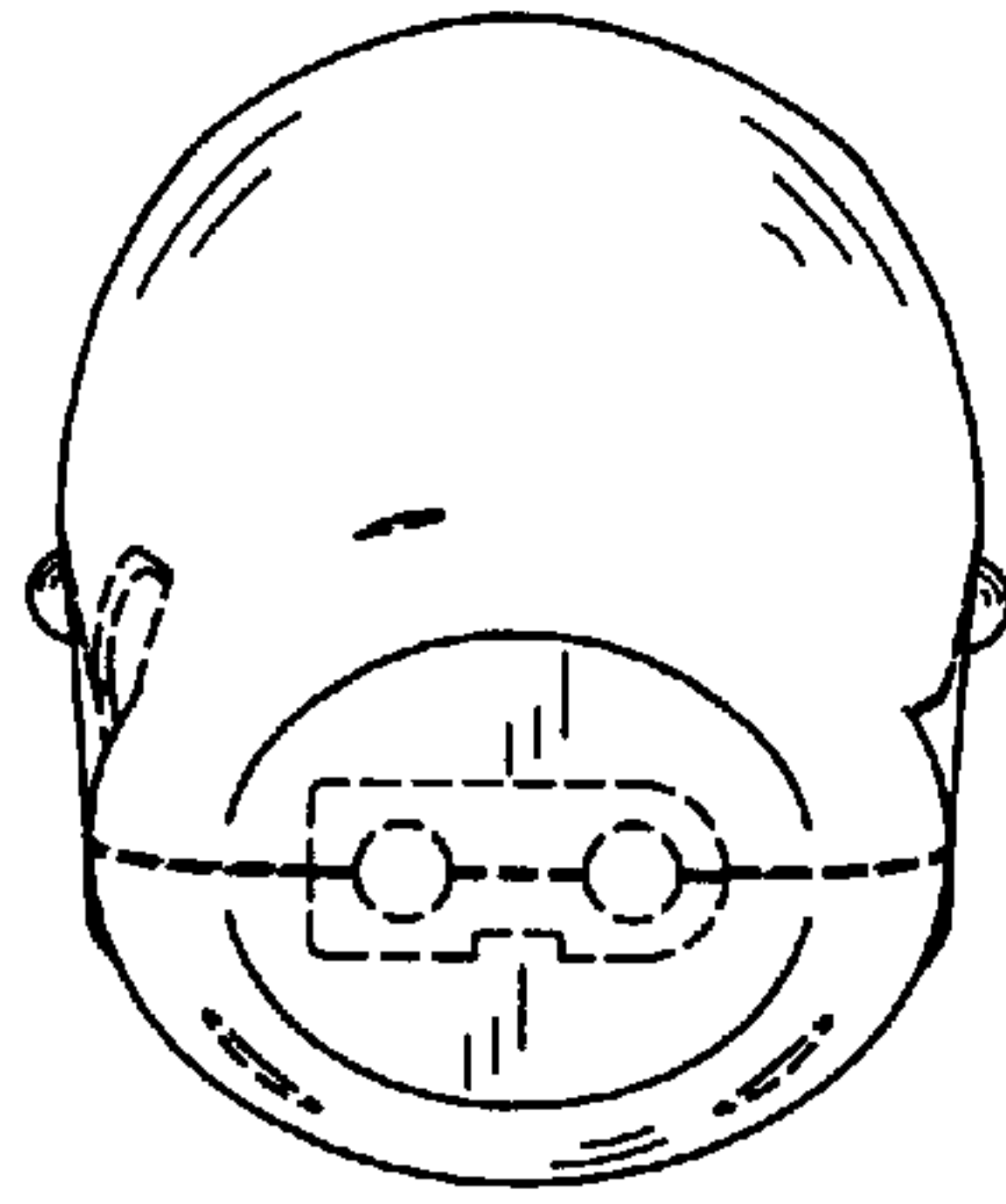

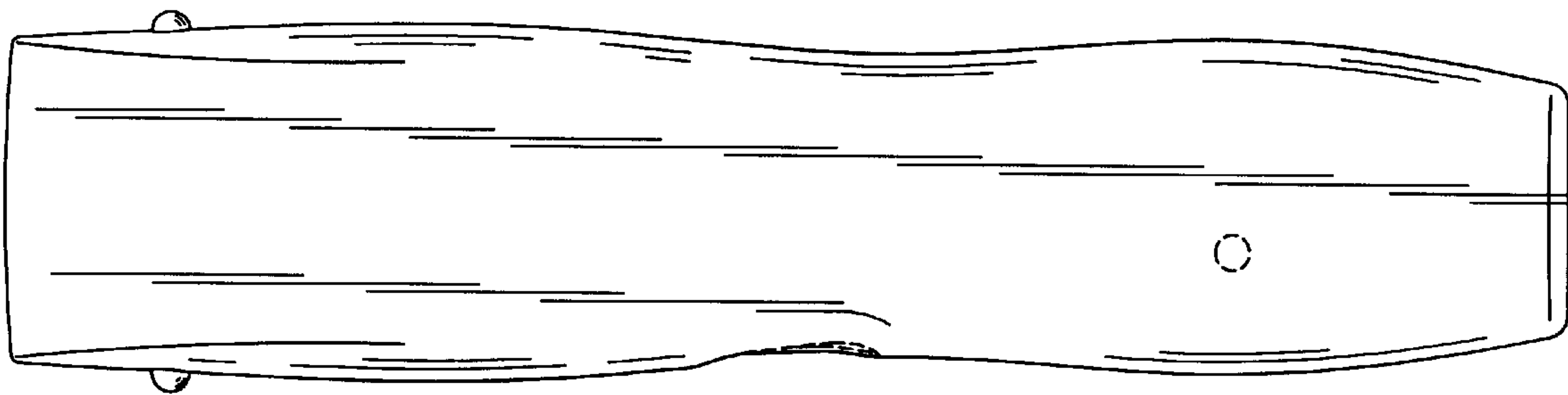

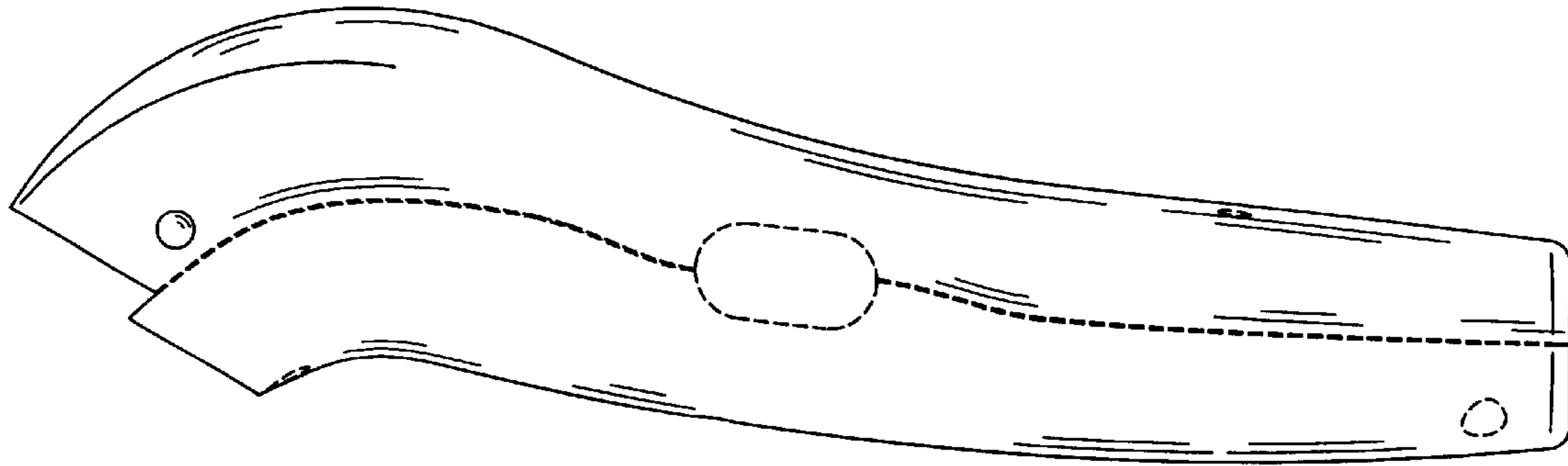

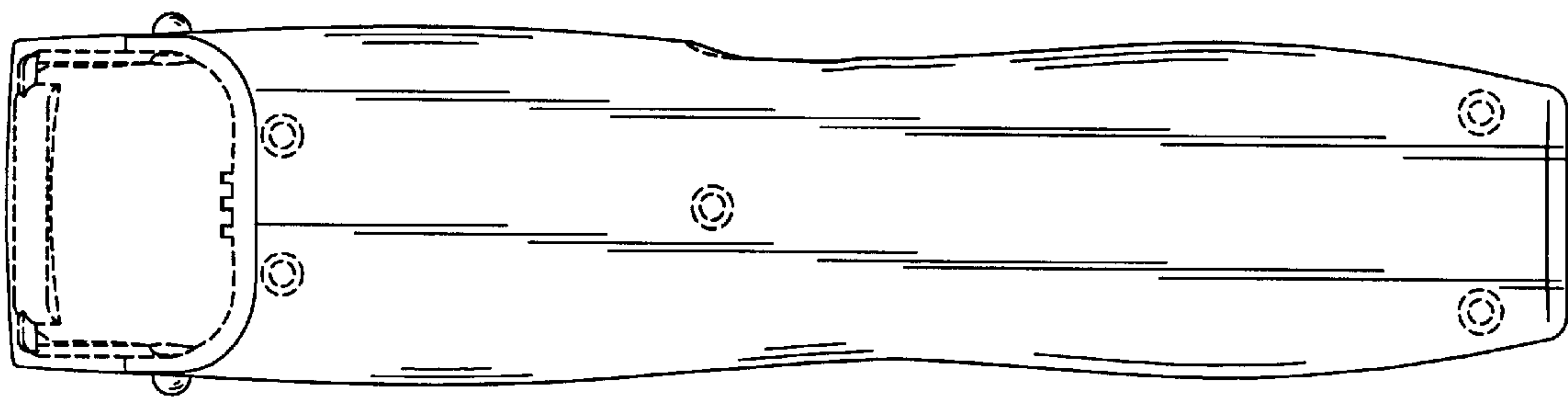

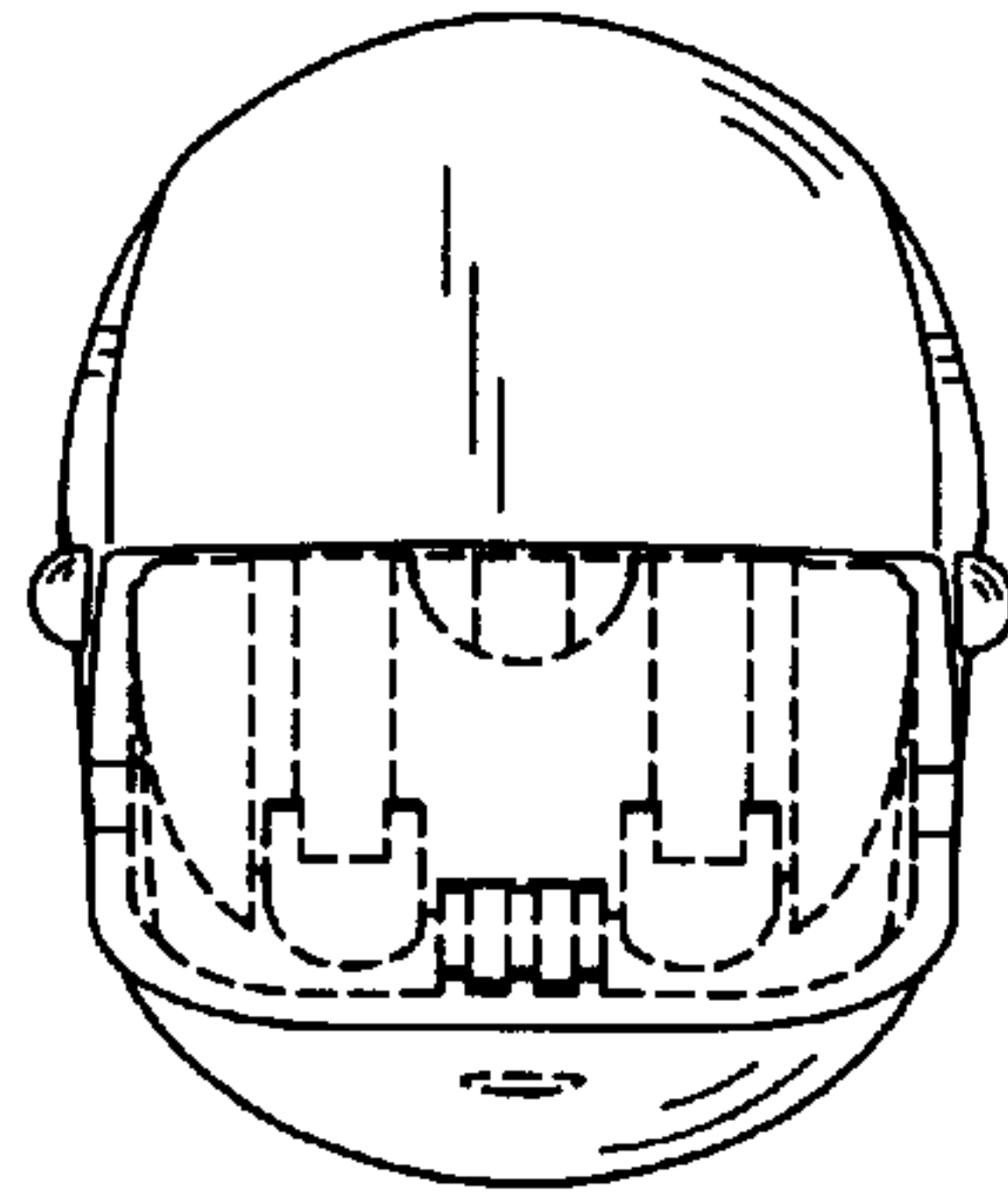

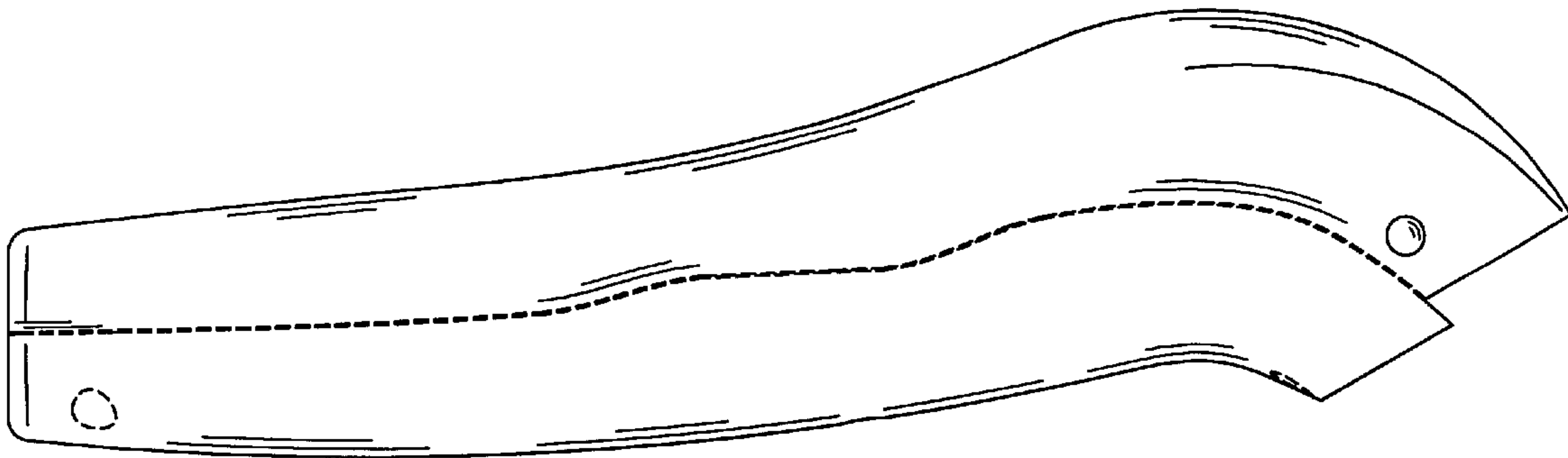
