(57) **CLAIM**

The ornamental design for a hair clipper stand, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the present stand for a hair clipper stand;

FIG. 2 is a front view of same;

FIG. 3 is a right side view of same;

FIG. 4 is a rear view of the hair clipper stand of FIG. 1;

FIG. 5 is a left side view of the hair clipper stand of FIG. 1;

FIG. 11 is a rear view of same;

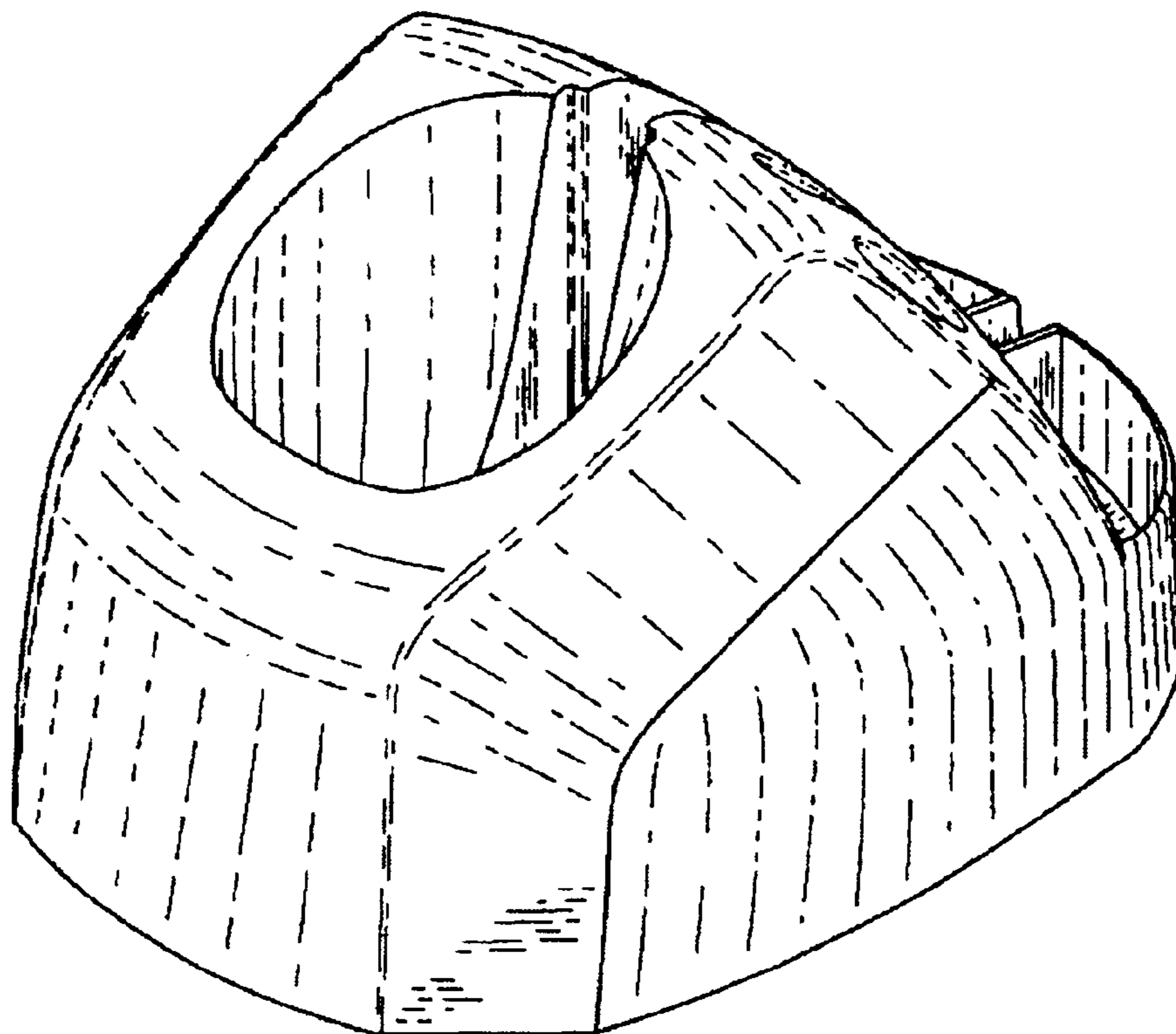
FIG. 12 is a left side view of the hair clipper stand of FIG. 8;

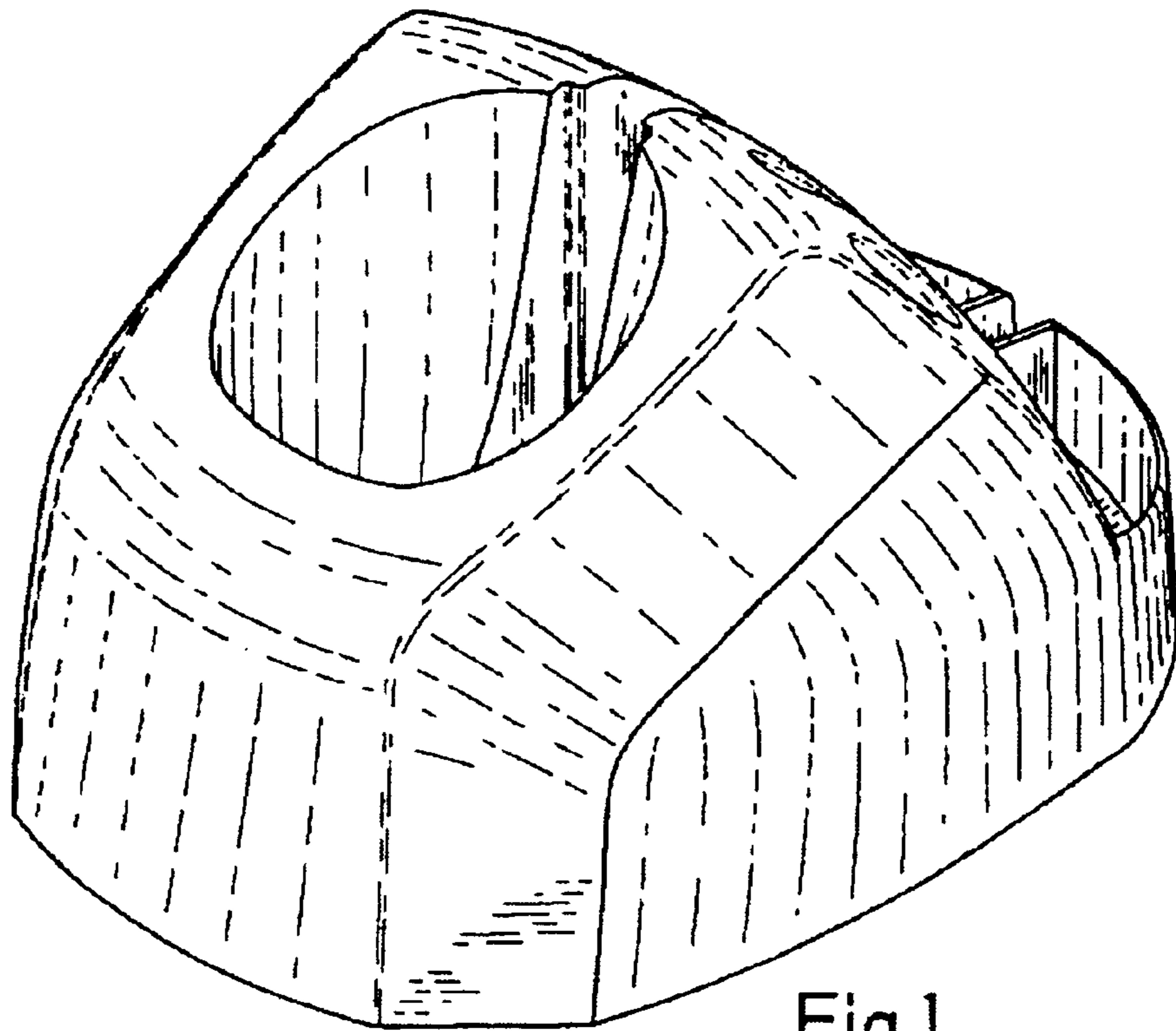

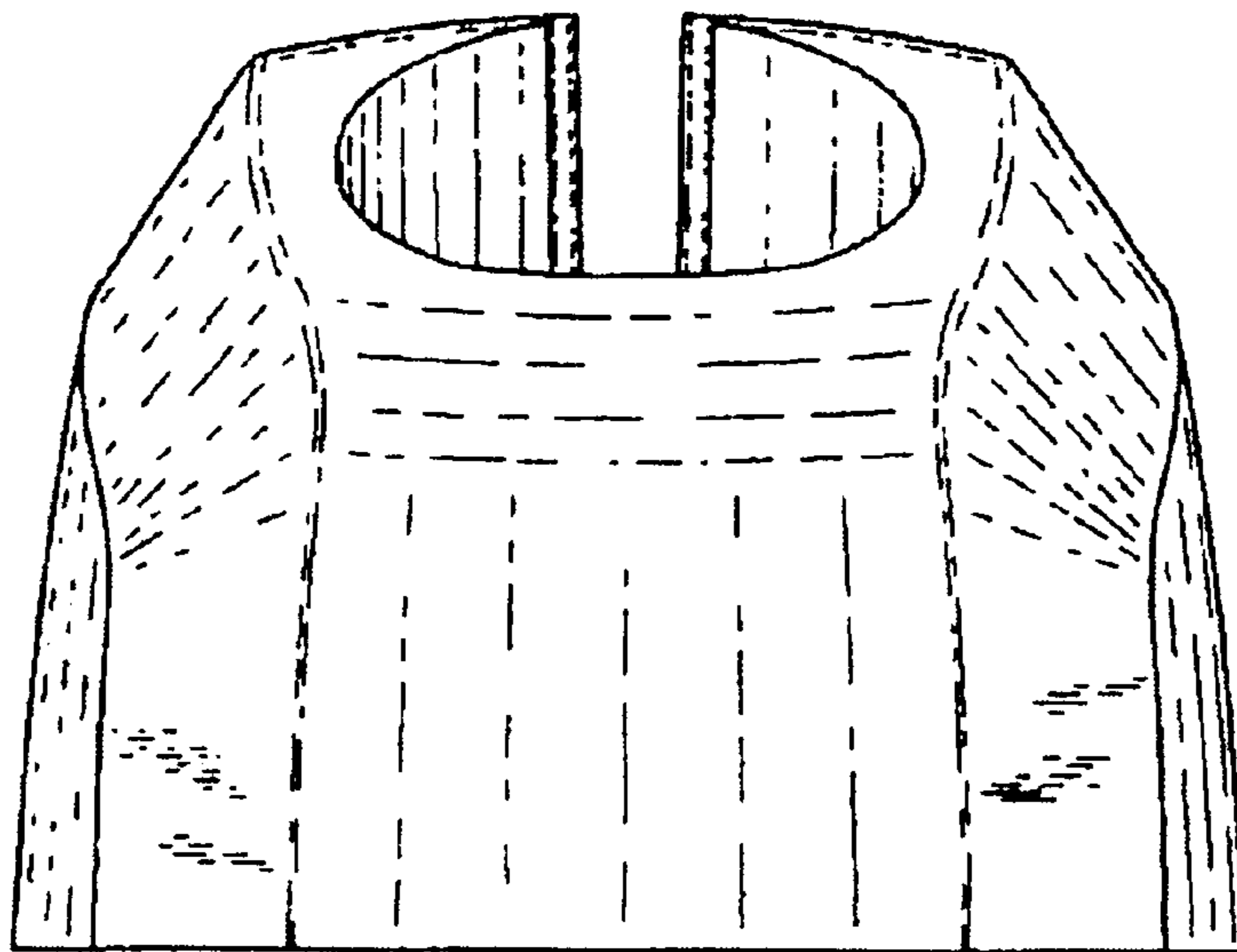

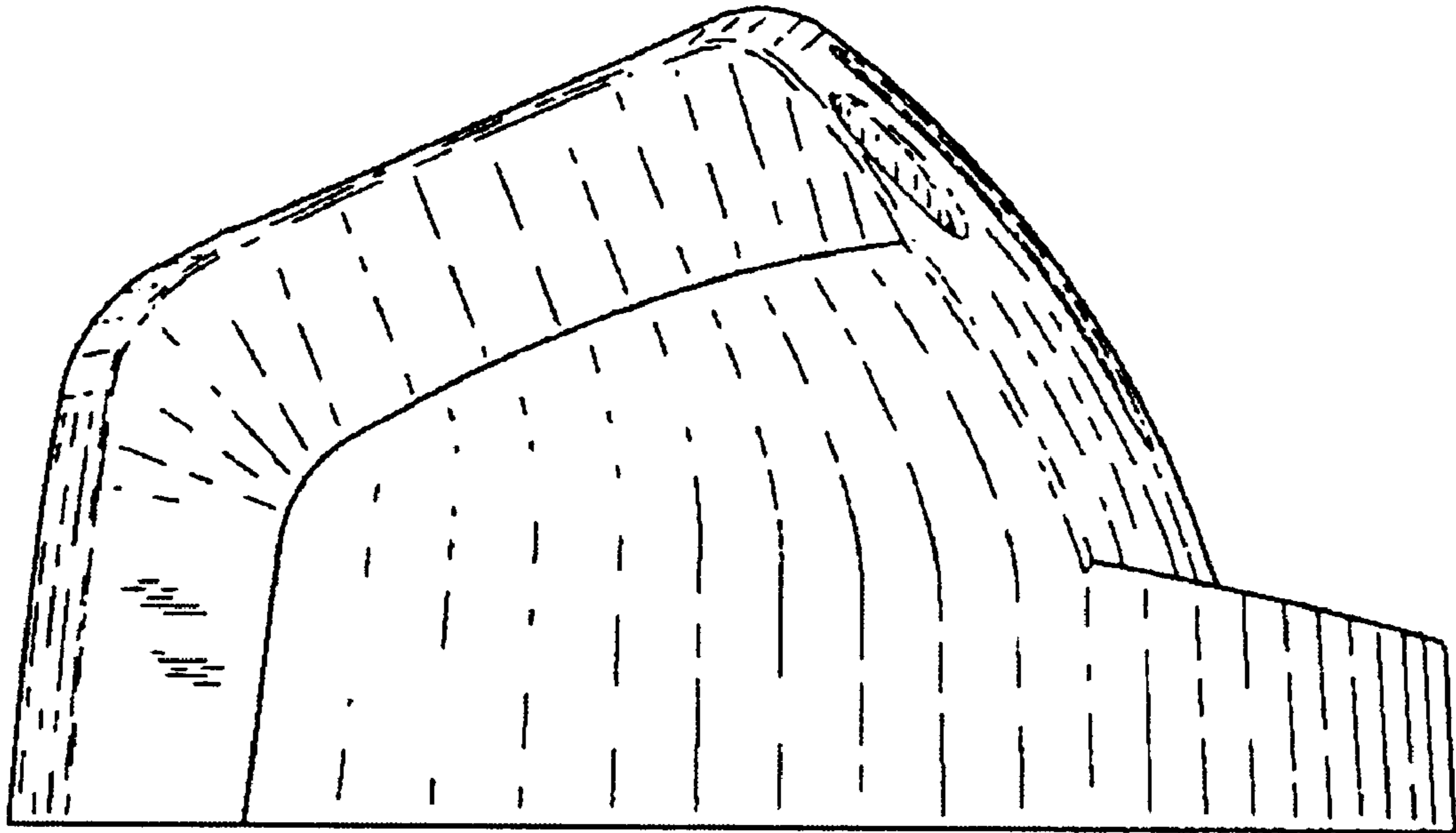

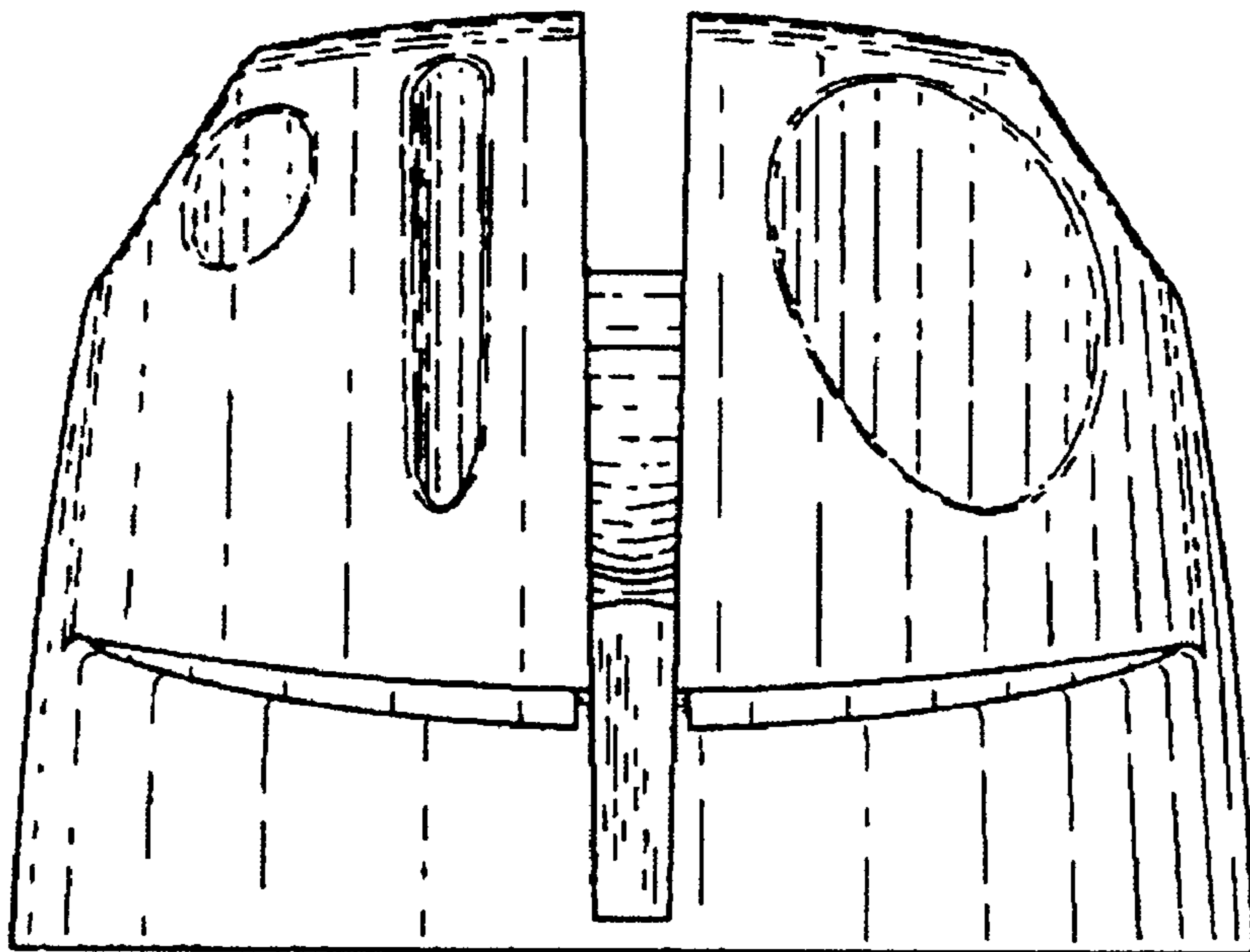

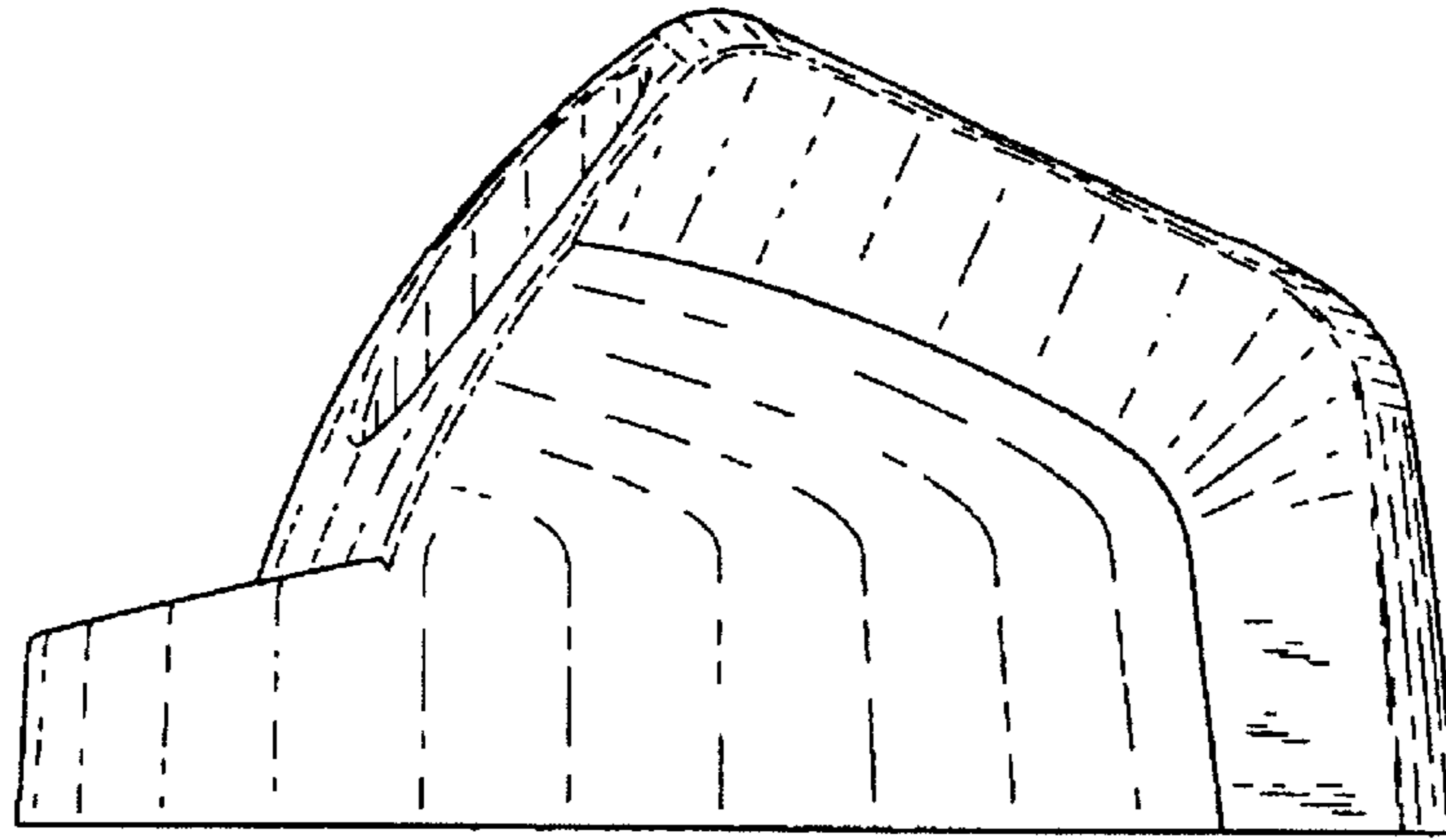

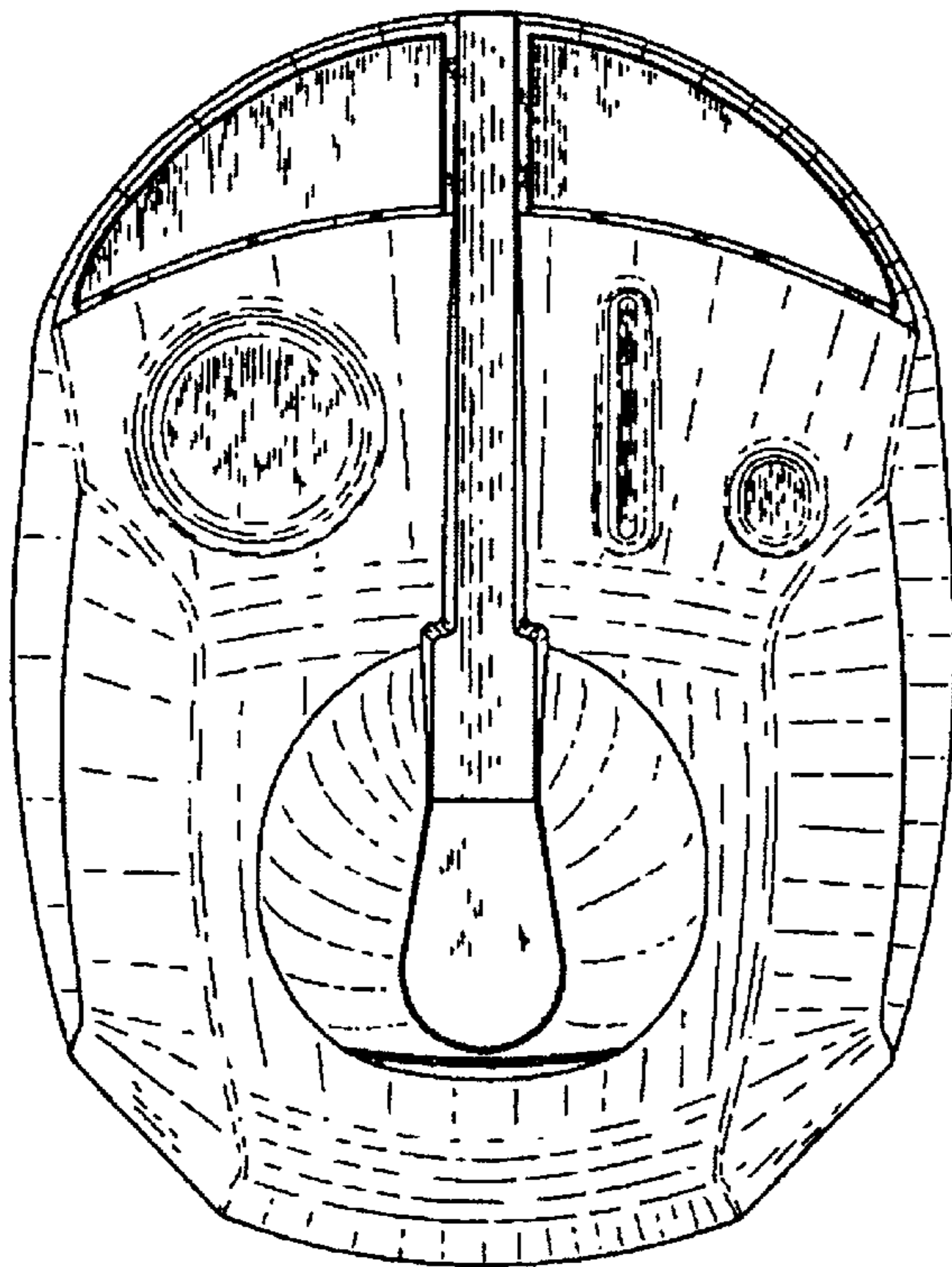

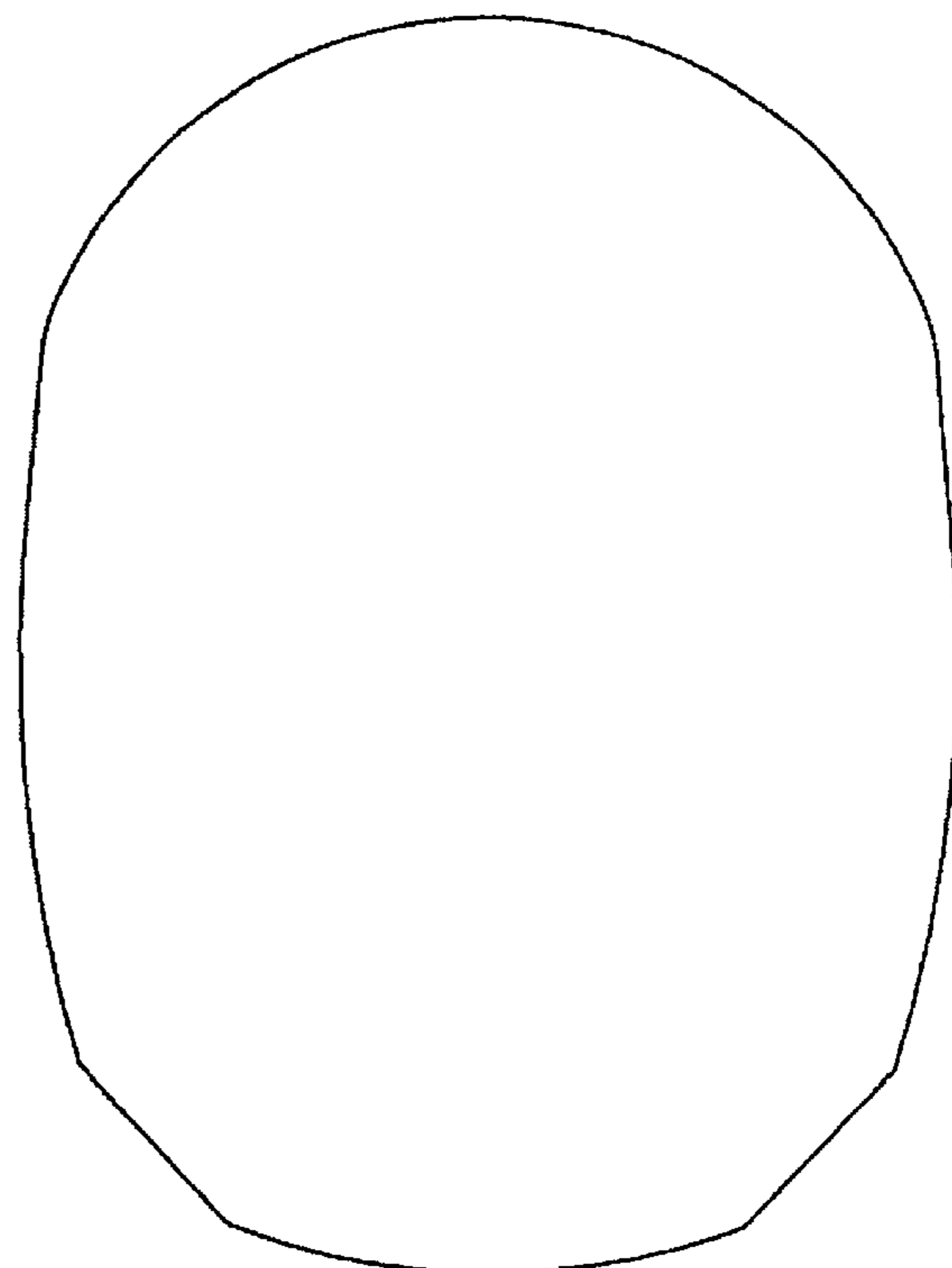

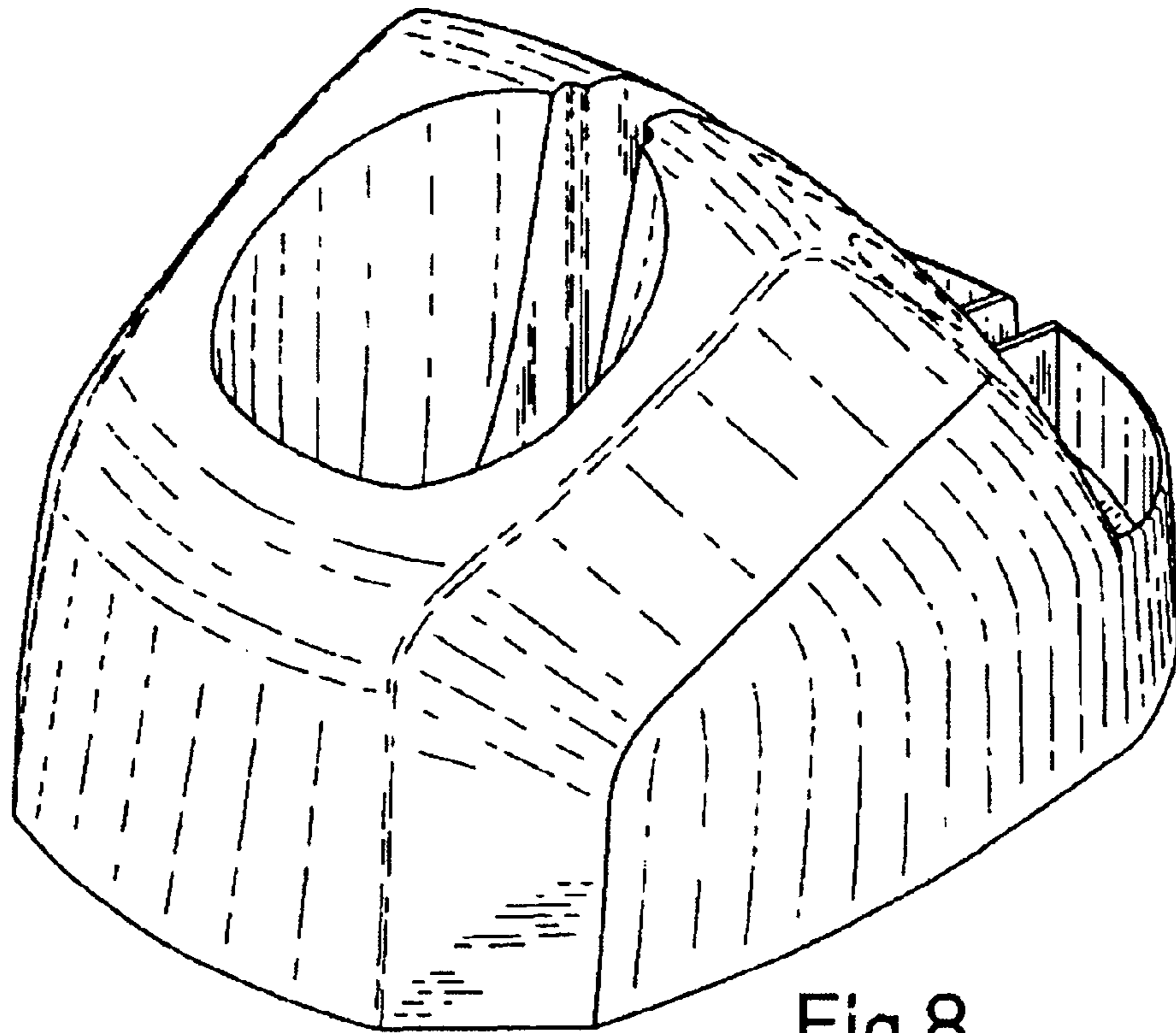

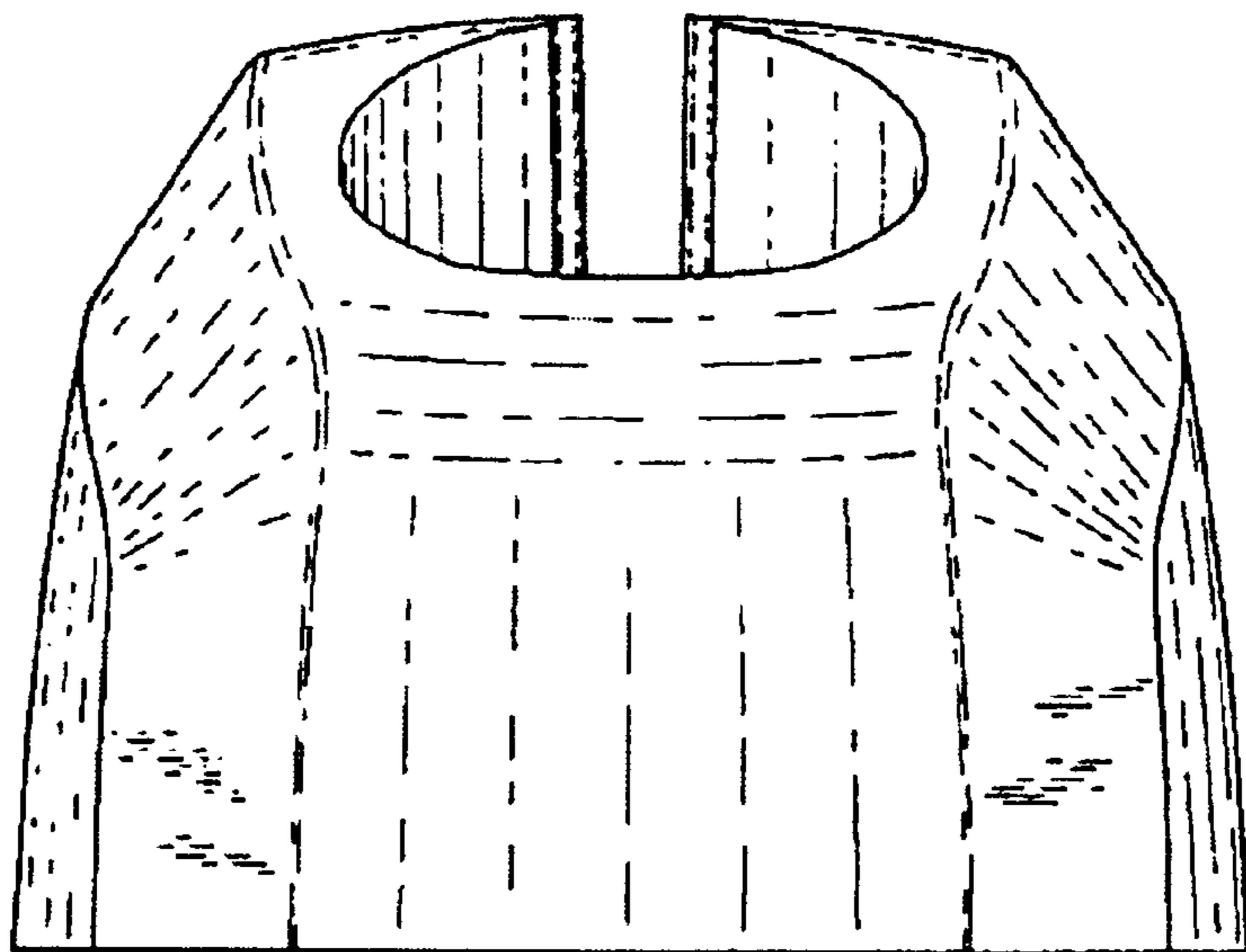

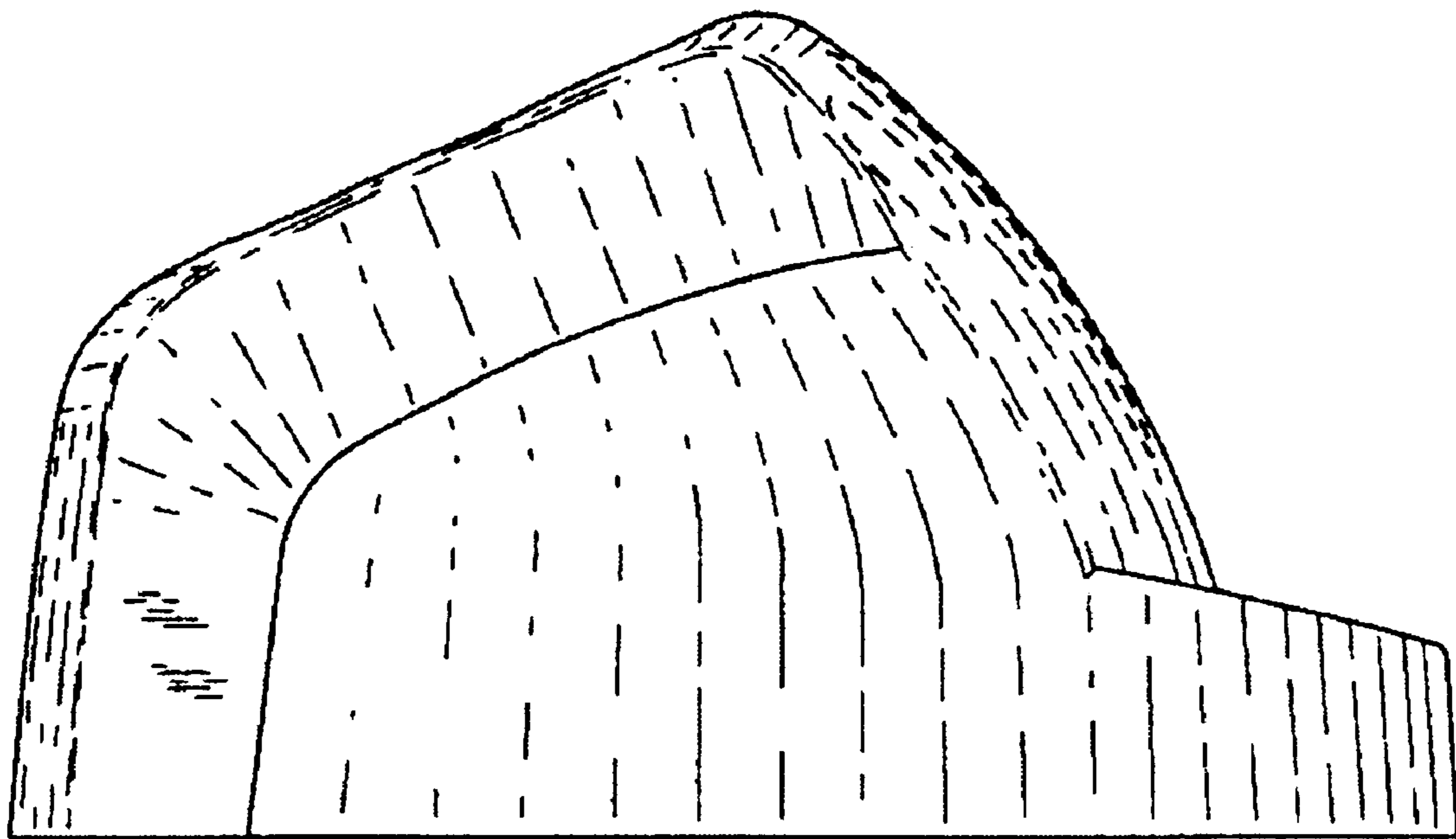

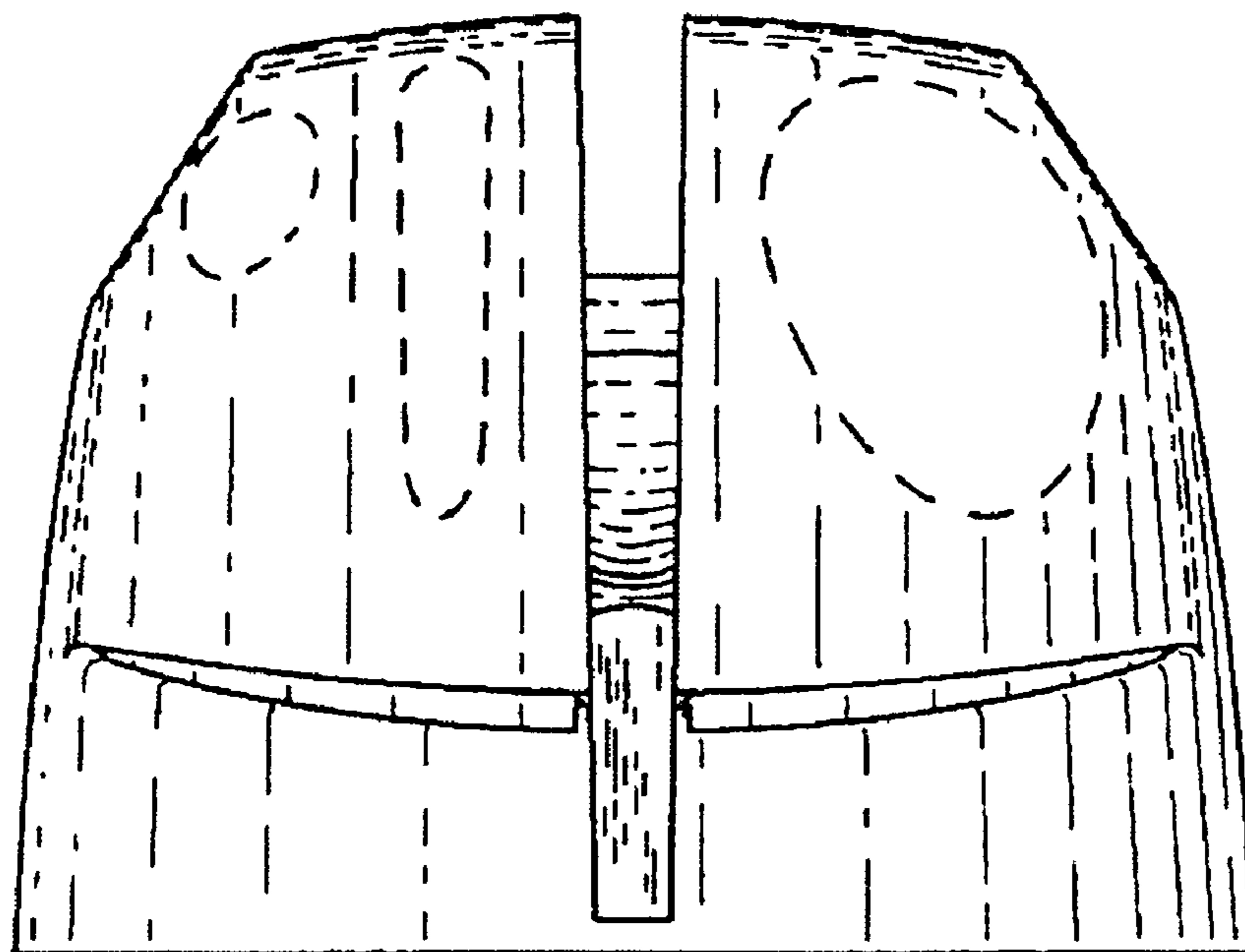

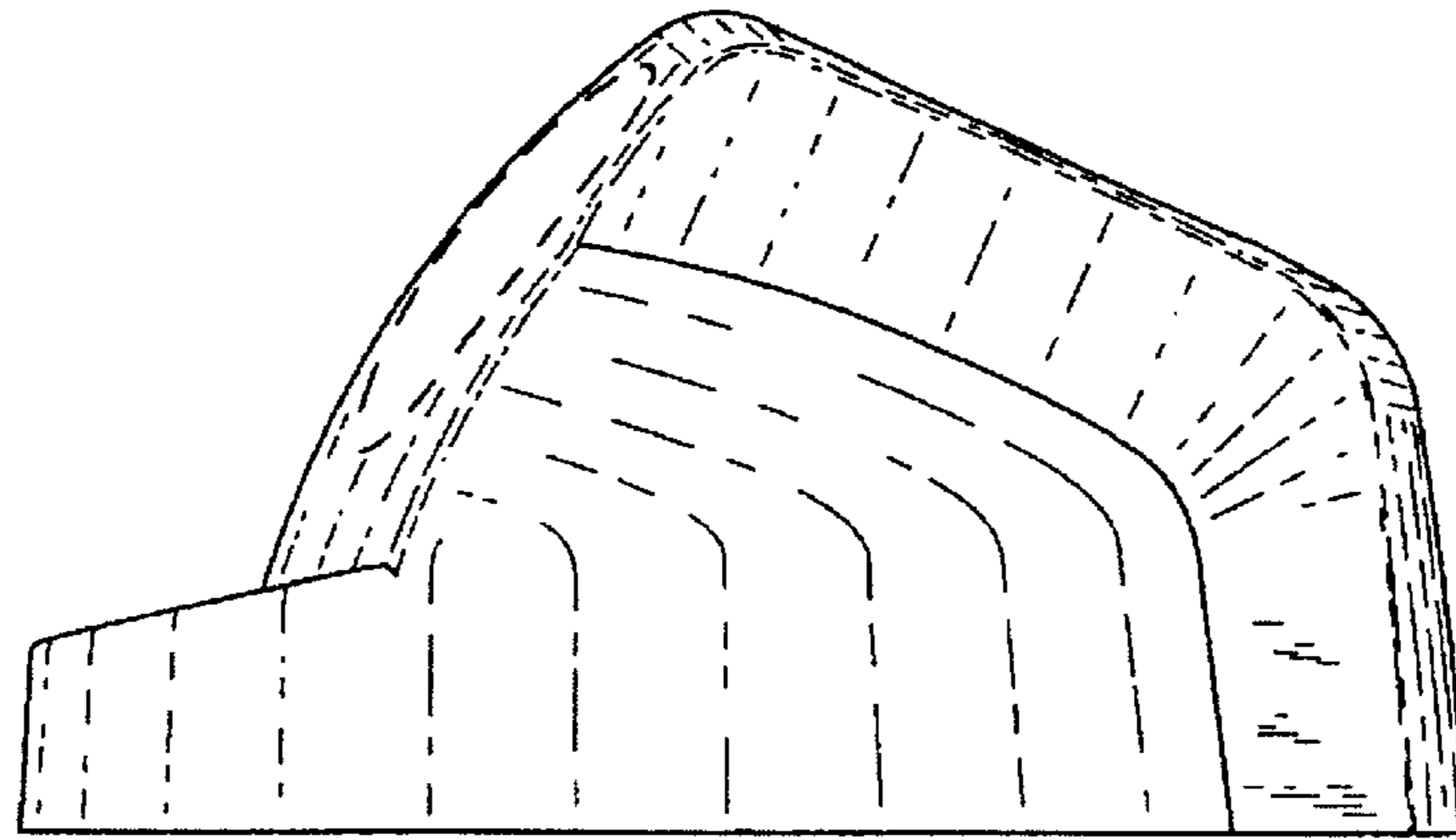

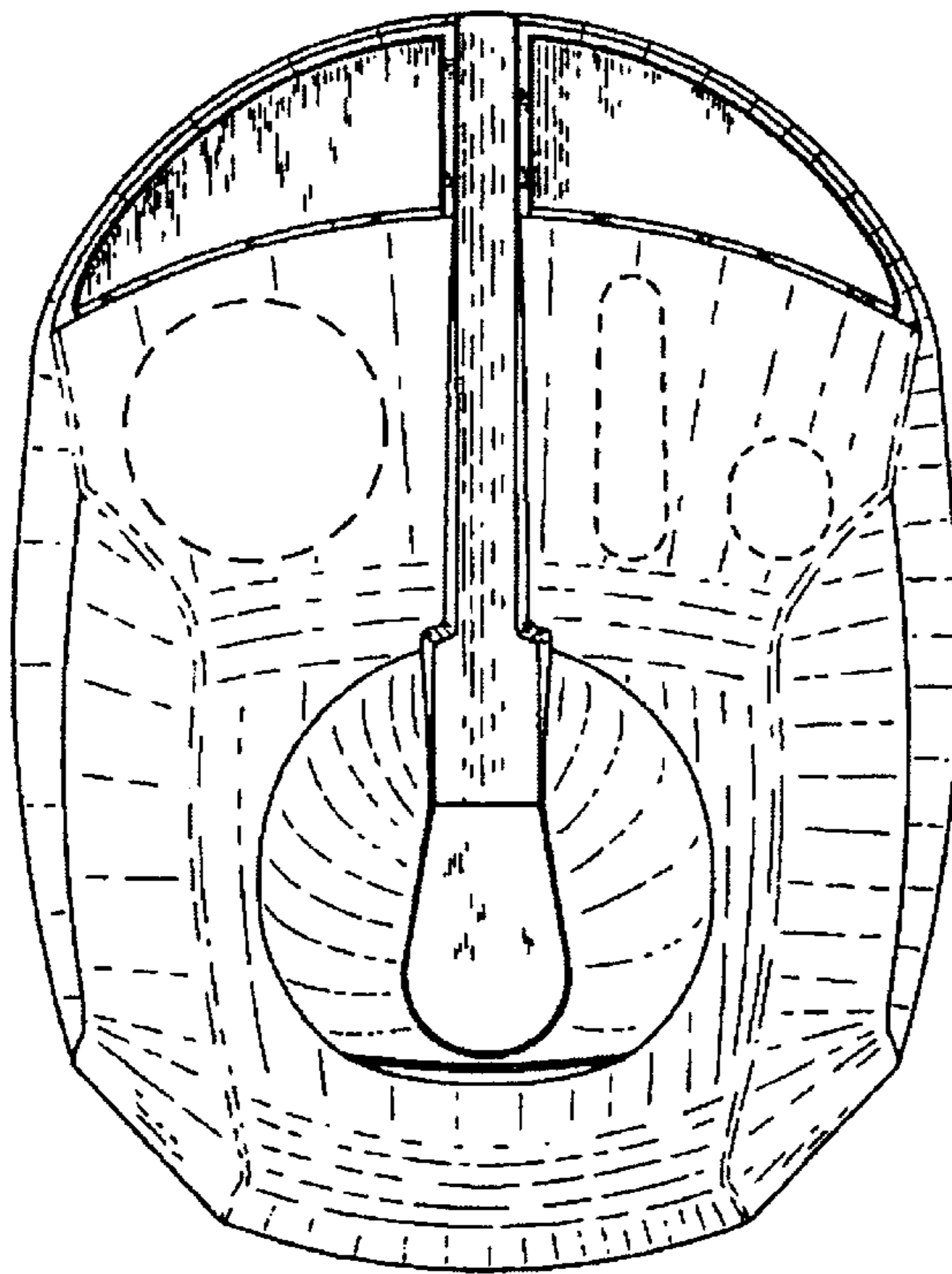

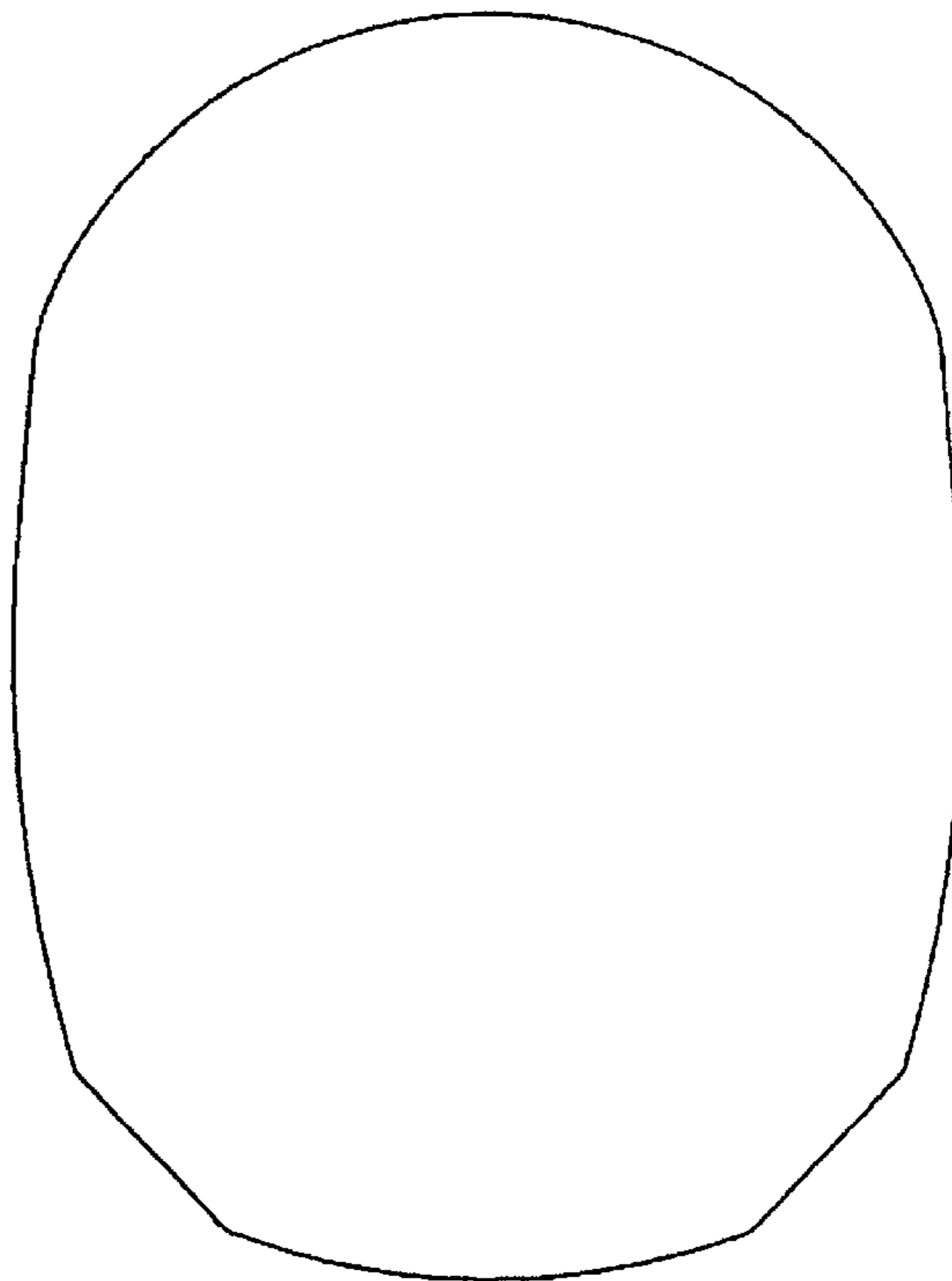
