and described.

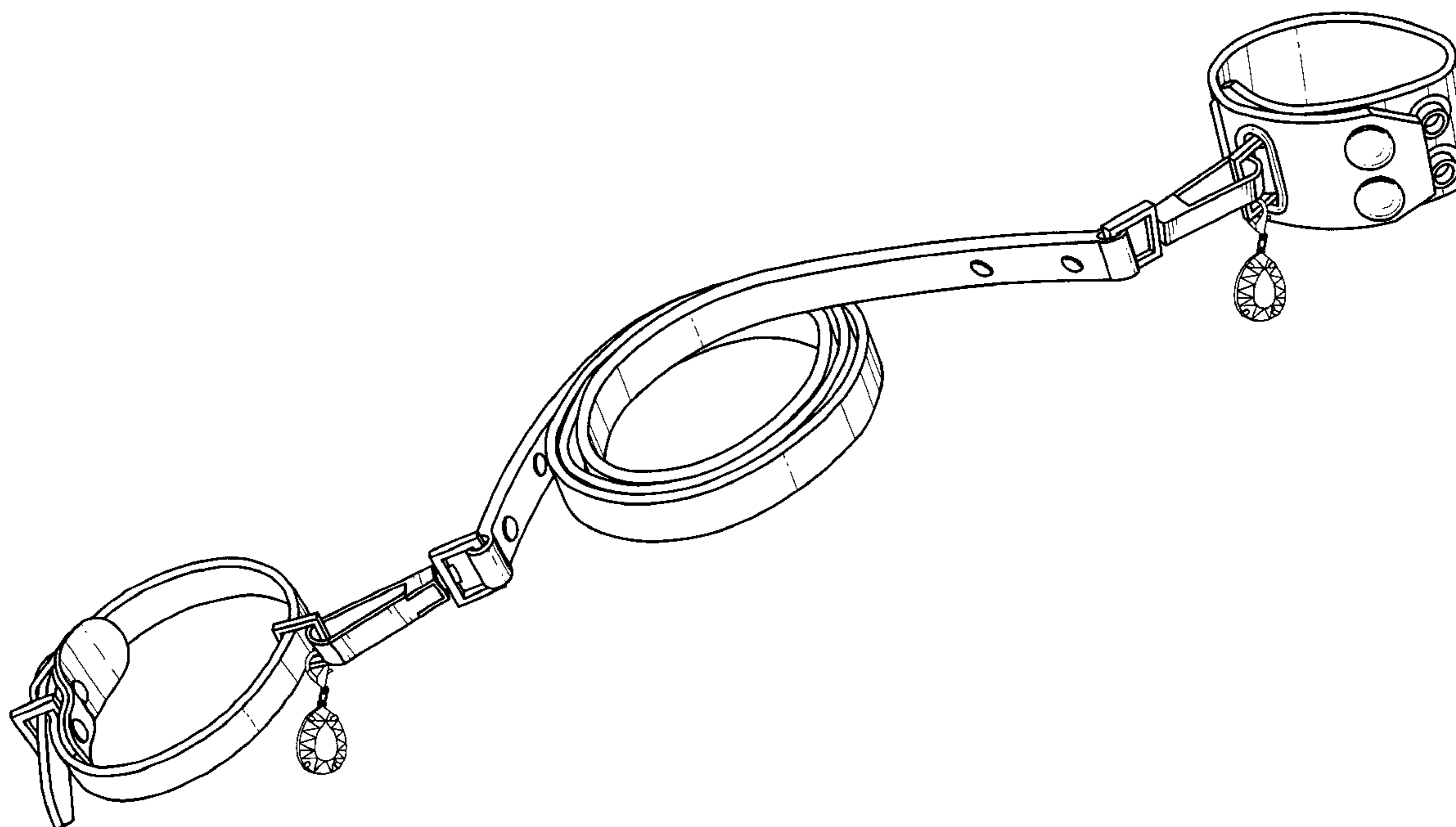
DESCRIPTION

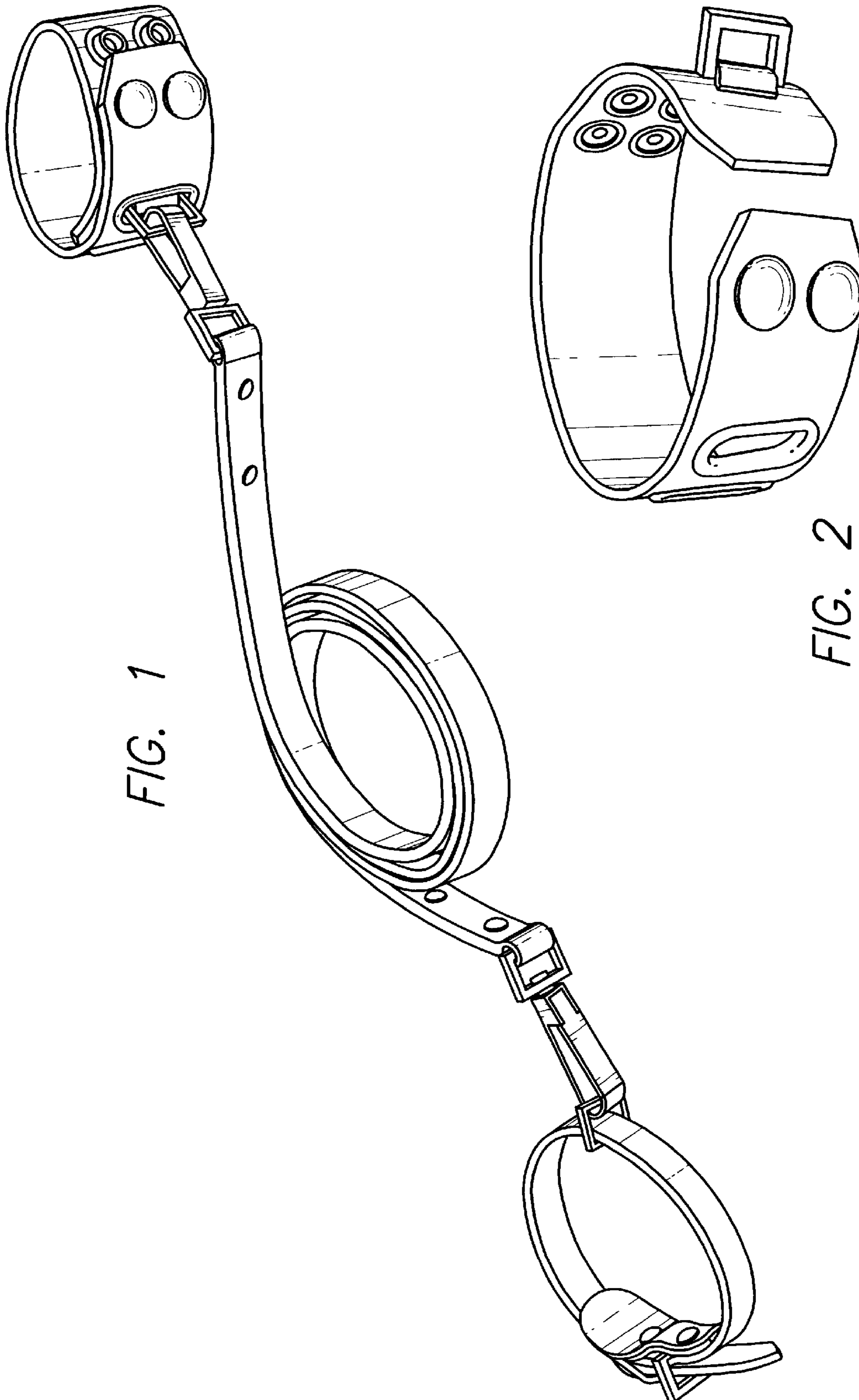

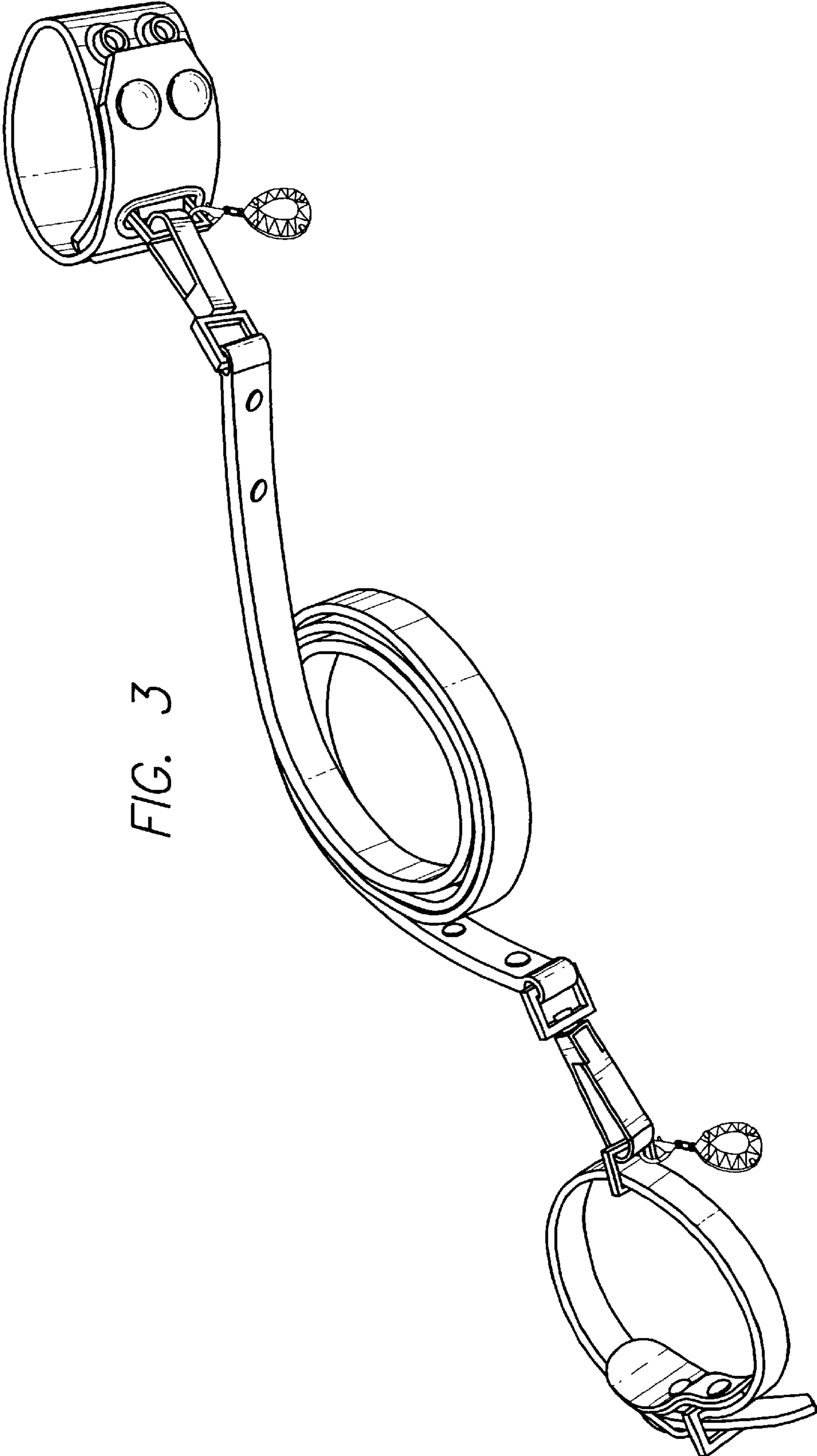

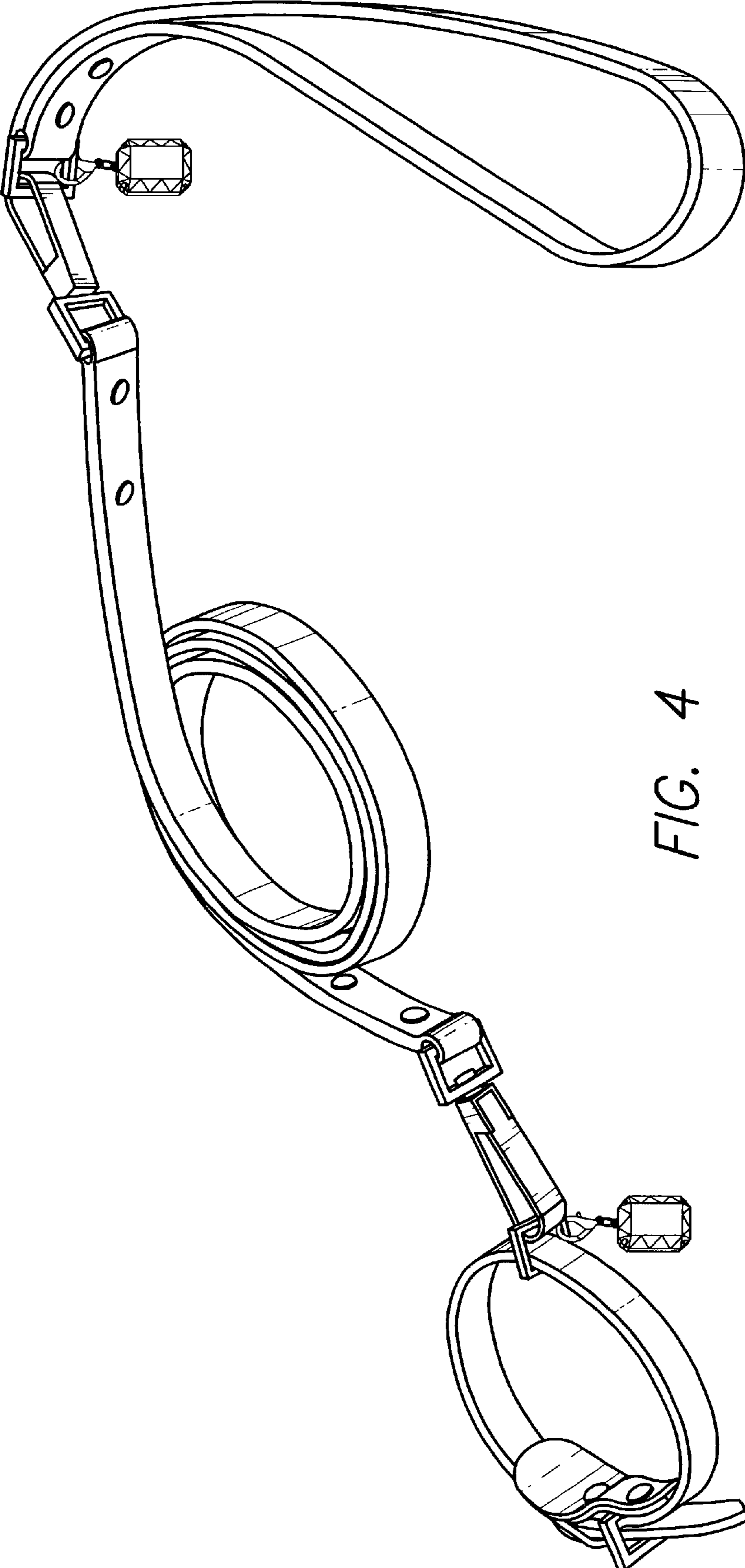
