(57) **CLAIM**

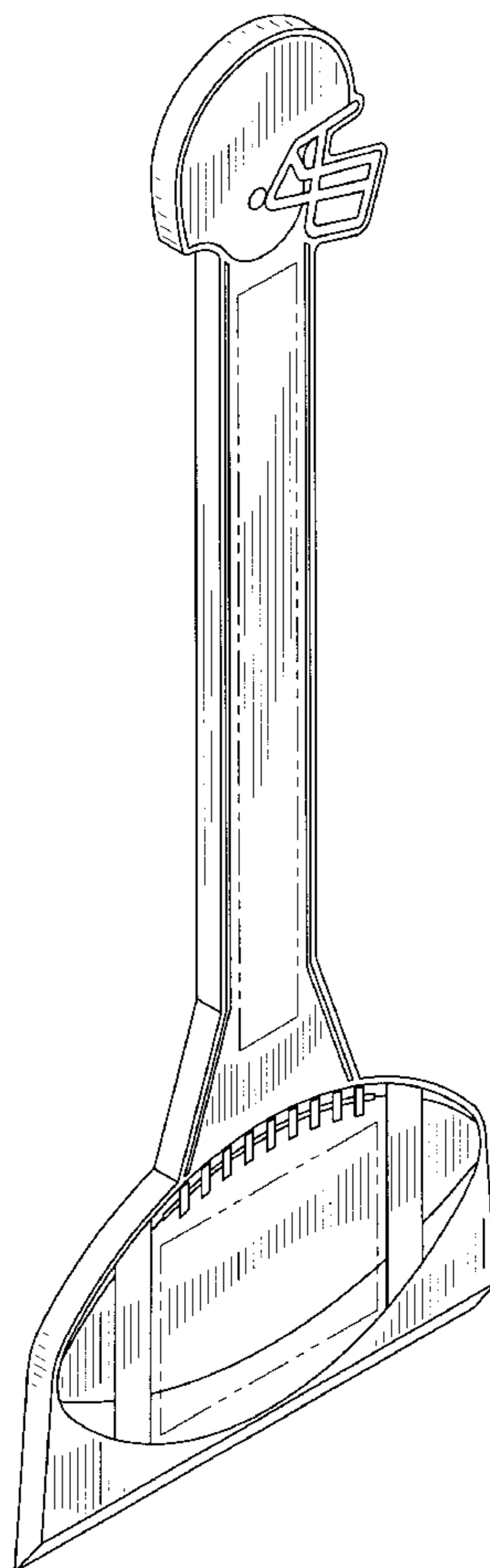
The ornamental design for an ice scraper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the ice scraper according to the invention;  
FIG. 2 is a top view of the ice scraper as shown in FIG. 1;  
FIG. 3 is a front view of the ice scraper as shown in FIG. 1;  
FIG. 4 is a side view of the ice scraper as shown in FIG. 1;  
FIG. 5 is a rear view of the ice scraper as shown in FIG. 1;  
FIG. 6 is a side view of the ice scraper as shown in FIG. 1, viewed from the opposite side of that shown in FIG. 4; and,  
FIG. 7 is a bottom view of the ice scraper as shown in FIG. 1.

The broken lines shown on the front of the scraper in FIGS. 1 and 3 are for illustrative purposes only and form no part of the claimed design.

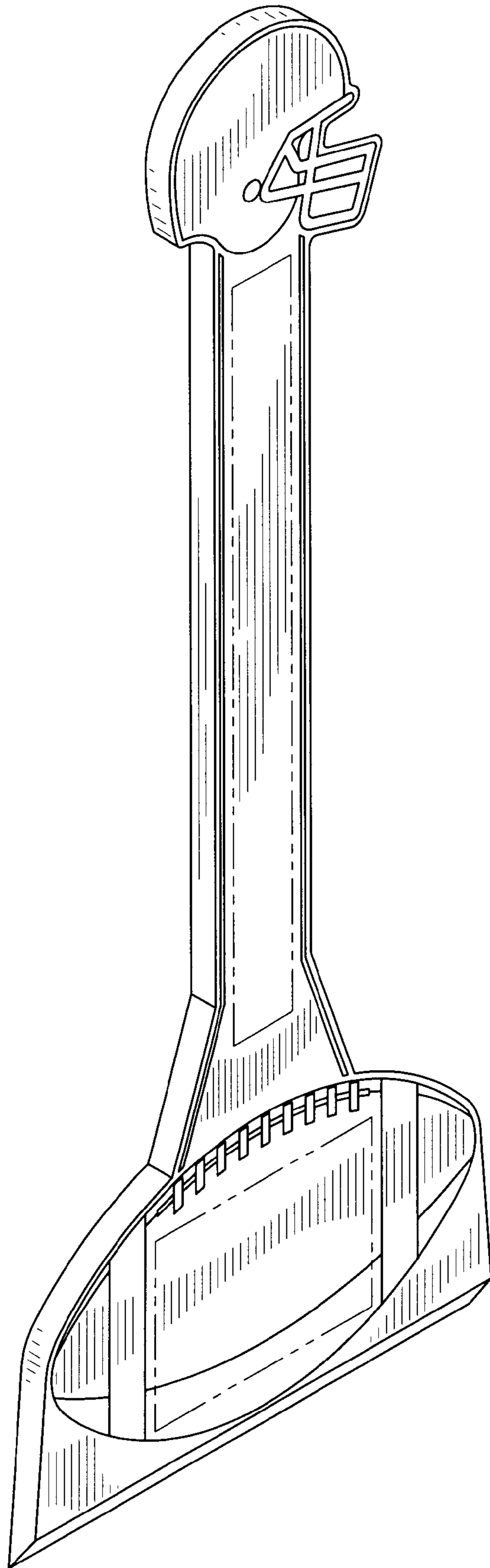

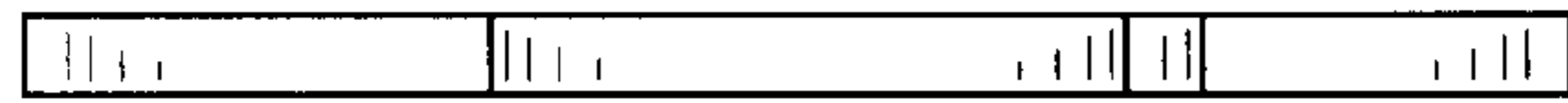

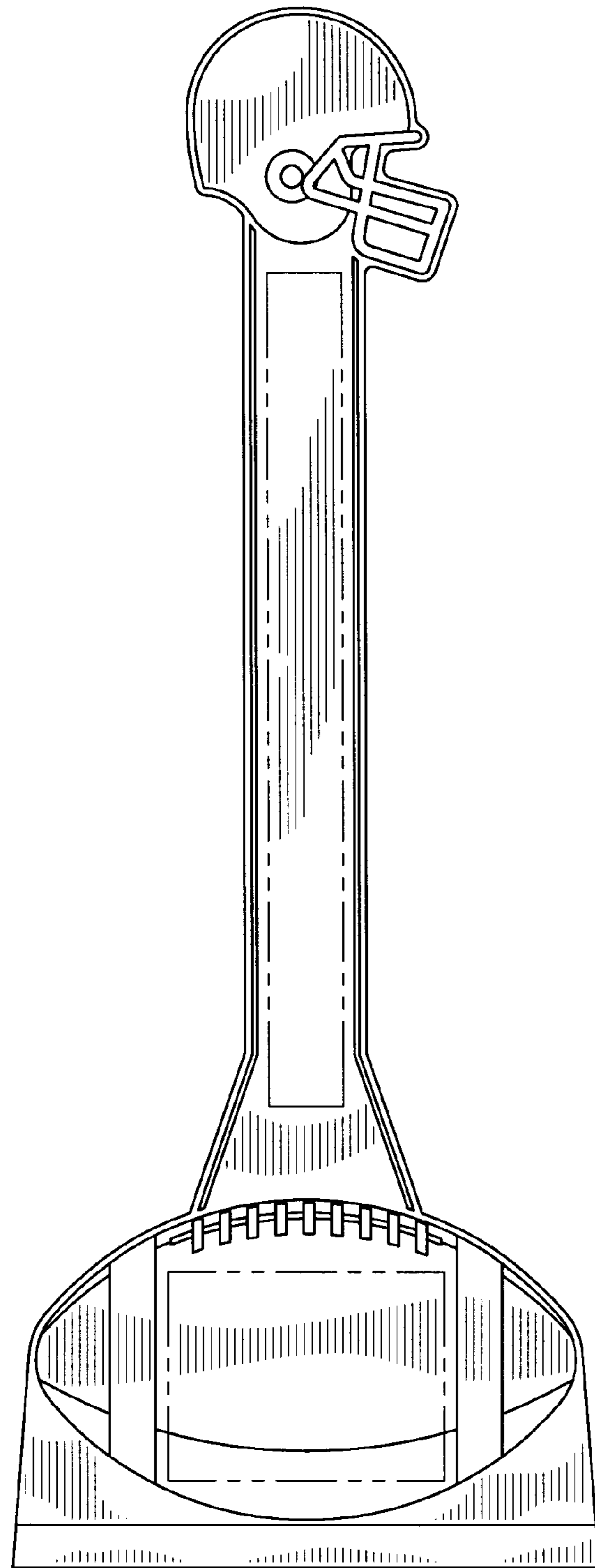

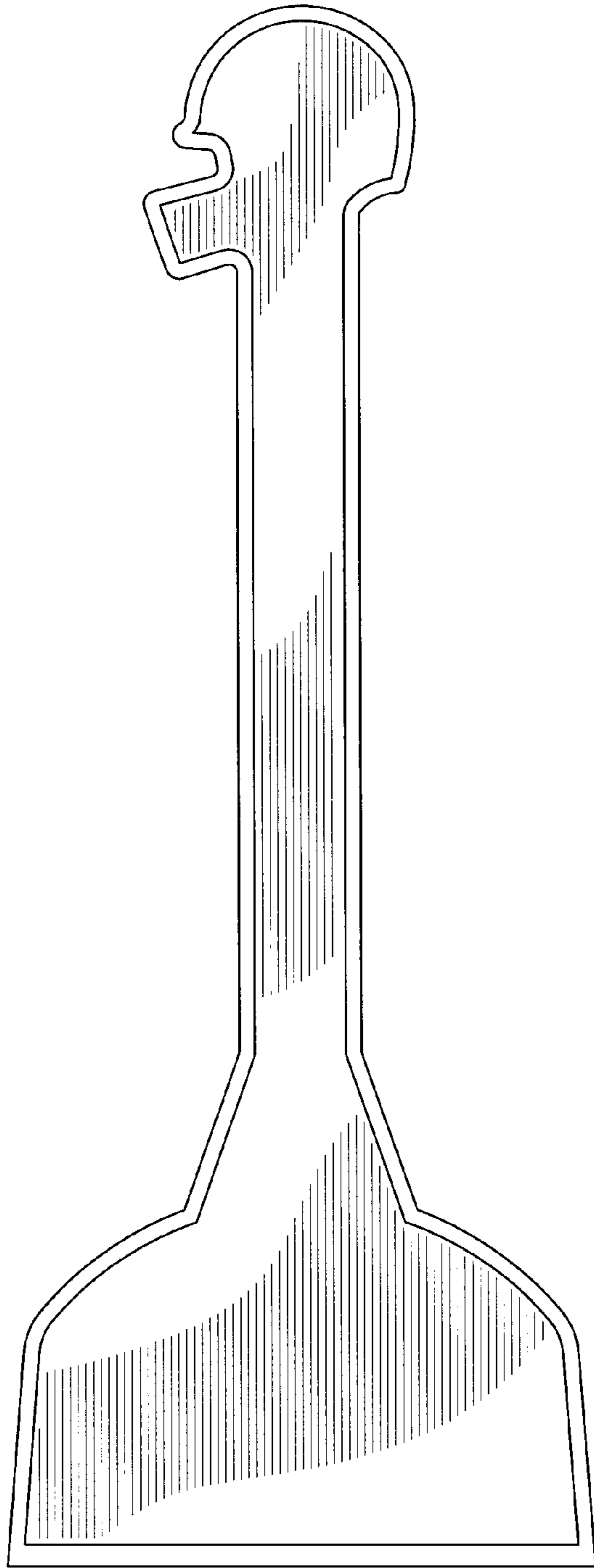

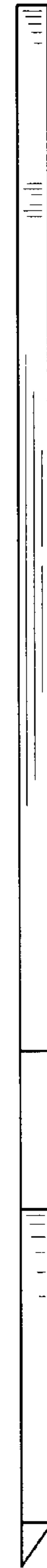
