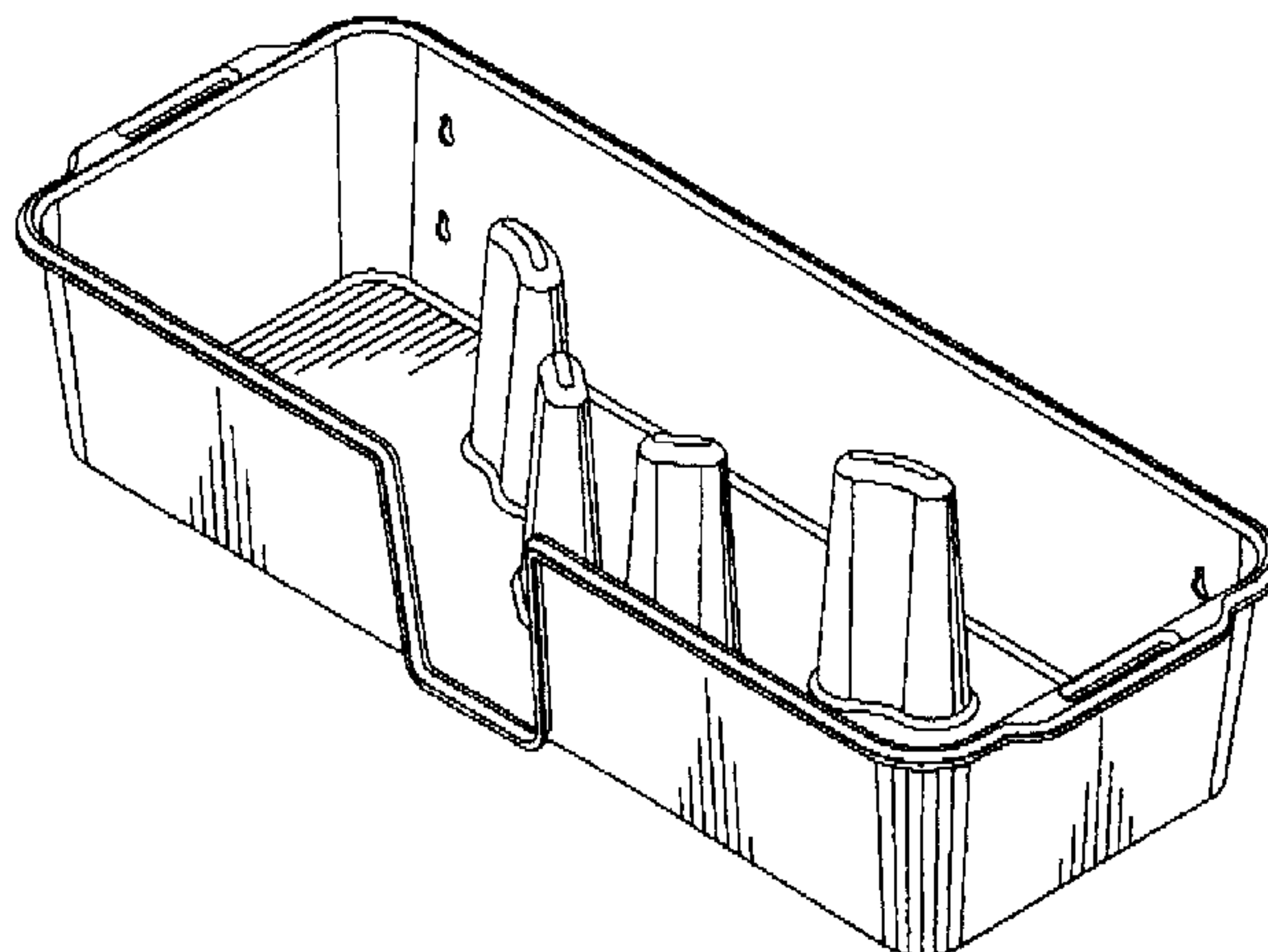
(57) **CLAIM**

The ornamental design for an clothes hanger storage device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a clothes hanger storage device showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a right side elevational view thereof;
FIG. 8 is a front perspective view thereof with brackets; and,
FIG. 9 is a front perspective view thereof with a lid.
The broken line showing of brackets and a lid in FIGS. 8 and 9 is for illustrative purposes only and forms no part of the claimed design.

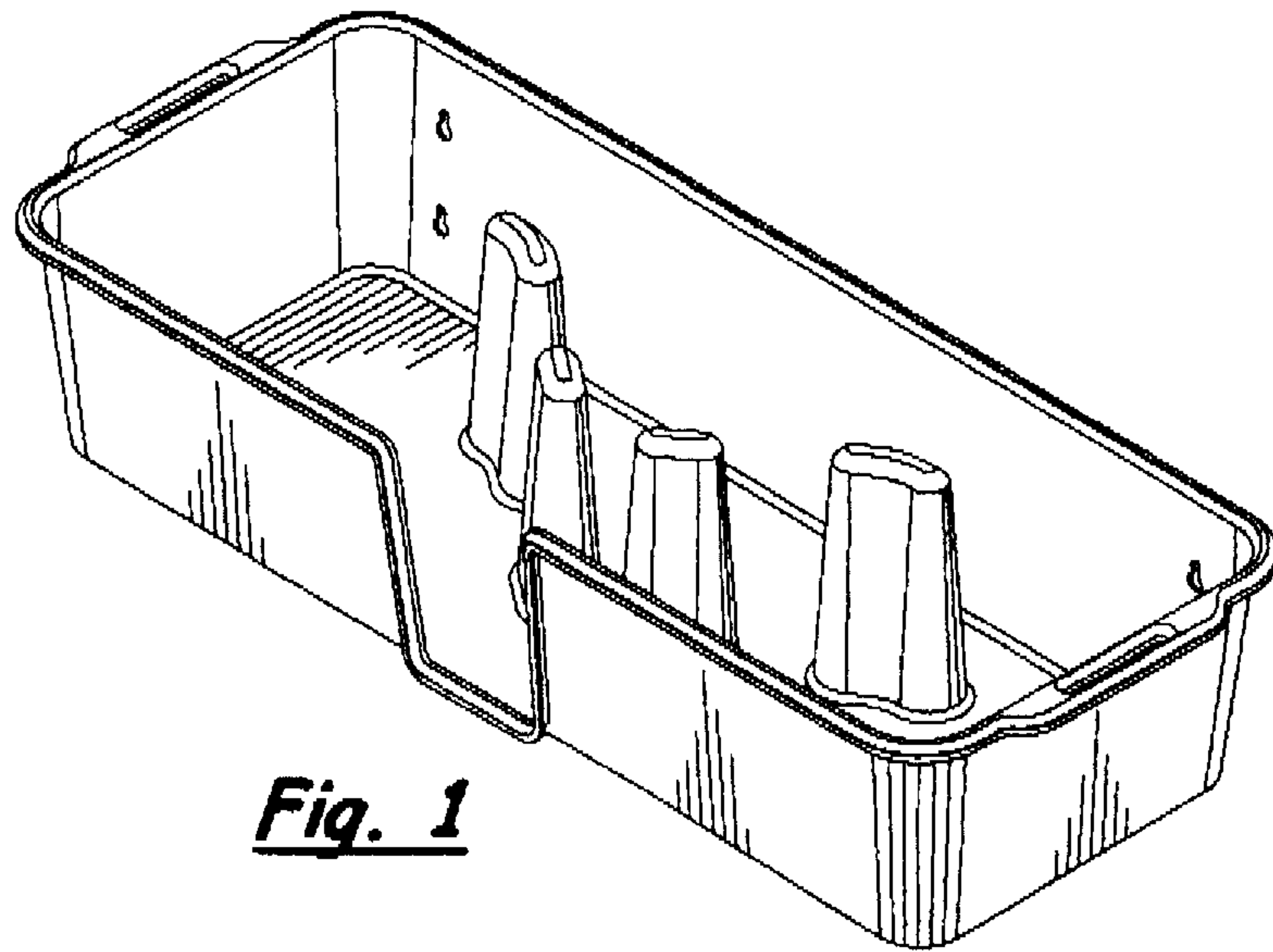

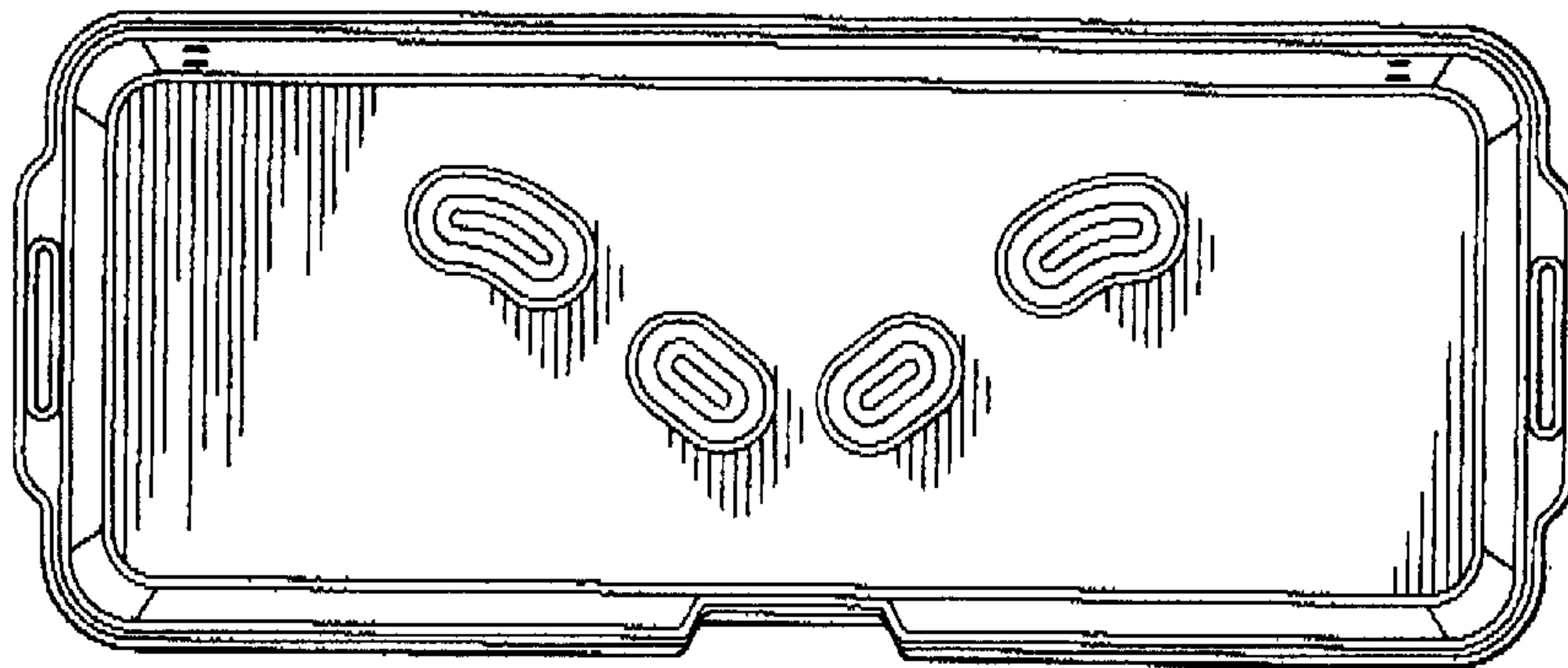

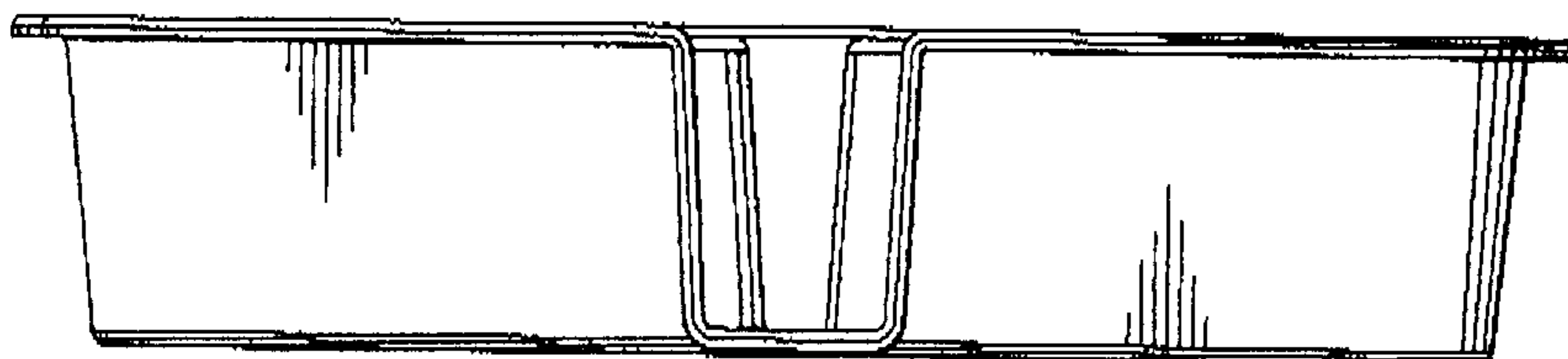

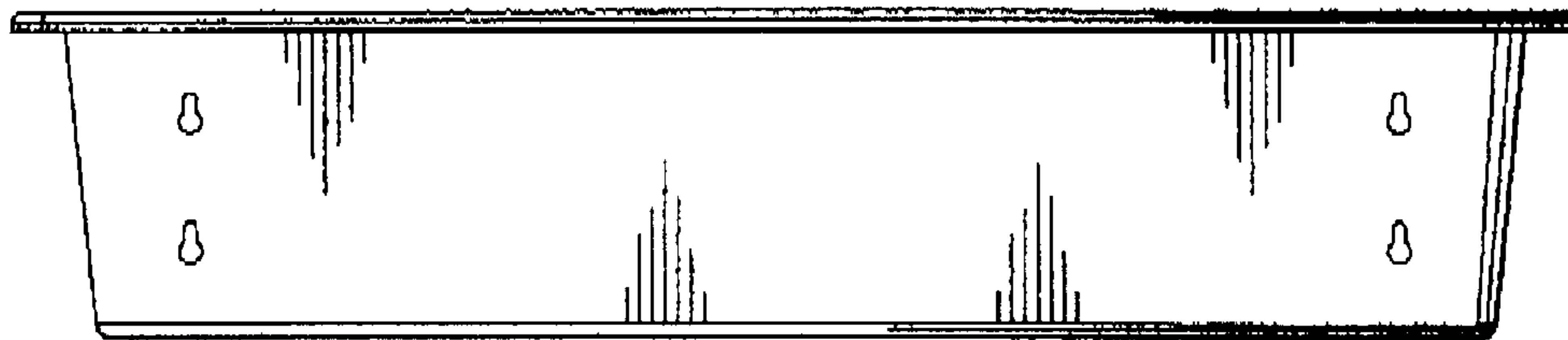

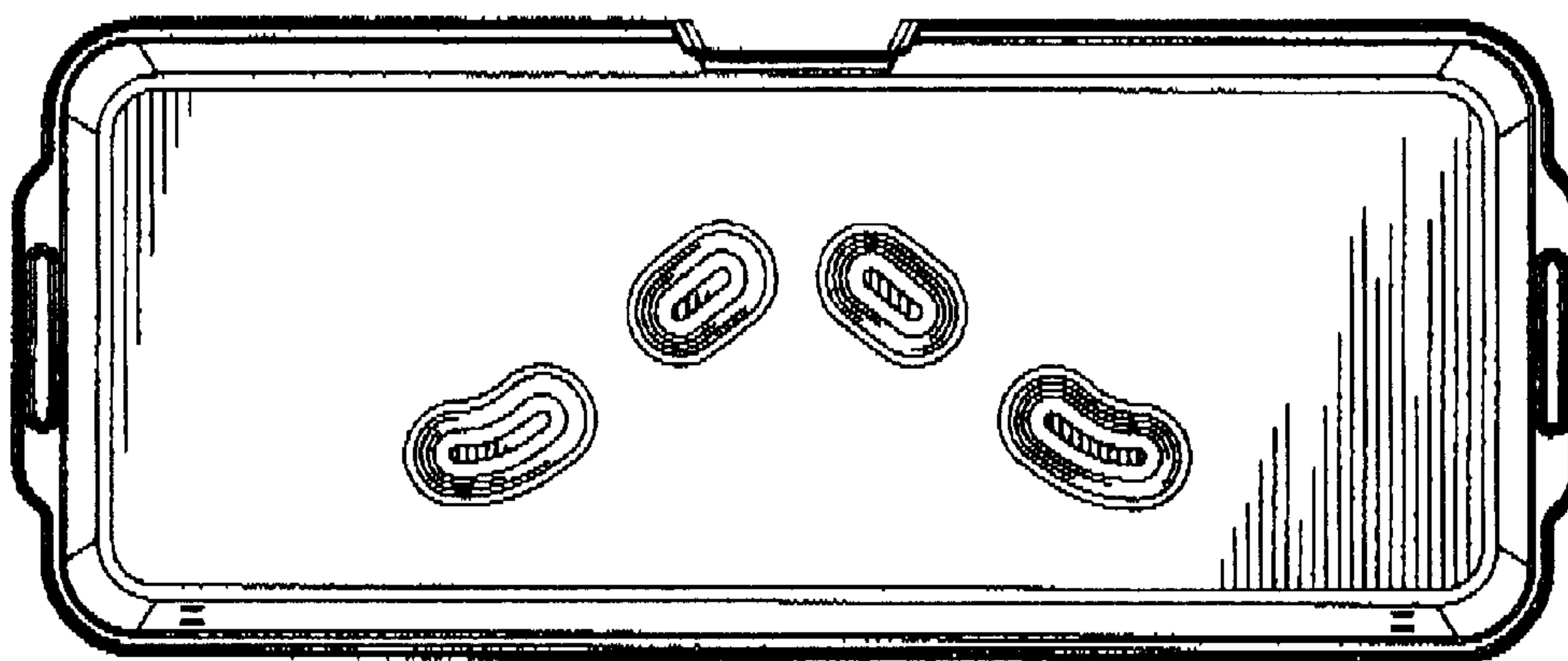

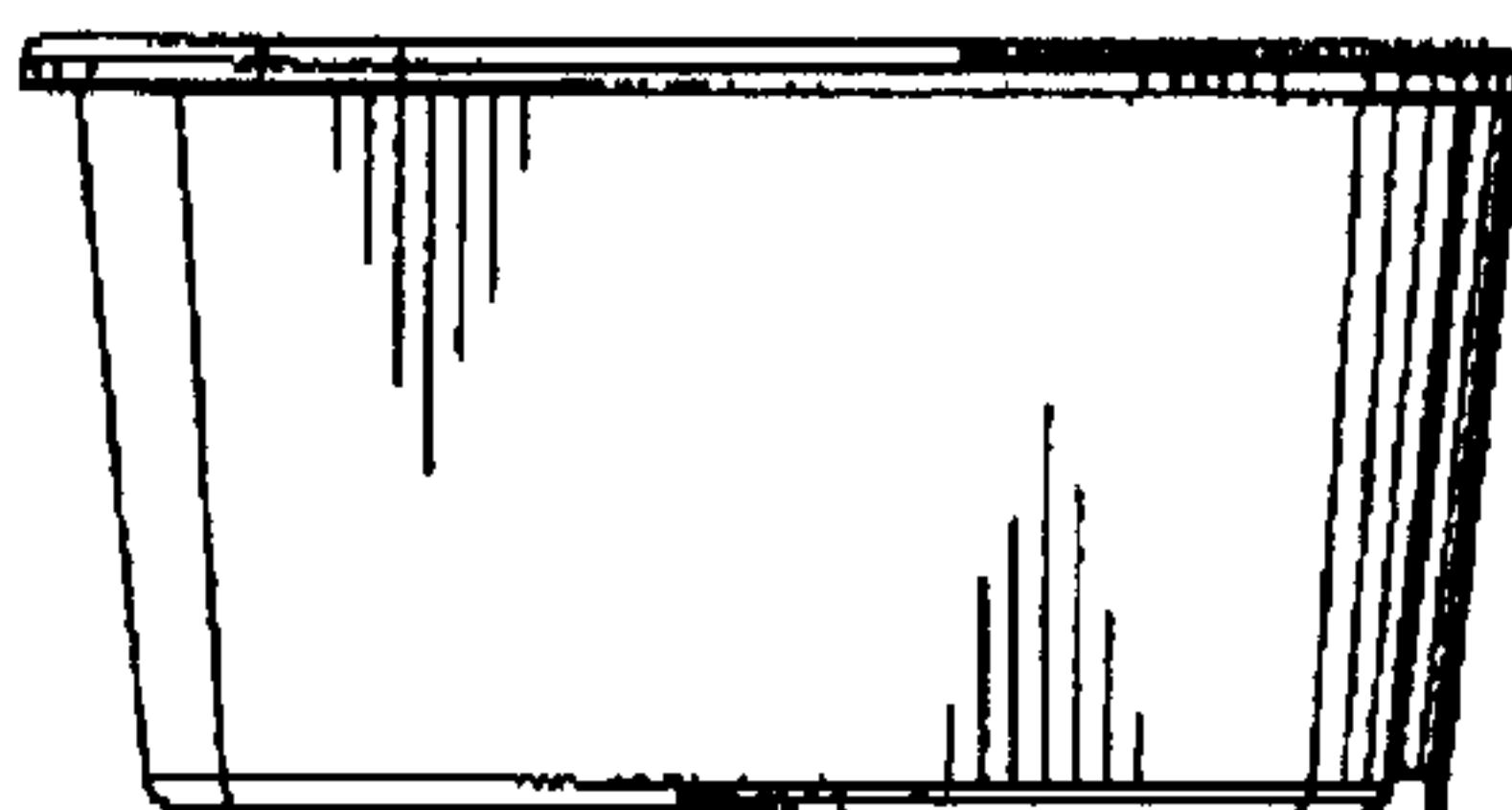

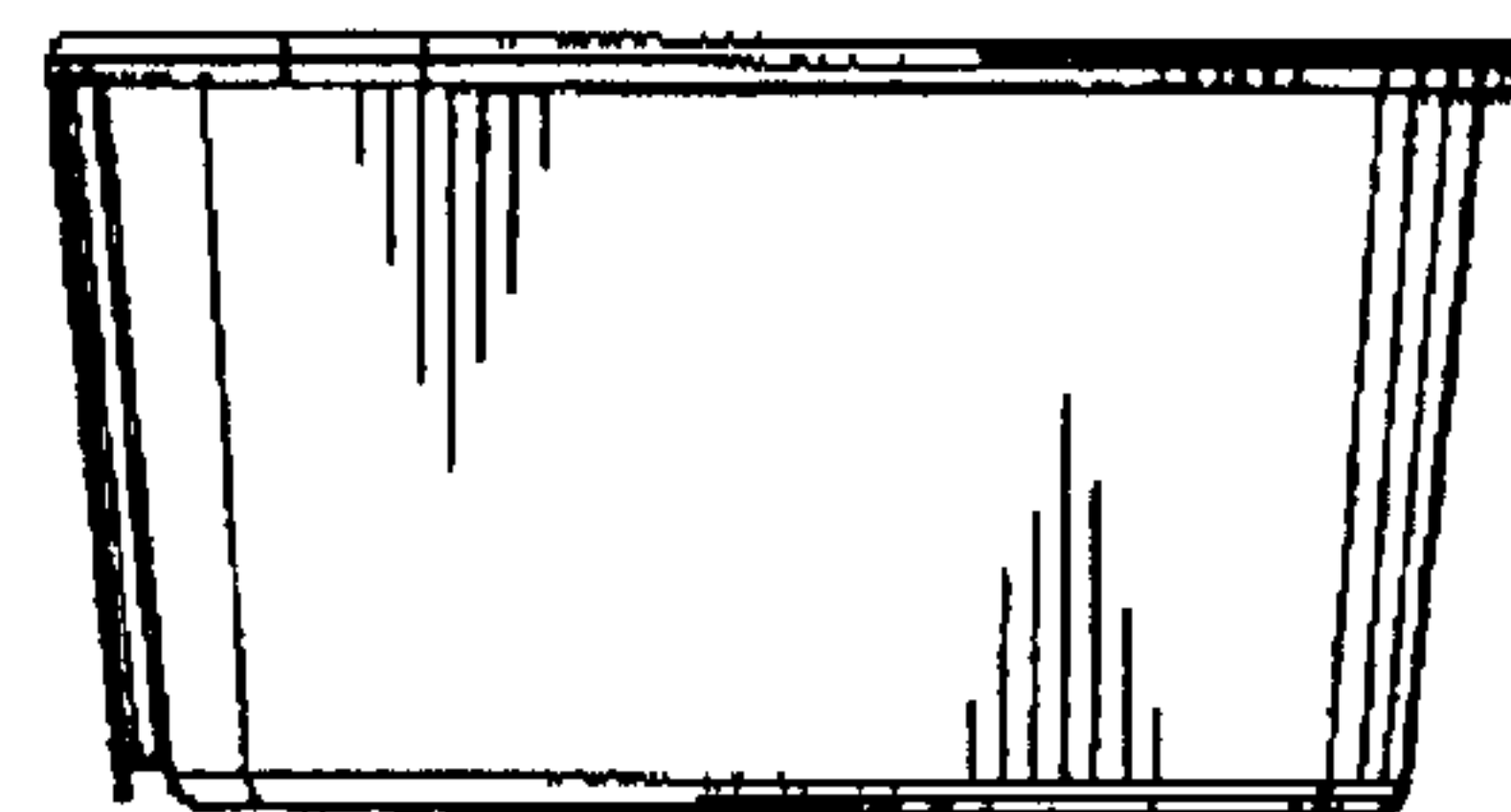

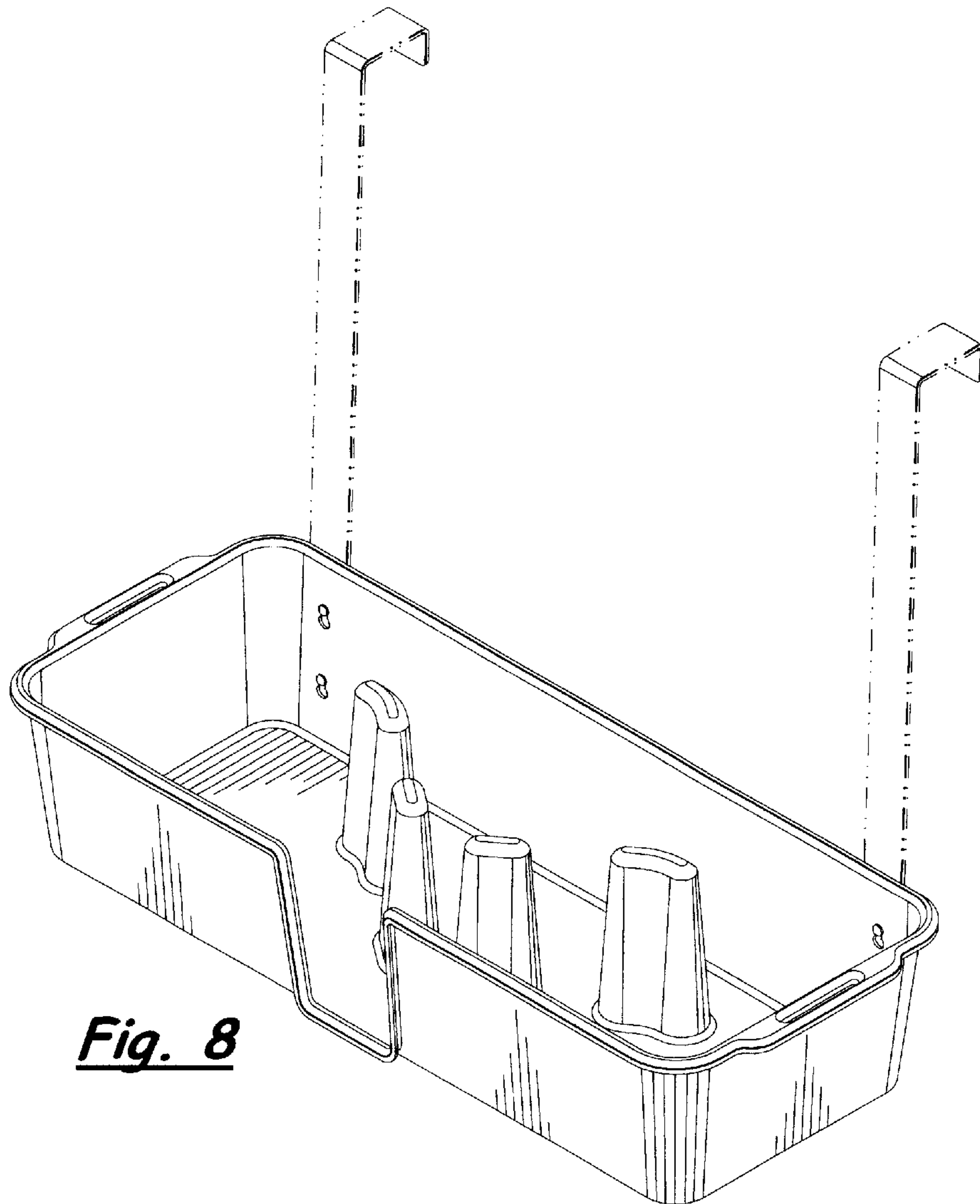

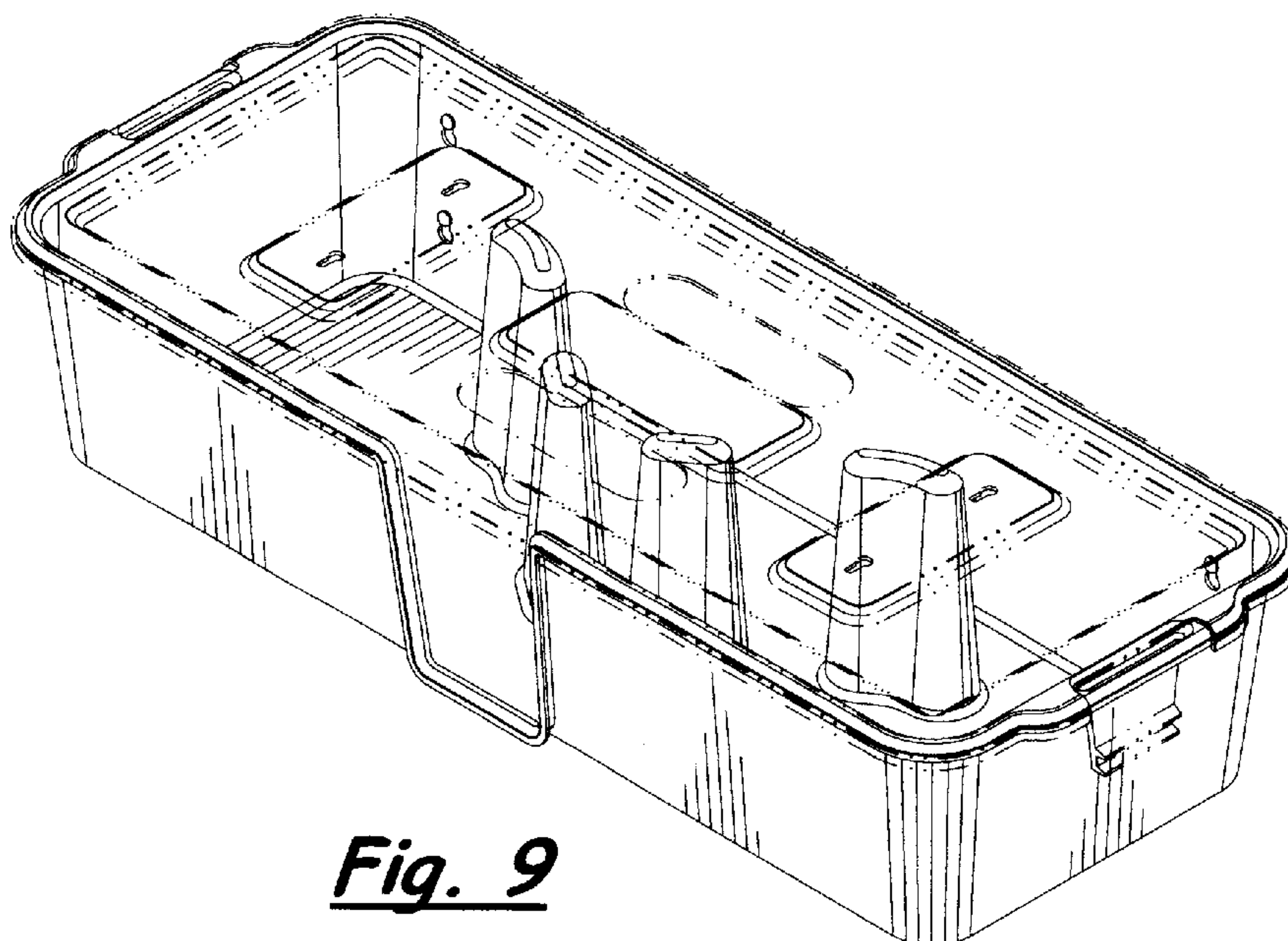
