(57) **CLAIM**

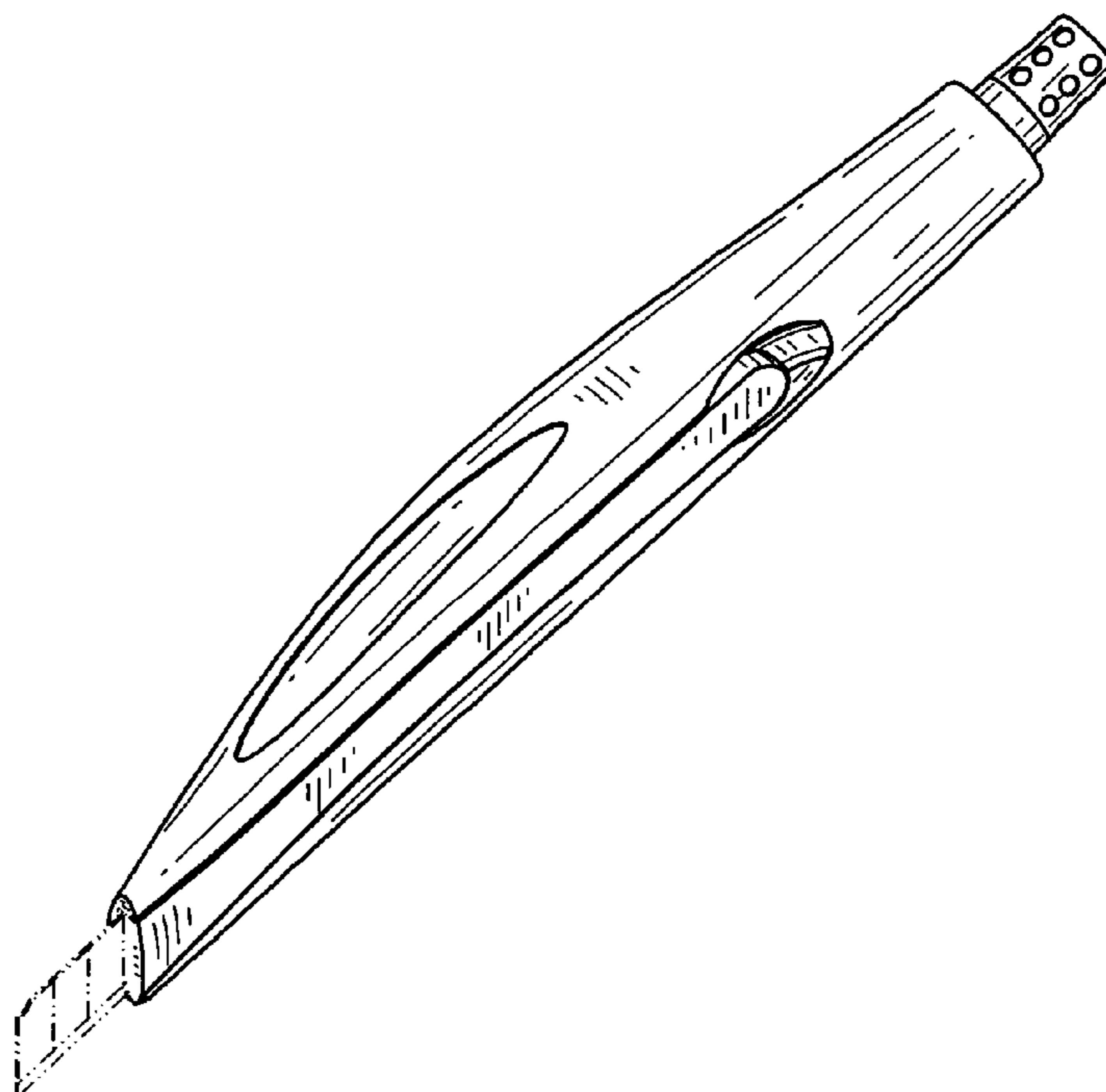
We claim the ornamental design for a utility knife, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a utility knife showing our new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a front view thereof; and,
FIG. 7 is a back view thereof.

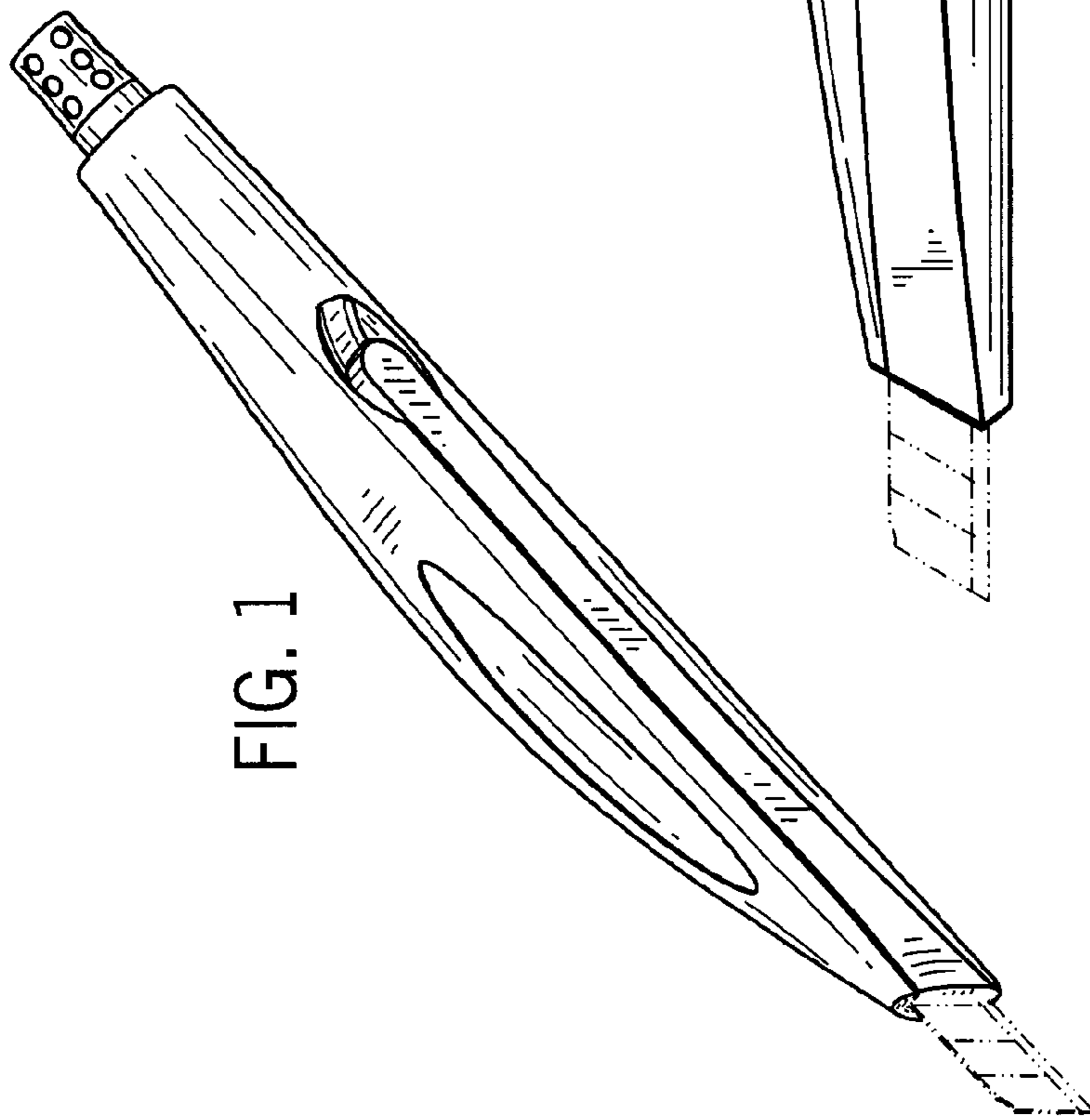

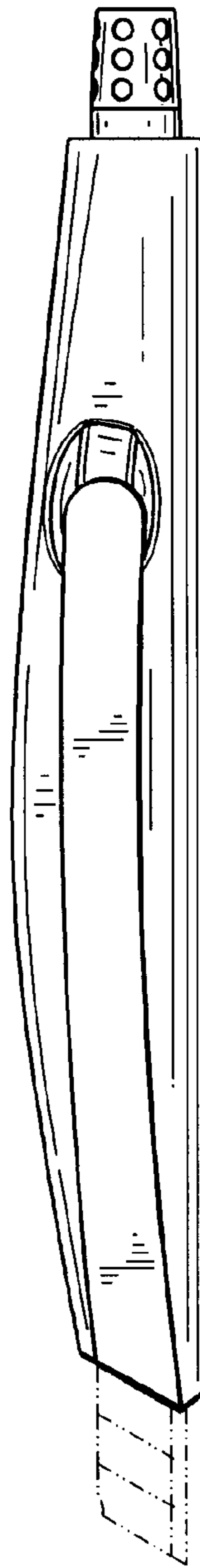

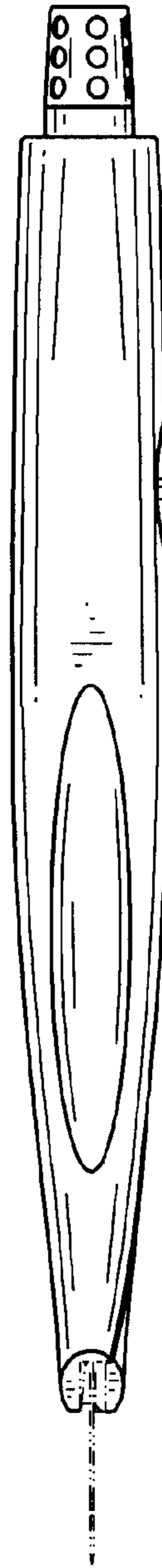

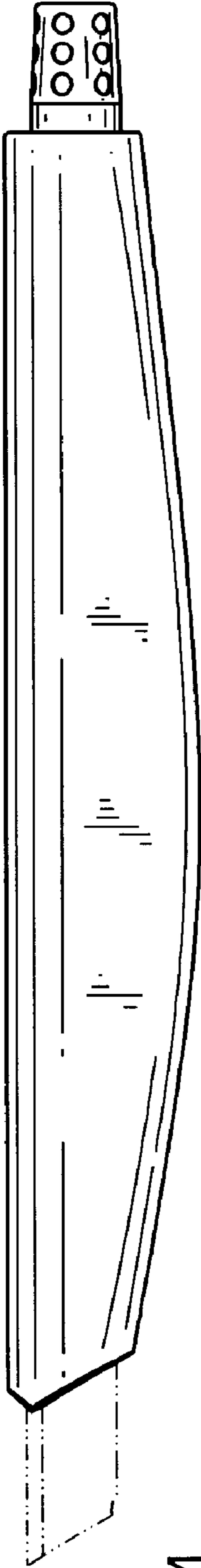

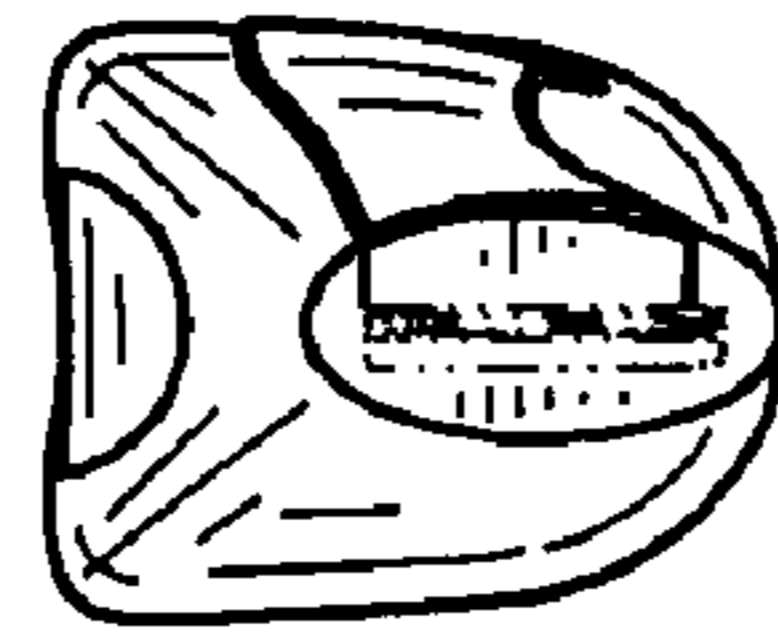

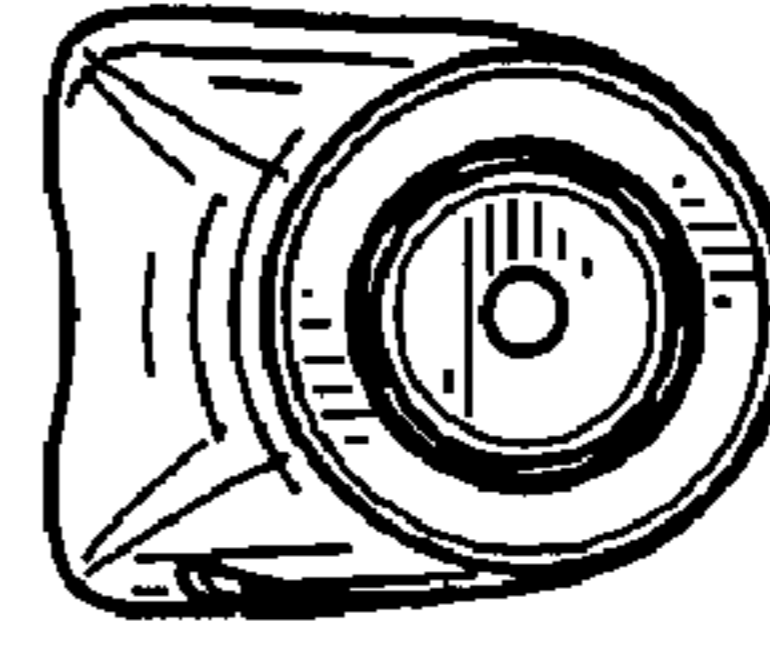
