(57) **CLAIM**

The ornamental design for latch furniture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front left side of latch furniture showing our new design, the latch furniture being illustrated in the latched position;

FIG. 2 is a perspective view similar to FIG. 1 but illustrating latch furniture in the release position;

FIG. 3 is a top plan view of latch furniture of FIG. 1, illustrating latch furniture in the latched position;

FIG. 4 is a top plan view similar to FIG. 3 but illustrating latch furniture in the release position;

FIG. 5 is a front elevation of latch furniture of FIG. 1 as seen from the bottom of FIG. 3;

FIG. 6 is a side elevation from the left of FIG. 3, illustrating latch furniture in the latched position;

FIG. 7 is a side elevation similar to FIG. 6 but illustrating latch furniture in the release position;

FIG. 8 is a side elevation from the right of FIG. 3, illustrating latch furniture in the latched position;

FIG. 9 is a side elevation similar to FIG. 8 but illustrating latch furniture in the release position;

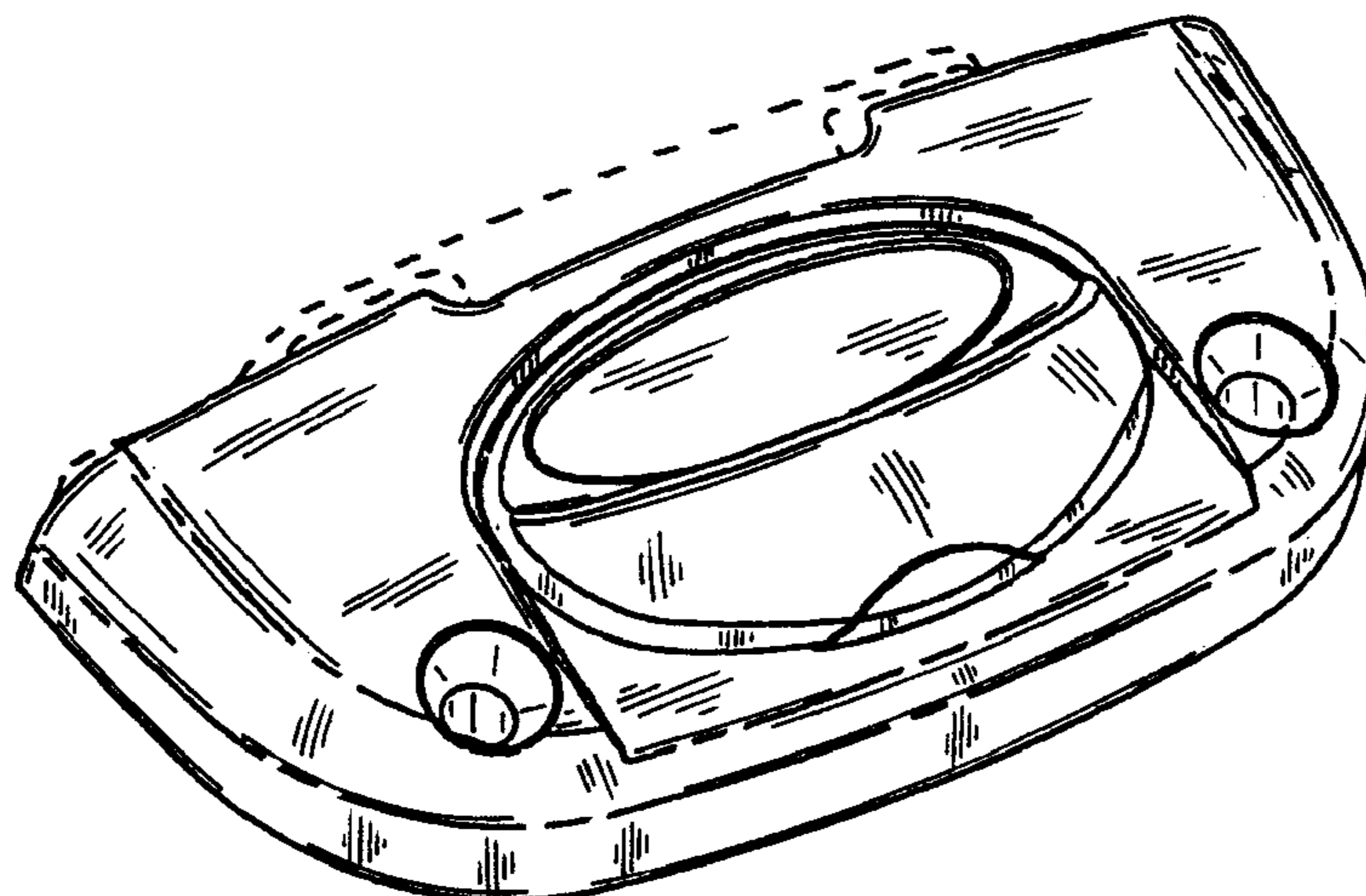
FIG. 10 is a rear elevation of latch furniture as seen from above in FIG. 3;

FIG. 11 is a bottom plan view of latch furniture of FIG. 1, illustrating latch furniture in the latched position; and,

FIG. 12 is a bottom plan view similar to FIG. 11 but illustrating latch furniture in the release position.

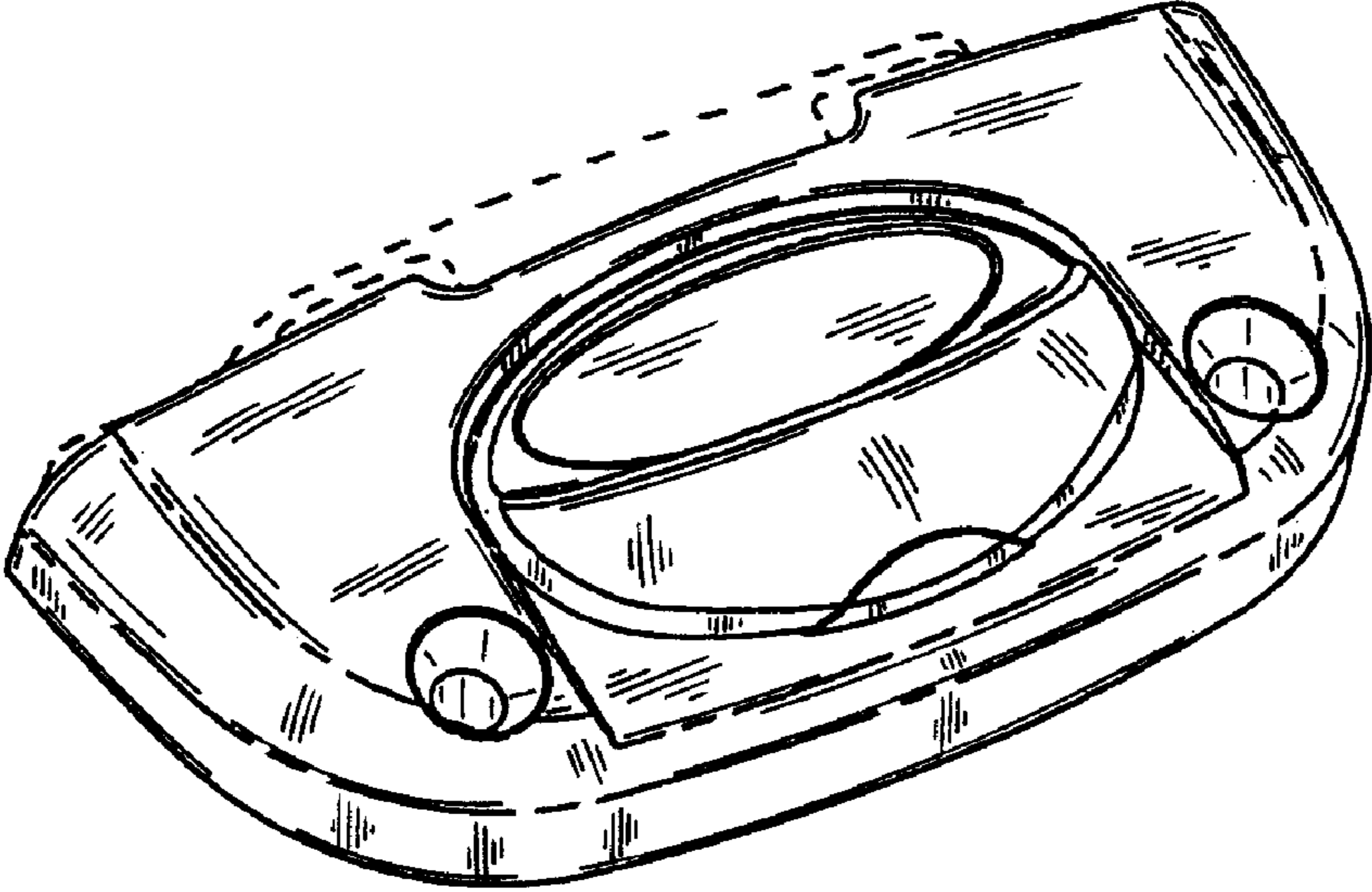

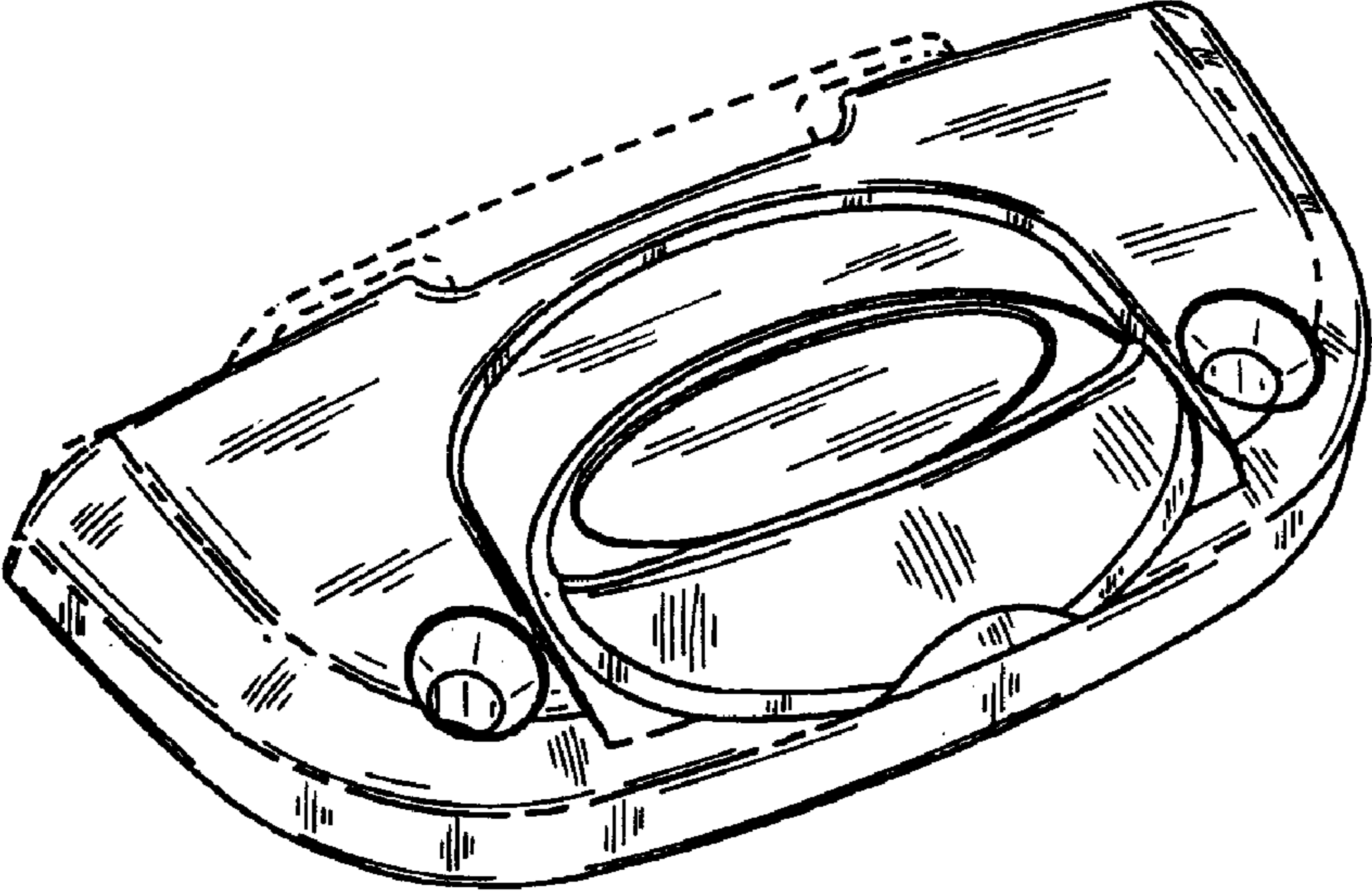

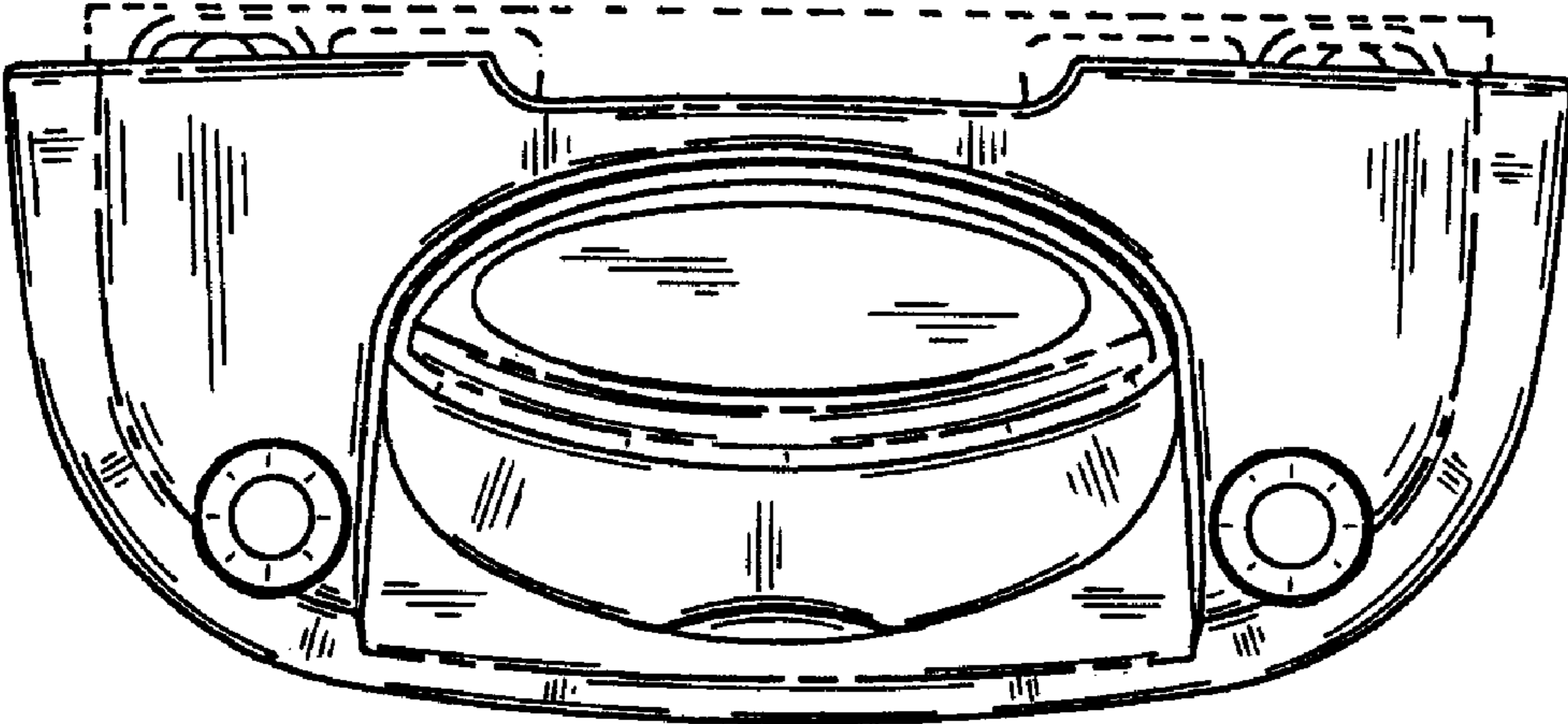

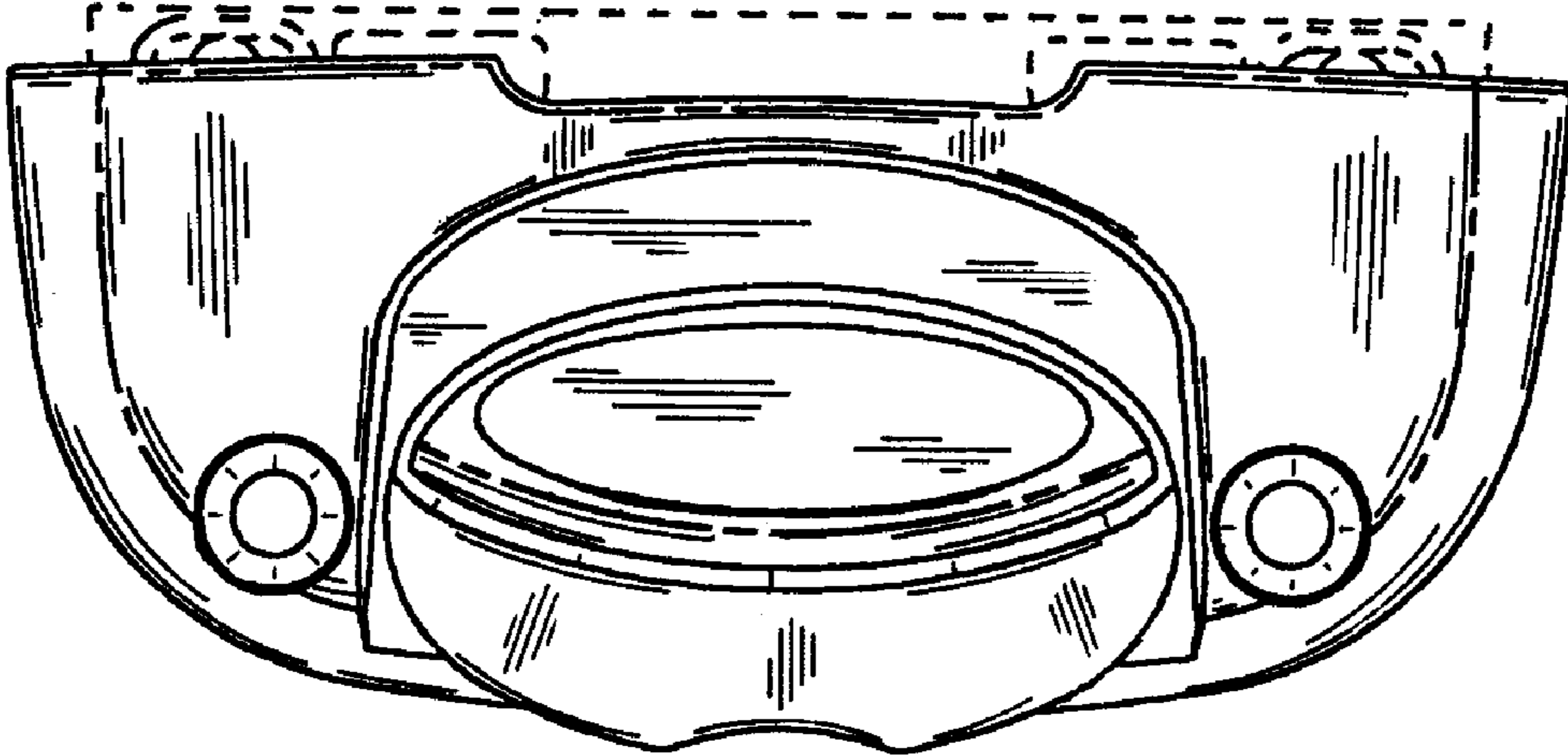

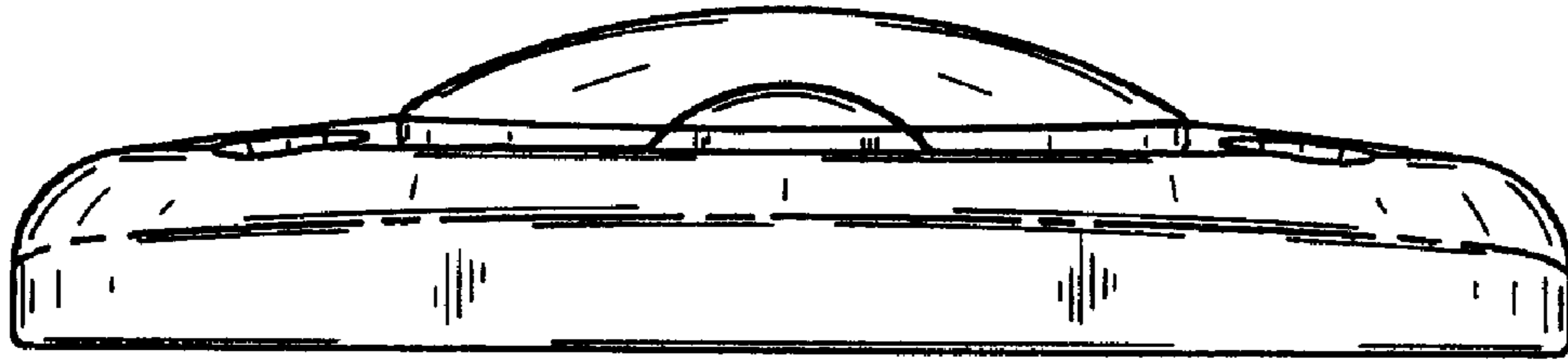

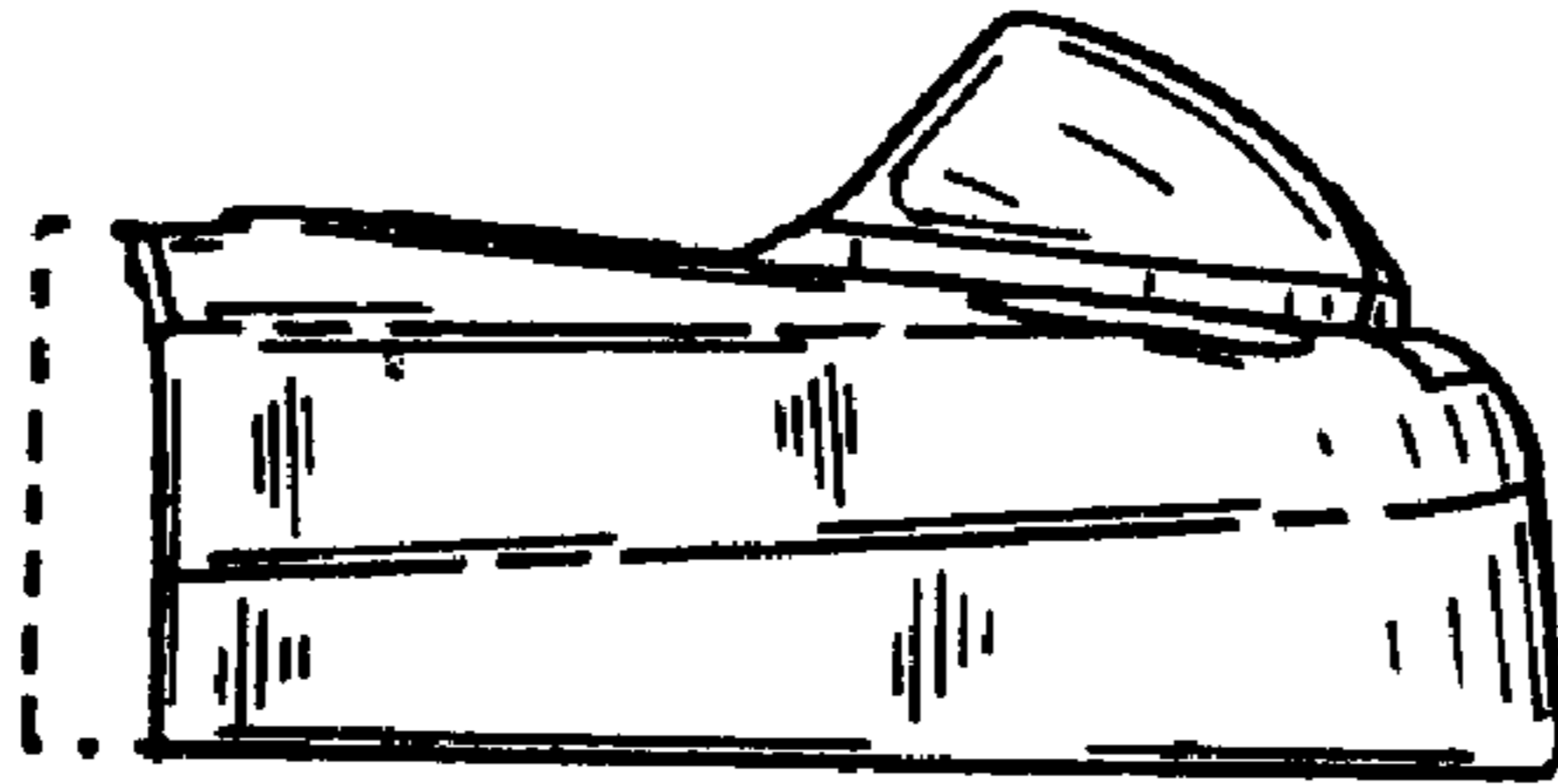

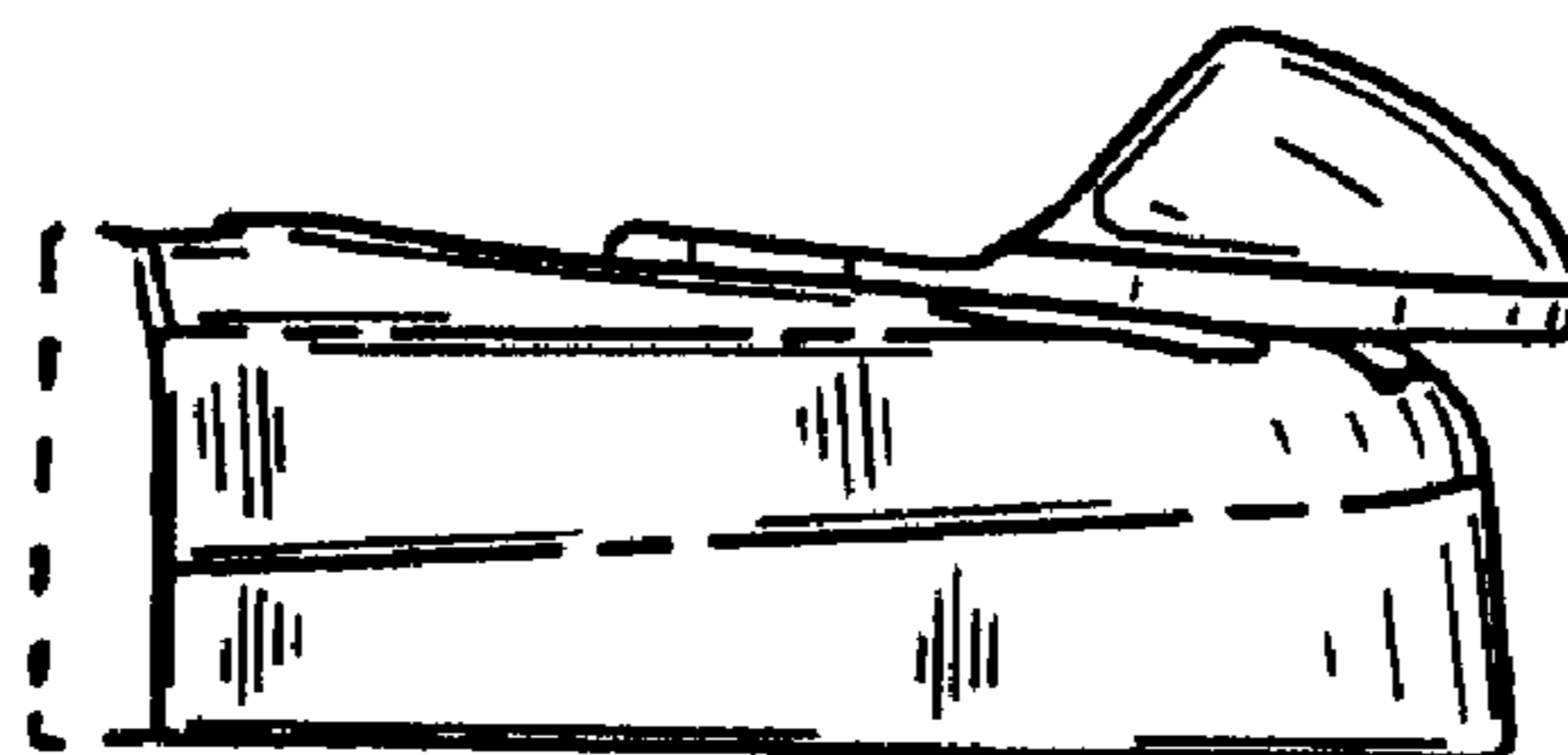

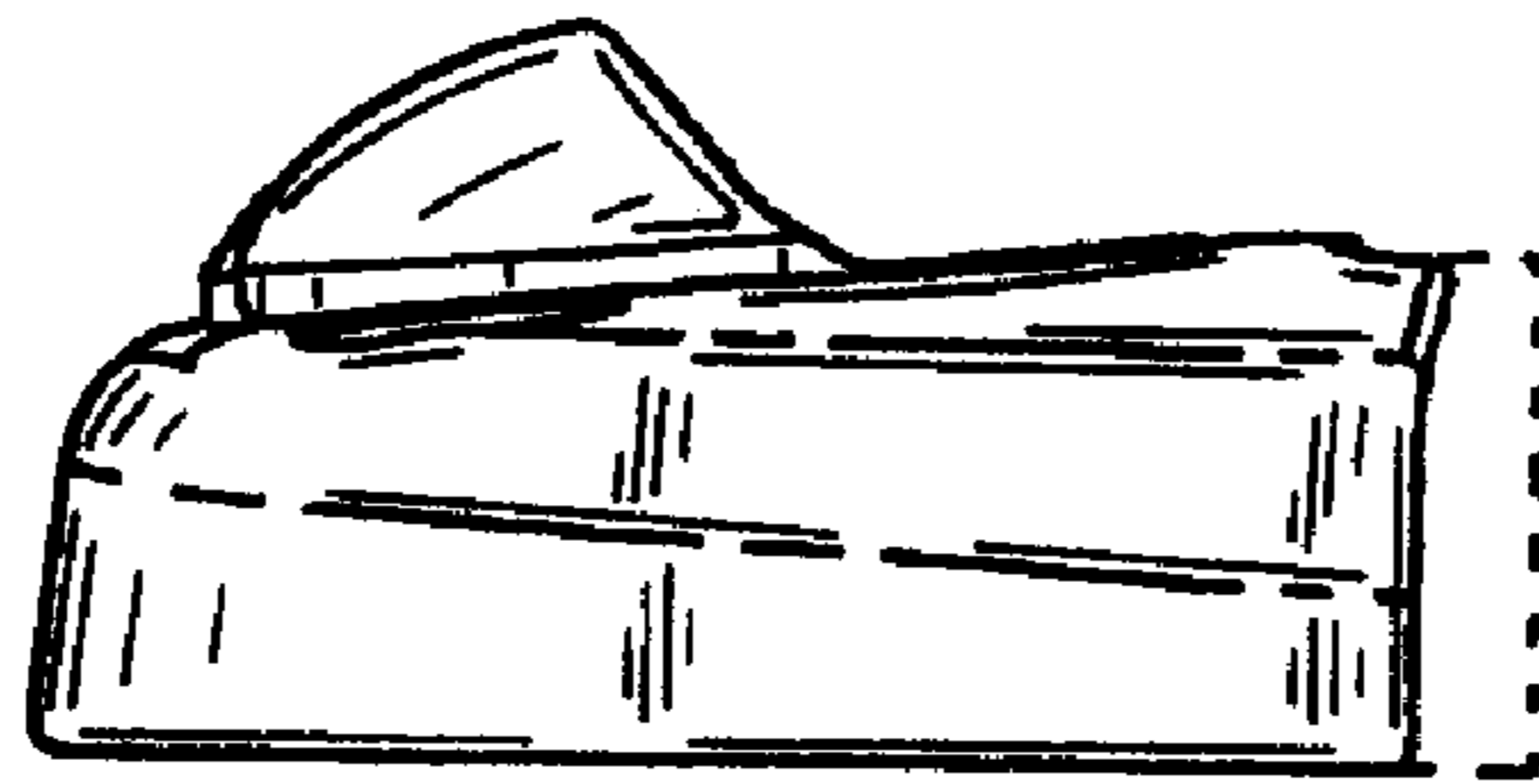

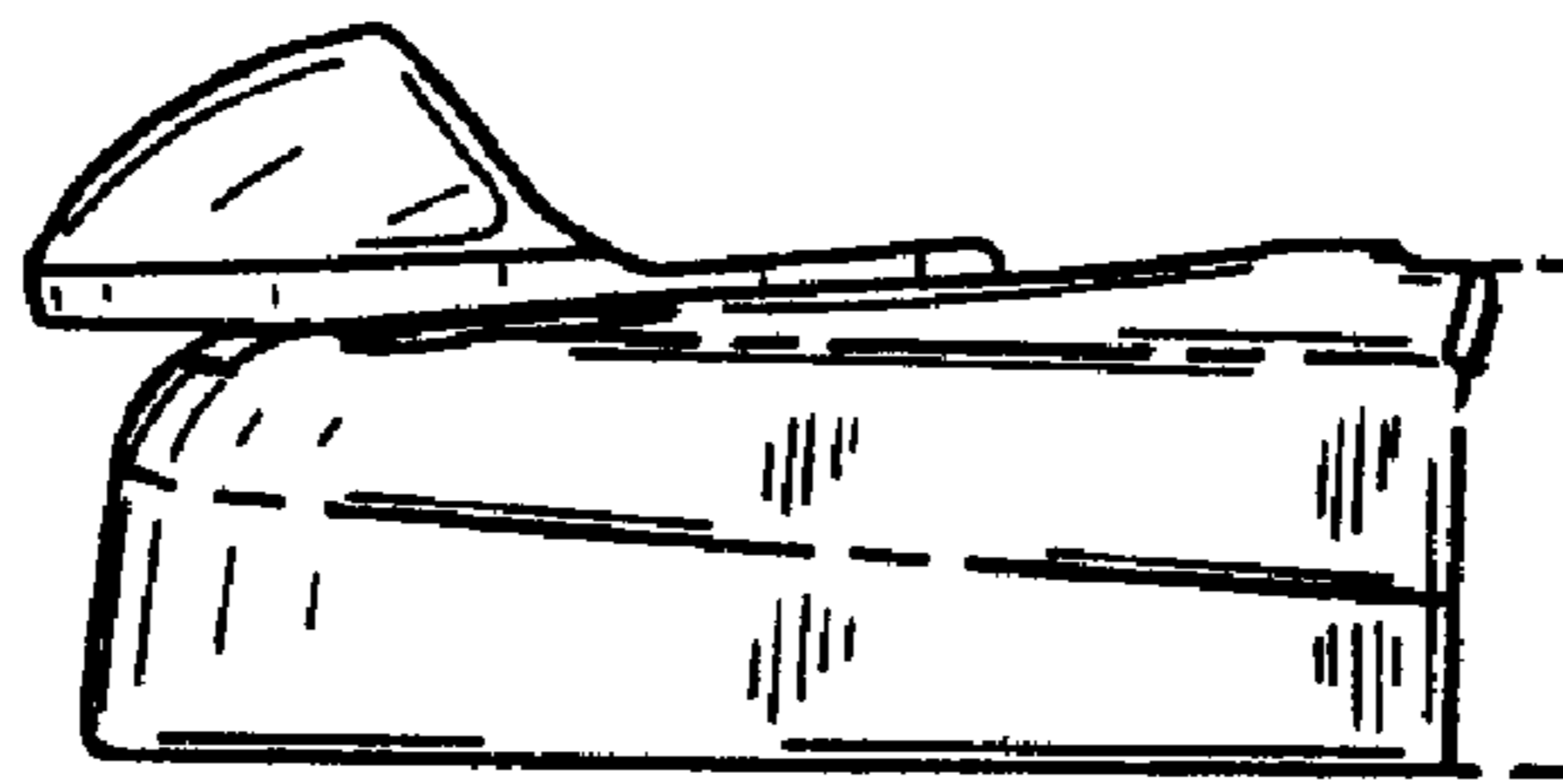

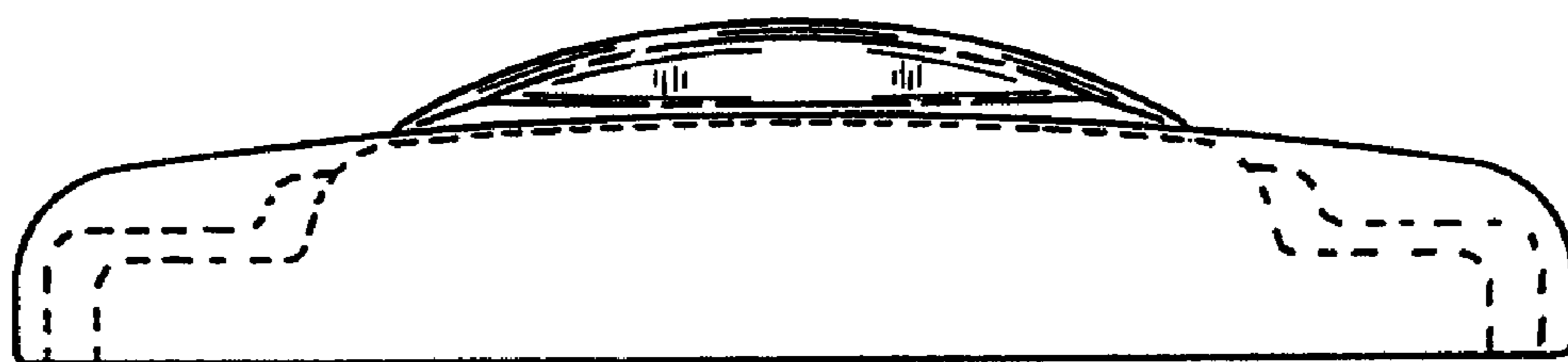

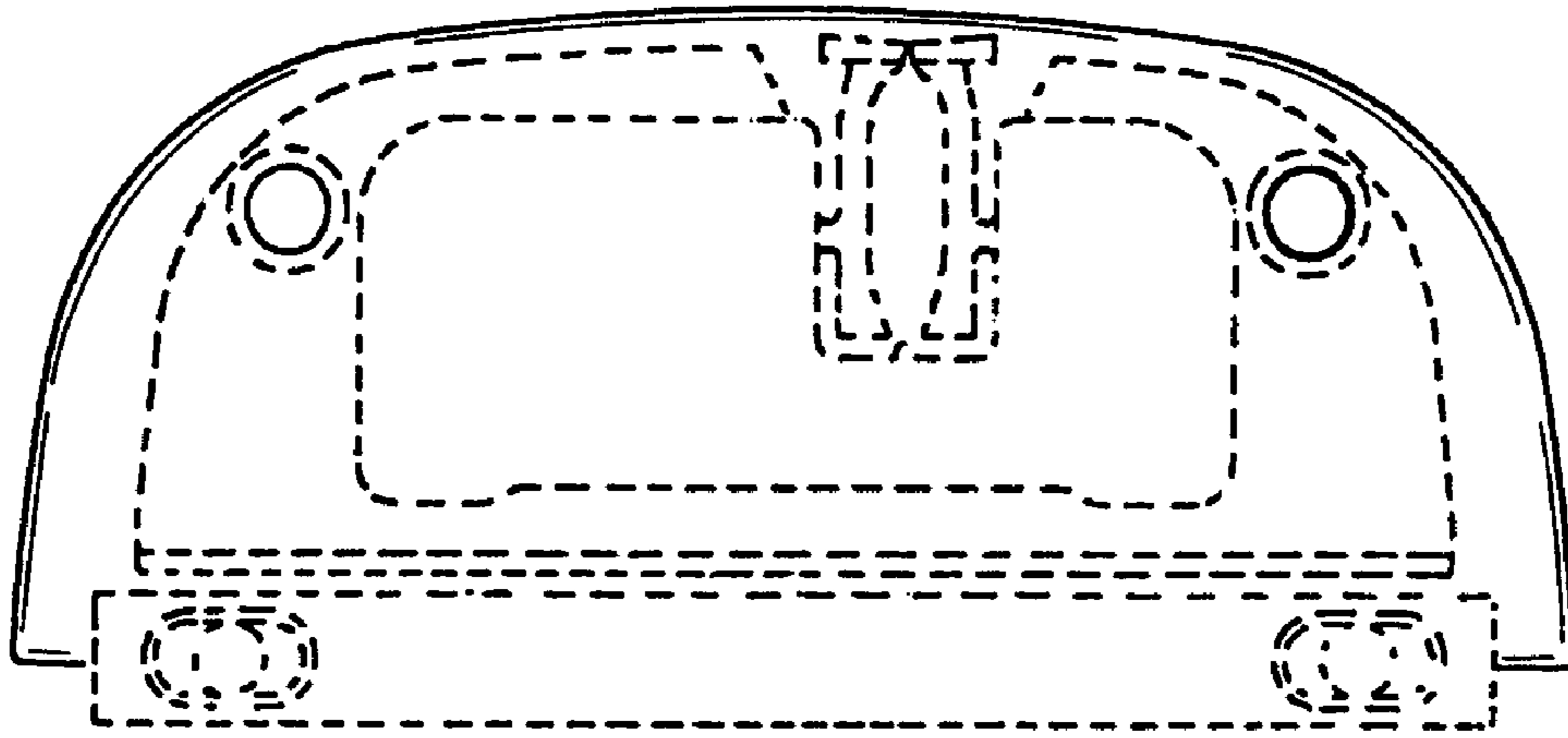

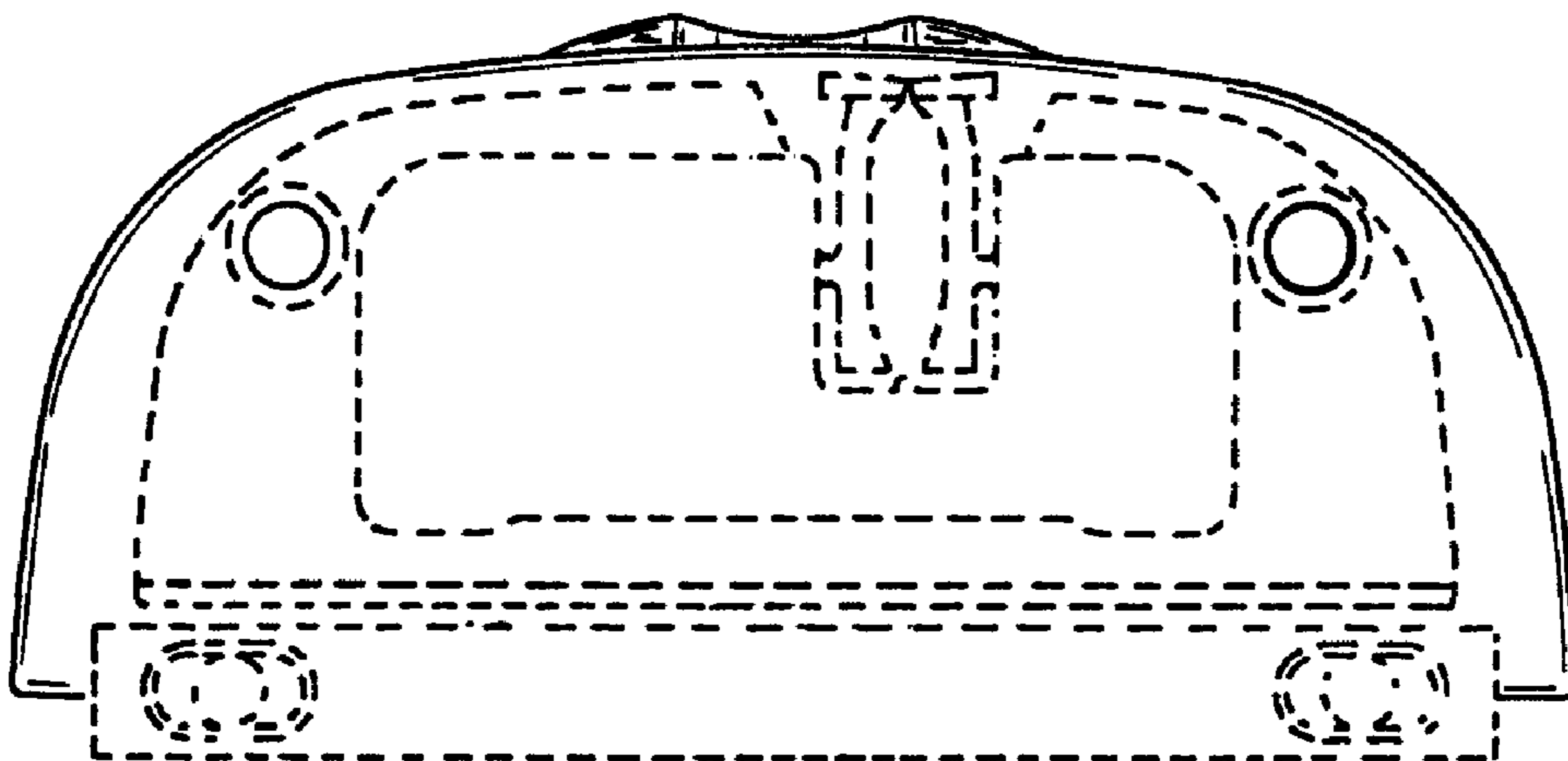
