(57) **CLAIM**

The ornamental design of a hand held, battery powered
sprayer, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view showing the top, one side and
portions of the back of my design for a hand held, battery
powered sprayer.

FIG. 3 is a right side elevational view of my design.

FIG. 5 is a rear elevational view of my design.

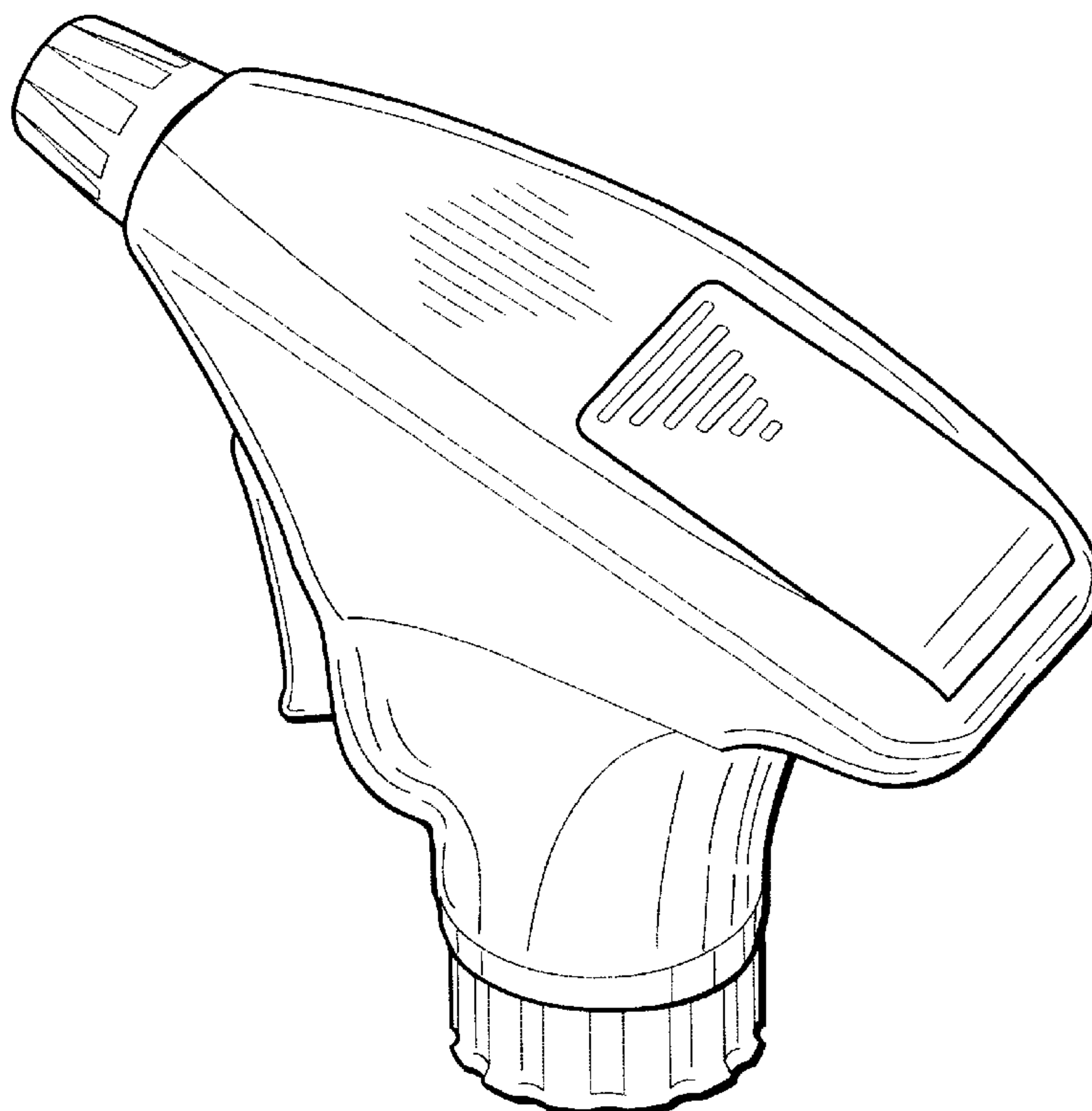
FIG. 6 is a top plan view of my design.

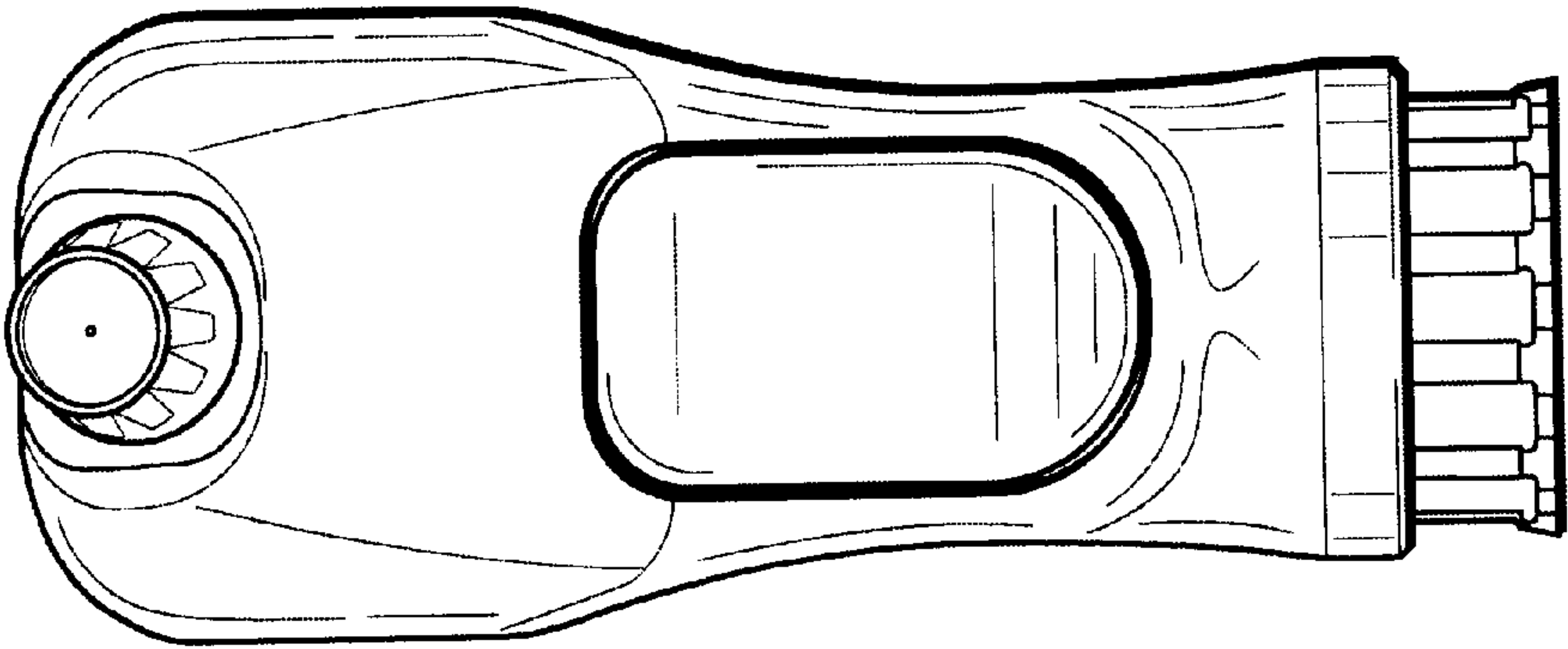

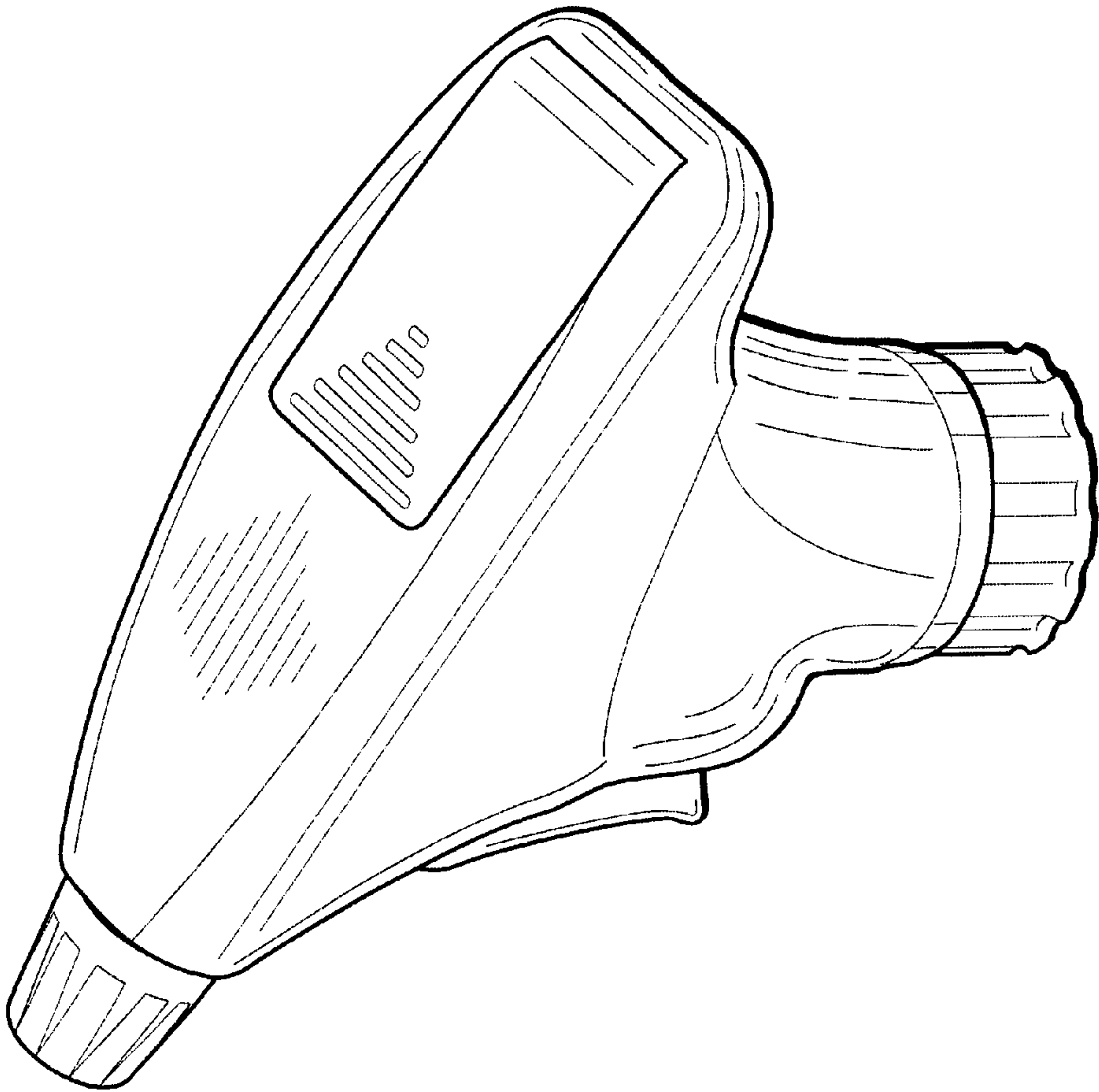

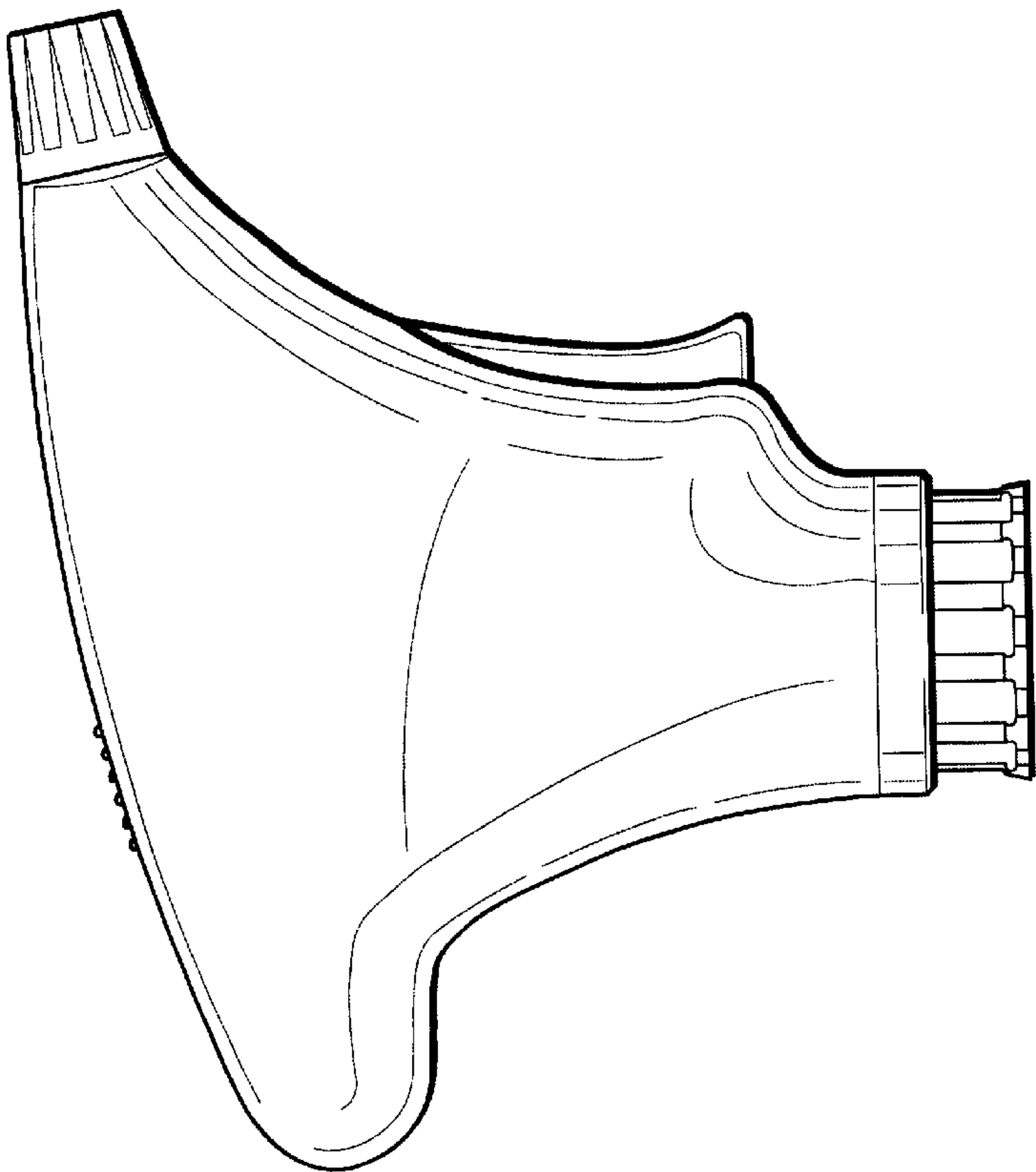

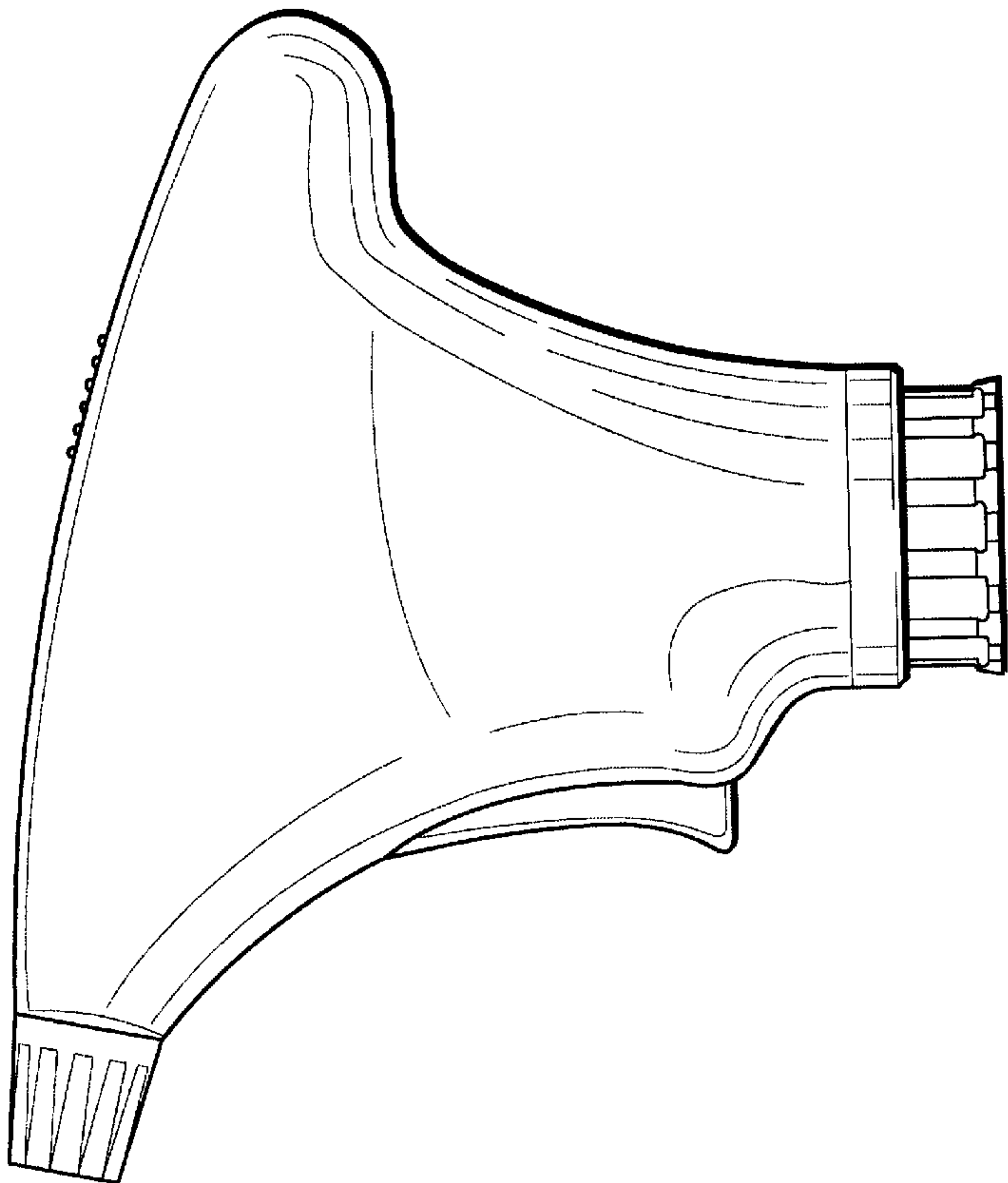

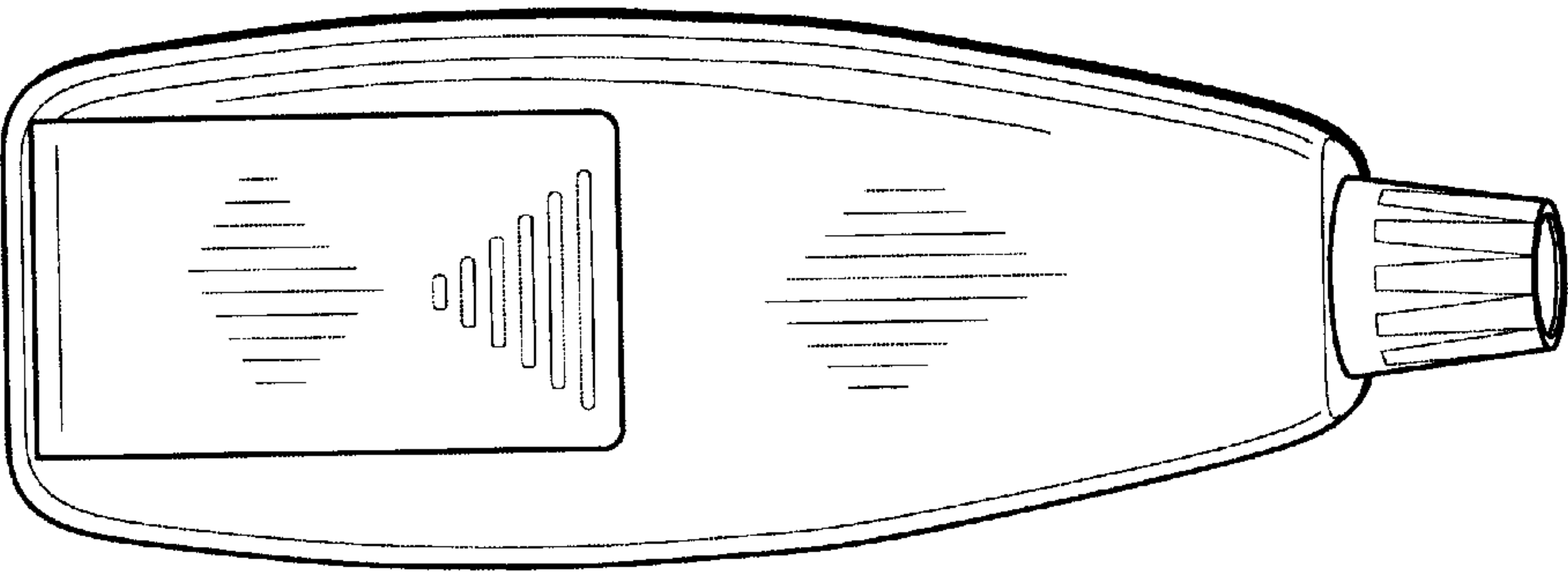

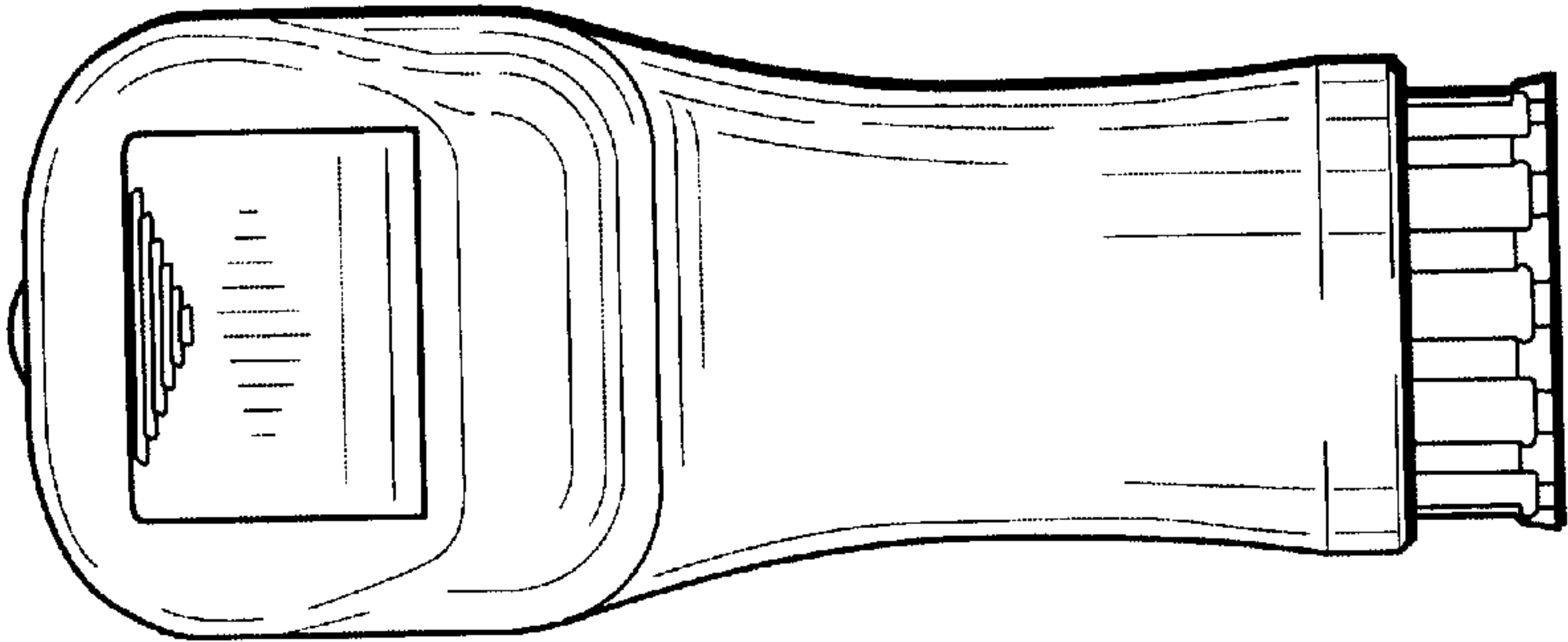

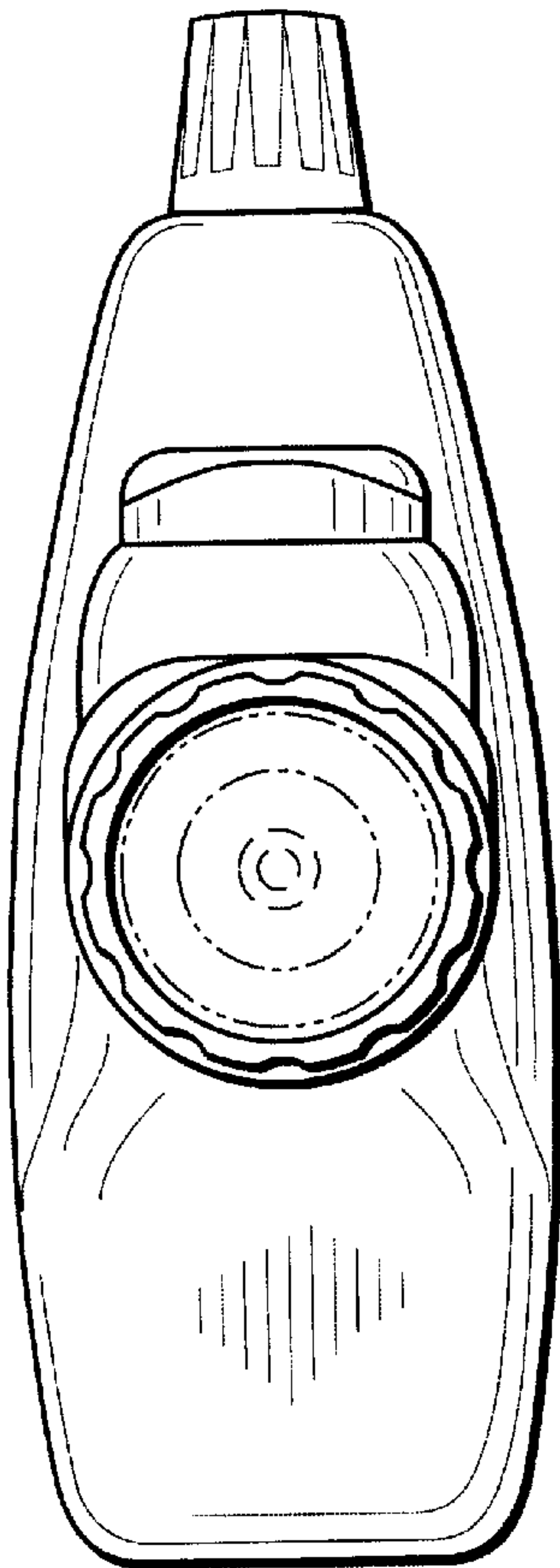

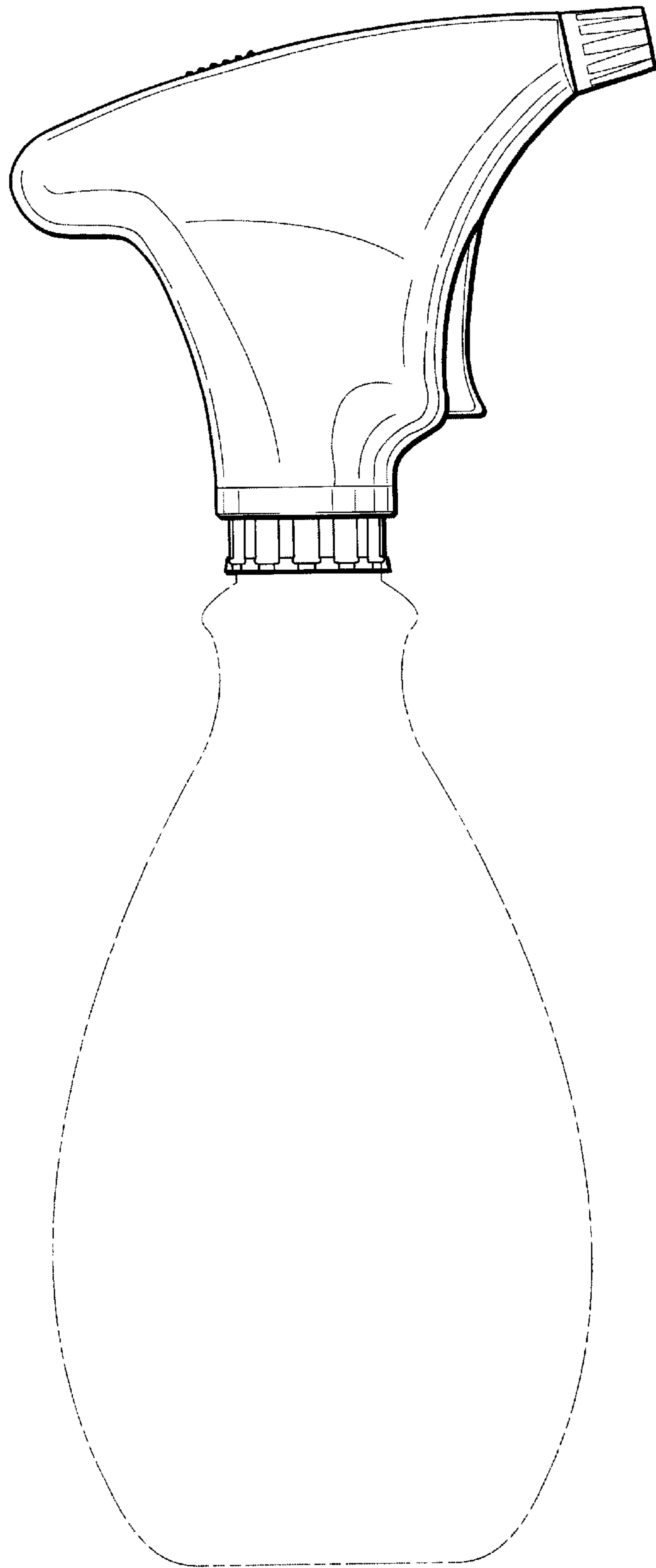
