The design is characterized by the gold color of the tip of the thermometer.

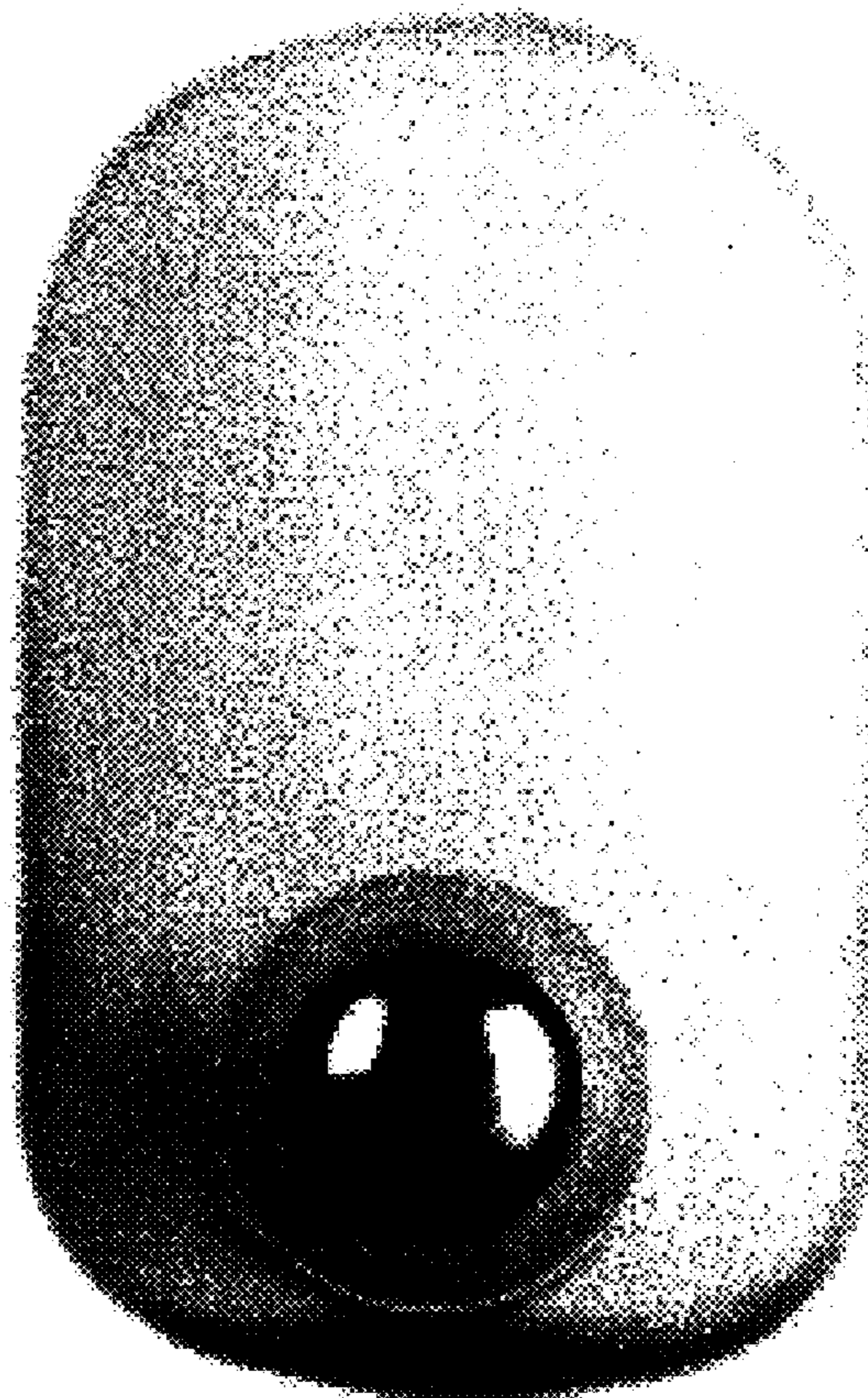

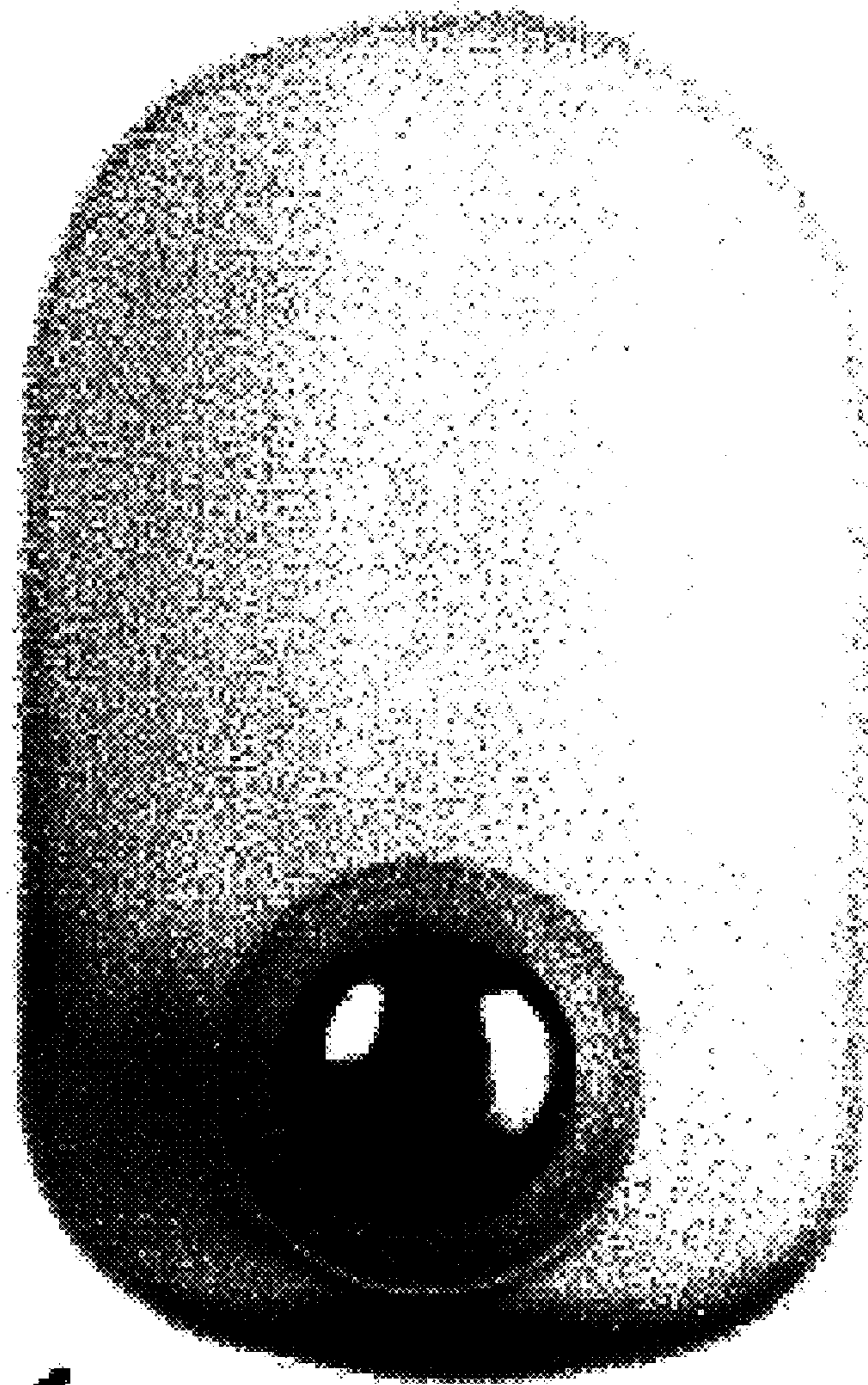

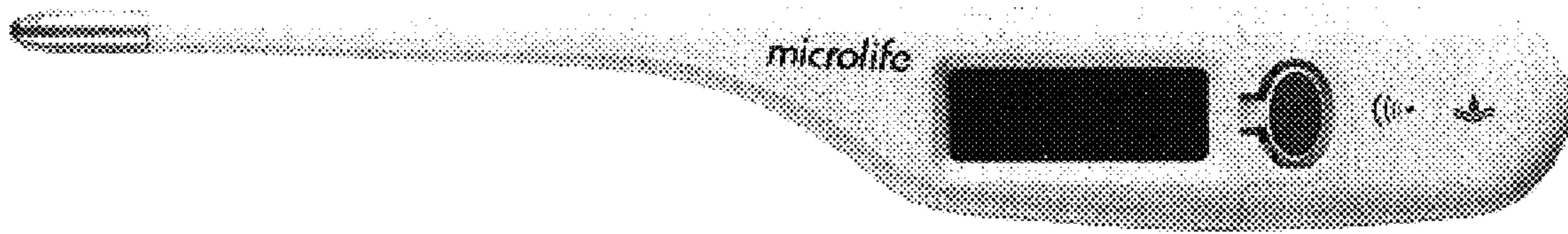

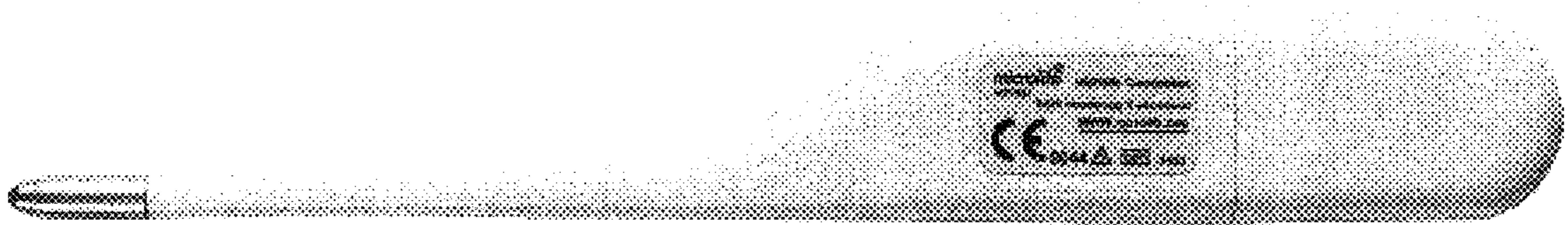

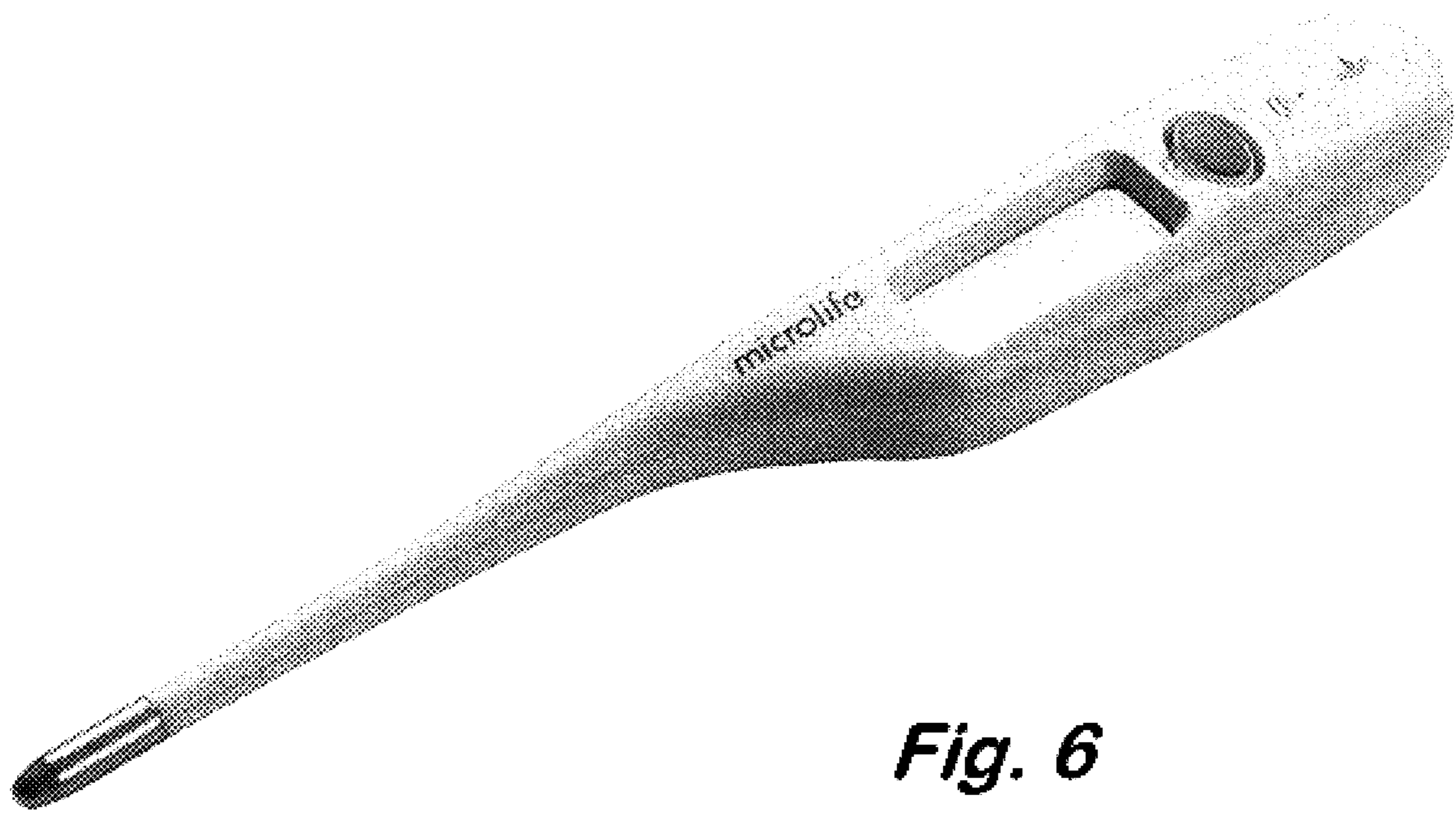

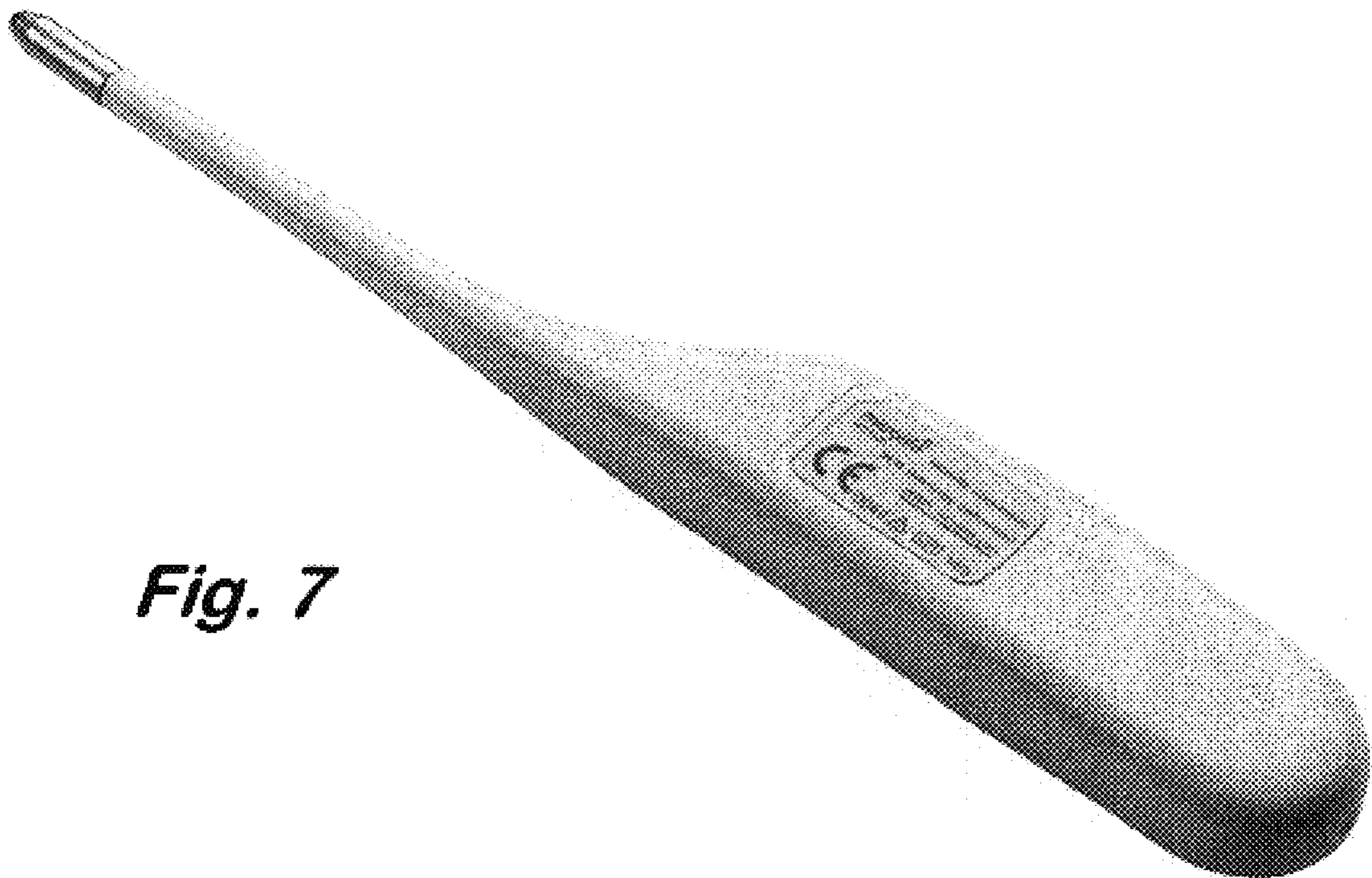
