(57) **CLAIM**

The ornamental design for a surface configuration of a motorcycle, toy, and/or other replicas, as shown and described.

FIG. 6 is a right side view of the surface configuration of a motorcycle, toy, and/or other replicas according to our novel design;

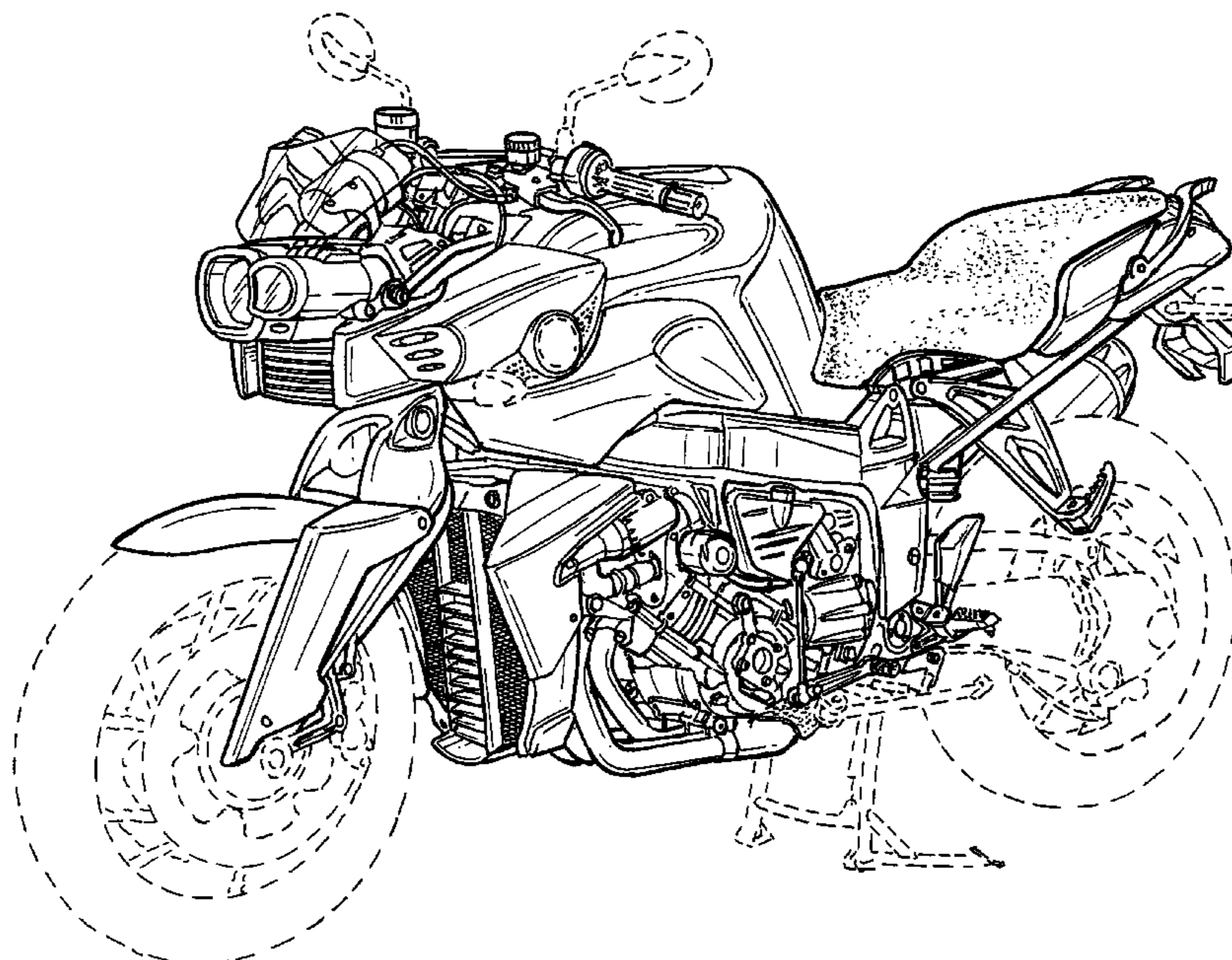
FIG. 7 is a front view of the surface configuration of a motorcycle, toy, and/or other replicas according to our novel design;

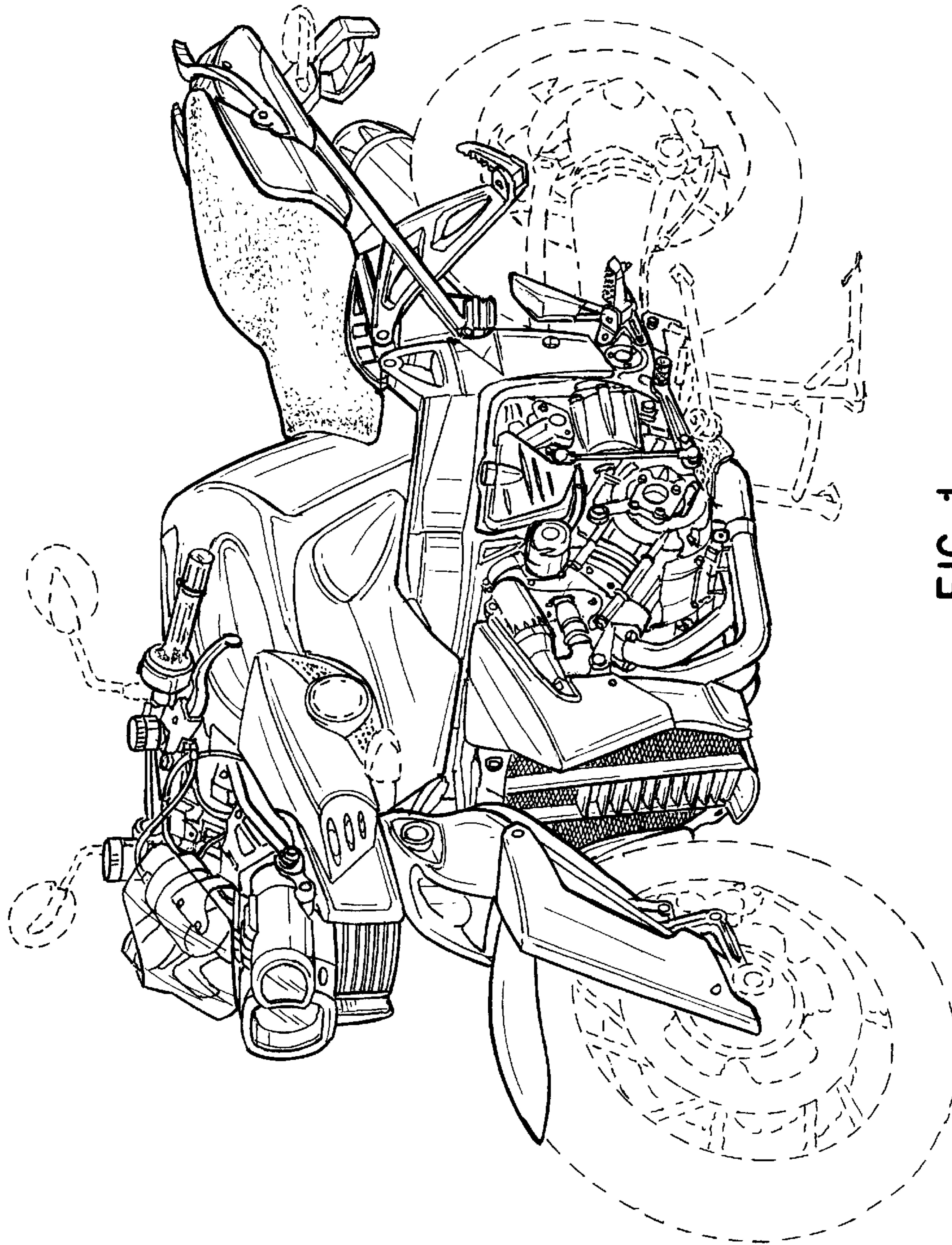

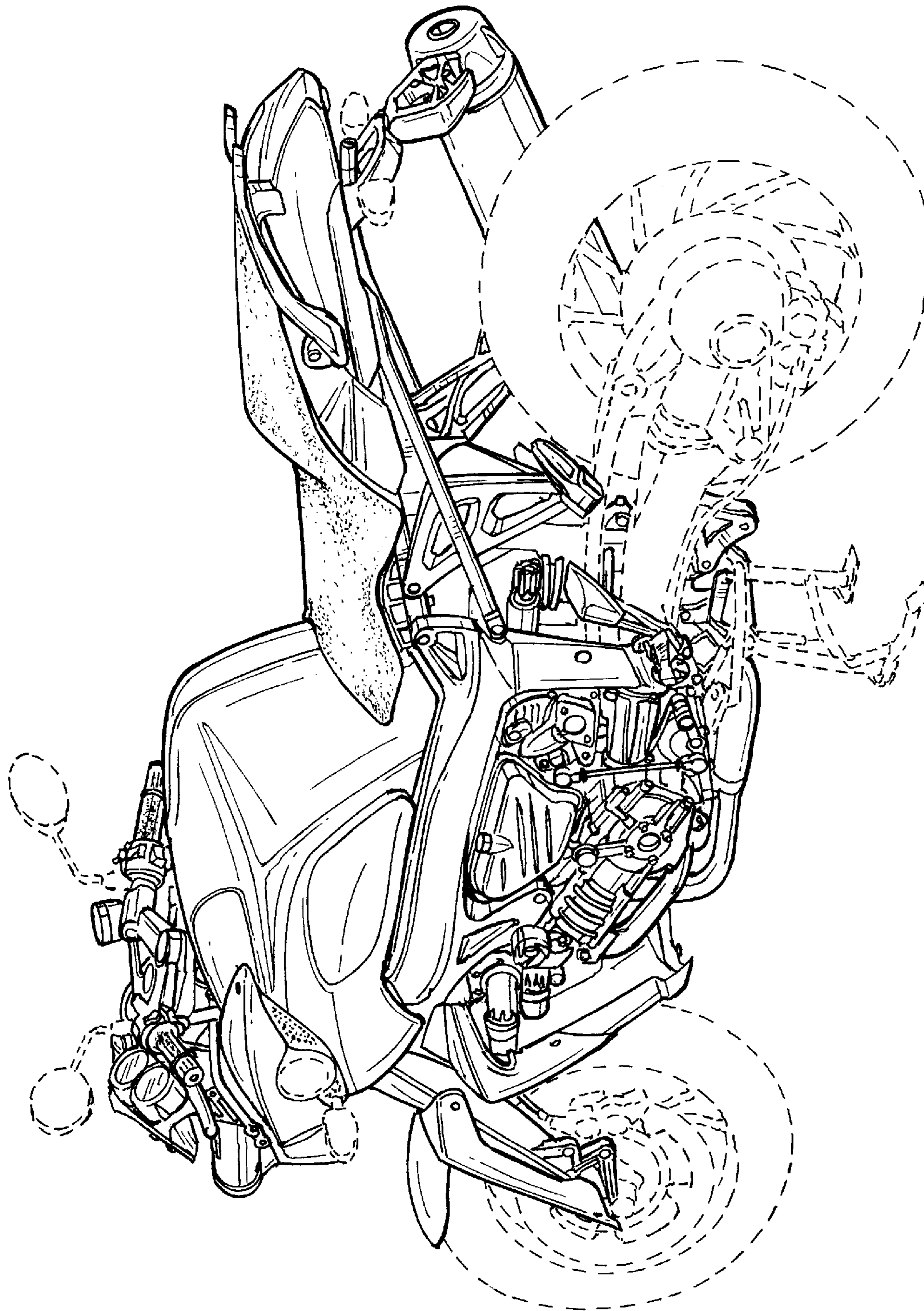

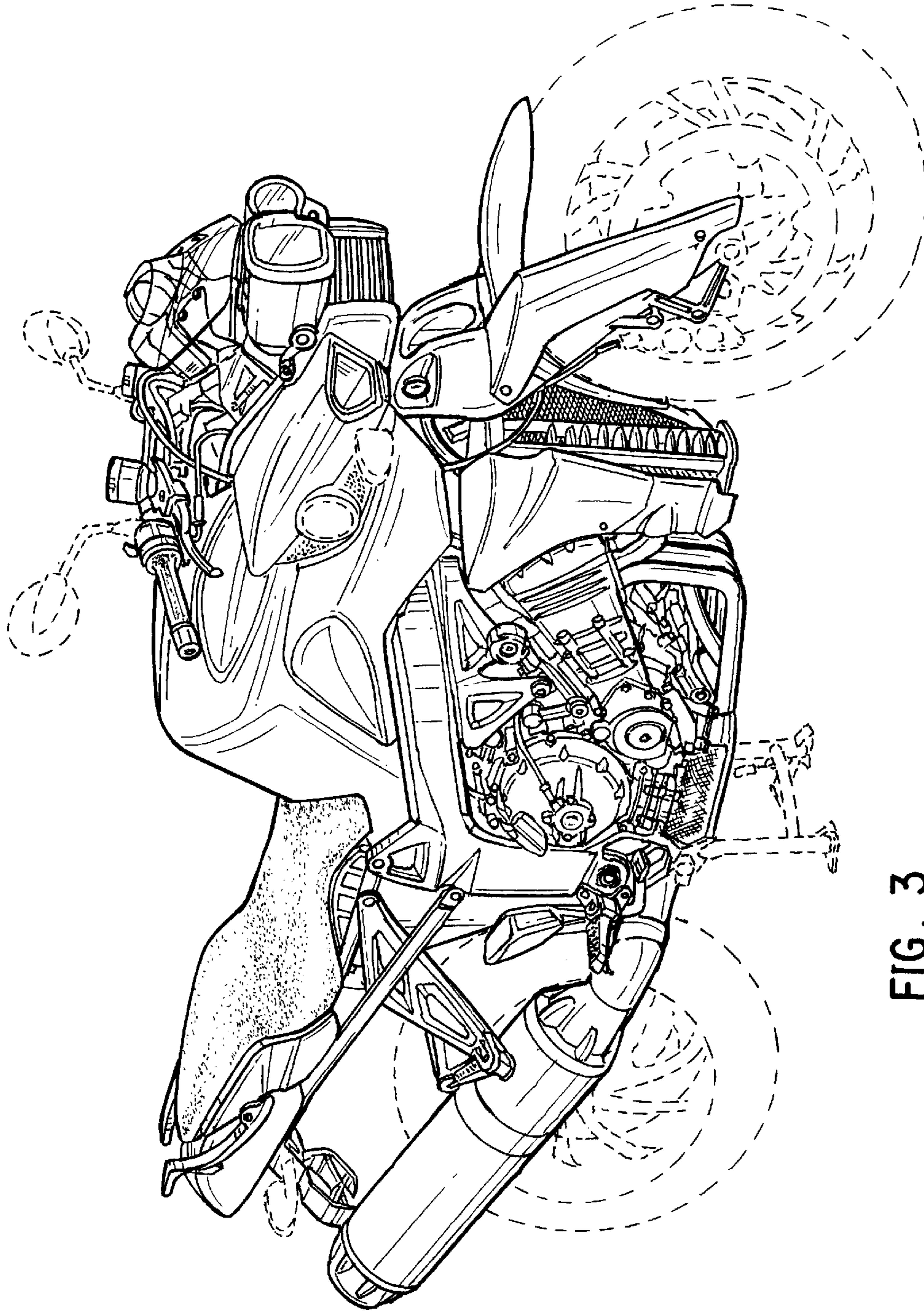

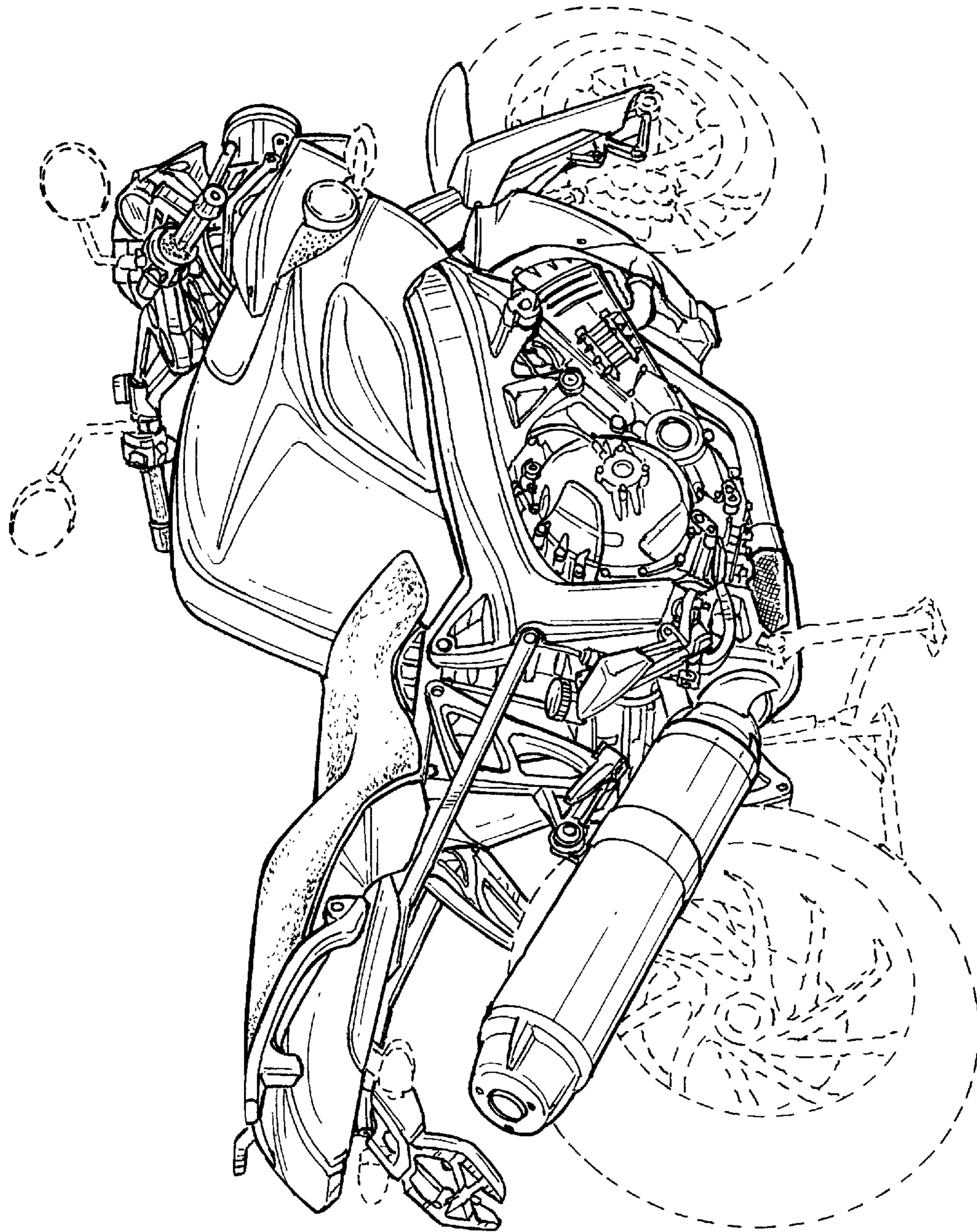

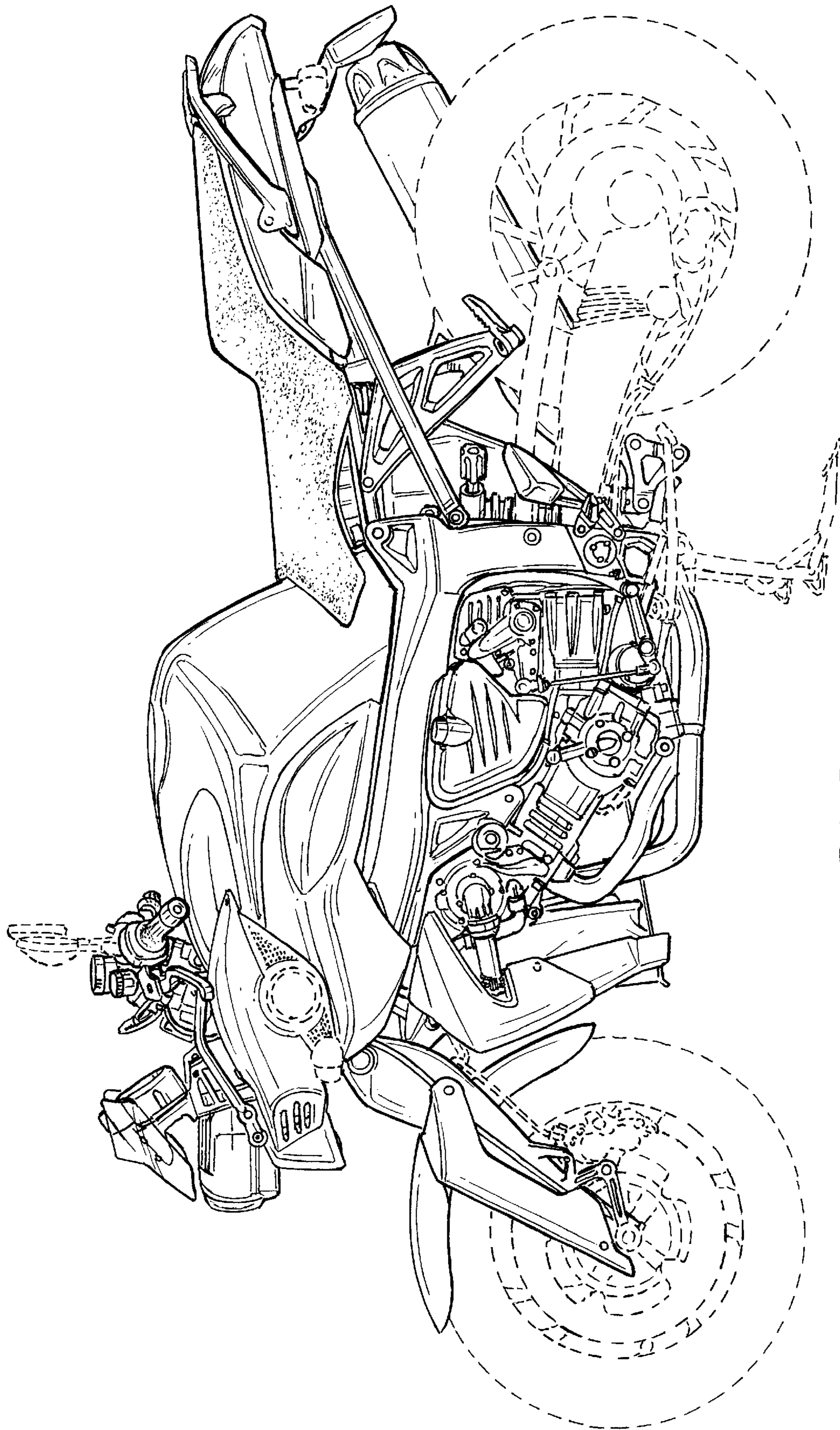

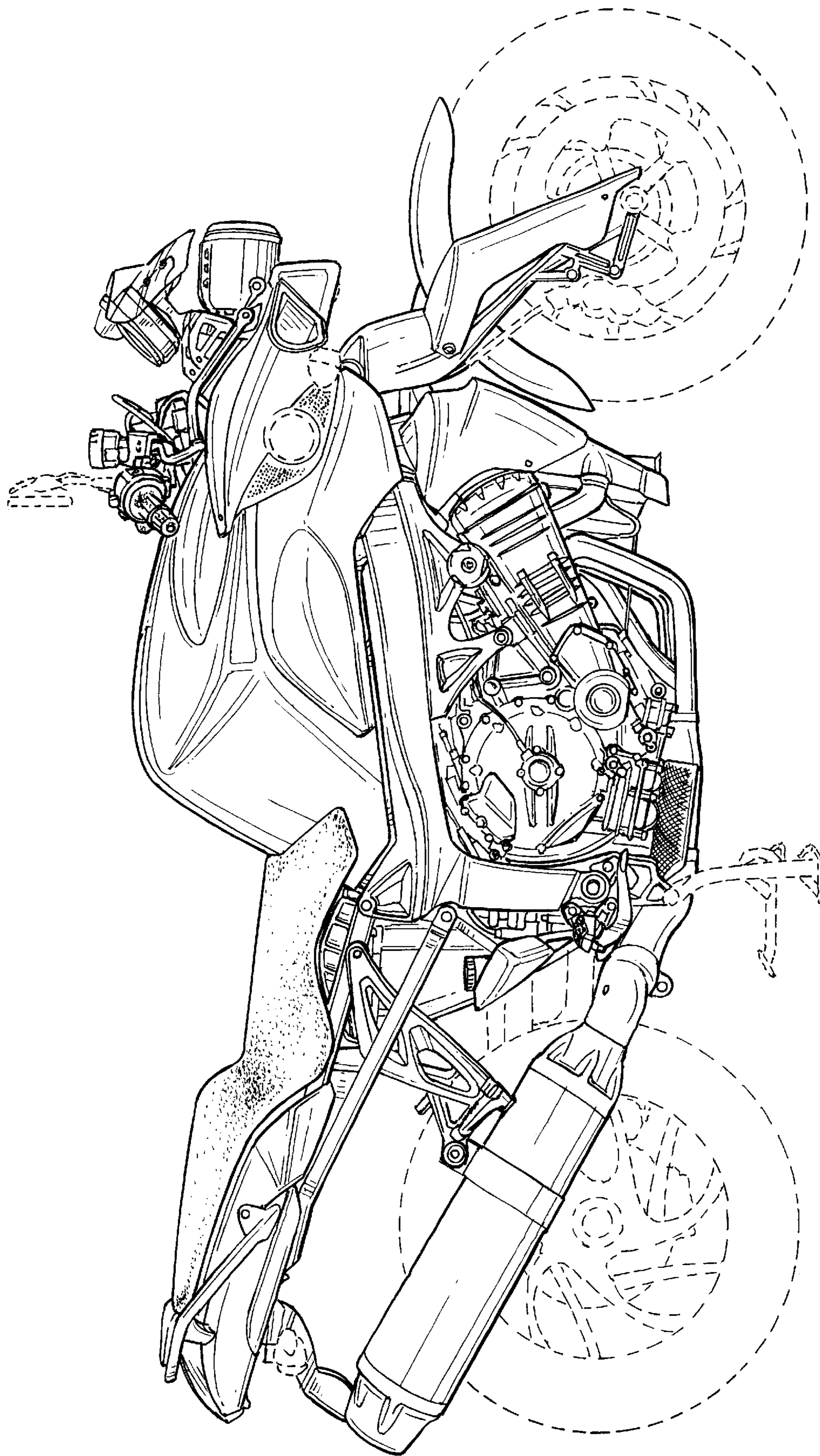
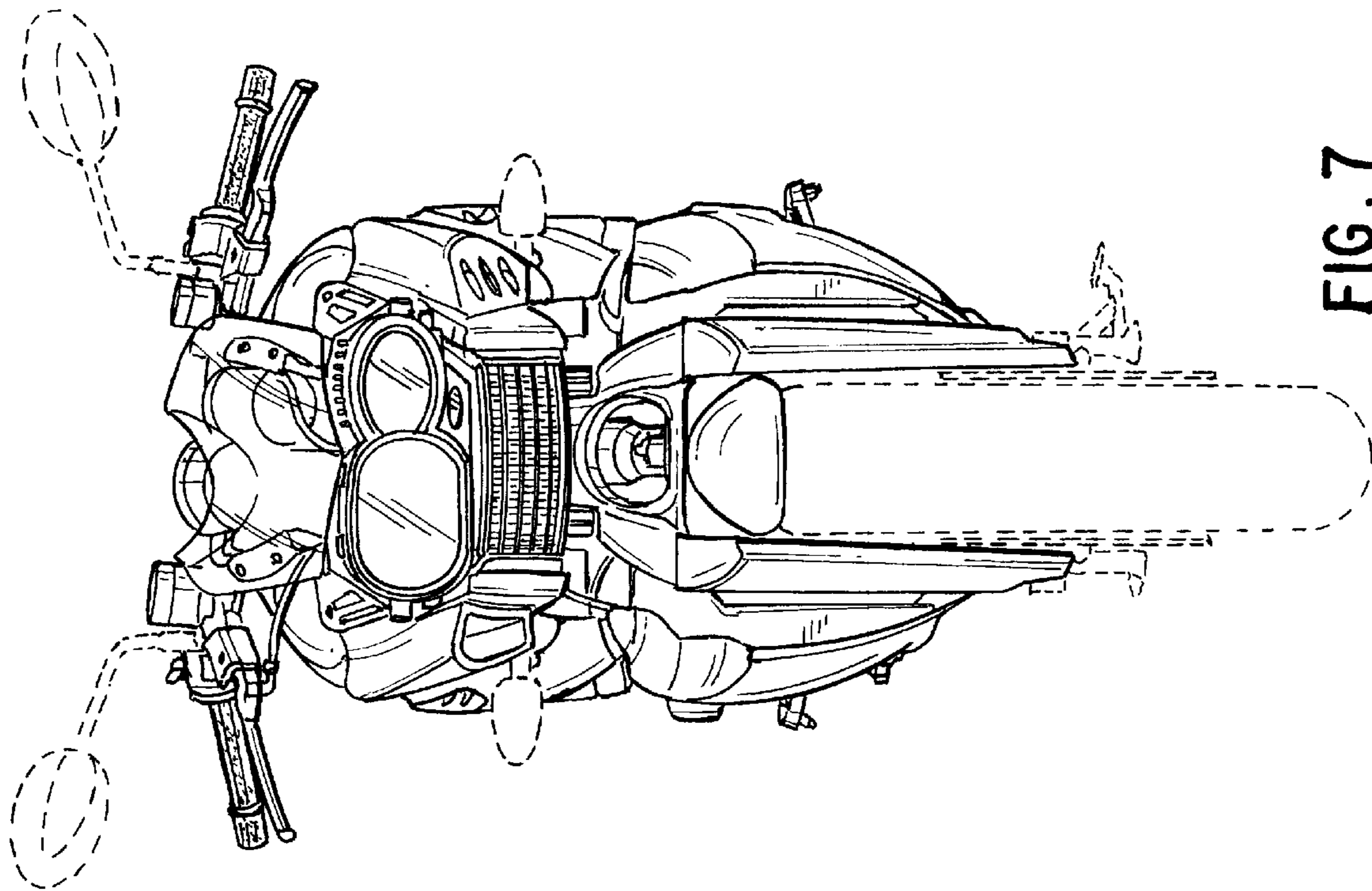
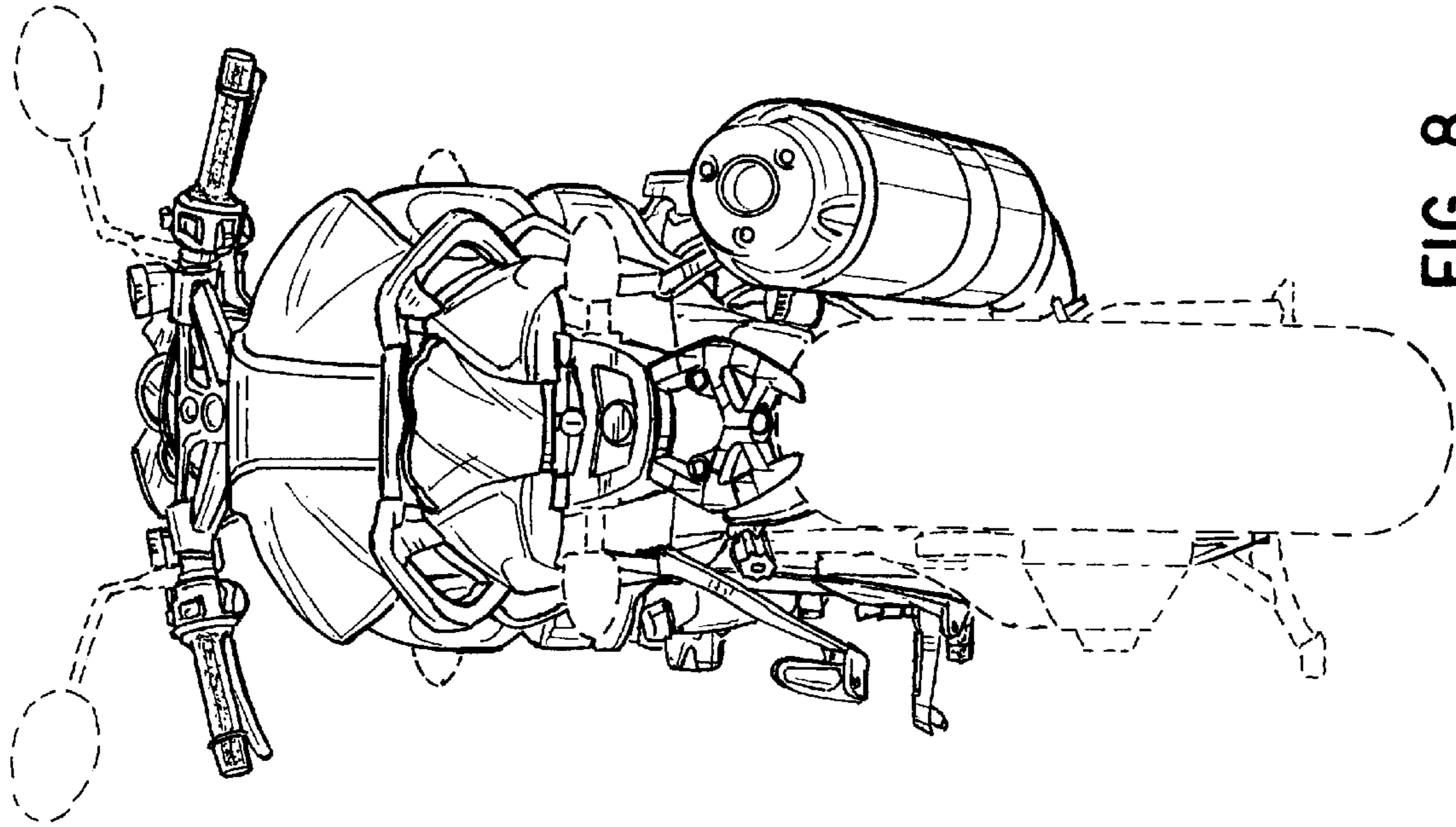

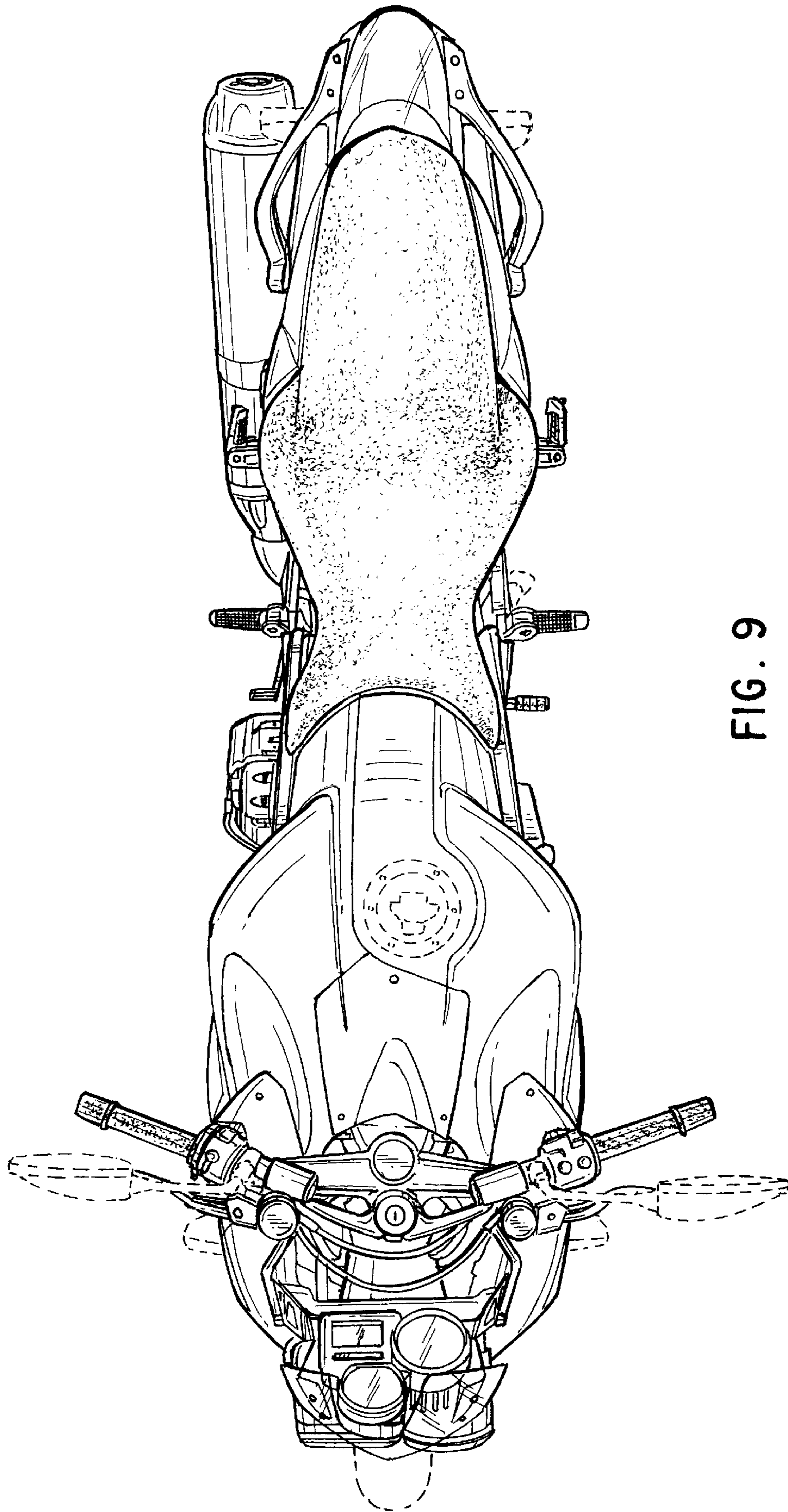
